(57) **CLAIM**

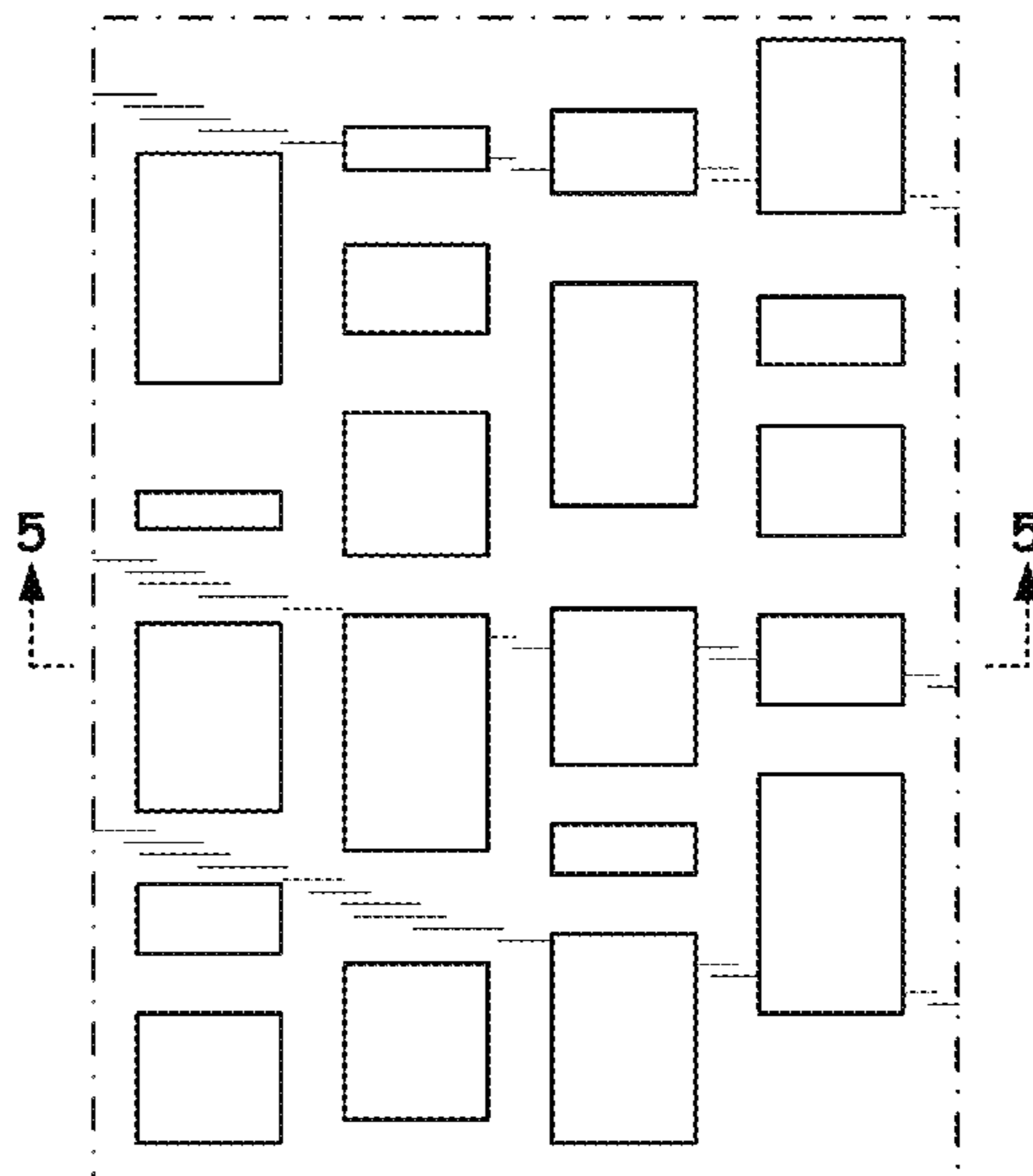
The ornamental design for a sheet with rectangular pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a sheet with rectangular pattern; FIG. 2 is a side view of FIG. 1, the opposing side being identical; FIG. 3 is a top view of FIG. 1, the bottom being identical; FIG. 4 is a back view of FIG. 1; and, FIG. 5 is a cross-sectional view taken along the line 5-5 indicated on FIG. 1.

The dot dash dot broken lines surrounding the sheet with rectangular pattern represent the boundaries of the claim and form no part thereof.

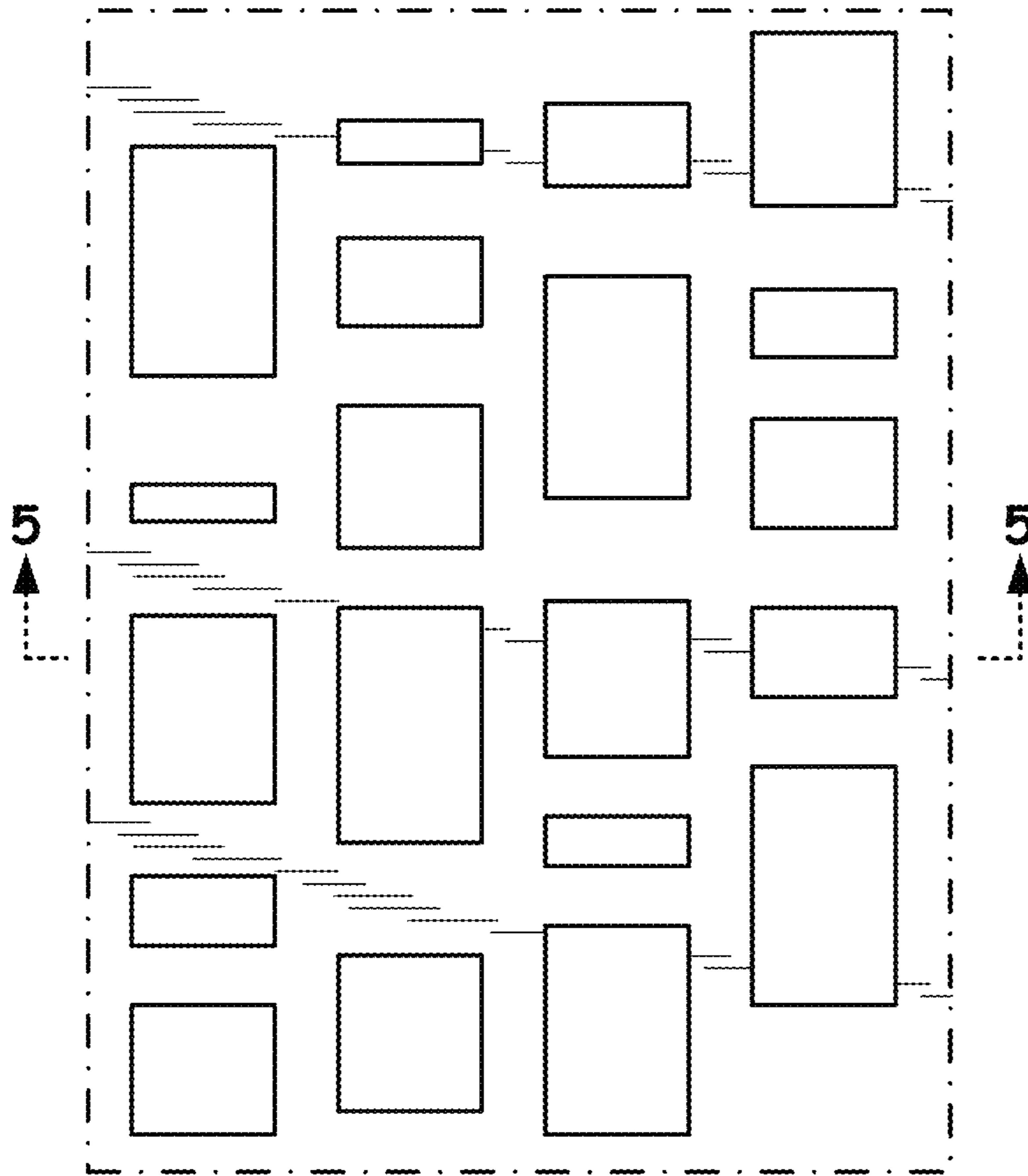

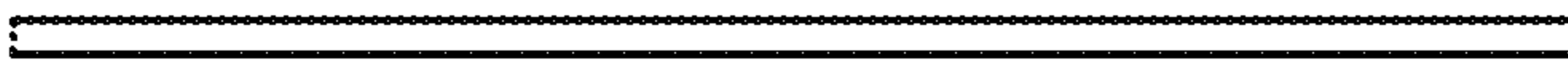

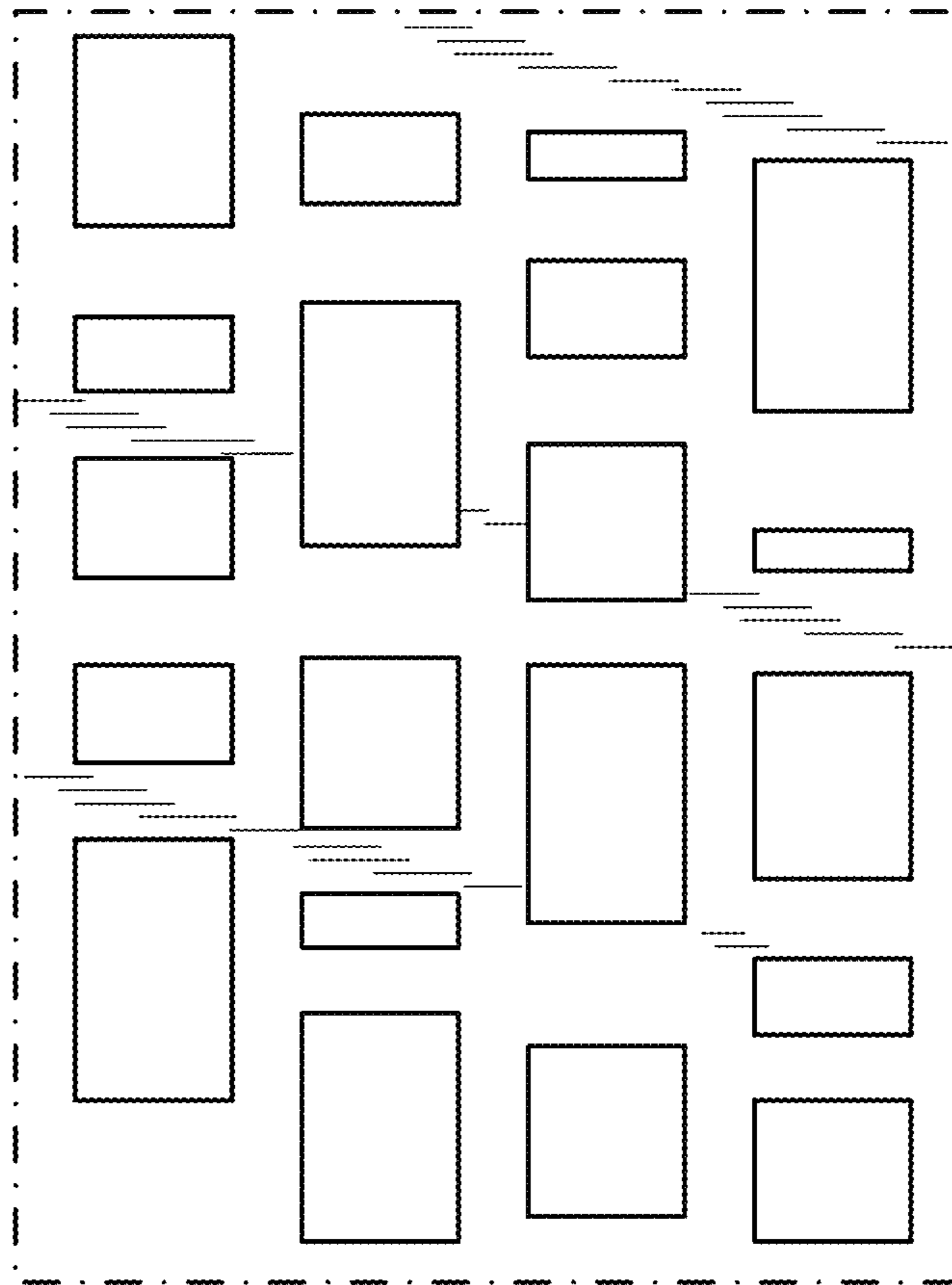
