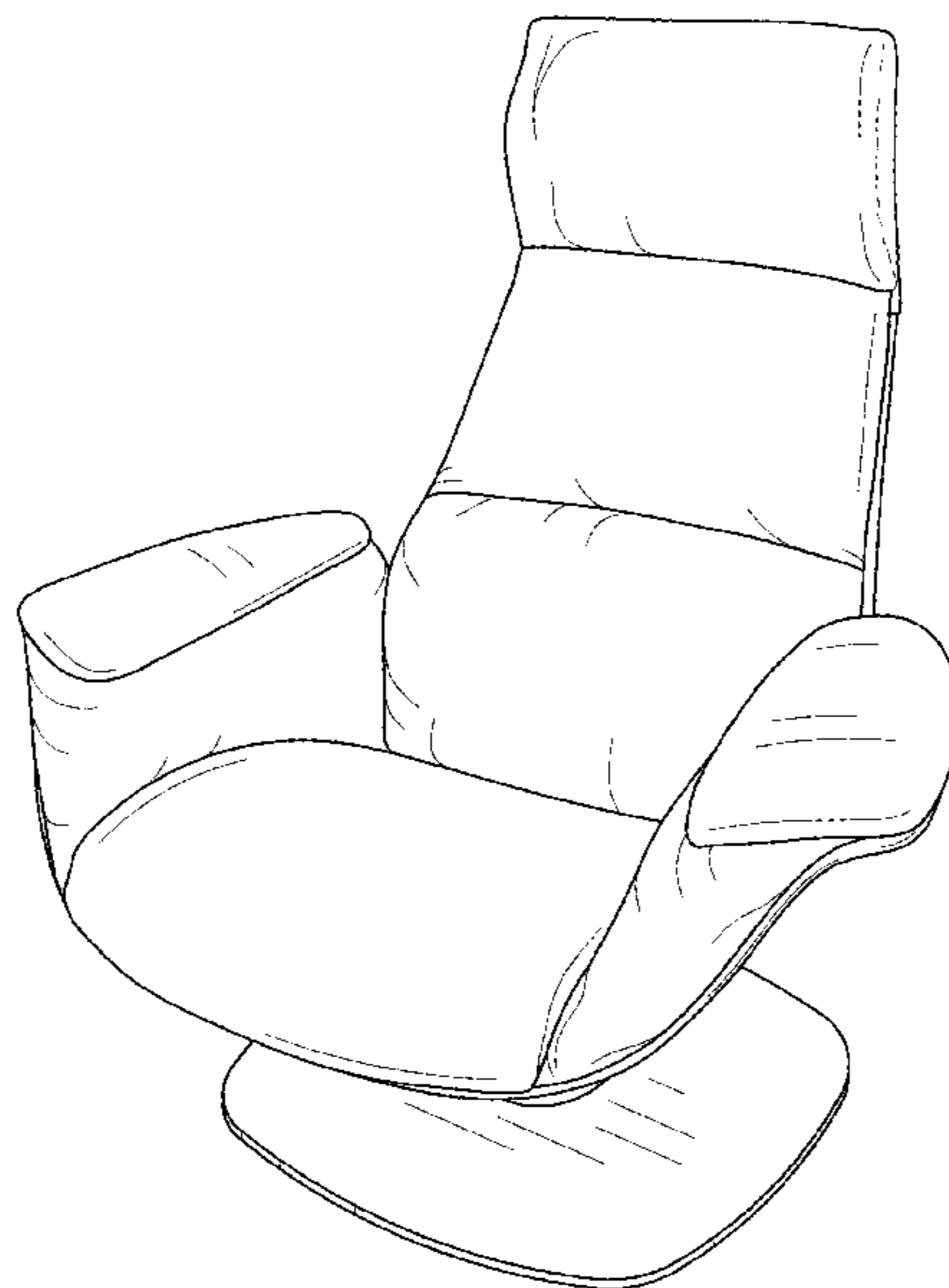
(57) **CLAIM**

I claim the ornamental design for a lounge chair, as shown and described.

DESCRIPTION

FIG. 1 is an elevated front perspective view of a lounge chair; FIG. 2 is a front perspective view of the lounge chair of FIG. 1; FIG. 3 is a rear perspective view of the lounge chair of FIG. 1; FIG. 4 is a right side perspective view of the lounge chair of FIG. 1; FIG. 5 is a left side perspective view of the lounge chair of FIG. 1; FIG. 6 is a top plan view of the lounge chair of FIG. 1; and, FIG. 7 is a bottom plan view of the lounge chair of FIG. 1. The dashed lines are for purposes of illustrating environmental structure and form no part of the claimed design.

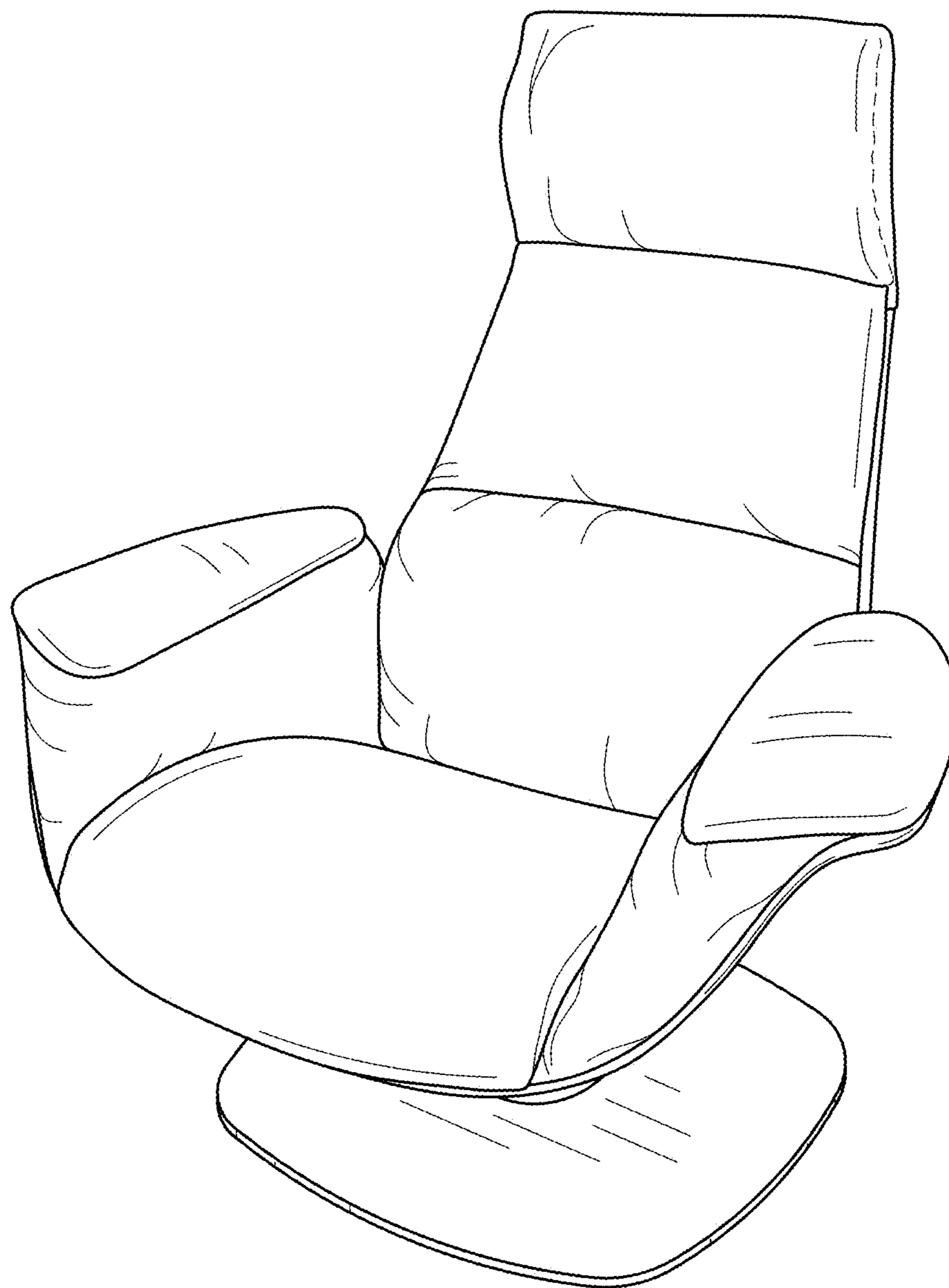

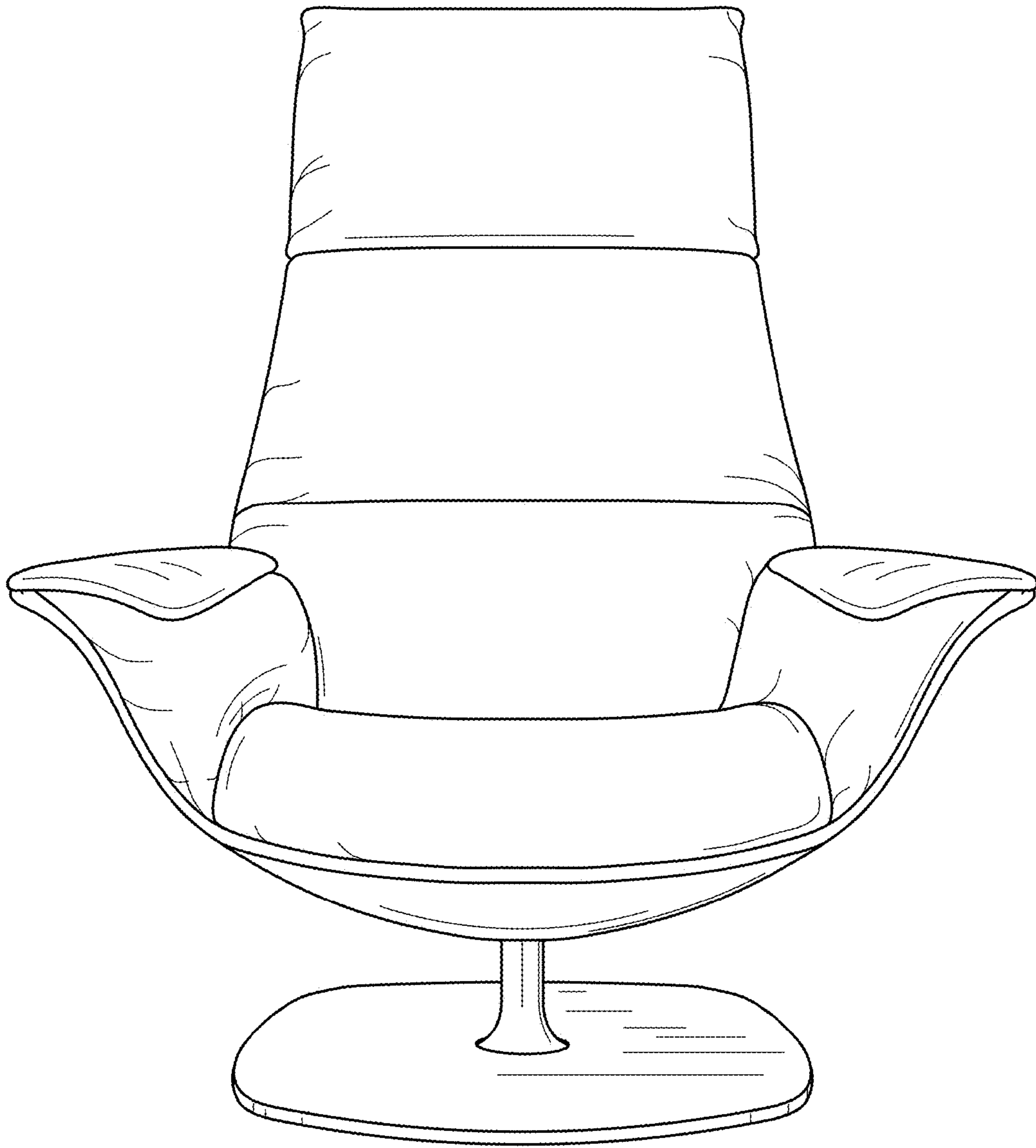

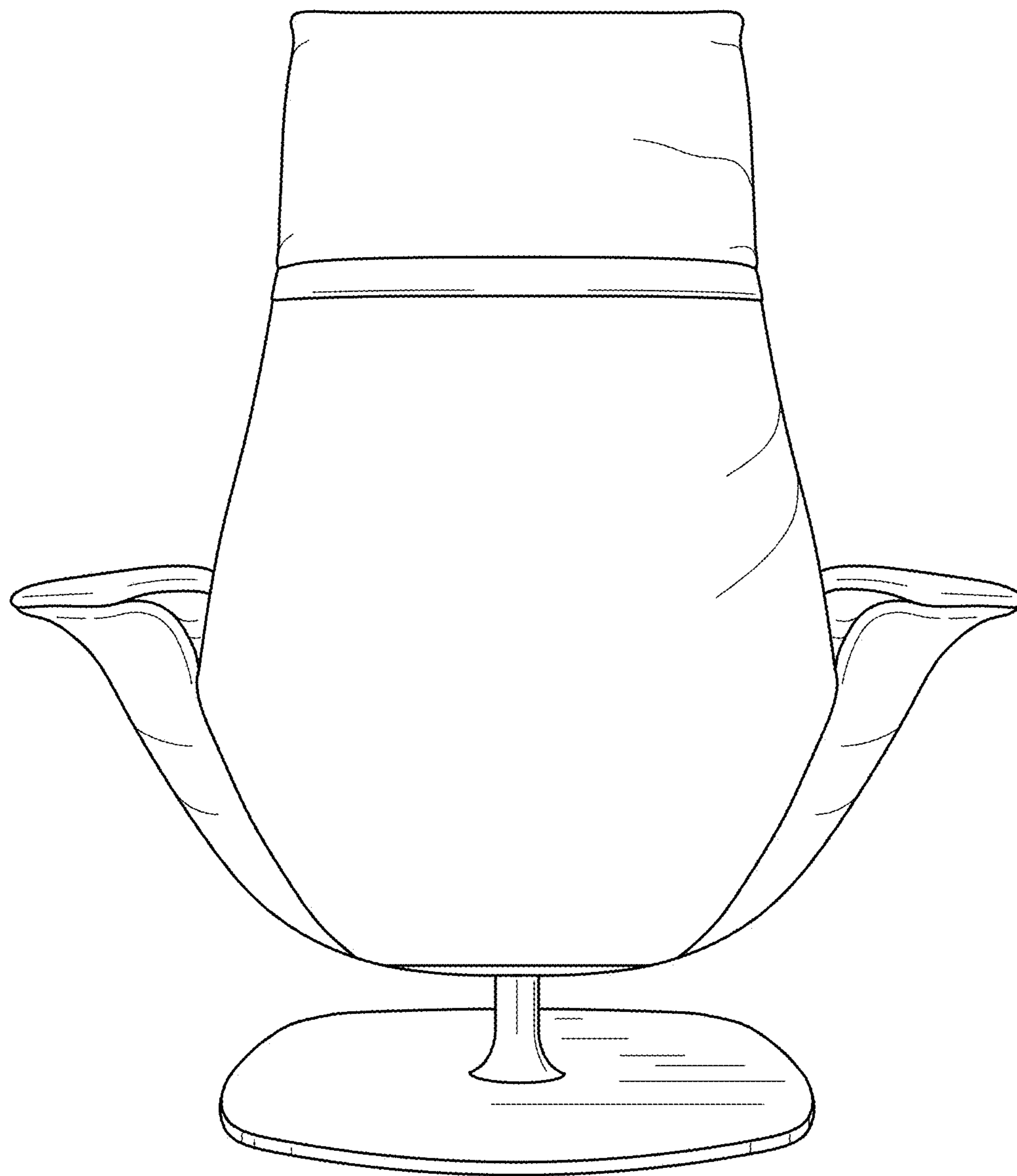

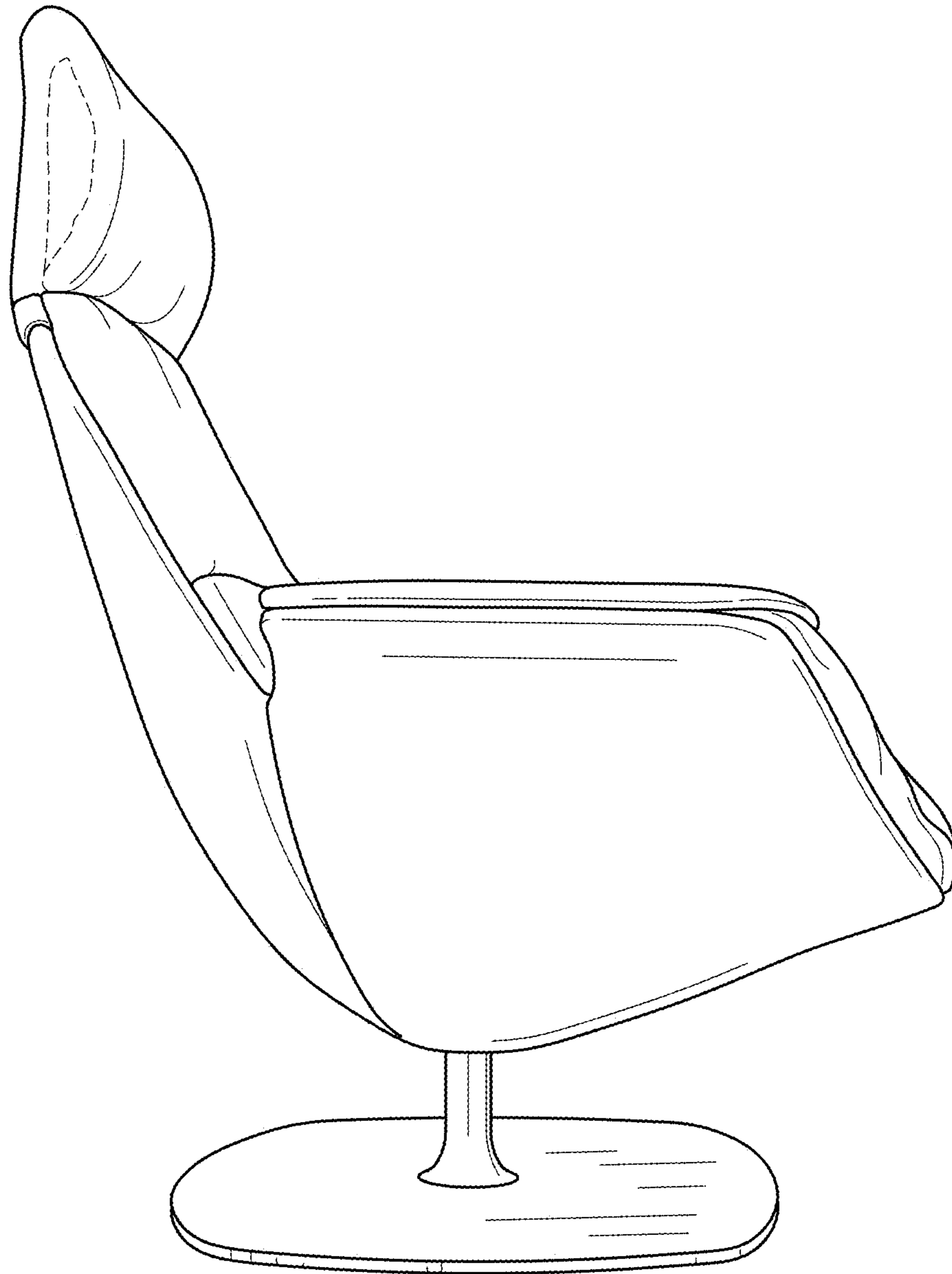

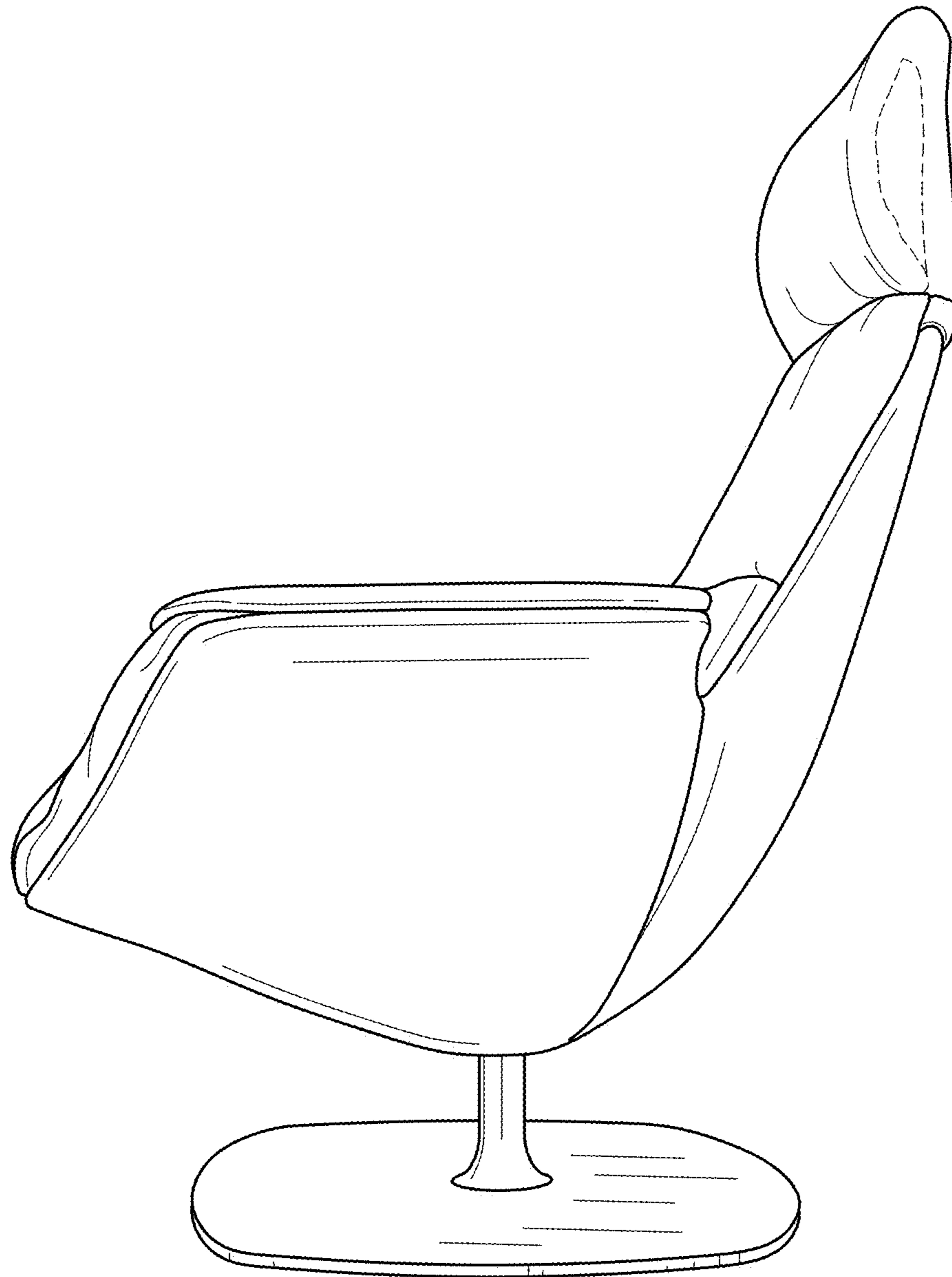

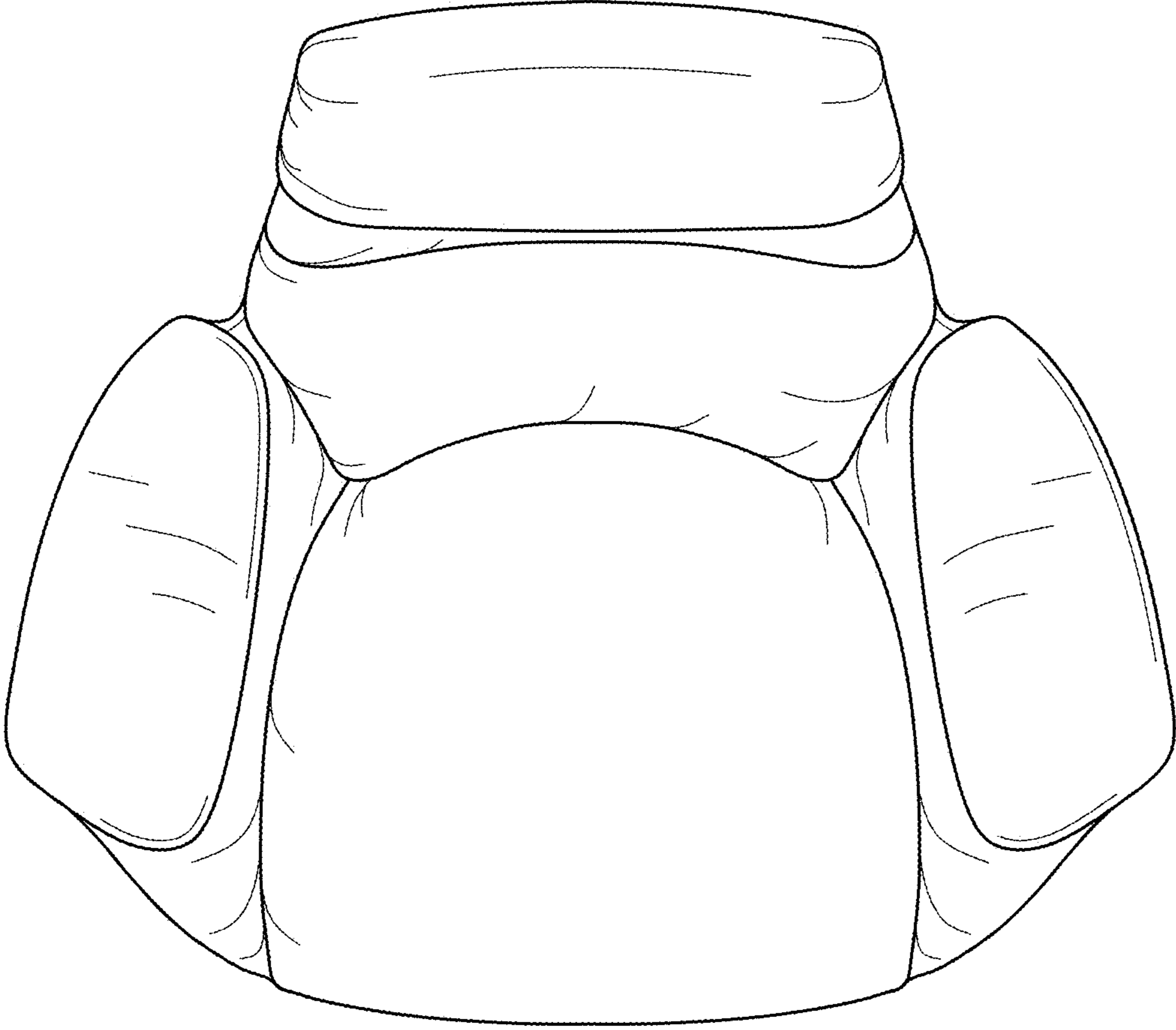

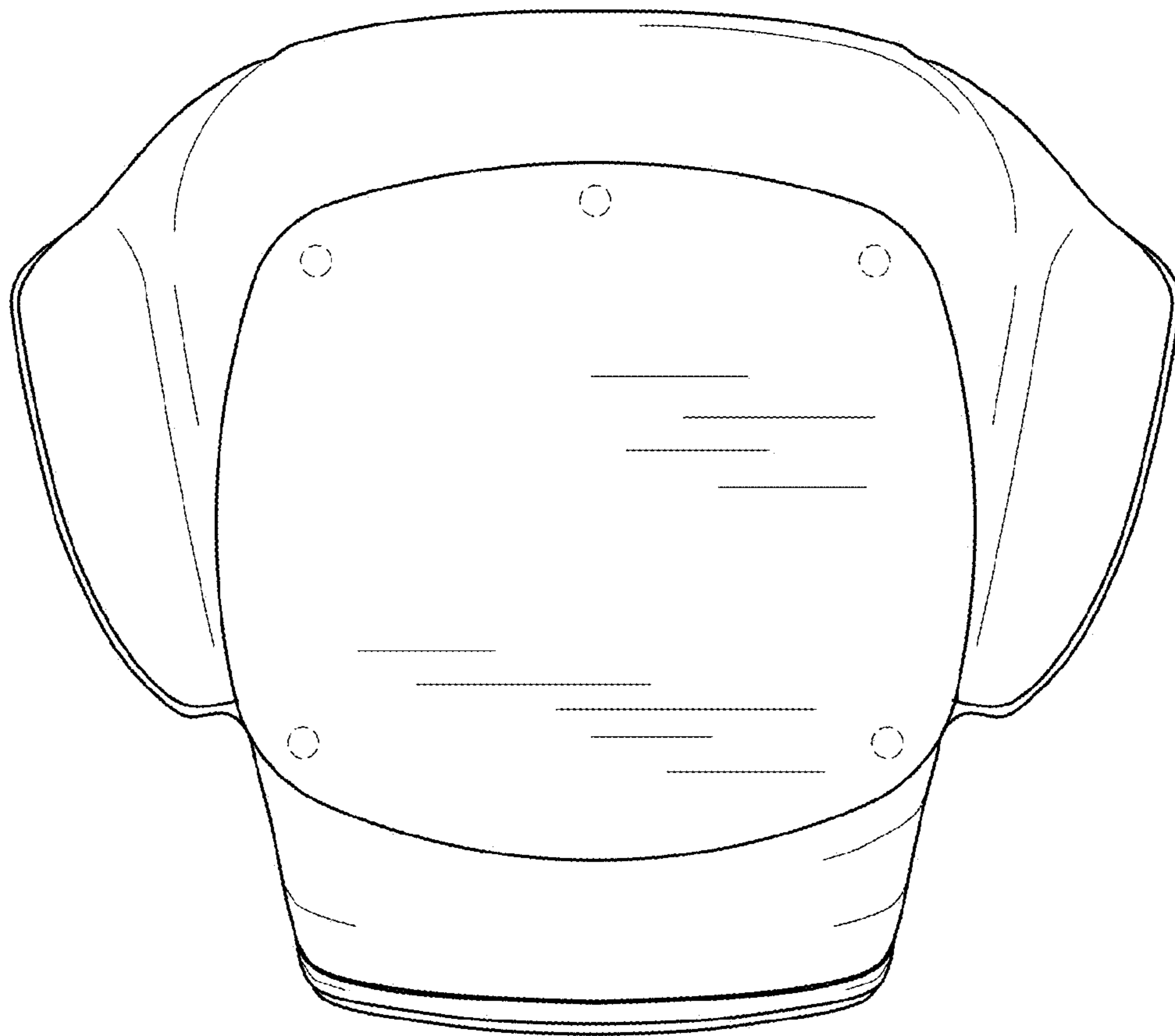
