**DESCRIPTION**

FIG. 1 is an isometric view of a pillow according to an embodiment of the invention.

FIG. 2 is a top plan view of the pillow of FIG. 1.

FIG. 3 is a bottom view of the pillow of FIG. 1.

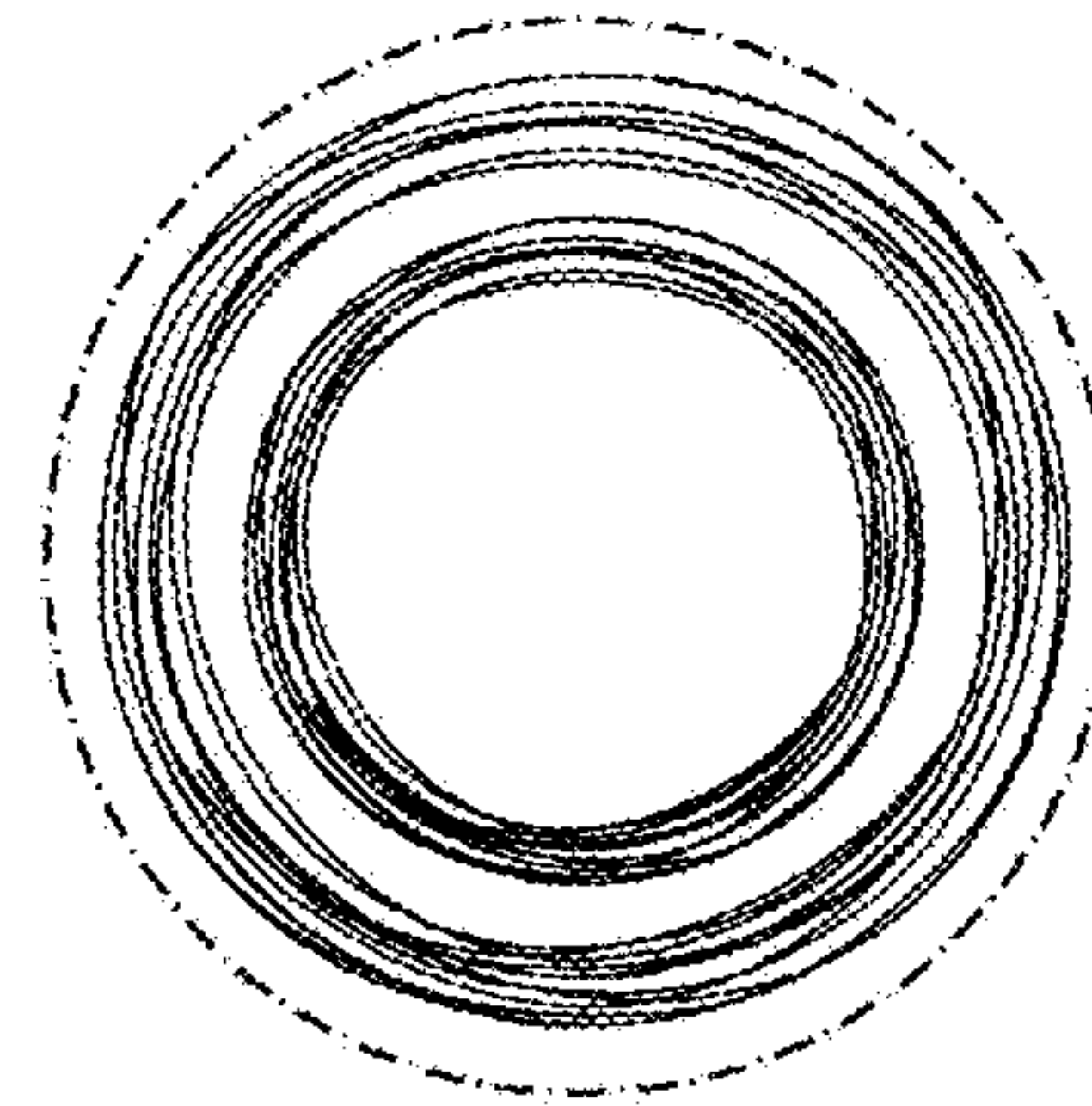
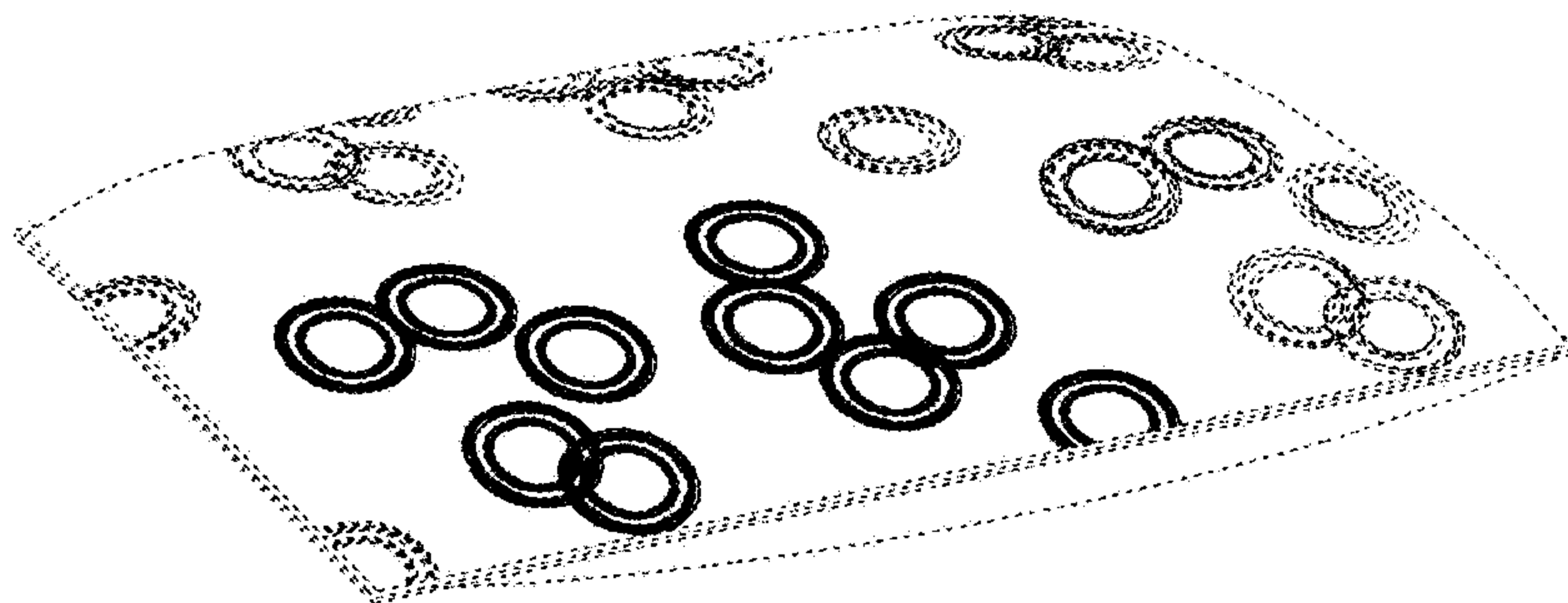
FIG. 4 is a perspective side view of the pillow of FIG. 1.

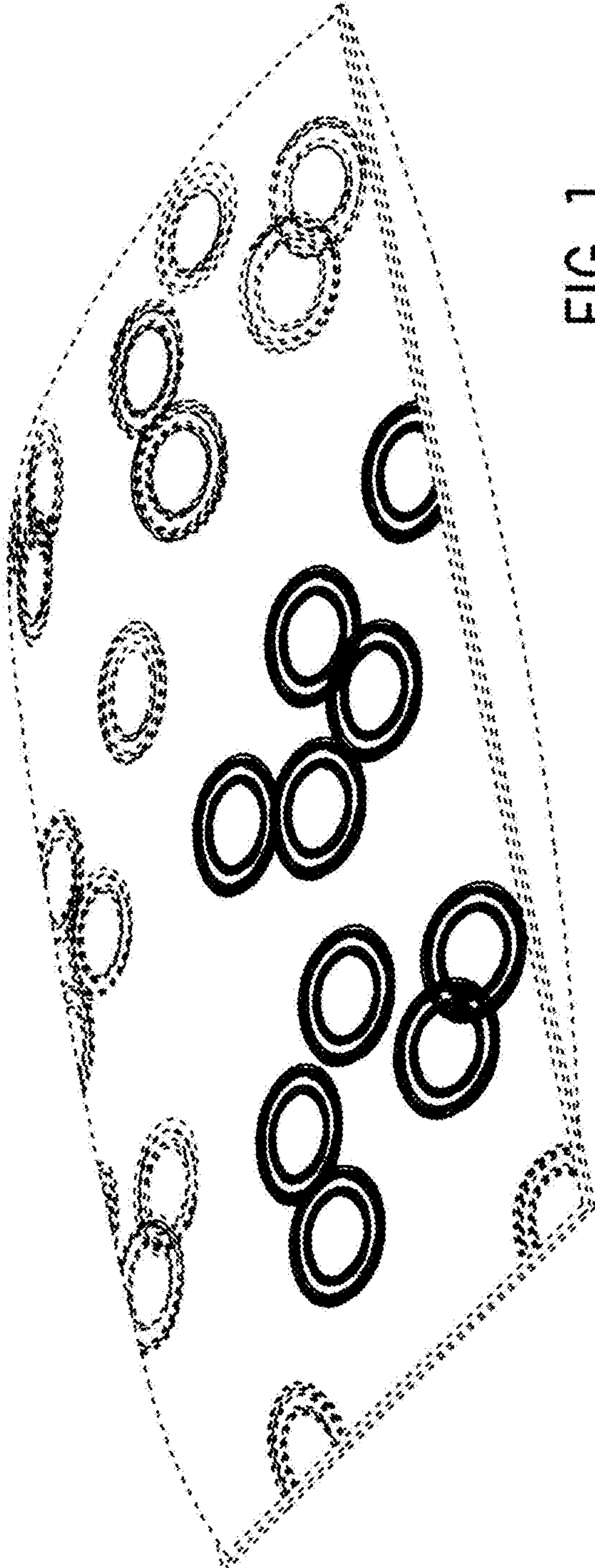

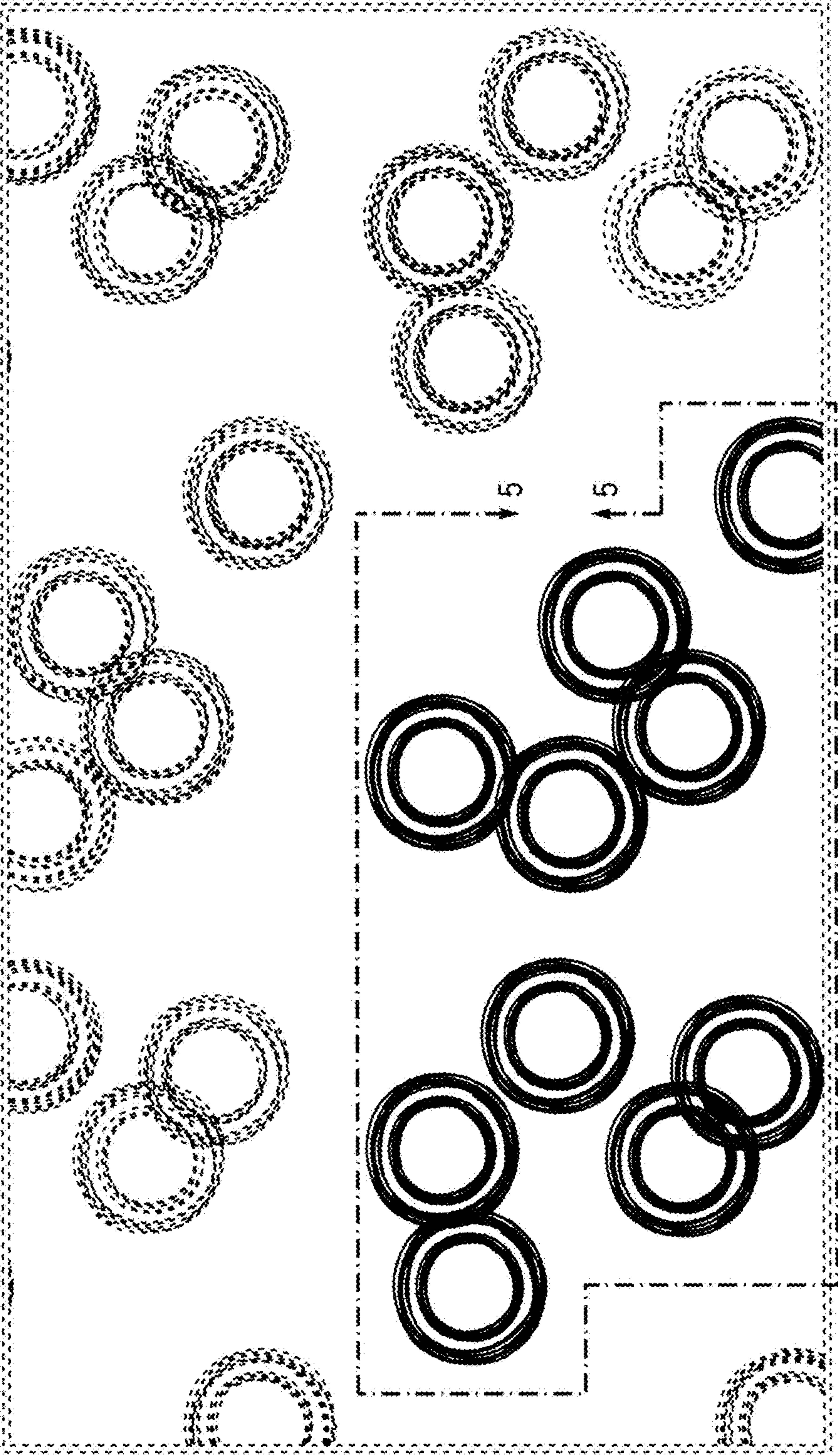

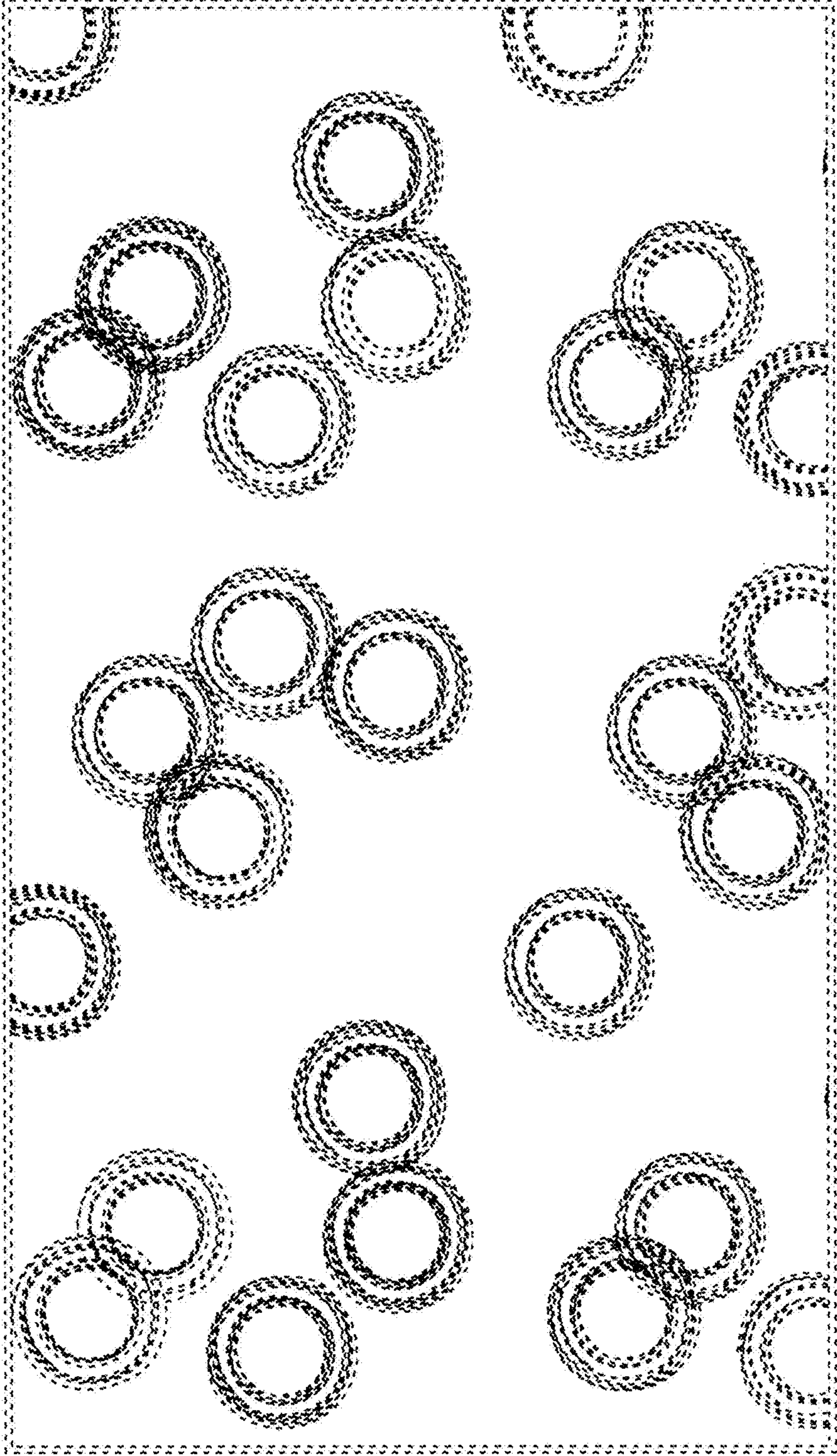

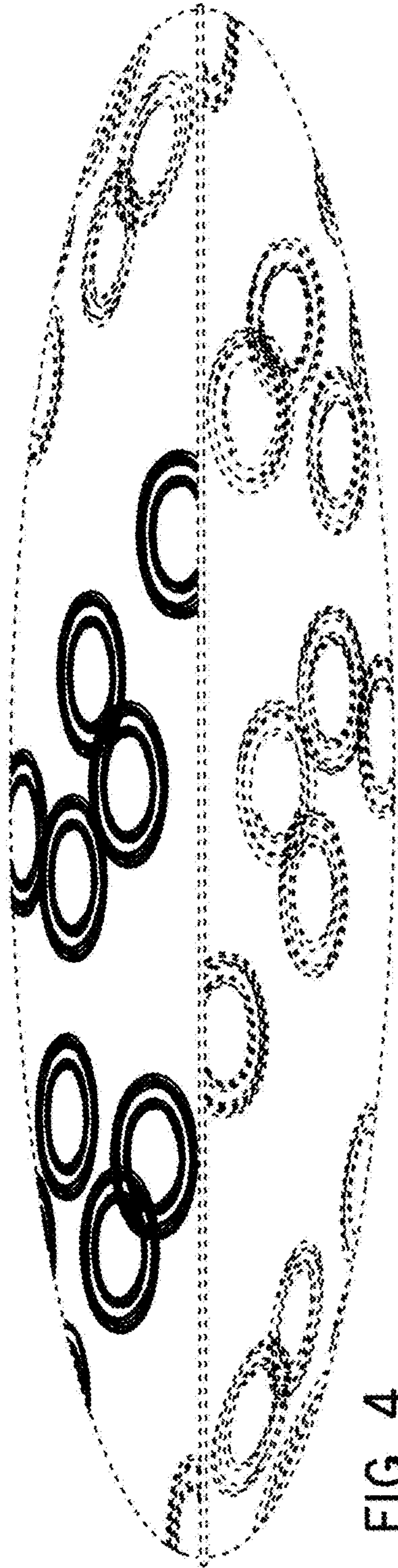

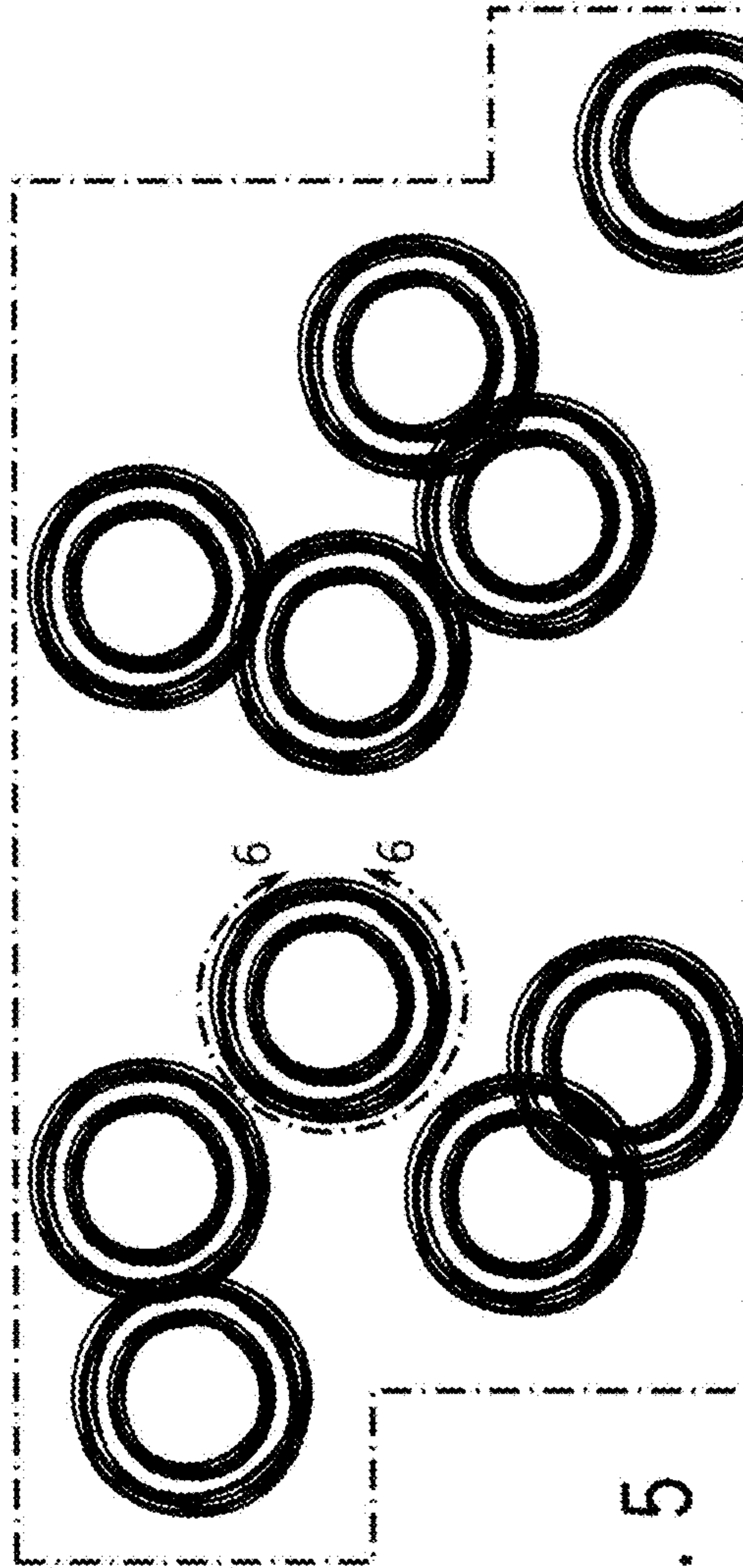

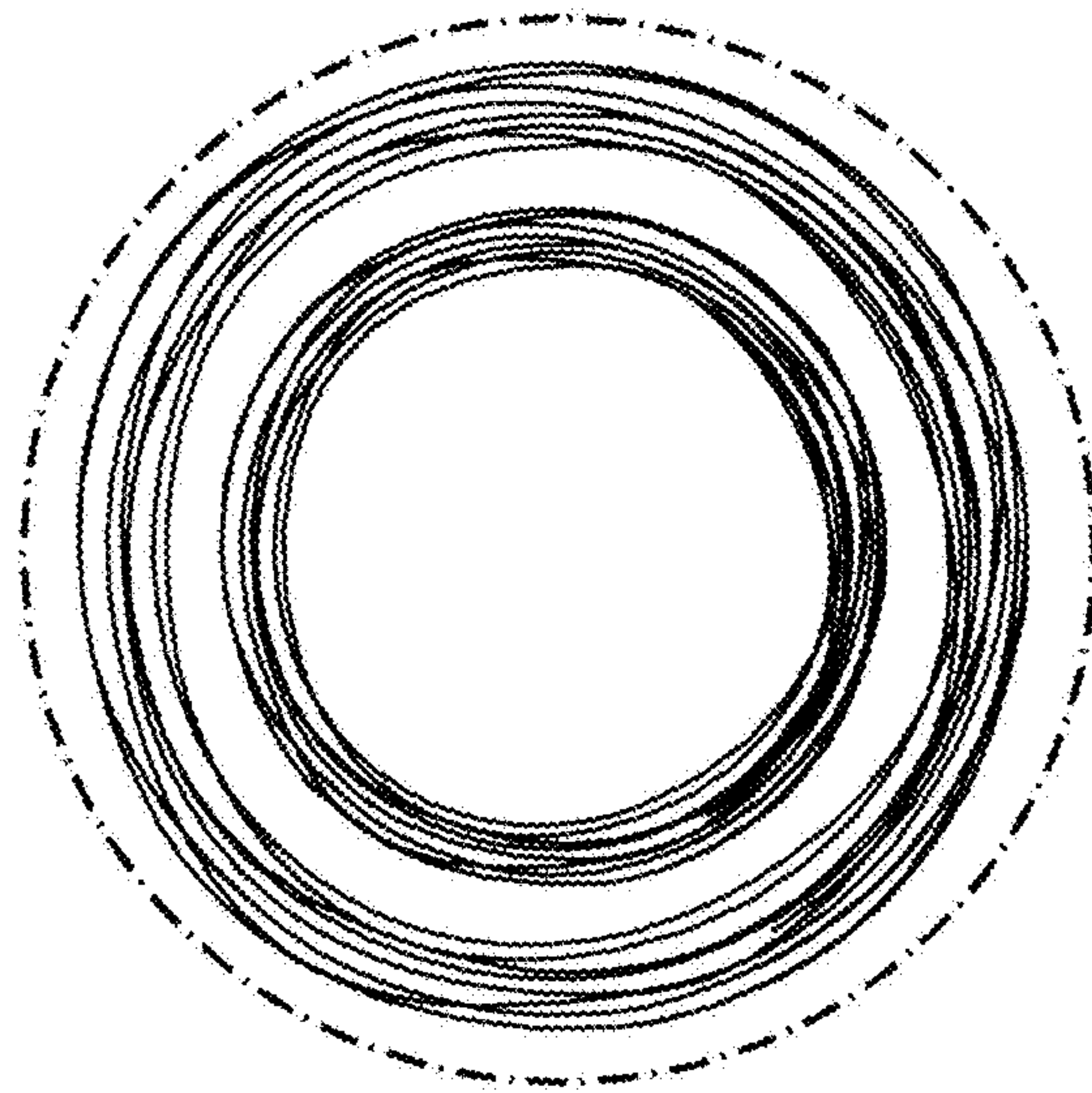
