(57) **CLAIM**

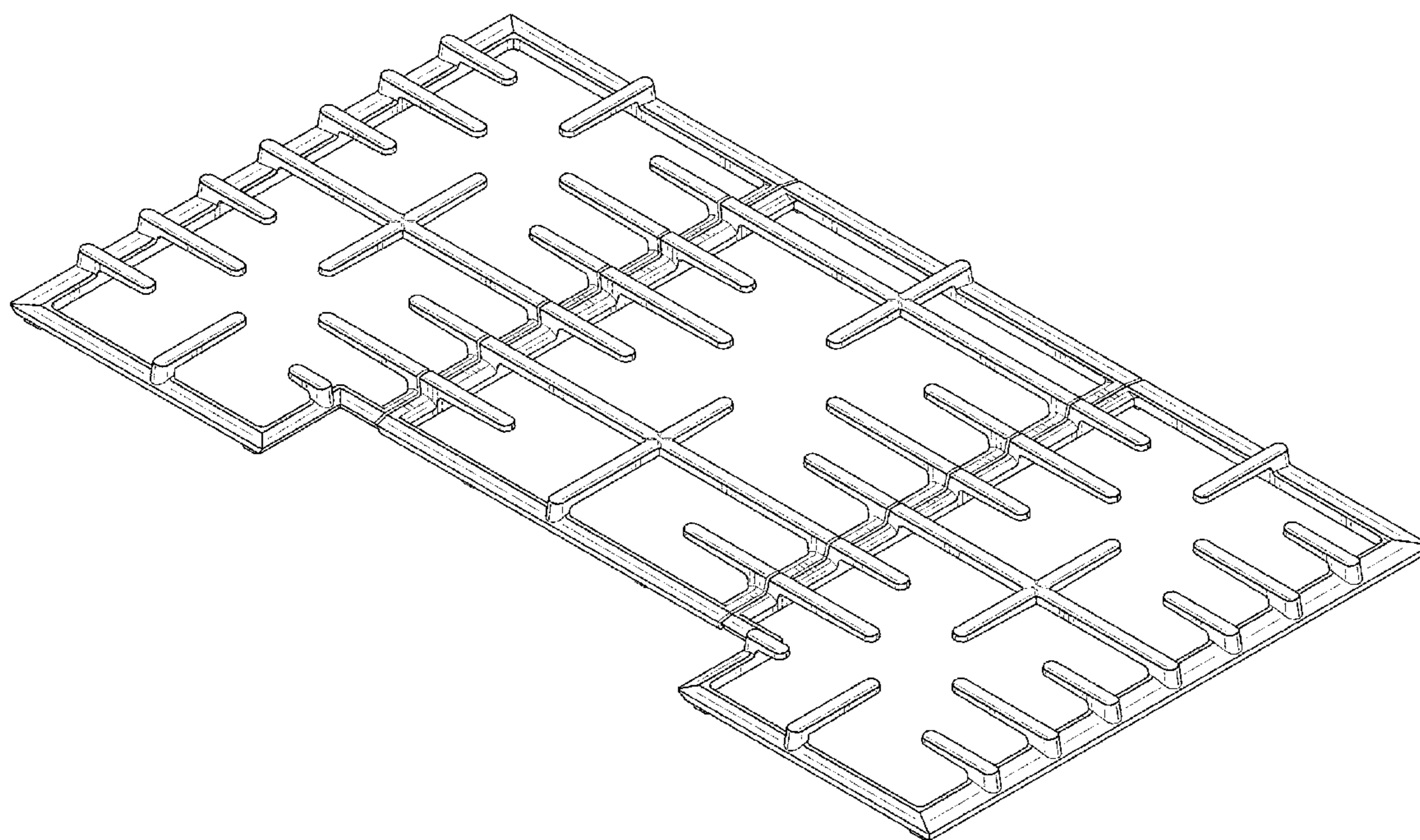
The ornamental design for a gas cooktop grate set, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a gas cooktop grate set according to our new ornamental design;

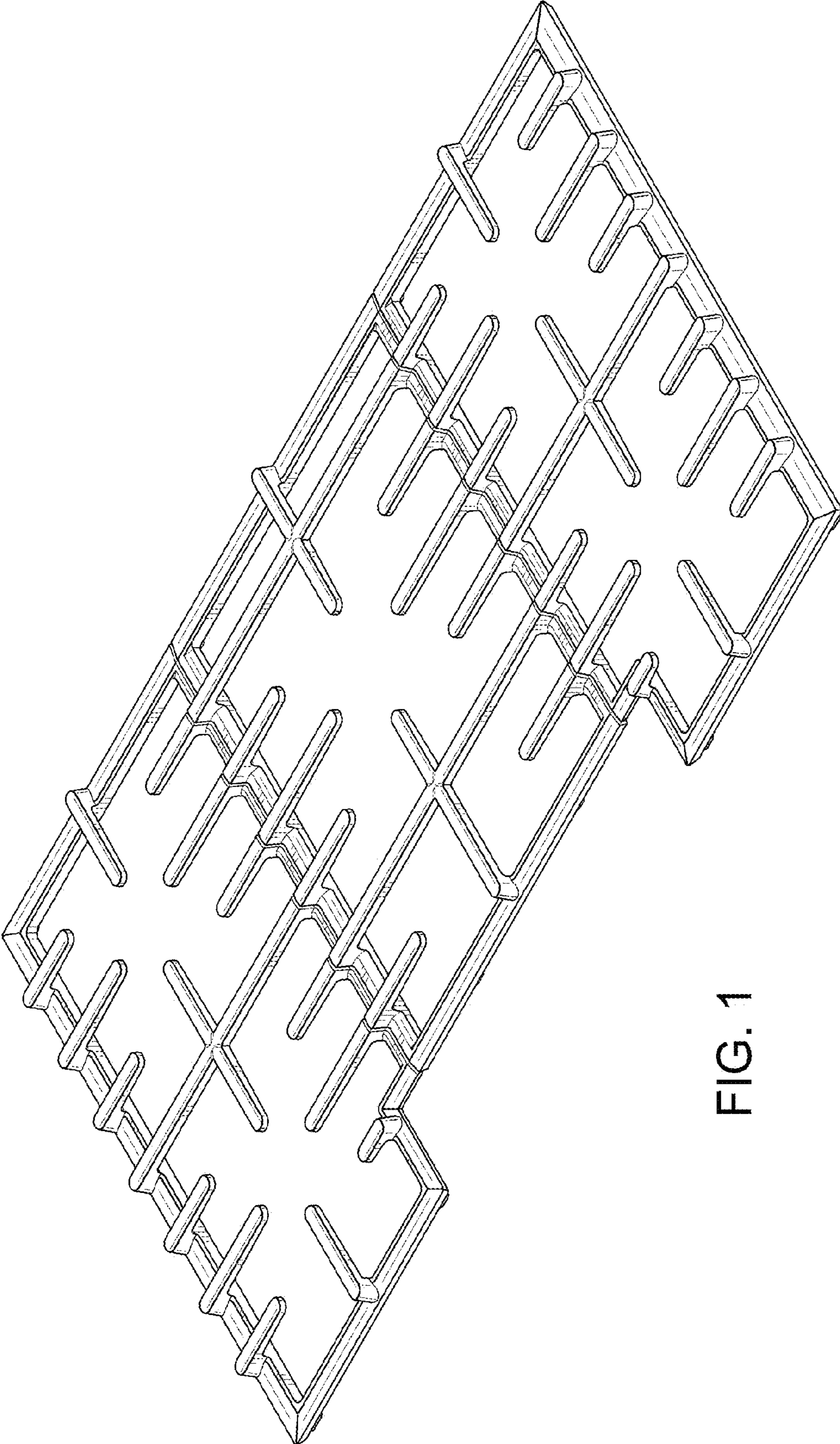

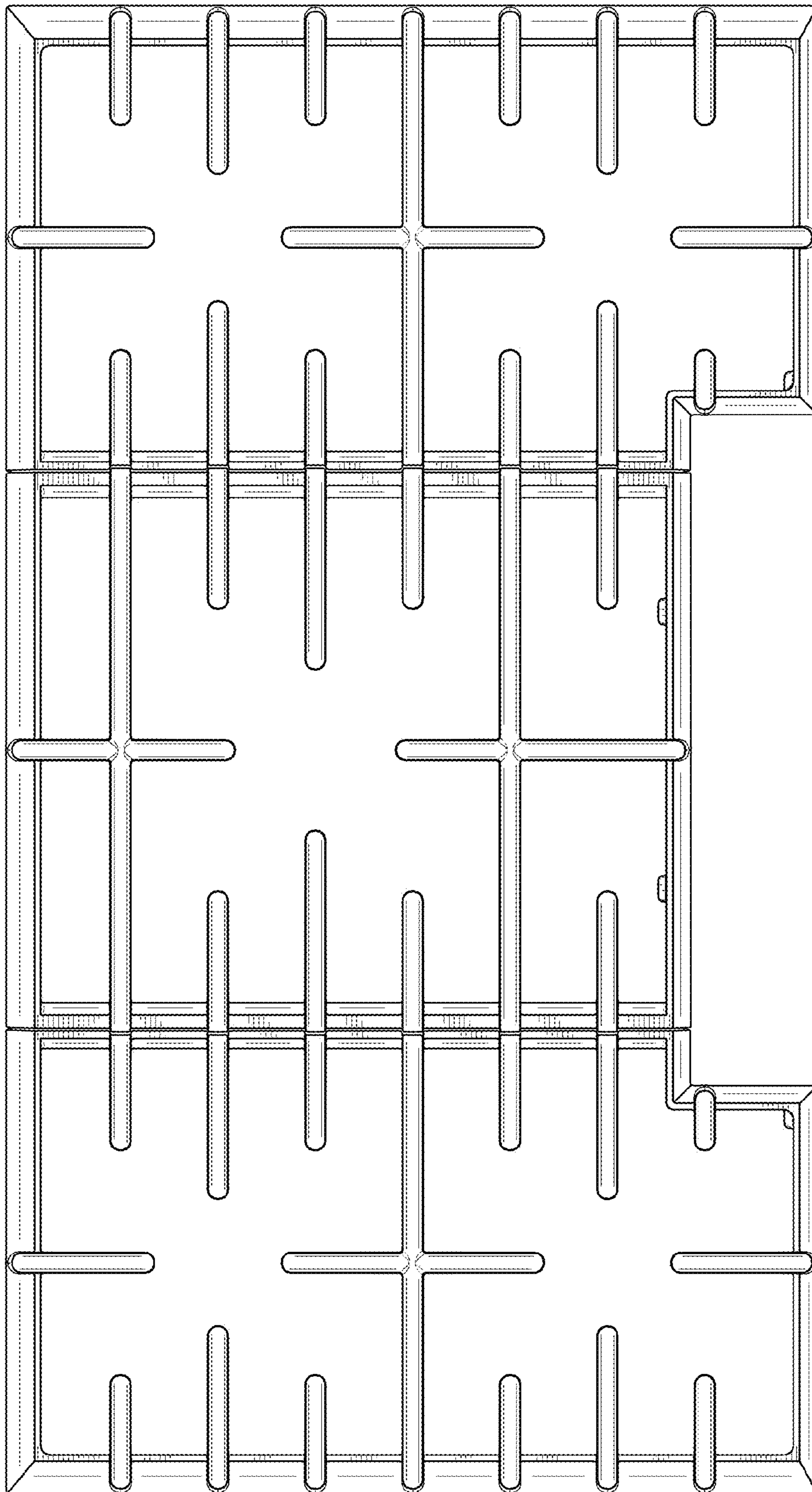

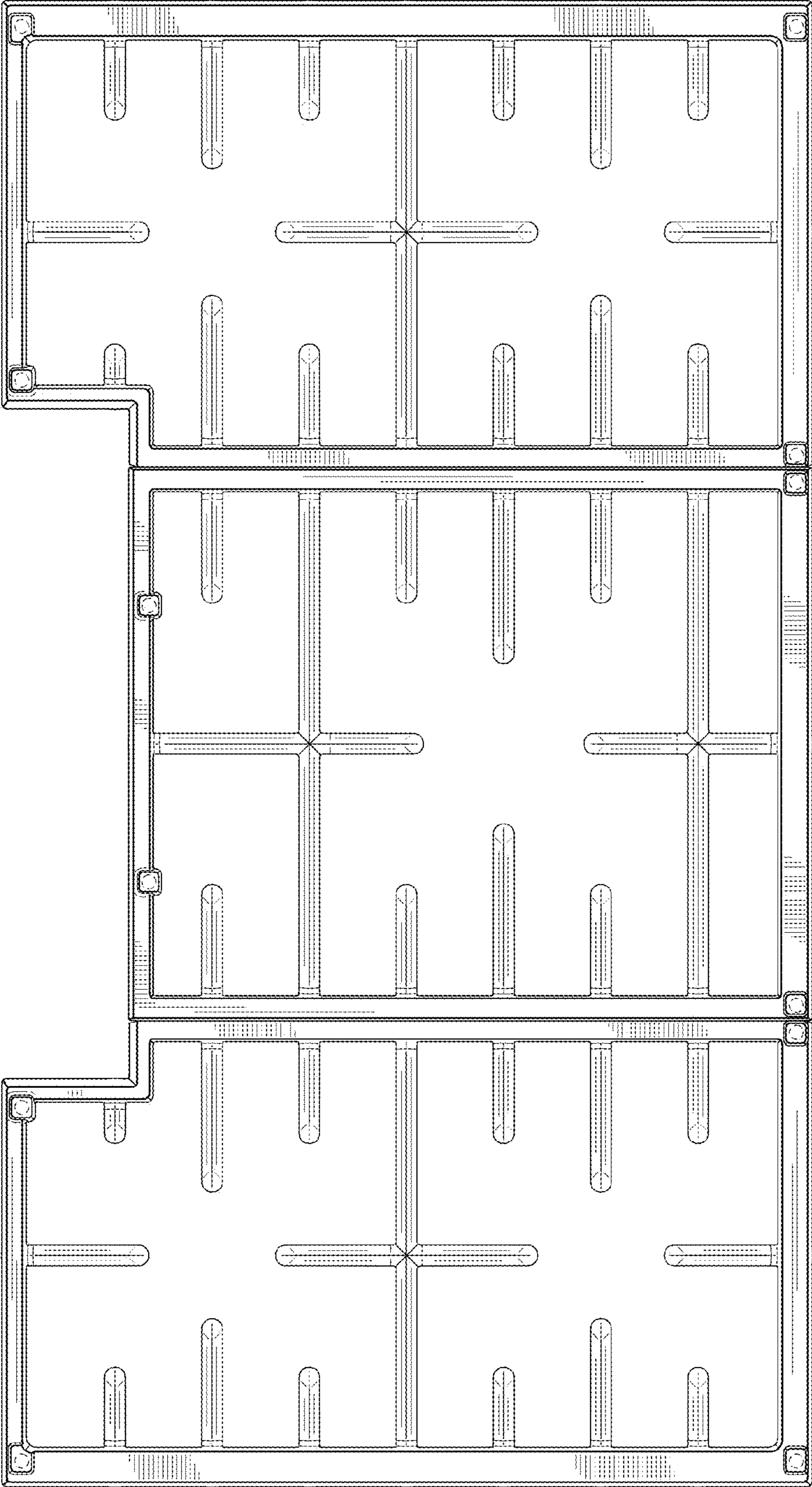

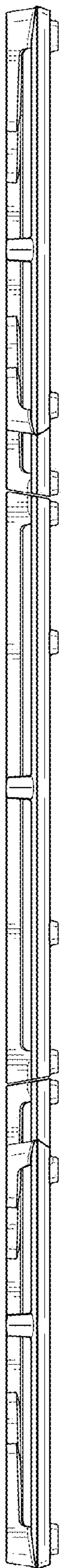

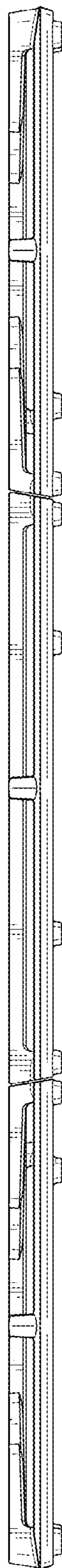

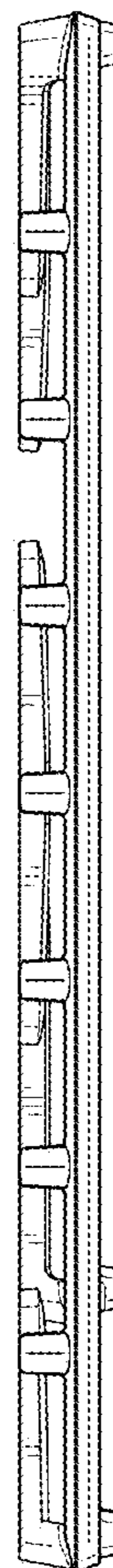
