(57) **CLAIM**

The ornamental design for a two-ring bottle carrier, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a top front perspective view of an ornamental design  
for a two-ring bottle carrier according to the present inven-  
tion.

FIG. 2 is a bottom rear perspective view of the two-ring bottle  
carrier of FIG. 1.

FIG. 3 is a top view of the two-ring bottle carrier of FIG. 1.

FIG. 4 is a partial cutaway side view taken along line 4-4 in  
FIG. 3, of the two-ring bottle carrier of FIG. 1.

FIG. 5 is a partial cutaway end view taken along line 5-5 in  
FIG. 3, of the two-ring bottle carrier of FIG. 1.

FIG. 6 is a bottom view of the two-ring bottle carrier of FIG.  
1.

FIG. 7 is a front side view of the two-ring bottle carrier of FIG.  
1, with dashed lines illustrating bottles secured in the two-  
ring bottle carrier.

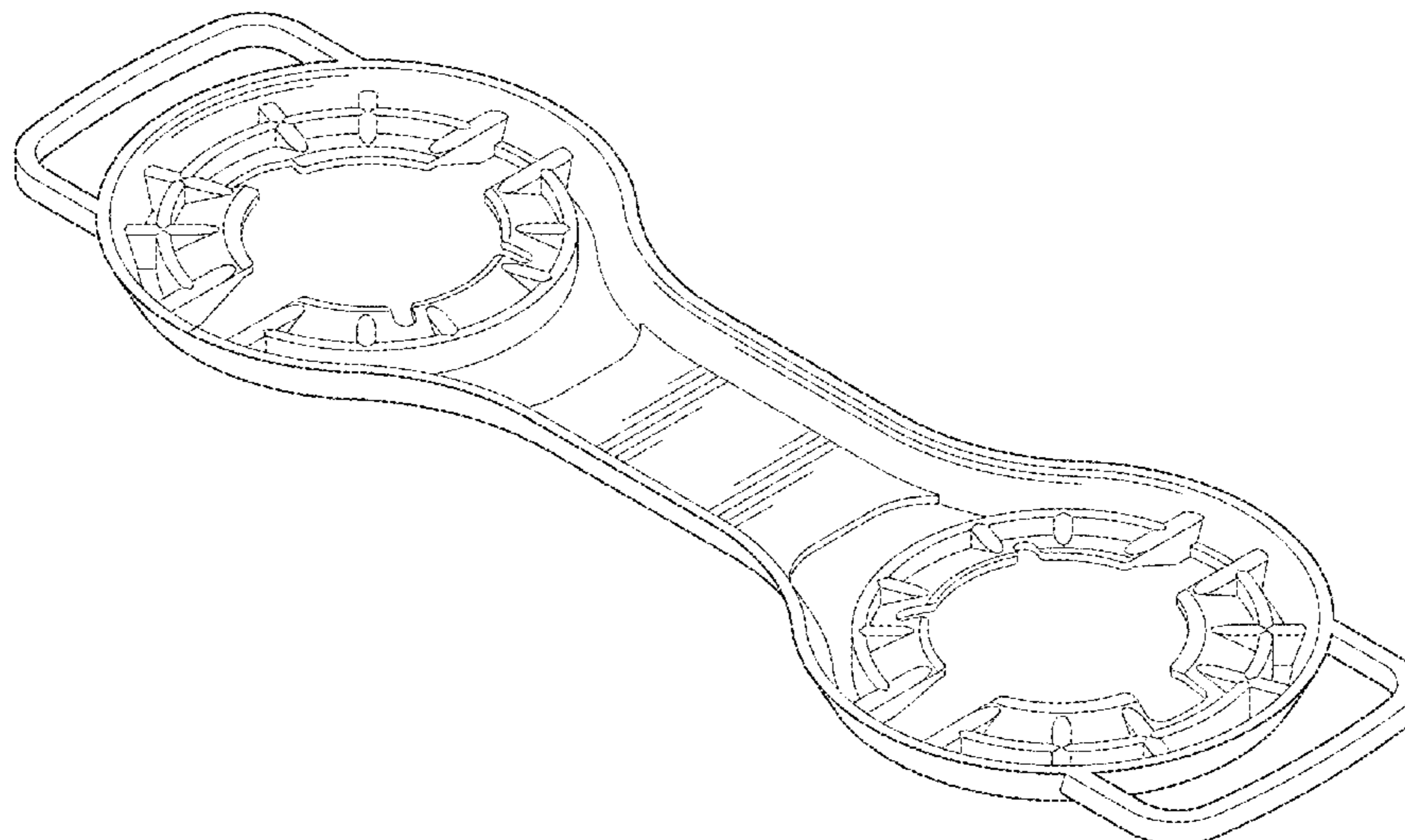
FIG. 8 is a back side view of the two-ring bottle carrier of FIG.  
1.

FIG. 9 is a left side view of the two-ring bottle carrier of FIG.  
1; and,

FIG. 10 is a right side view of the two-ring bottle carrier of

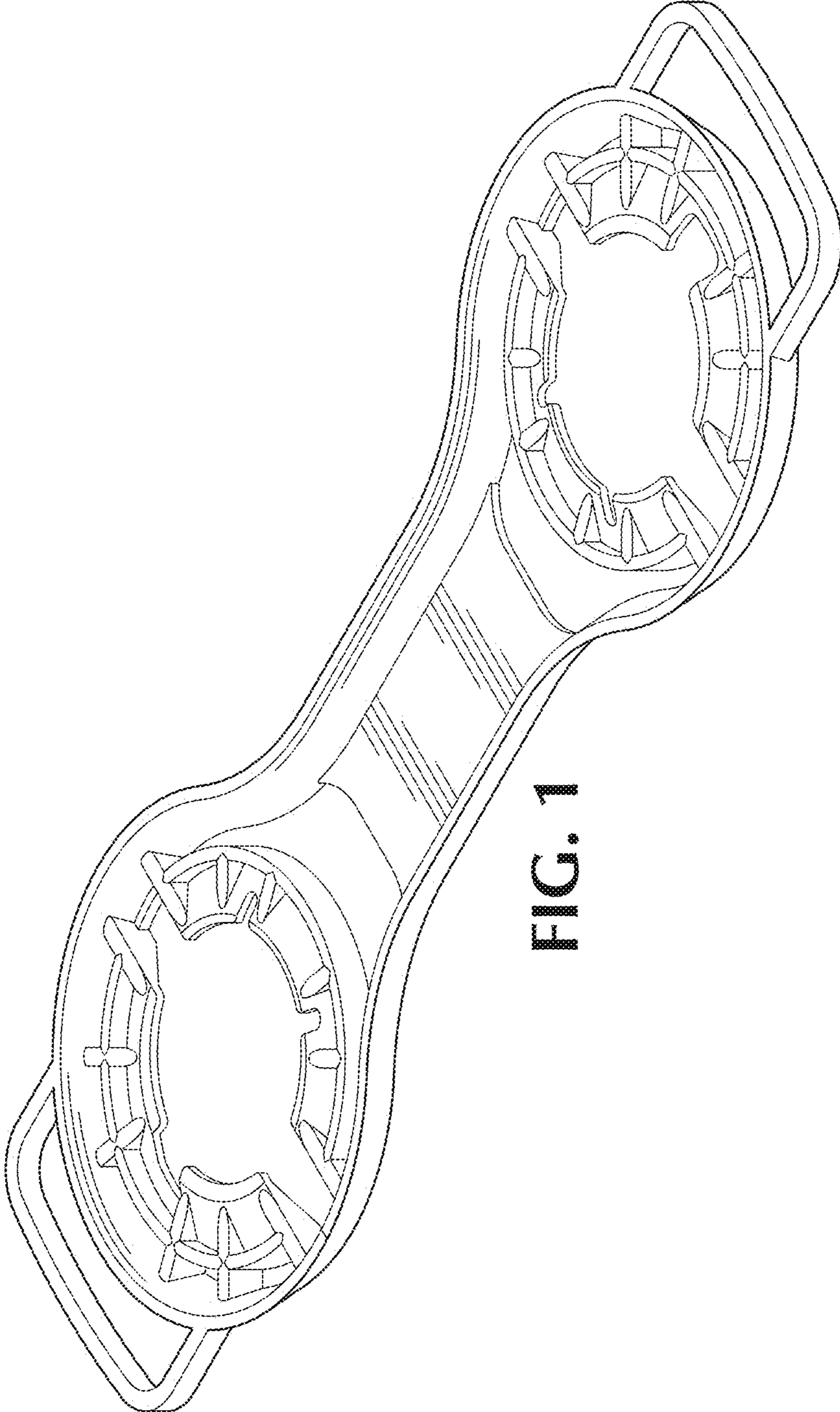

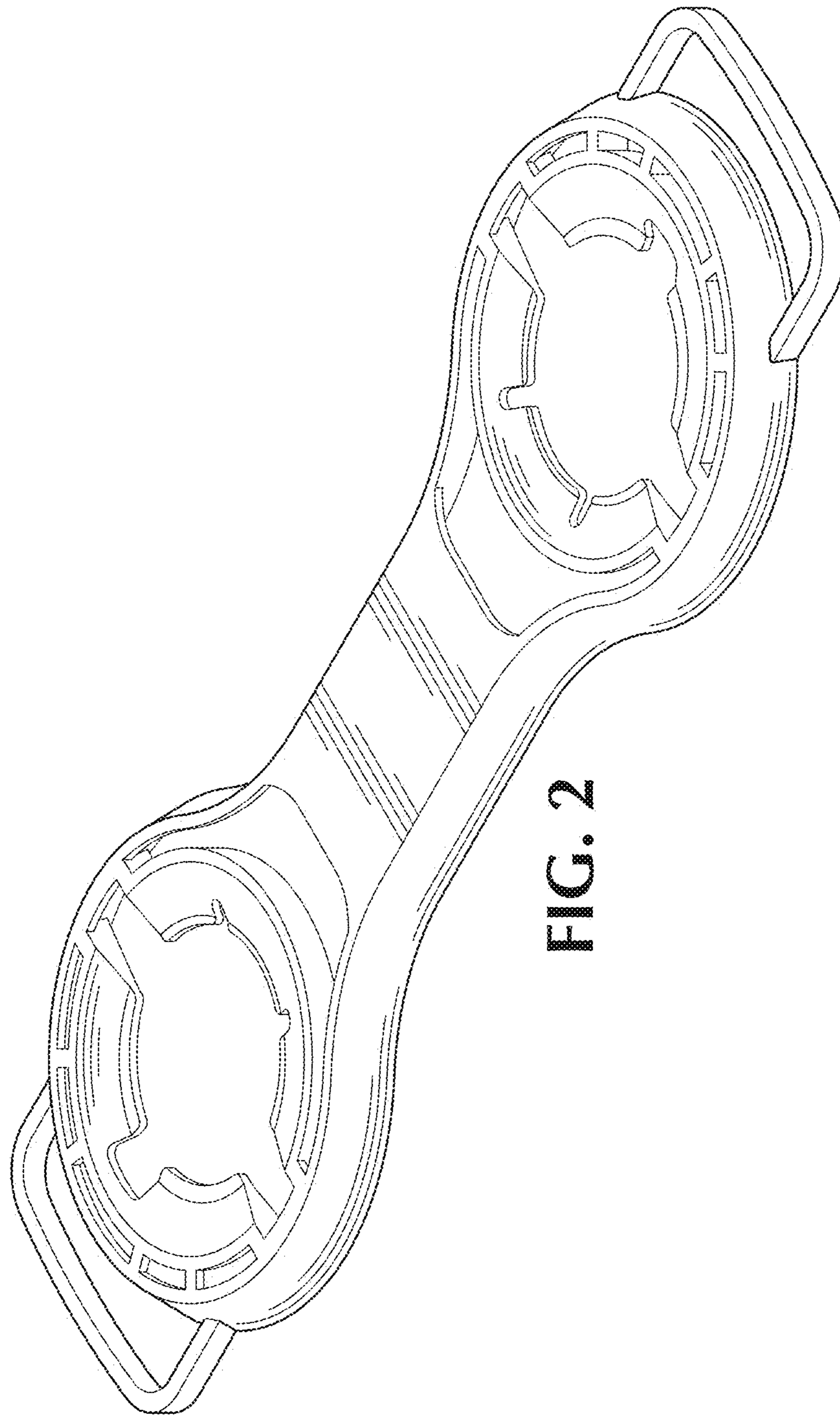

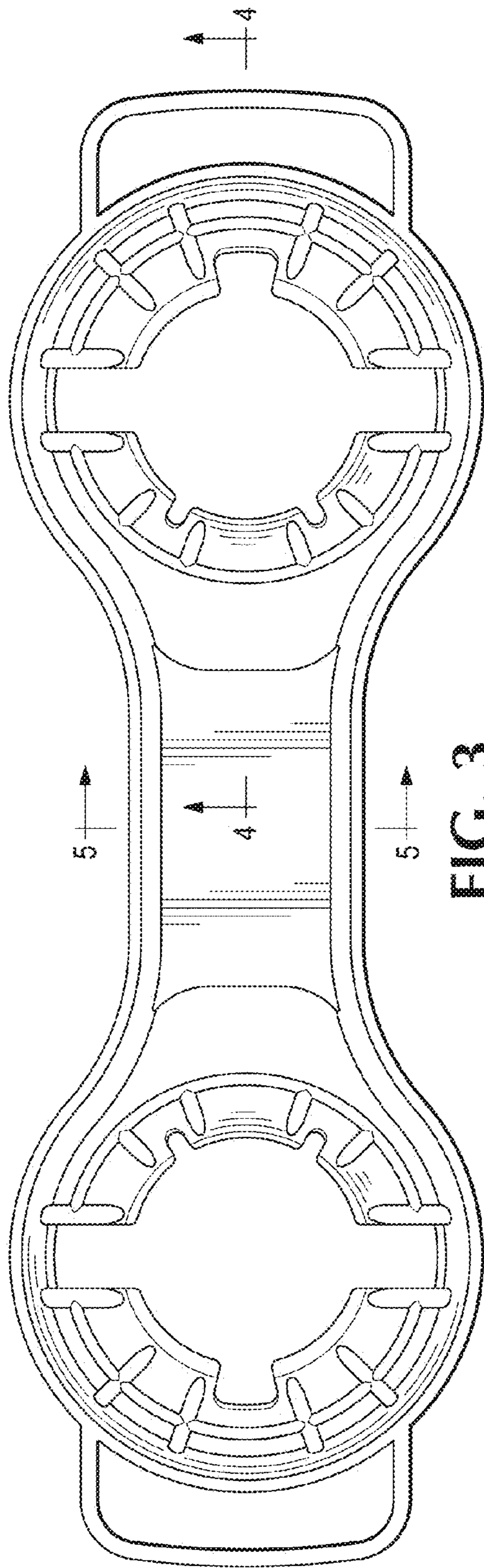

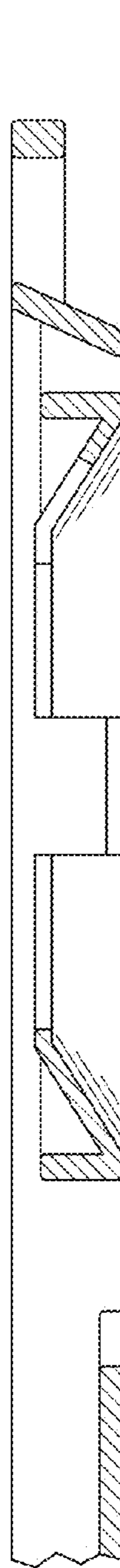

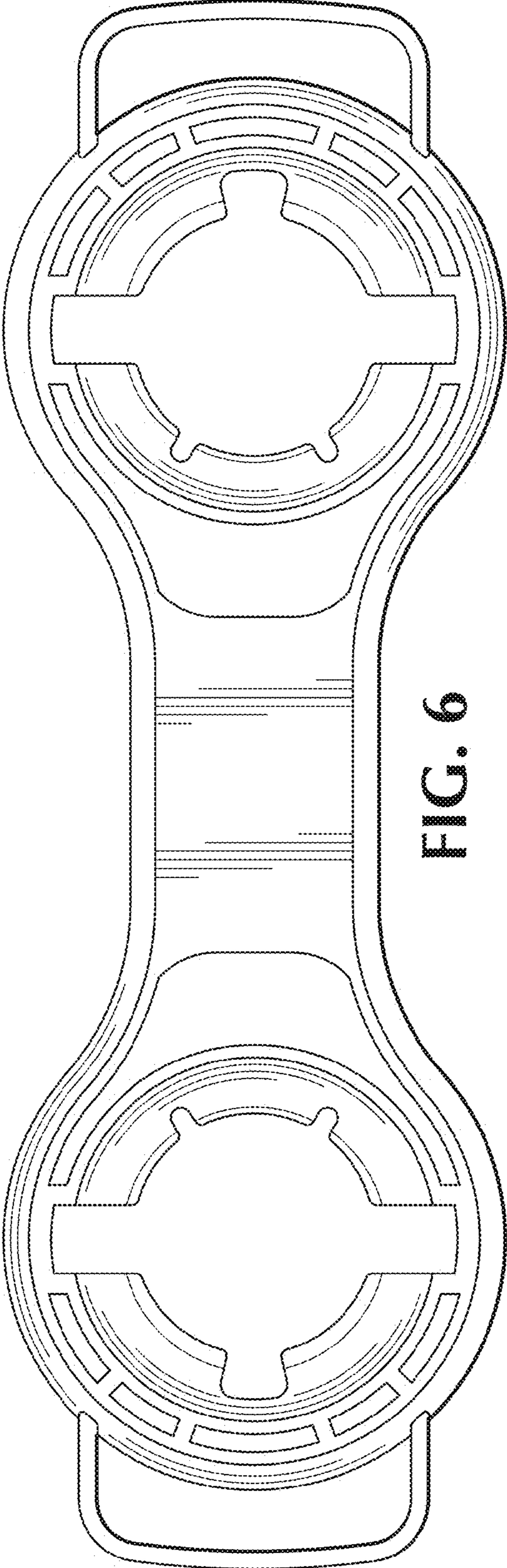

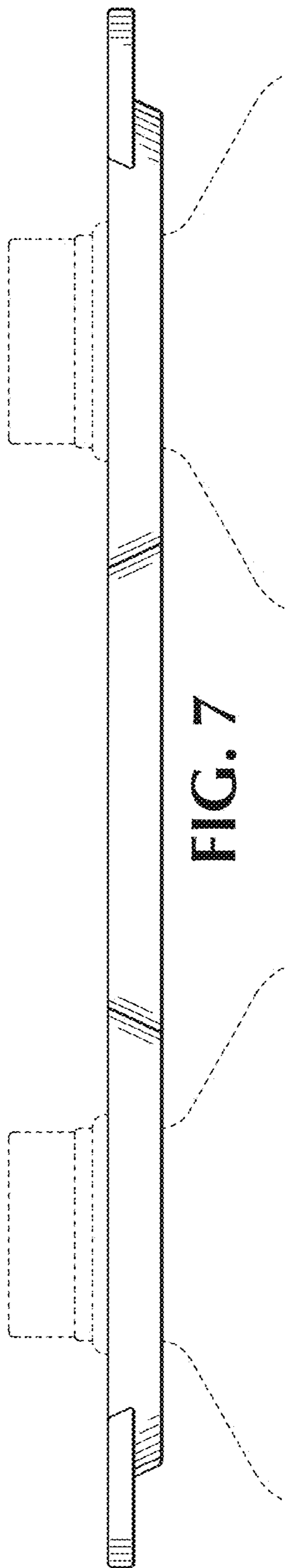
