FIG. 3 is a rear elevation view of the sand jewelry;

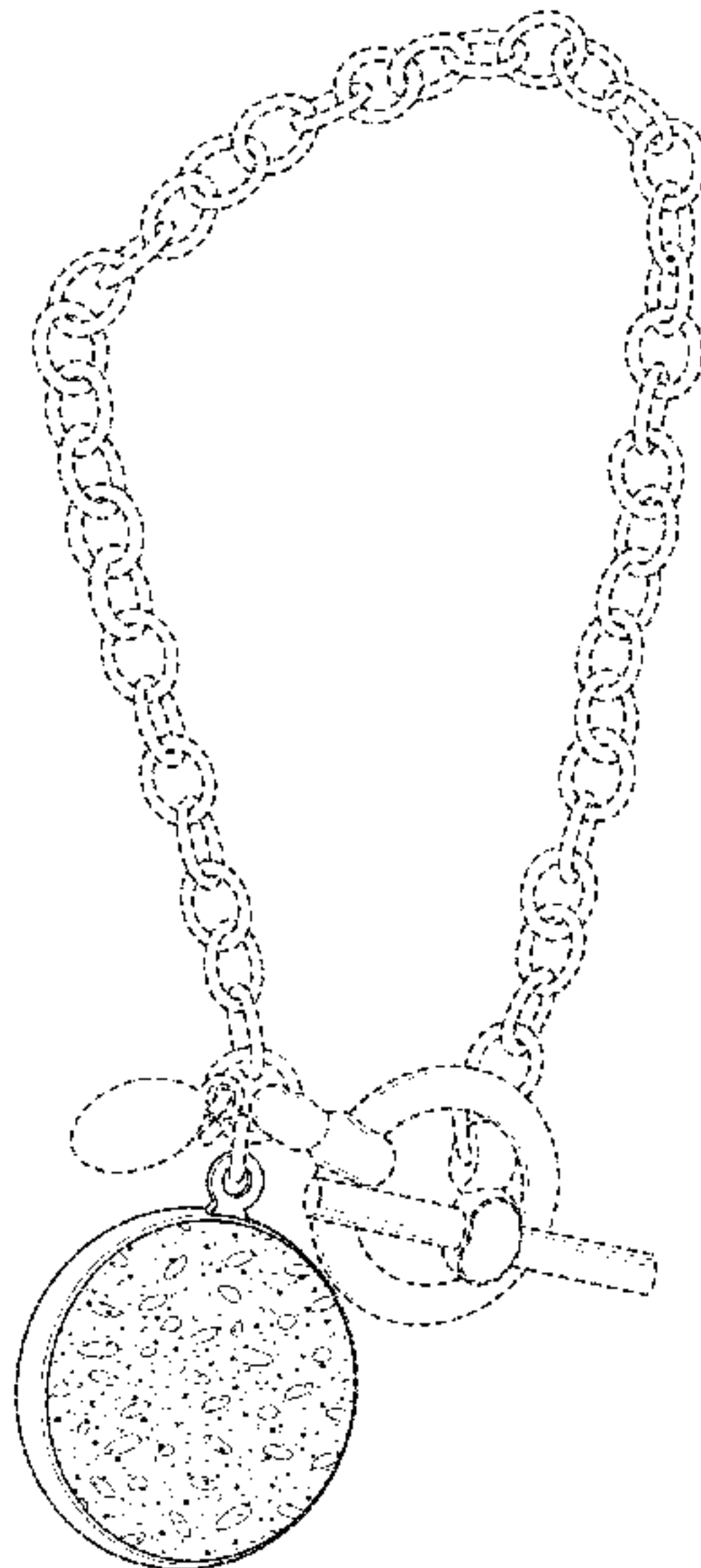
FIG. 4 is a bottom view of the sand jewelry;

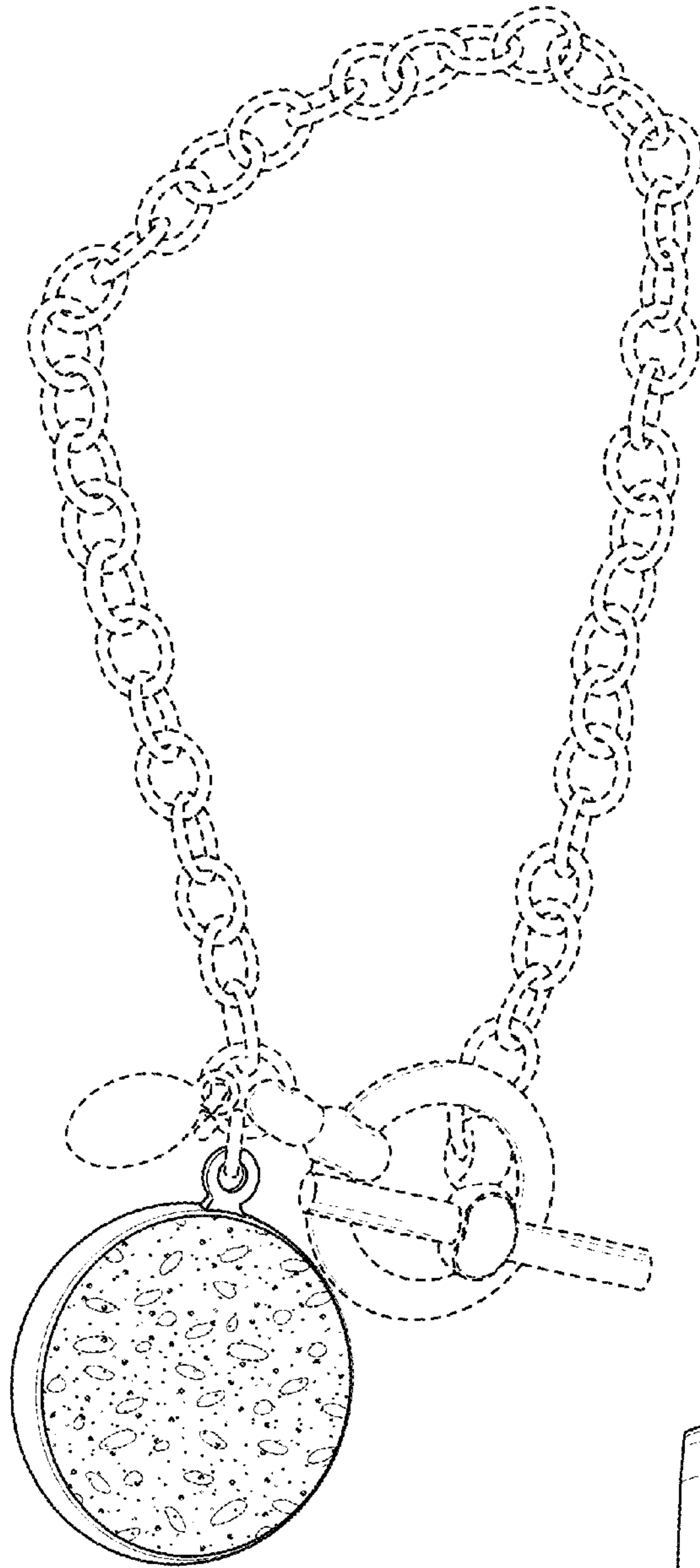

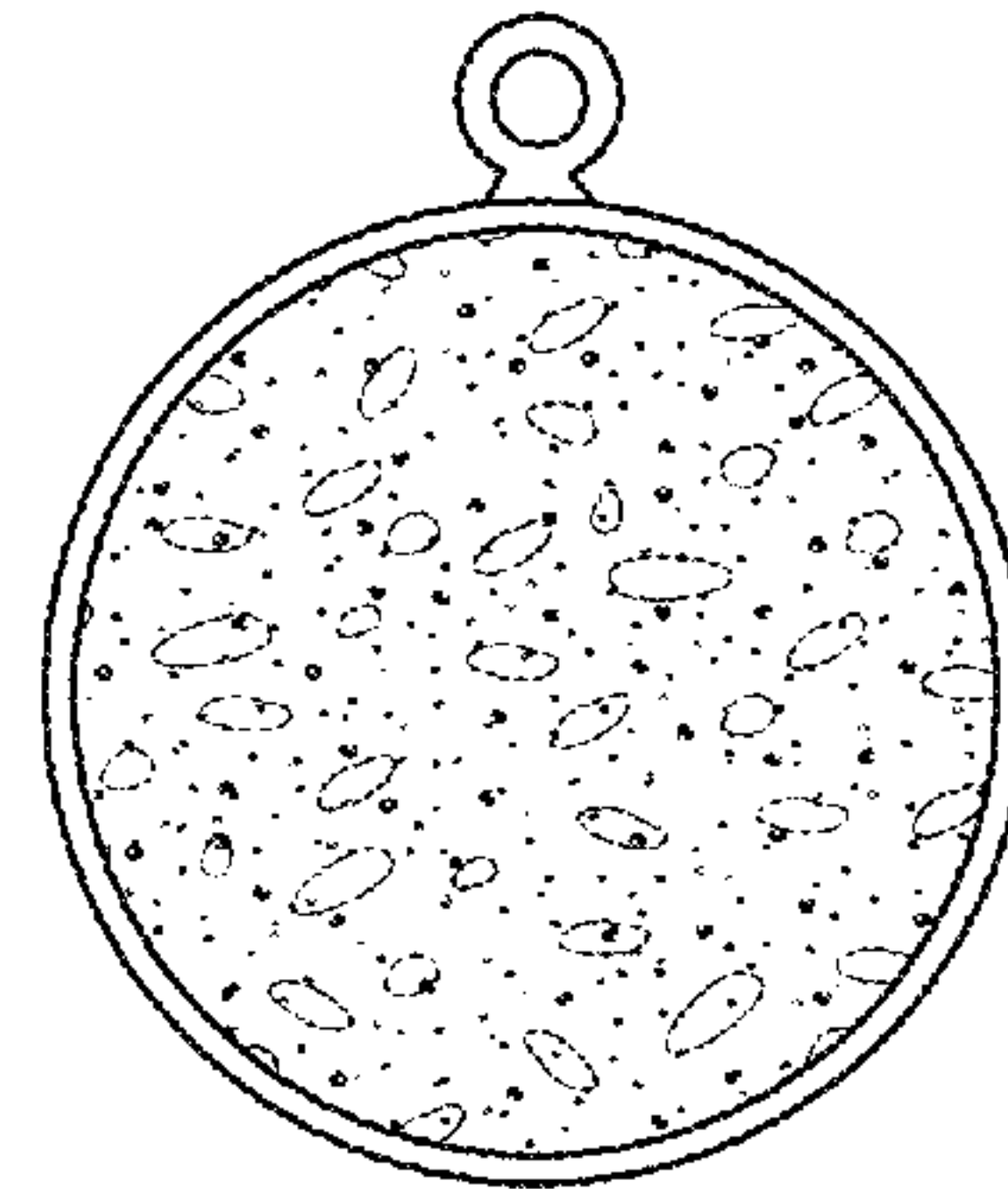

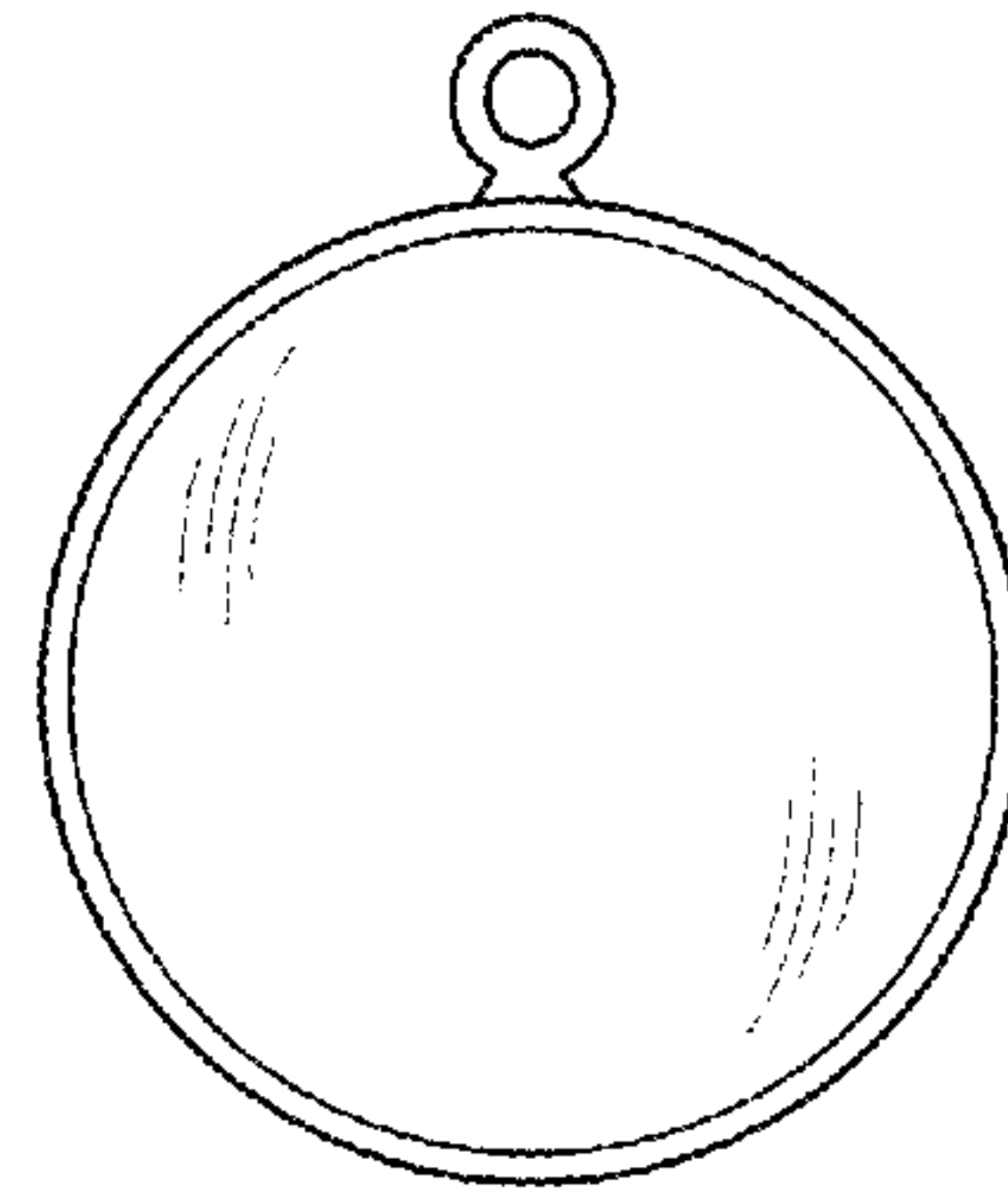

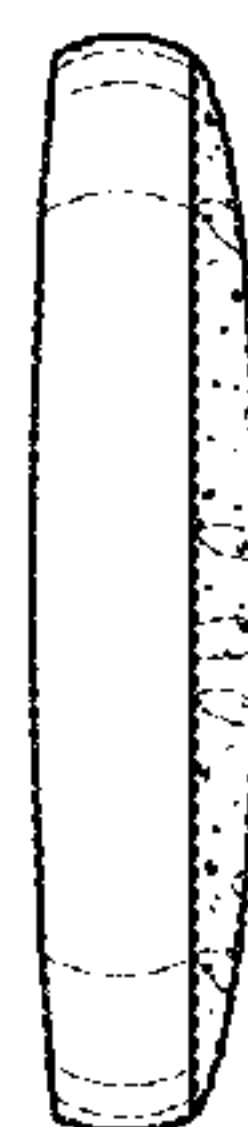
