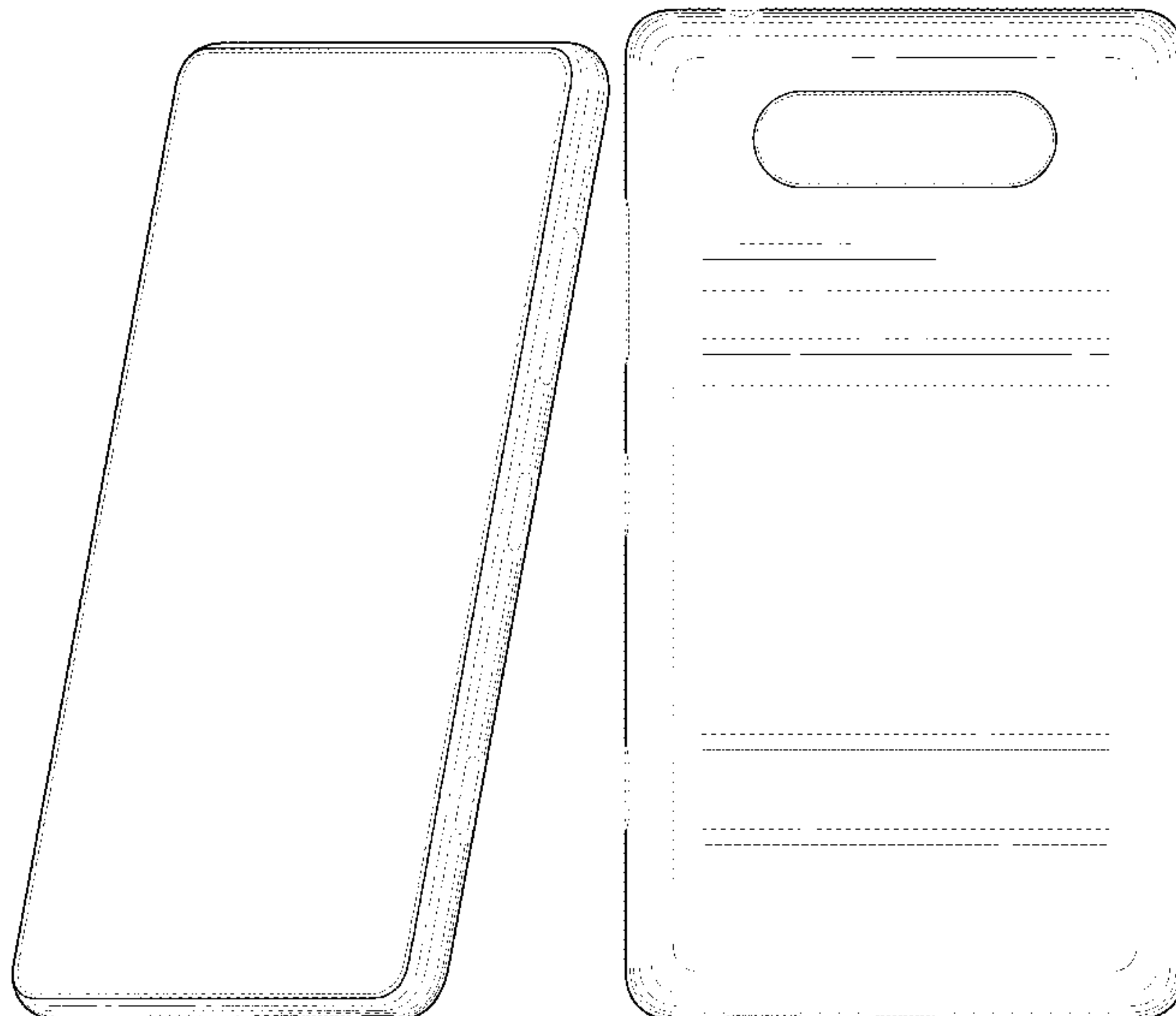
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a handset rear cover showing our new design;

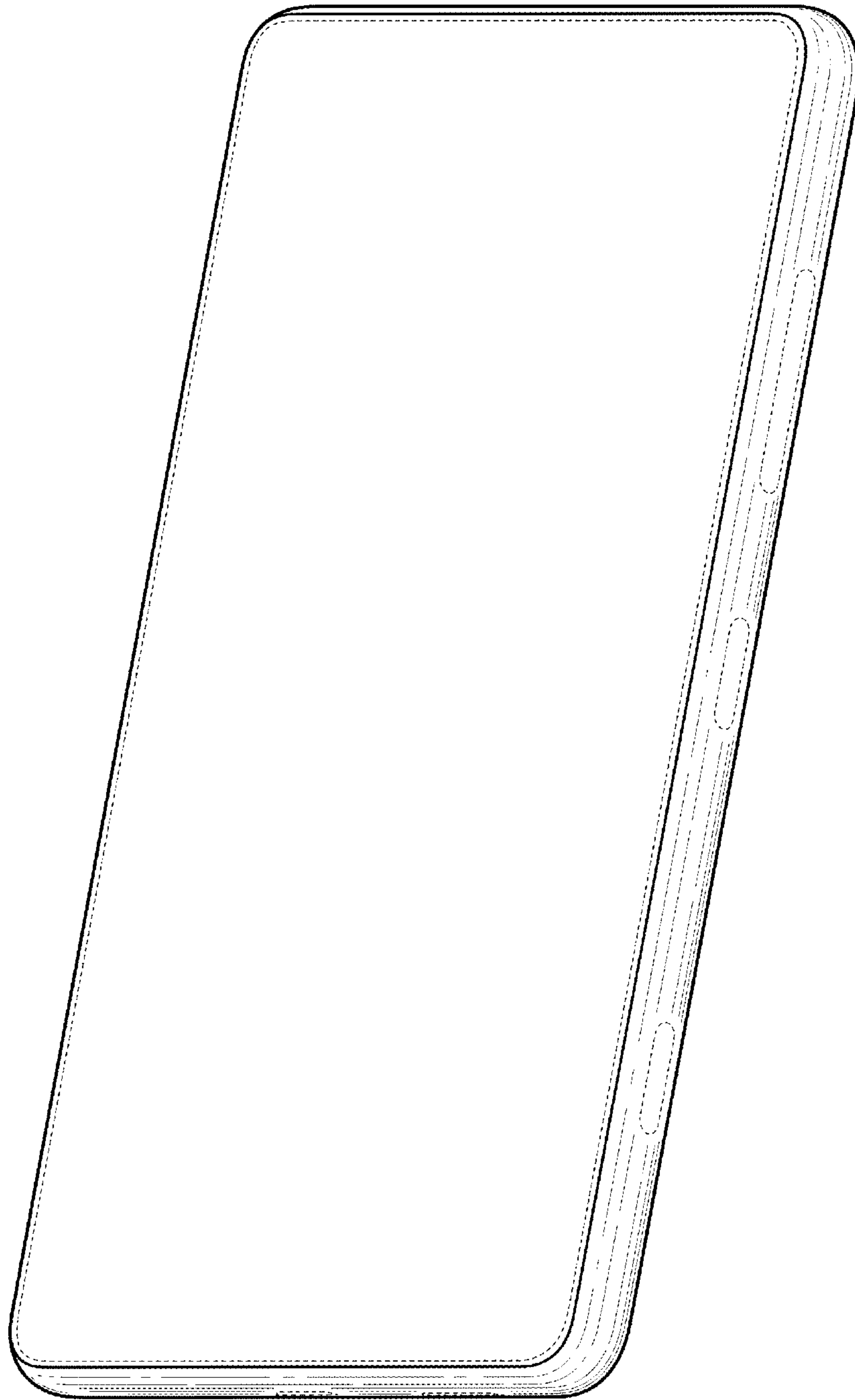

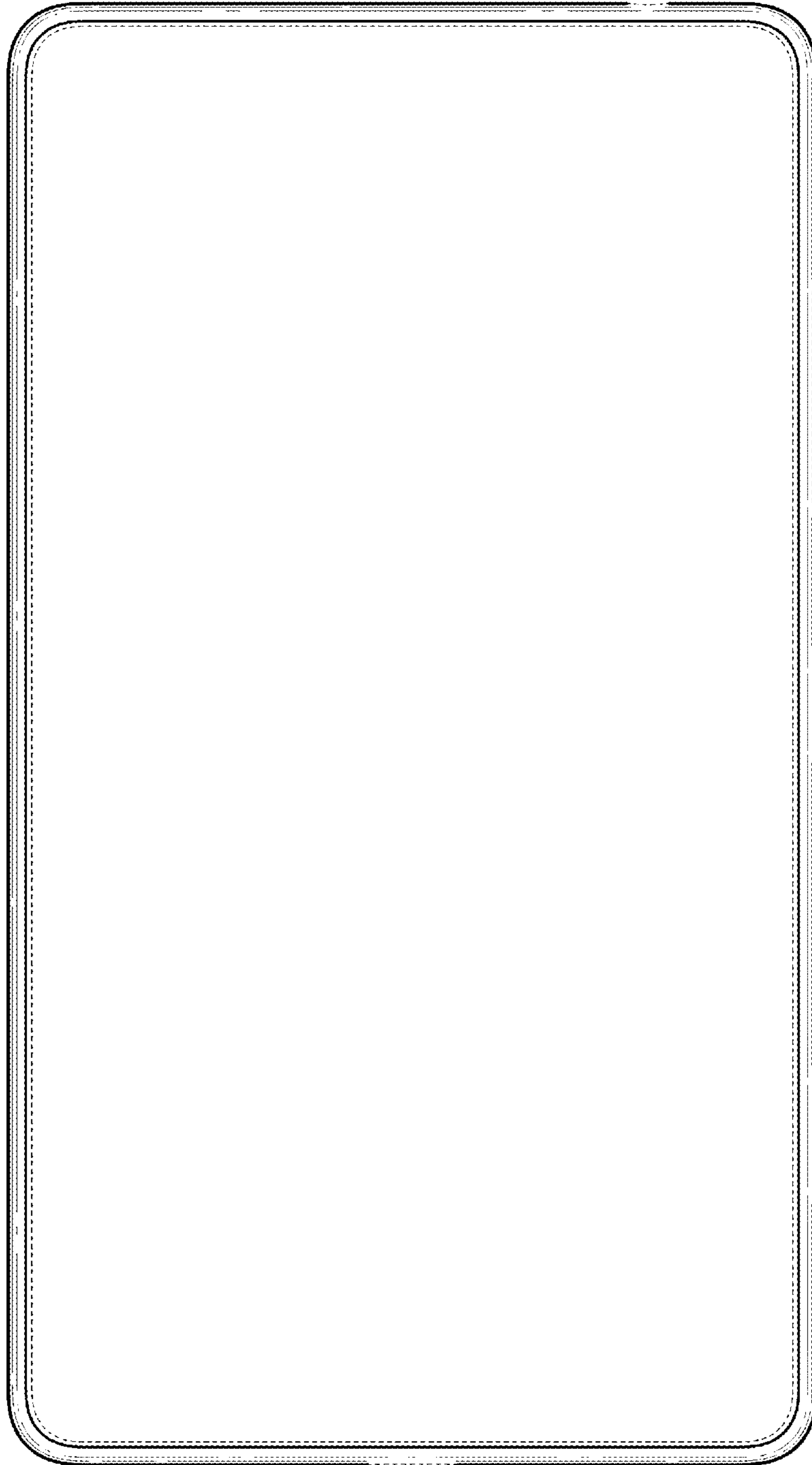

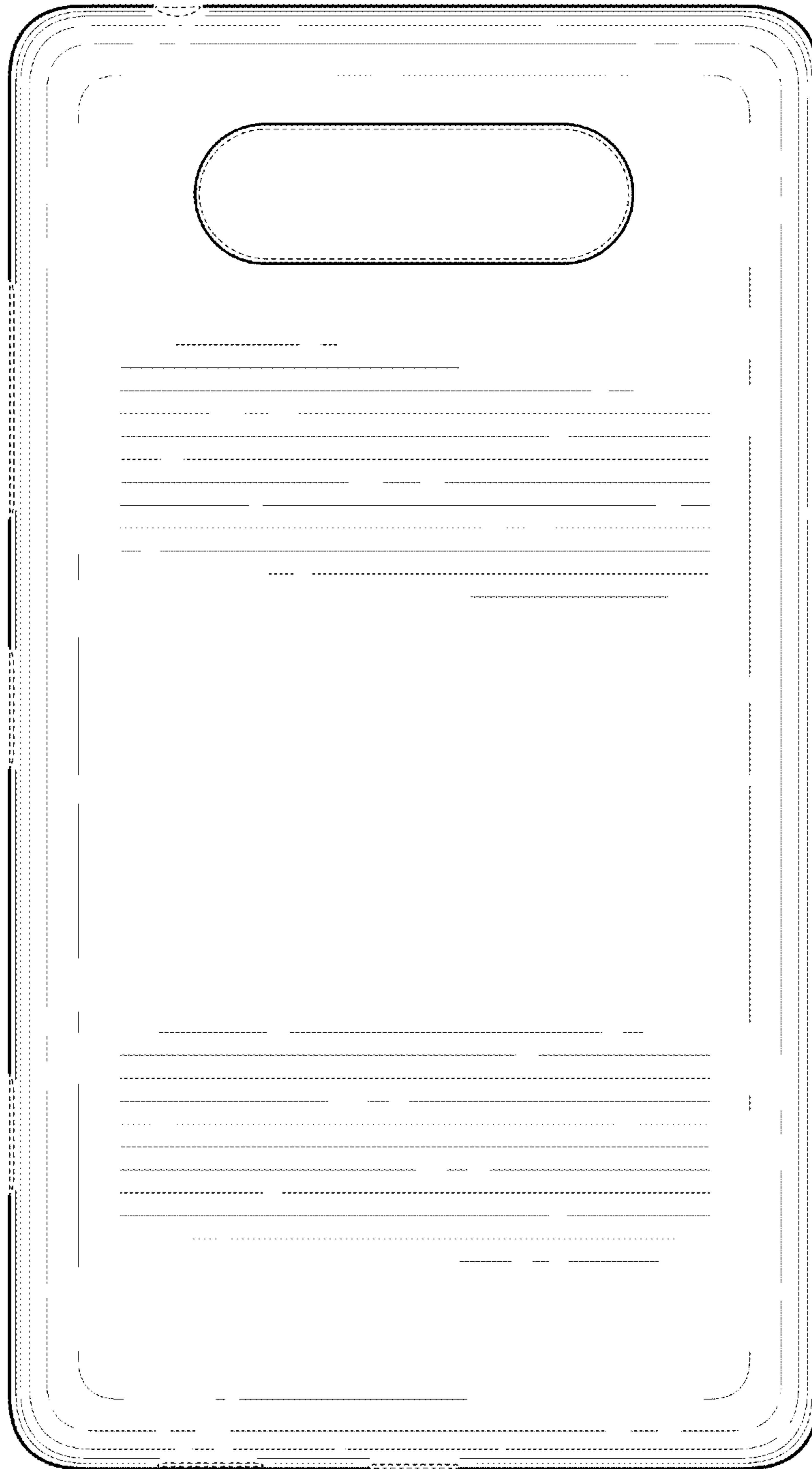

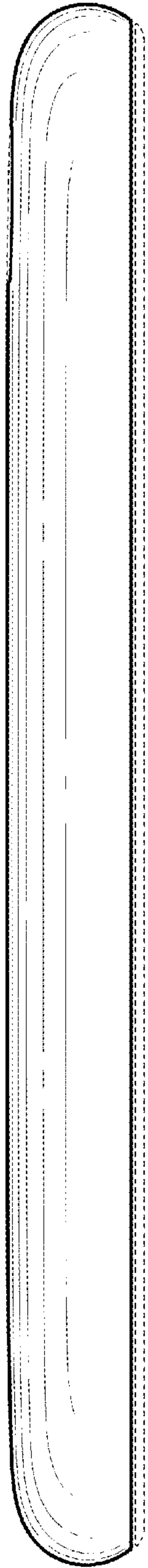

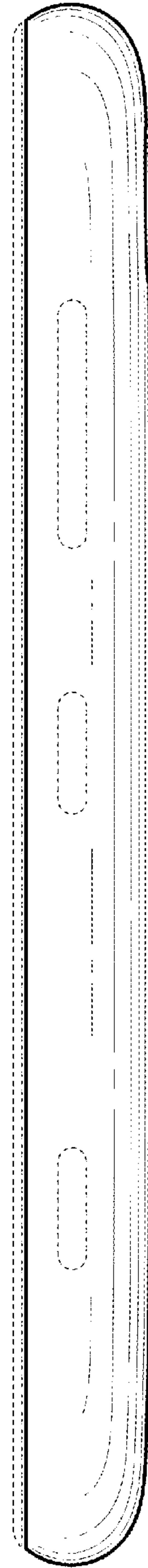

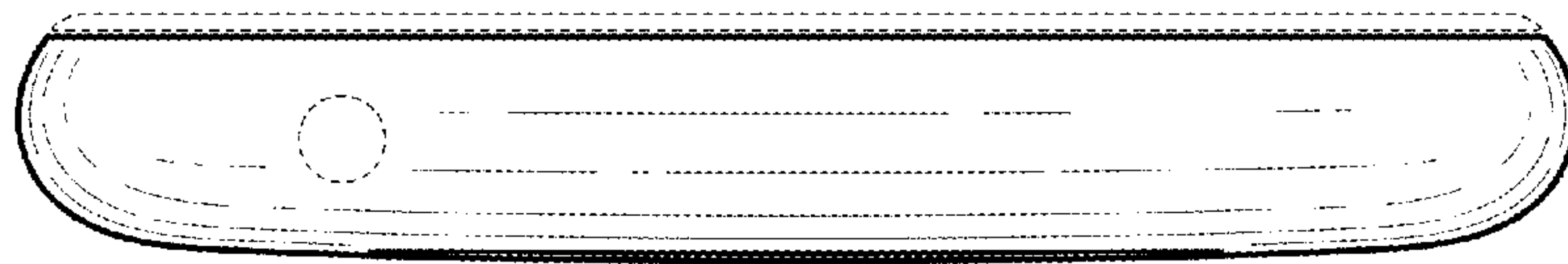

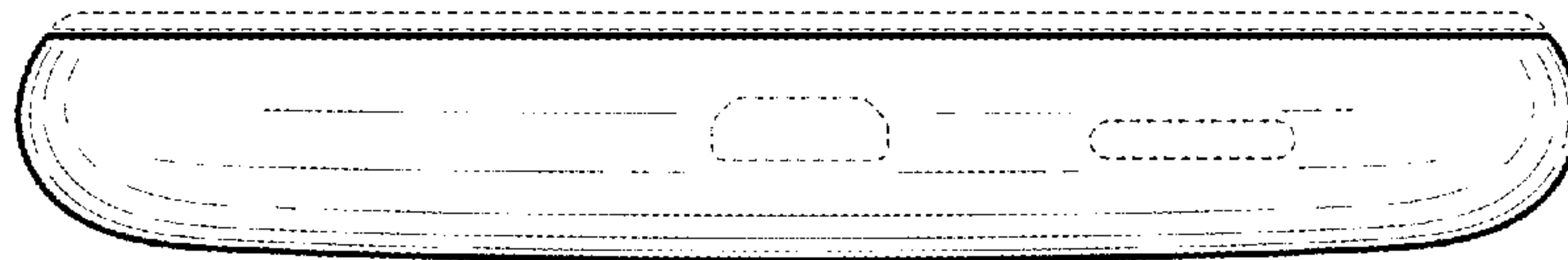
