**DESCRIPTION**

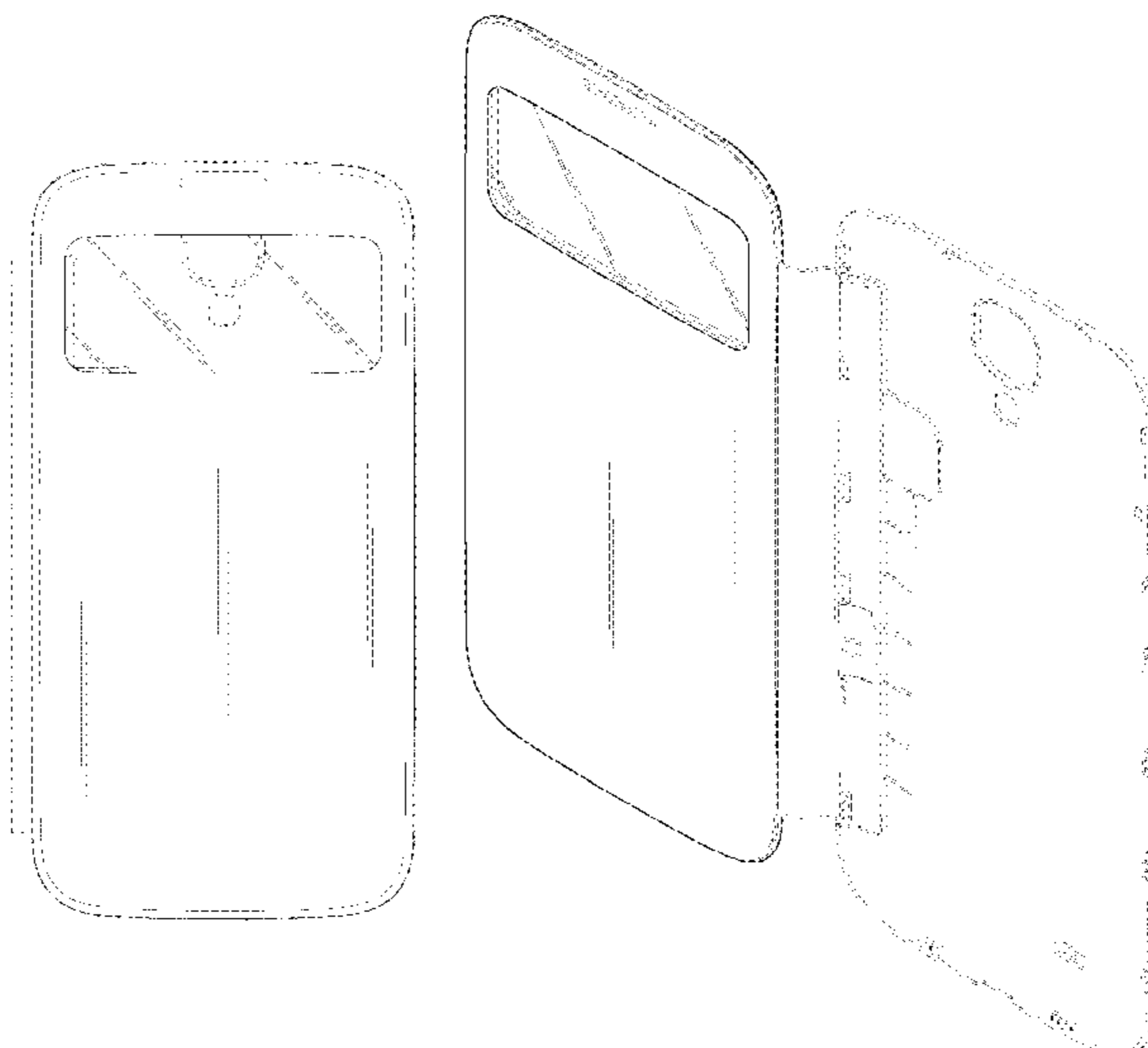
FIG. 1 is a front perspective view of a case for electronic device showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of the case for an electronic device in an open state showing the exterior thereof; and, FIG. 9 is a perspective view of the case for an electronic device in an open state showing the interior thereof. The dash-dot broken lines represent the bounds of the claimed design while all other broken lines depict unclaimed environment; the broken lines form no part of the claimed design.

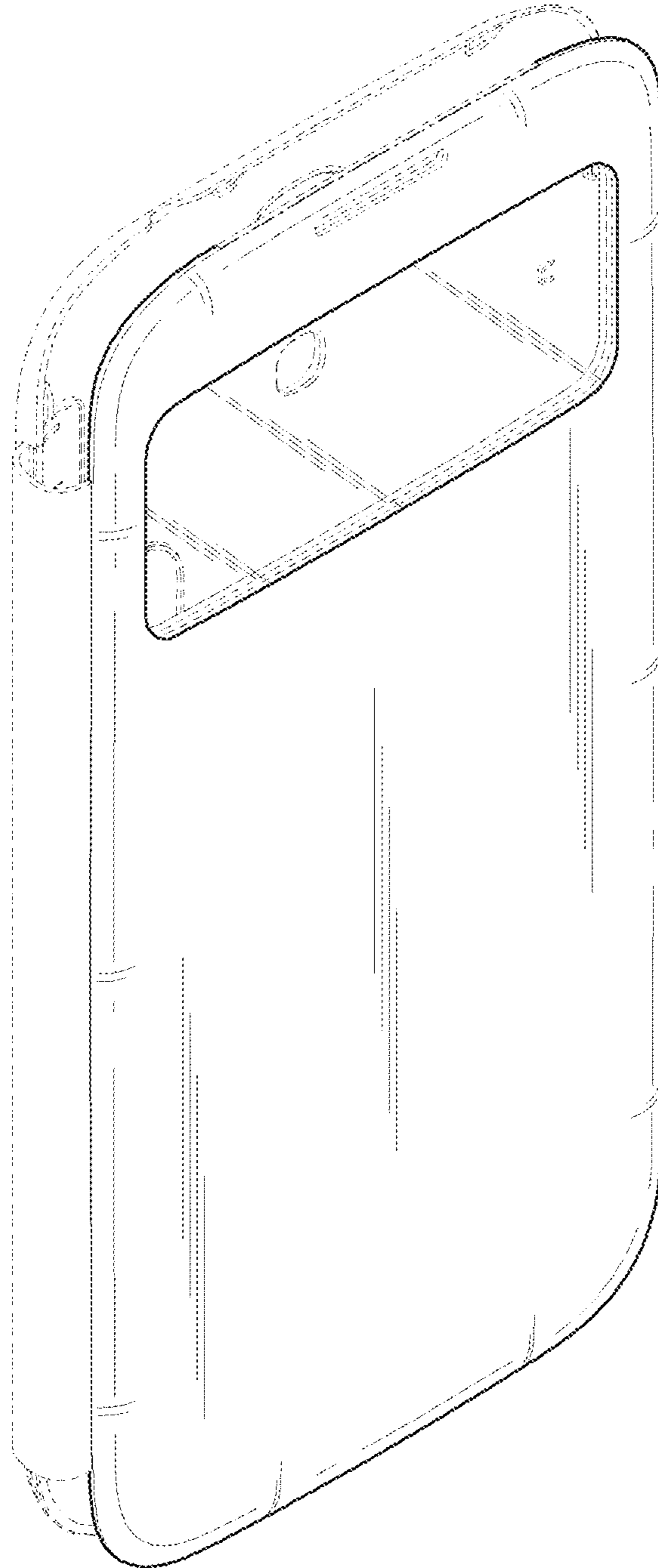

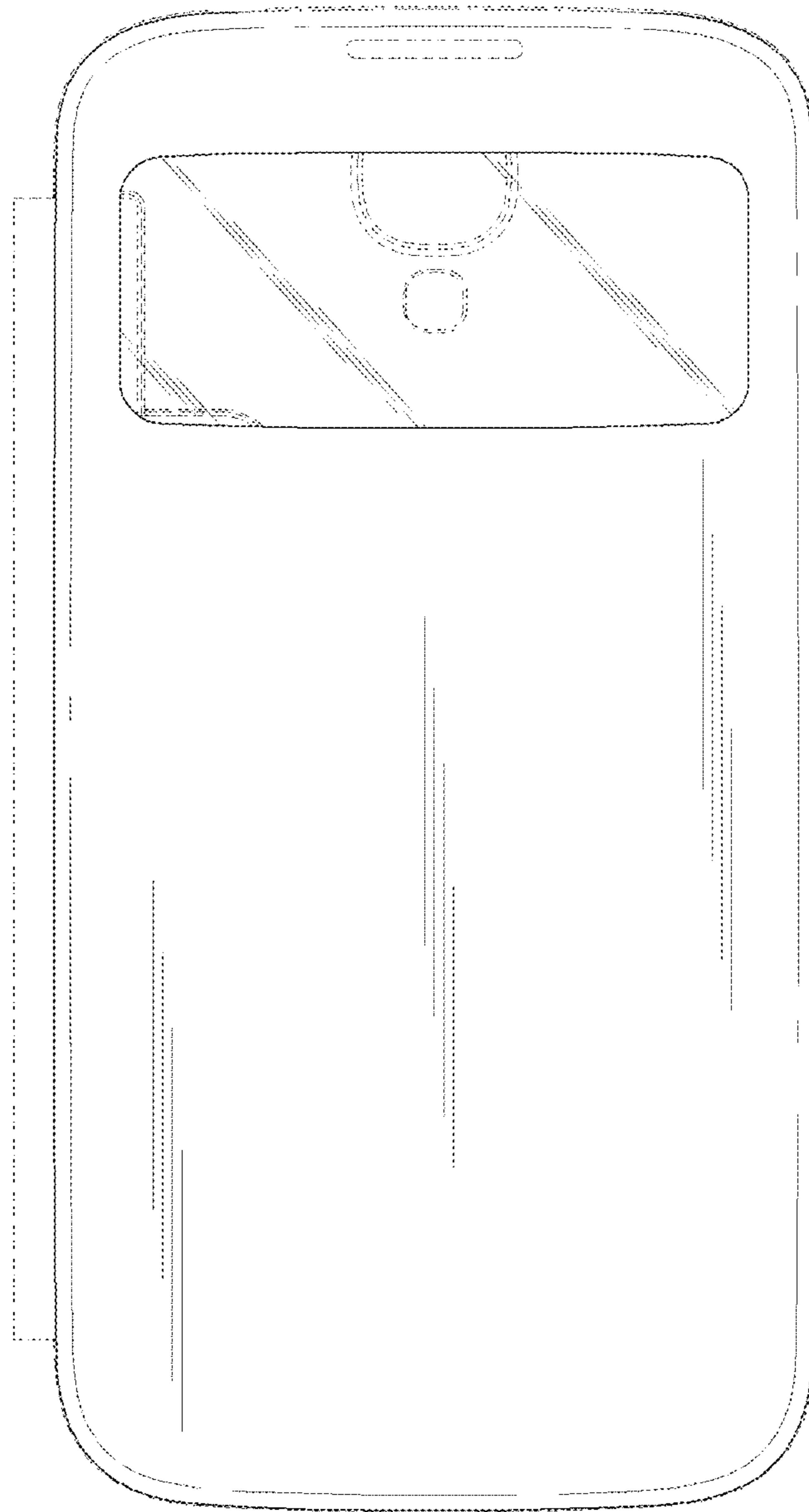

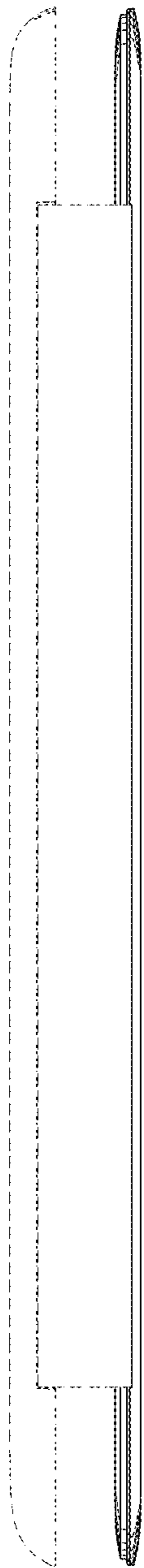

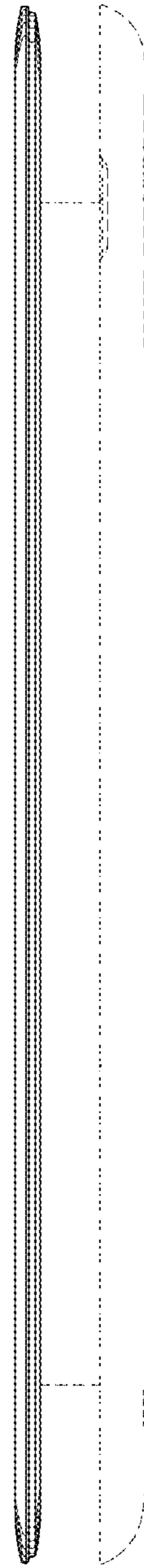

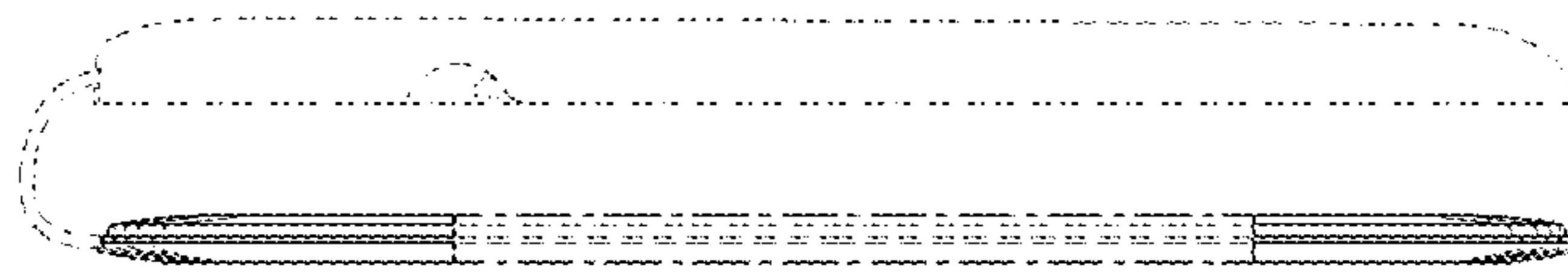

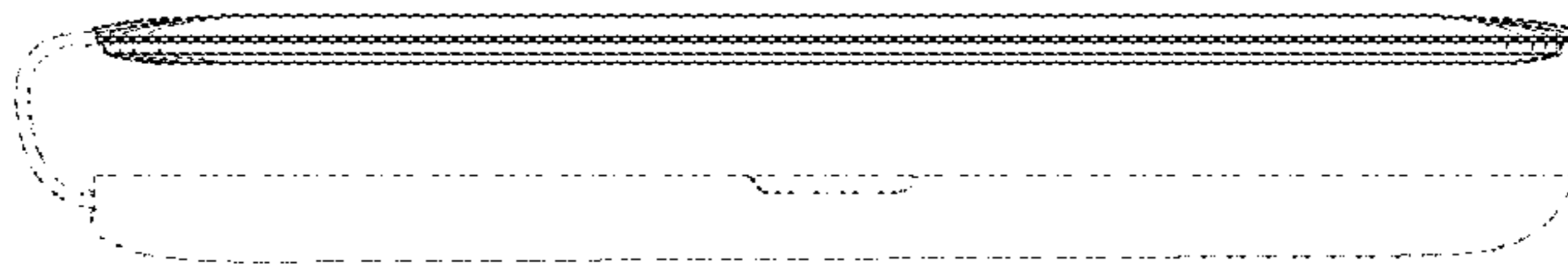

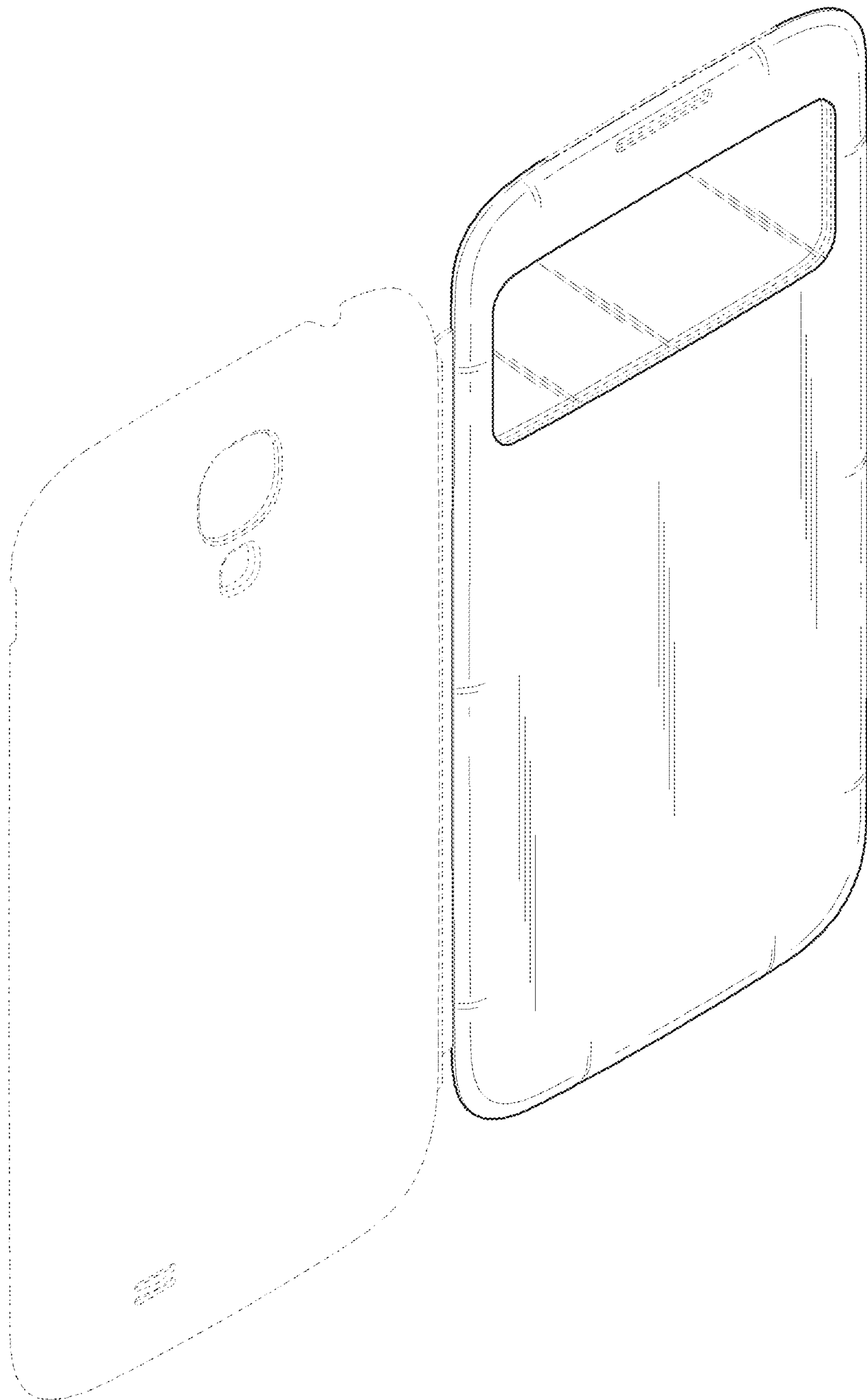
