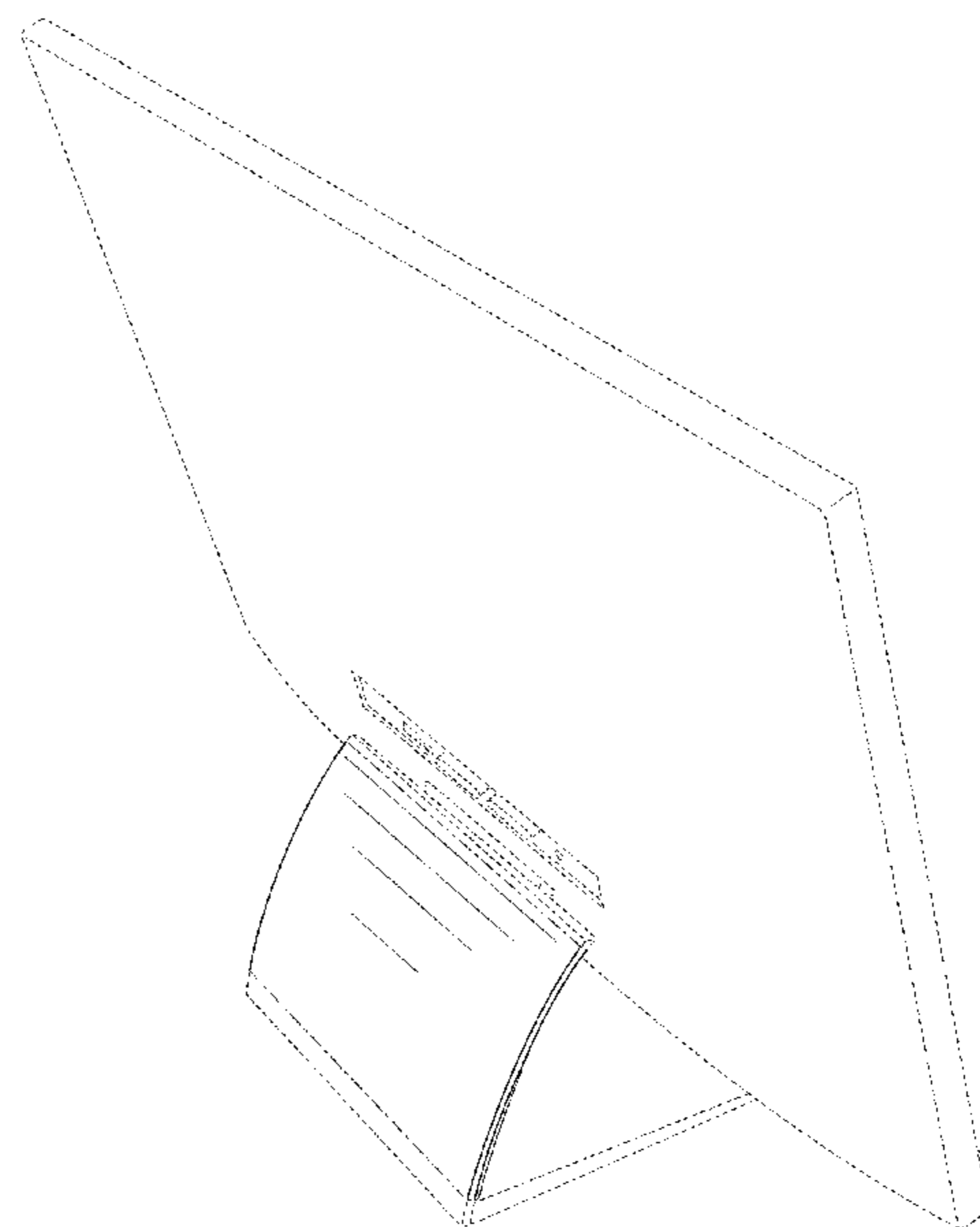
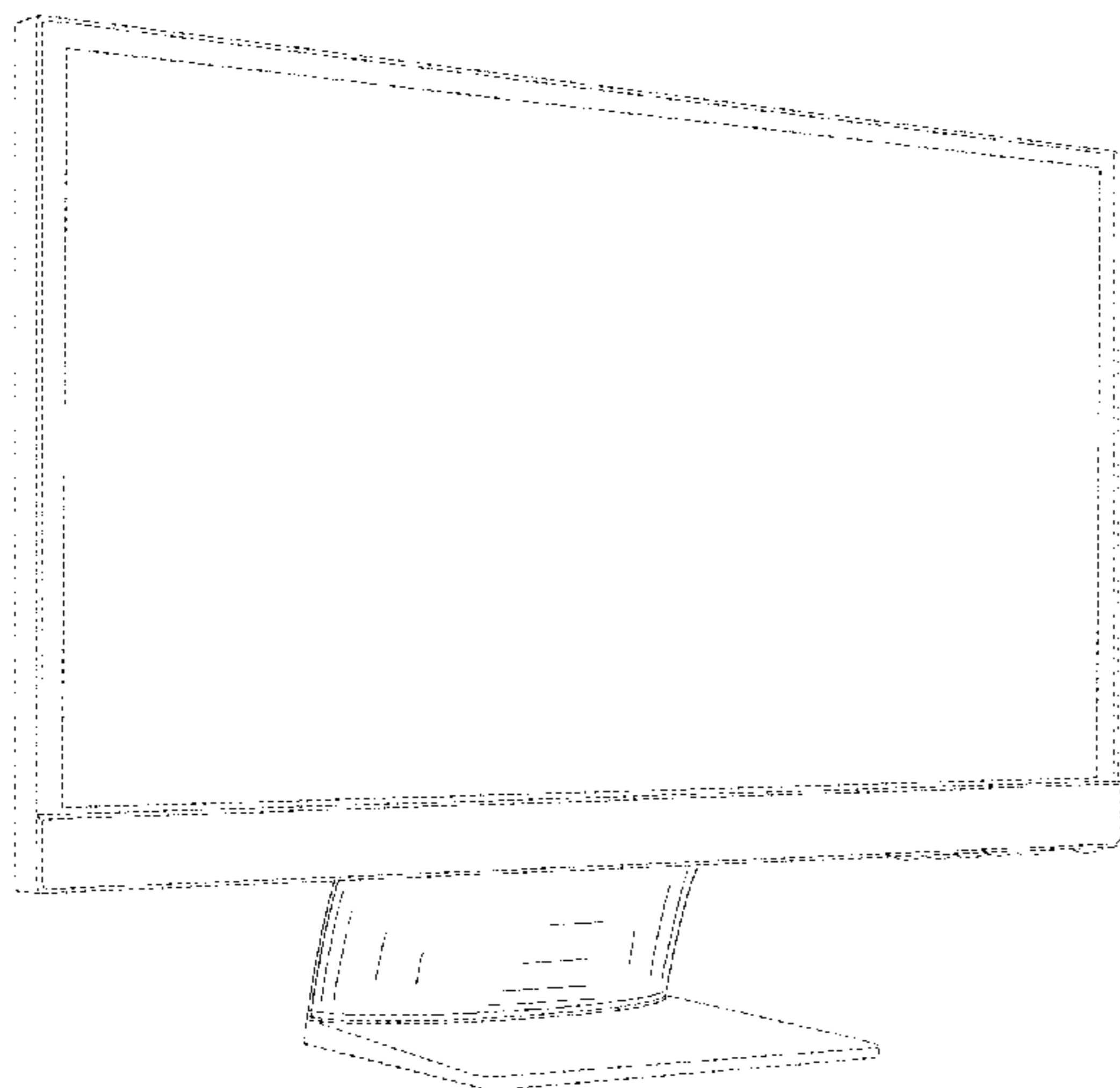
(57) **CLAIM**

We claim the ornamental design for a display, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a display;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a left side view thereof; and,  
FIG. 7 is a right side view thereof.  
The dash-dash broken lines in FIGS. 1-7 illustrate portions of the display that form no part of the claimed design. The short dash-long dash broken lines in FIGS. 1-7 illustrate boundary lines which form no part of the claimed design.

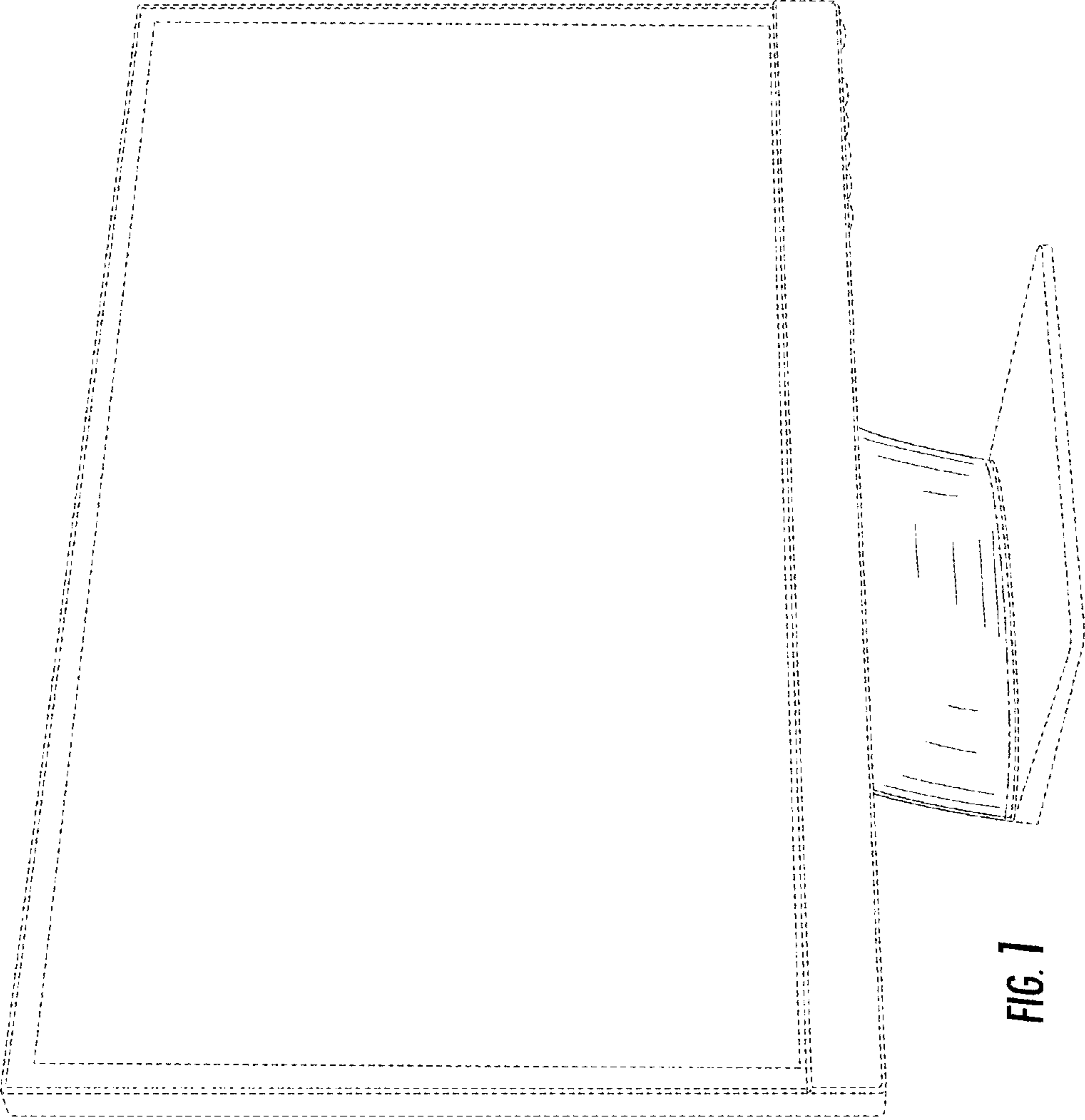

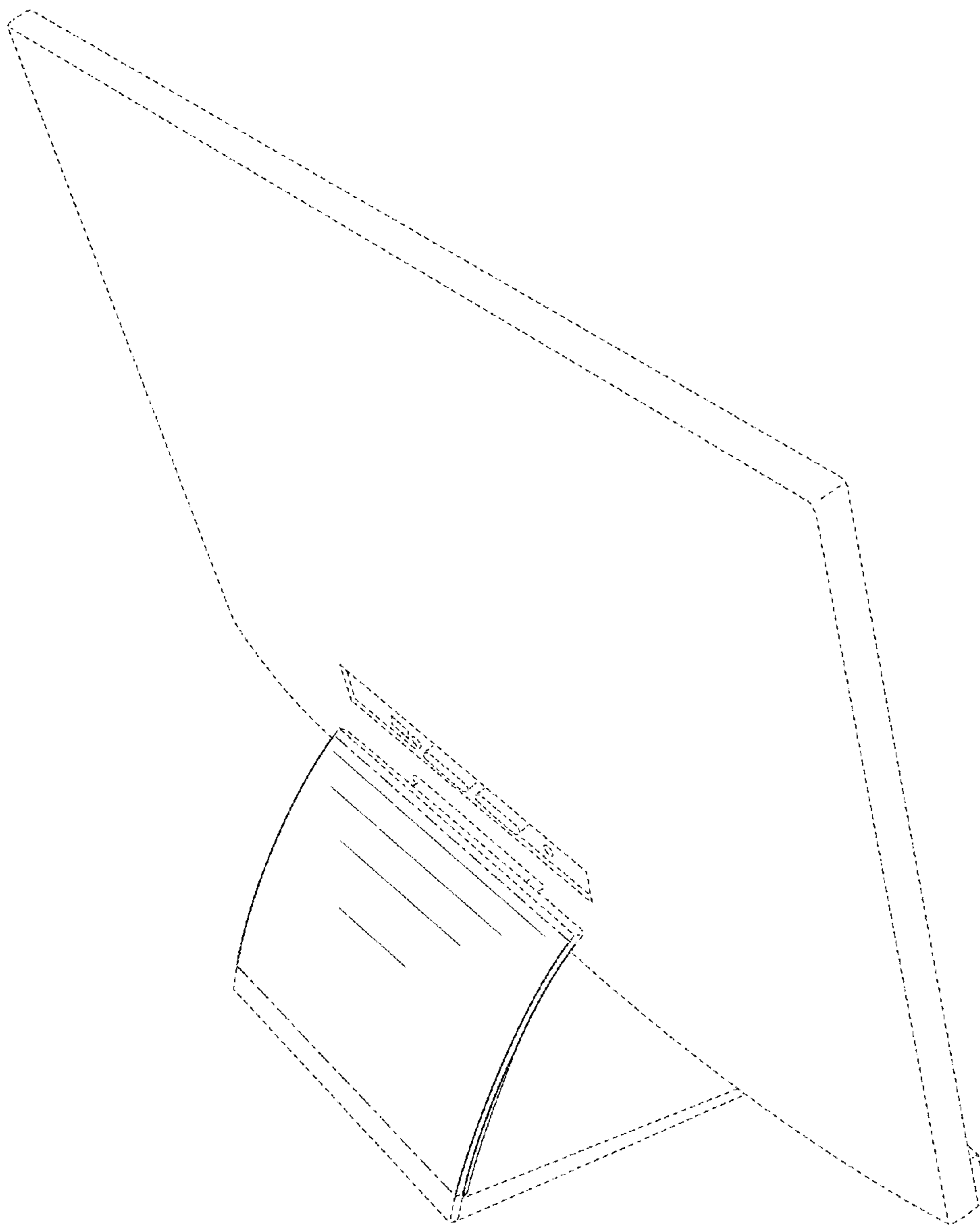

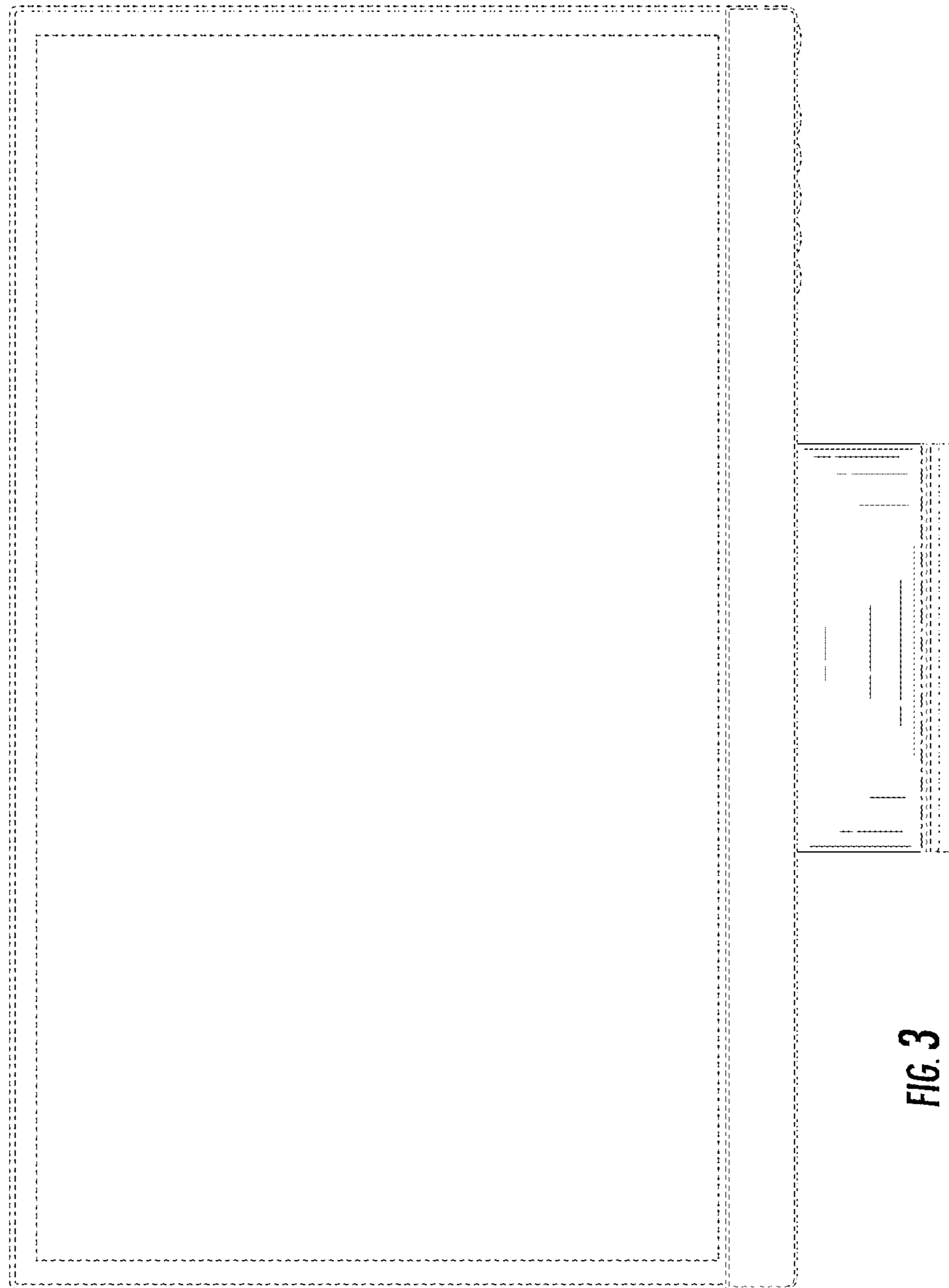

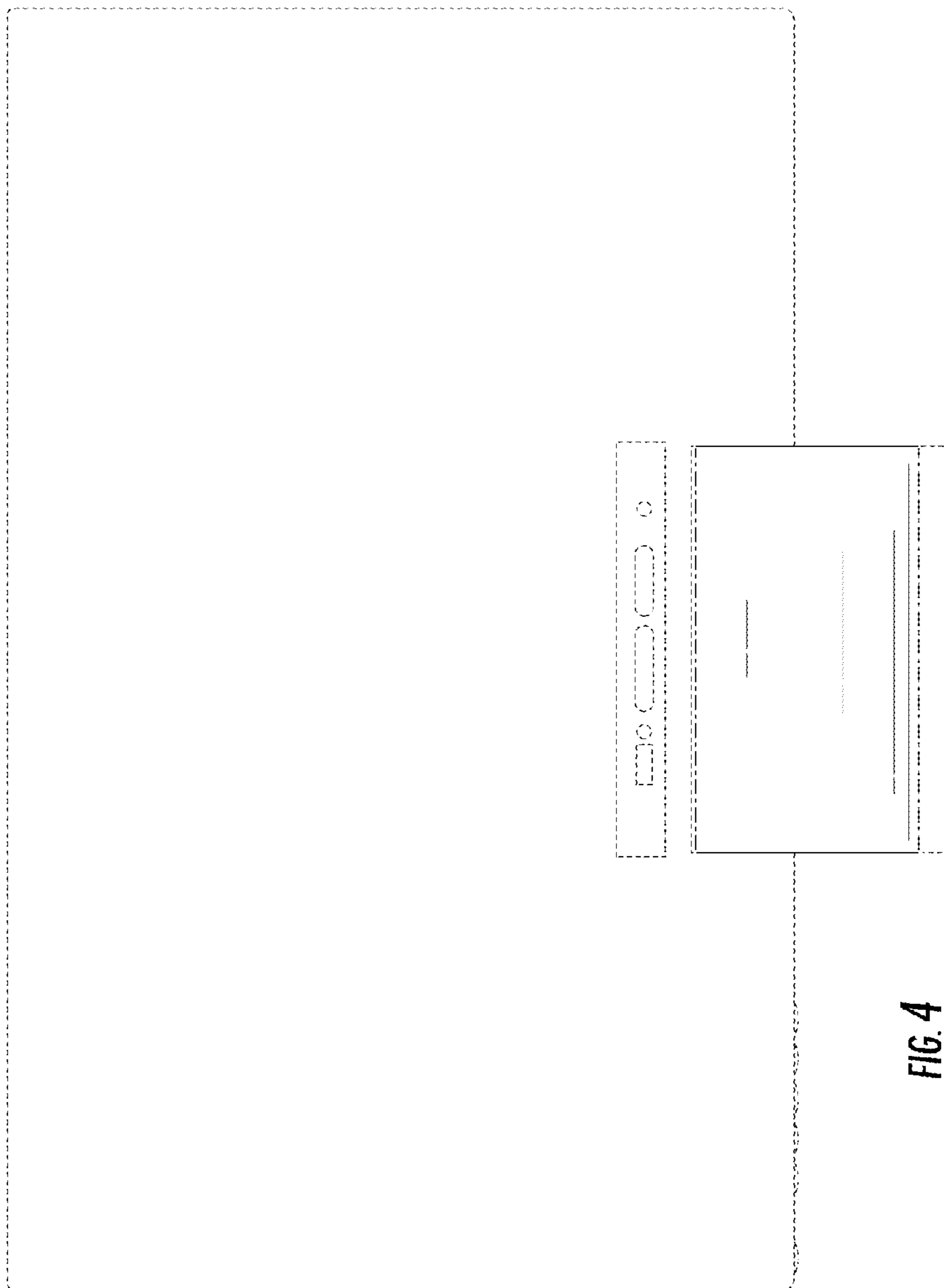

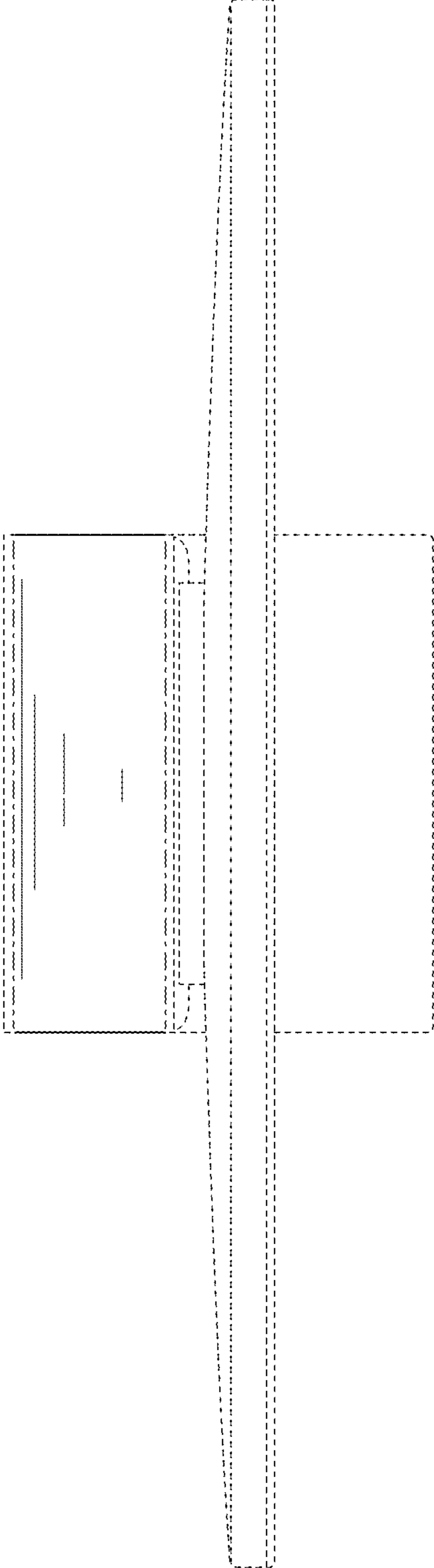
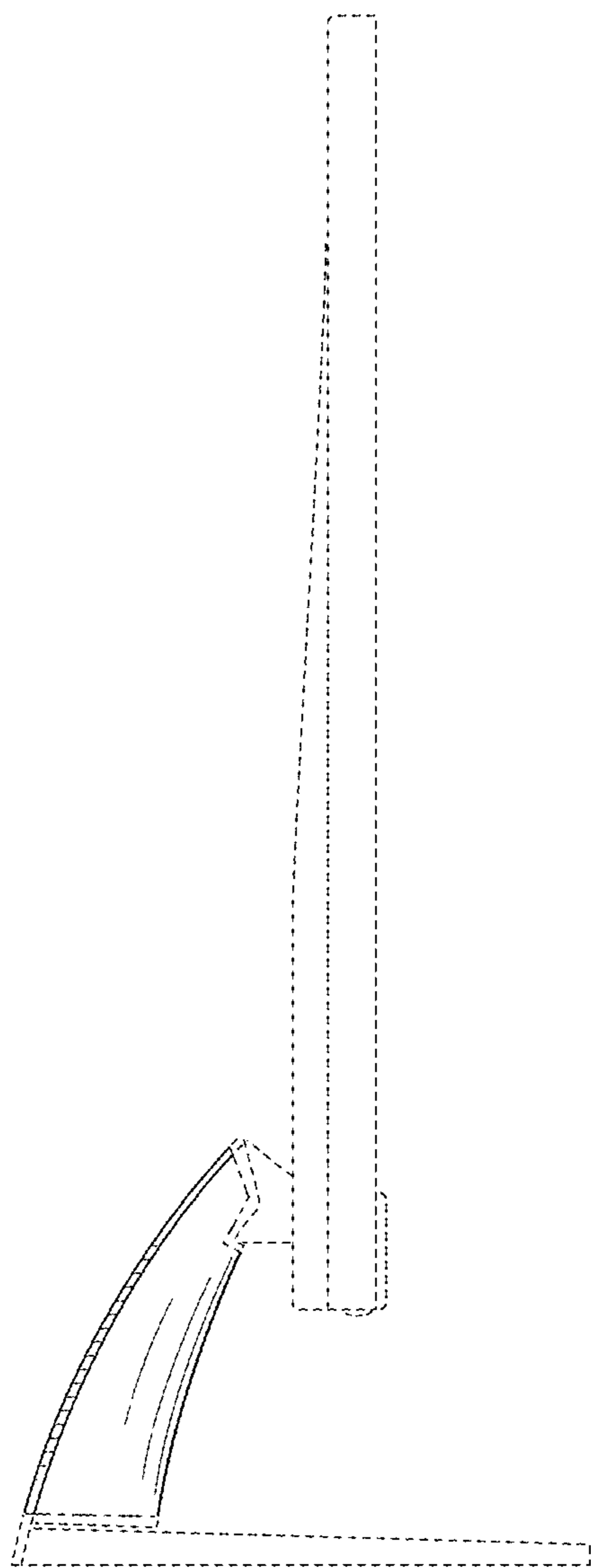
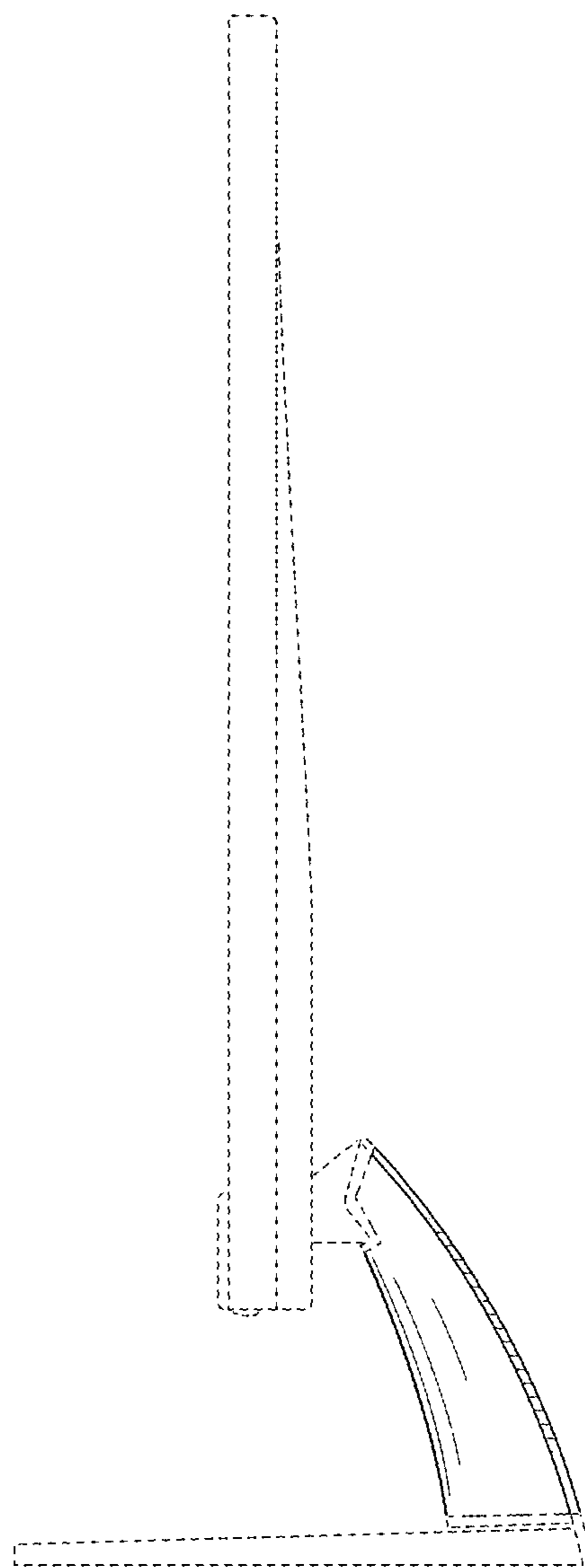
