FIG. 8 is an enlarged perspective view thereof along the lines 8-8 and 8'-8' of FIG. 6.

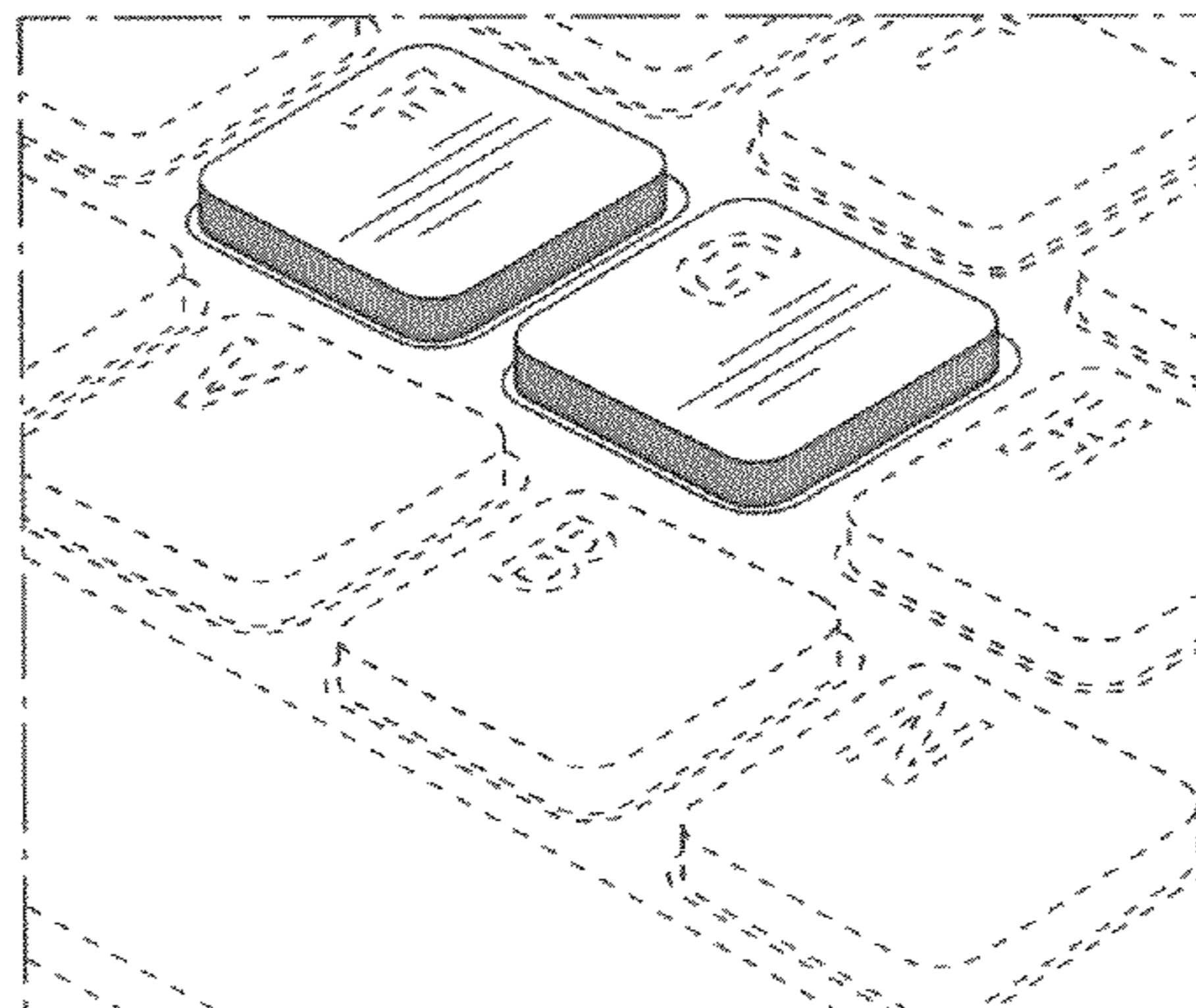


FIG. 9 is an enlarged top plan view thereof along the lines 9-9 and 9'-9' of FIG. 7.

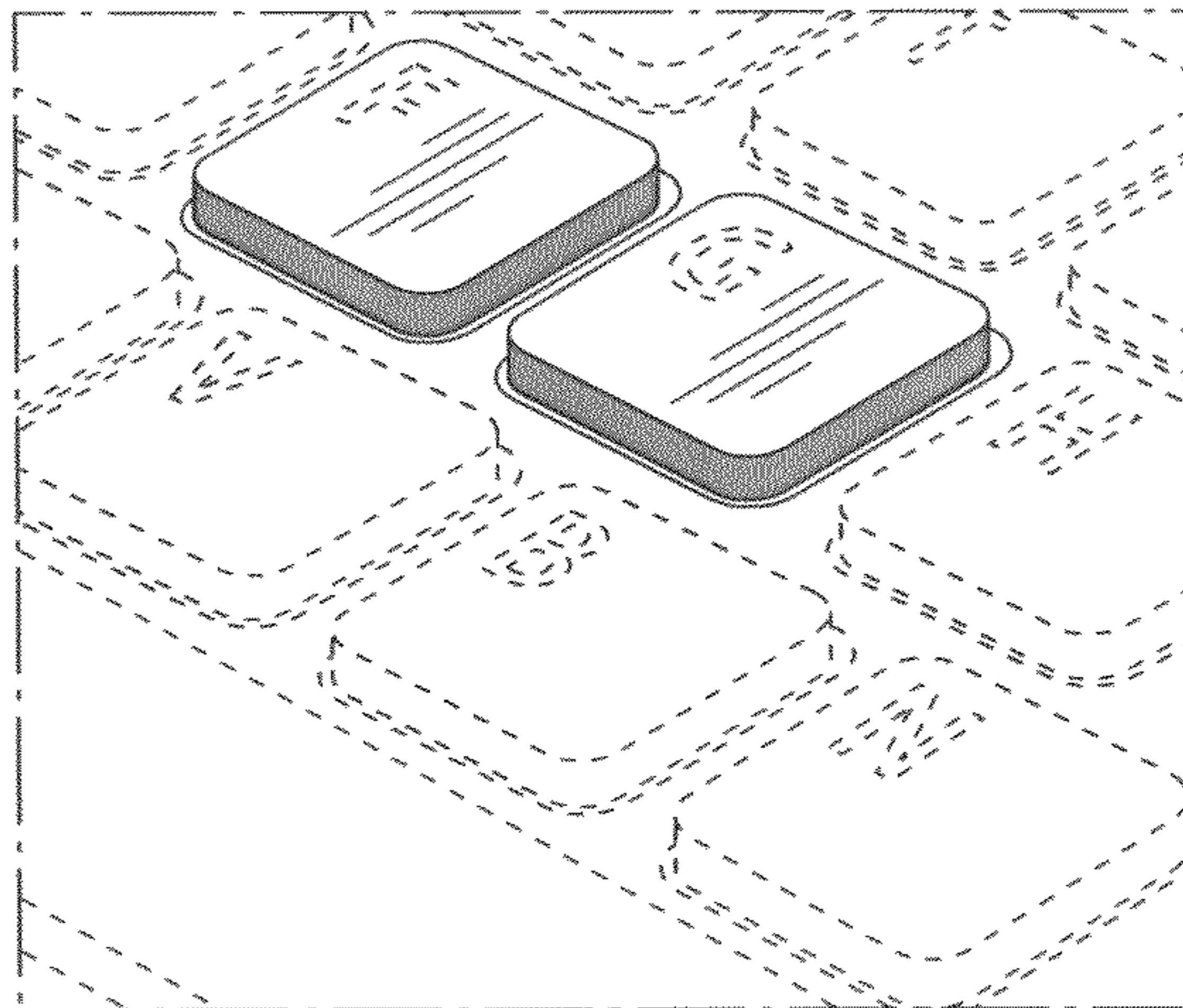

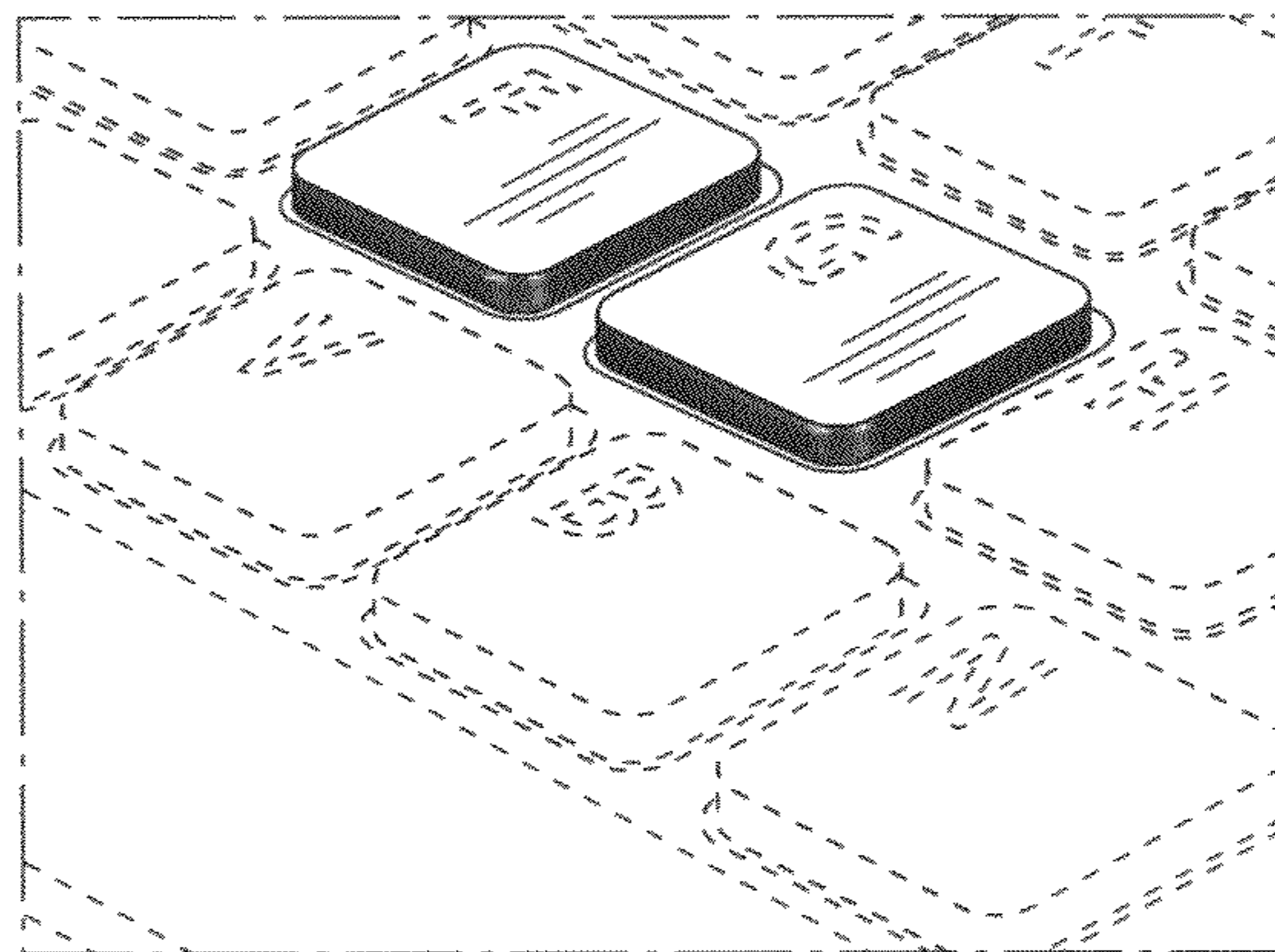

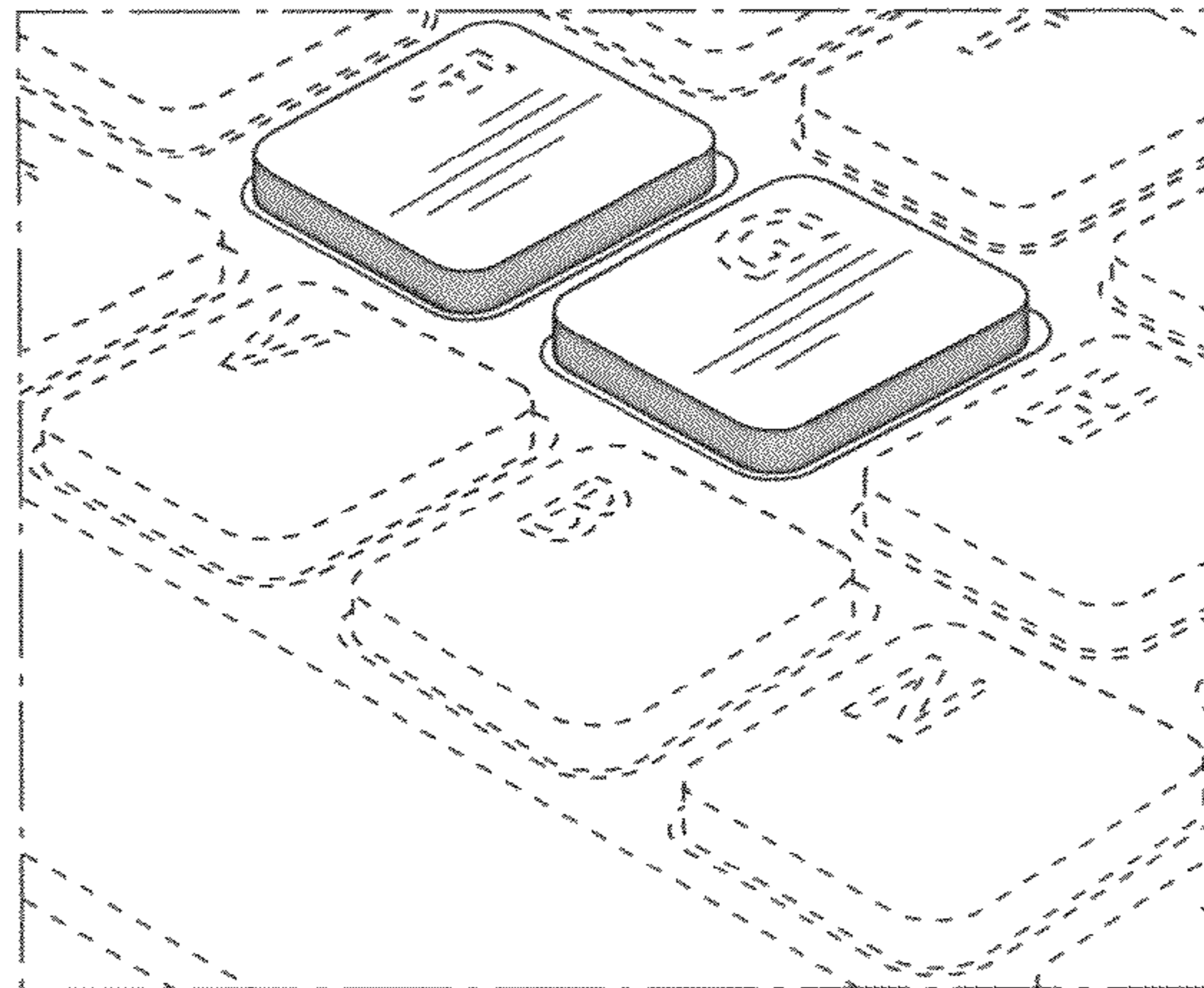

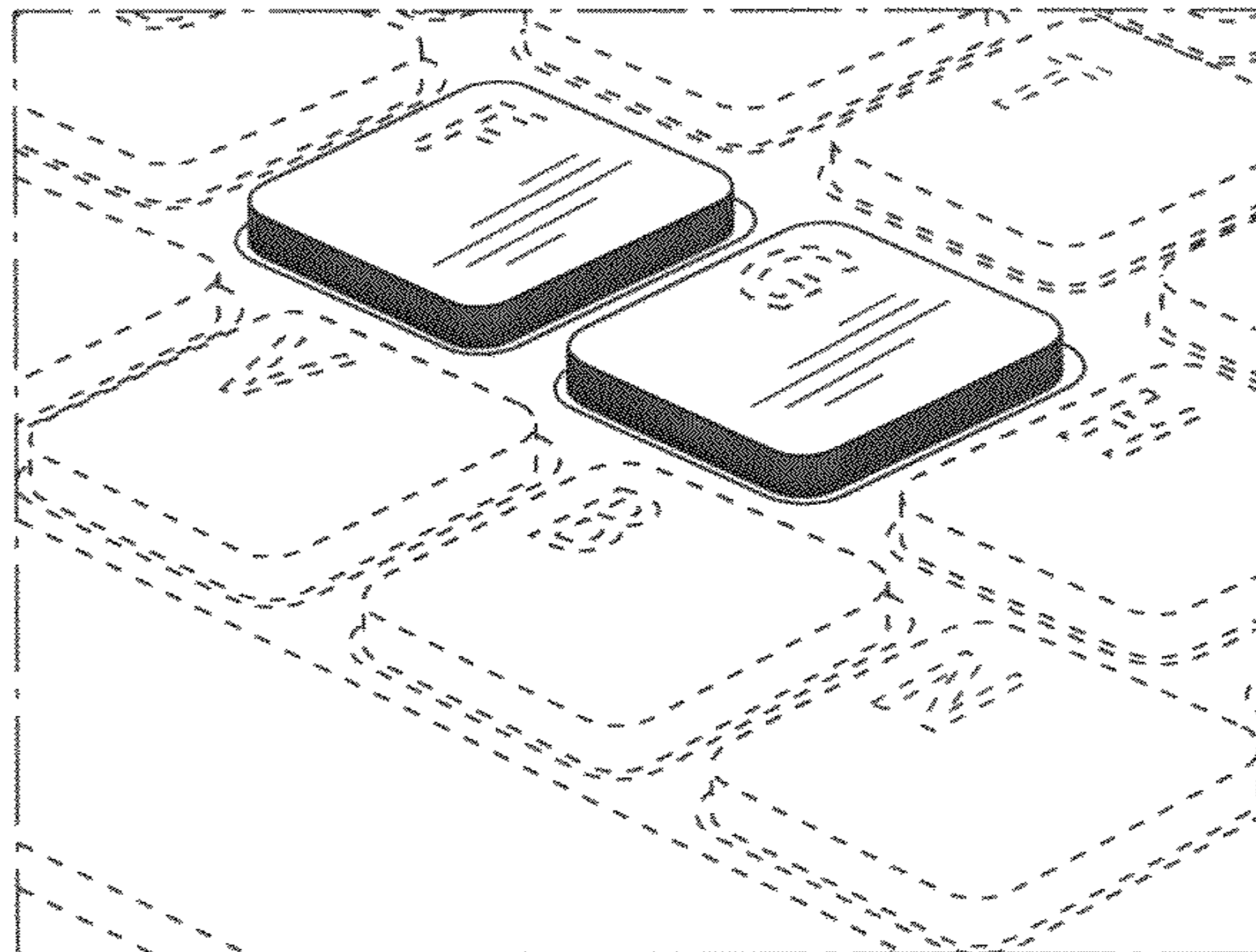

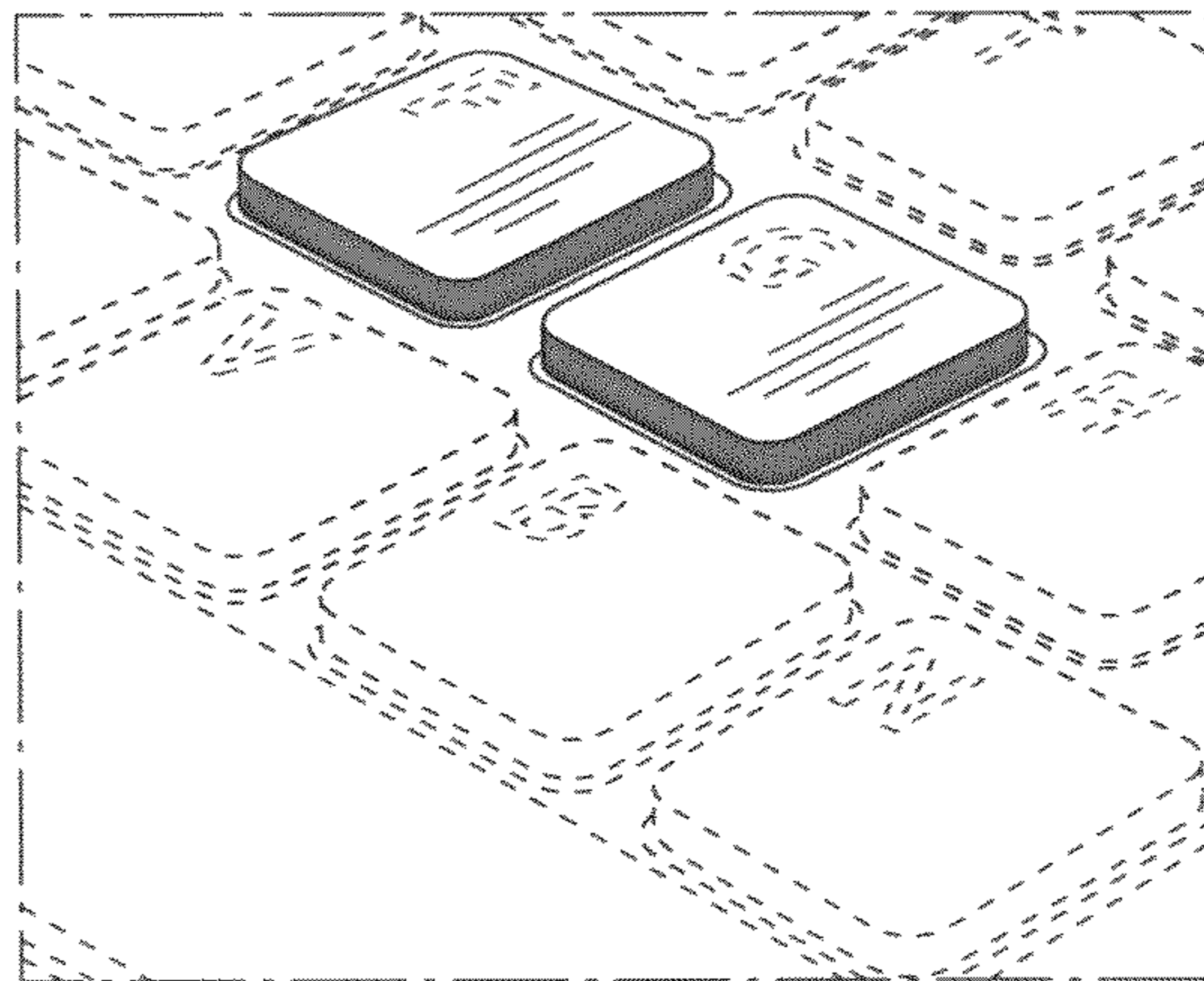

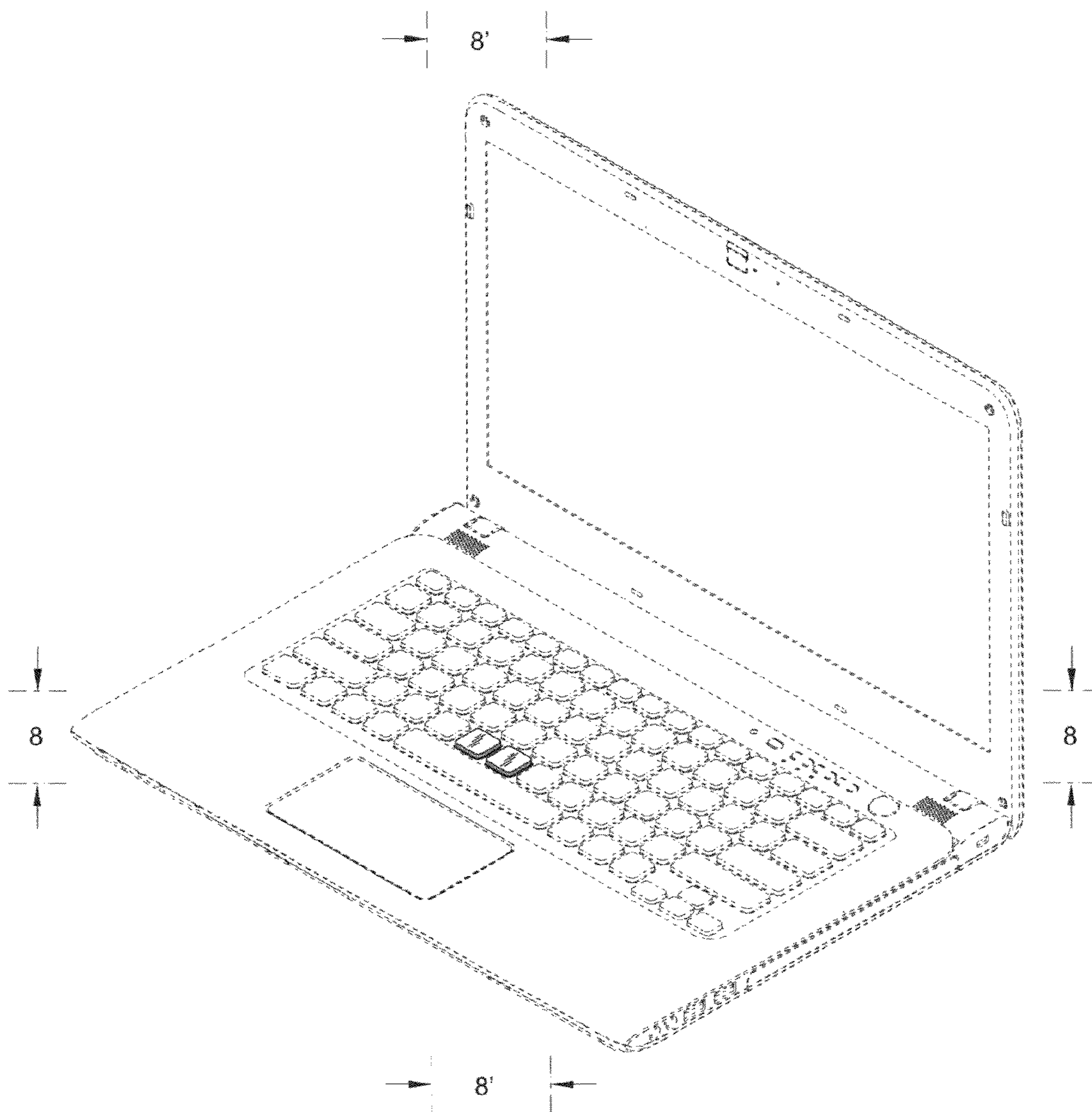

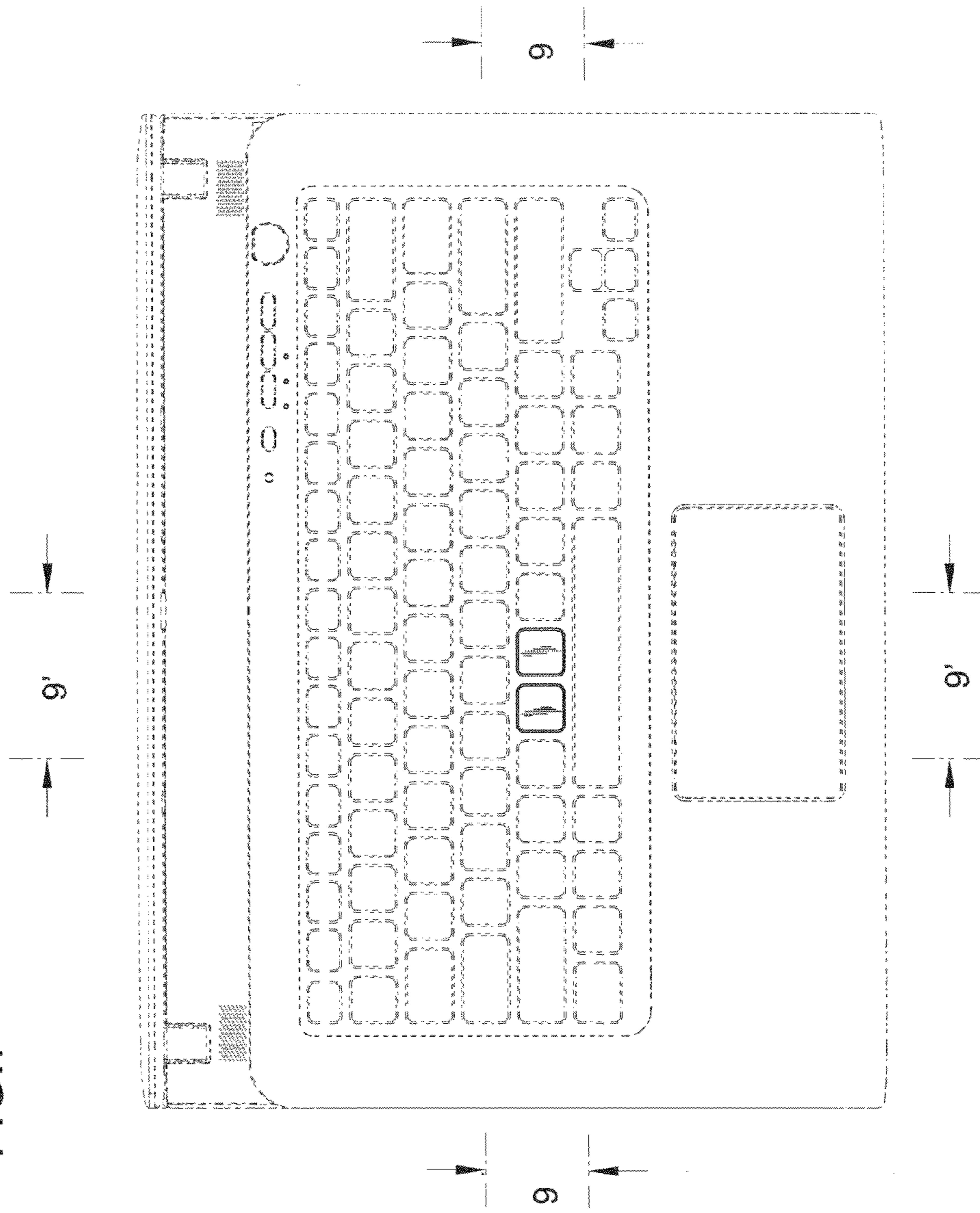

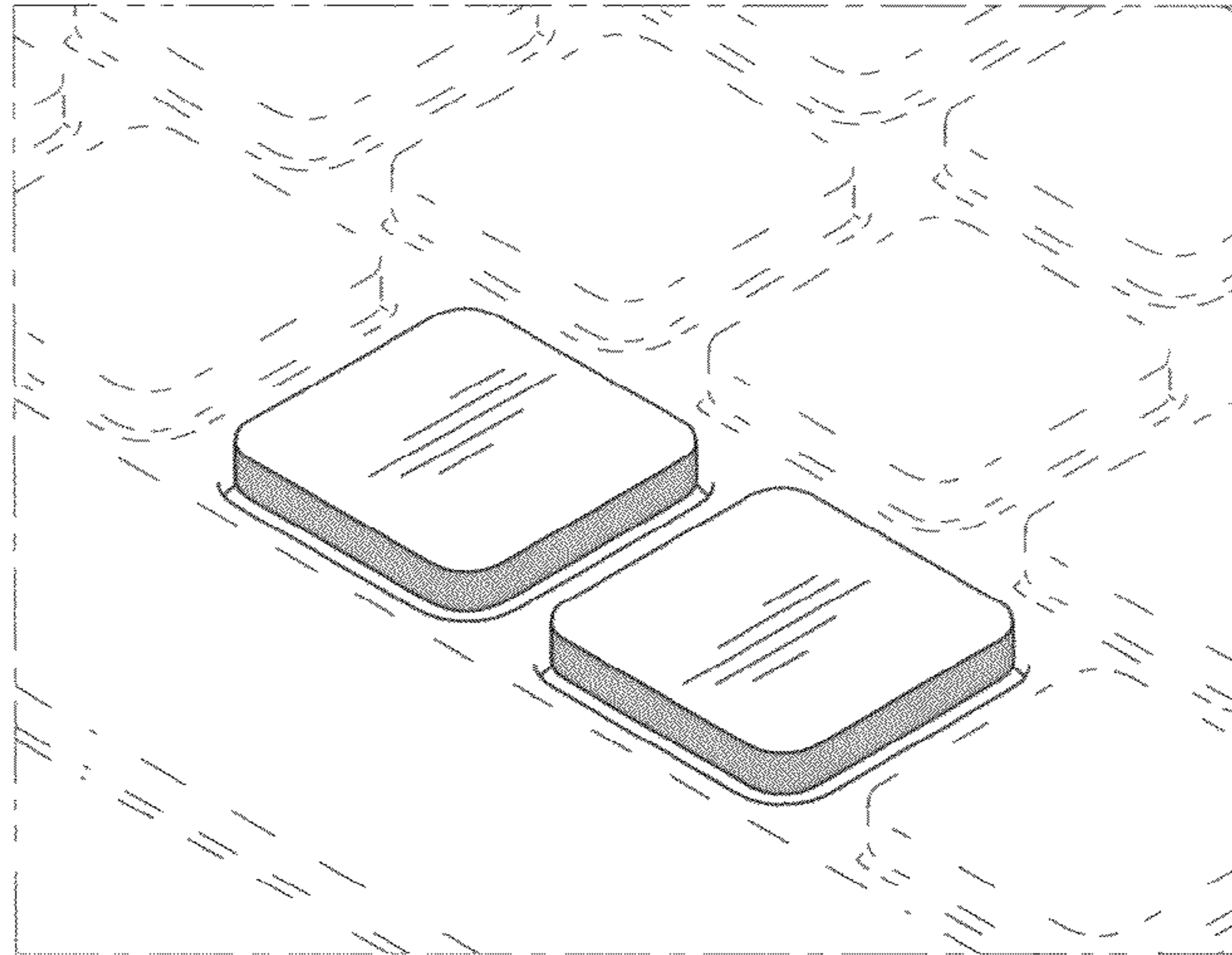

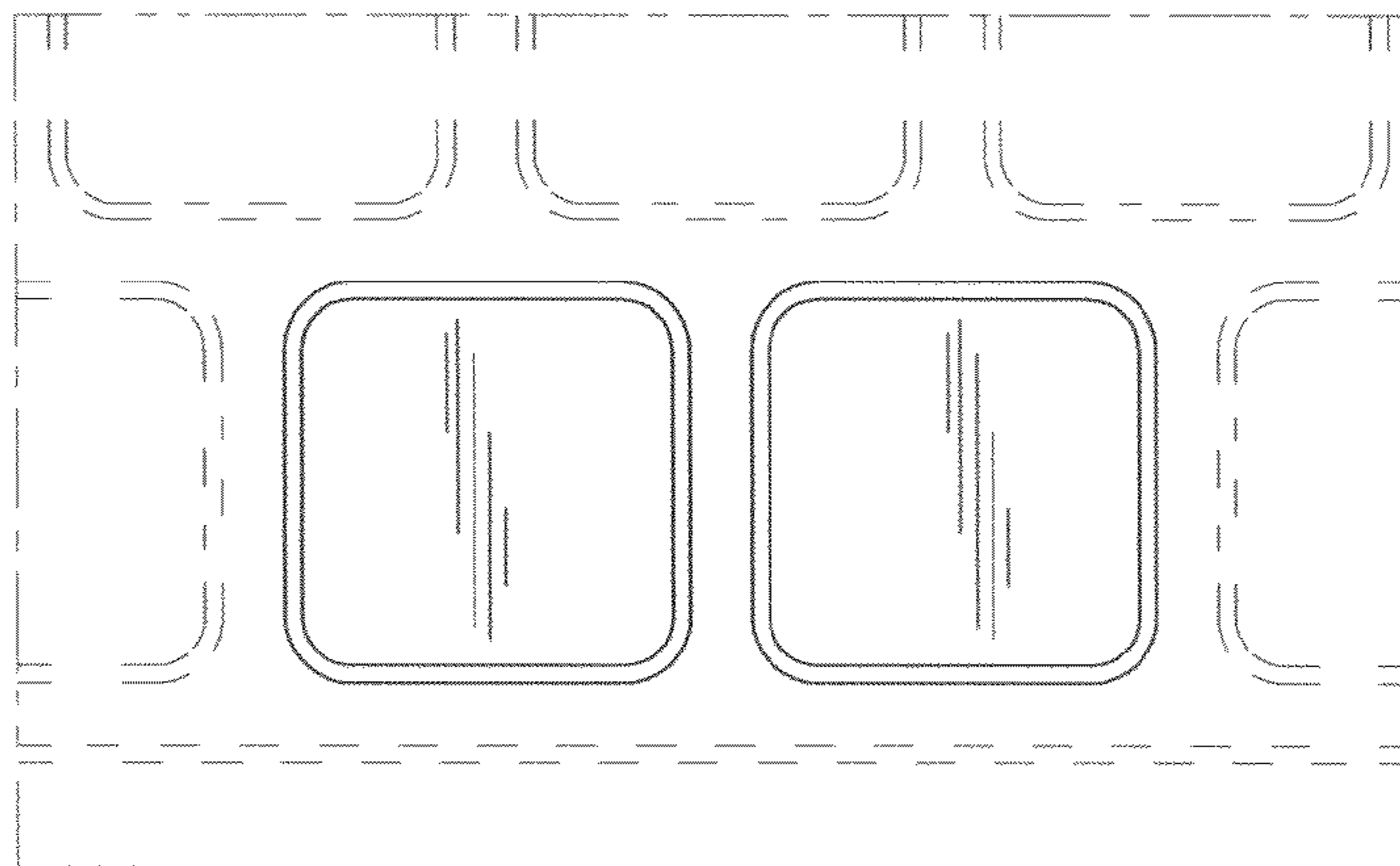

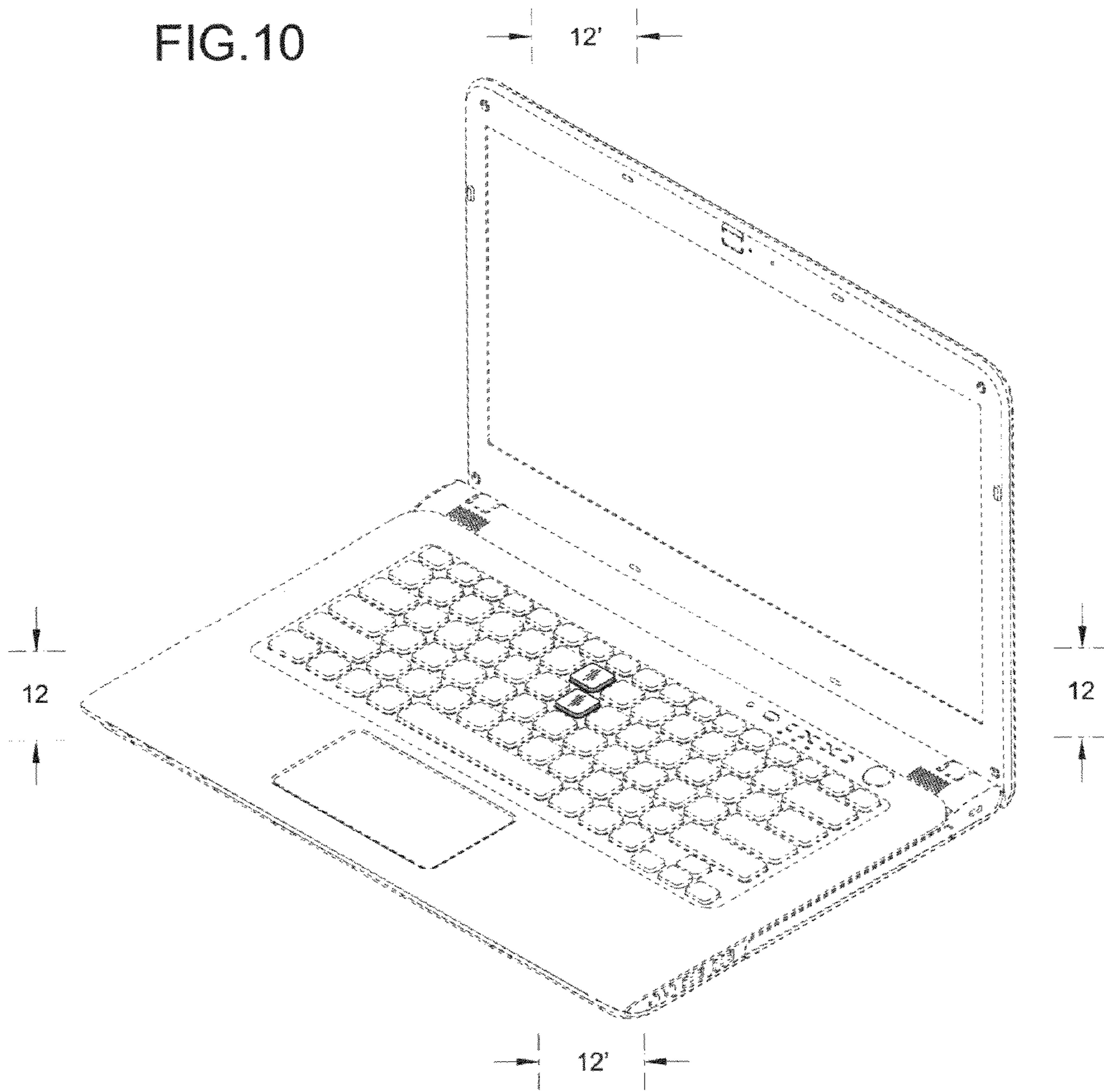

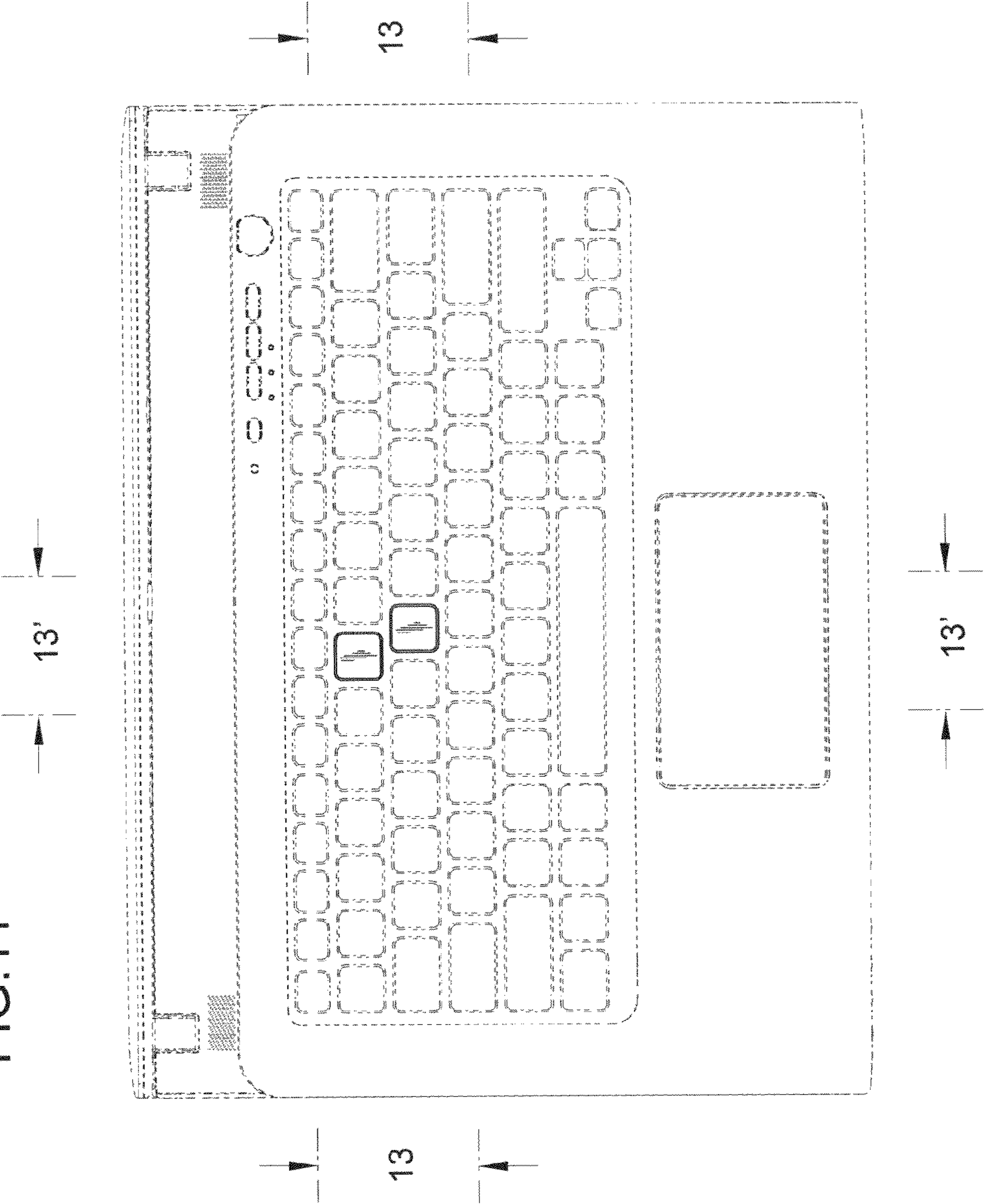

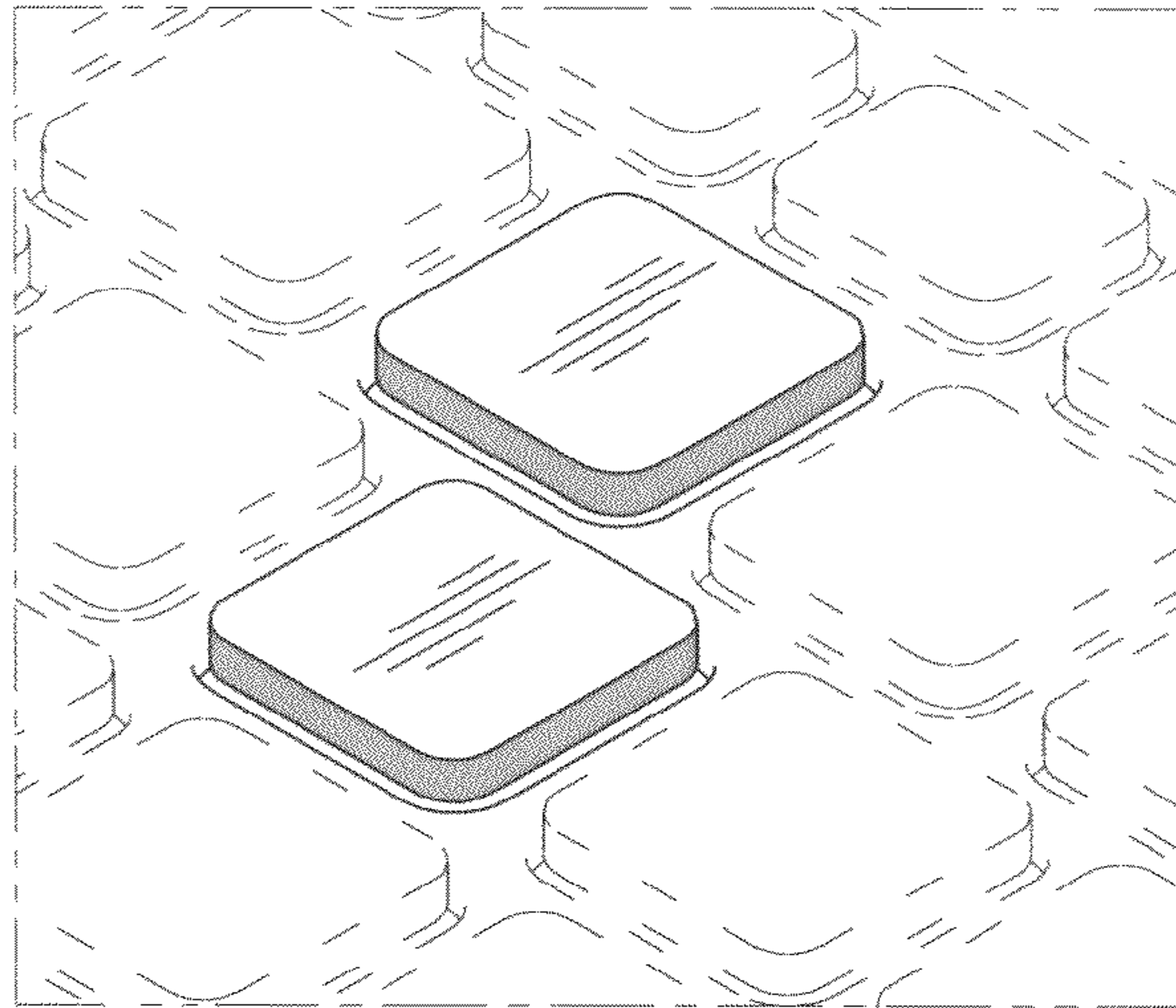

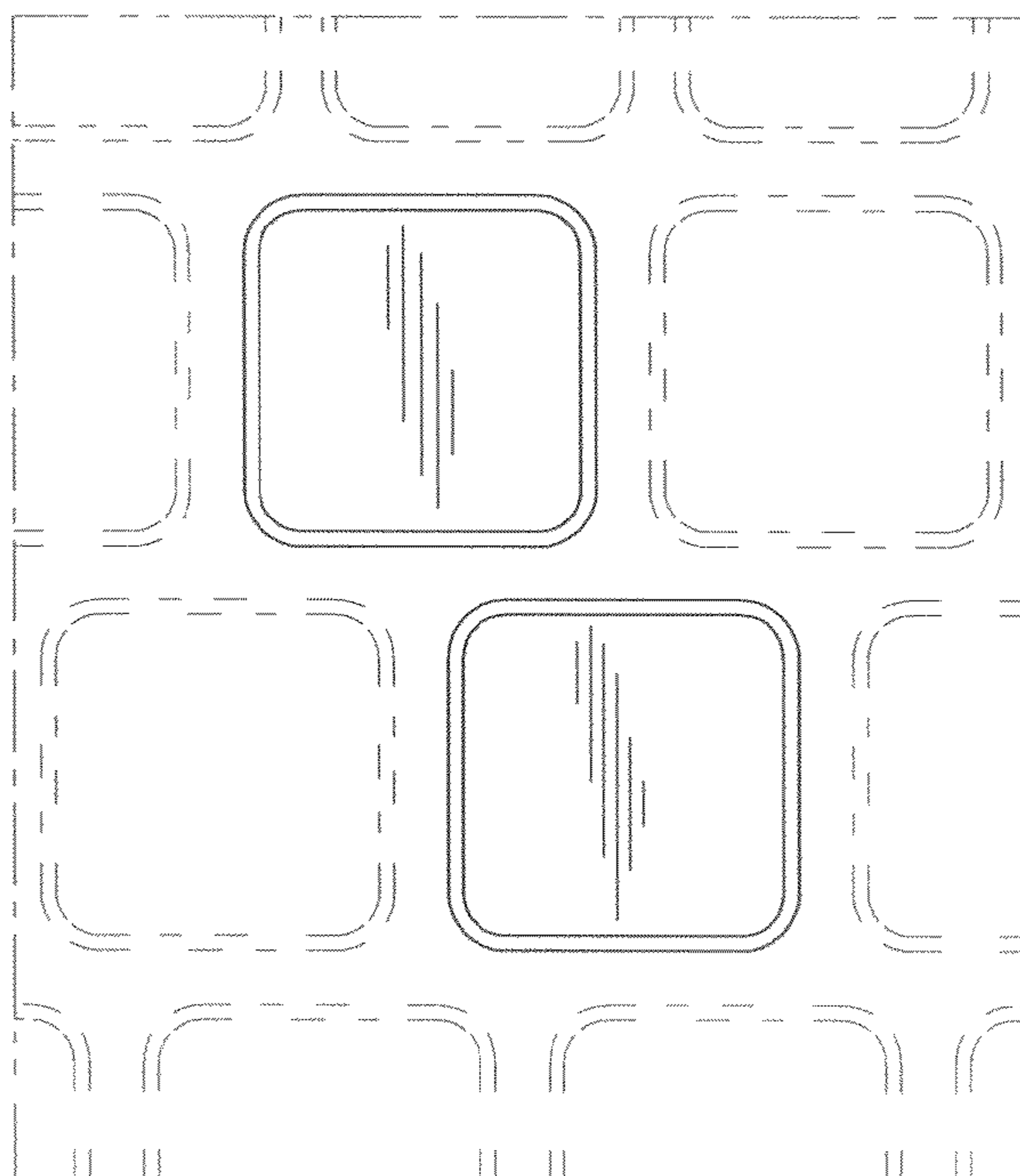

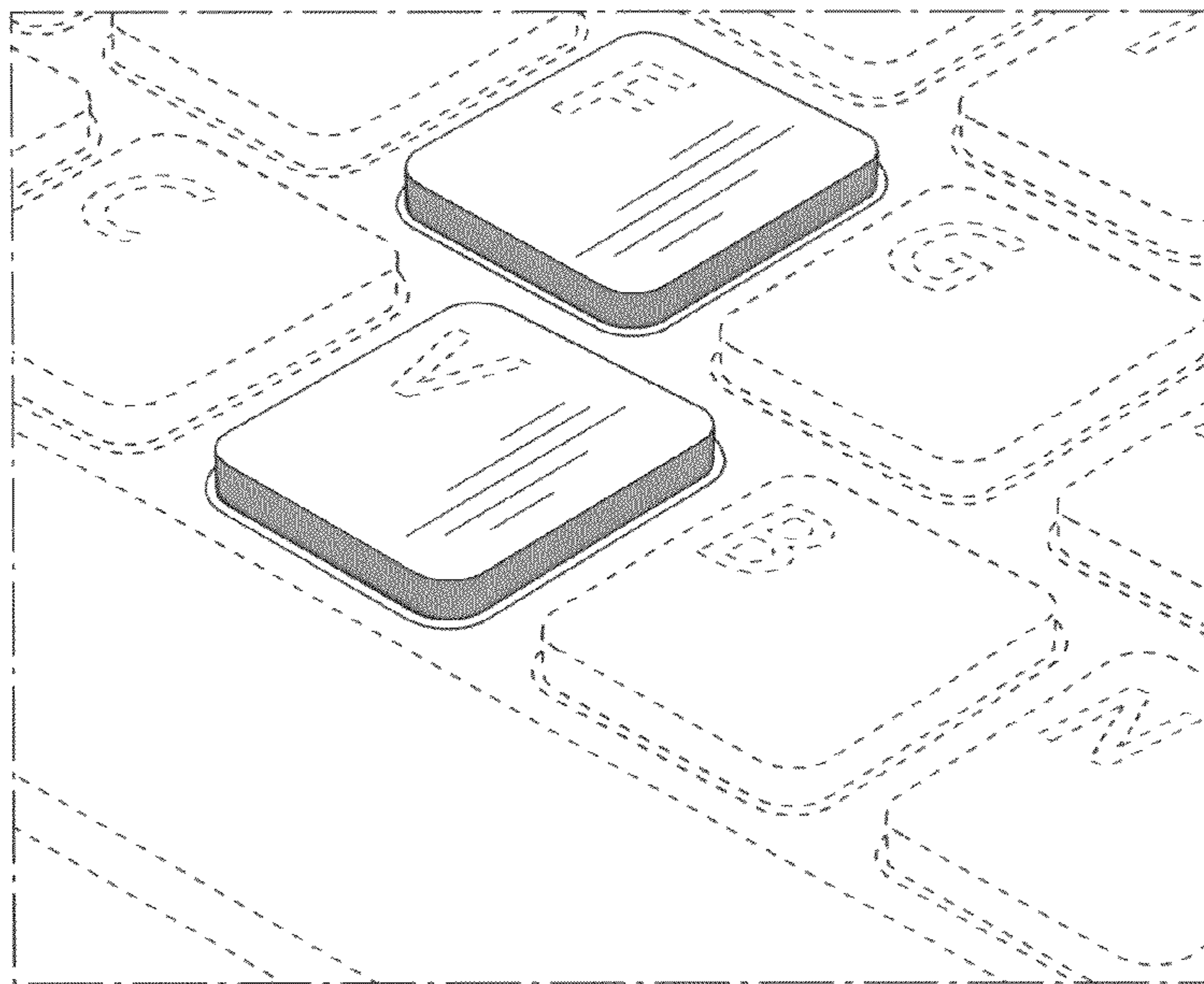

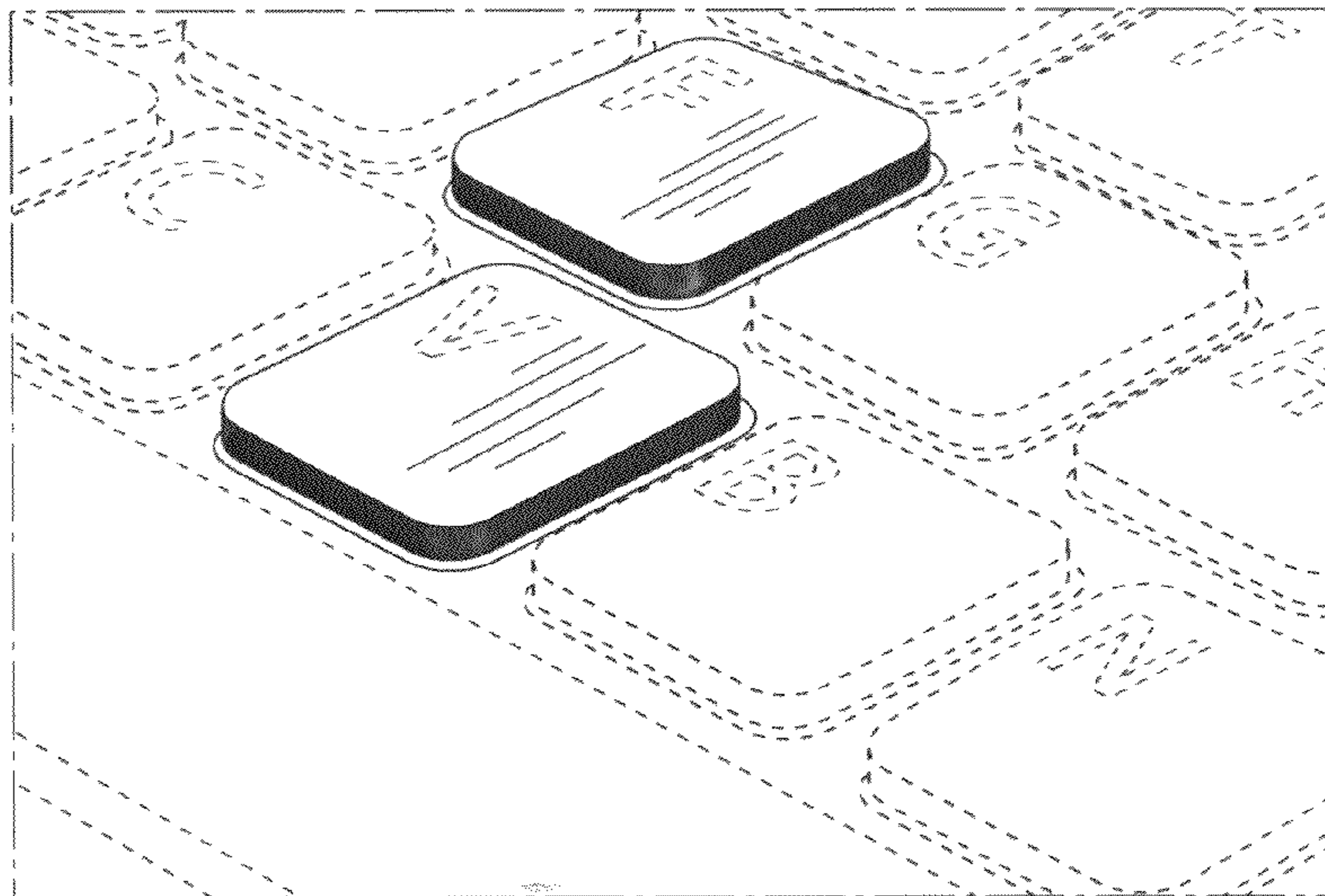

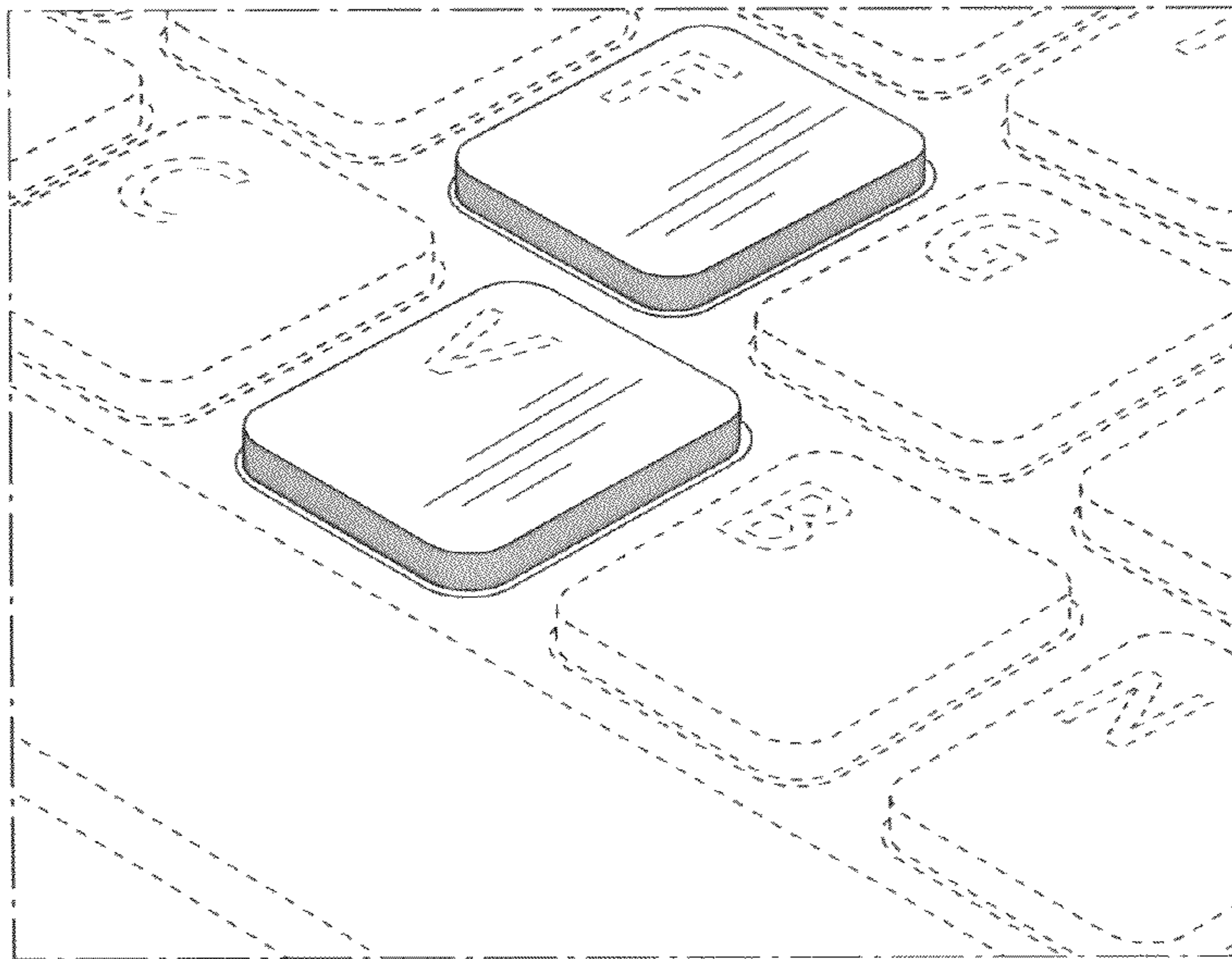

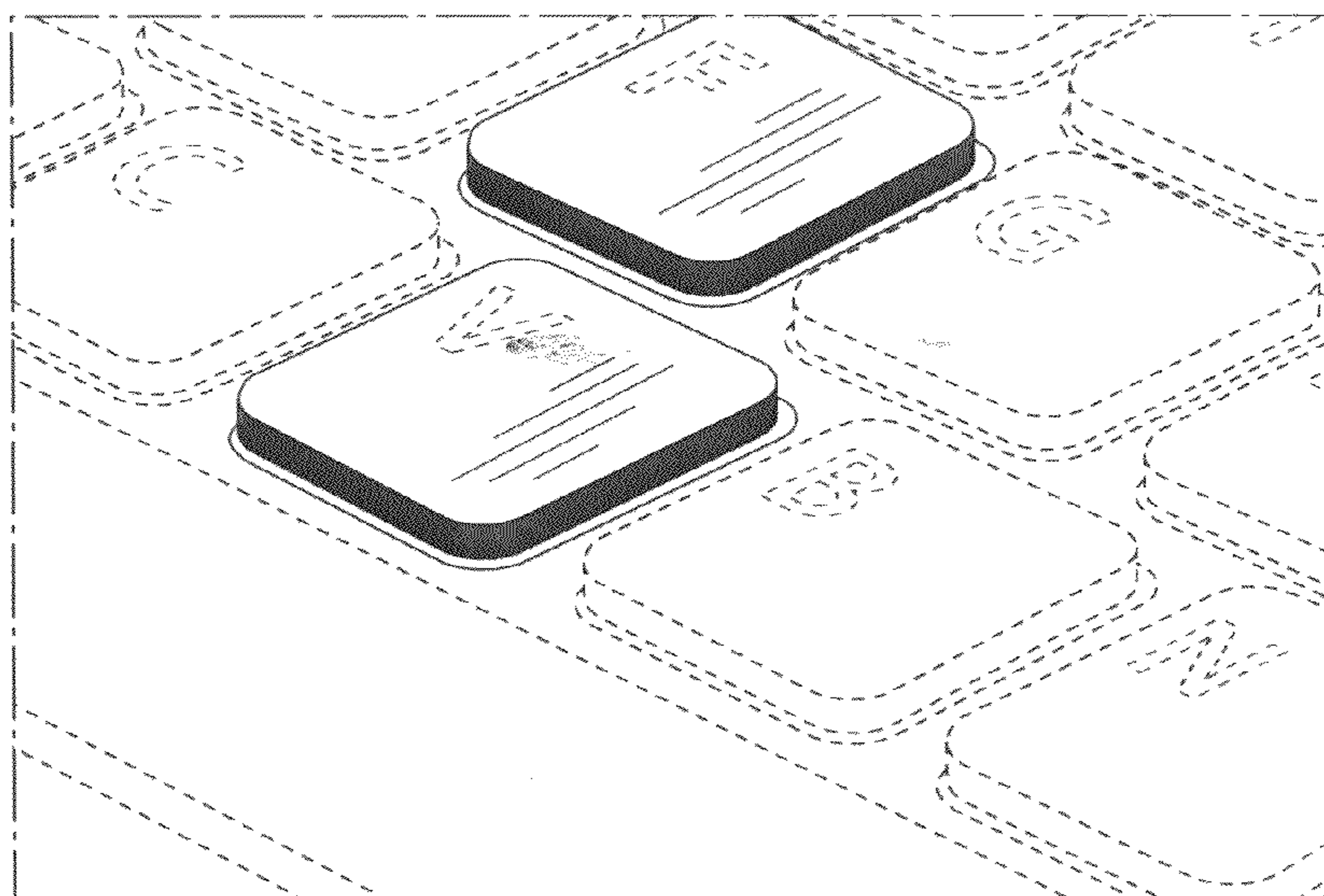

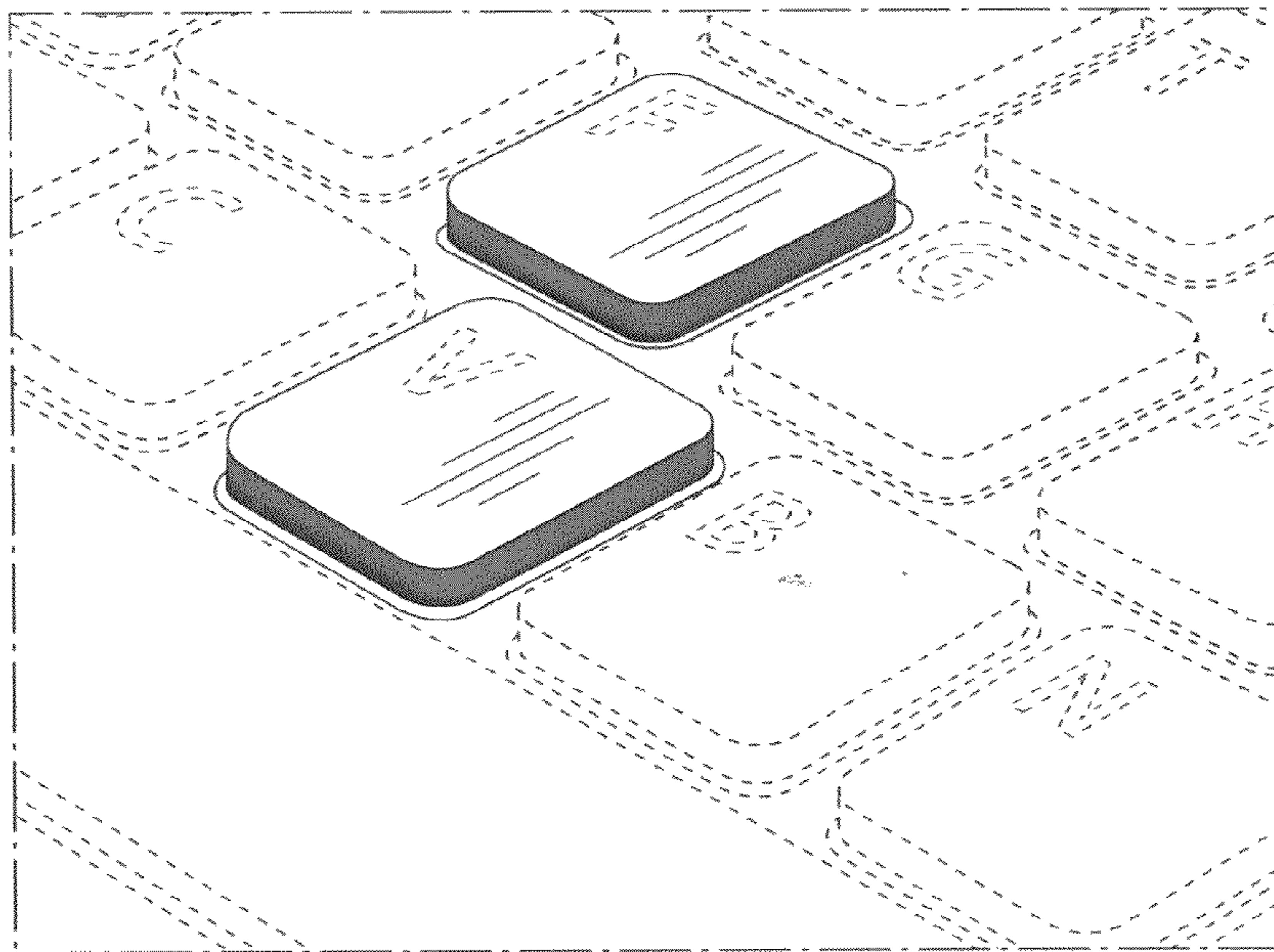

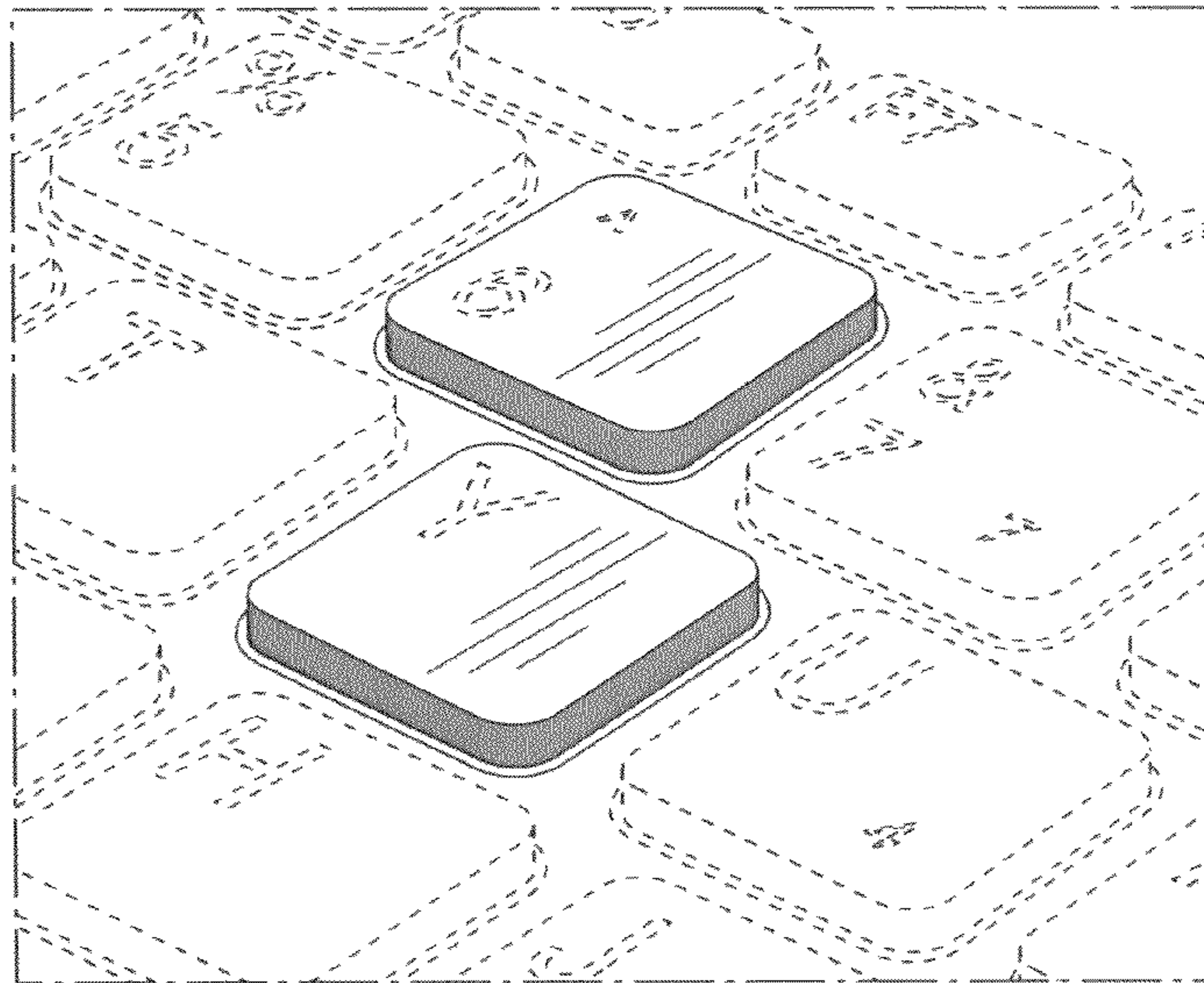

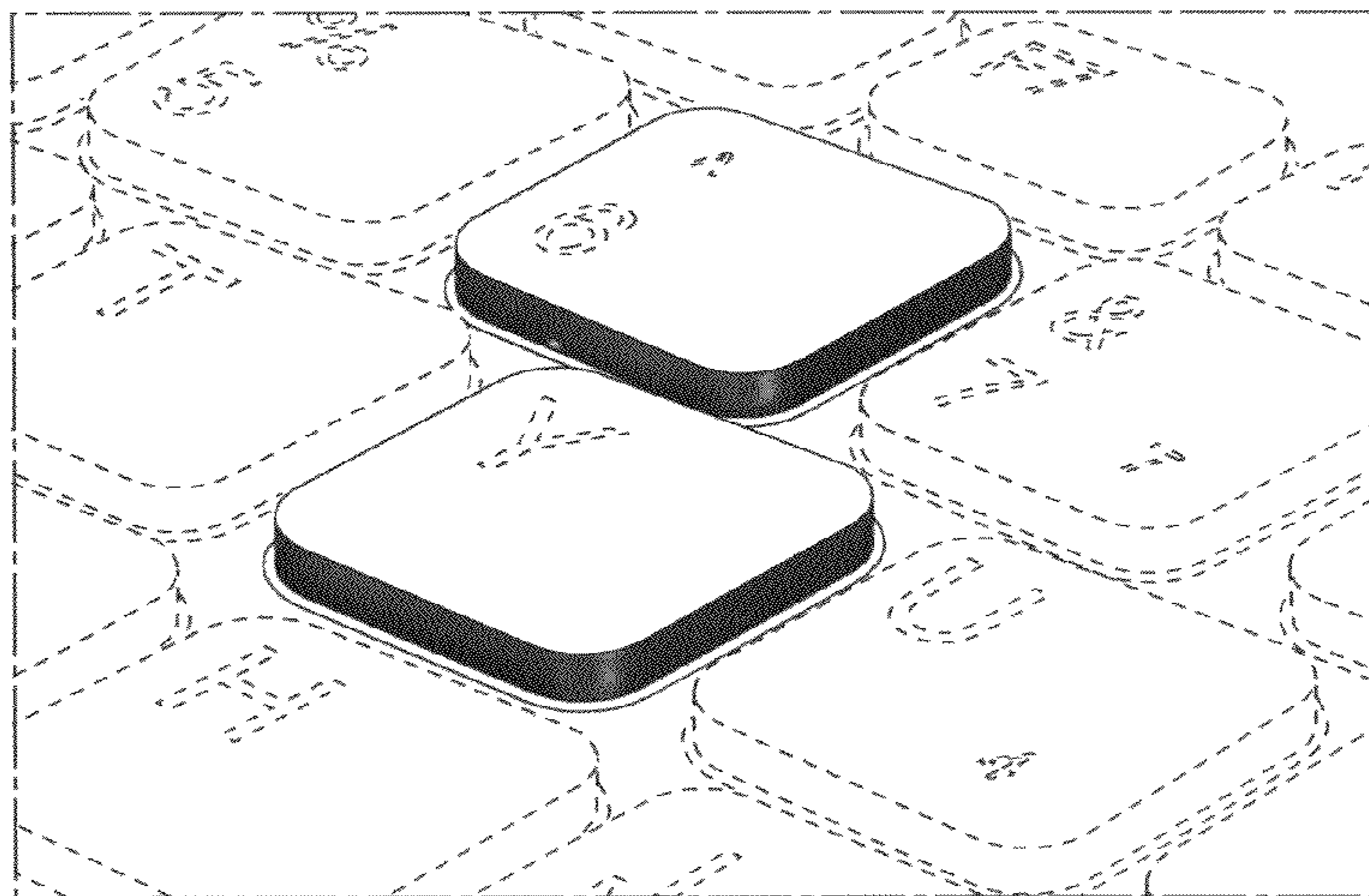

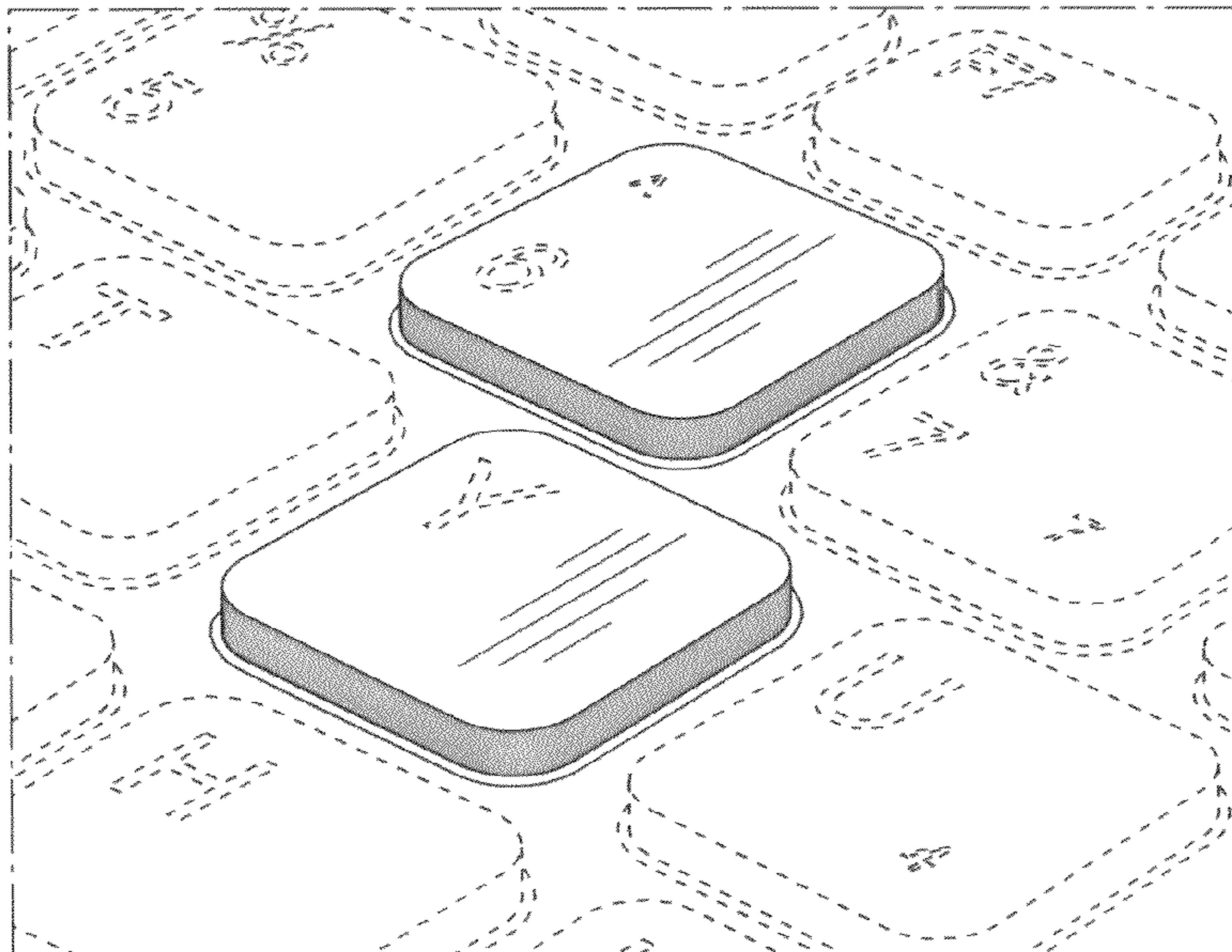

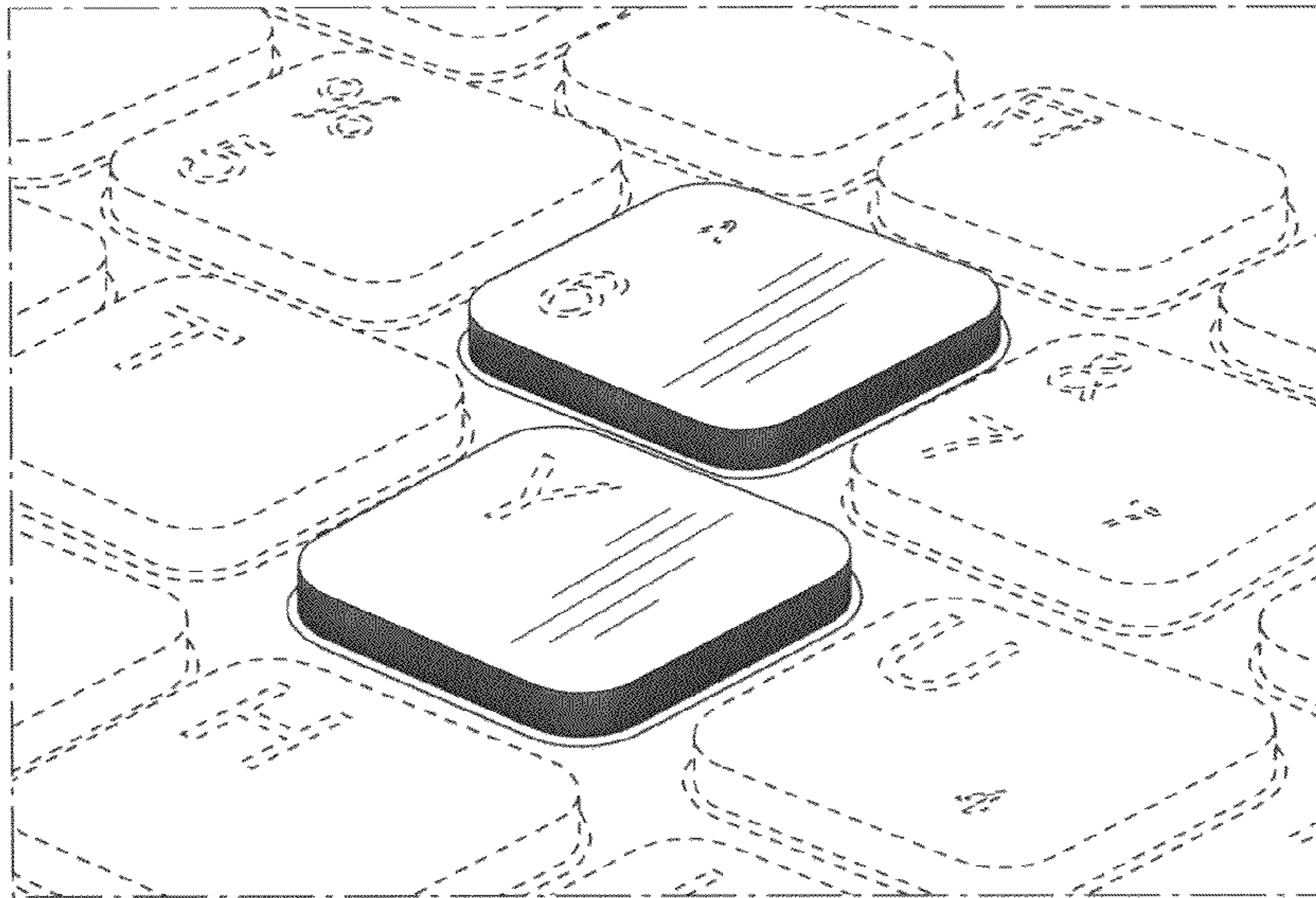
