FIG. 2 is a front view thereof wherein the display screen with graphical user interface is shown in a mobile terminal;

FIG. 3 is a front view thereof wherein the display screen with graphical user interface is shown in the example of another environment;

FIG. 4 is a front view thereof wherein the display screen with graphical user interface is shown in the example of another environment; and,

FIG. 5 is a perspective view of the display screen with graphical user interface of FIG. 2.

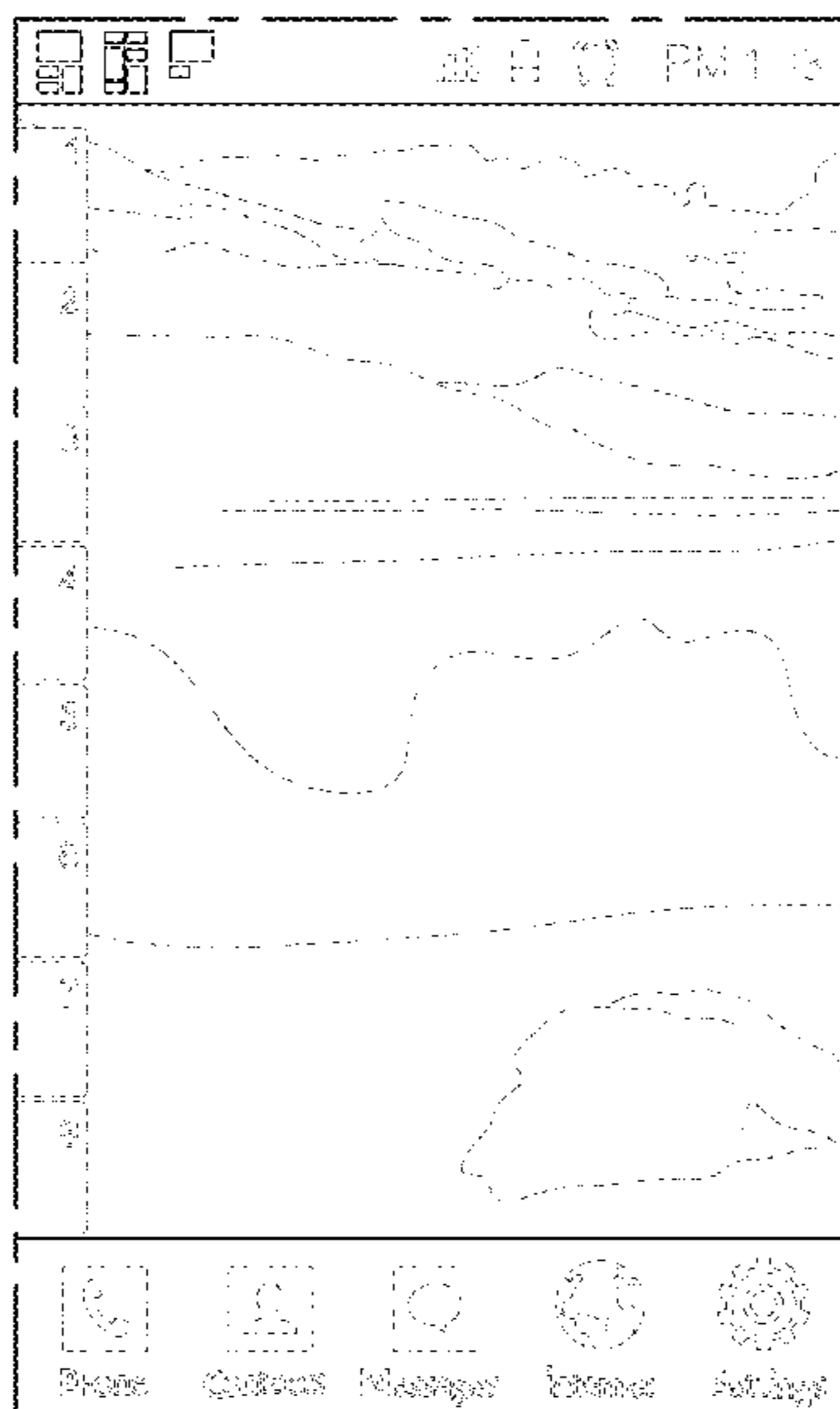

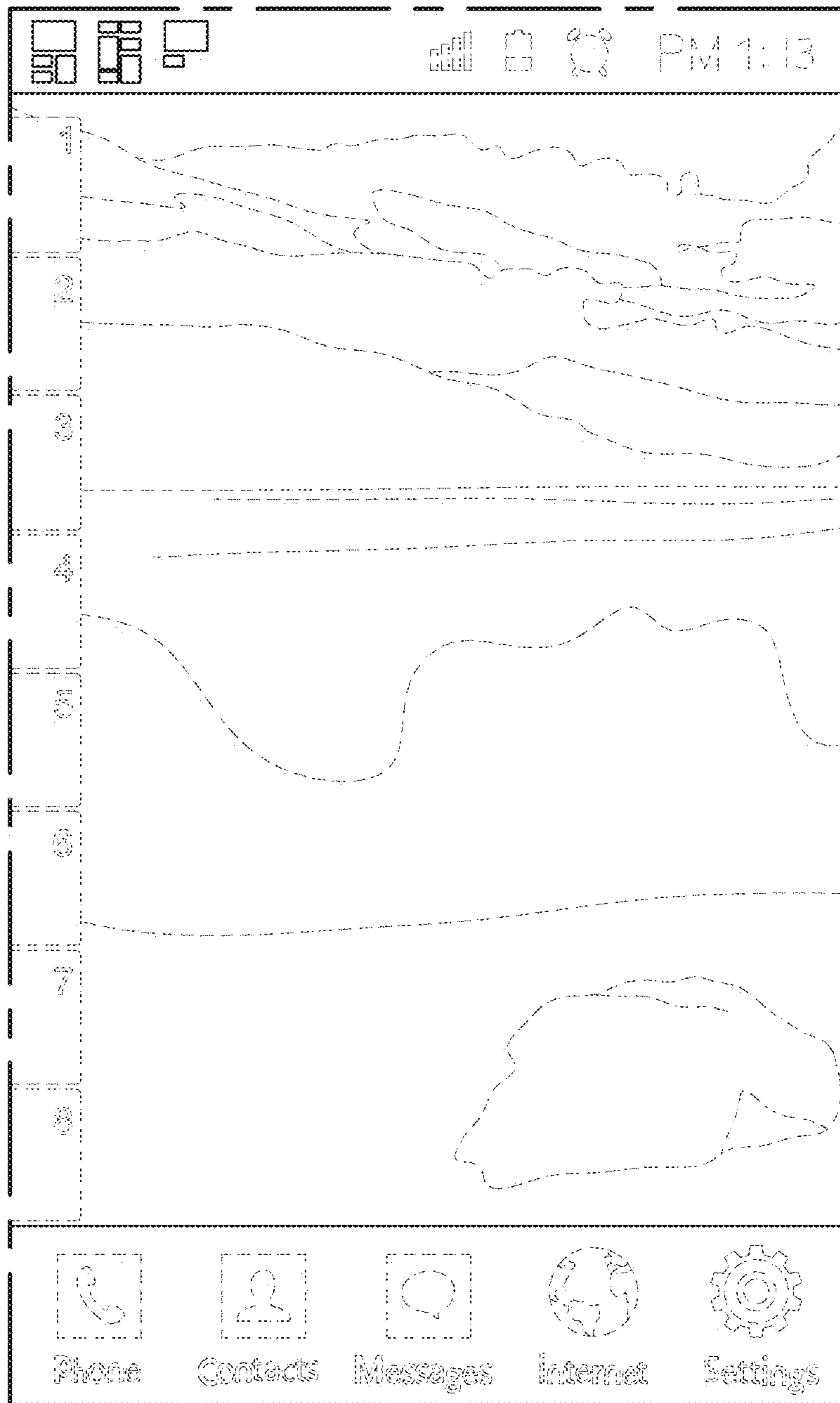

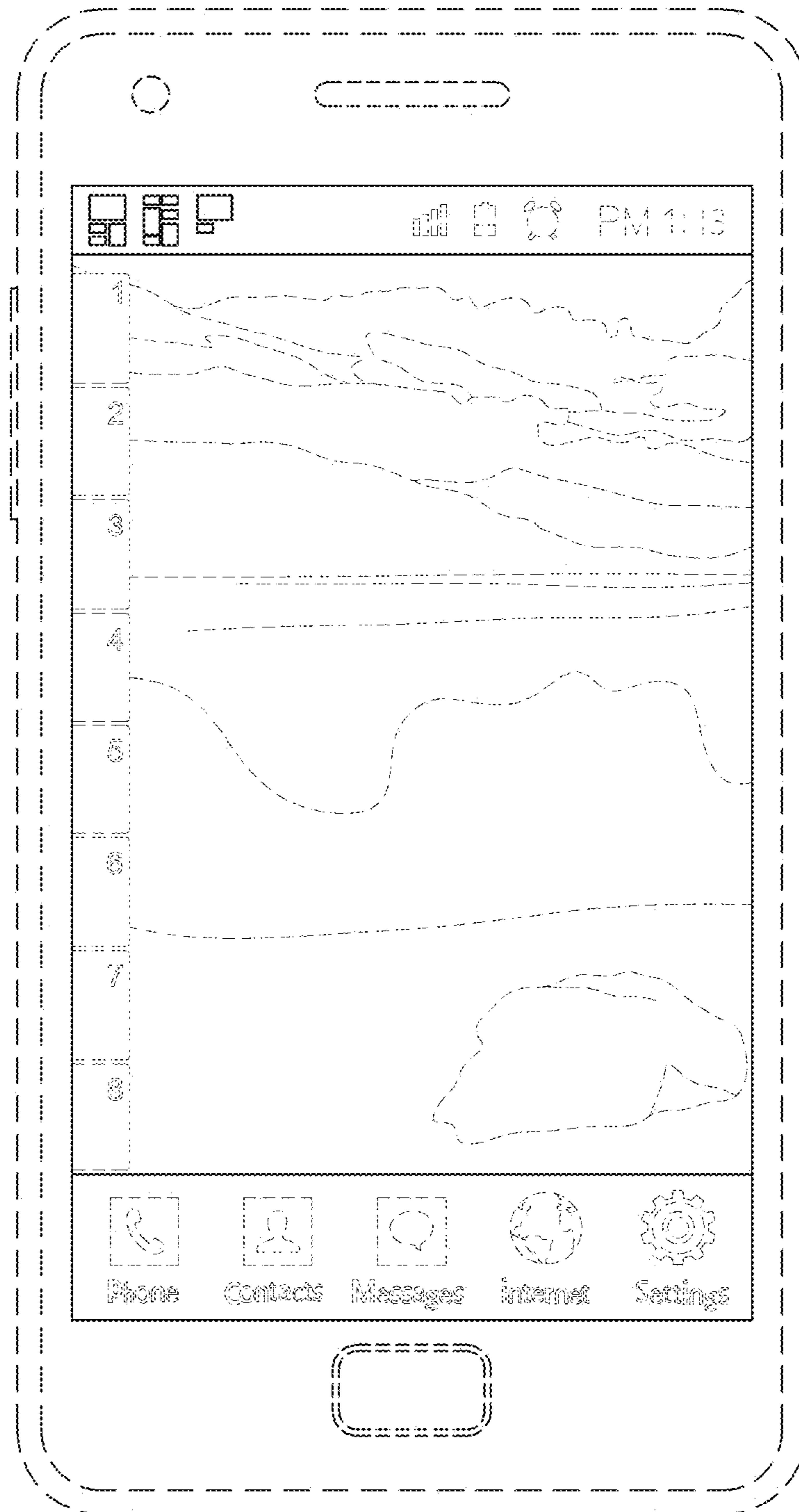

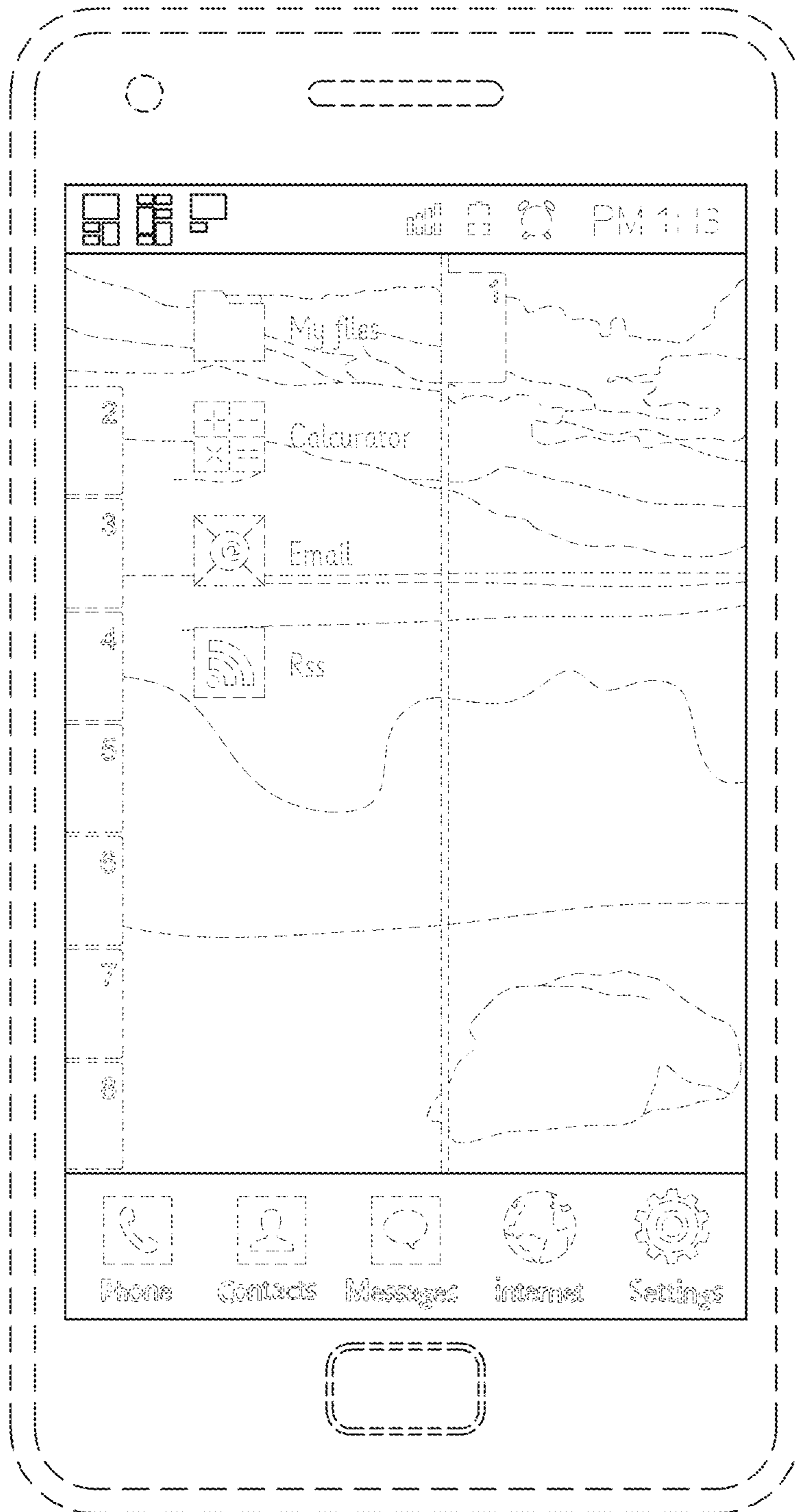

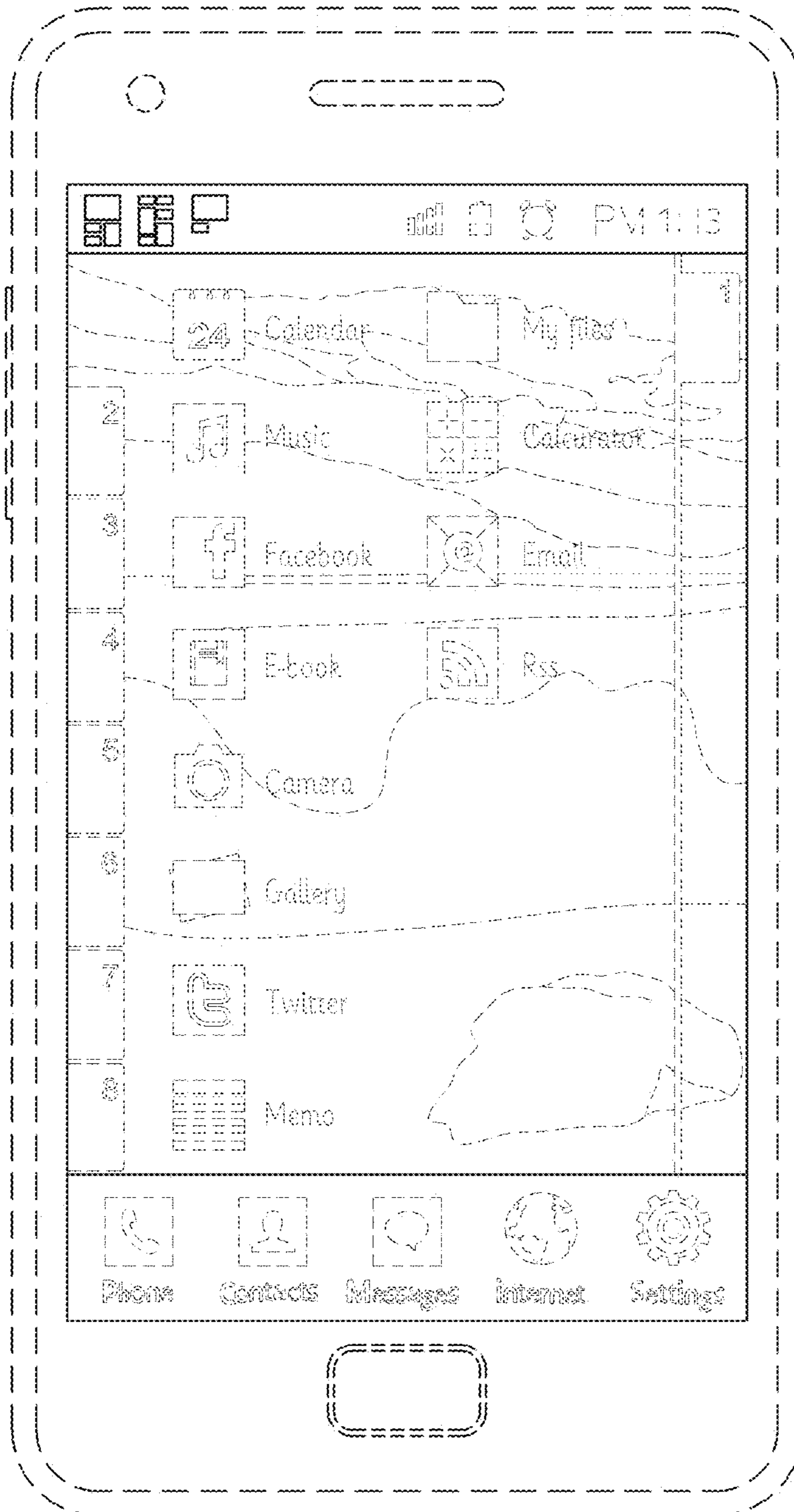
