(57) **CLAIM**

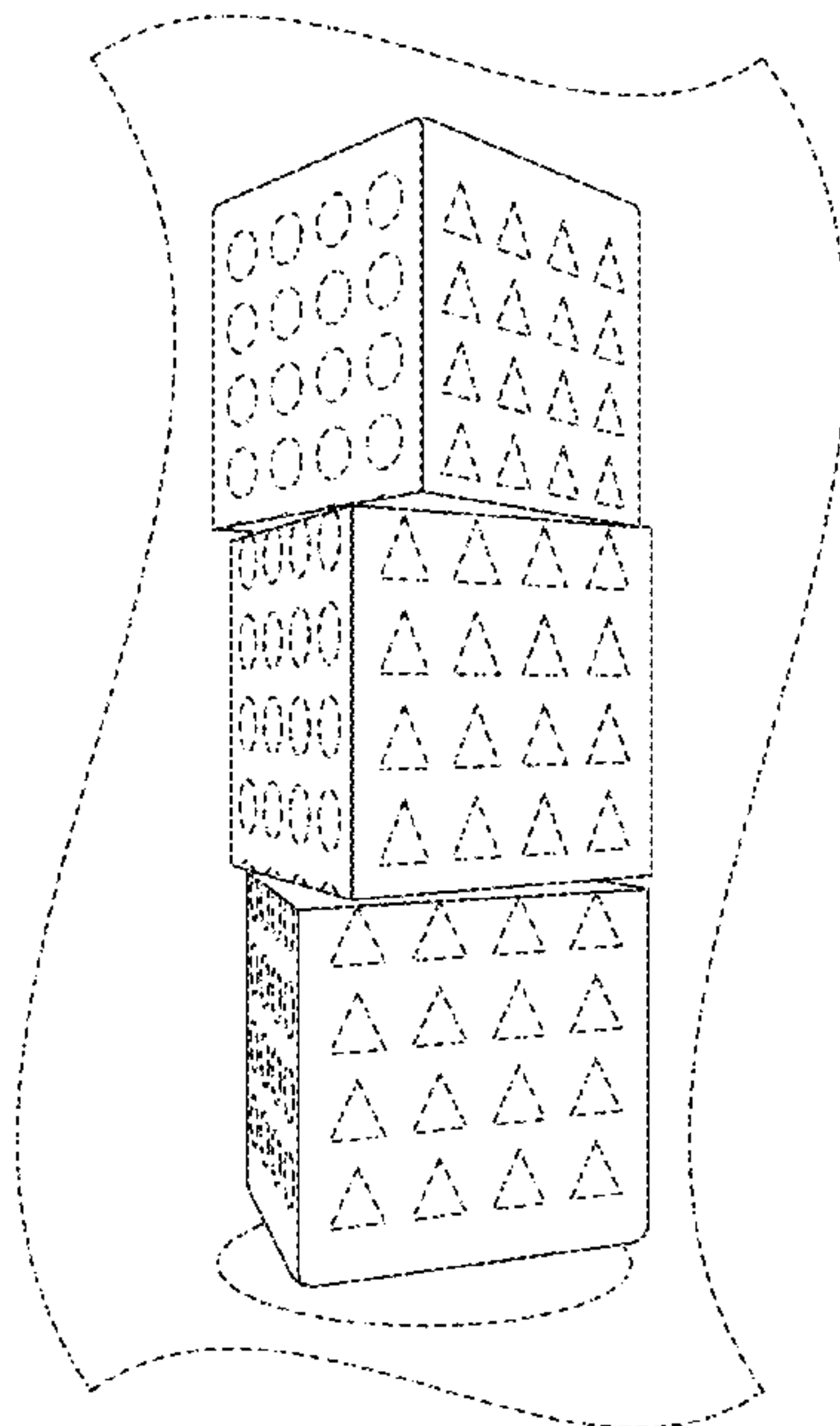
The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a view of a display screen with graphical user interface showing our new design; and, FIG. 2 is a view of the display screen with graphical user interface of FIG. 1 shown in a position of use on an unclaimed example device display screen.

The broken lines in the figures depicting the outline of a display screen, objects within and around the design and text represent unclaimed environmental subject matter and form no part of the claimed design.

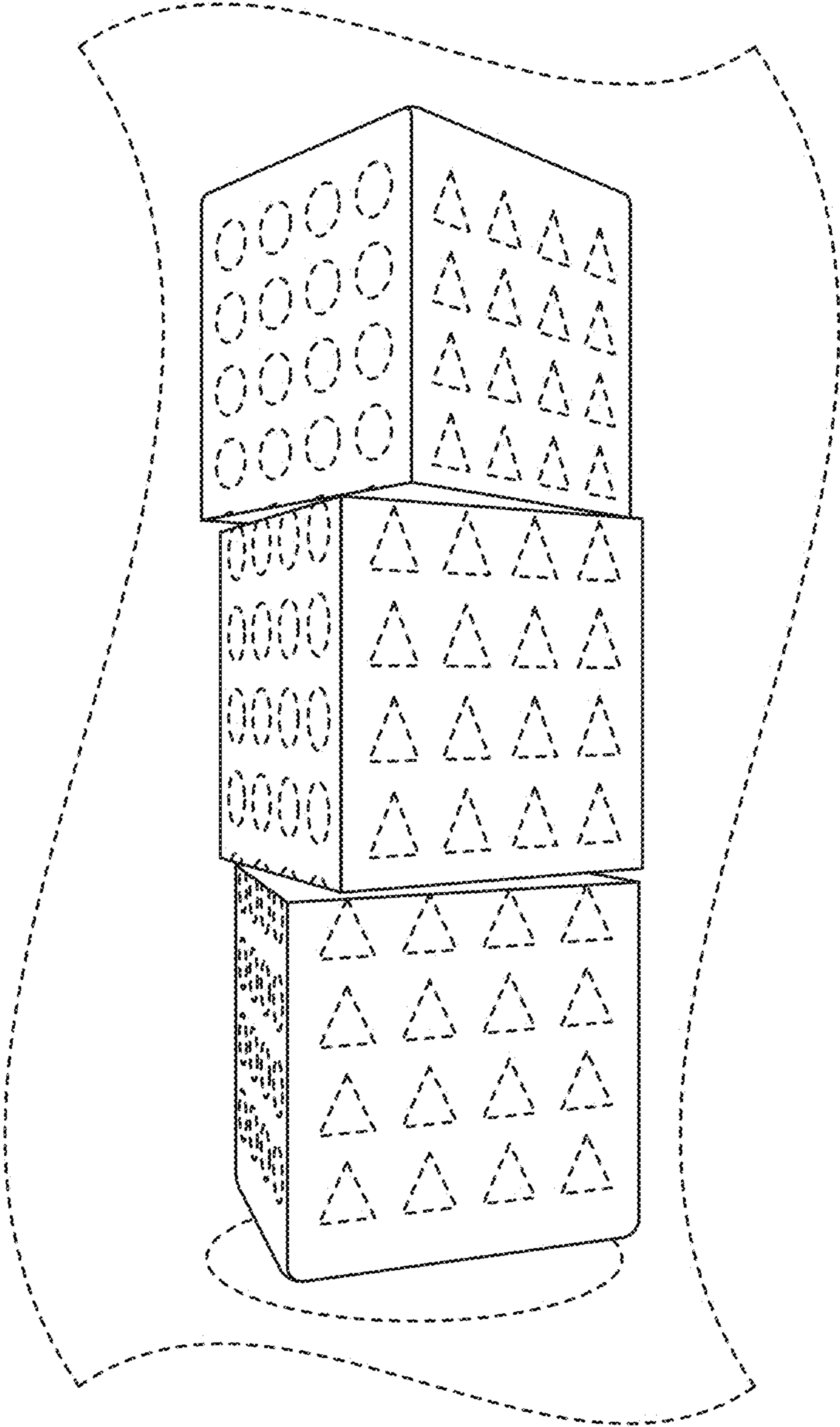

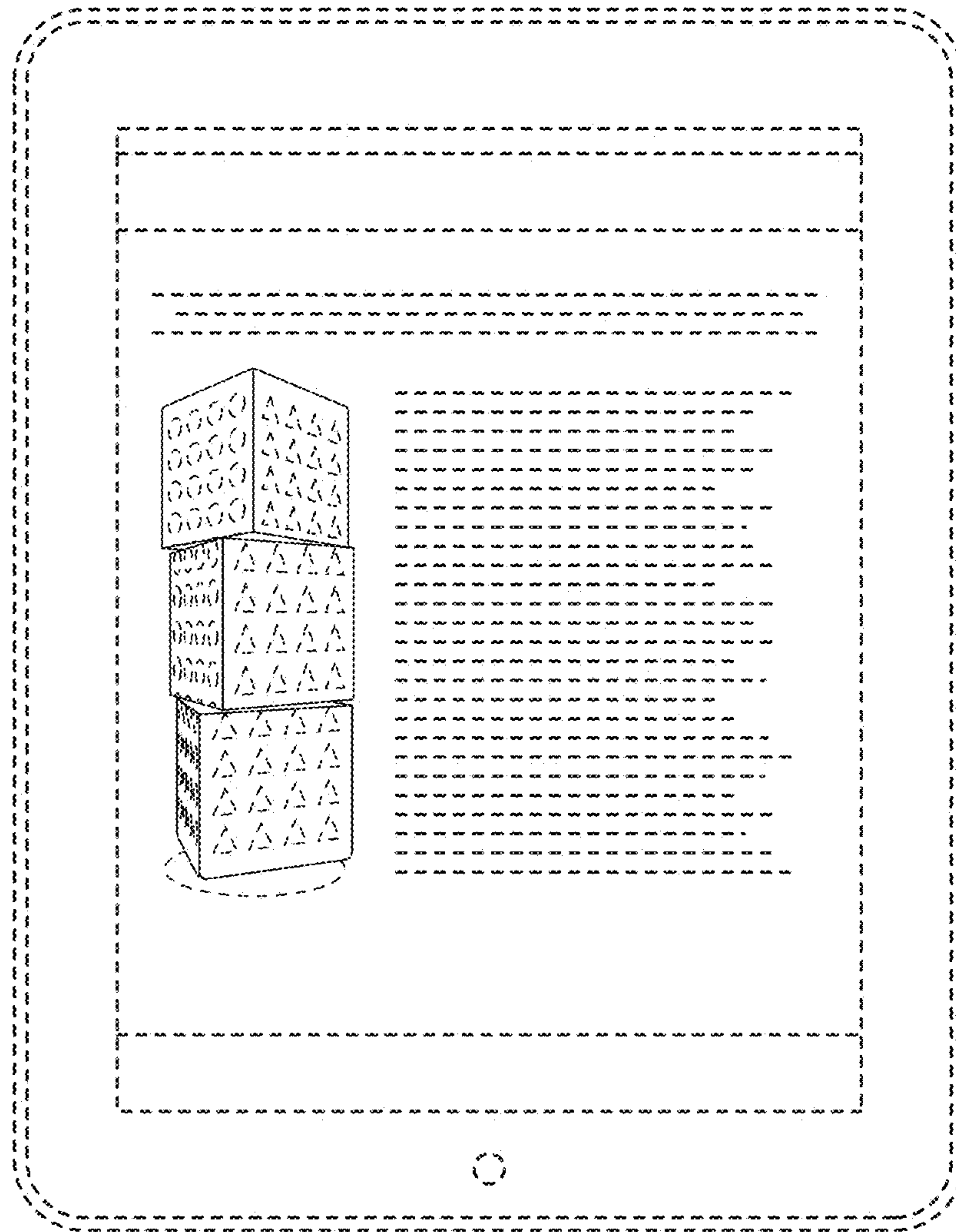
