(57) **CLAIM**

We claim the ornamental design for an extra flexible weld wire conduit for industrial robot, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an extra flexible weld wire conduit for industrial robot of the present invention;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;

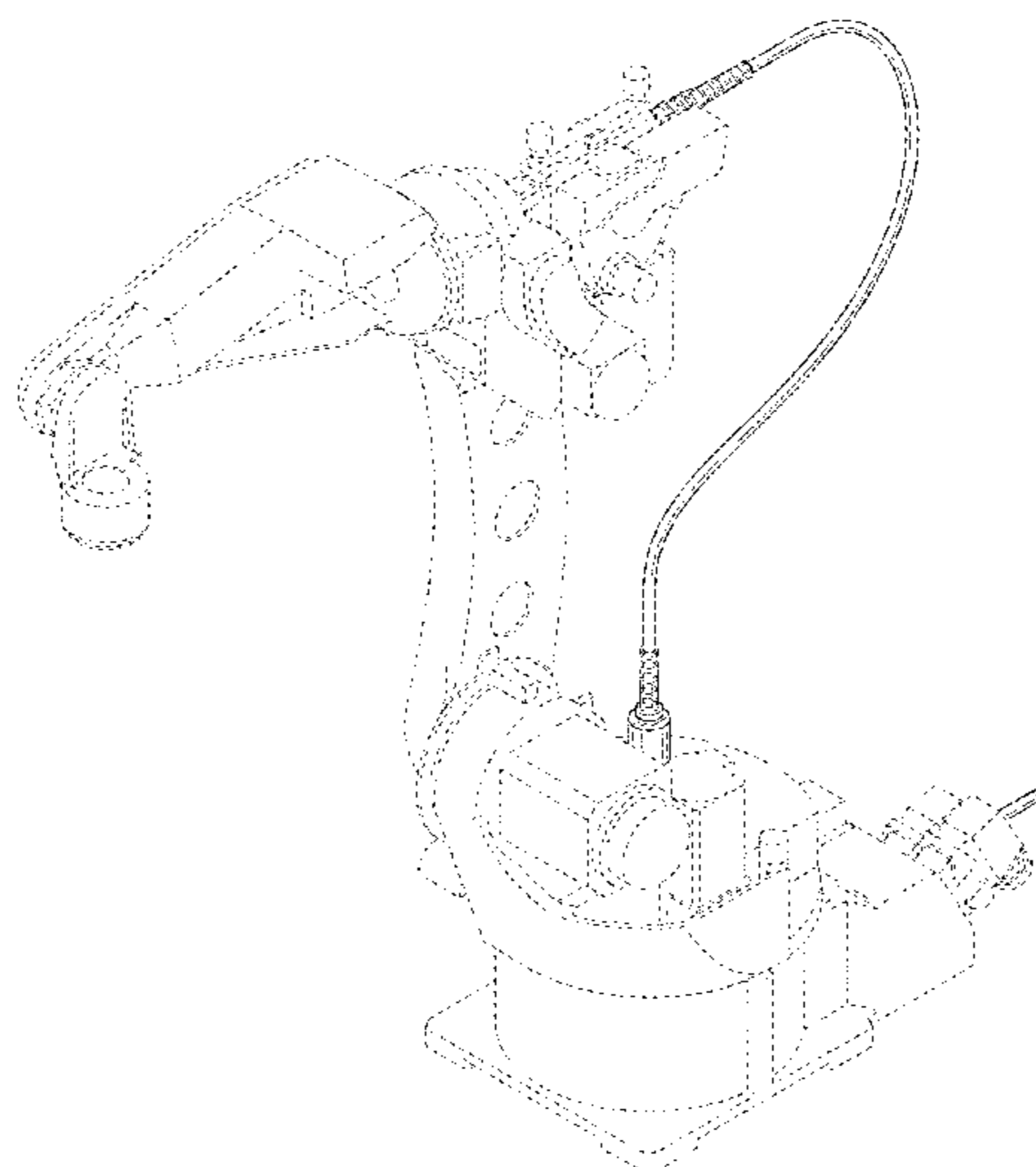

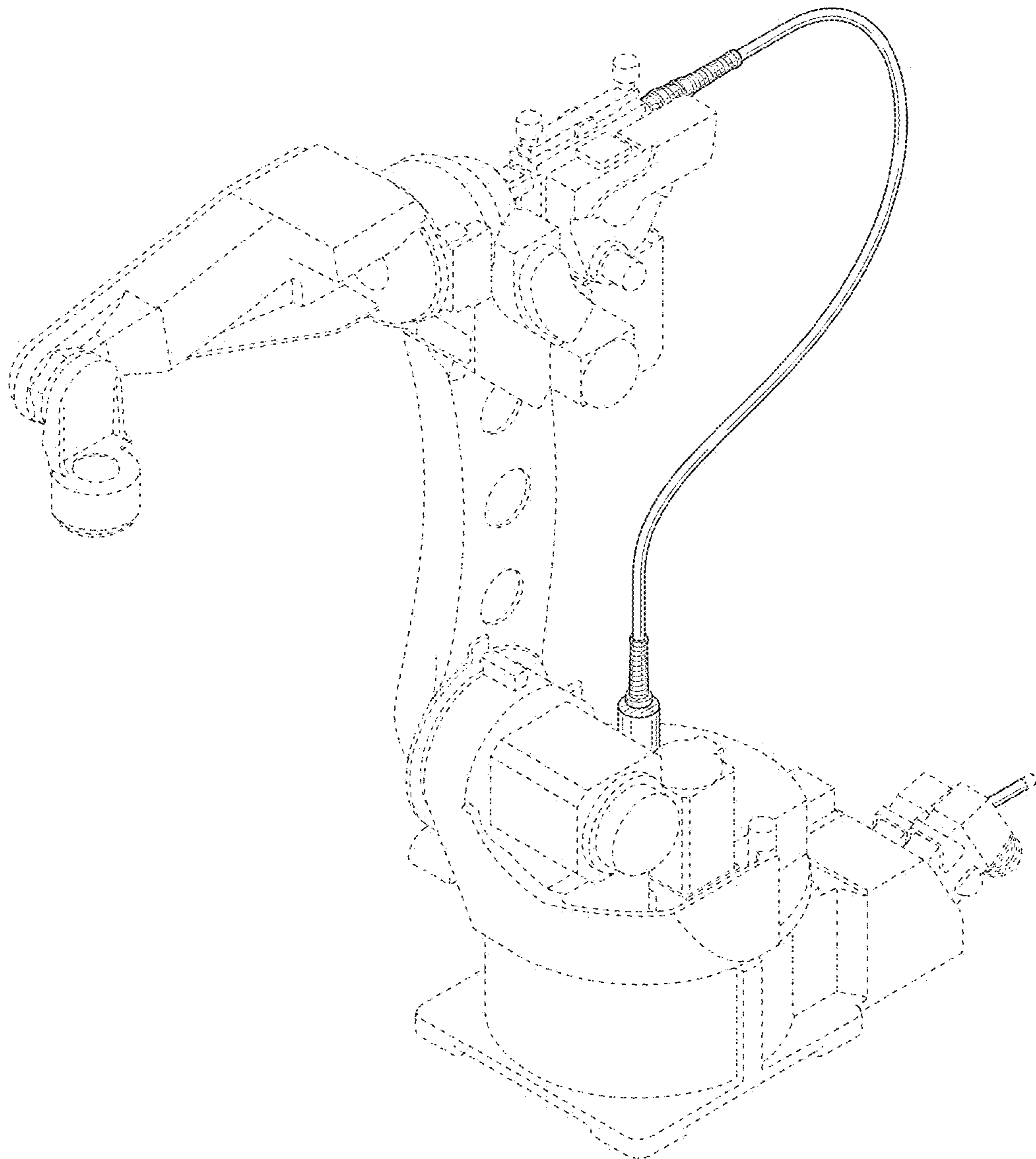

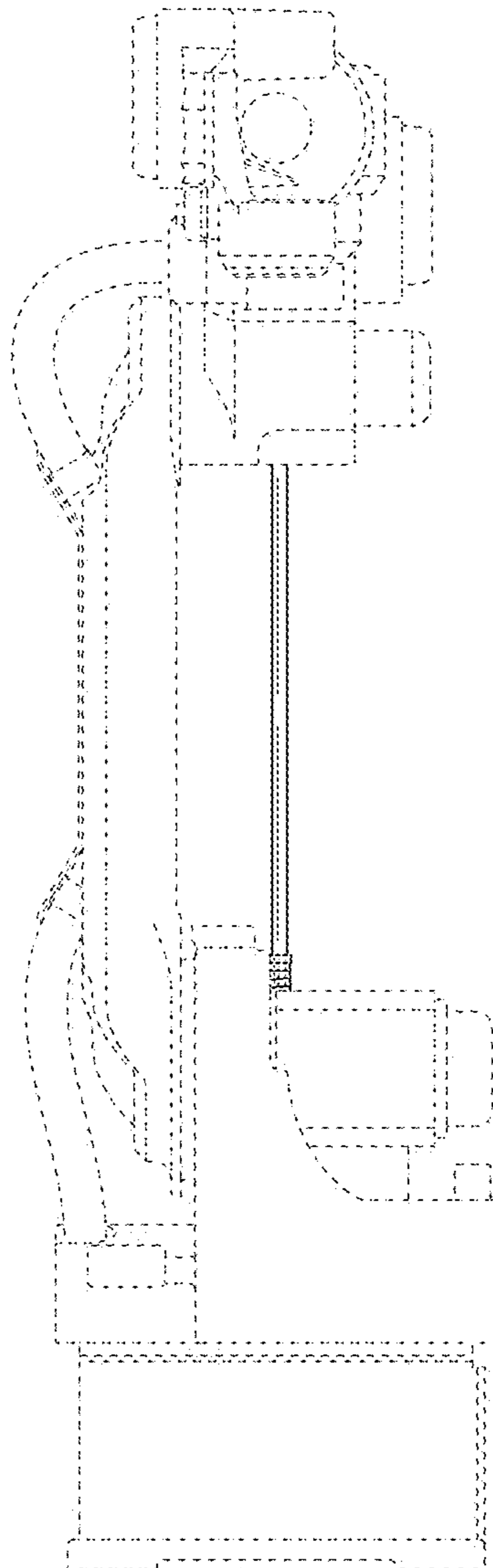

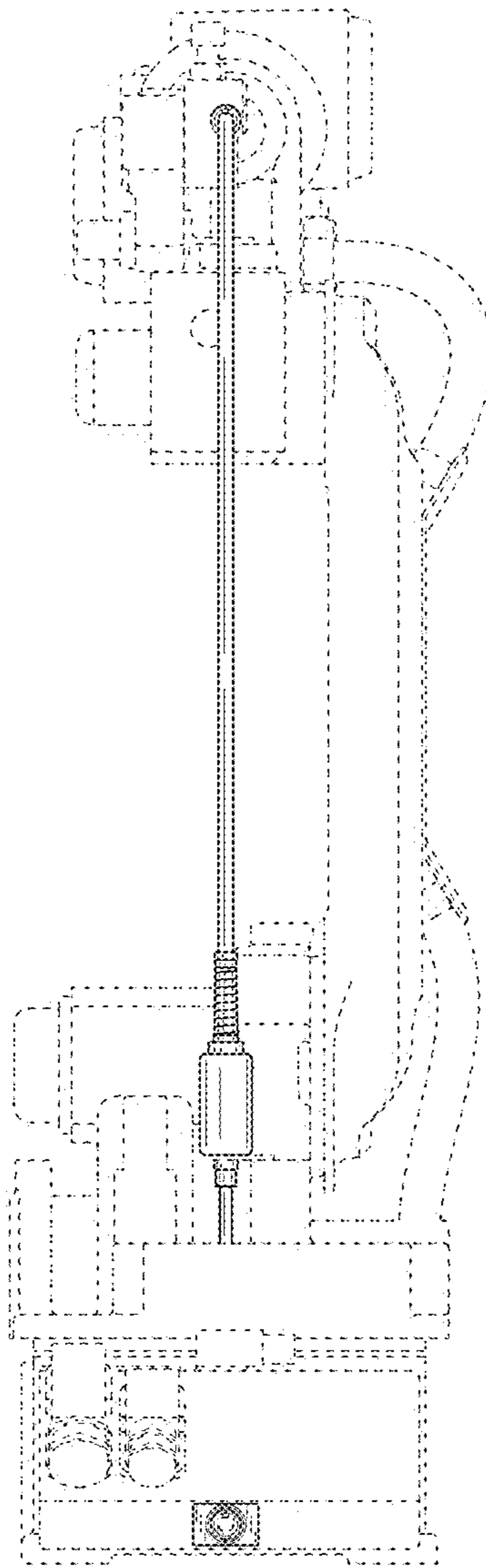

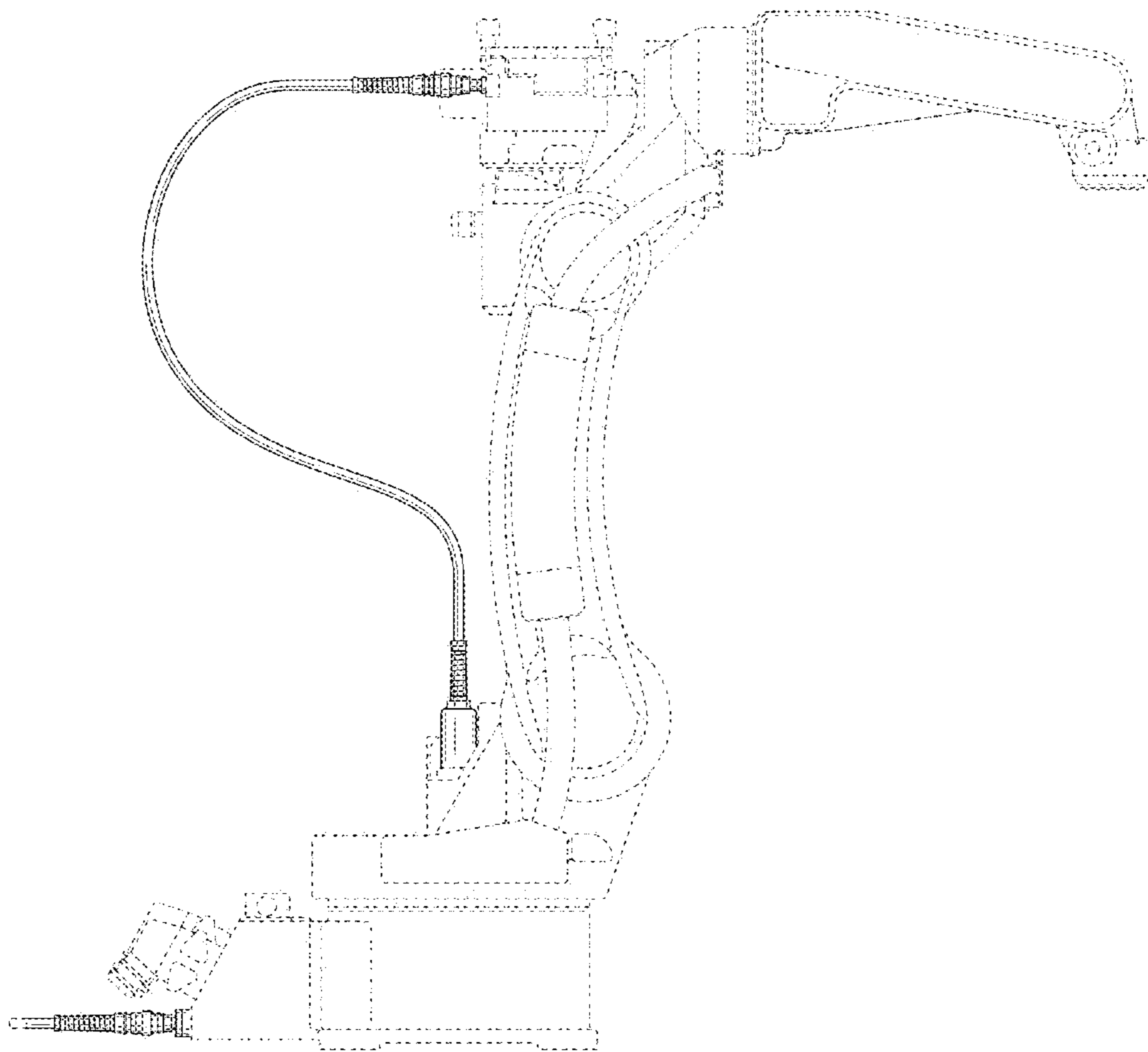

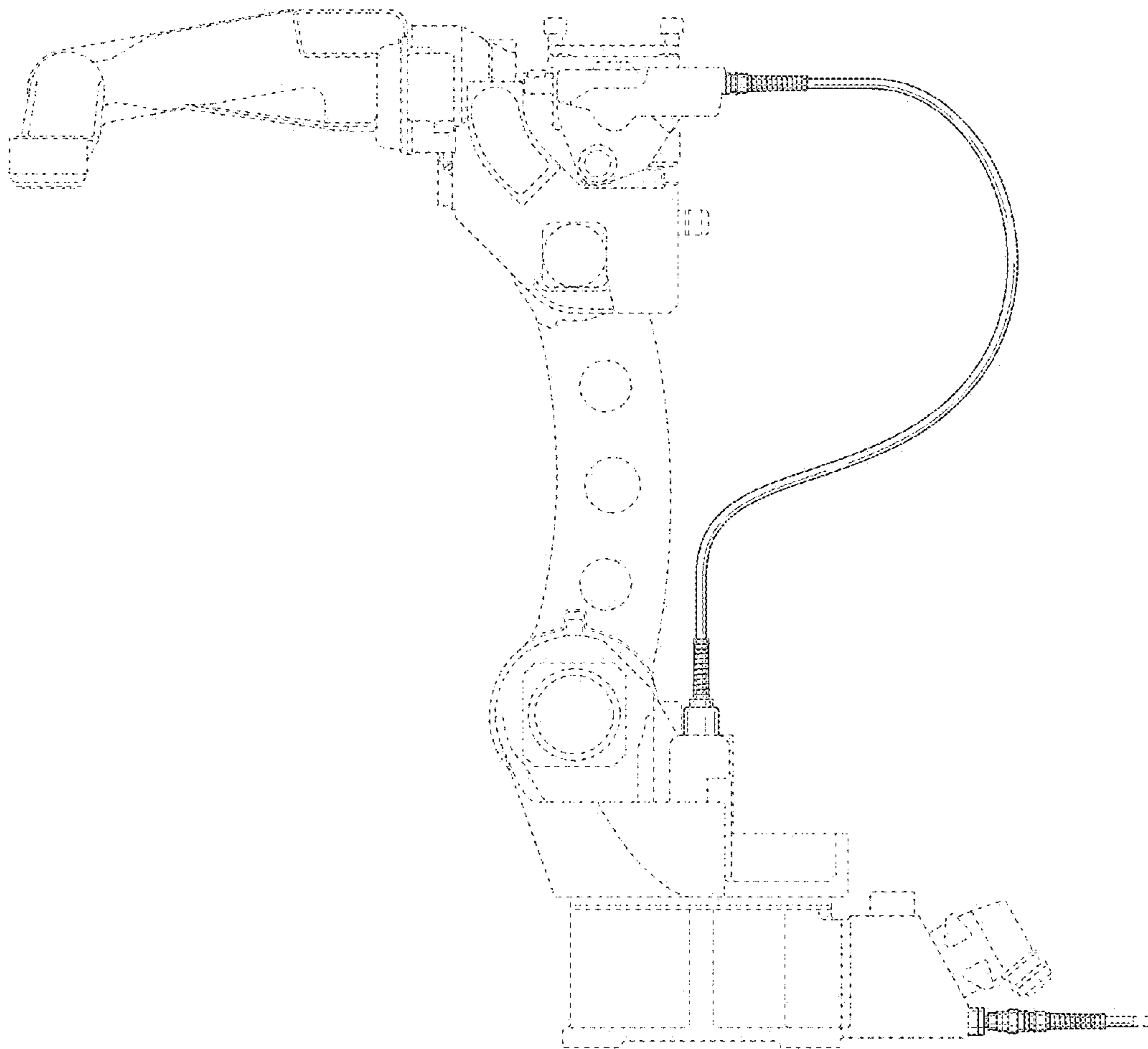

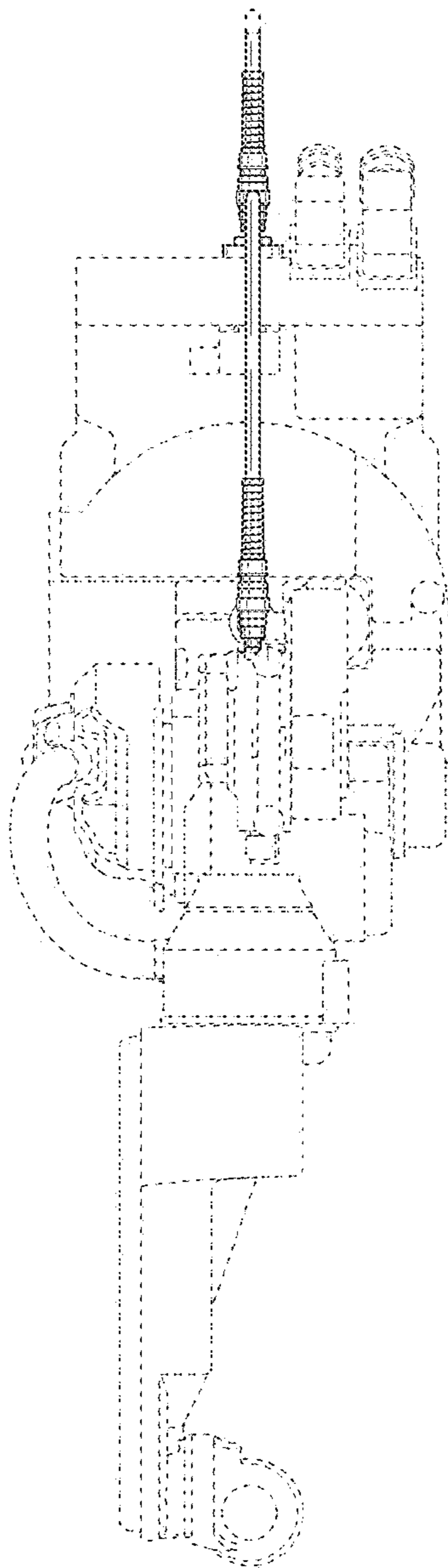
