(57) **CLAIM**

The ornamental design for a roper style cowboy boot roller skate, as shown and described.

DESCRIPTION

FIG. 1 shows an overhead perspective view of the cowboy boot skate.

FIG. 2 shows a right side view of the cowboy boot roller skate

FIG. 3 shows a left side view of the cowboy boot roller skate

FIG. 4 shows a bottom view of the cowboy boot roller skate, showing the skate plate and wheel portion.

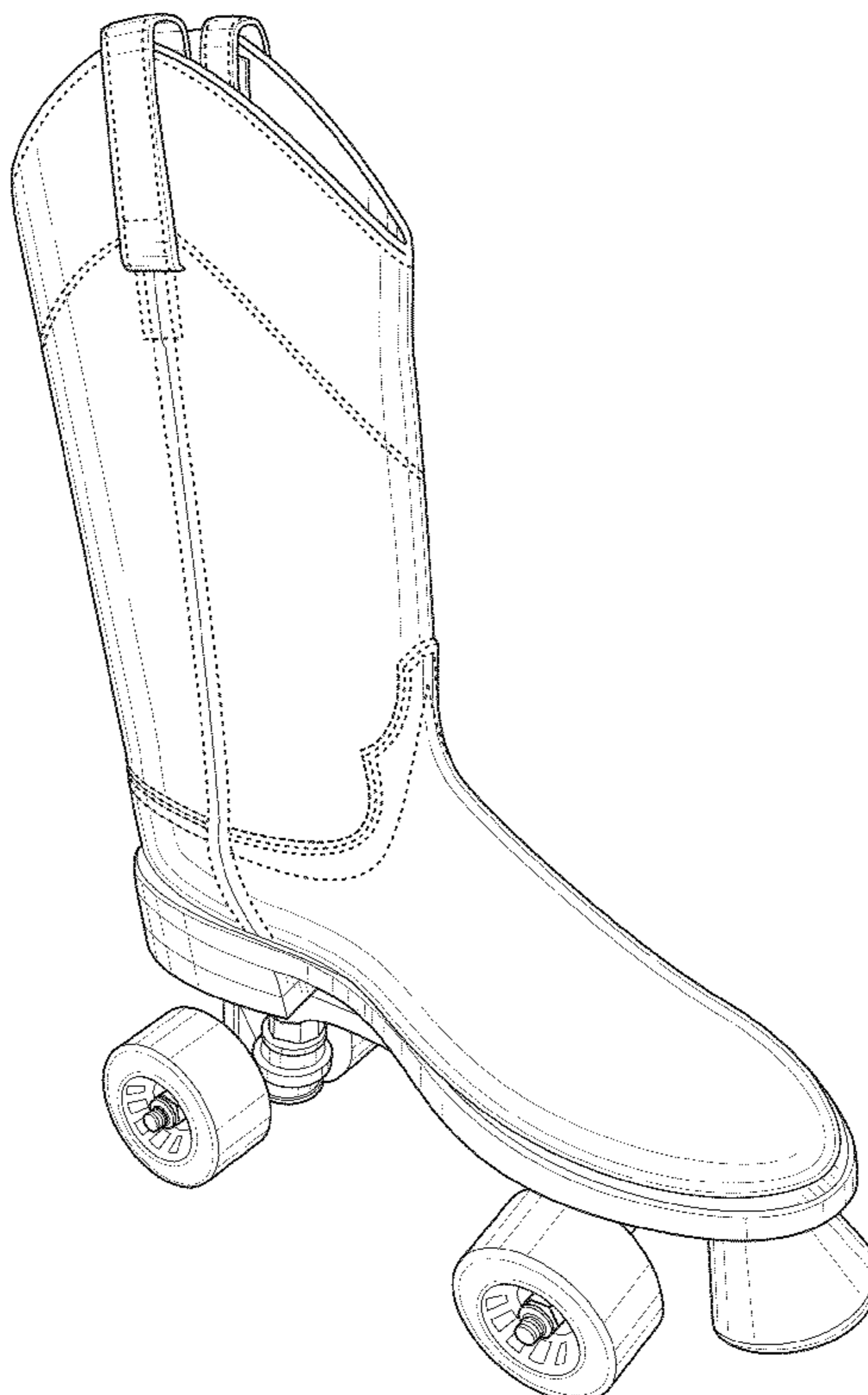
FIG. 5 shows a top view of the cowboy boot roller skate, showing the boot interior.

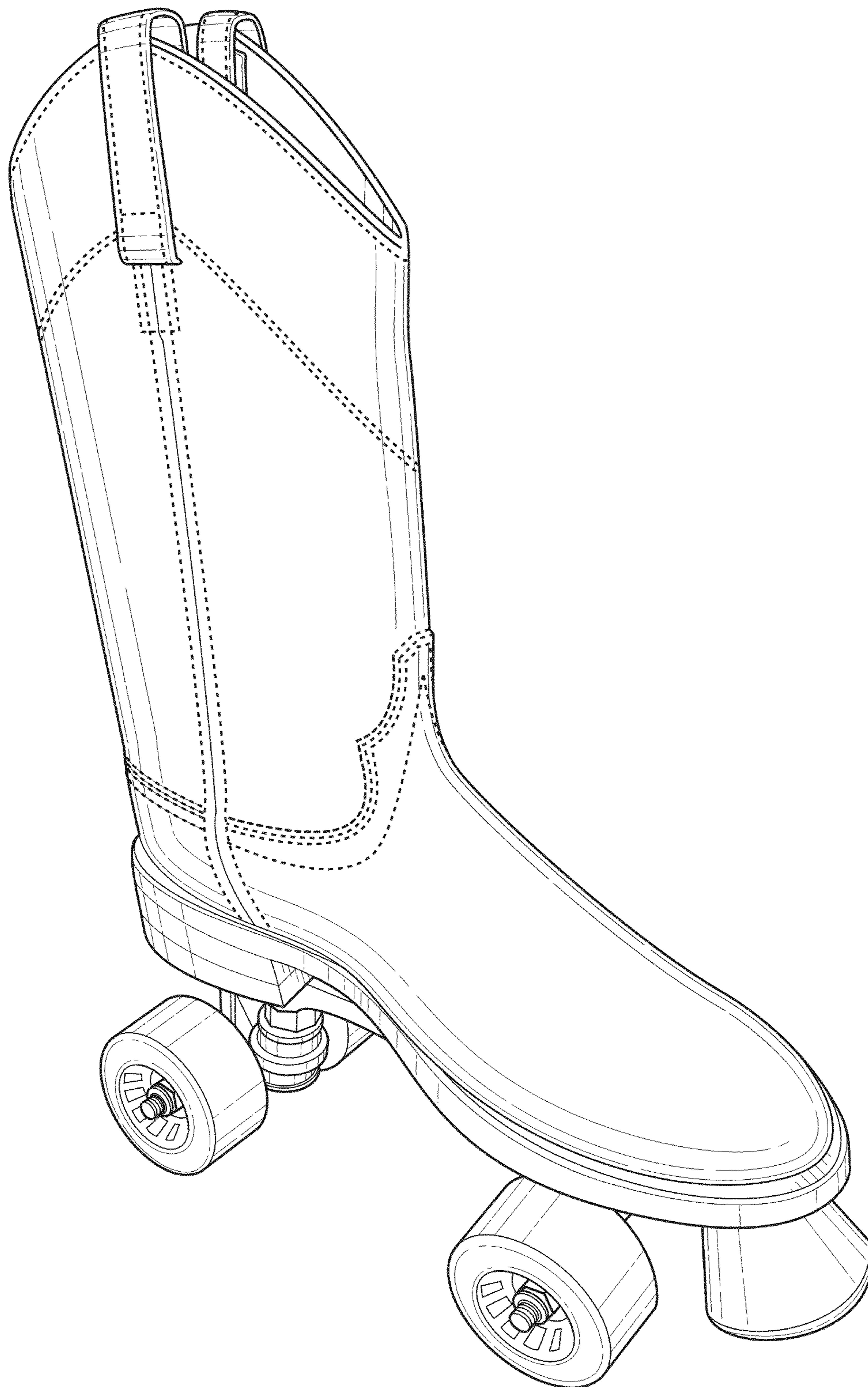

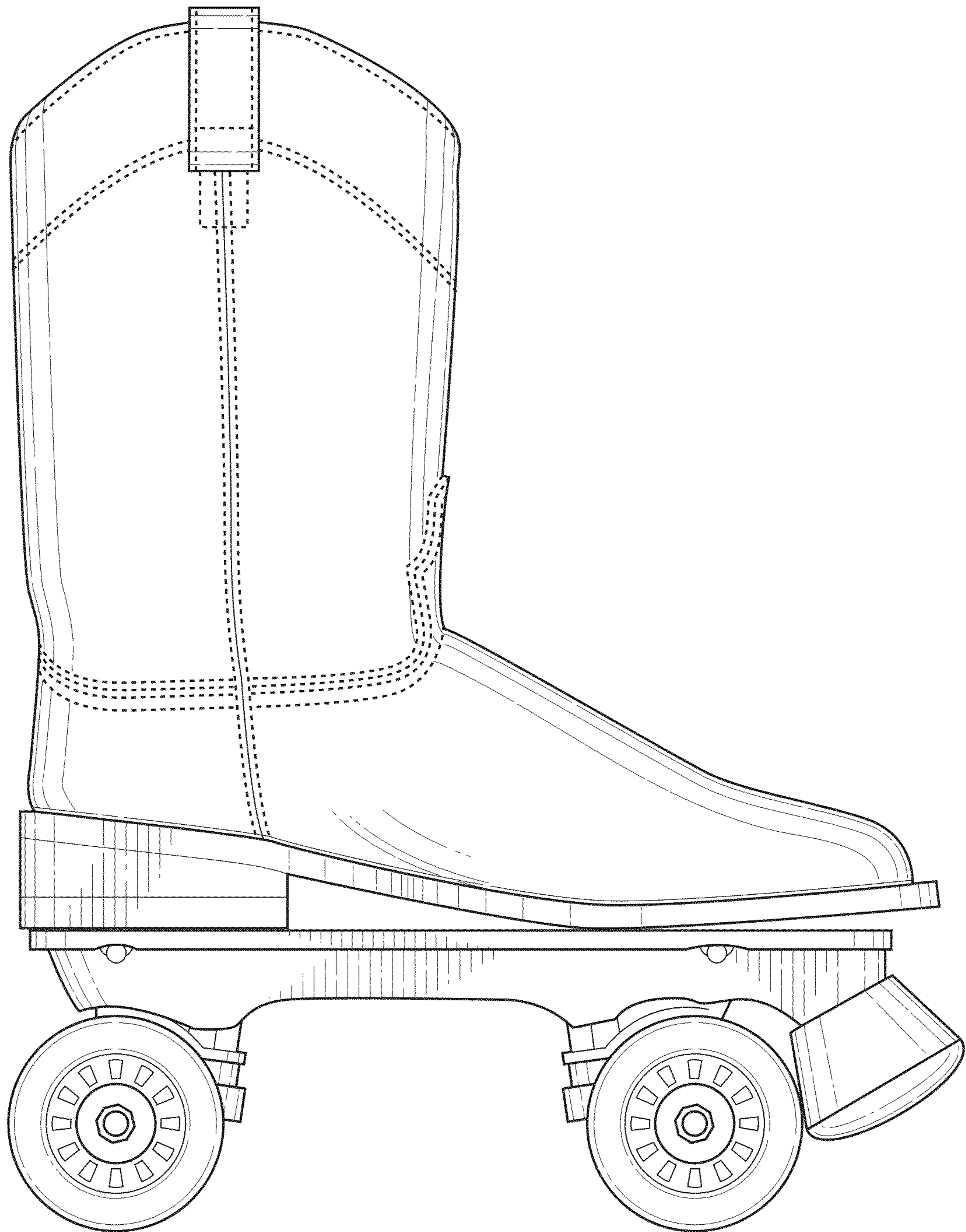

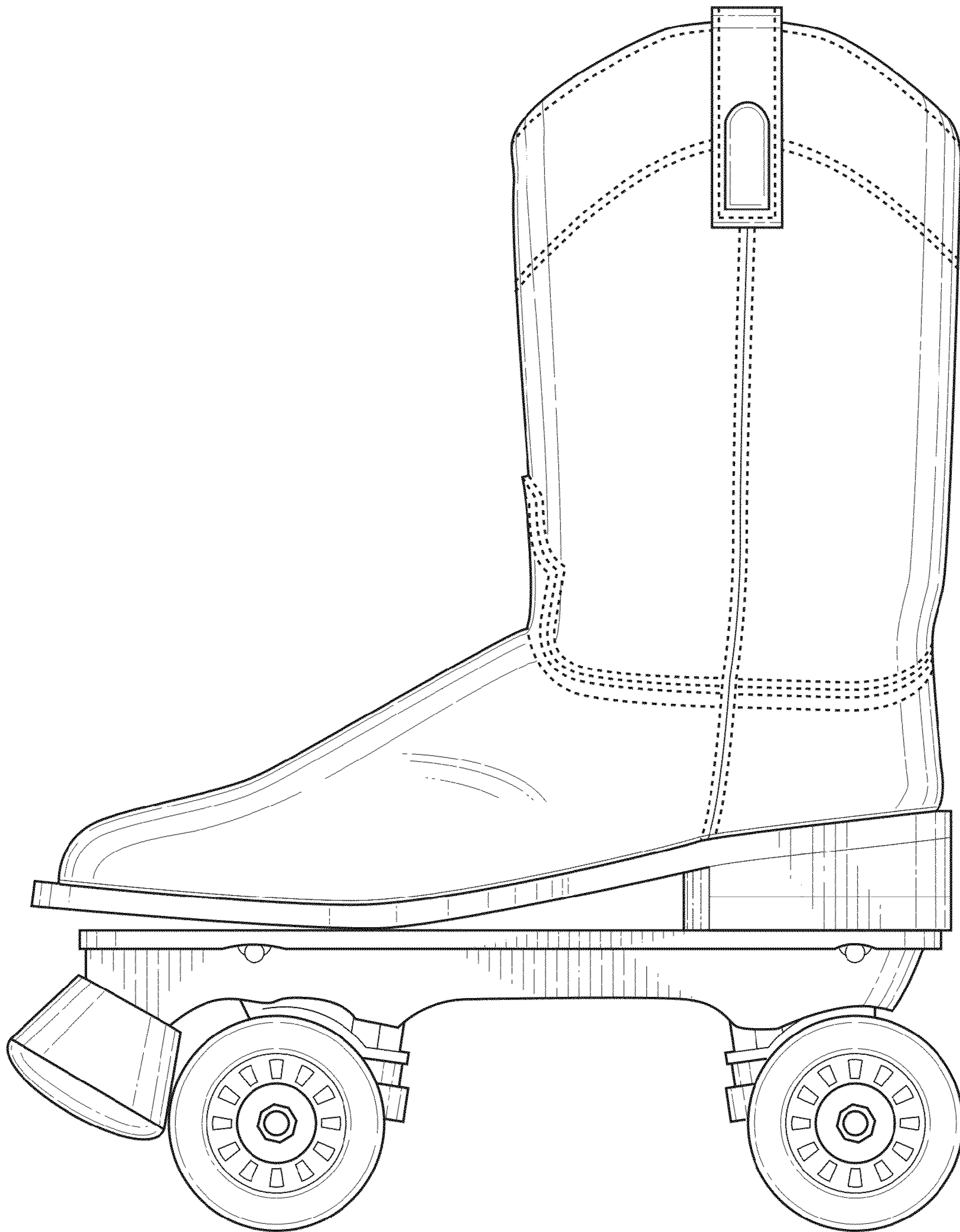

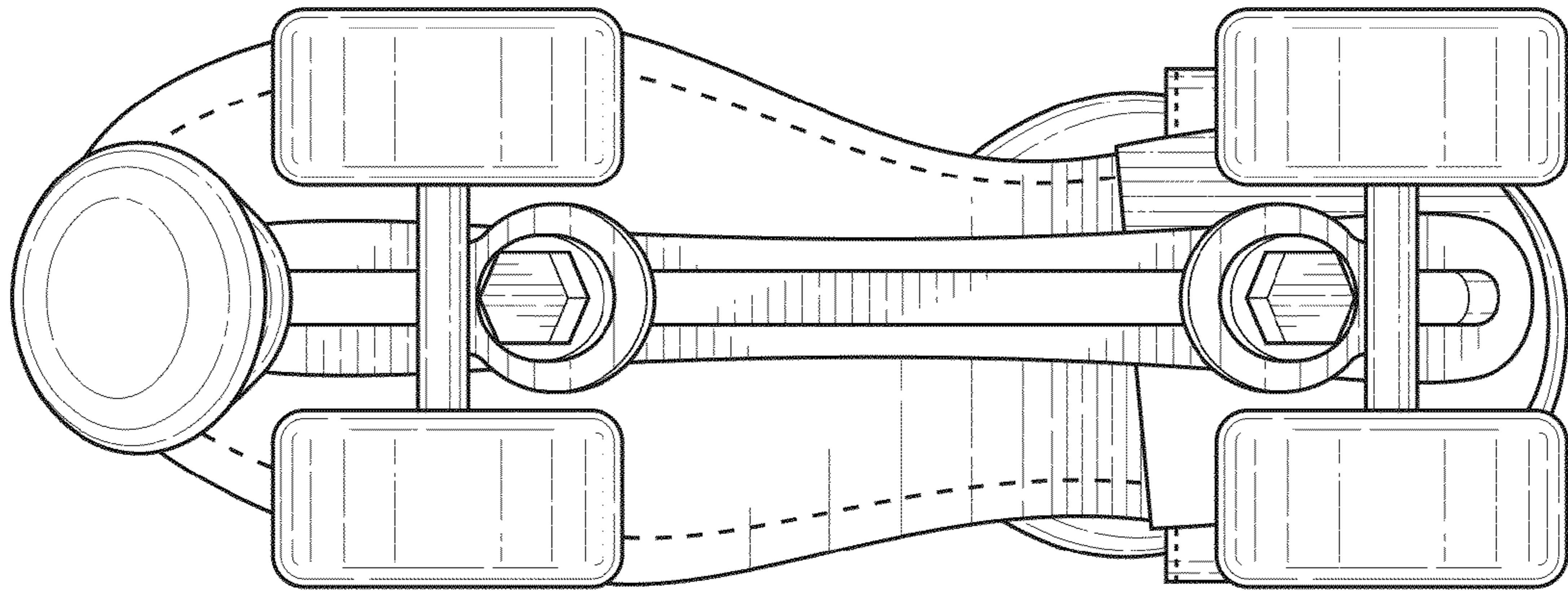

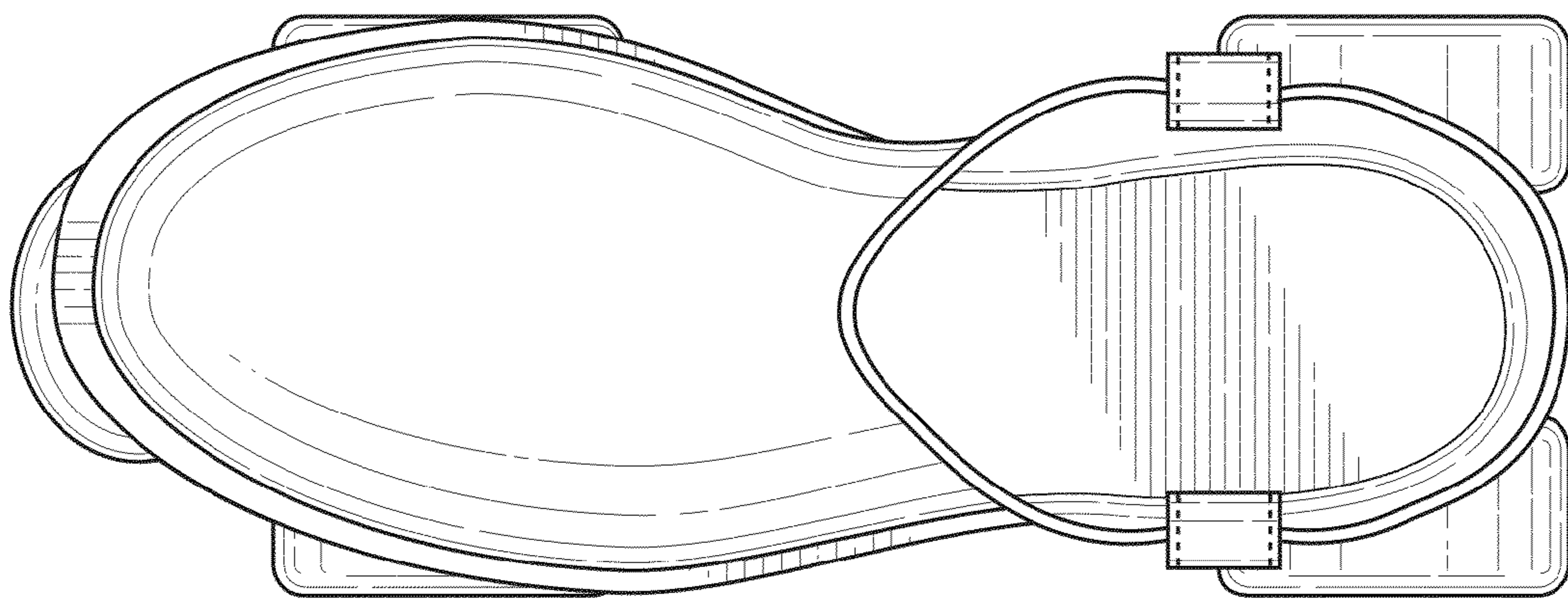

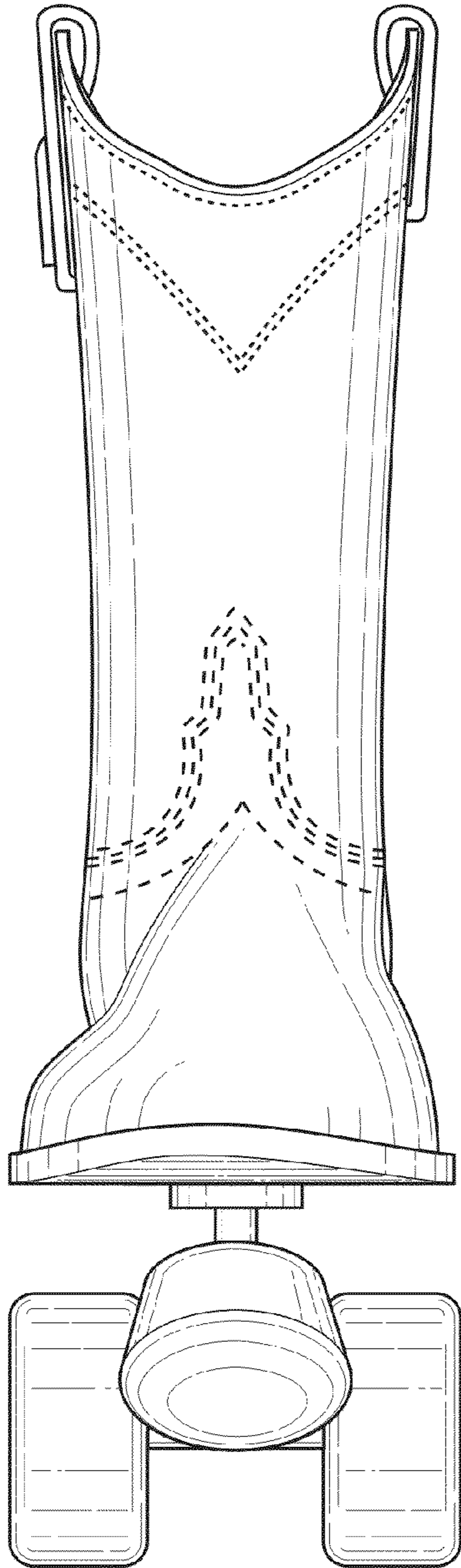

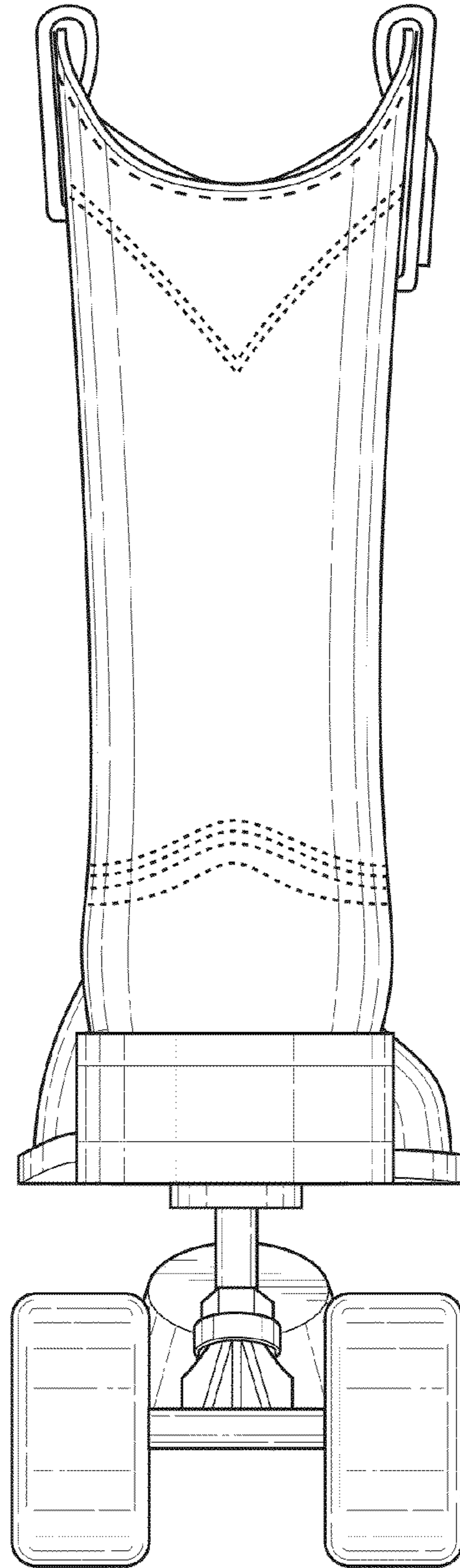
