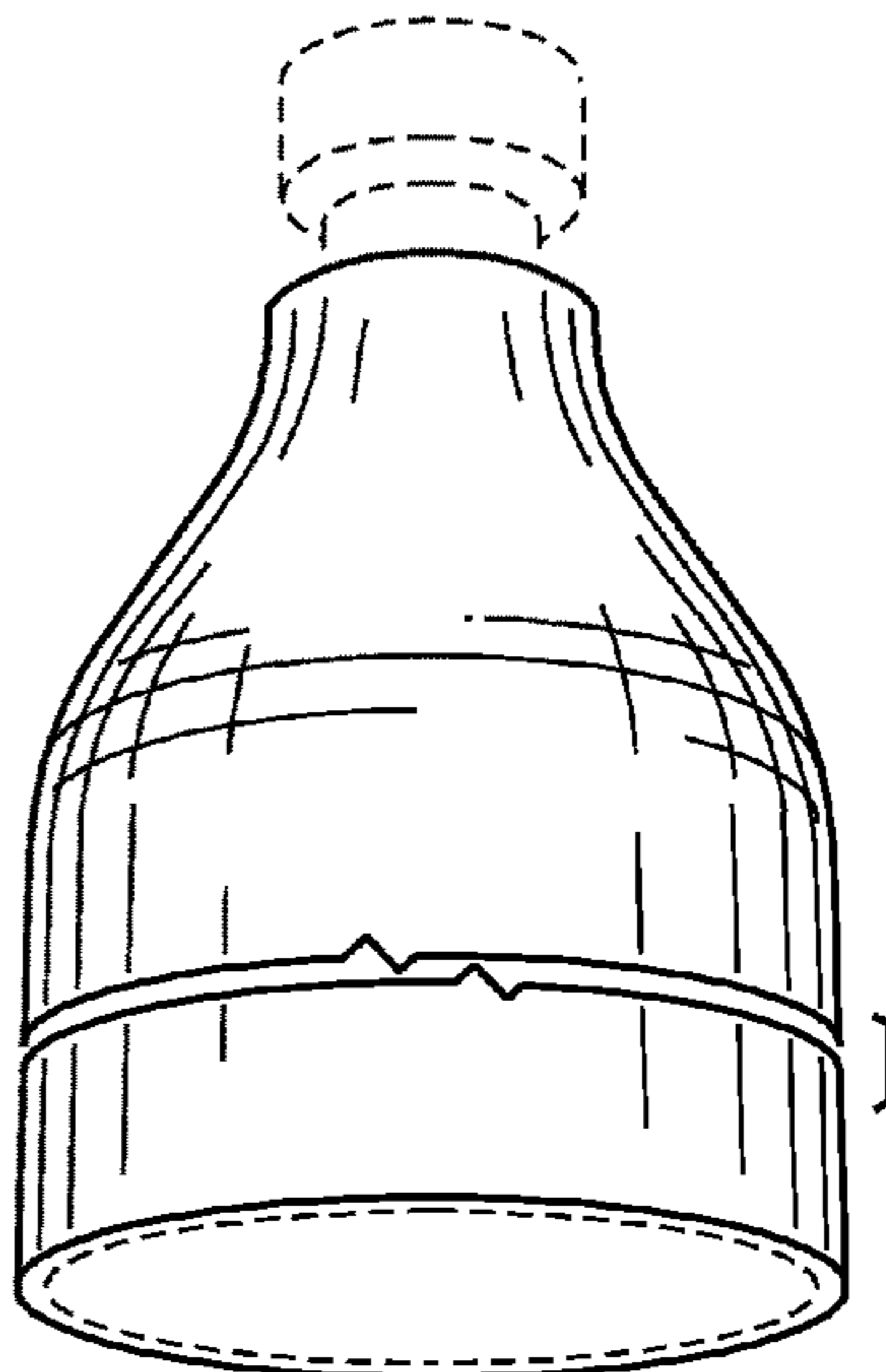
FIG. 1 is a top perspective view of a showerhead according to an exemplary embodiment;

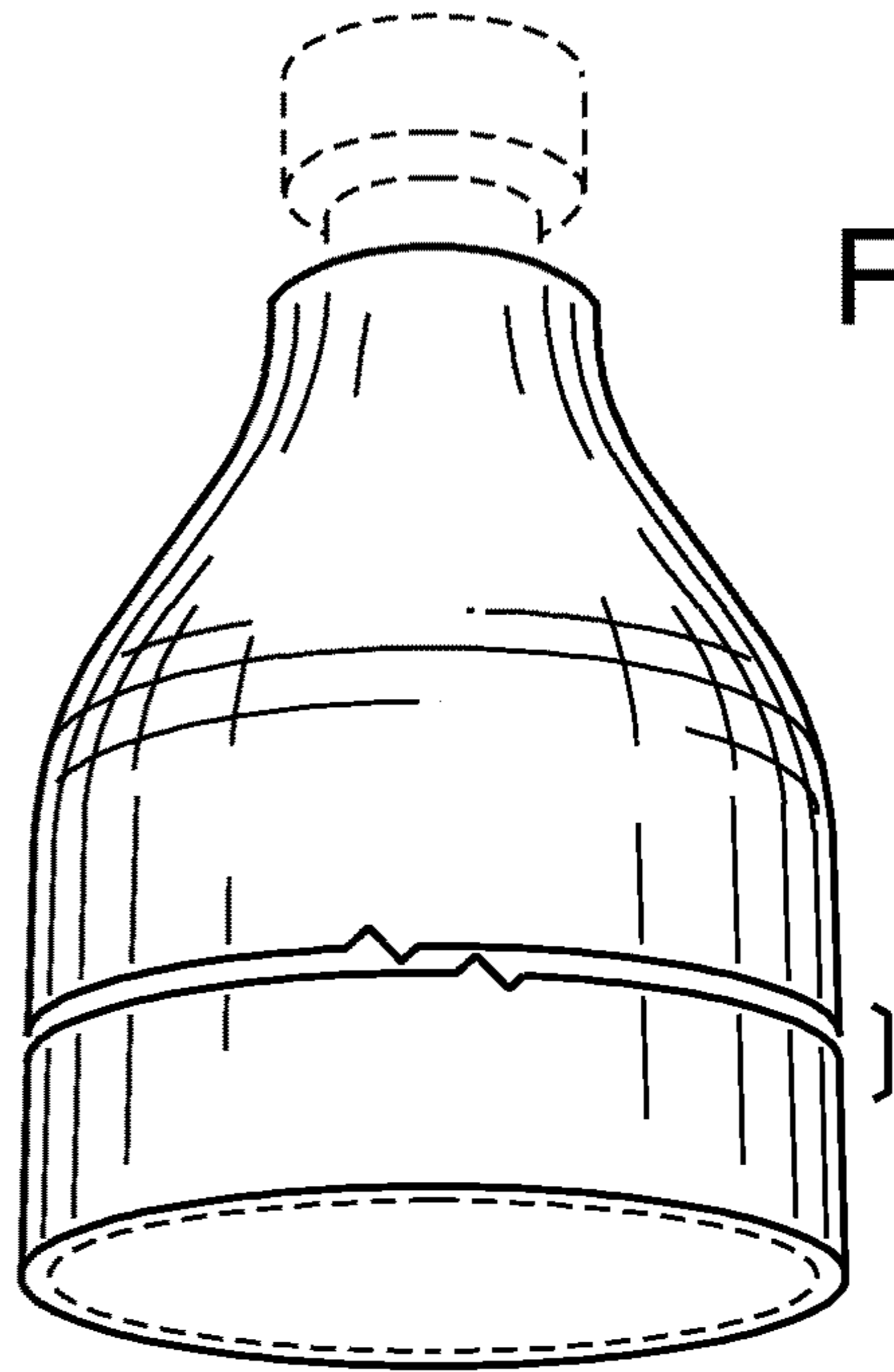

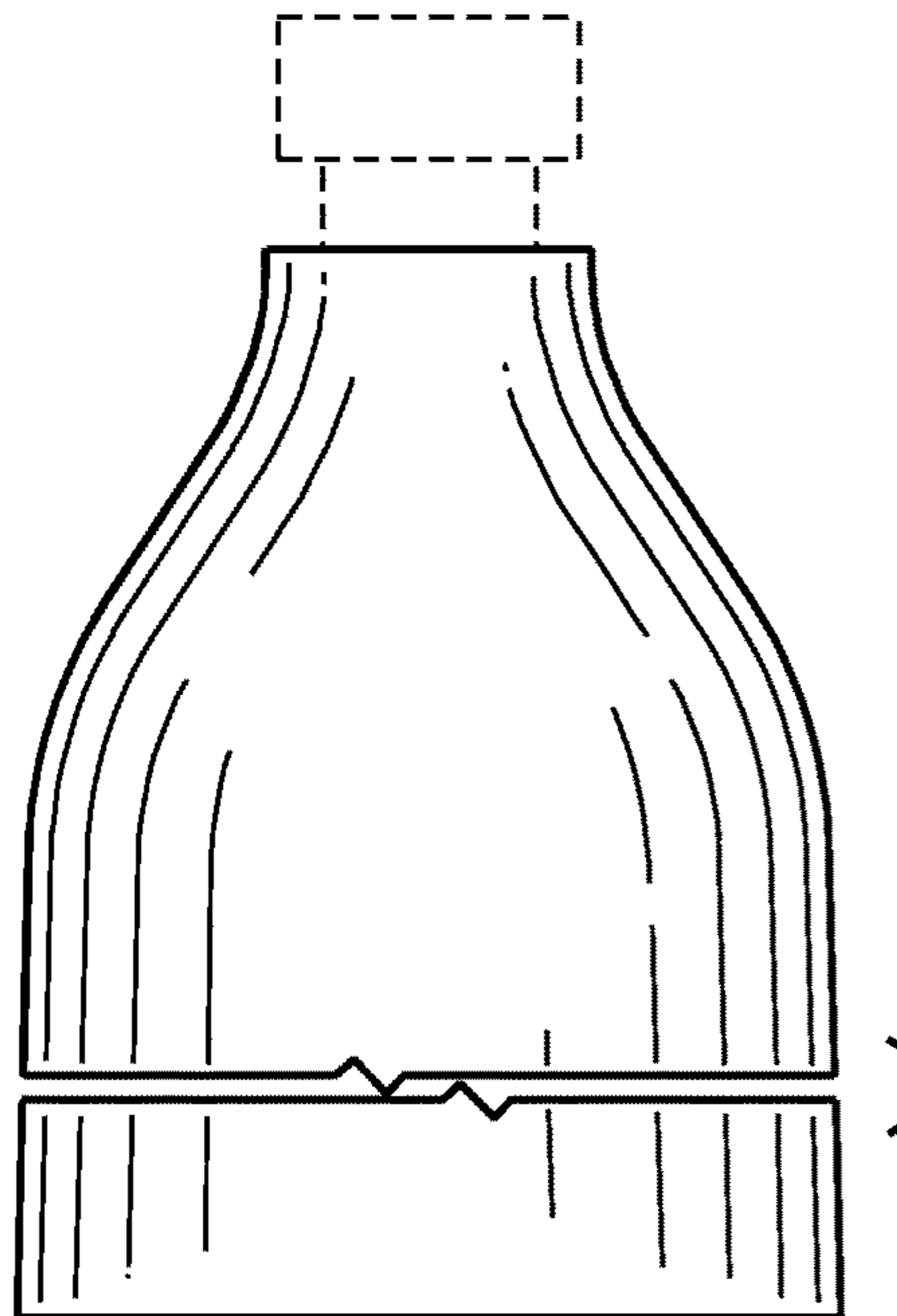

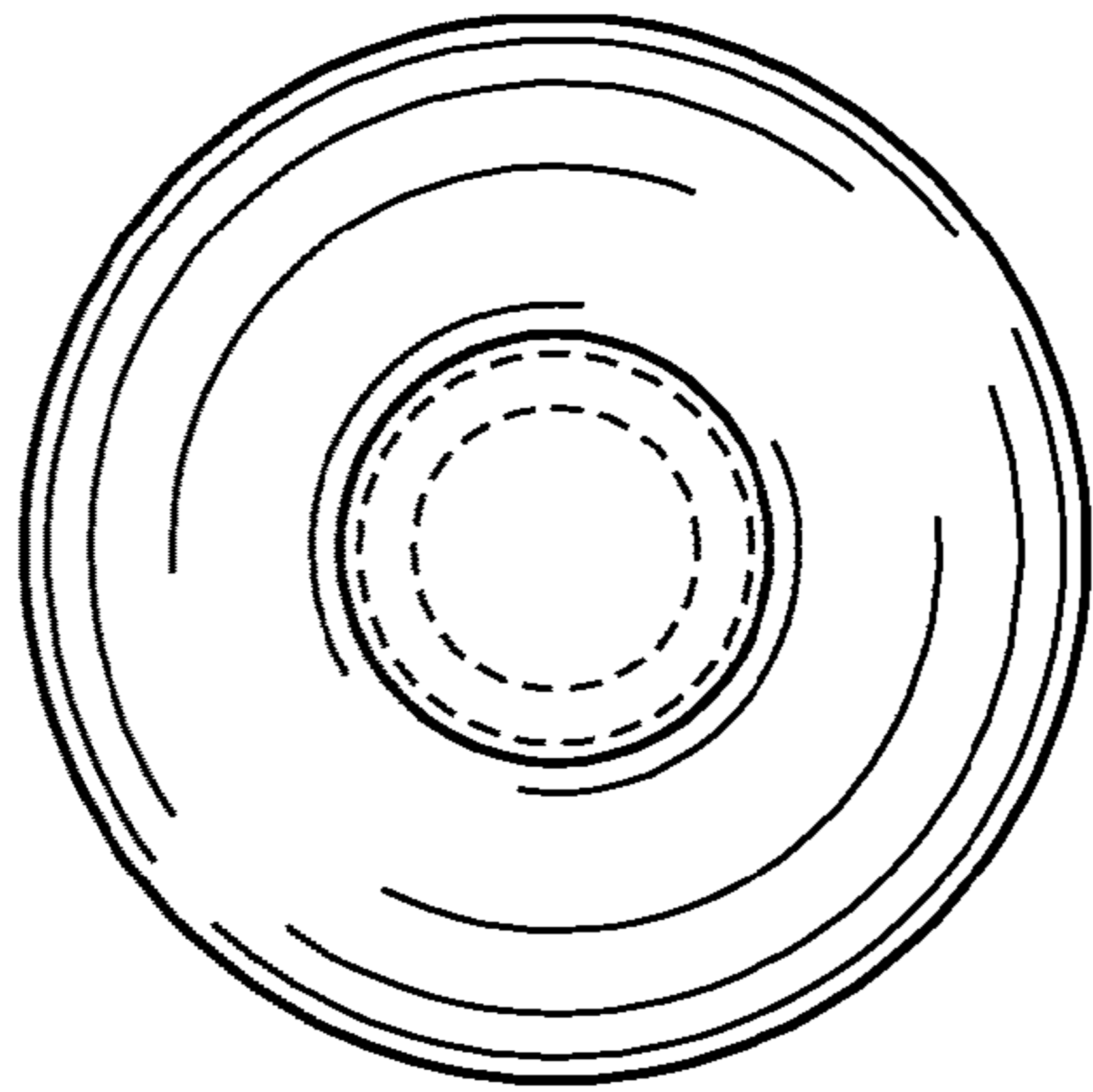

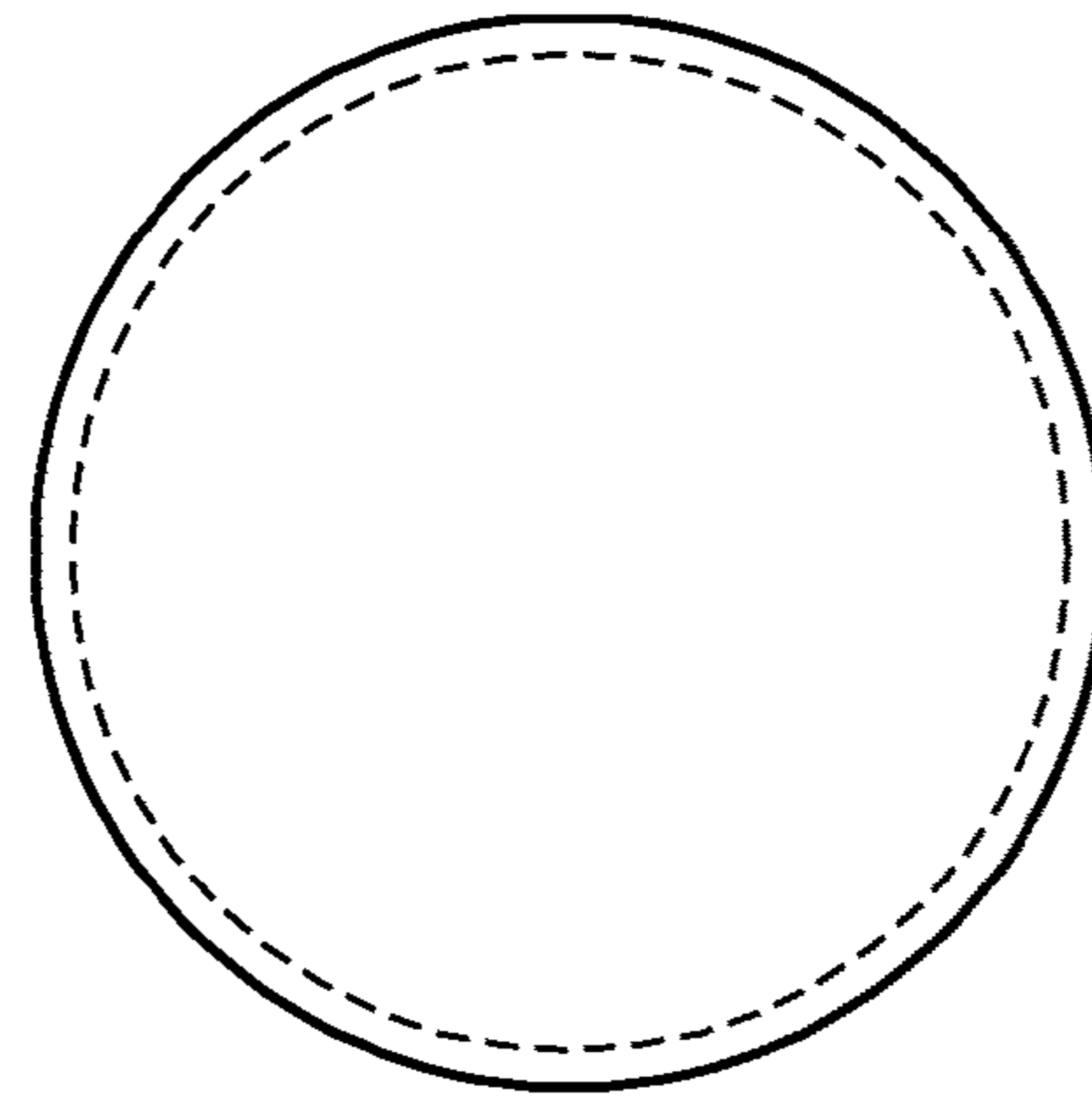
