(57) **CLAIM**

I claim the ornamental design for light therapy lamp, as shown.

DESCRIPTION

FIG. 4 is a front elevational view thereof;

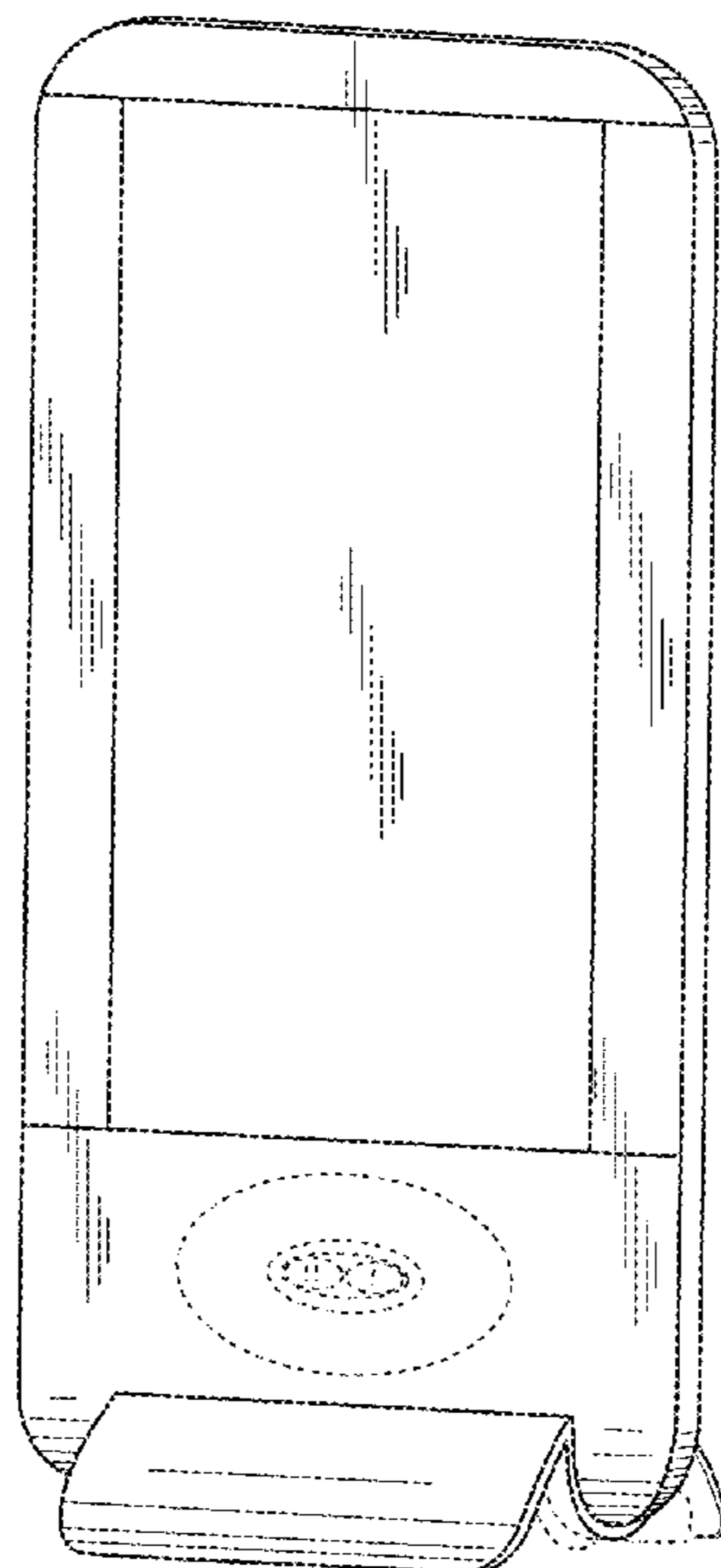
FIG. 5 is a back elevational view thereof;

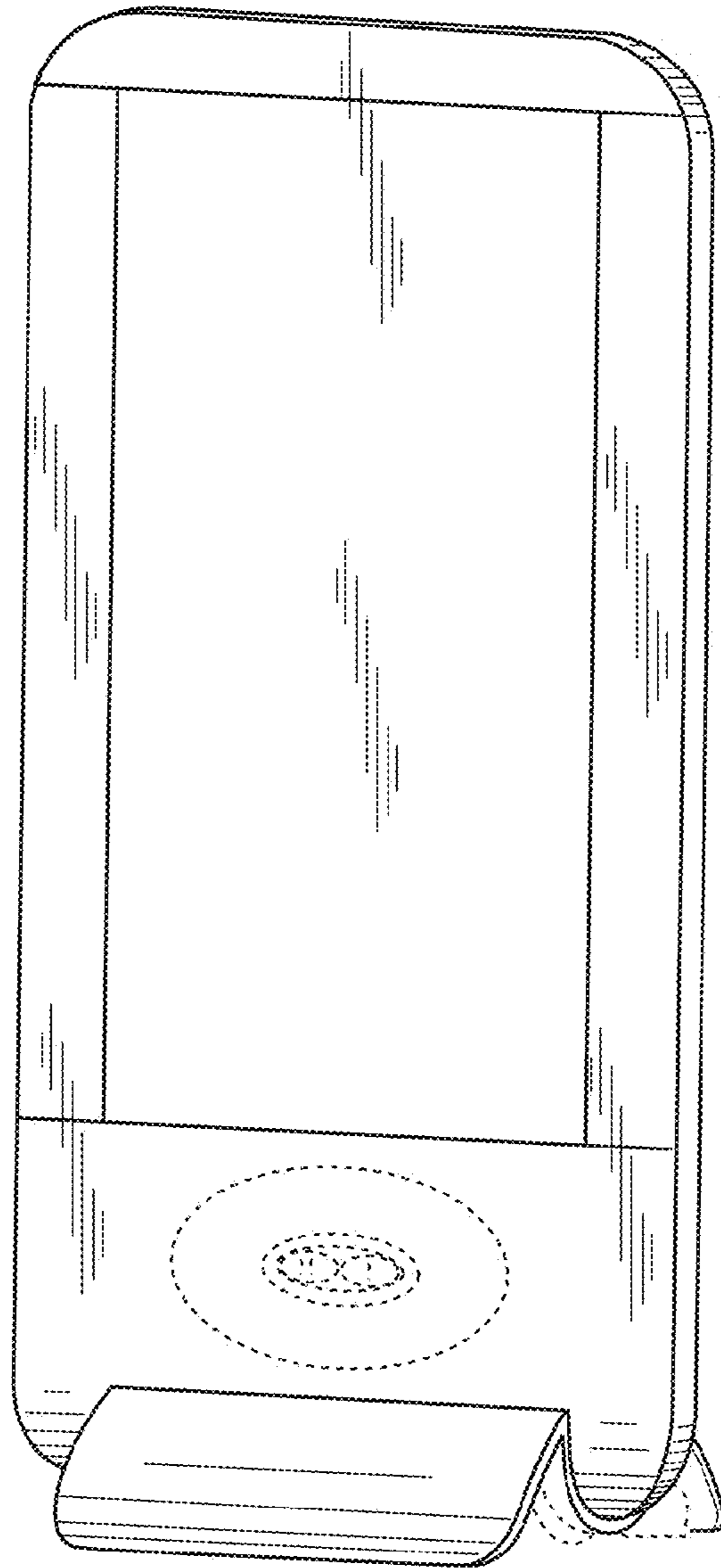

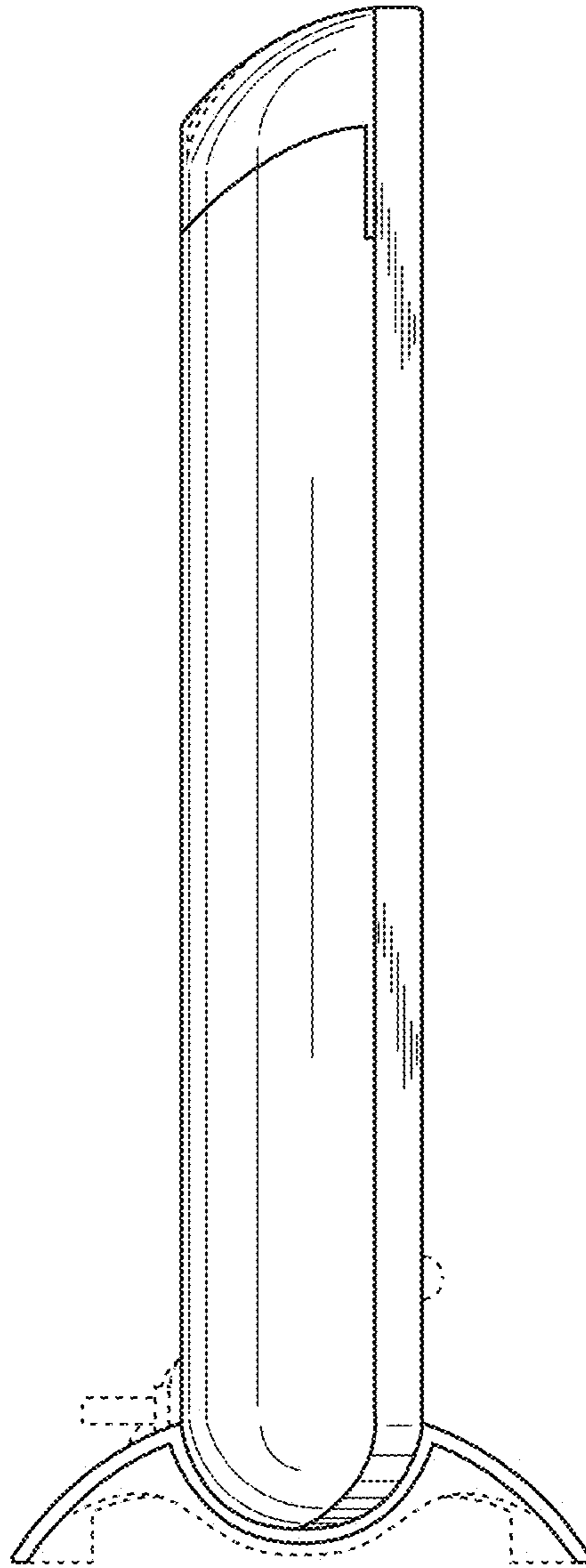

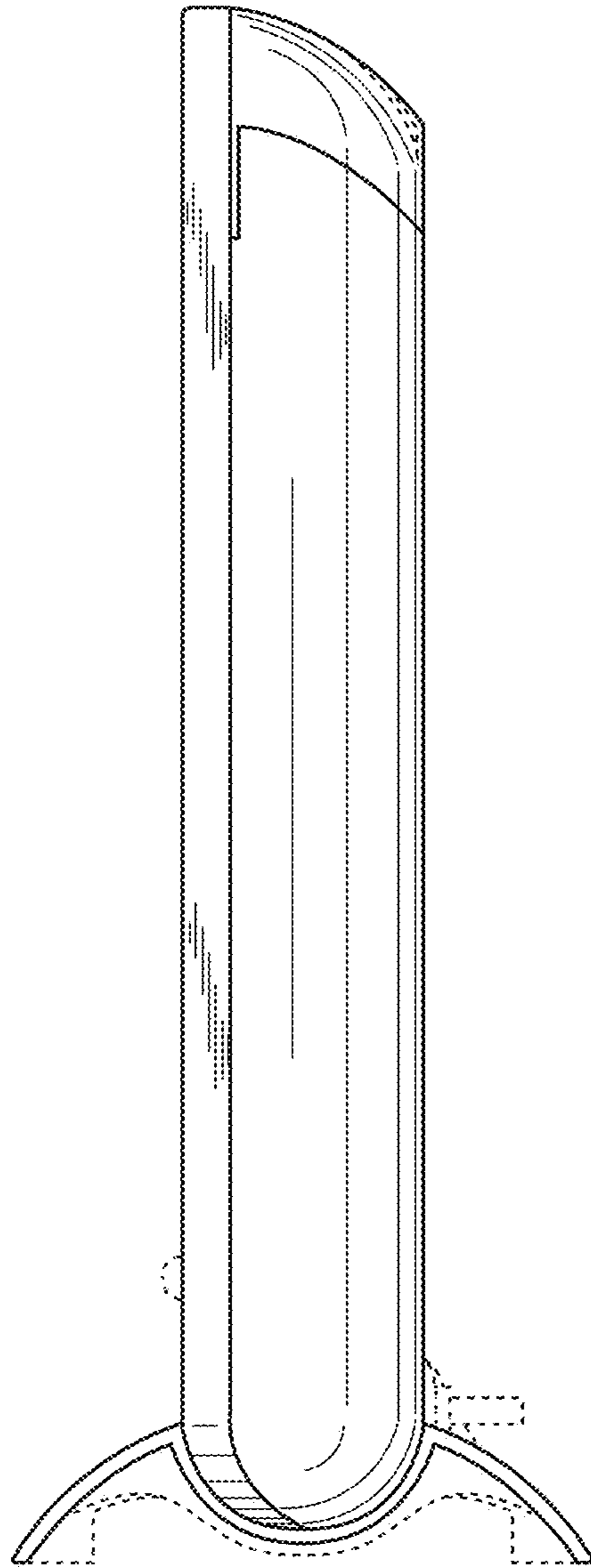

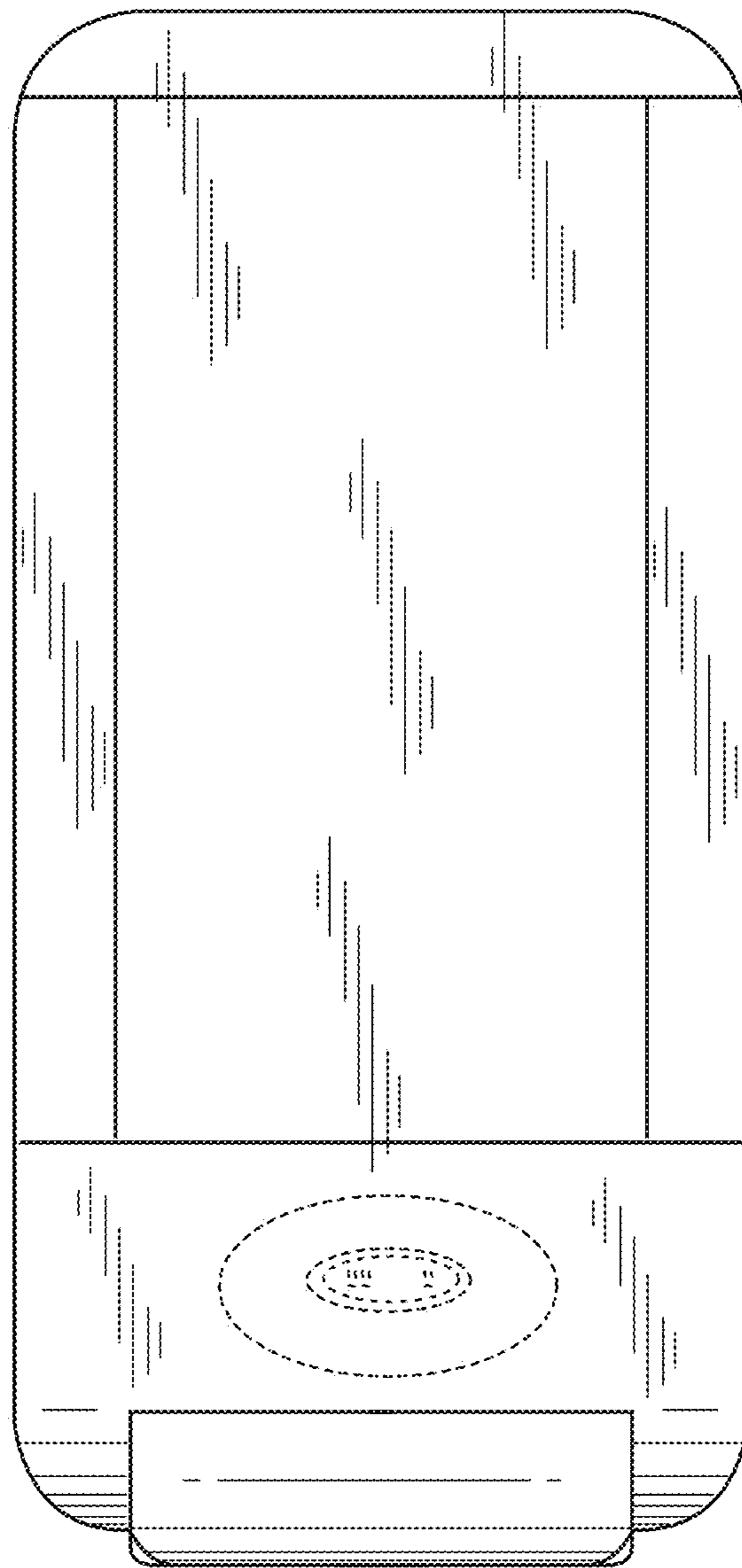

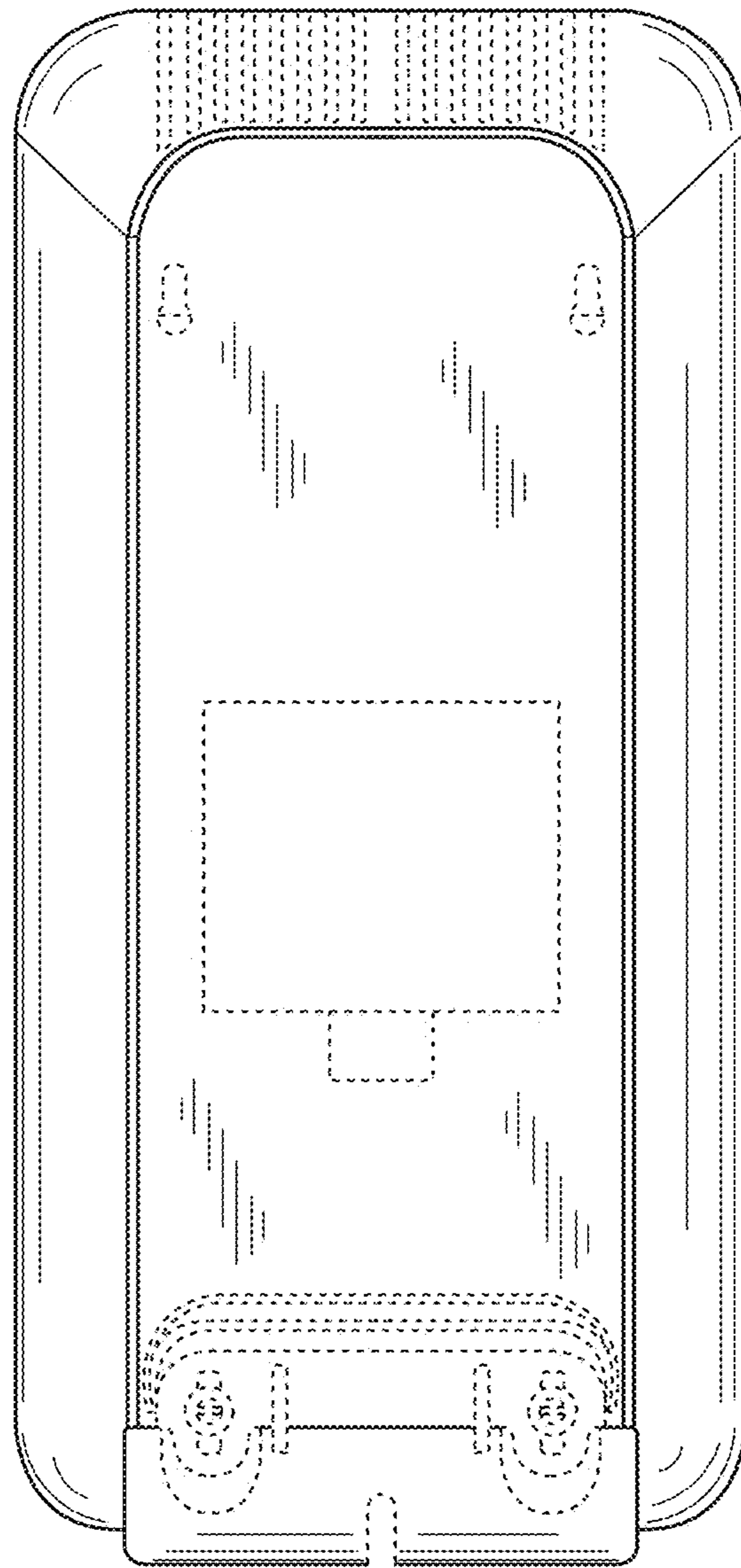

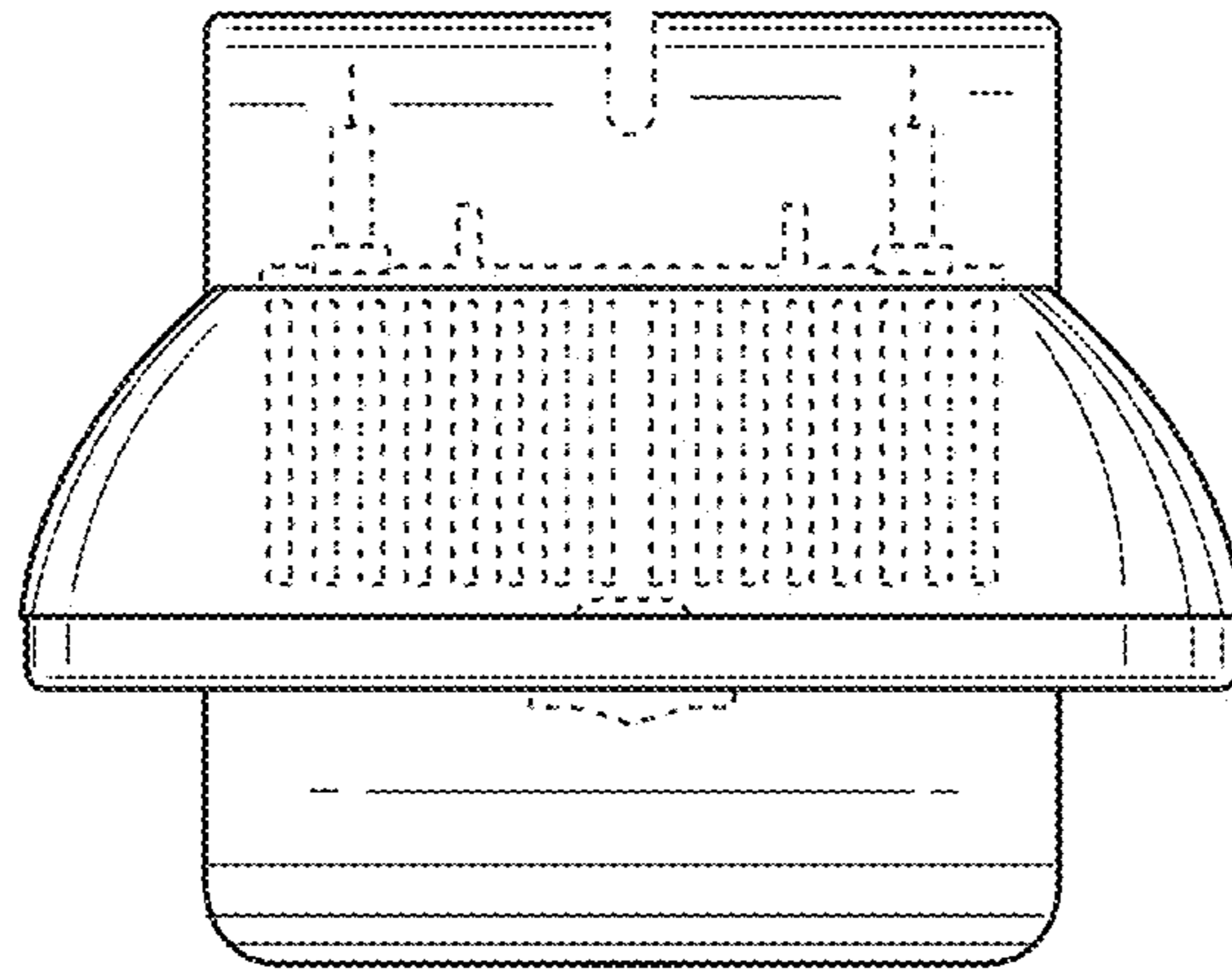

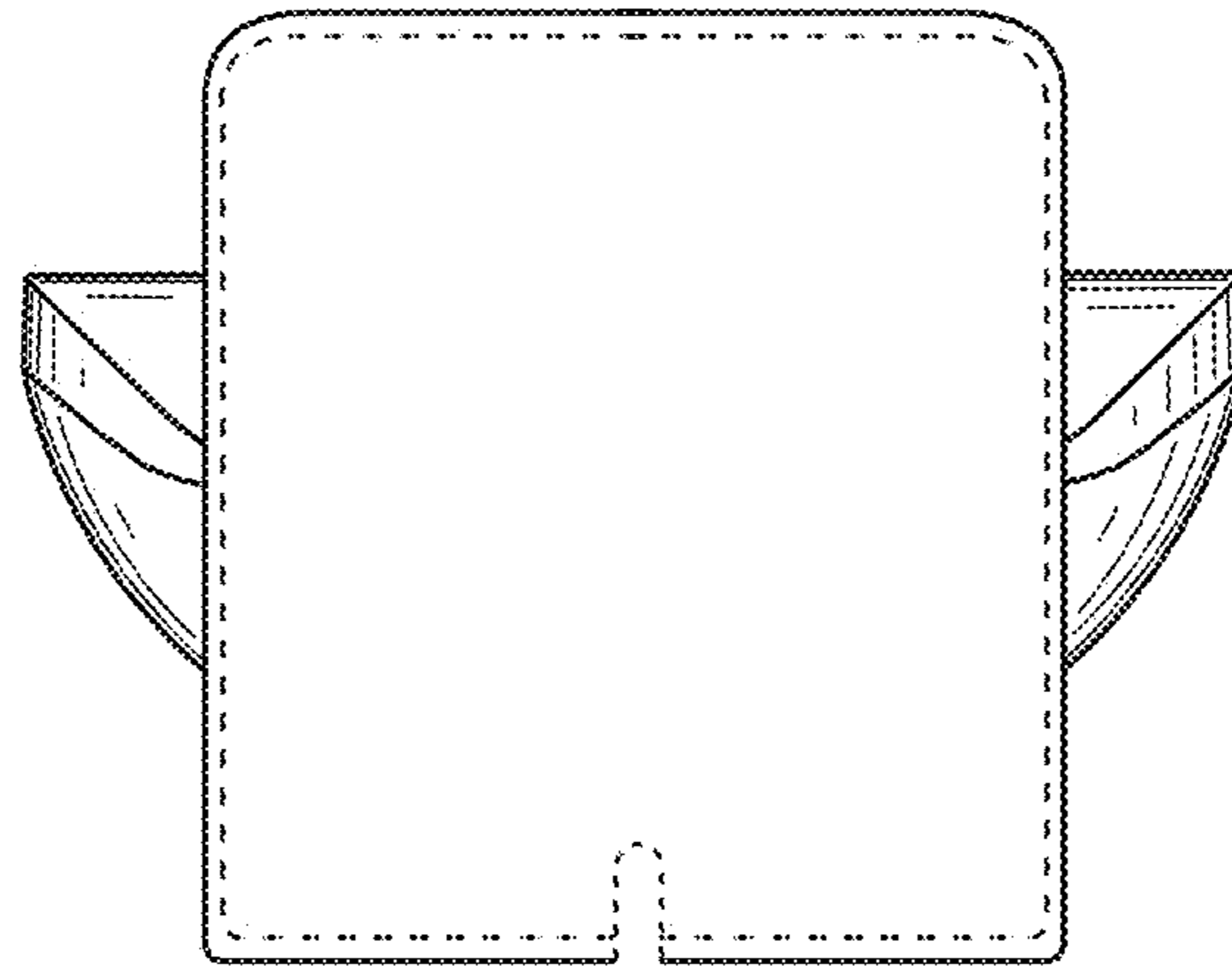
