(57) **CLAIM**

The ornamental design for a lighted chandelier, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, perspective view of the lighted chandelier of the invention;

FIG. 2 is a front, side view of the lighted chandelier of FIG. 1; FIG. 3 is a back, side view of the lighted chandelier fan of FIG. 1;

FIG. 4 is a right, side view of the lighted chandelier of the invention;

FIG. 5 is a left, side view of the lighted chandelier of the invention;

FIG. 6 is a top view of the lighted chandelier of the invention;

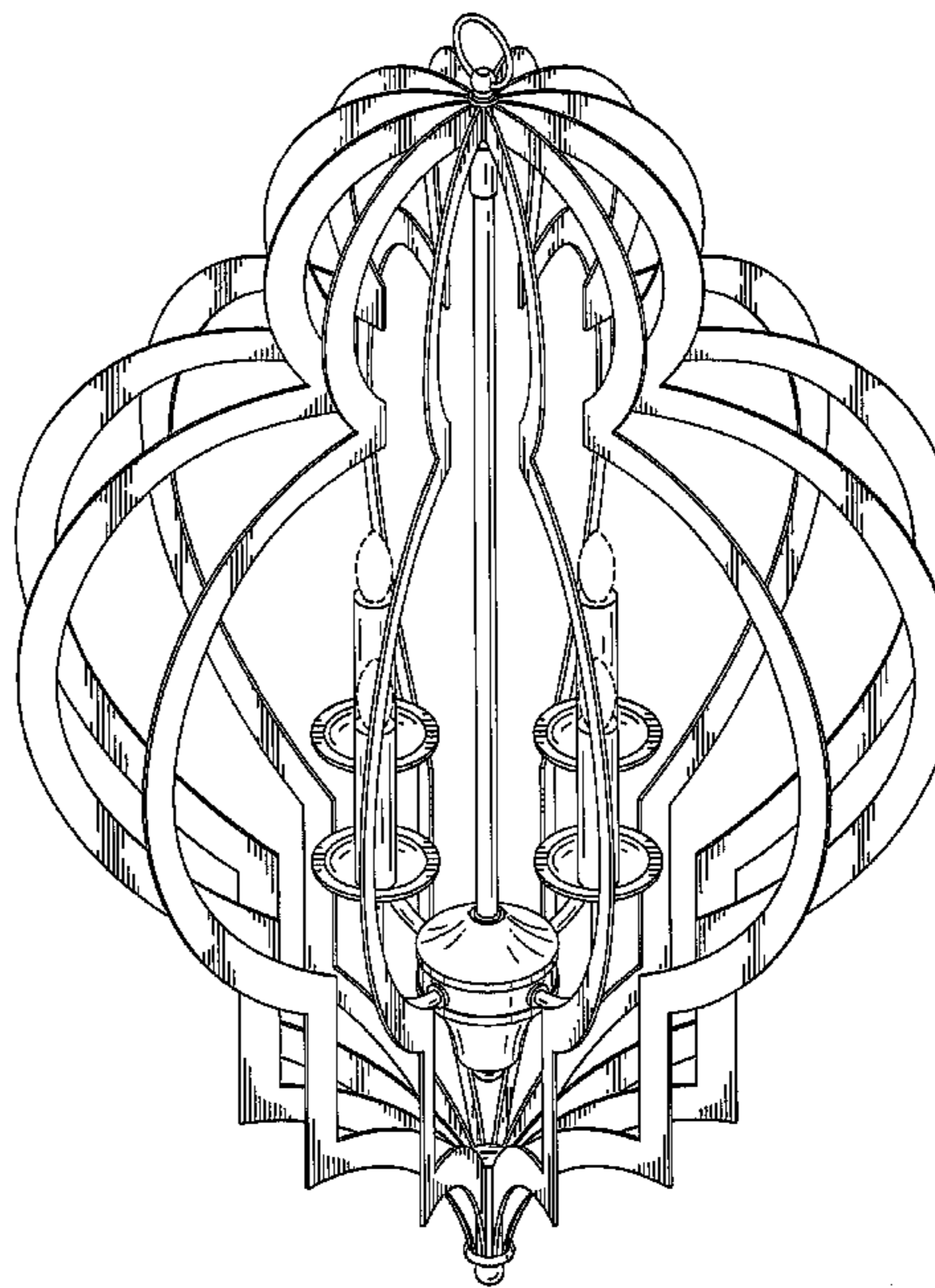
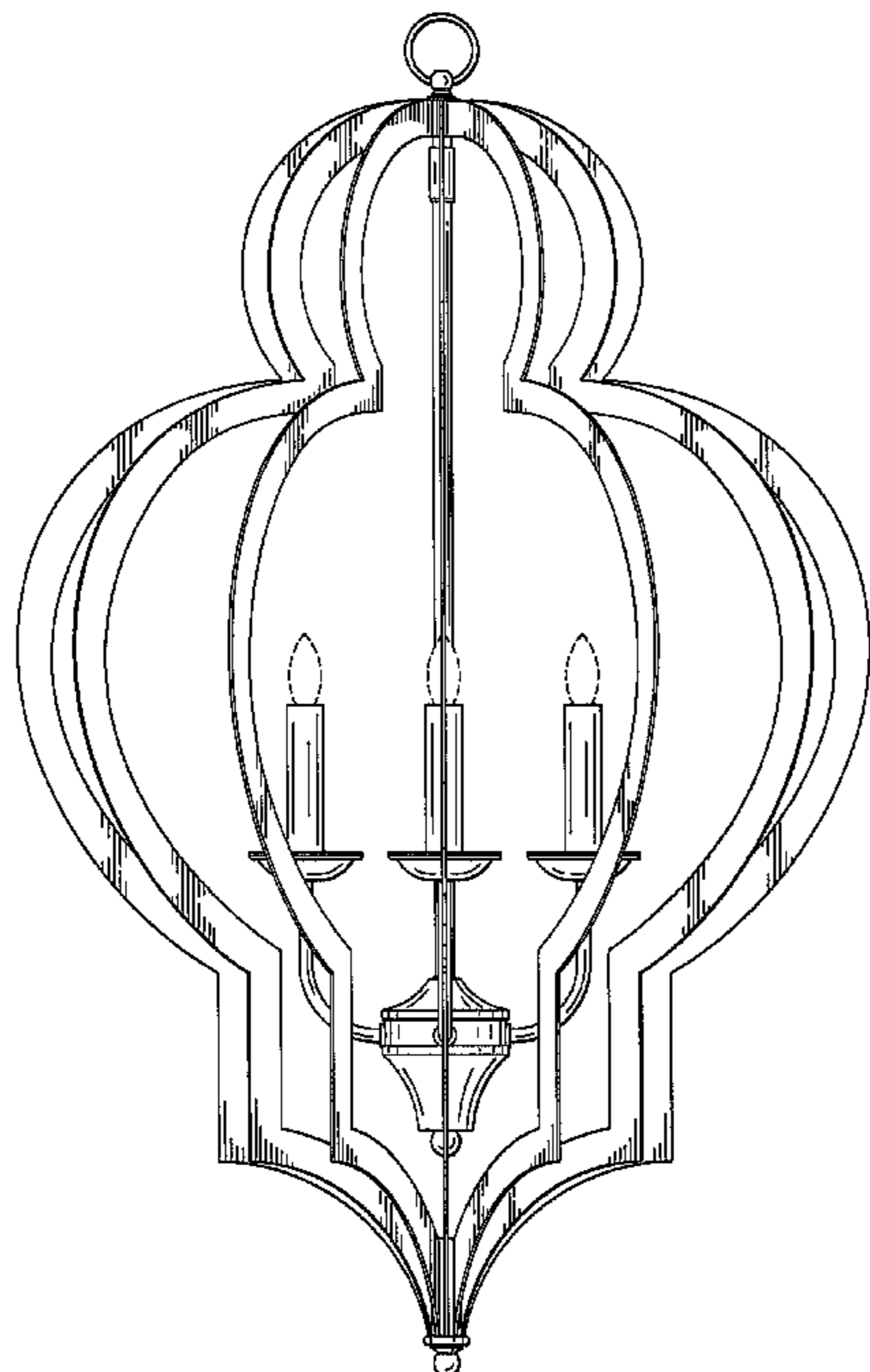

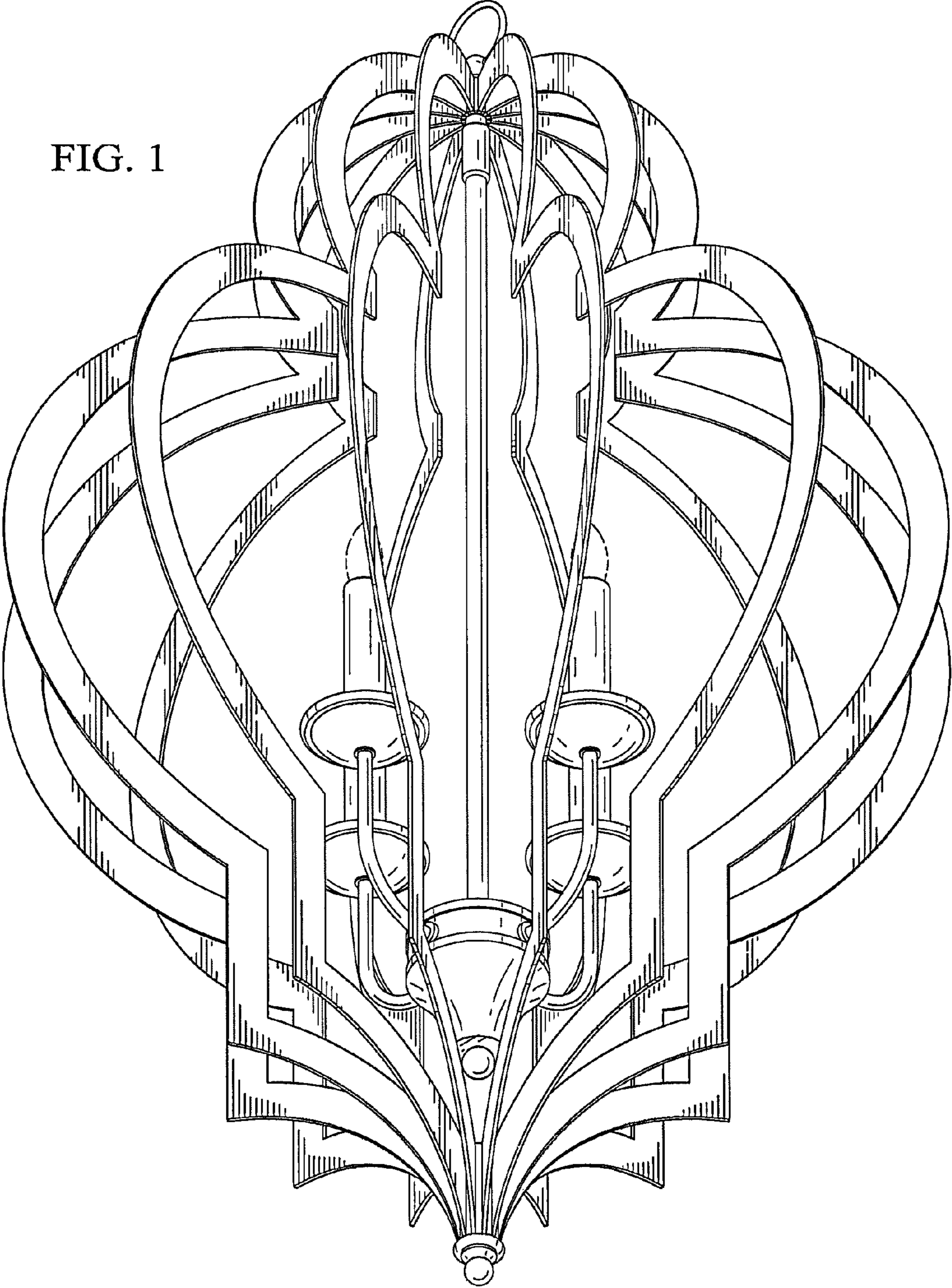

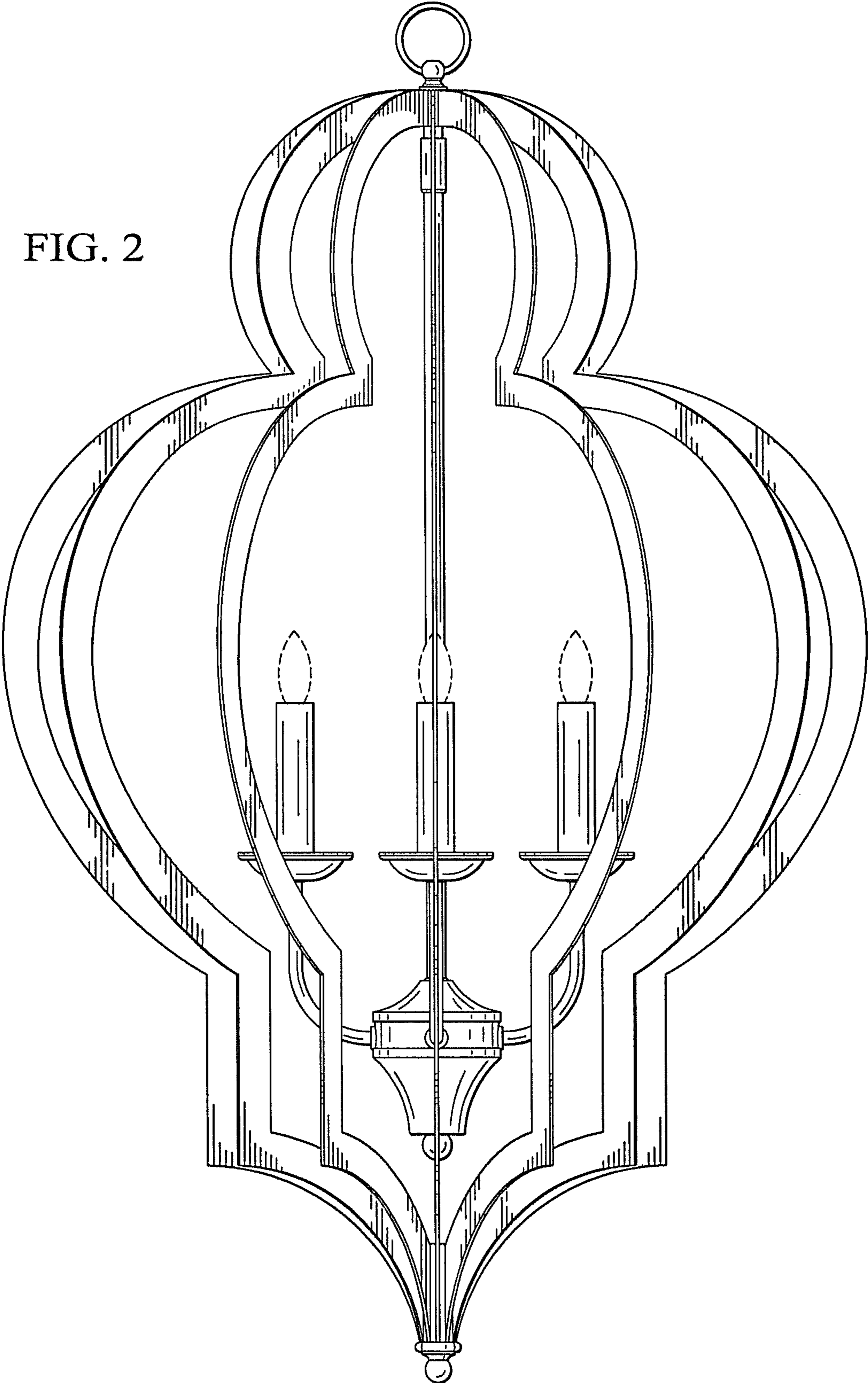

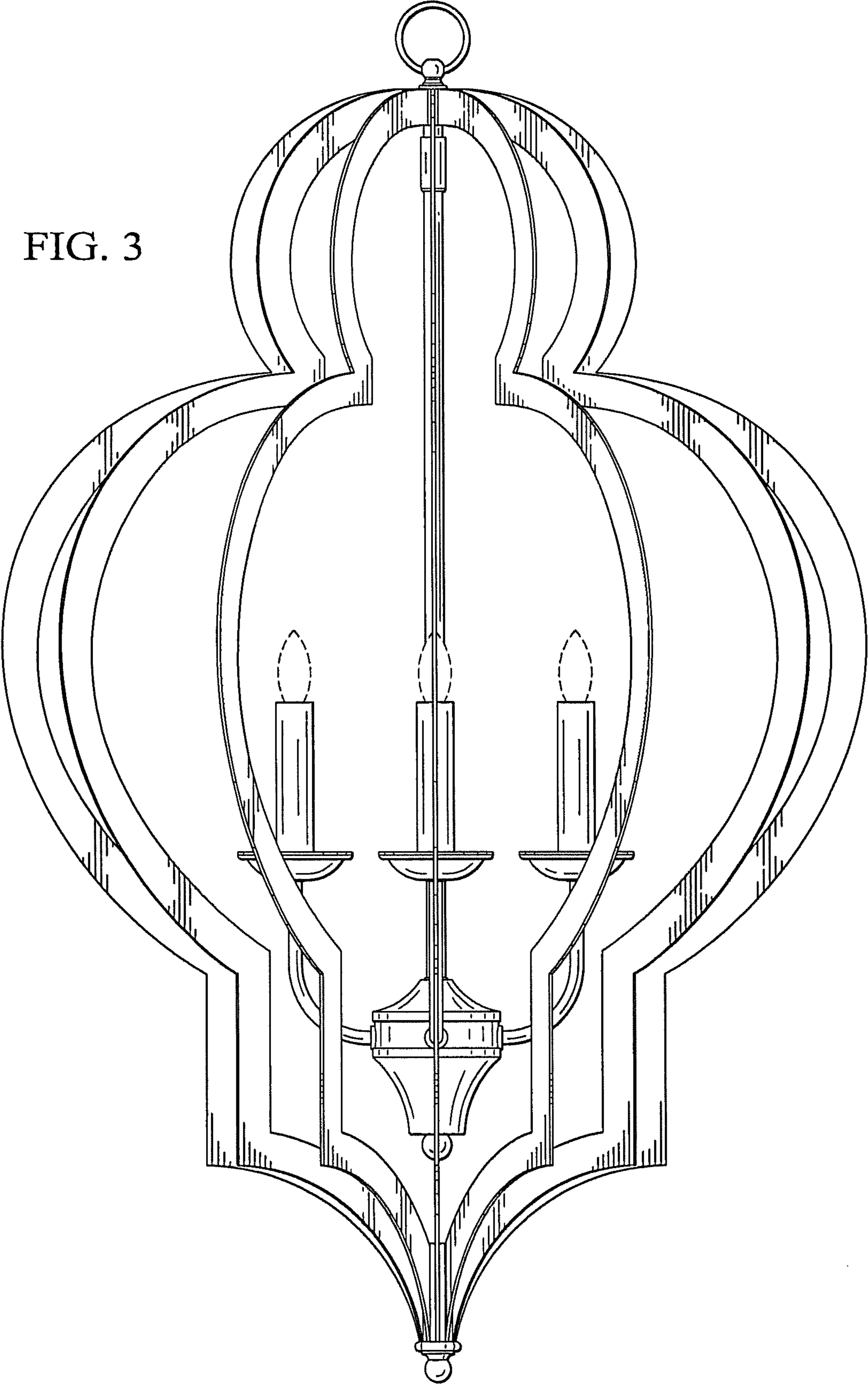

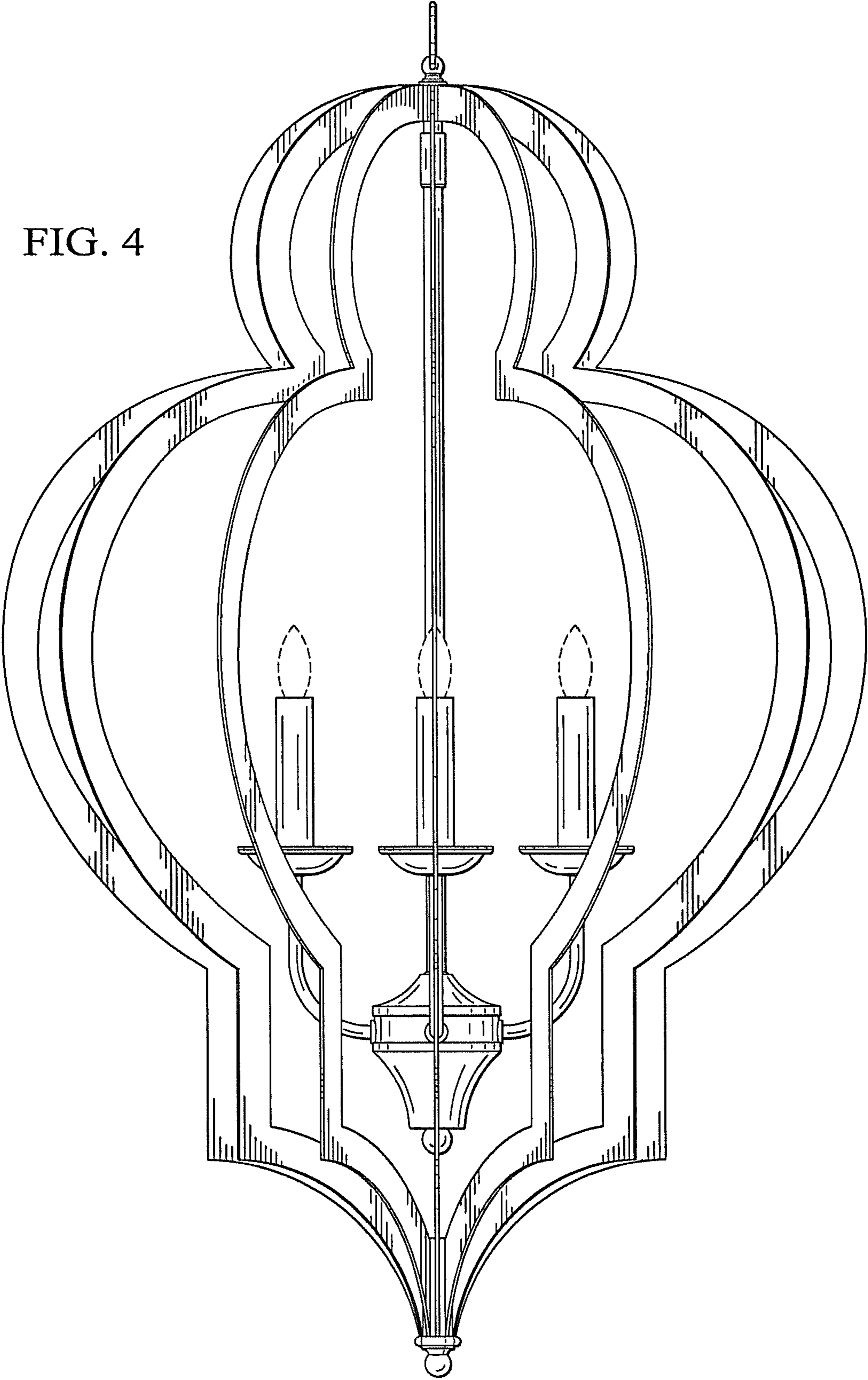

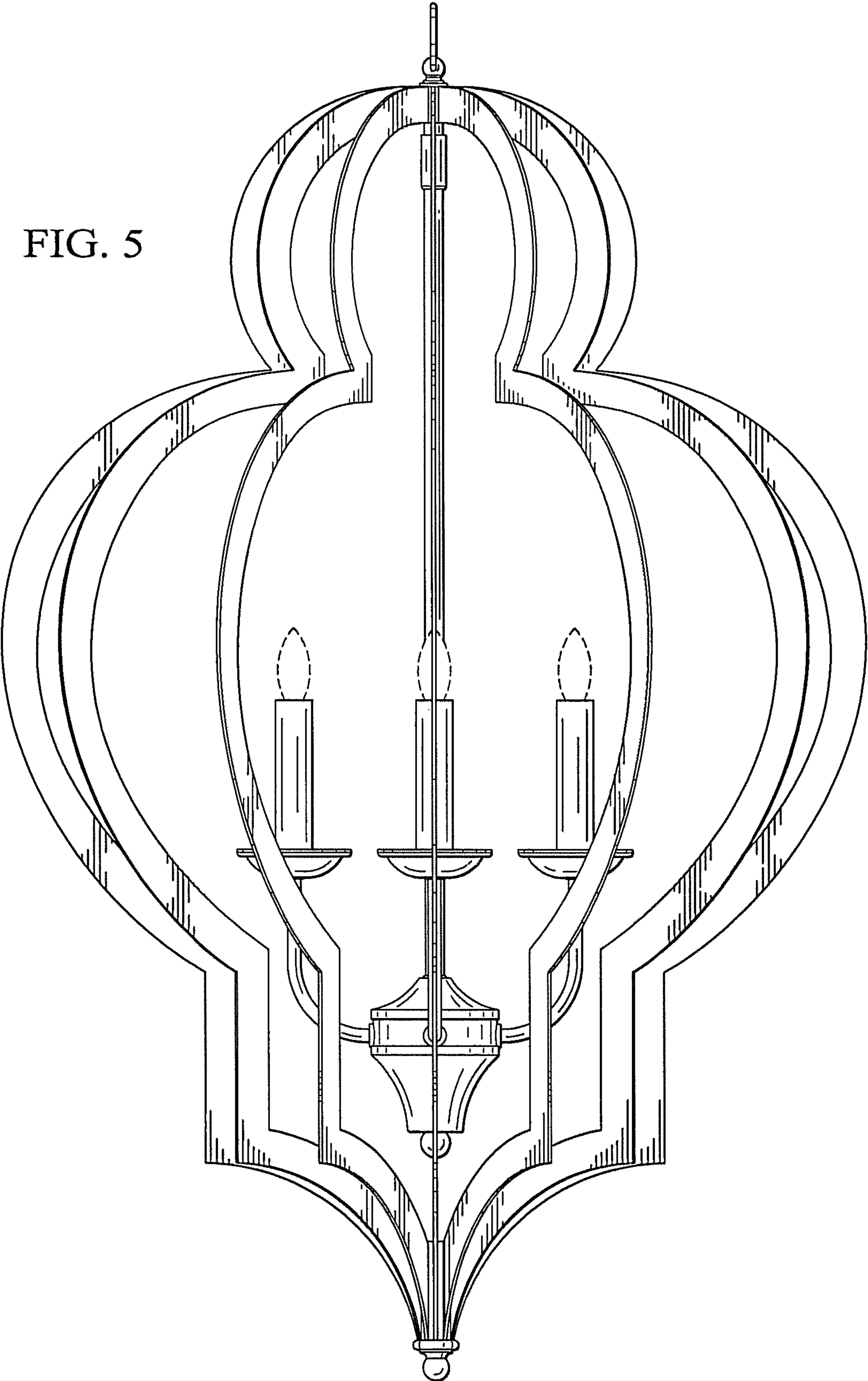

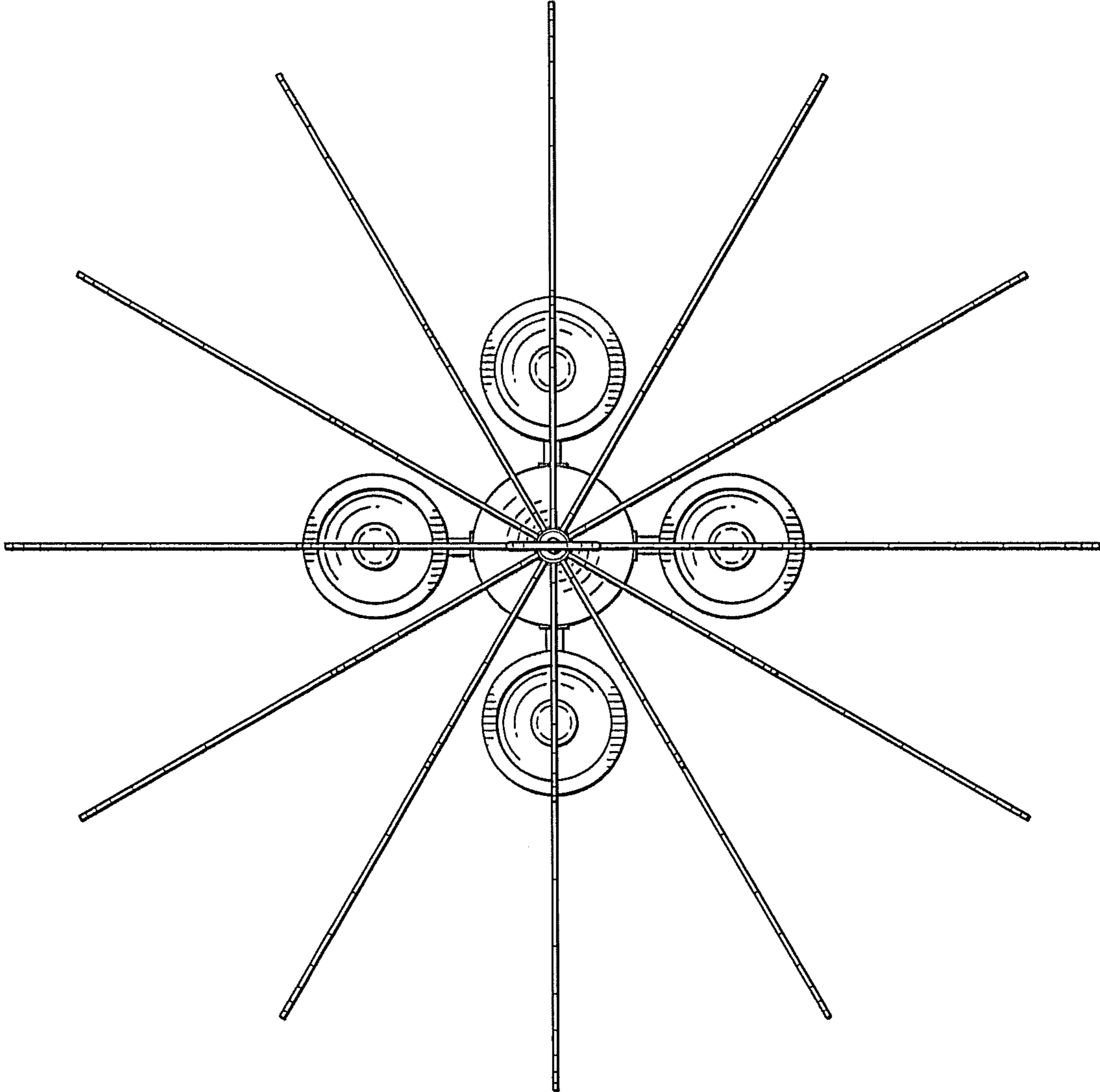

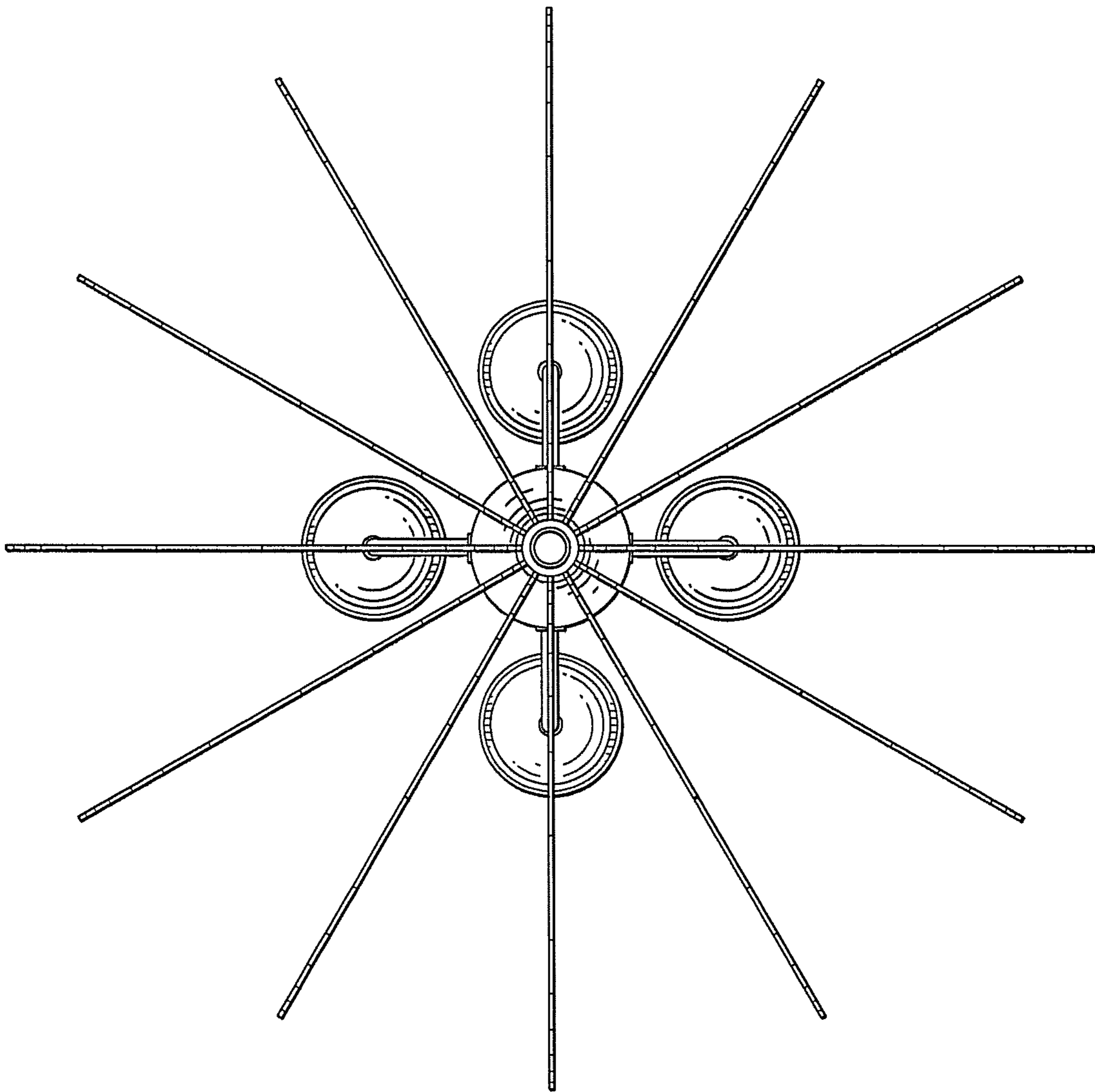
