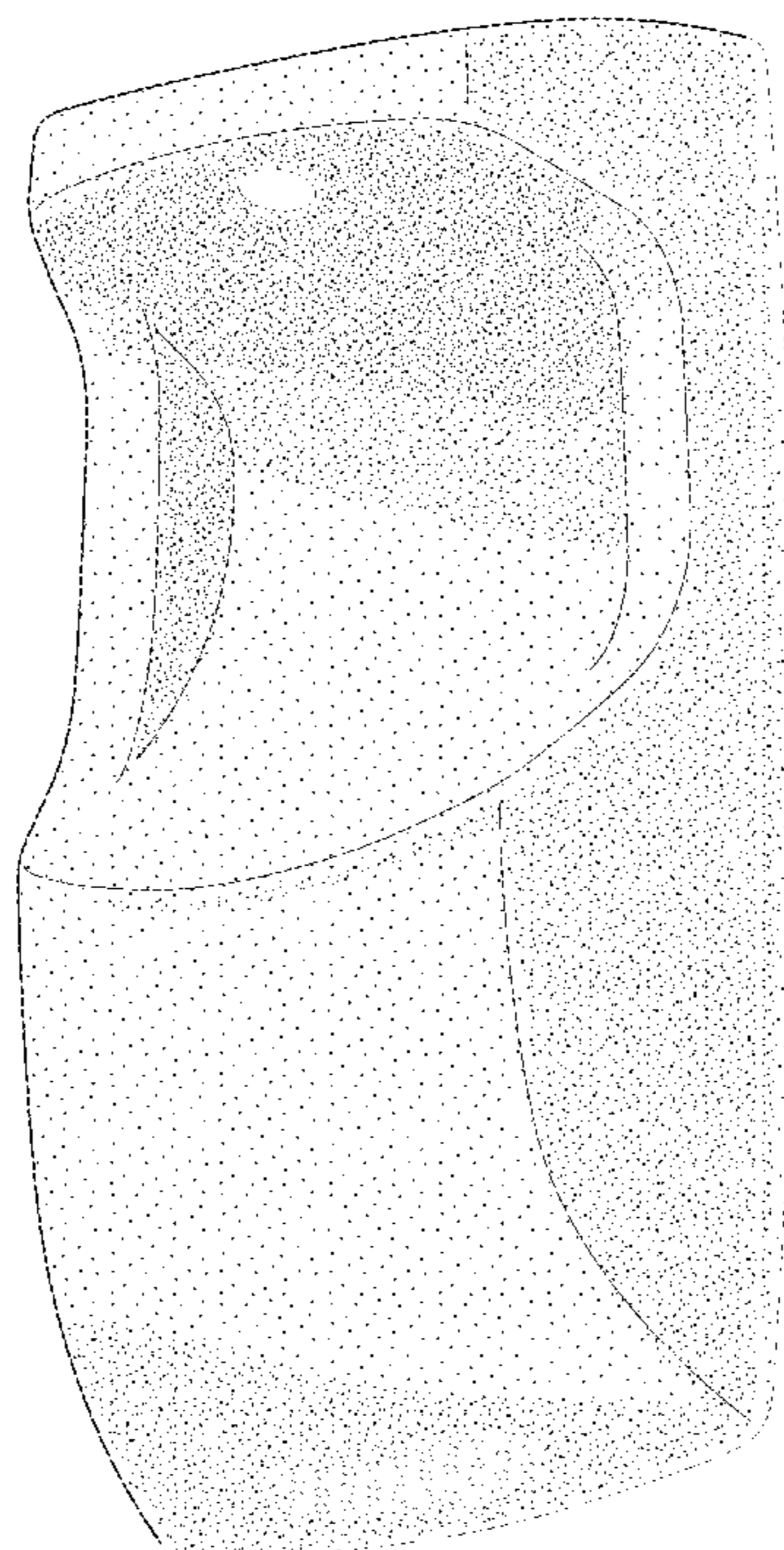
(57) **CLAIM**

The ornamental design for the dryer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the dryer with the rear edge, air inlets and air outlet being shown in phantom lines; FIG. 2 is a left elevational view thereof with the rear edge and air inlets being shown in phantom lines and the right elevational view being a mirror image thereof; FIG. 3 is a front elevational view thereof with the air inlets and air outlet being shown in phantom lines; FIG. 4 is a rear elevational view thereof illustrating the outline thereof in phantom lines; FIG. 5 is a top plan view thereof with the rear edge being shown in phantom lines; FIG. 6 is a bottom plan view thereof with the rear edge and air inlets being shown in phantom lines; FIG. 7 is a front perspective view of the dryer; FIG. 8 is a left elevational view thereof with the right elevational view being a mirror image thereof; FIG. 9 is a front elevational view thereof; FIG. 10 is a rear elevational view of the outline thereof; FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom plan view thereof. The broken phantom lines depict unclaimed subject matter only and form no part of the claimed design.

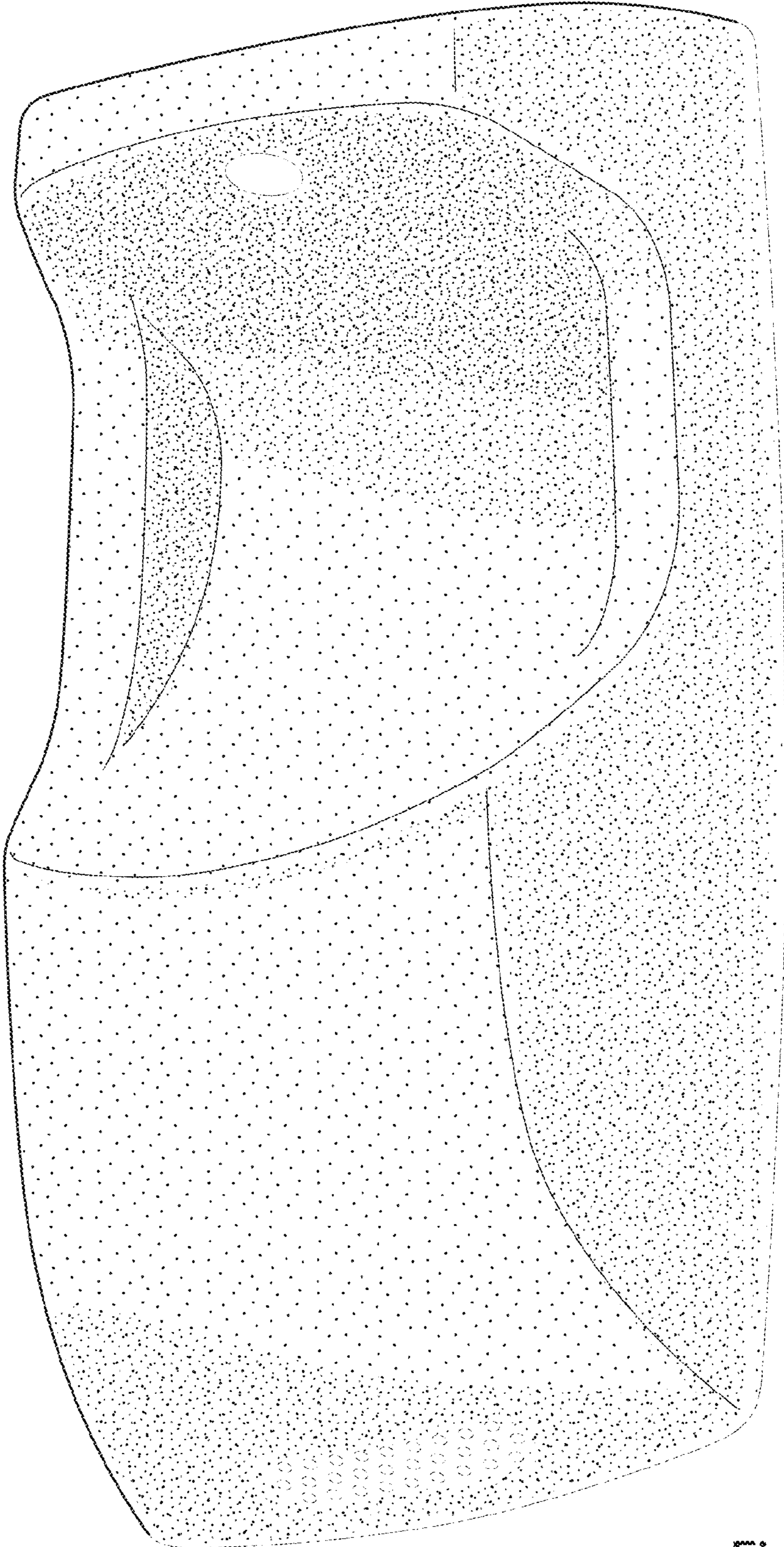

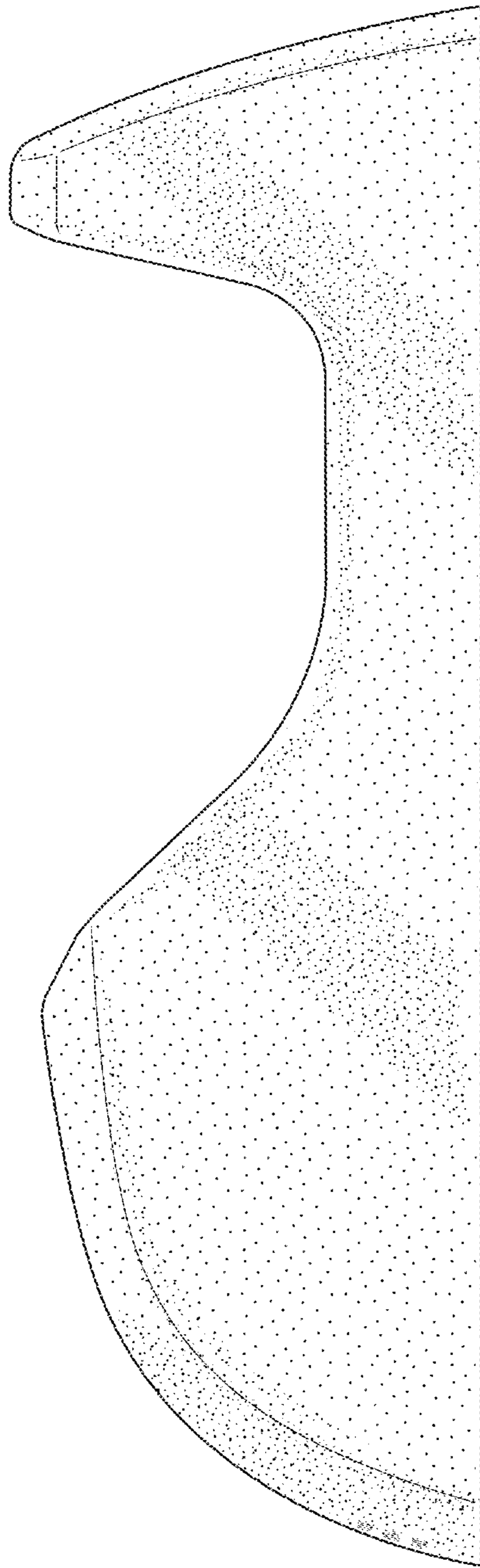

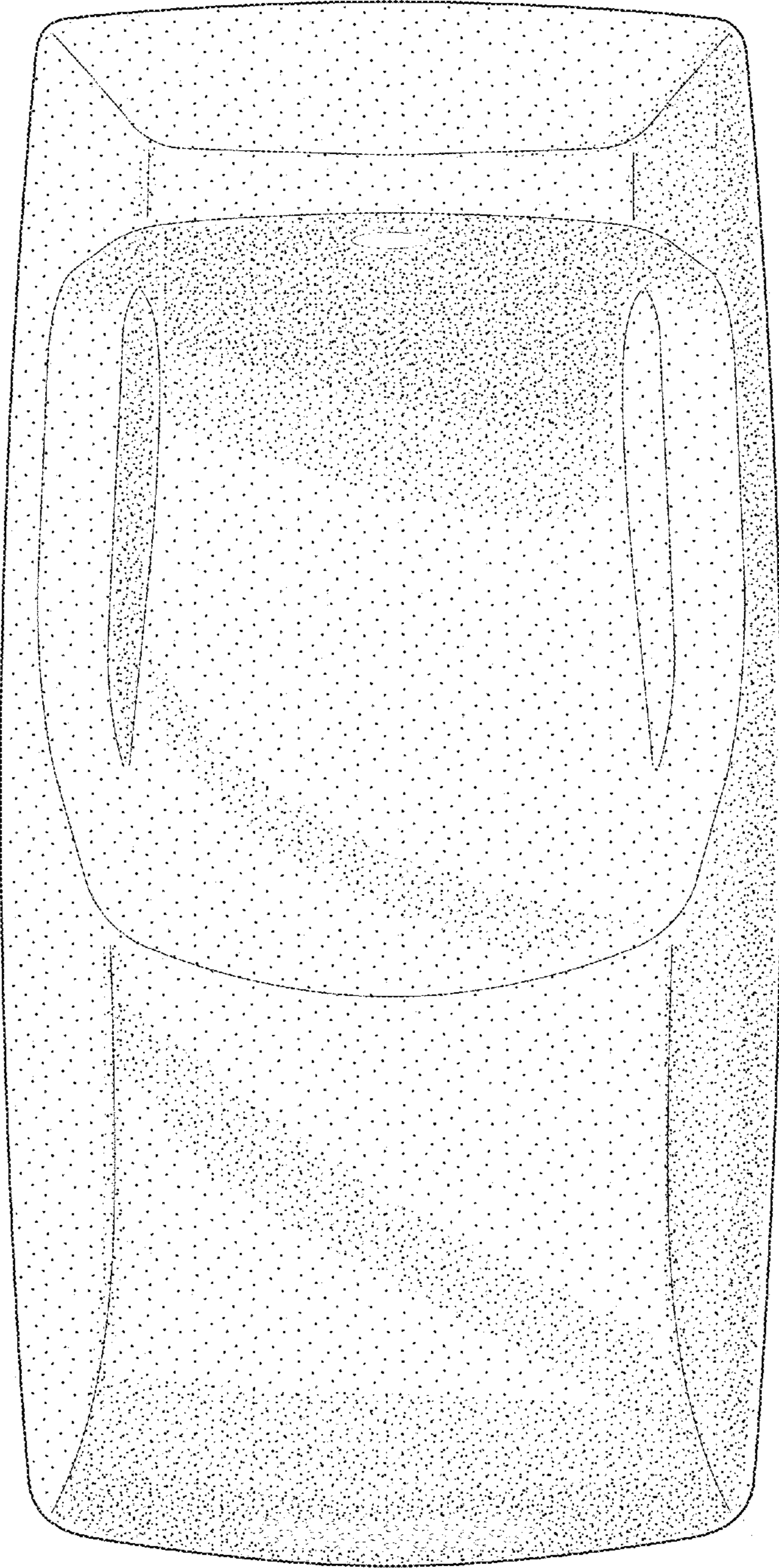

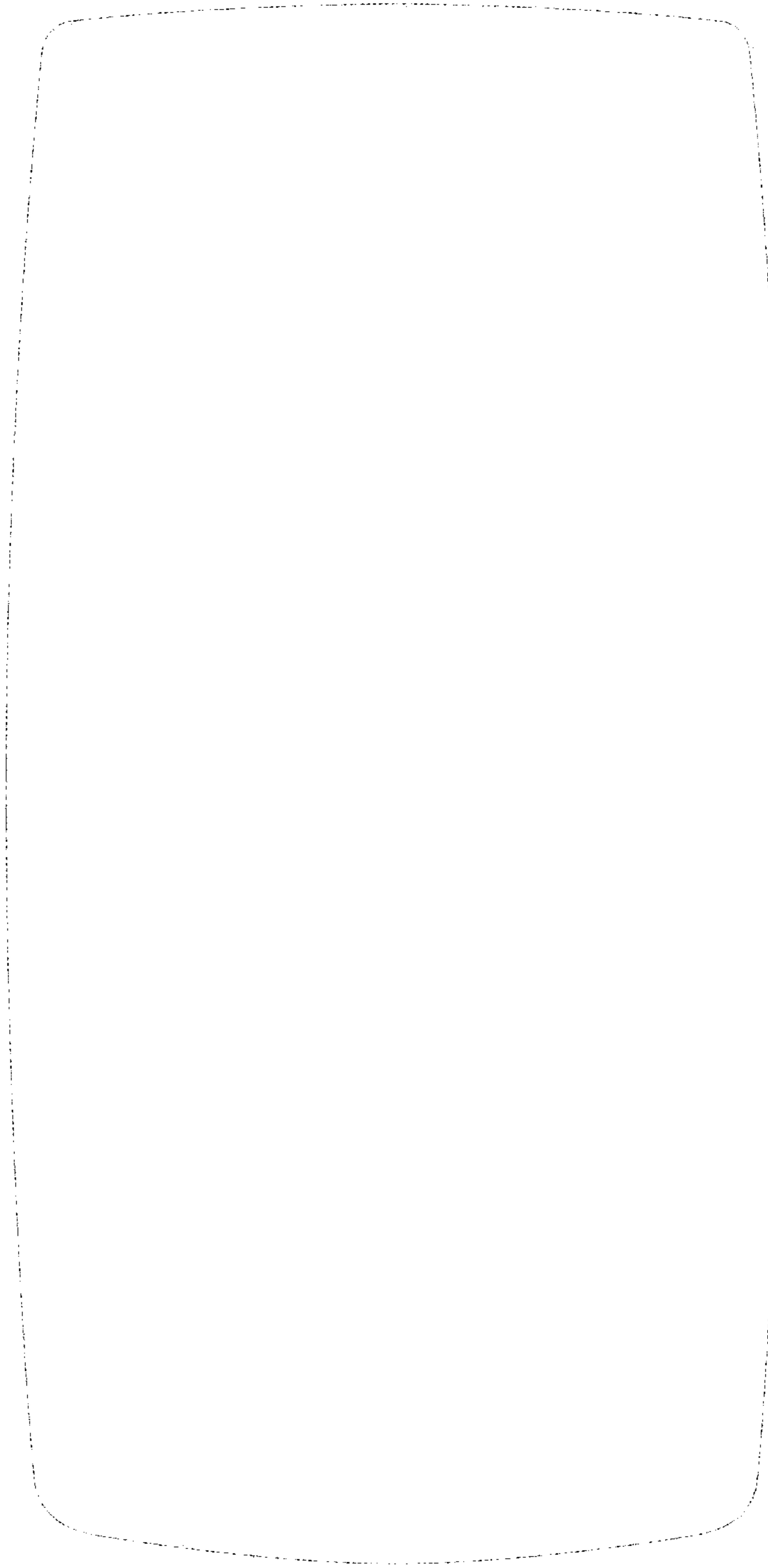

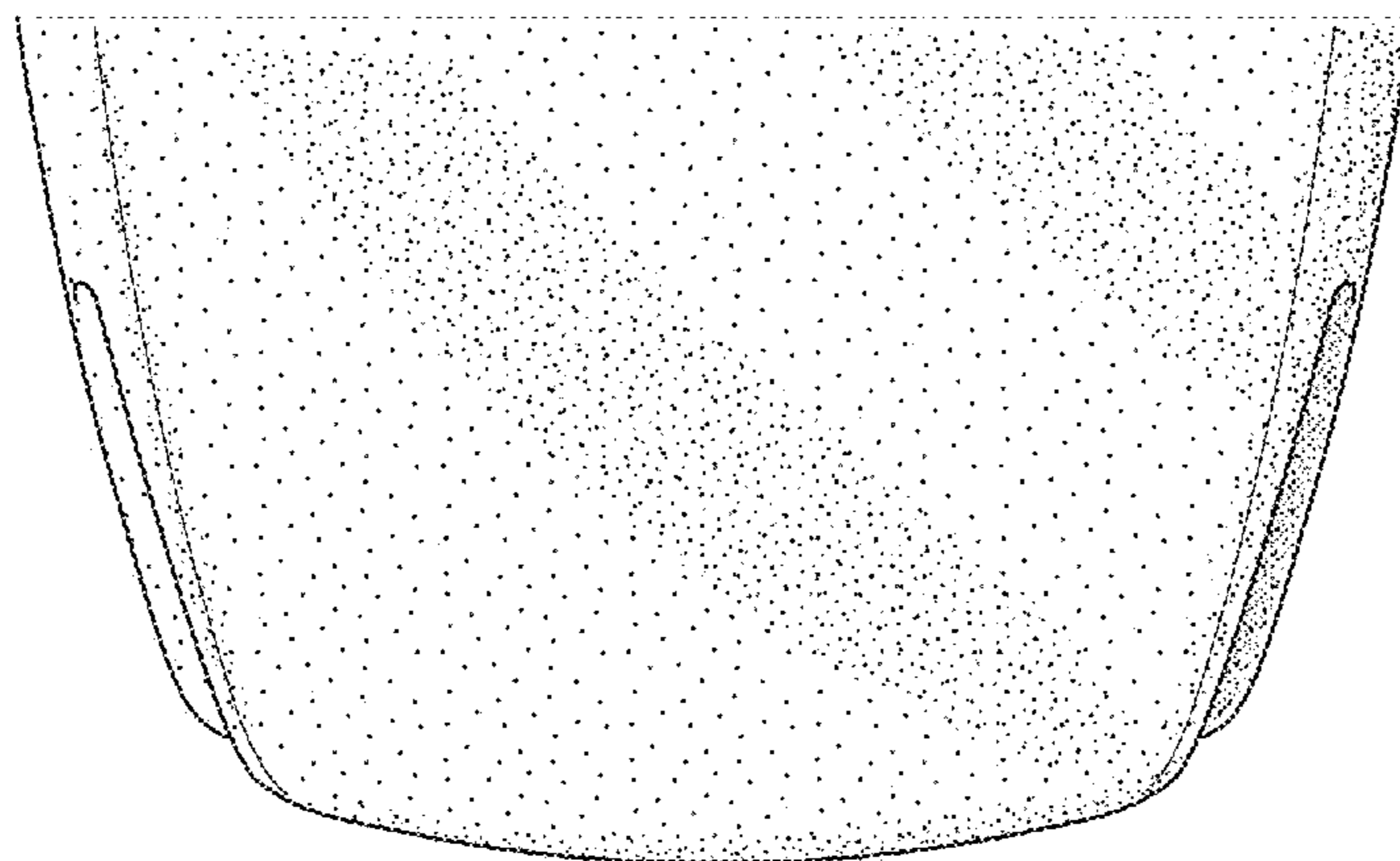

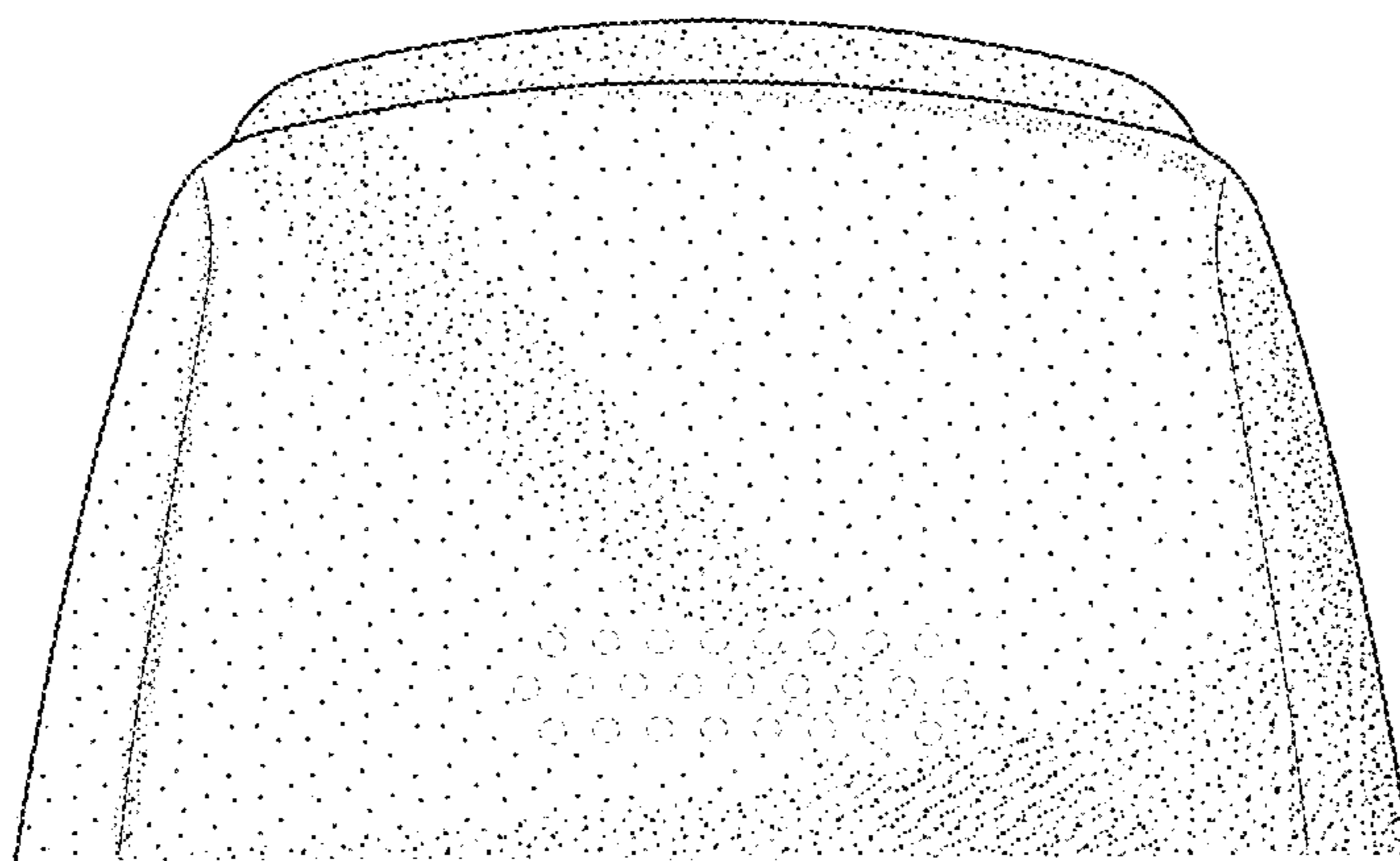

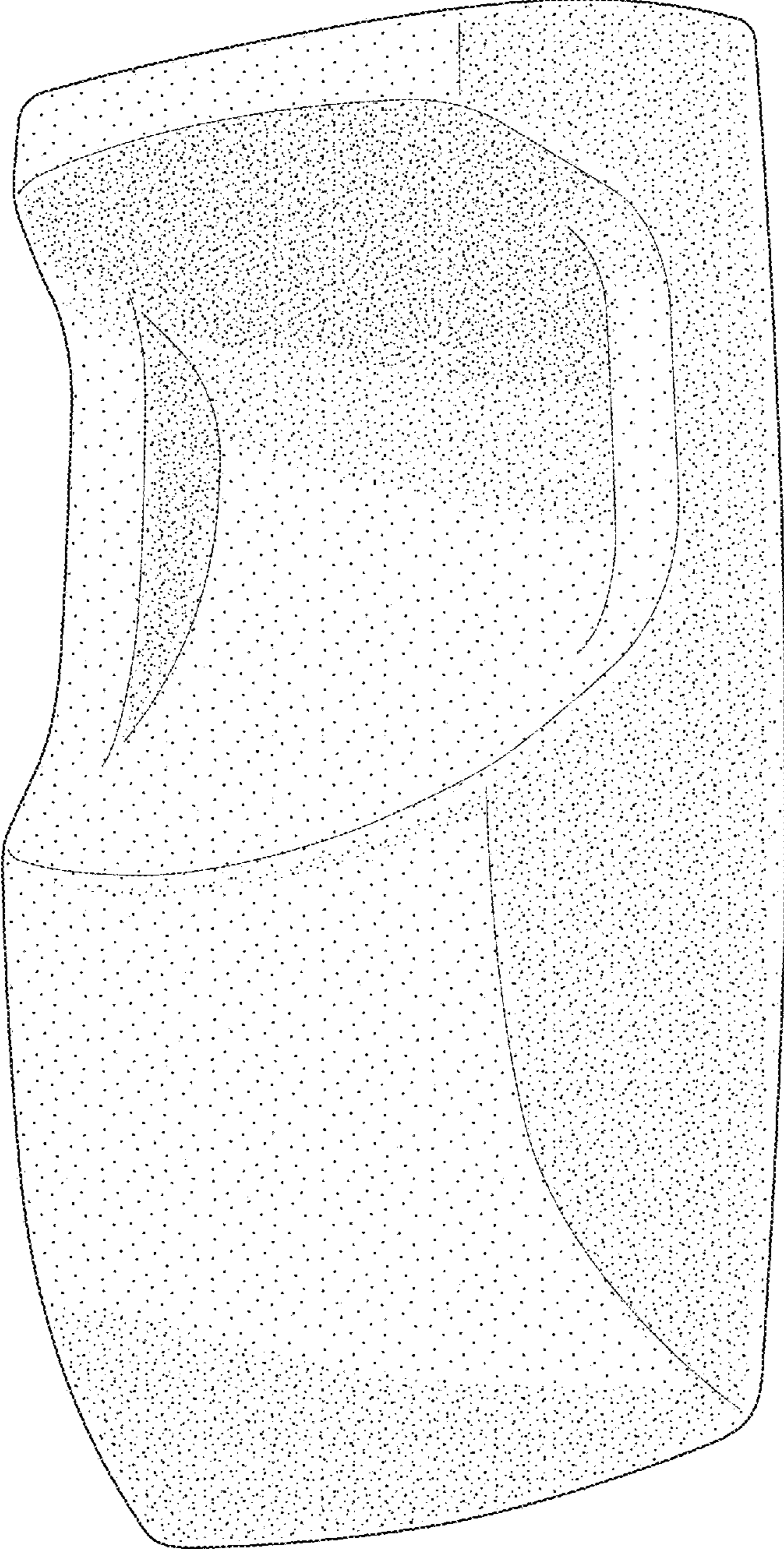

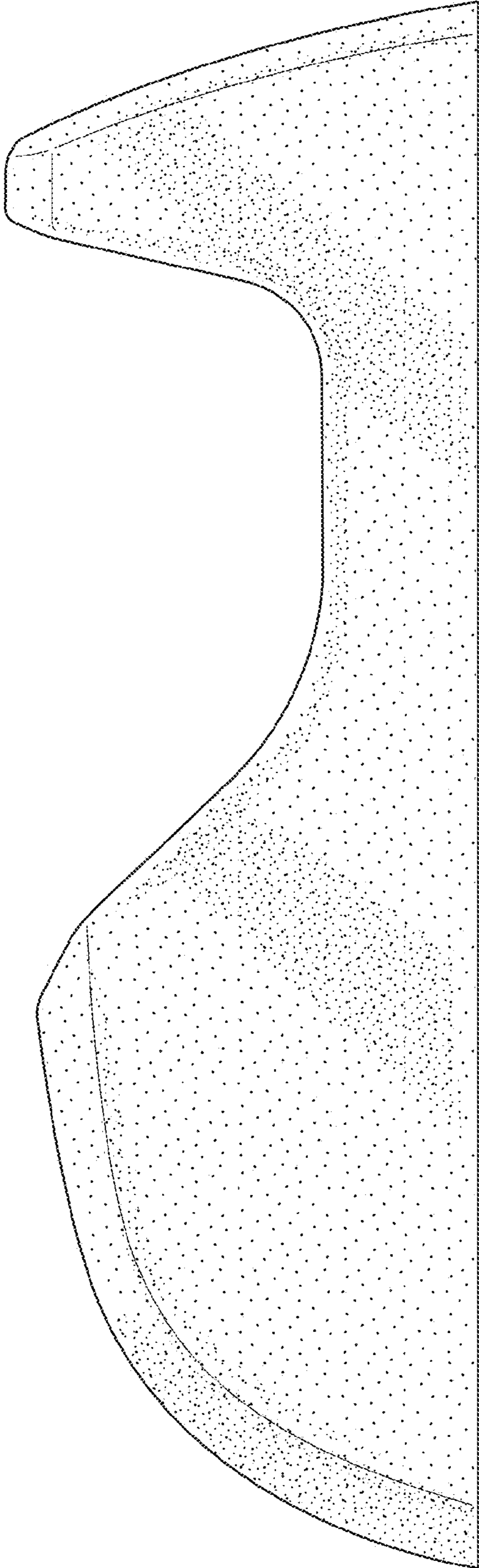

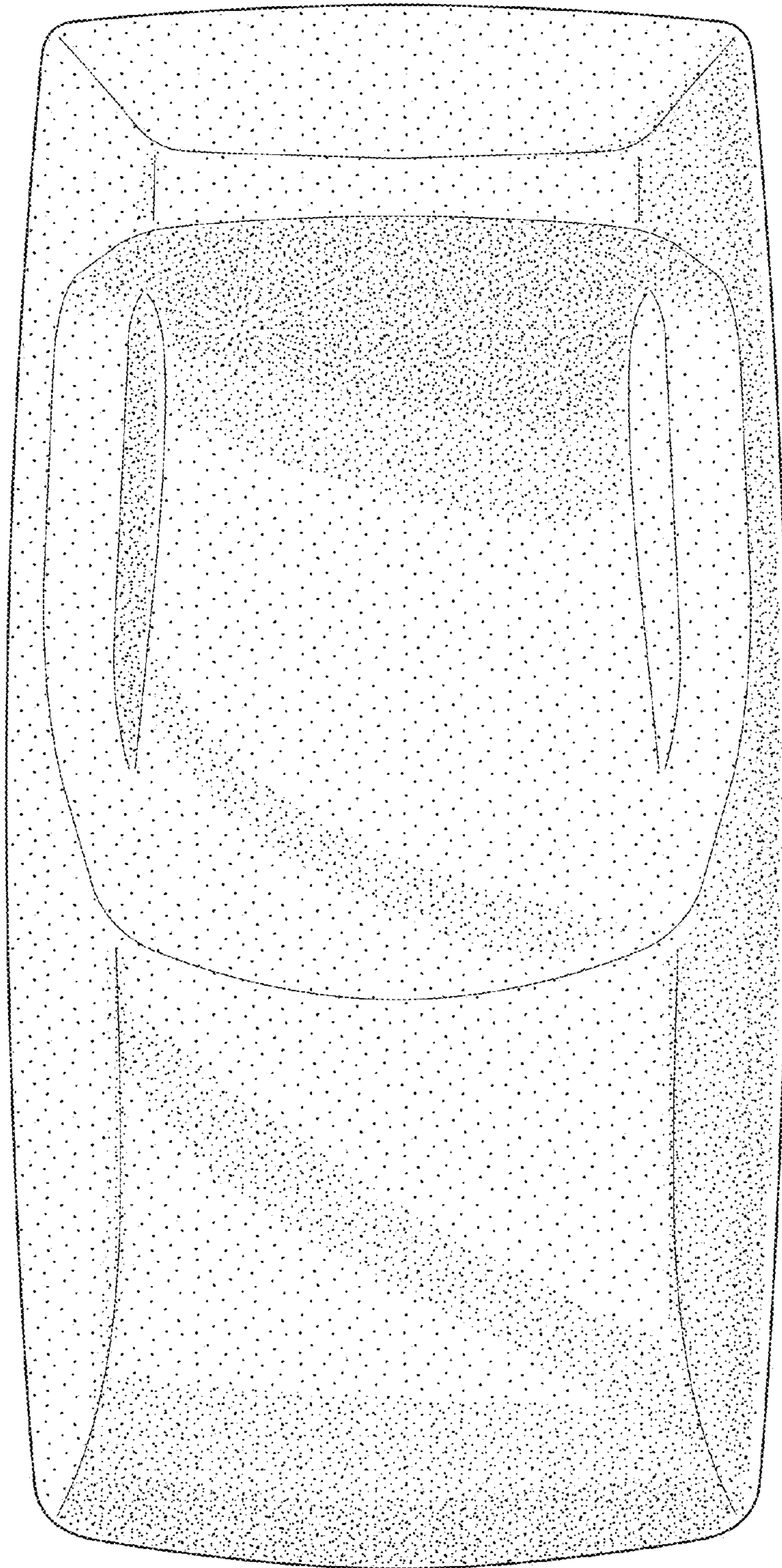

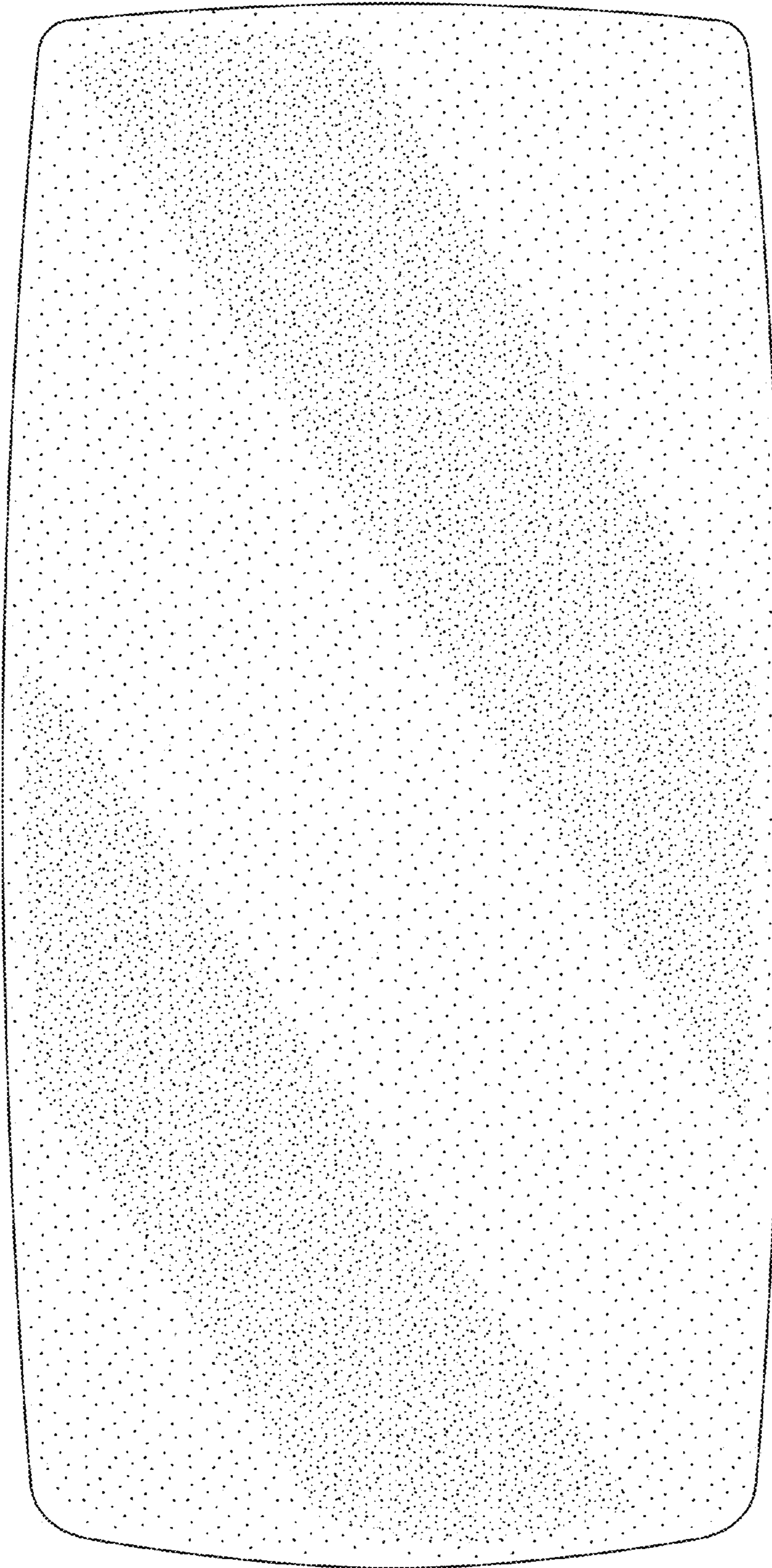

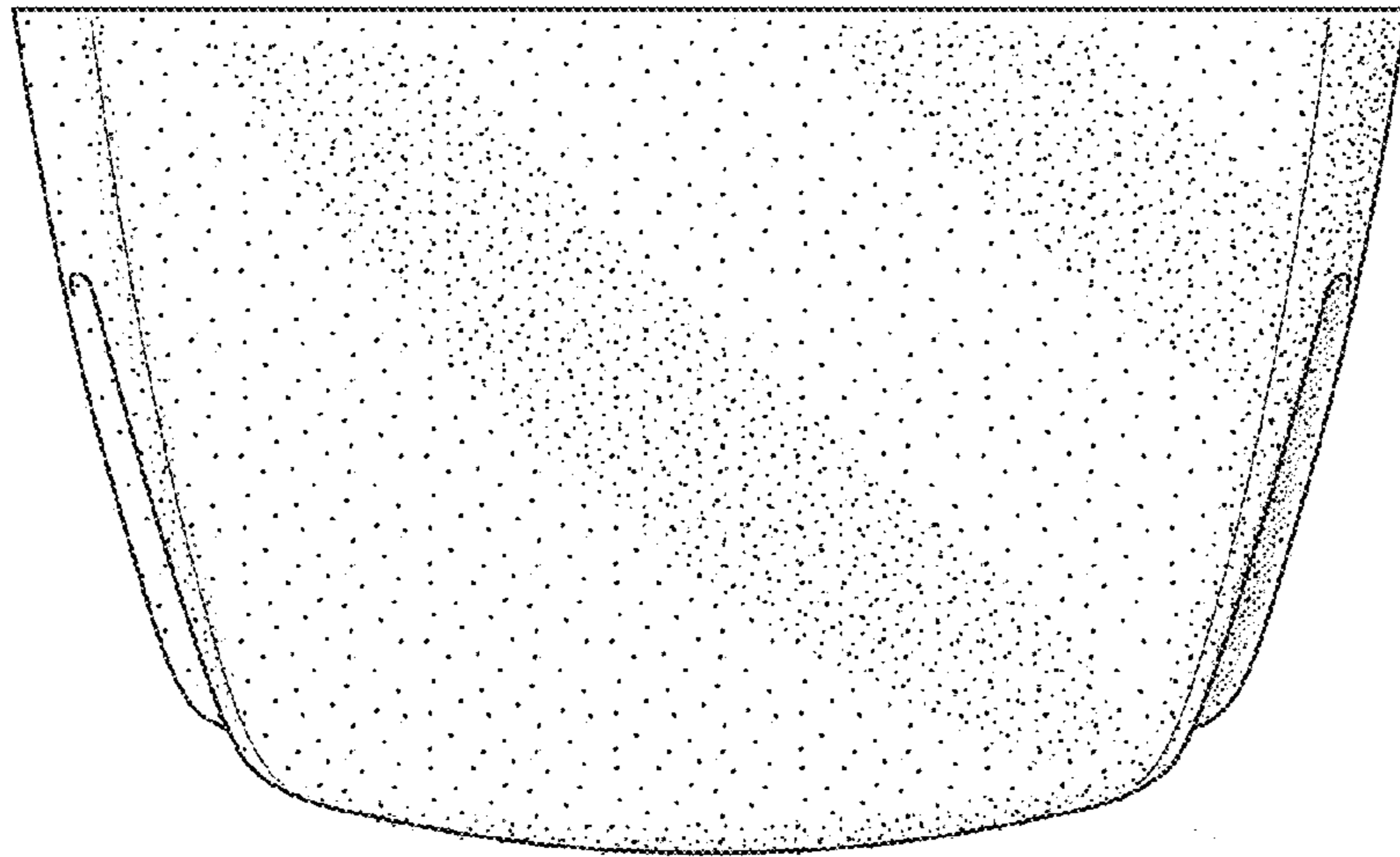

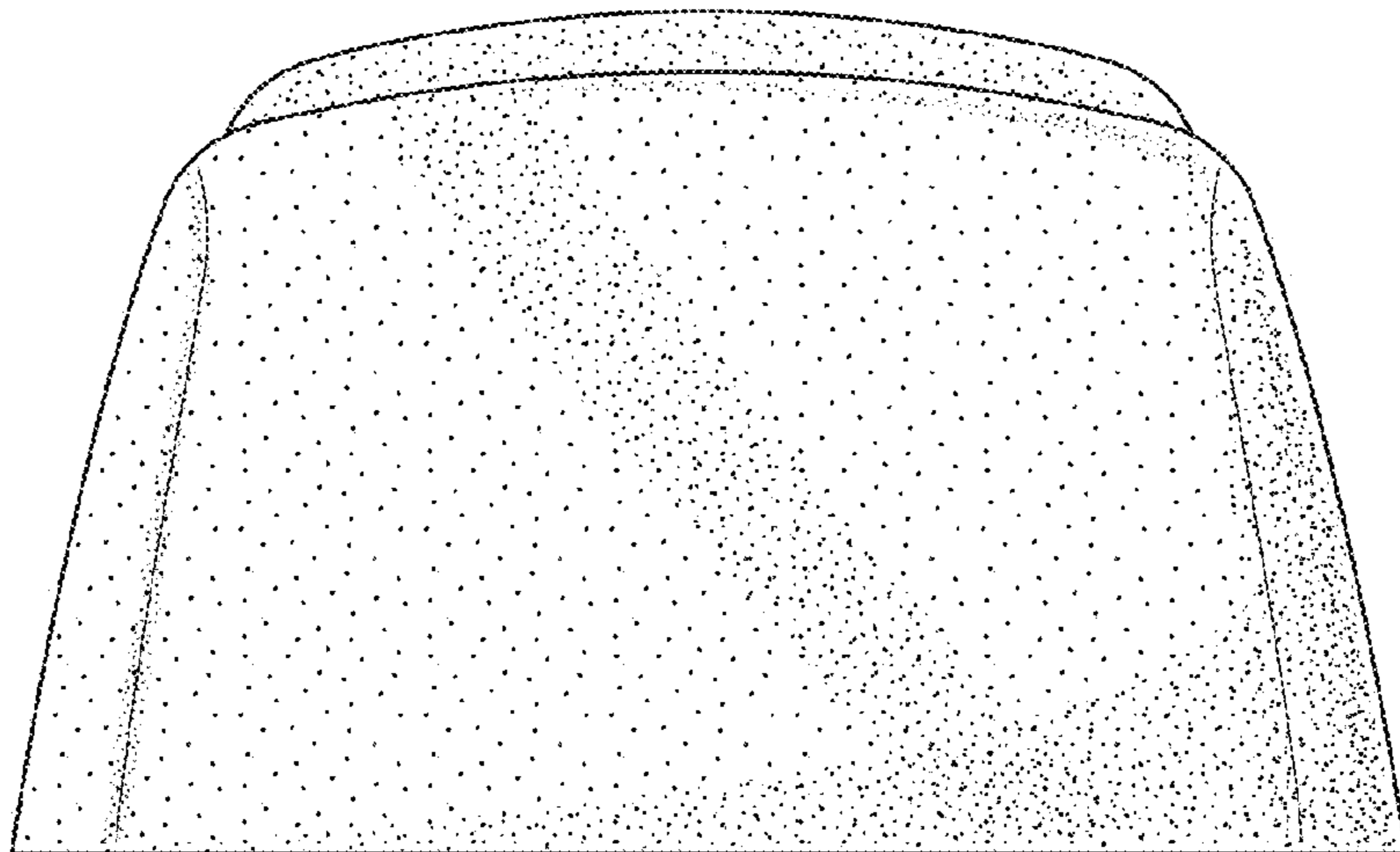
