**DESCRIPTION**

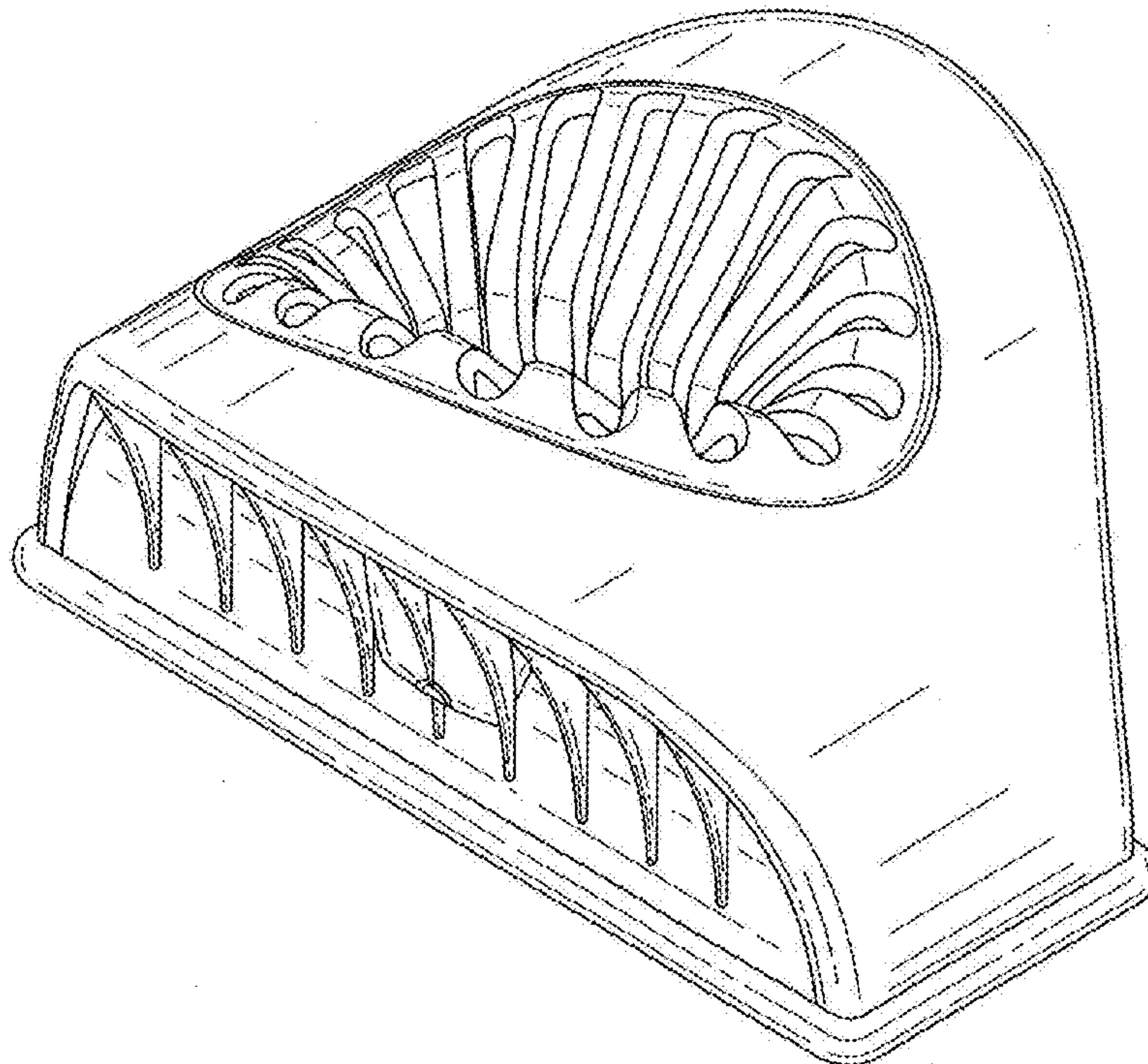

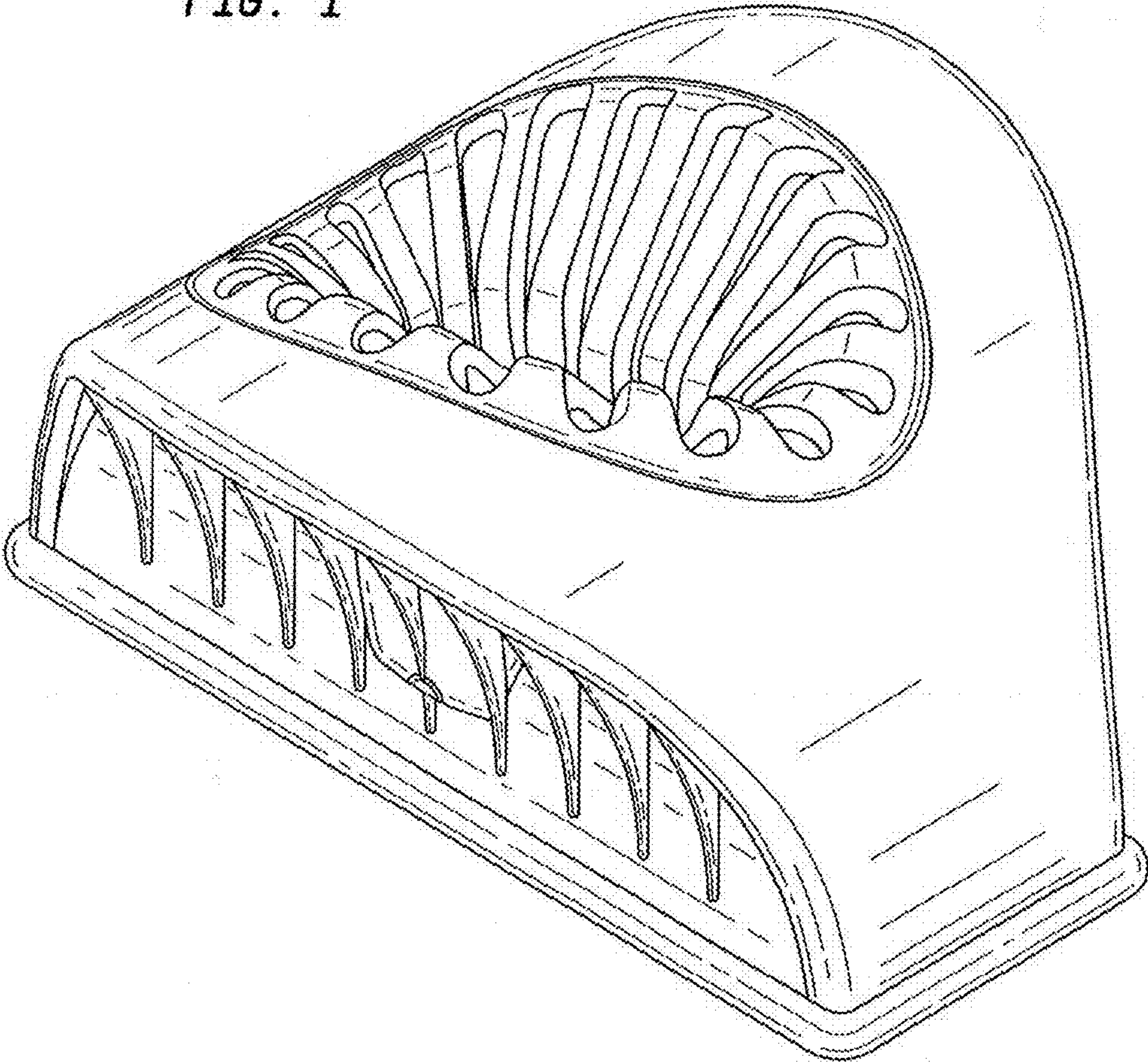

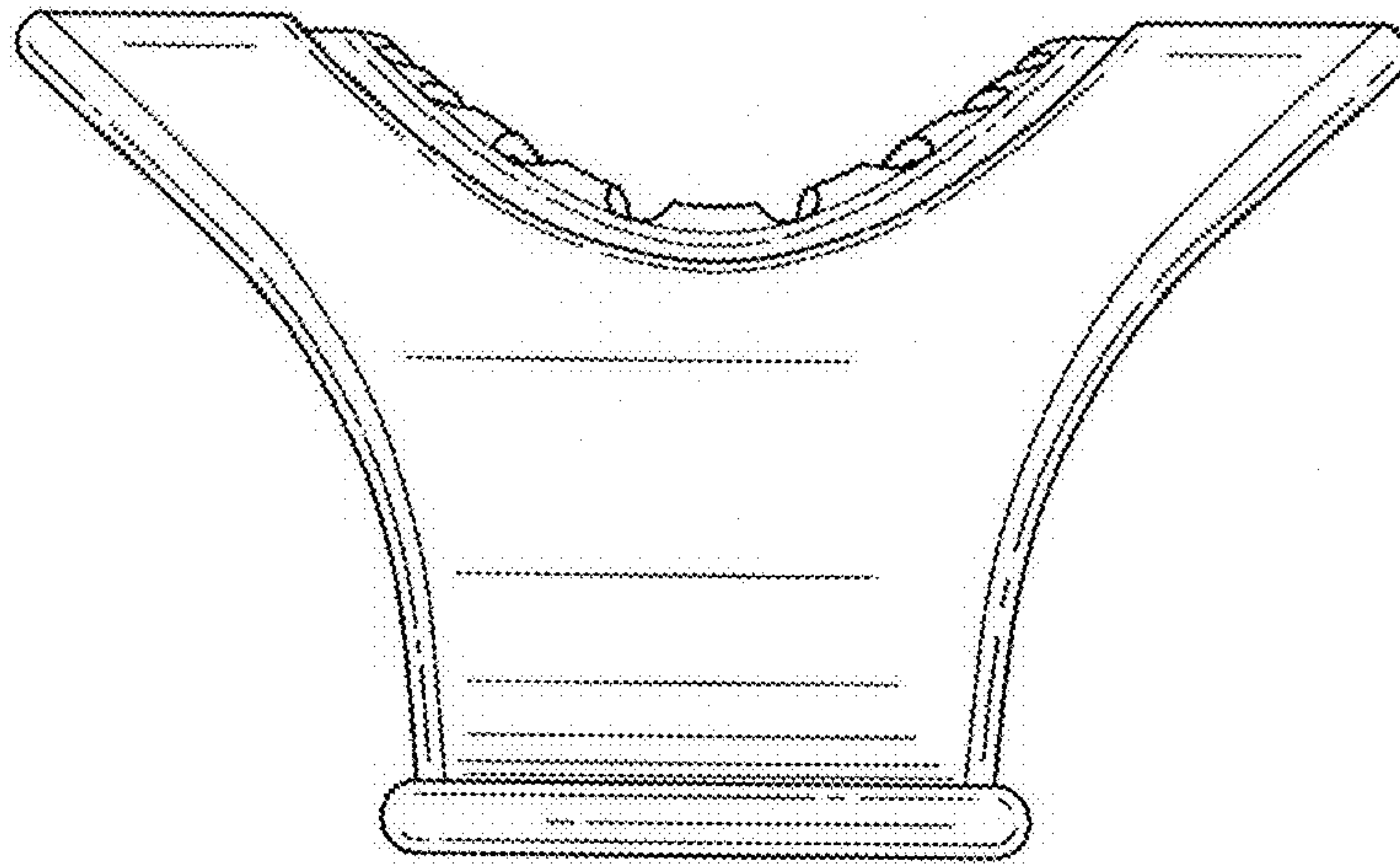

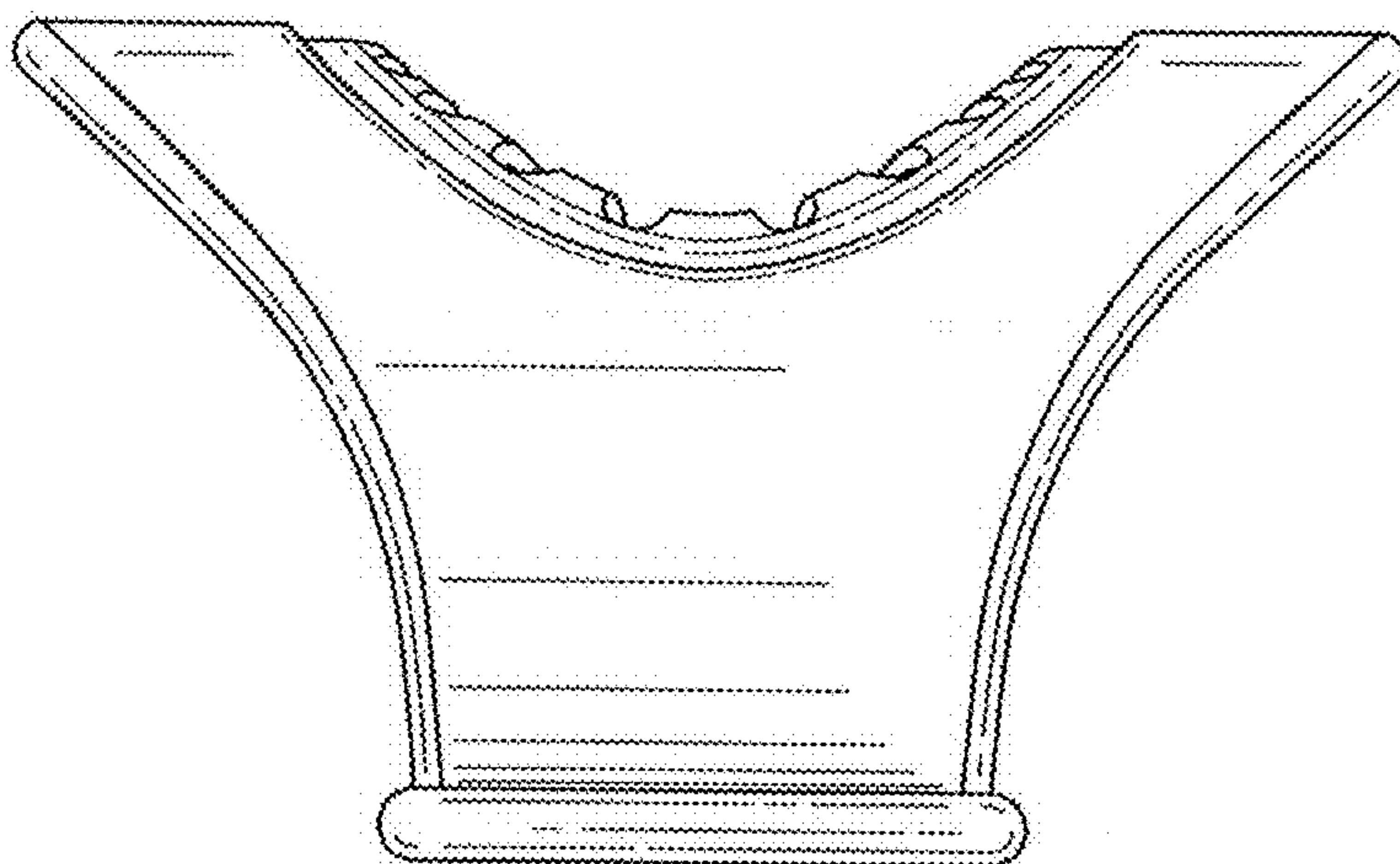

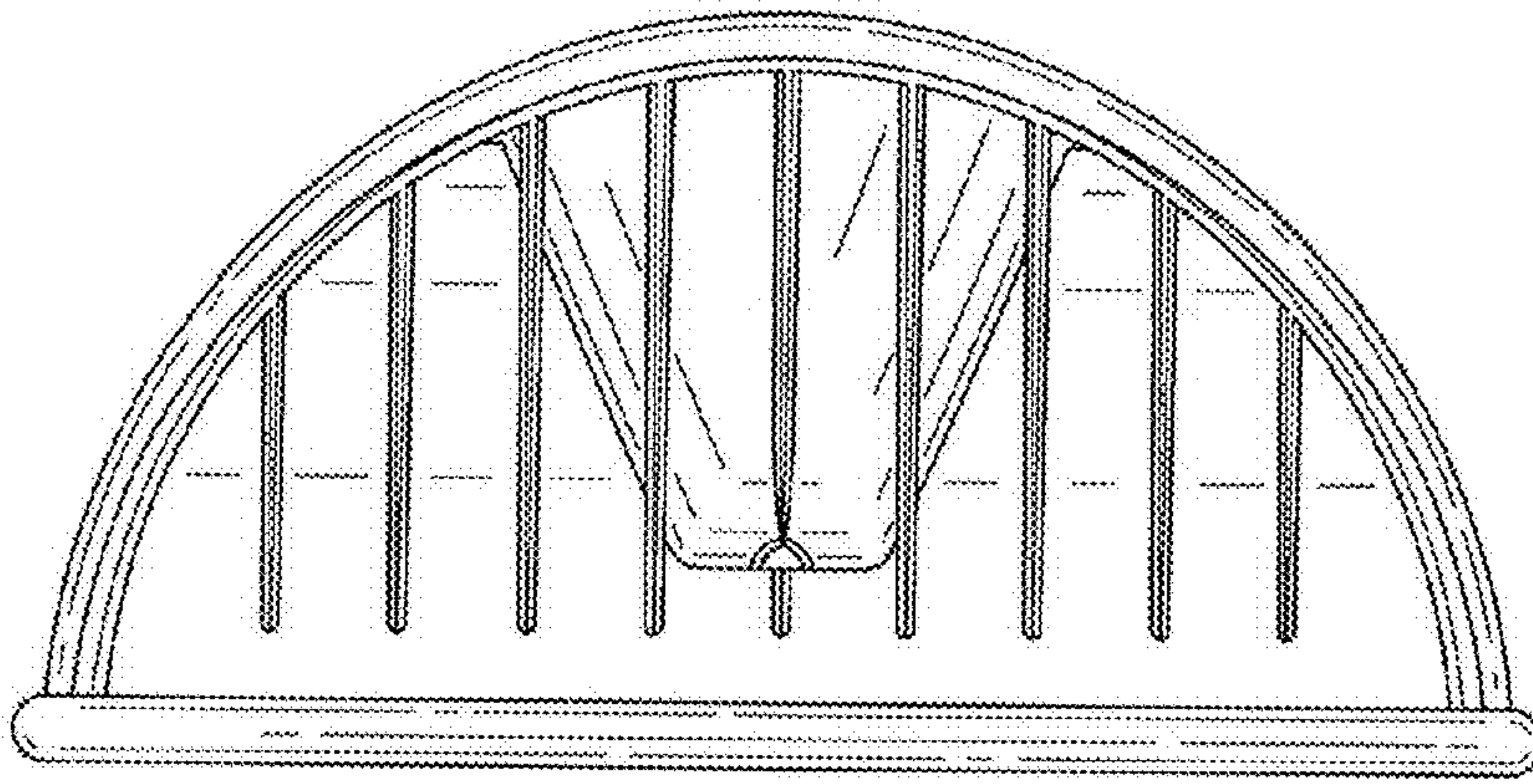

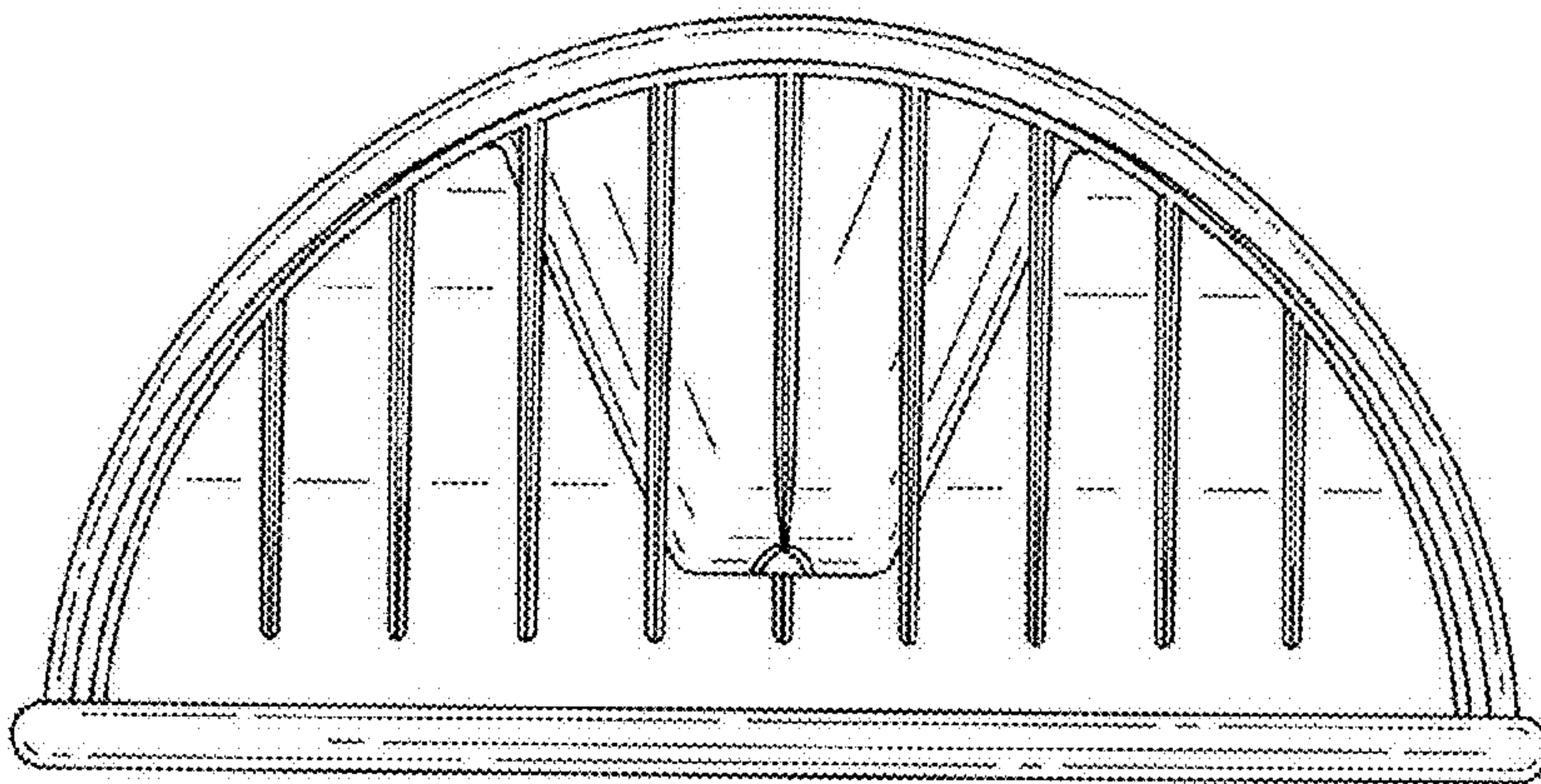

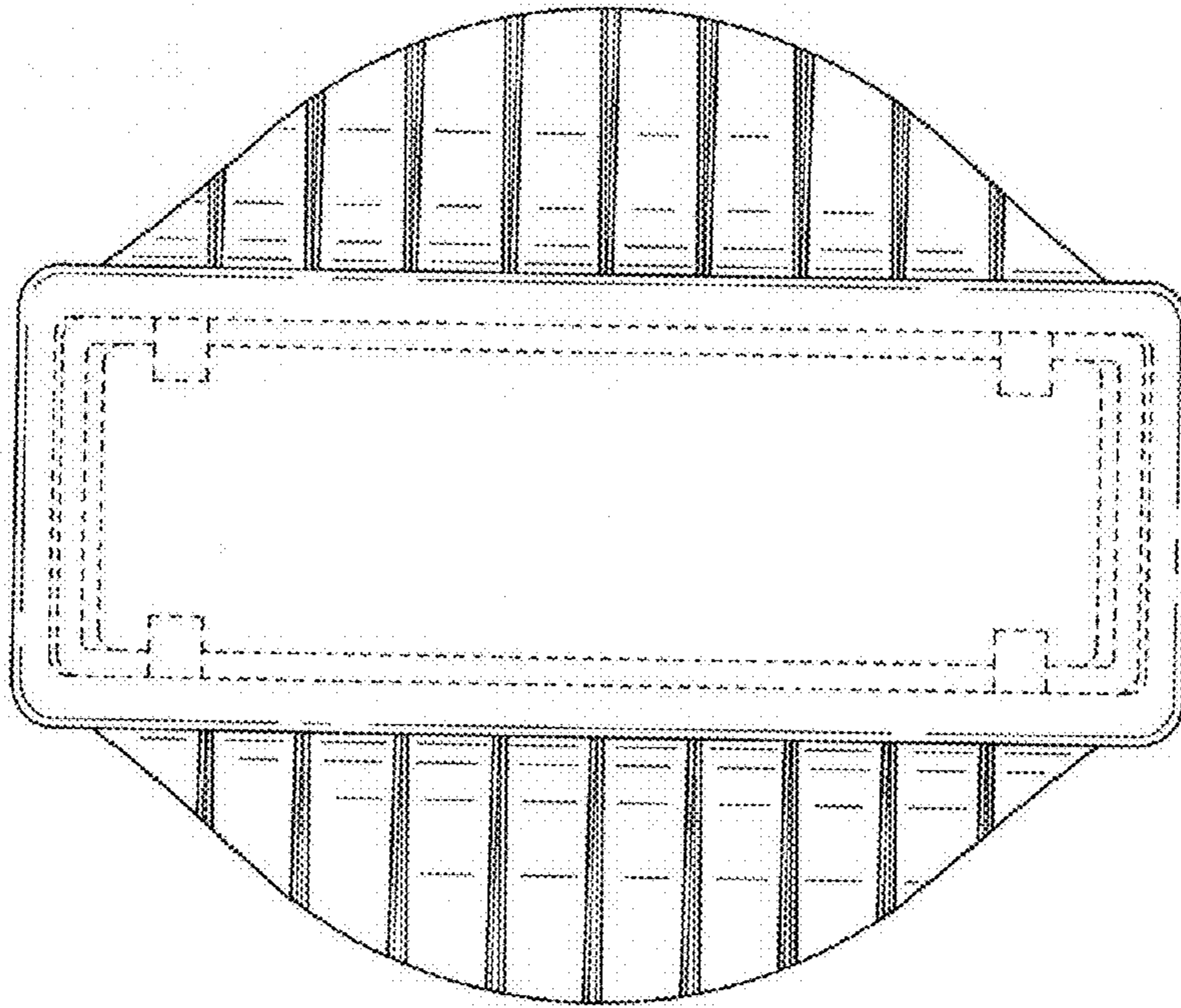
