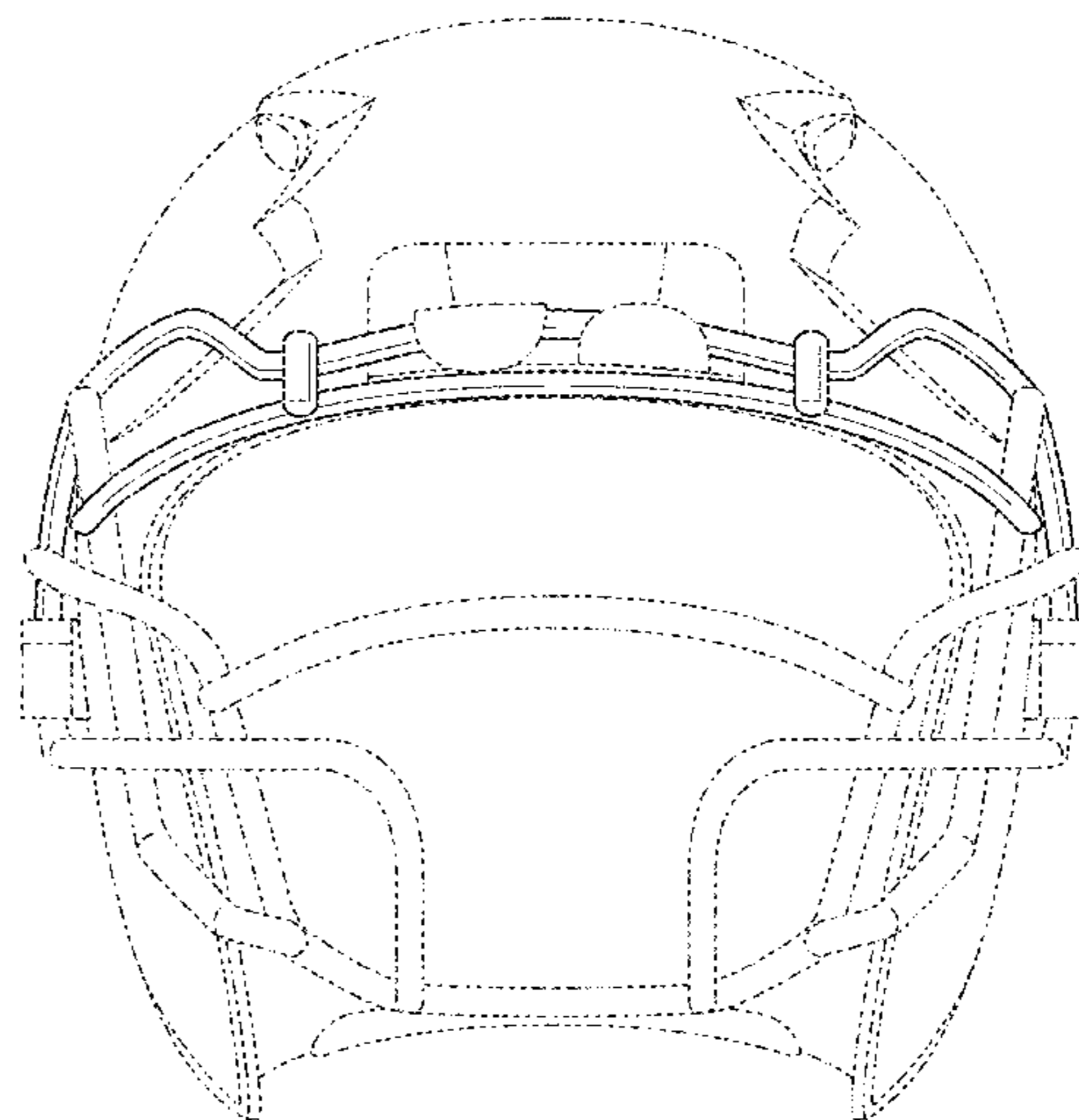
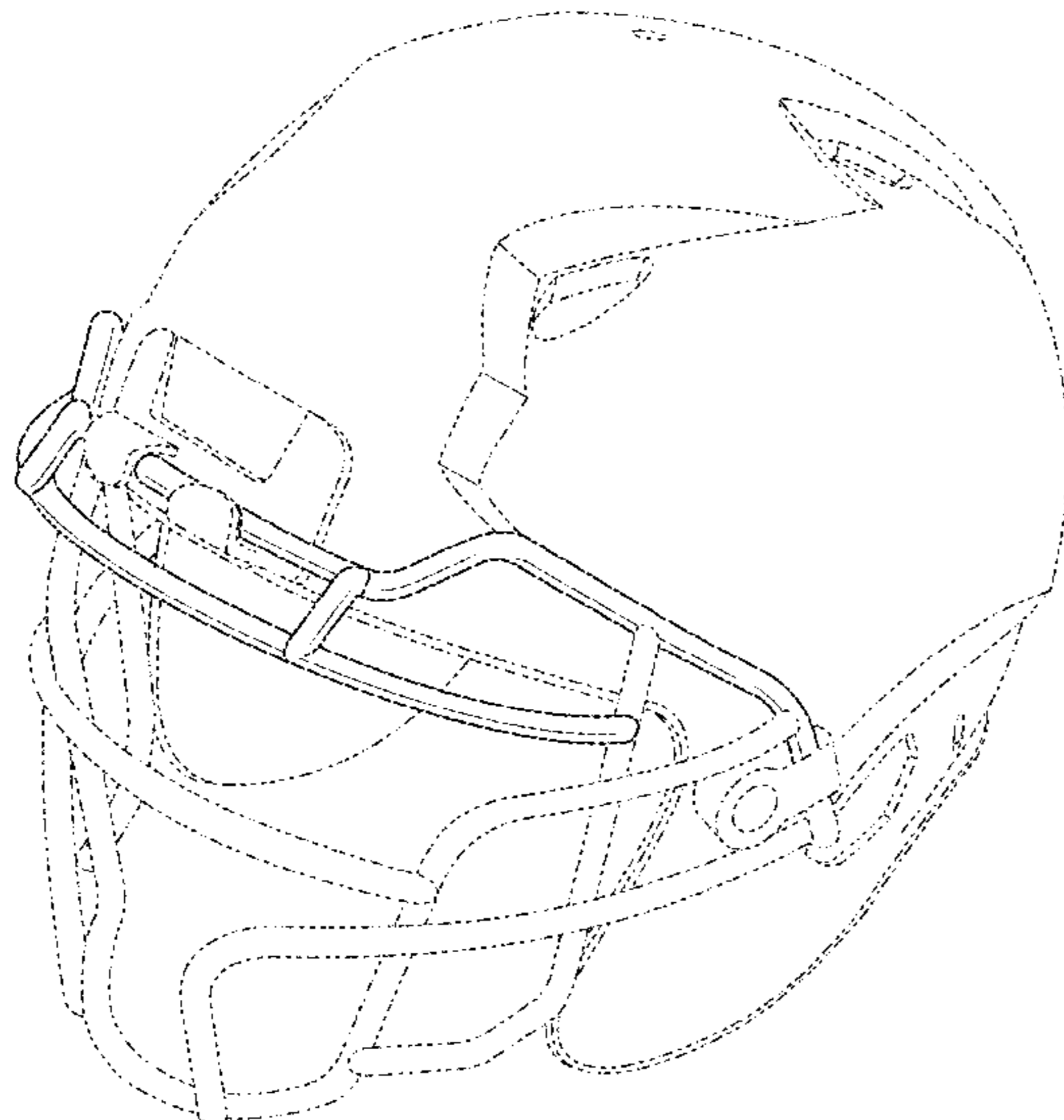
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, top, left perspective view of a faceguard used with a helmet showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a side elevational view thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.

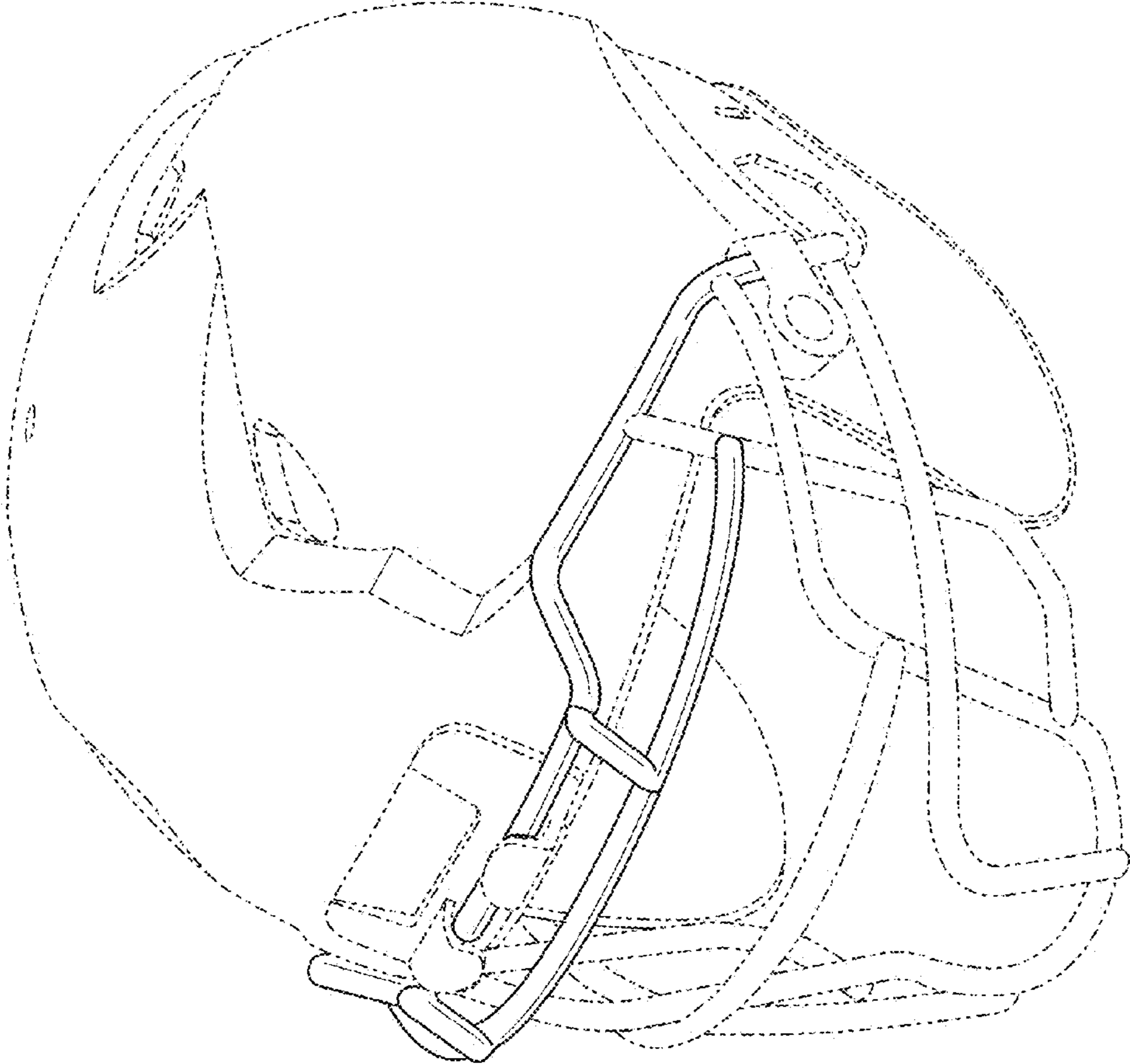

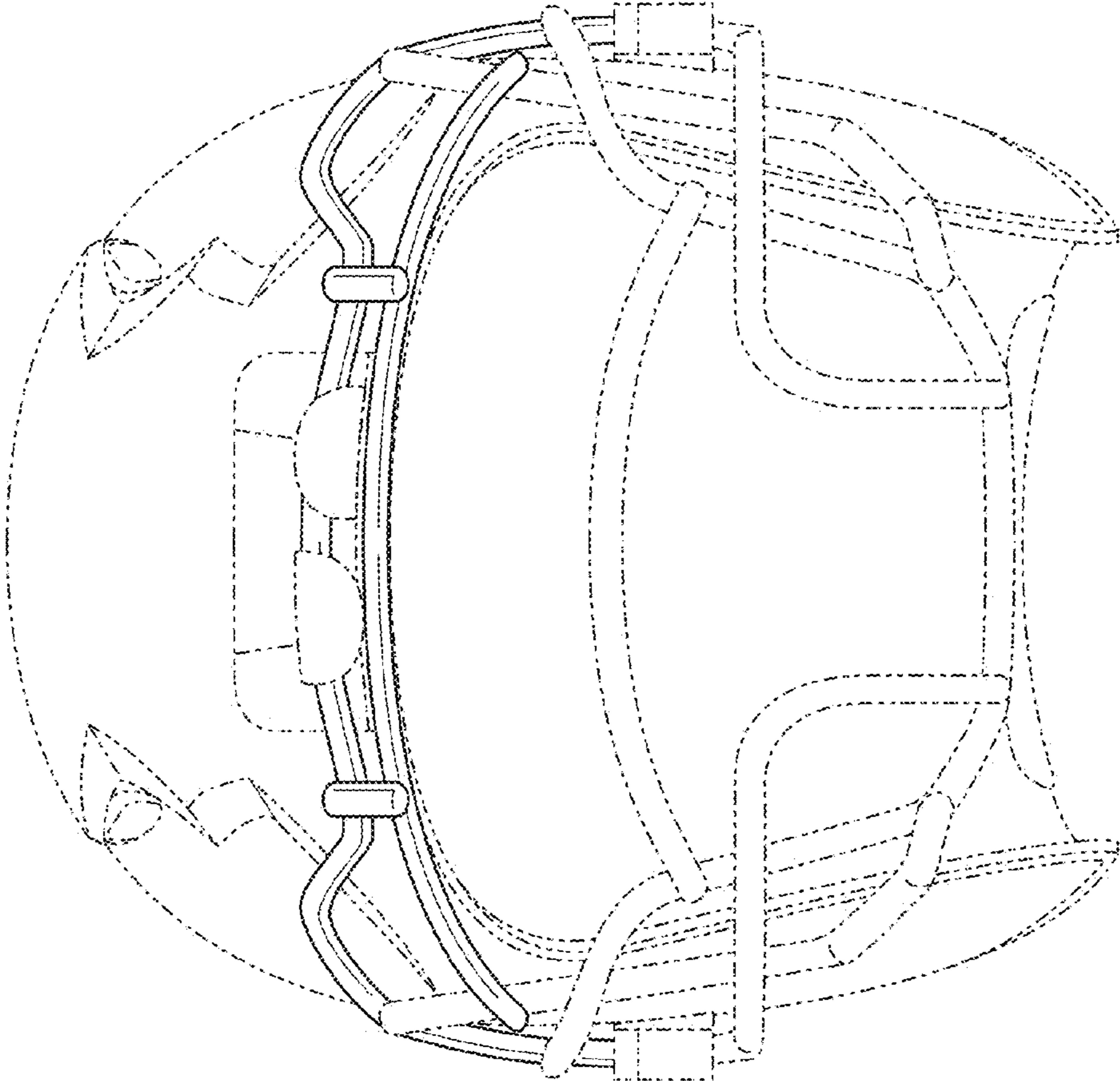

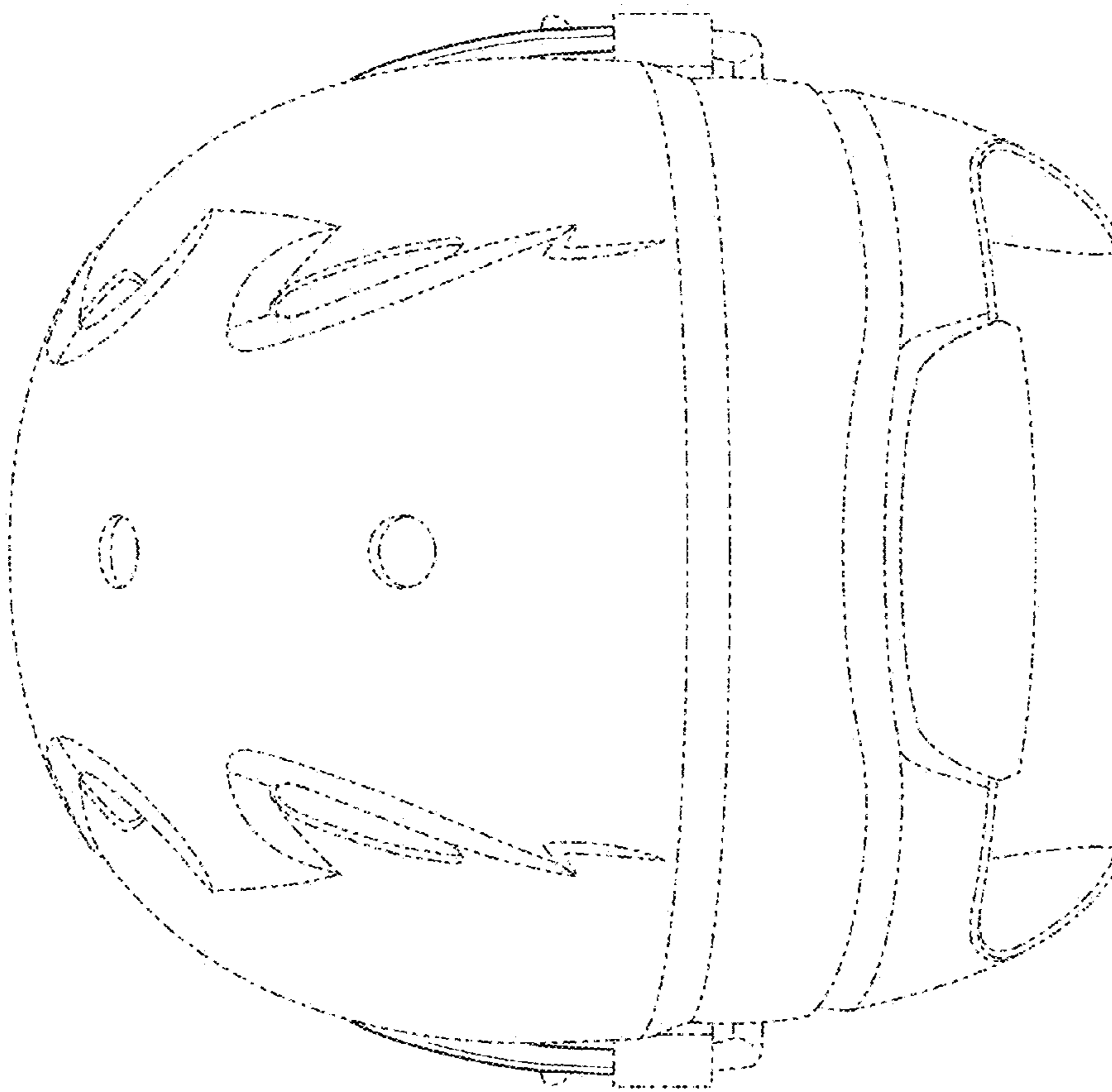

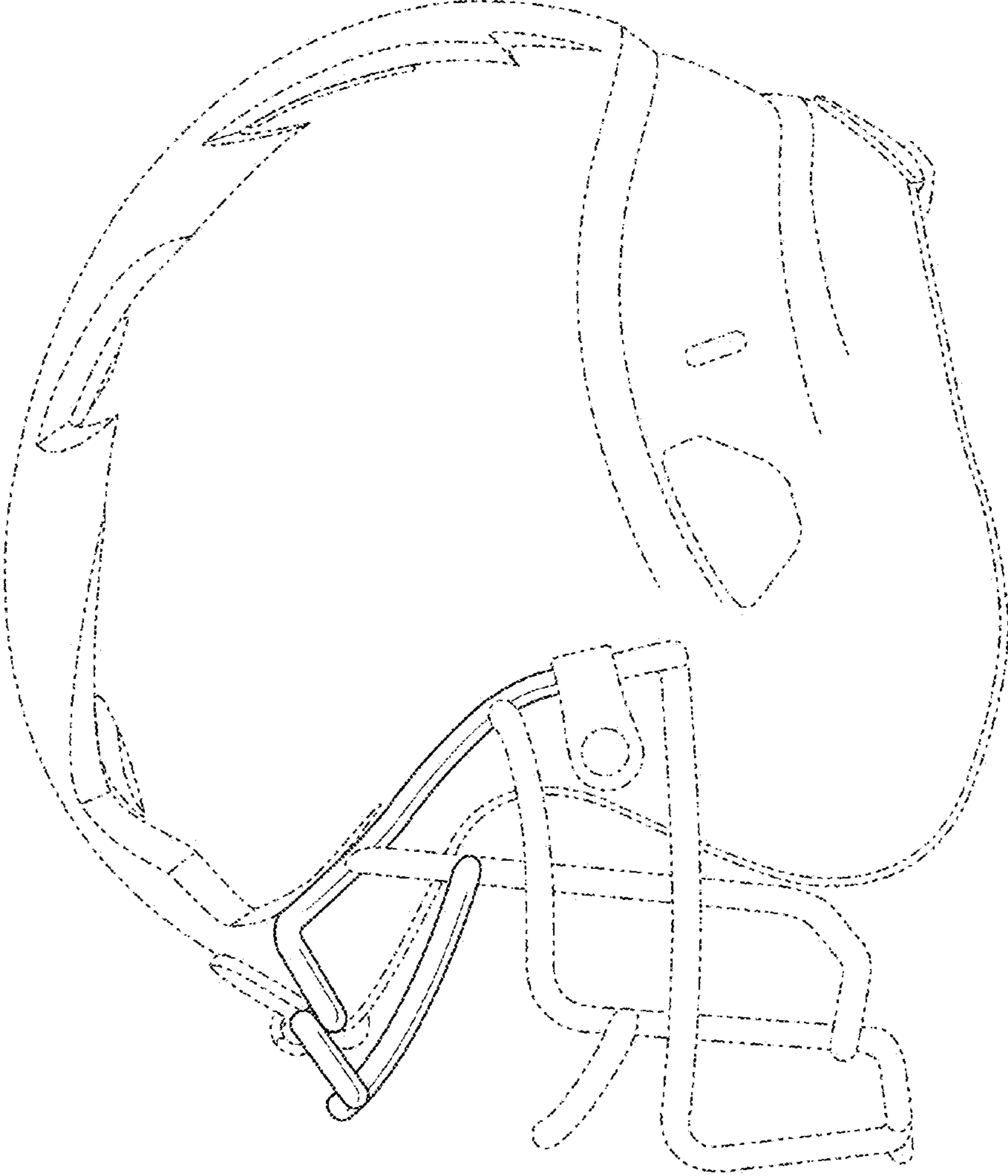

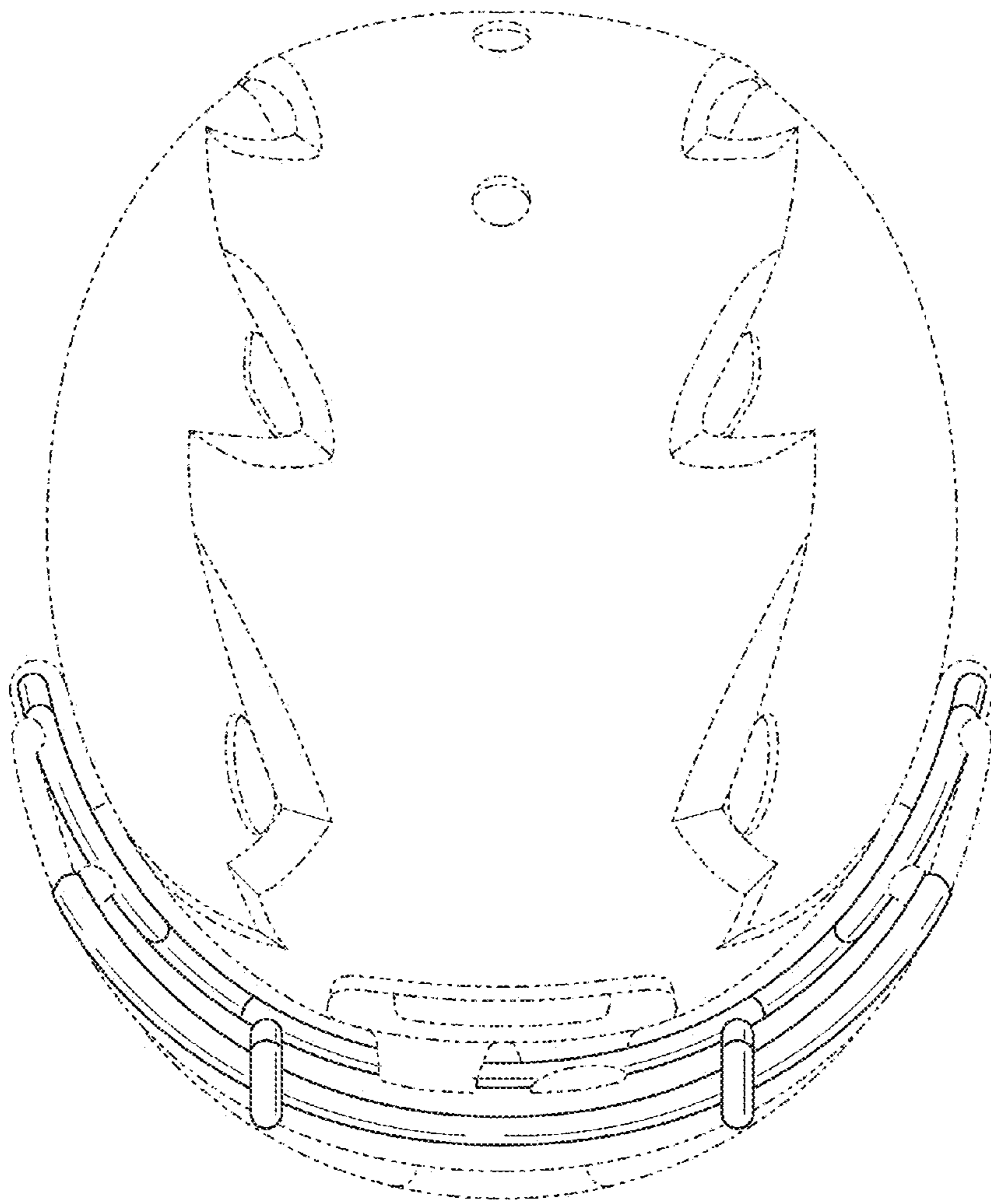

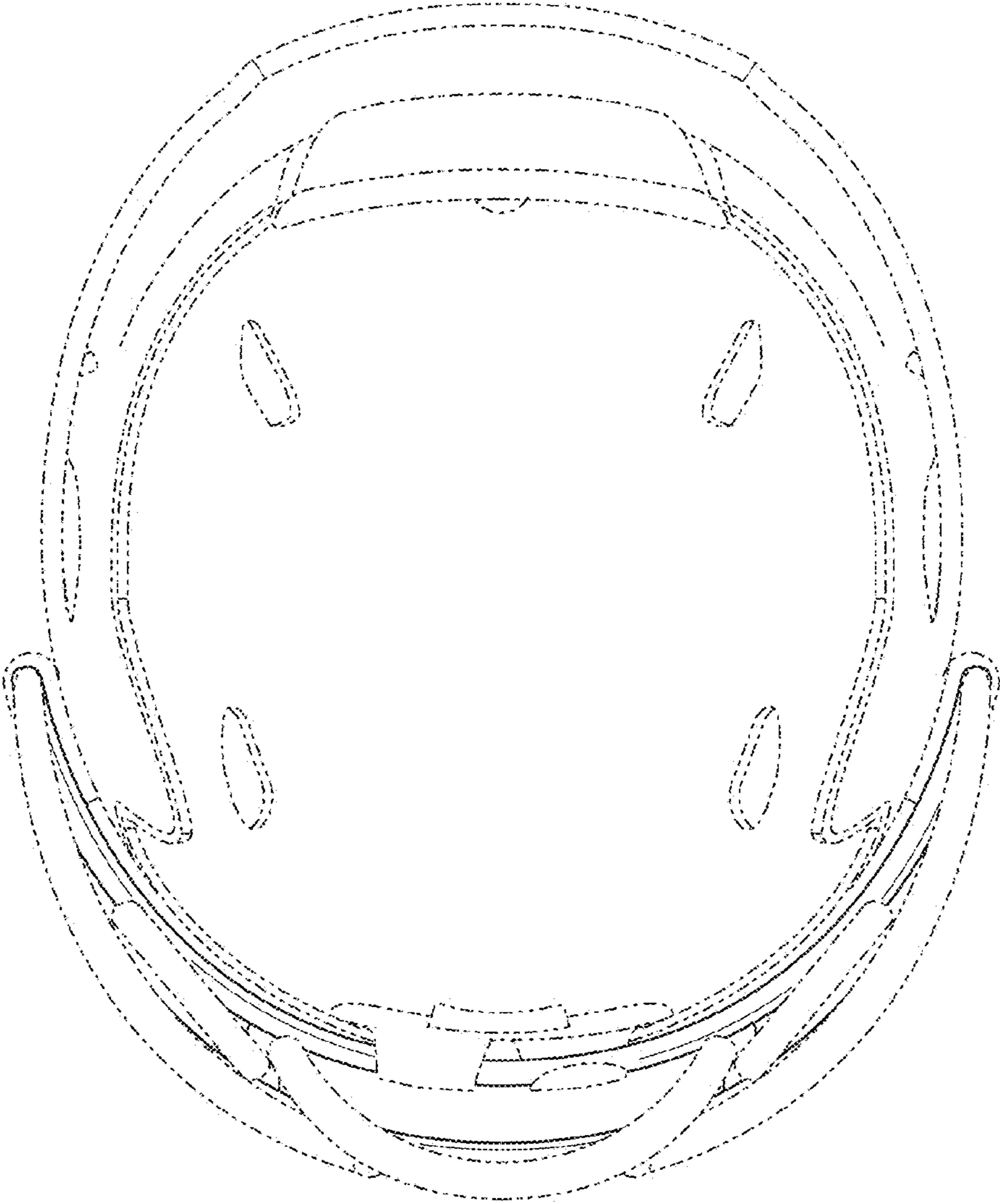
