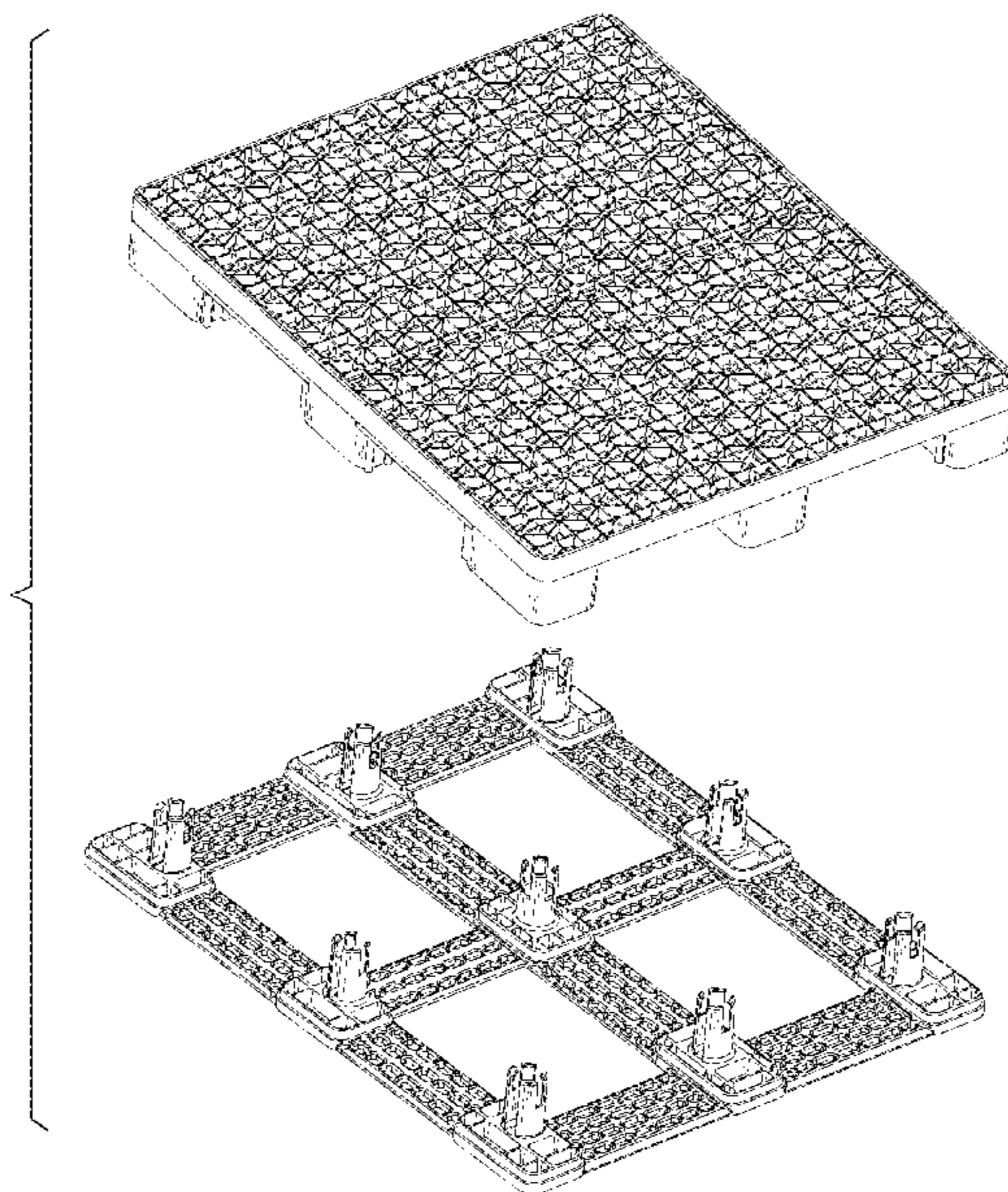
(57) **CLAIM**

I claim the ornamental design for a pallet, as shown and described.

DESCRIPTION

FIG. 1 is an exploded top perspective view of a pallet, showing a top portion and a bottom portion my new design;
 FIG. 2 is an exploded bottom perspective view thereof;
 FIG. 3 is a top perspective view thereof;
 FIG. 4 is a bottom perspective view thereof;
 FIG. 5 is an exploded front elevational view thereof, the rear elevational view being a mirror image thereof;
 FIG. 6 is an exploded left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 7 is an exploded top plan view thereof;
 FIG. 8 is an exploded bottom plan view thereof;
 FIG. 9 is a cross-sectional view of the top portion of the pallet, taken along lines 9-9 of FIG. 6;
 FIG. 10 is a cross-sectional view of the top portion of the pallet, taken along lines 10-10 of FIG. 6;
 FIG. 11 is a cross-sectional view of the top portion of the pallet, taken along lines 11-11 of FIG. 6;
 FIG. 12 is a partial enlarged cross-sectional view taken along line 12-12 of FIG. 9;
 FIG. 13 is a partial enlarged cross-sectional view taken along line 13-13 of FIG. 10; and,
 FIG. 14 is a partial enlarged cross-sectional view taken along line 14-14 of FIG. 11.

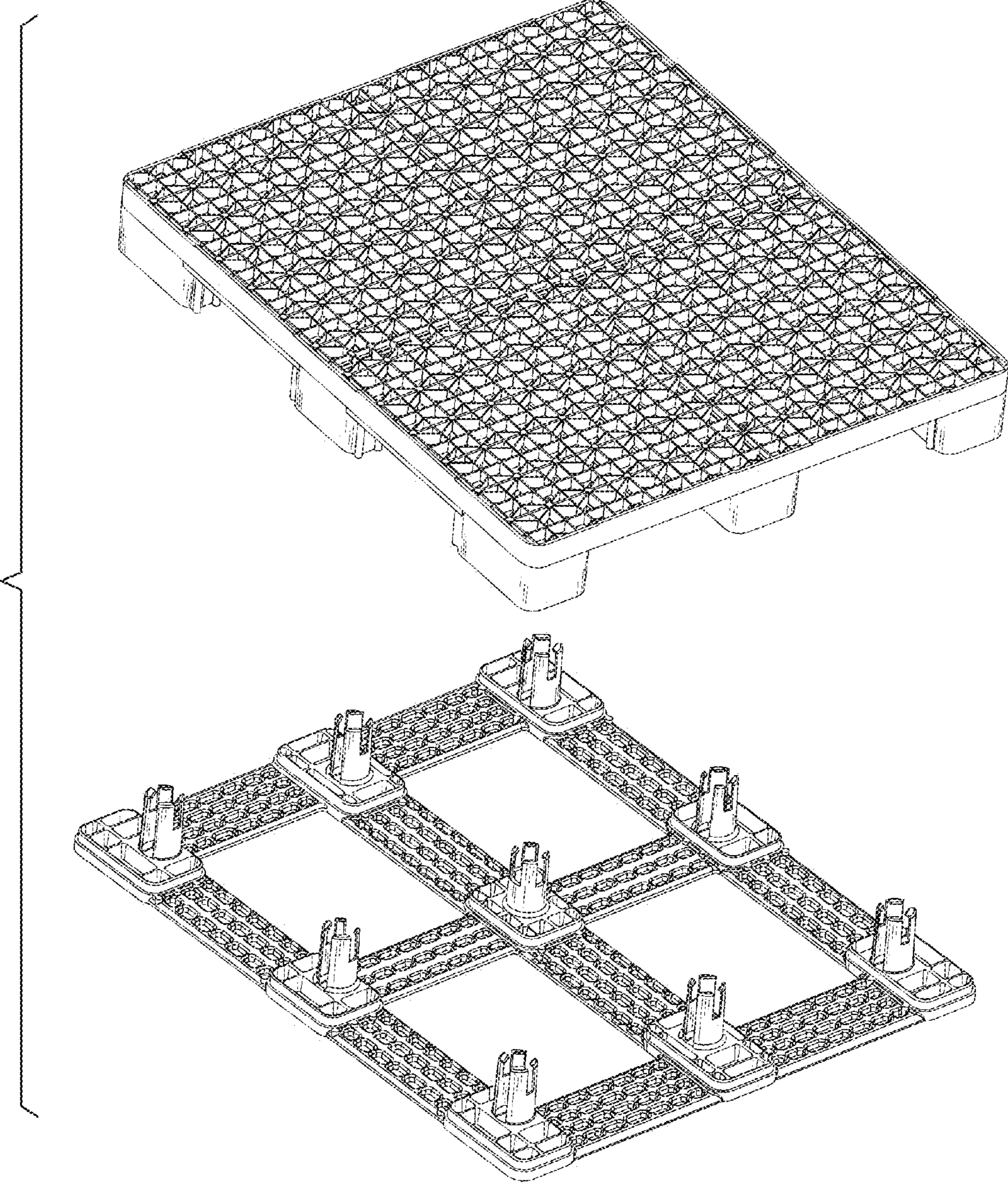

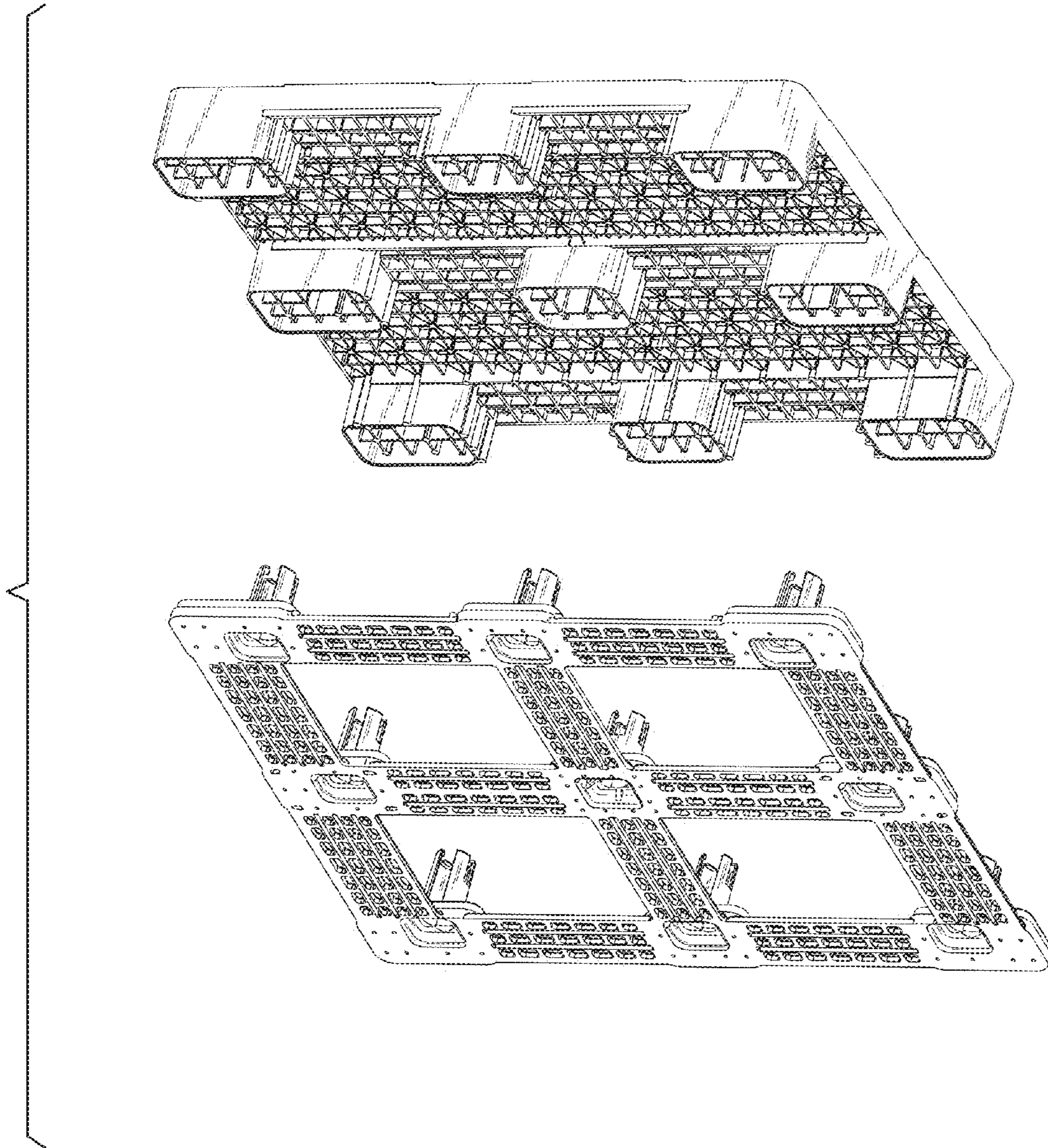

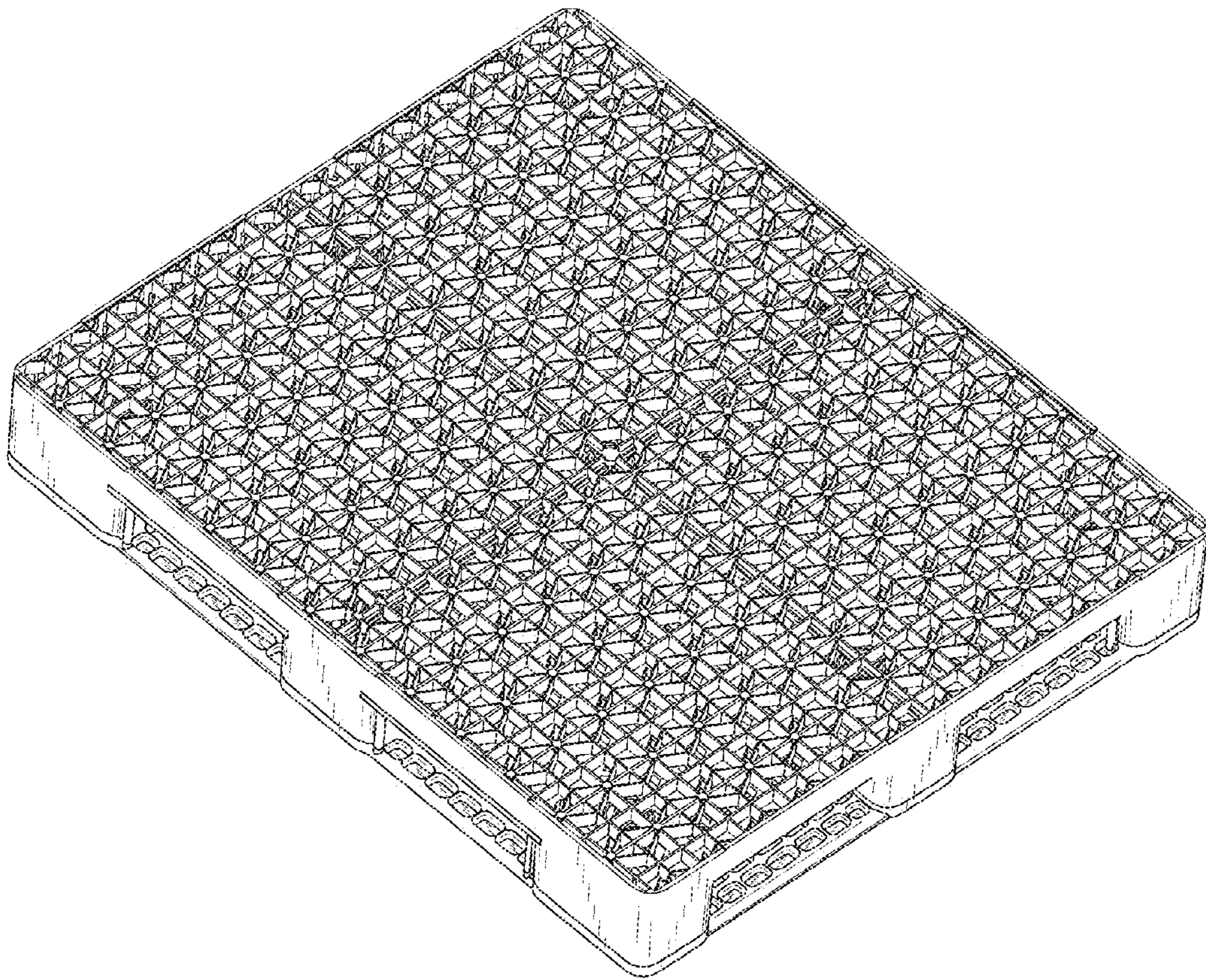

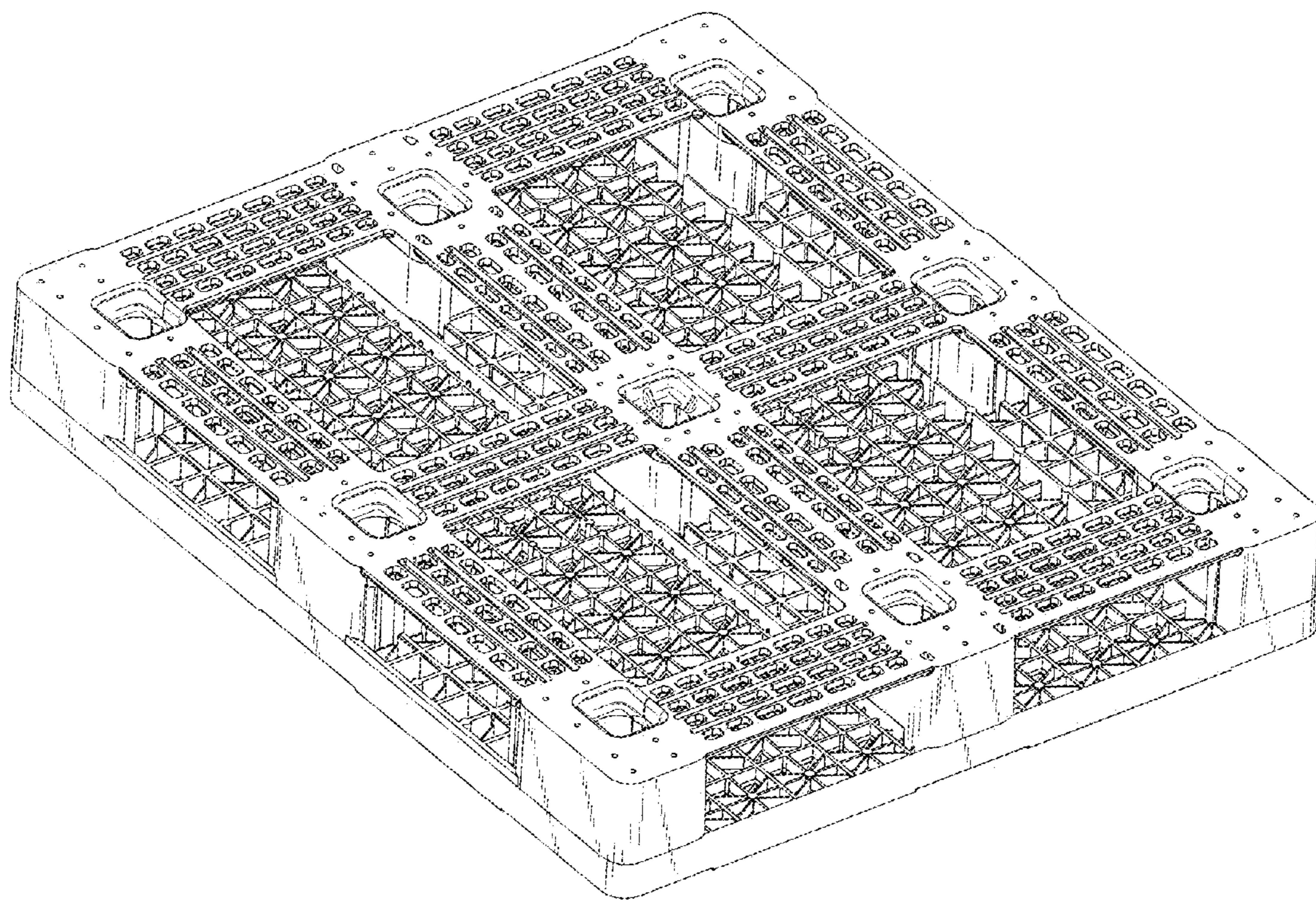

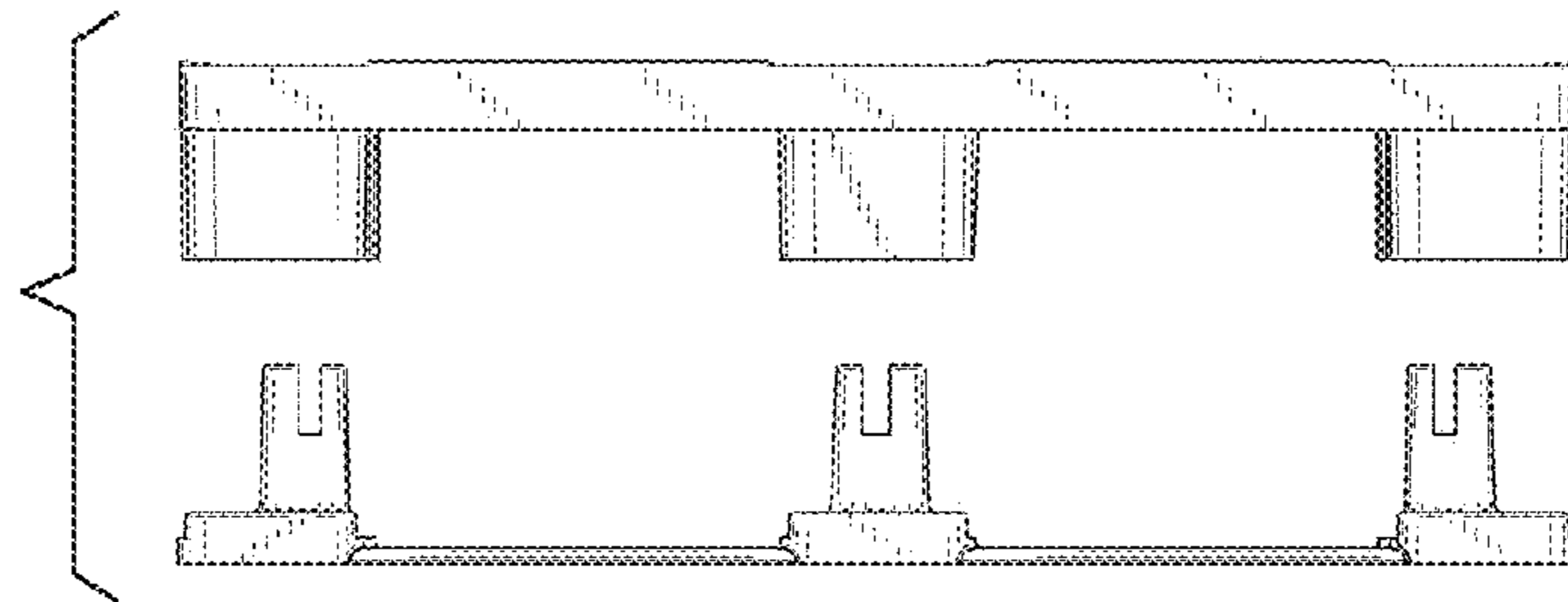

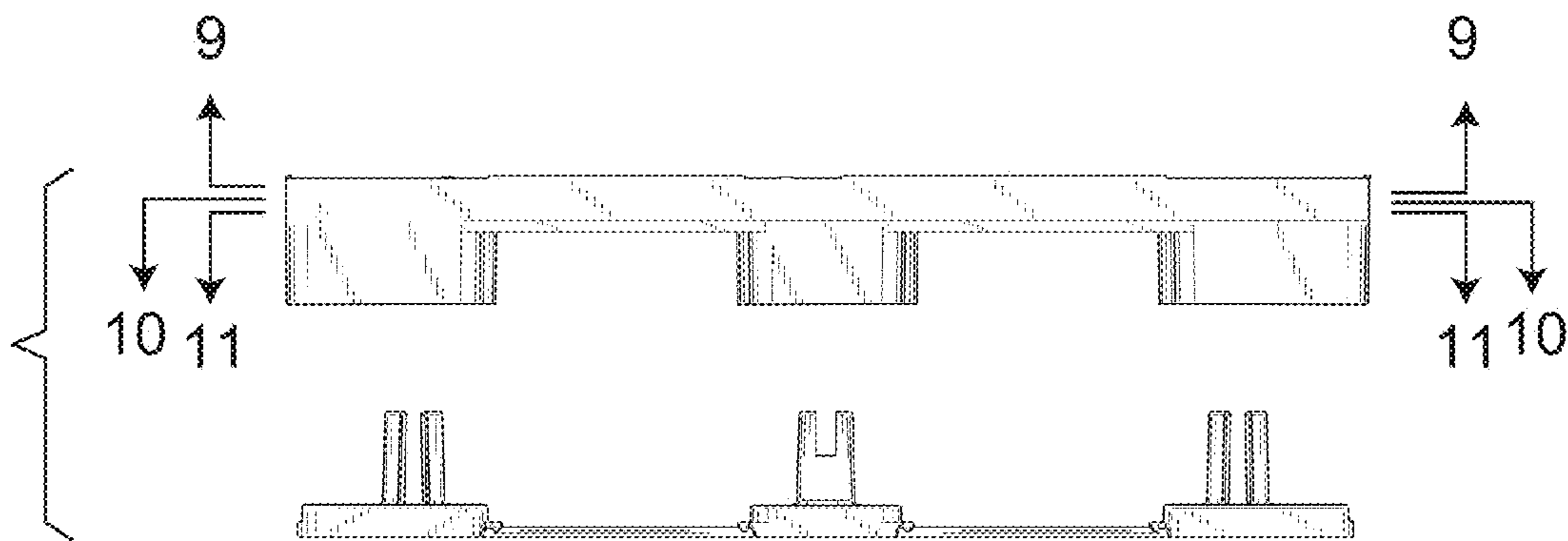

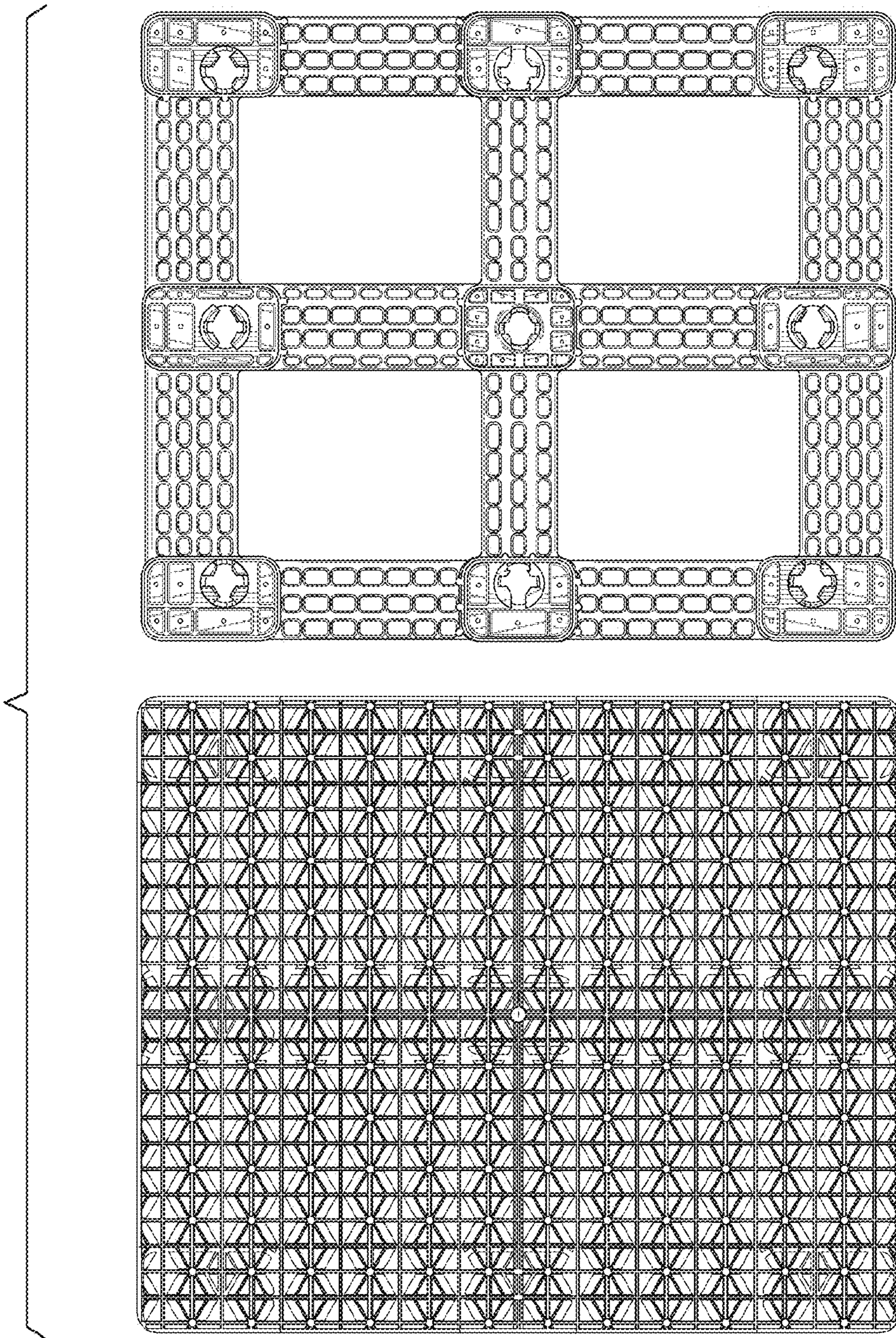

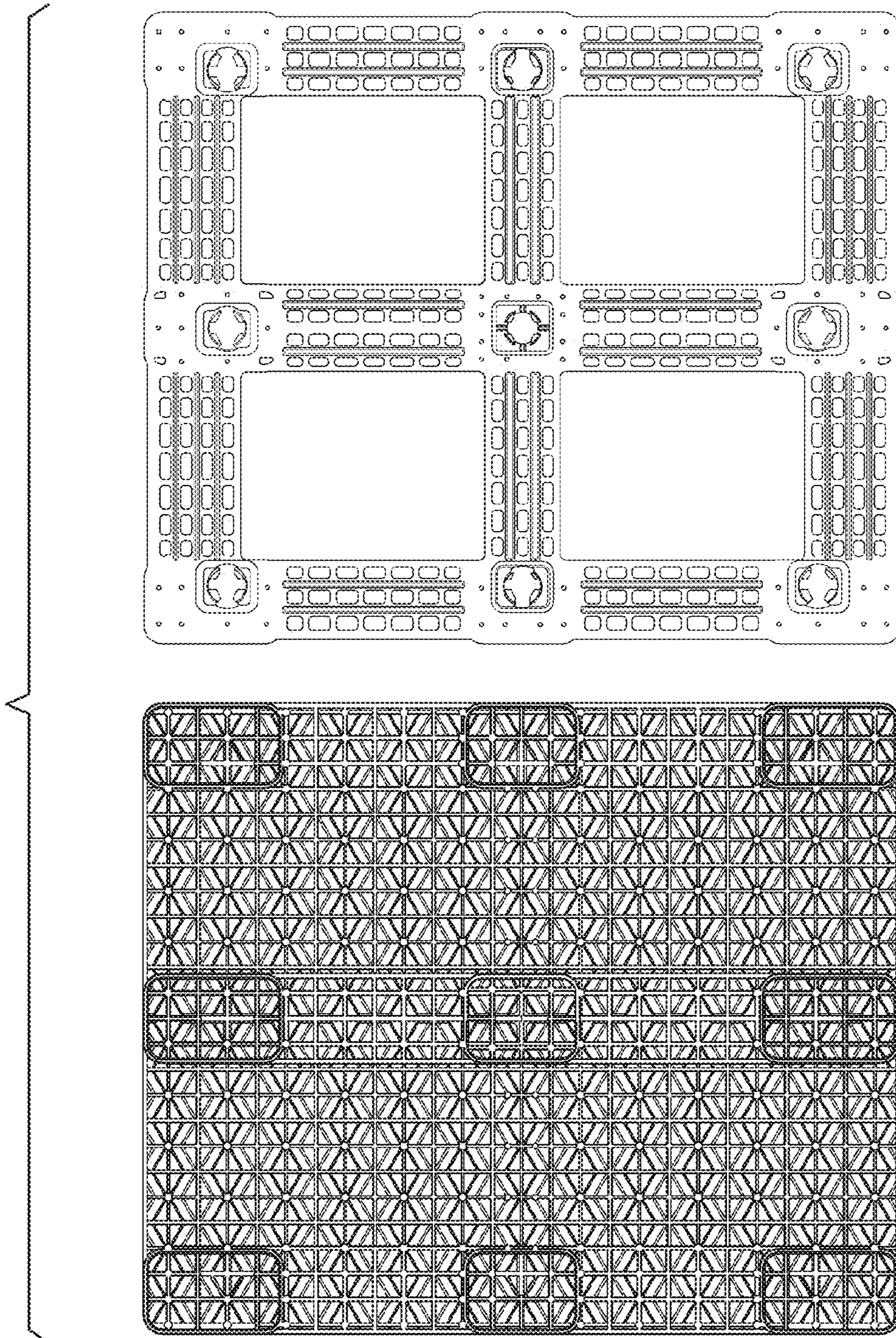
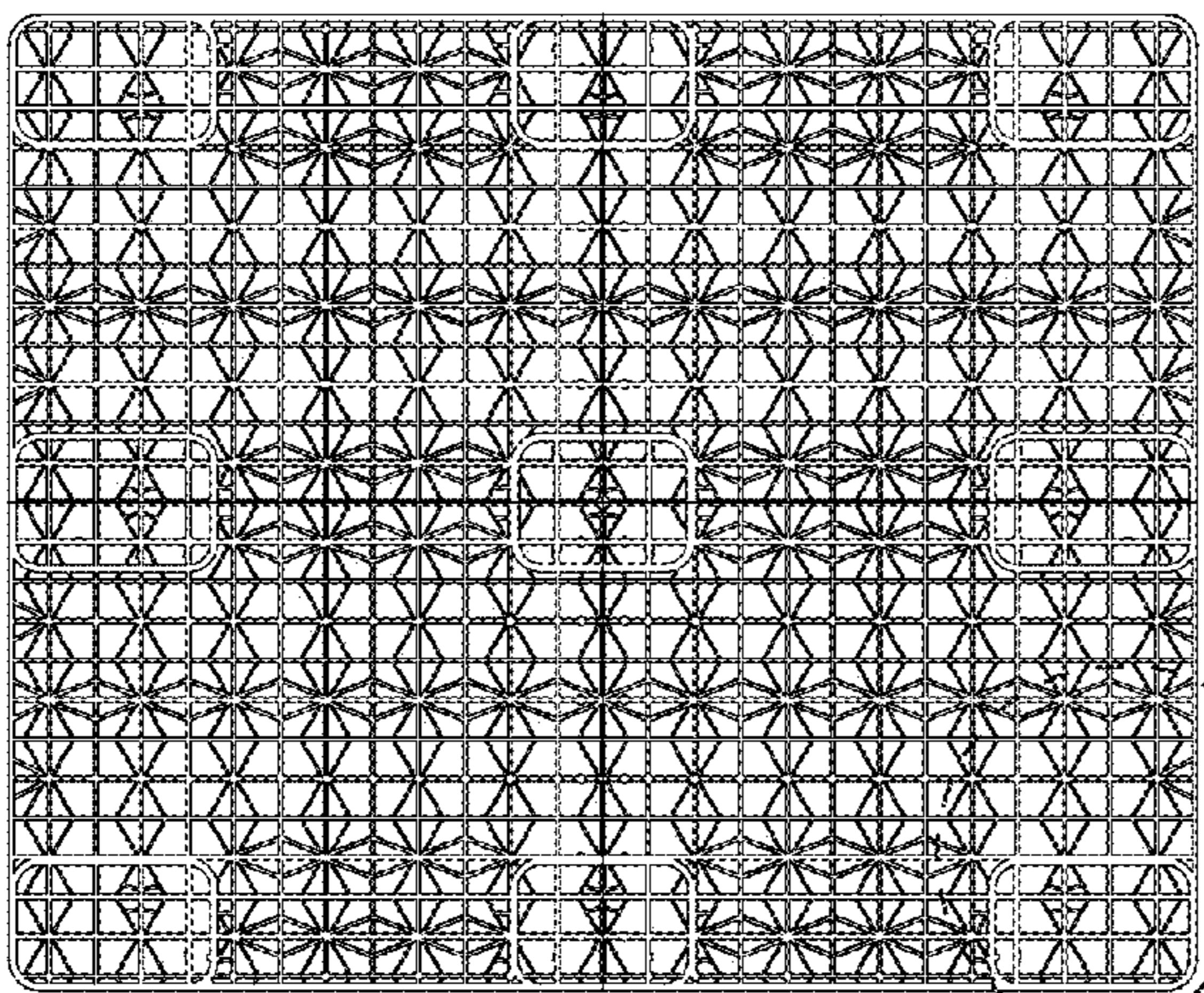
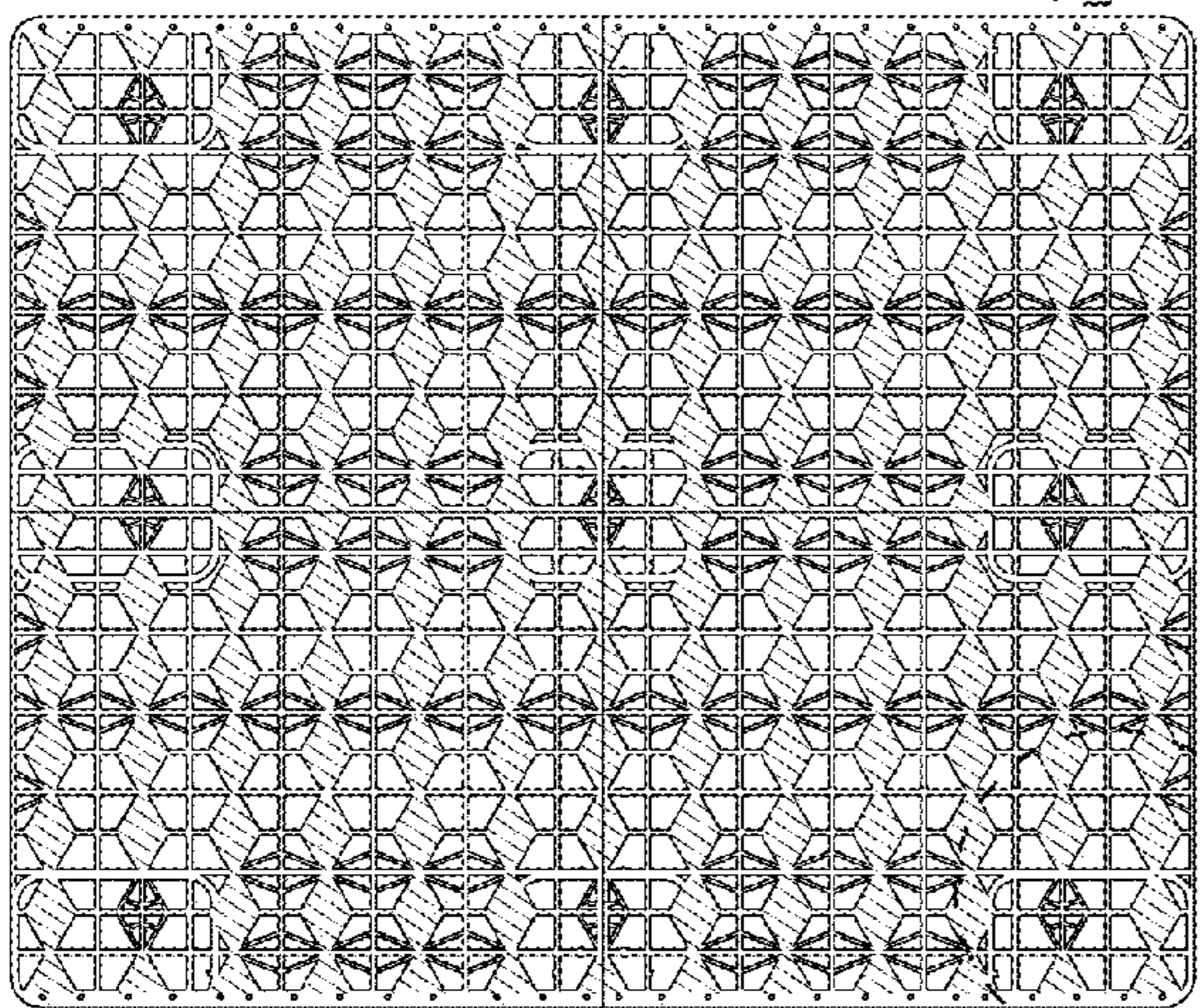


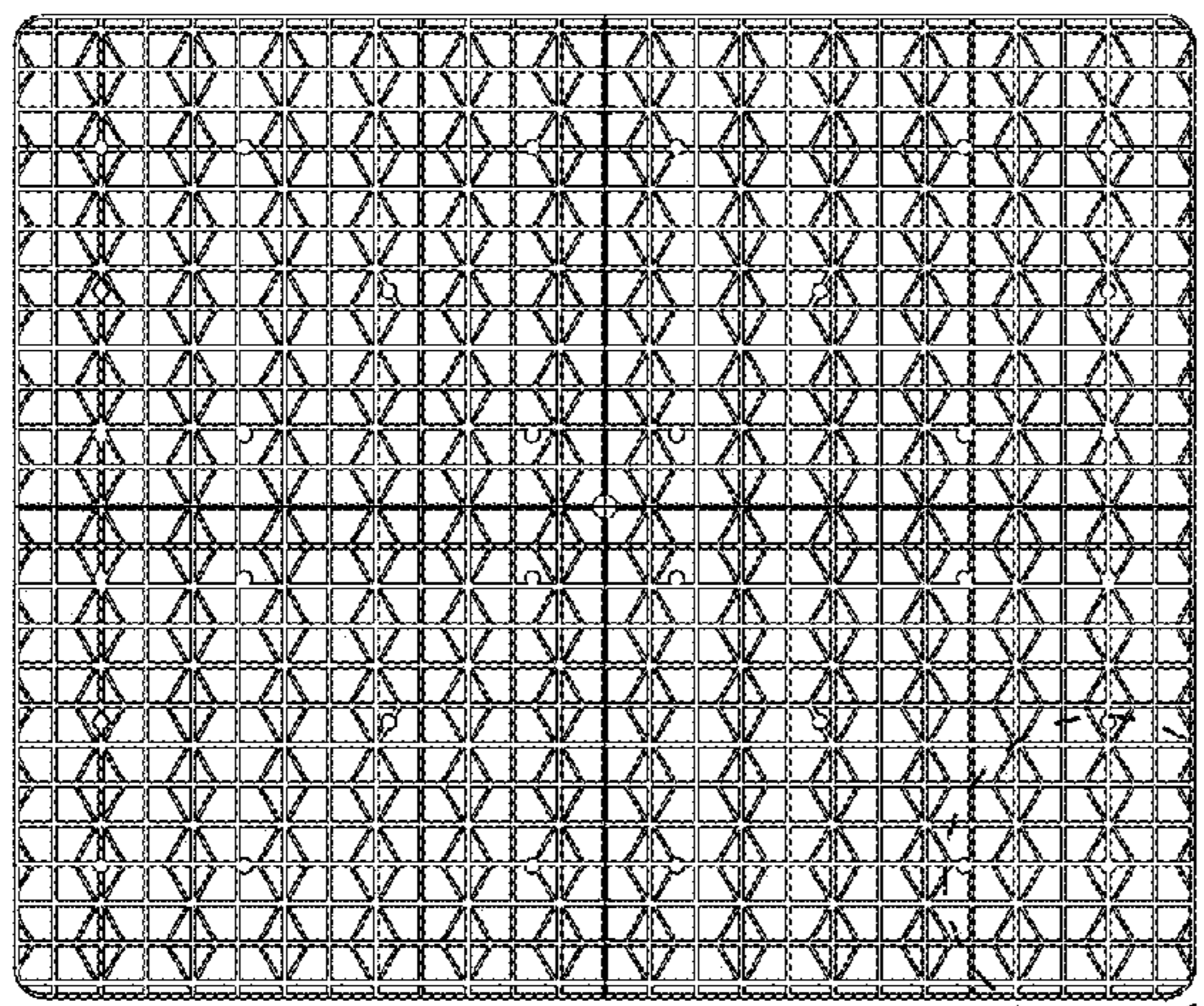

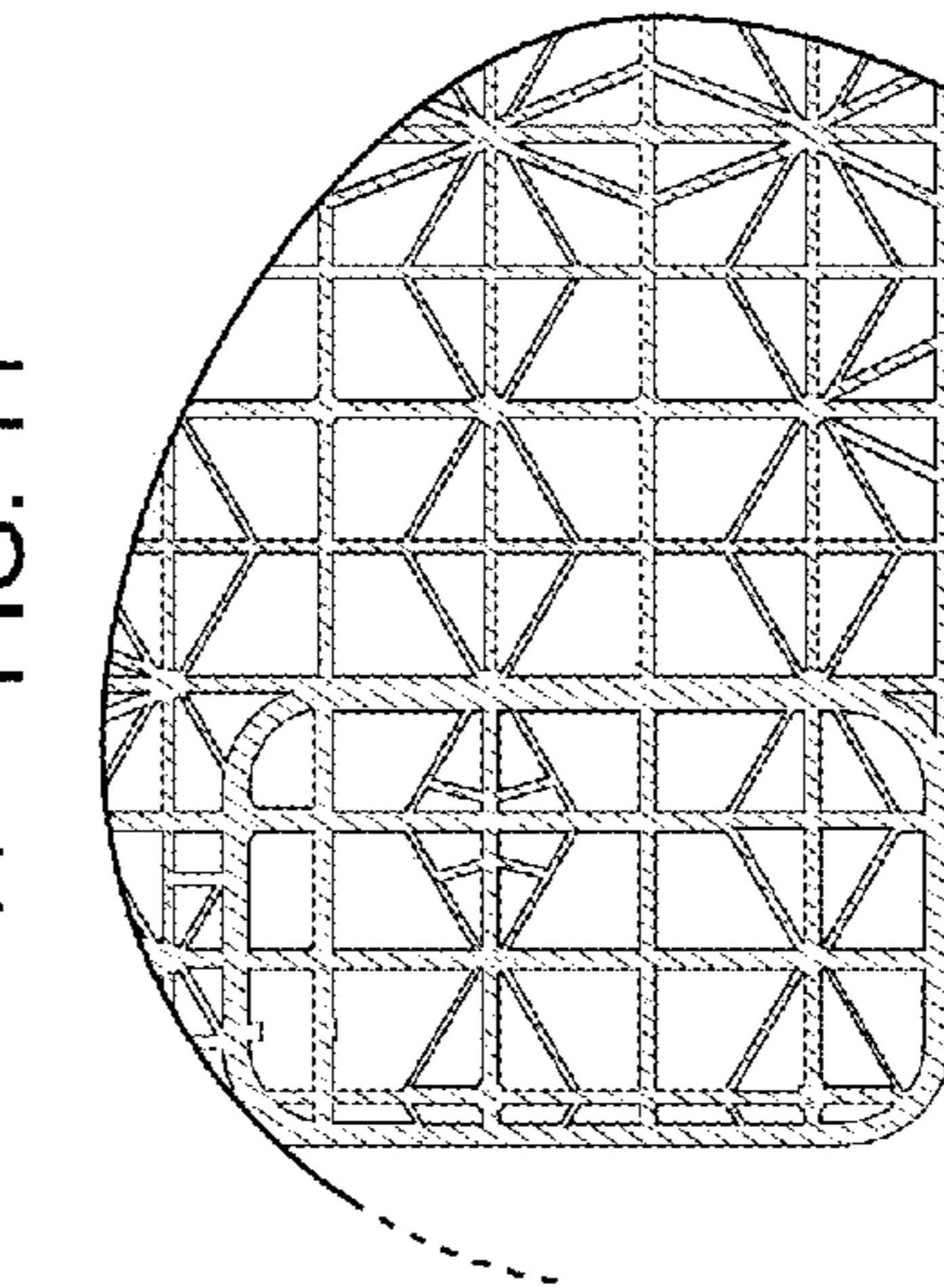

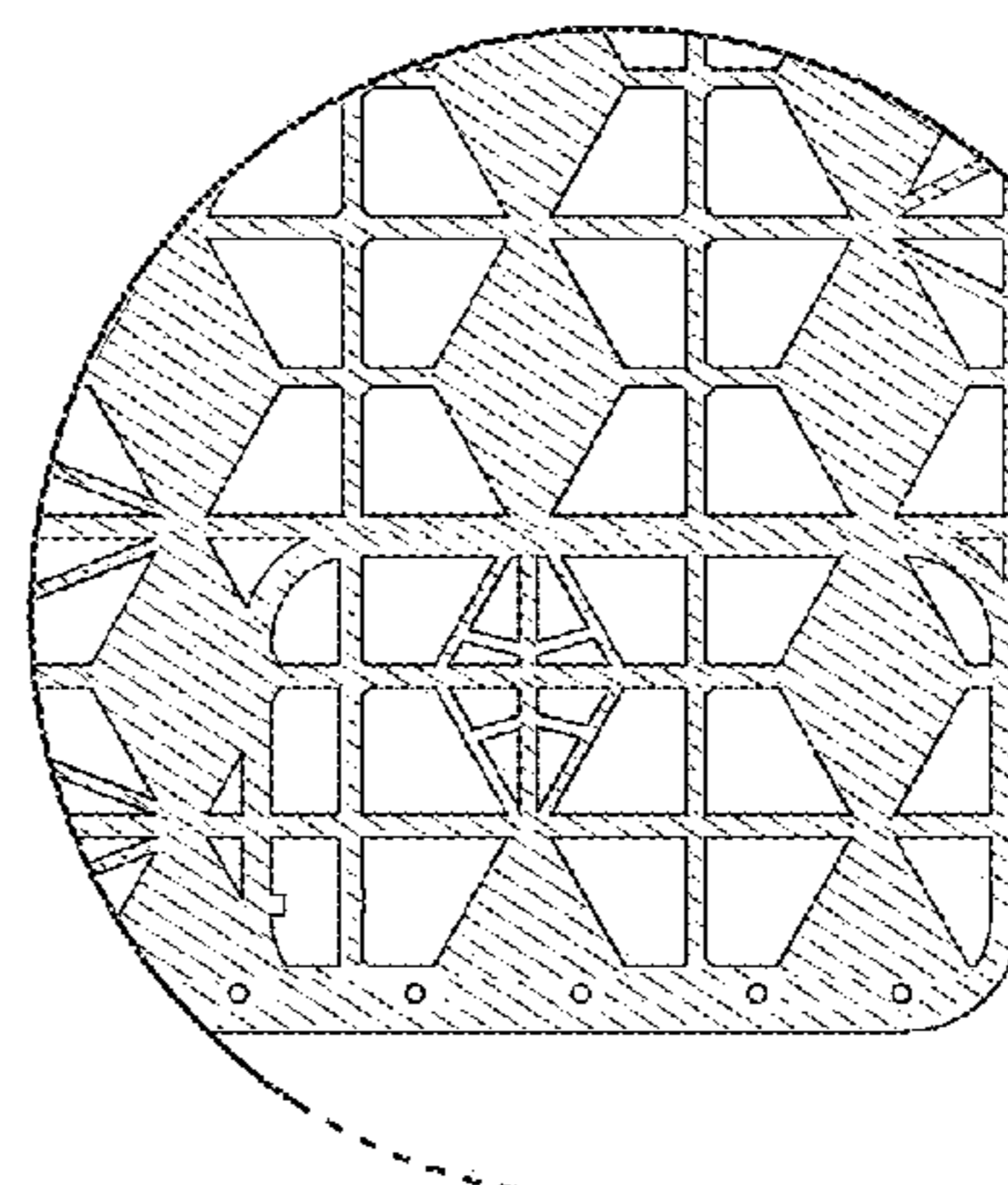

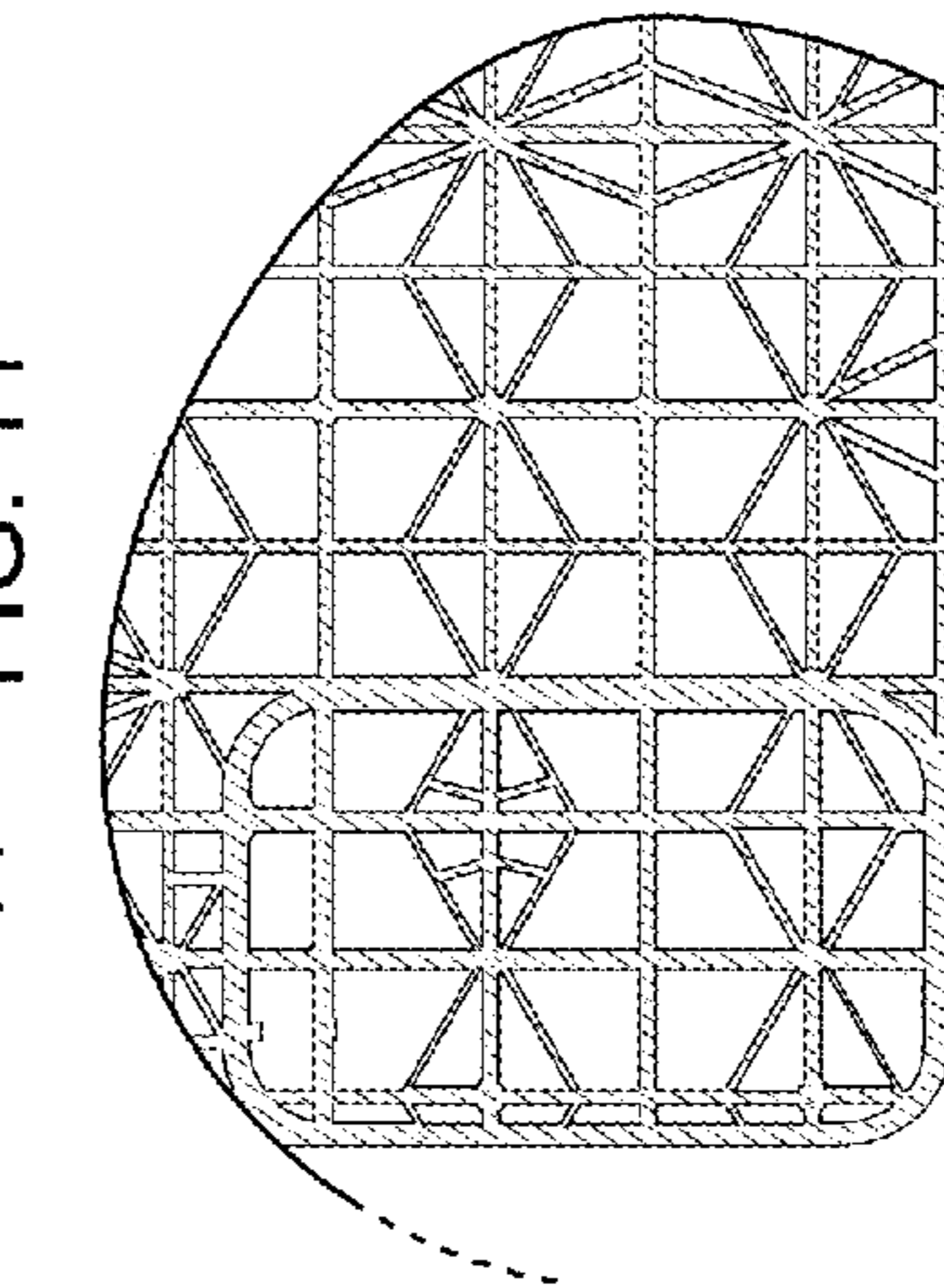
