**DESCRIPTION**

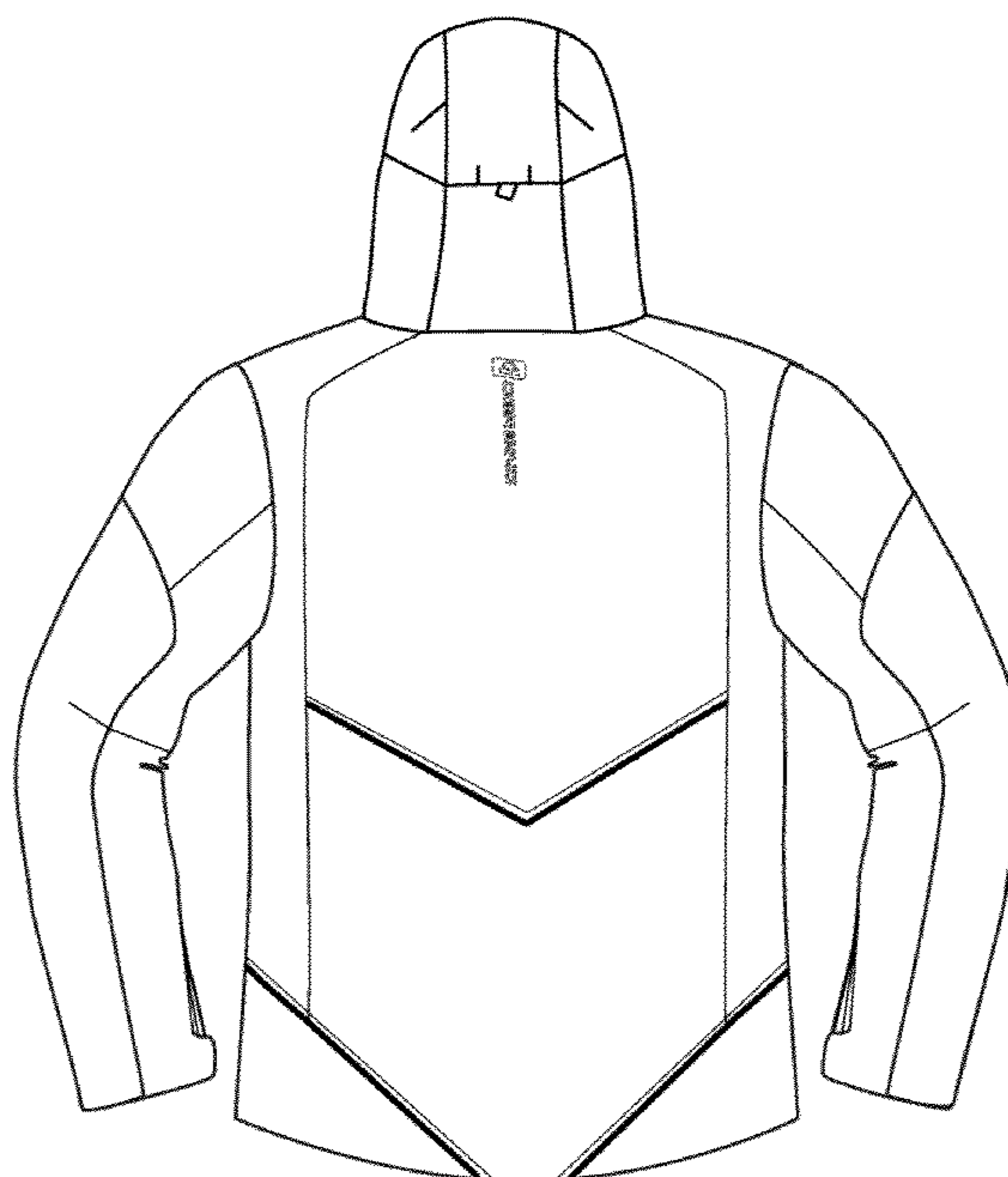
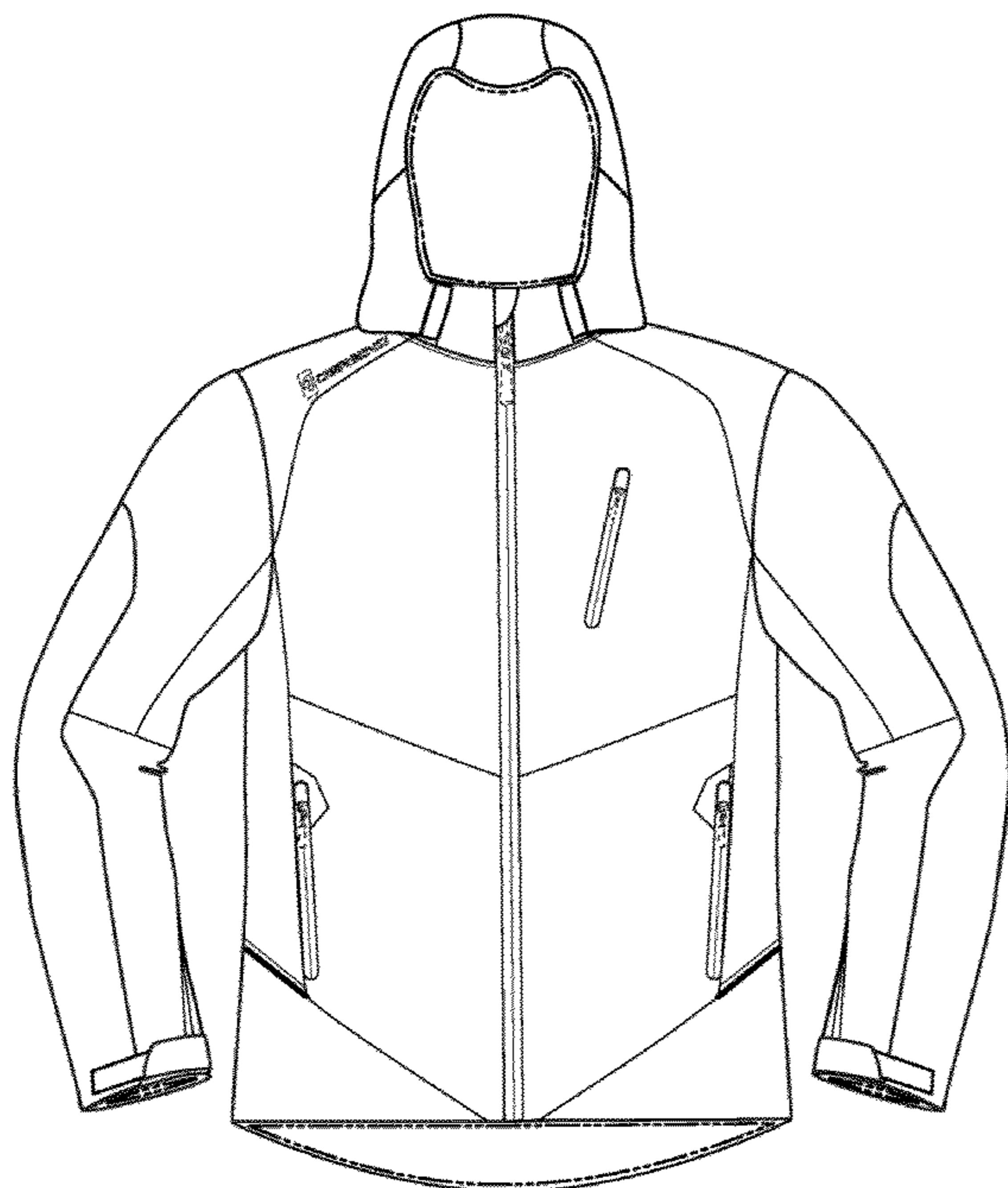
FIG. 4 is a left side elevational view of the ski jacket from FIGS. 1-3;

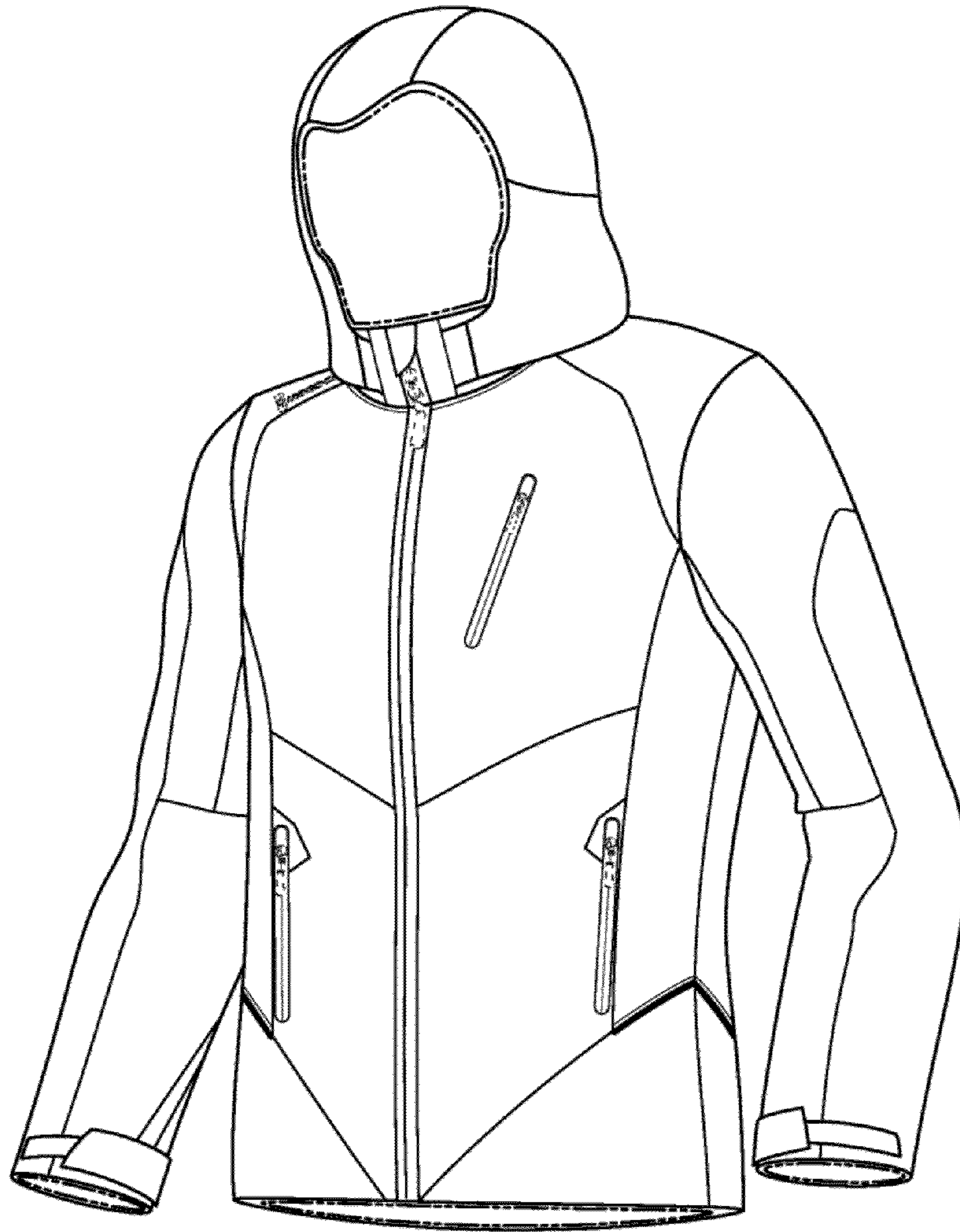

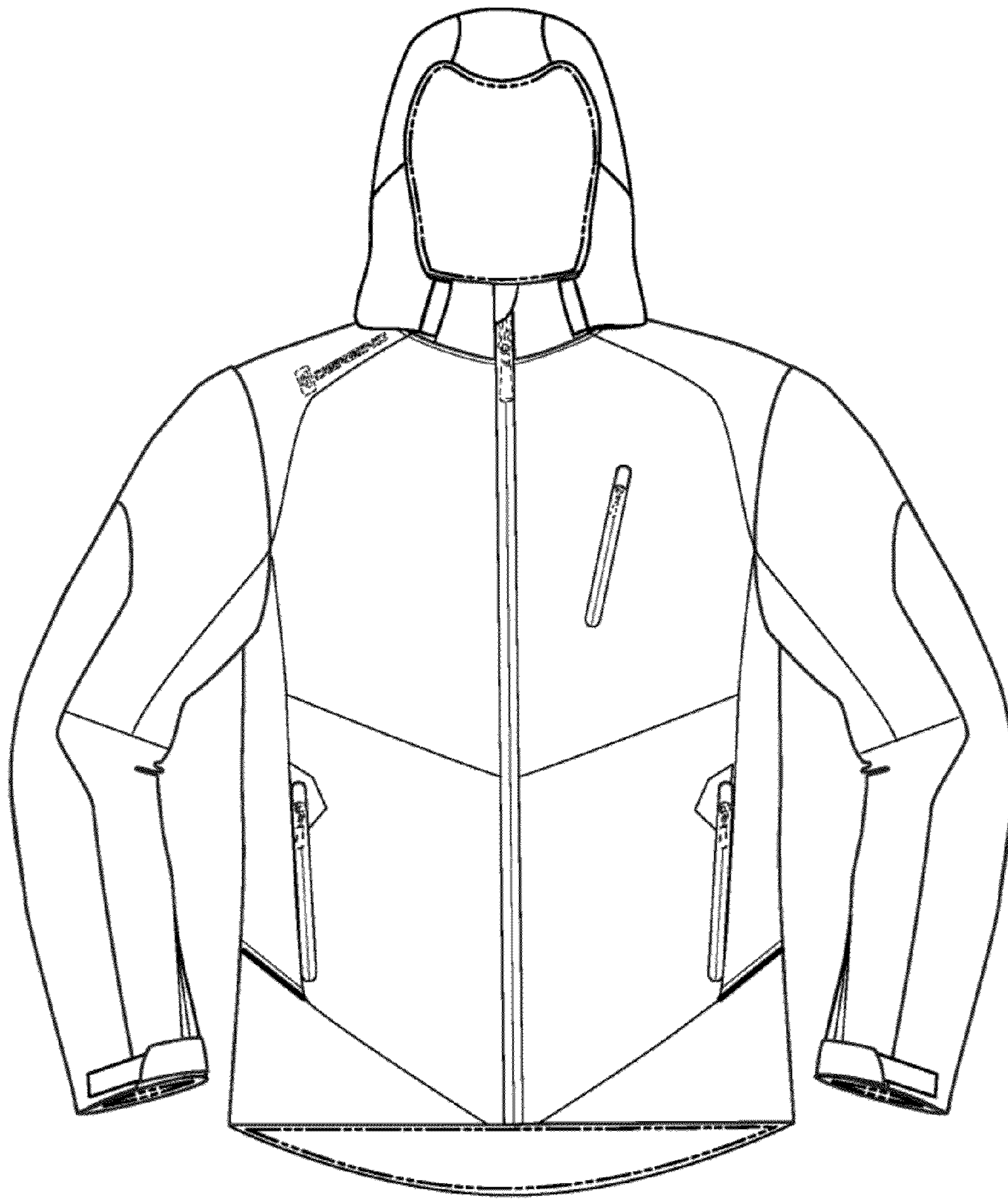
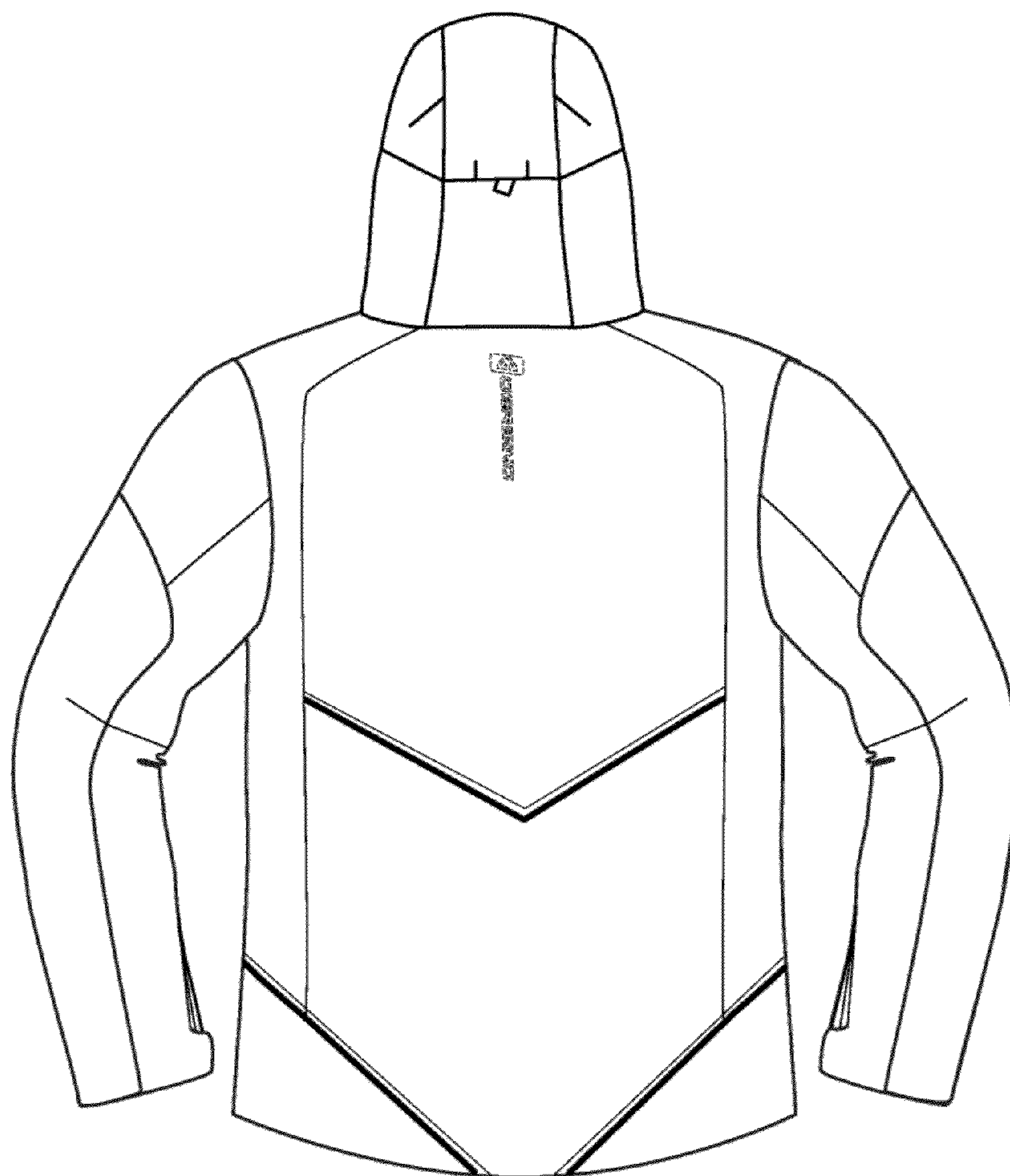
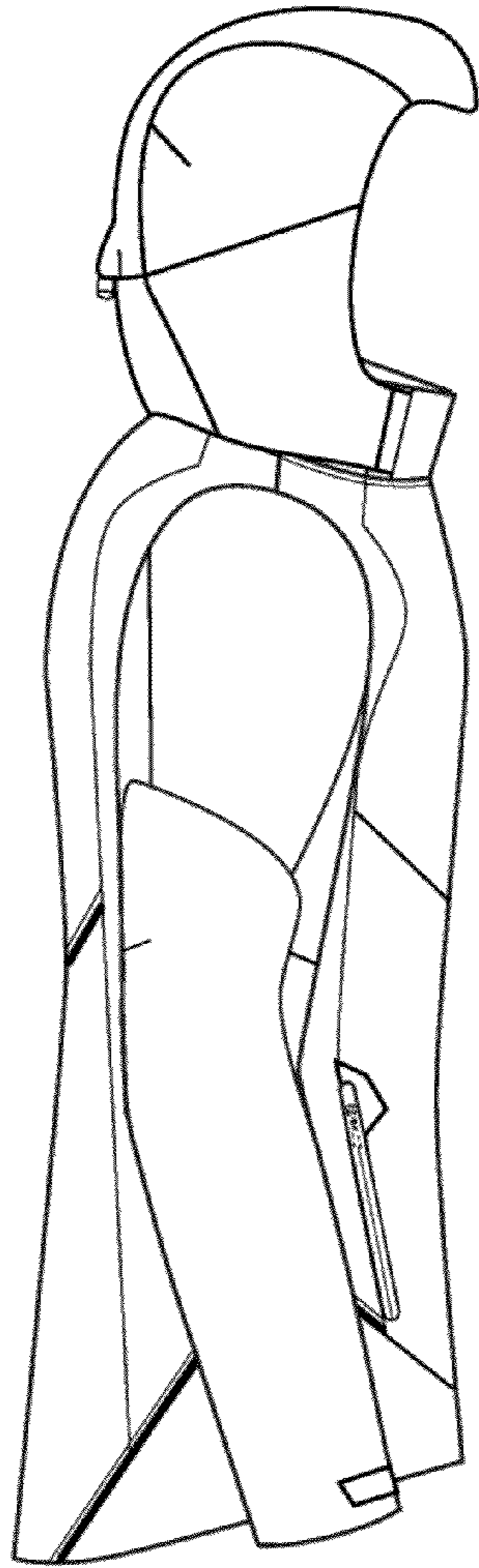


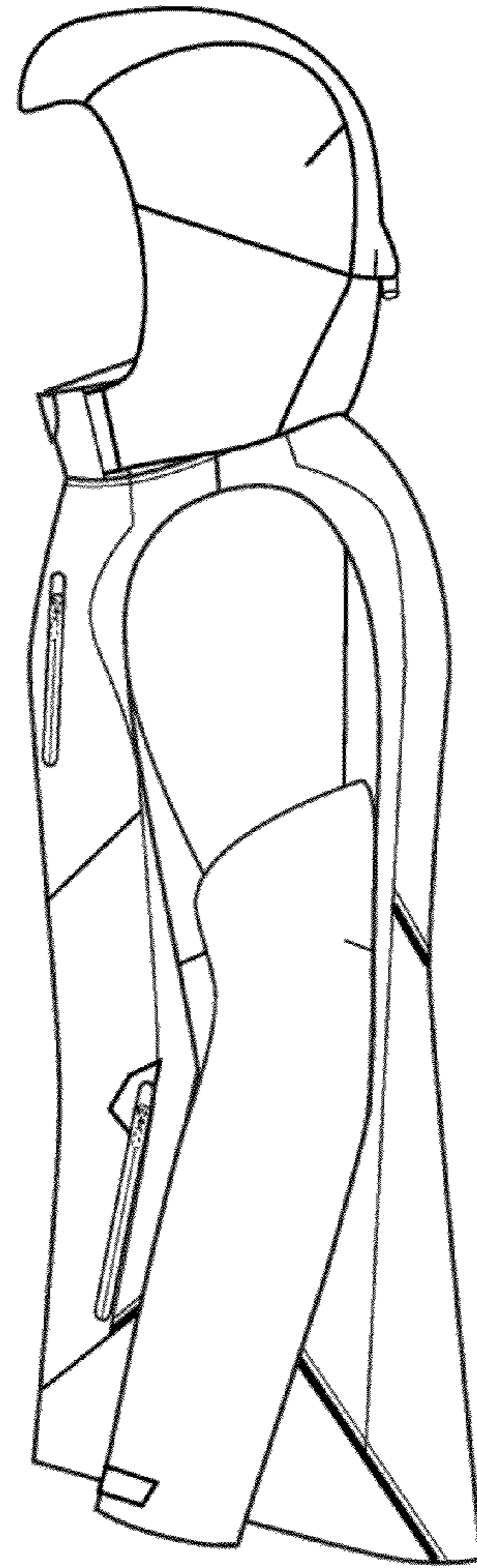

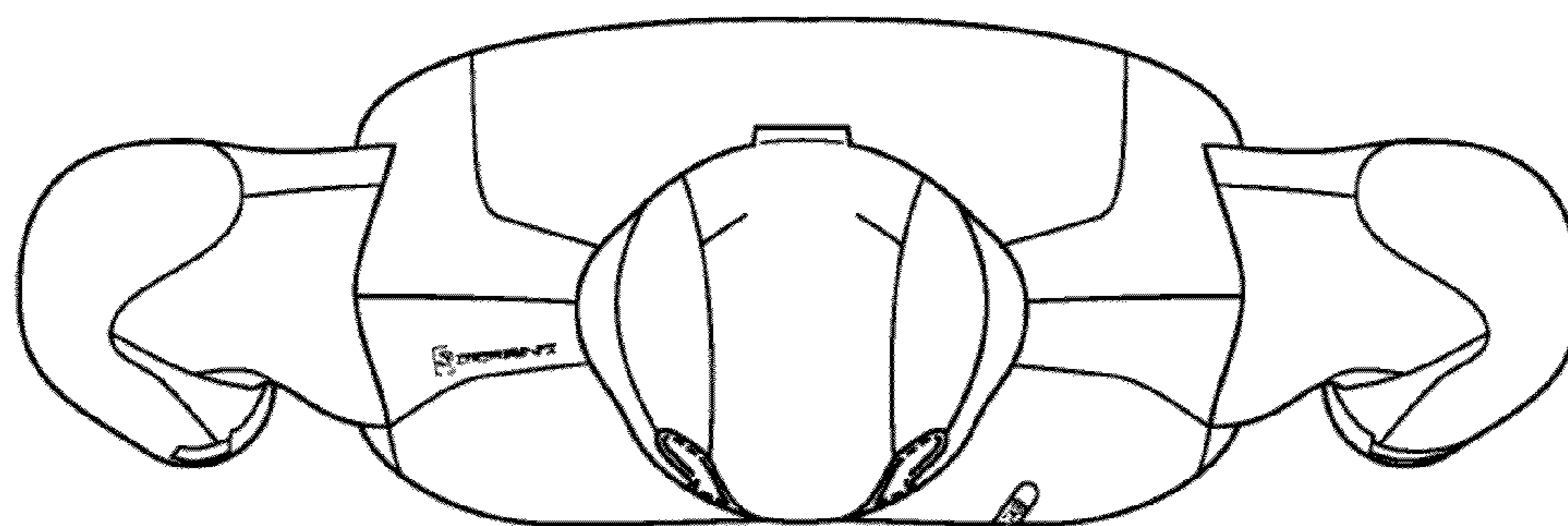

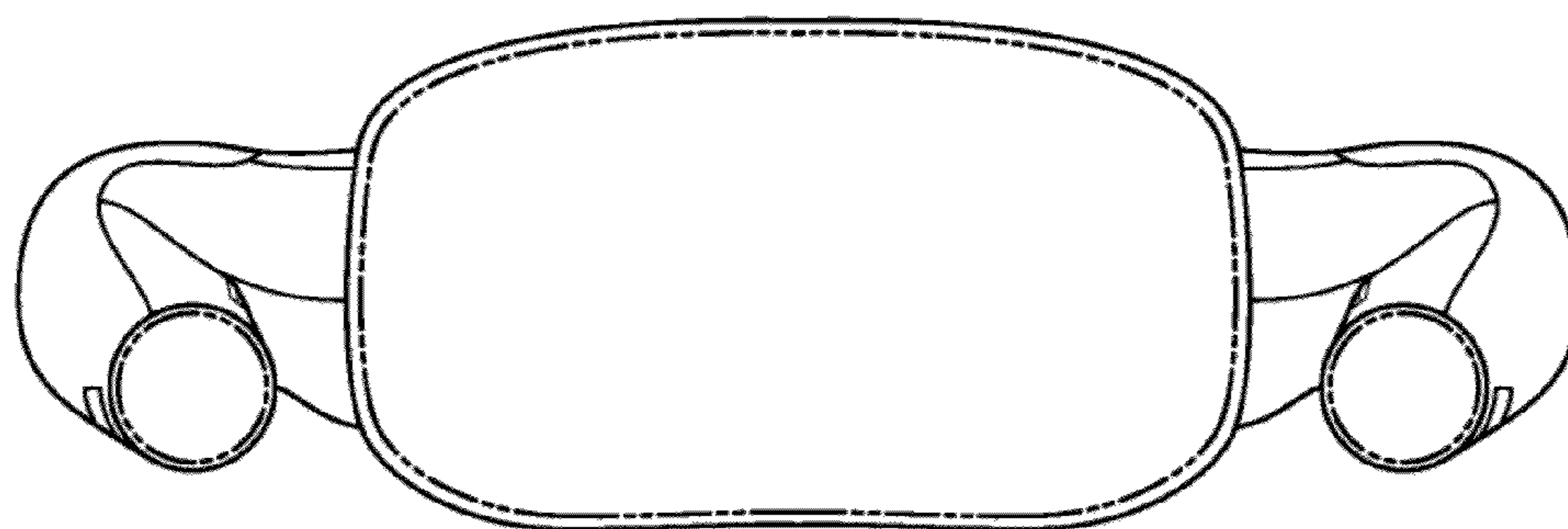
