DESCRIPTION

FIG. 1 is a perspective view of a boot upper according to a first embodiment of my new design;

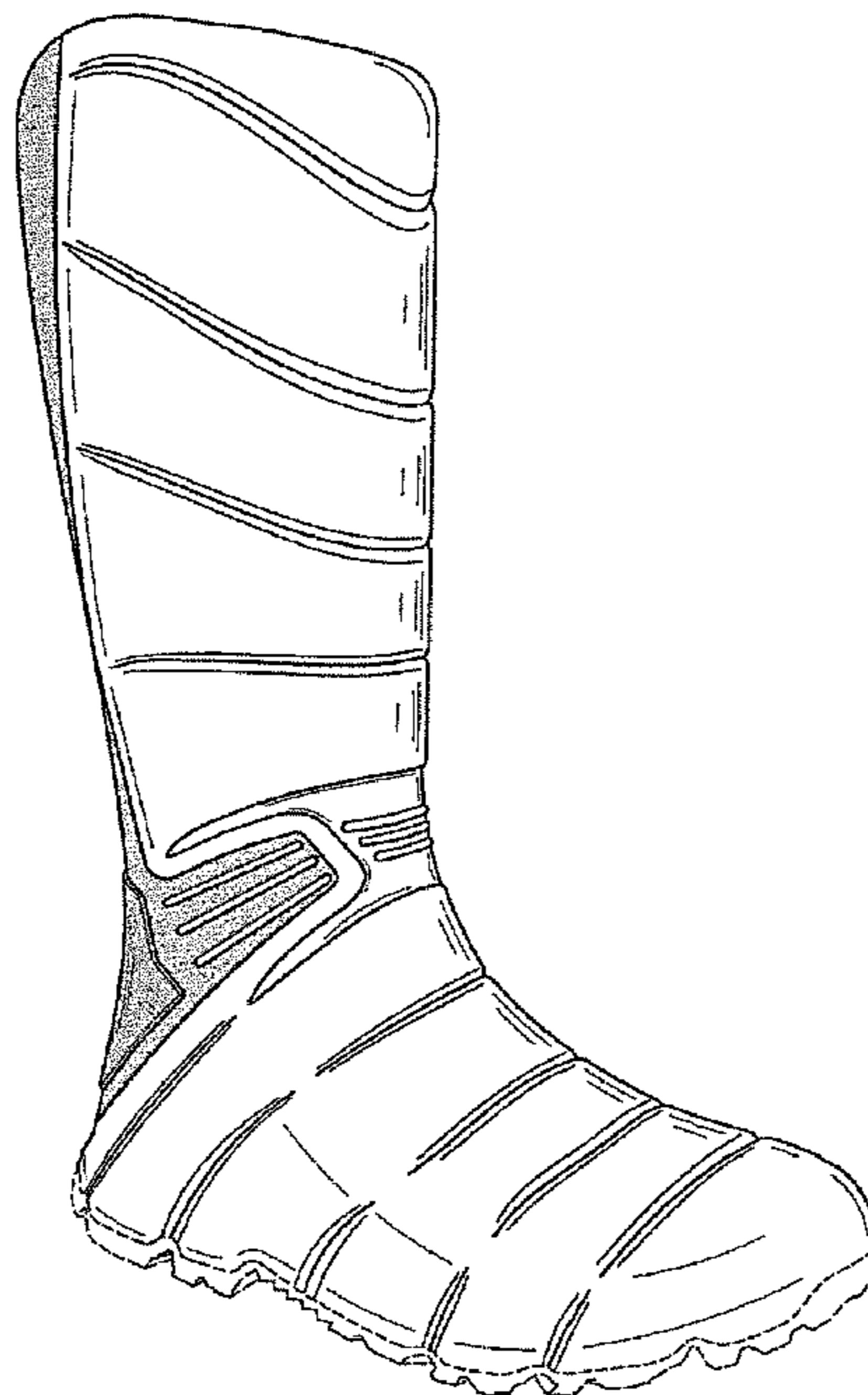

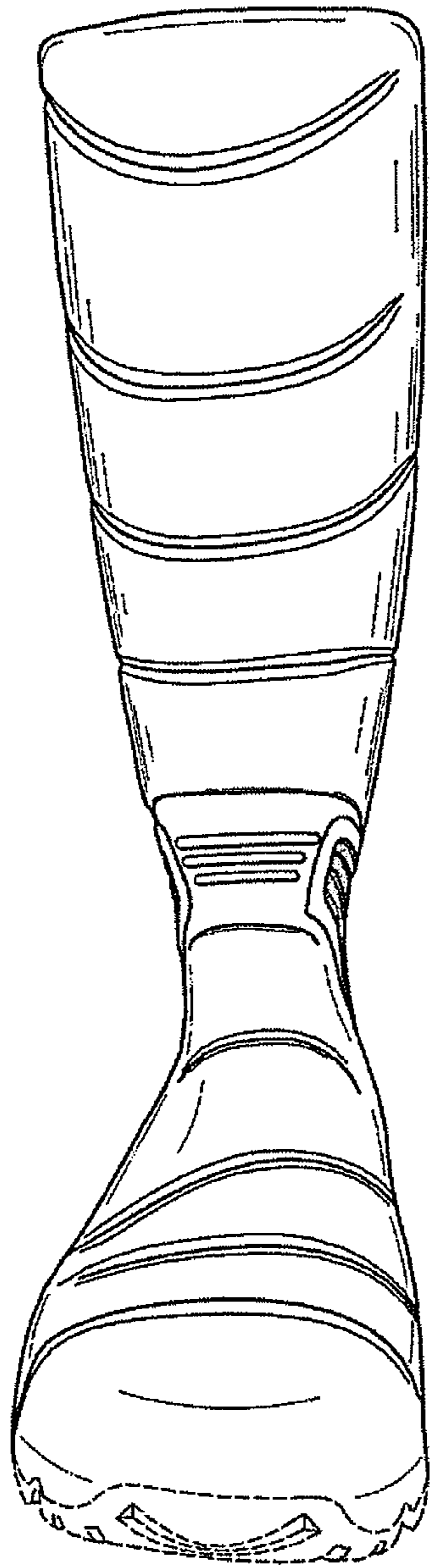

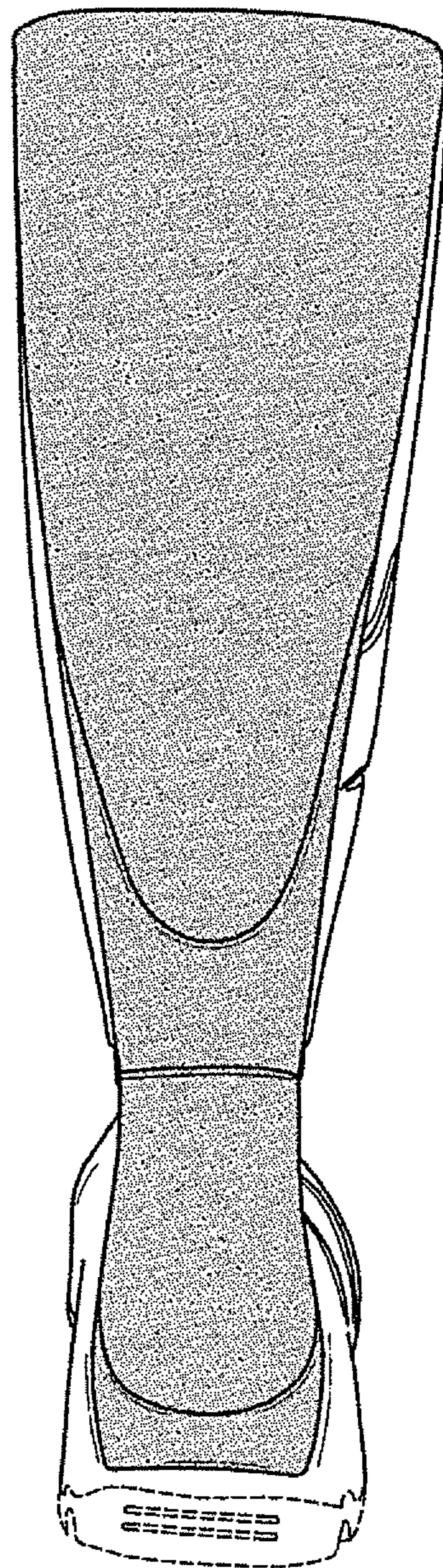

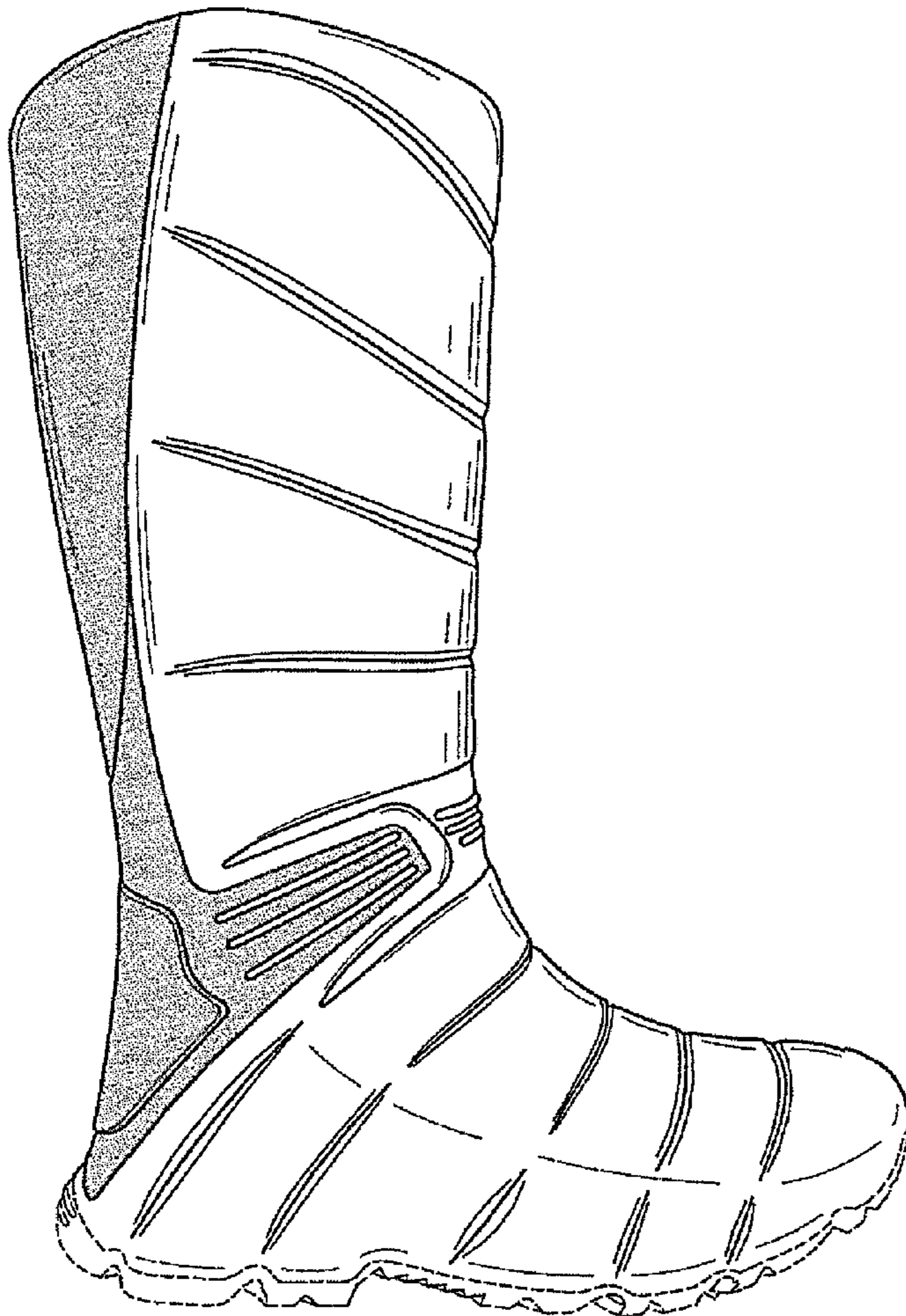

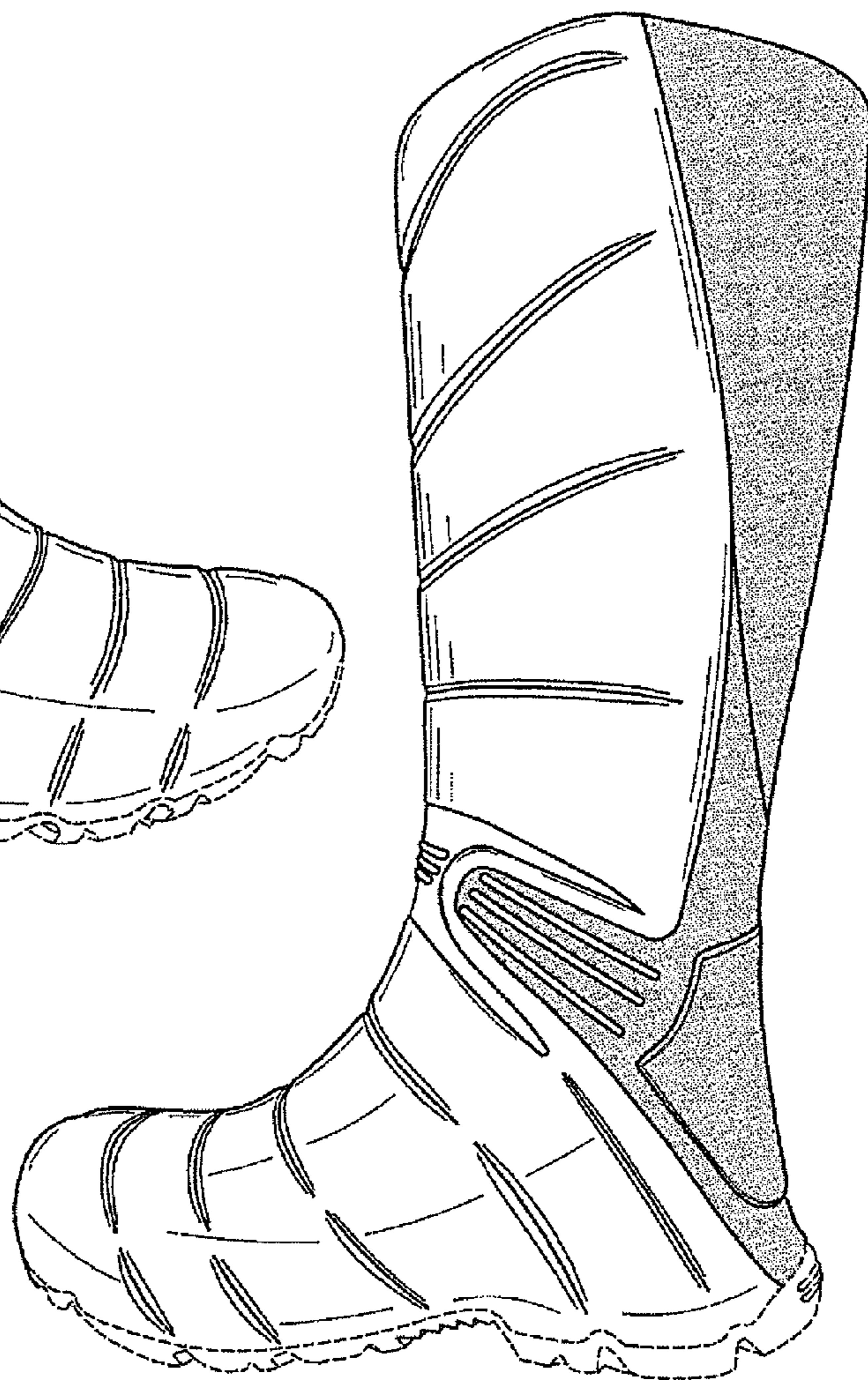

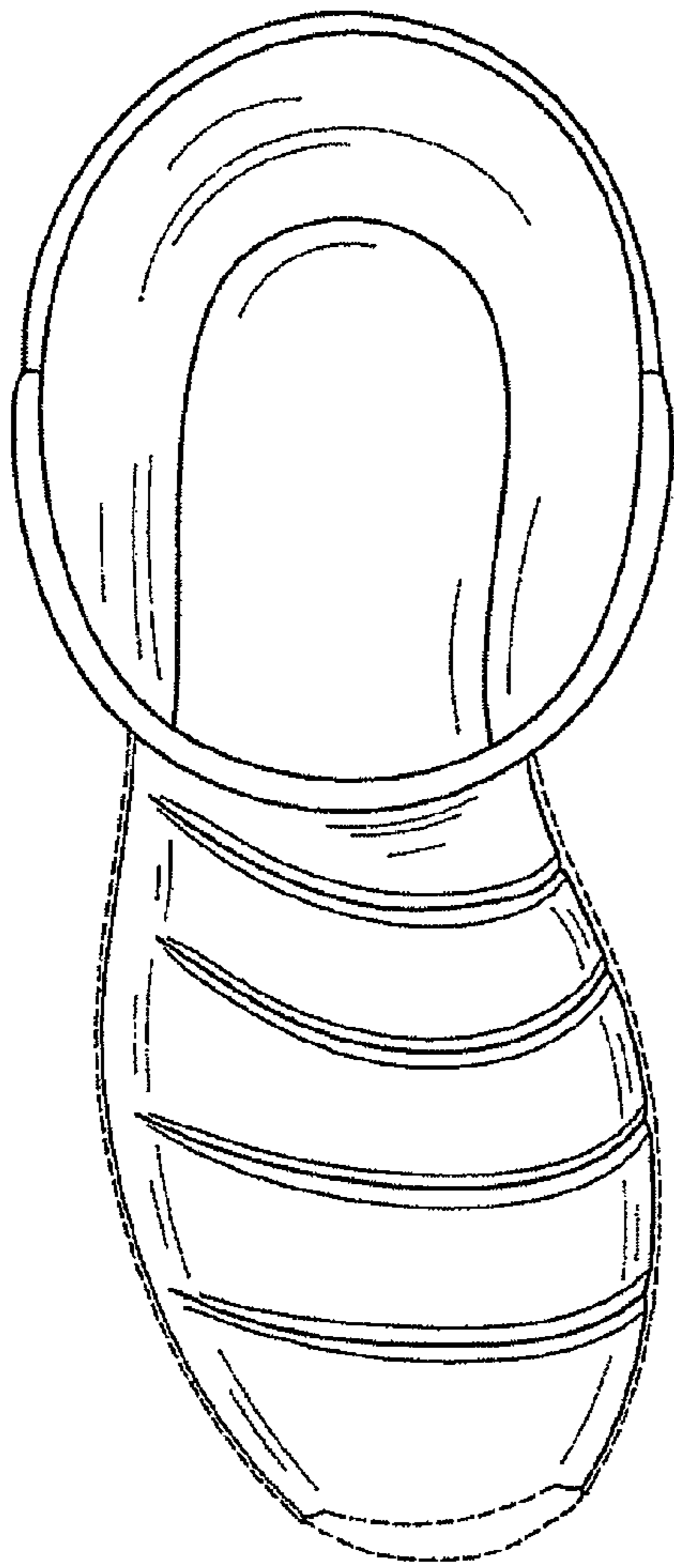

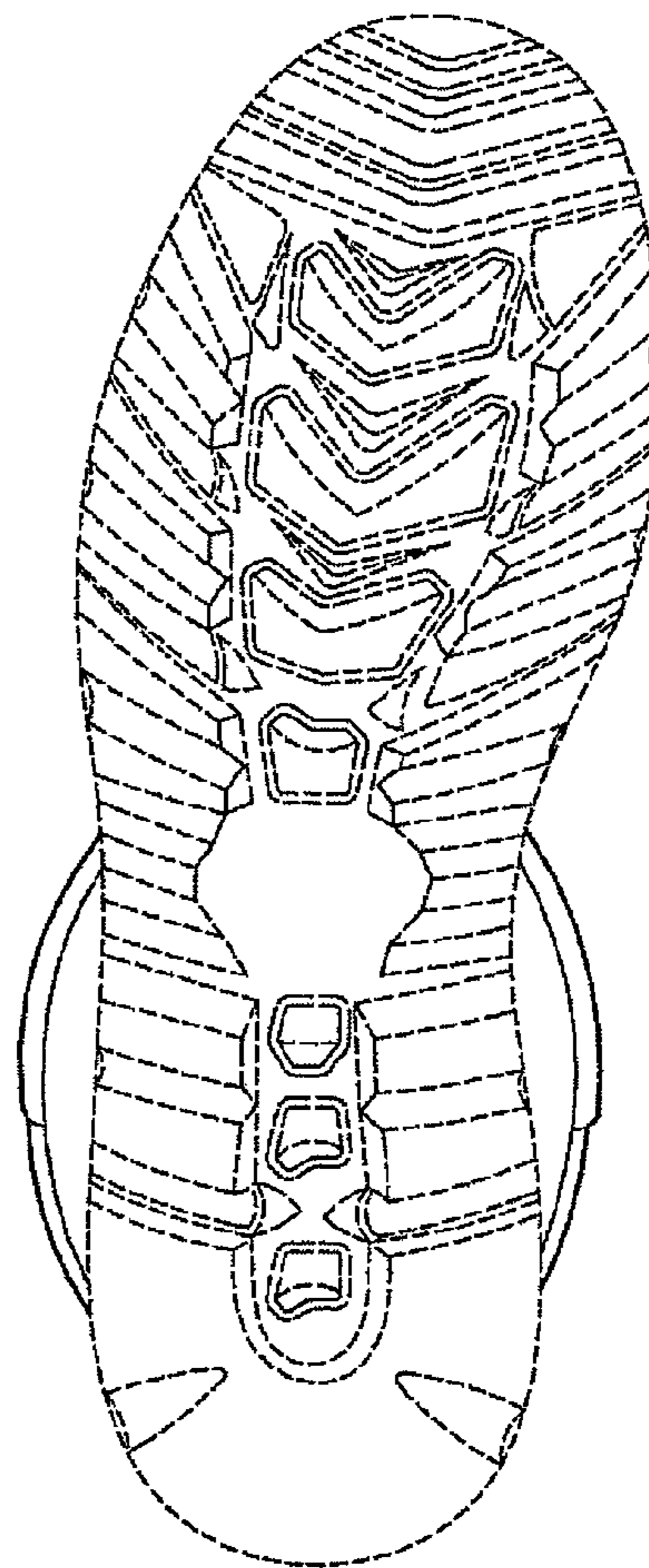

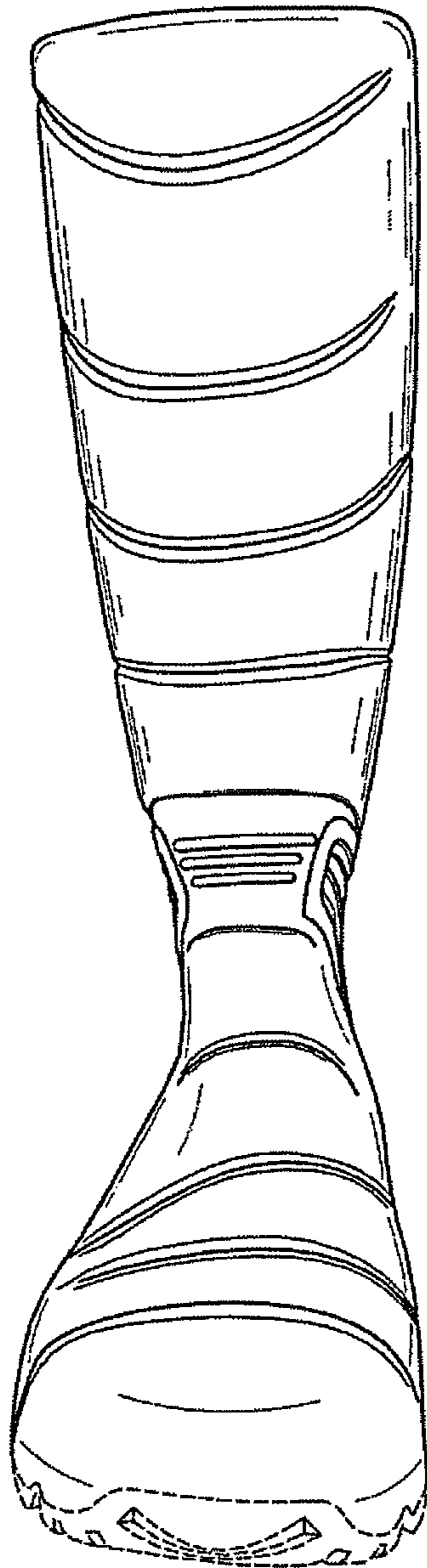

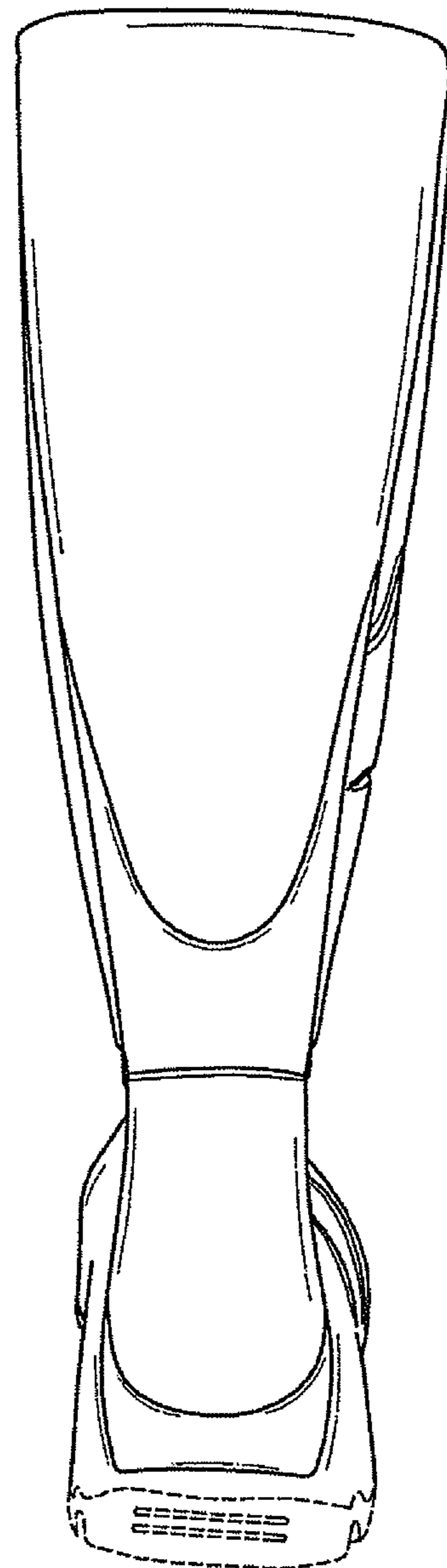

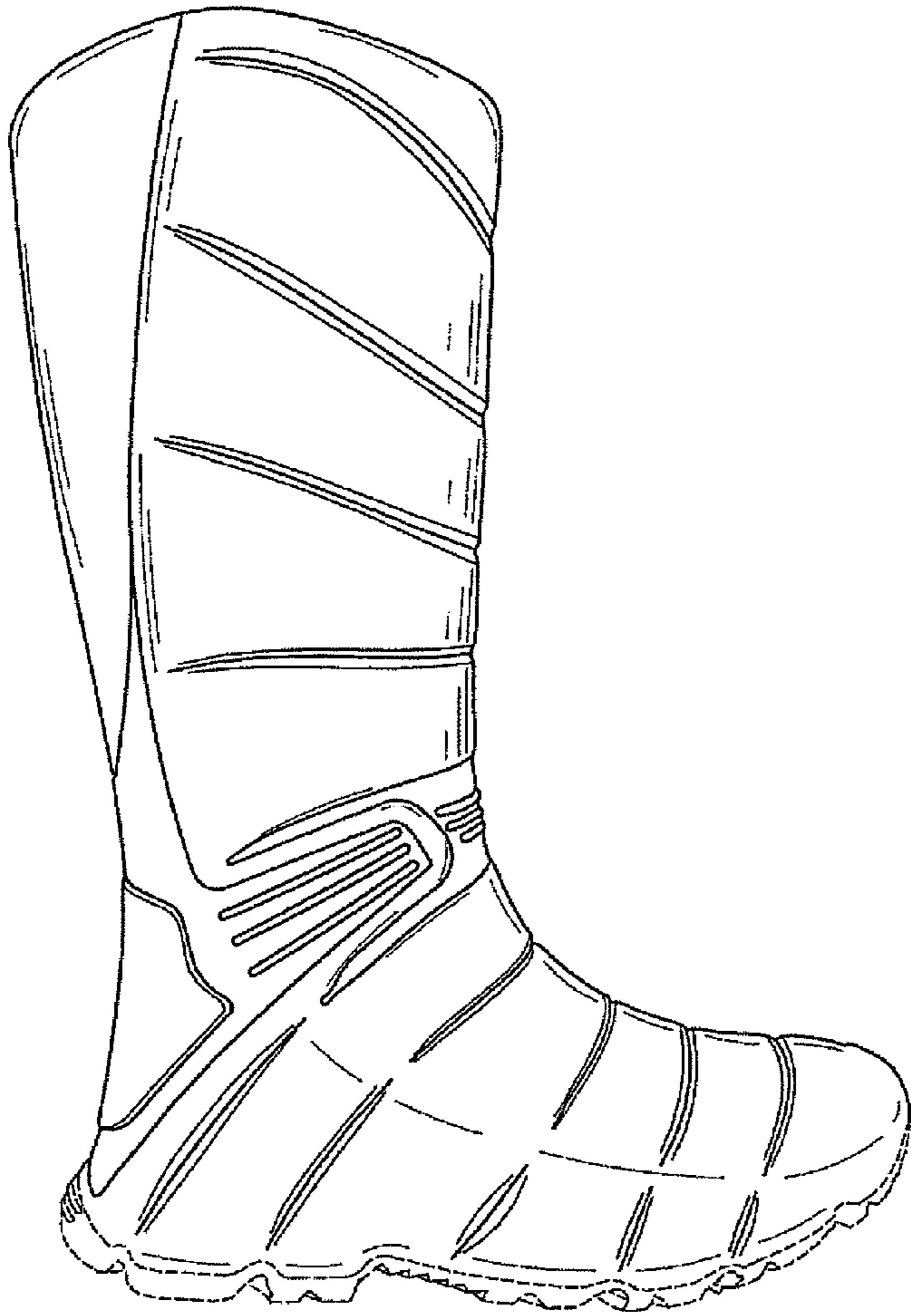

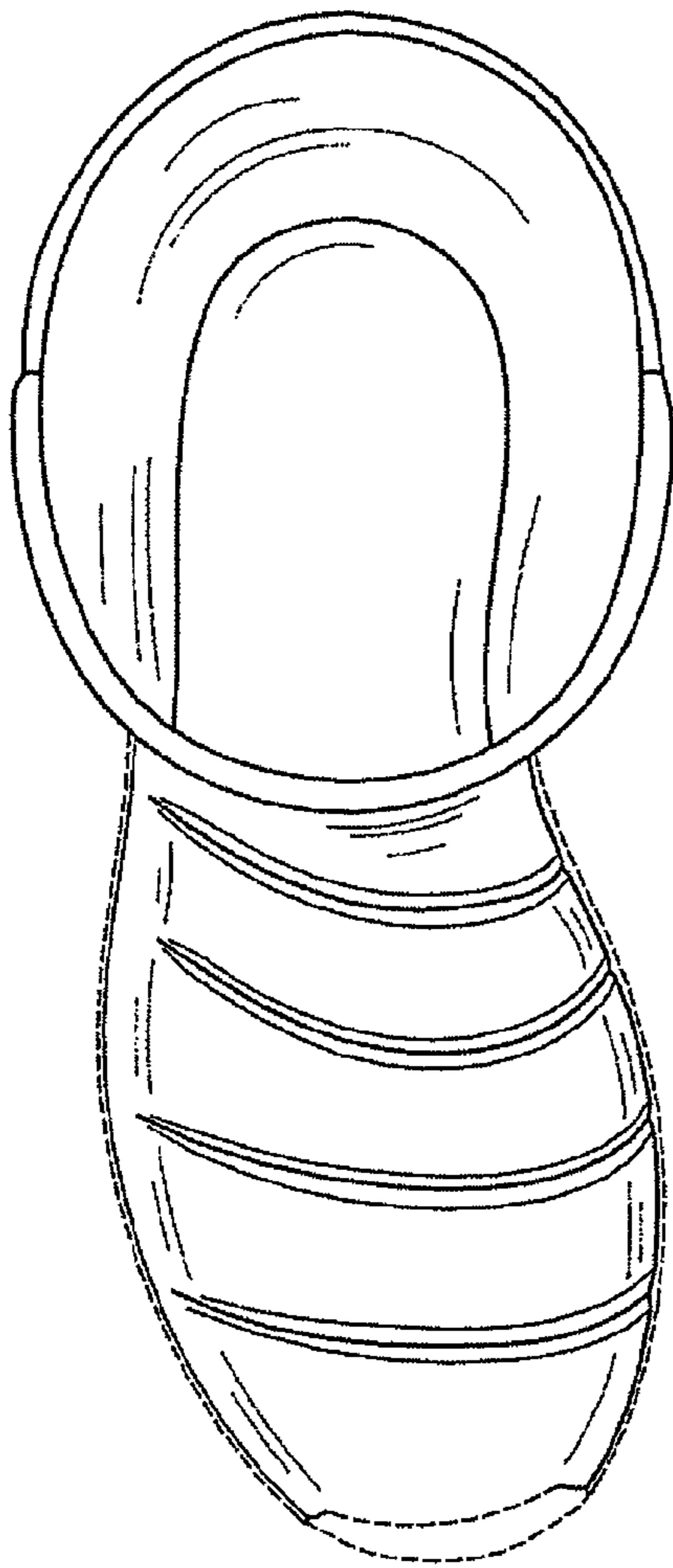

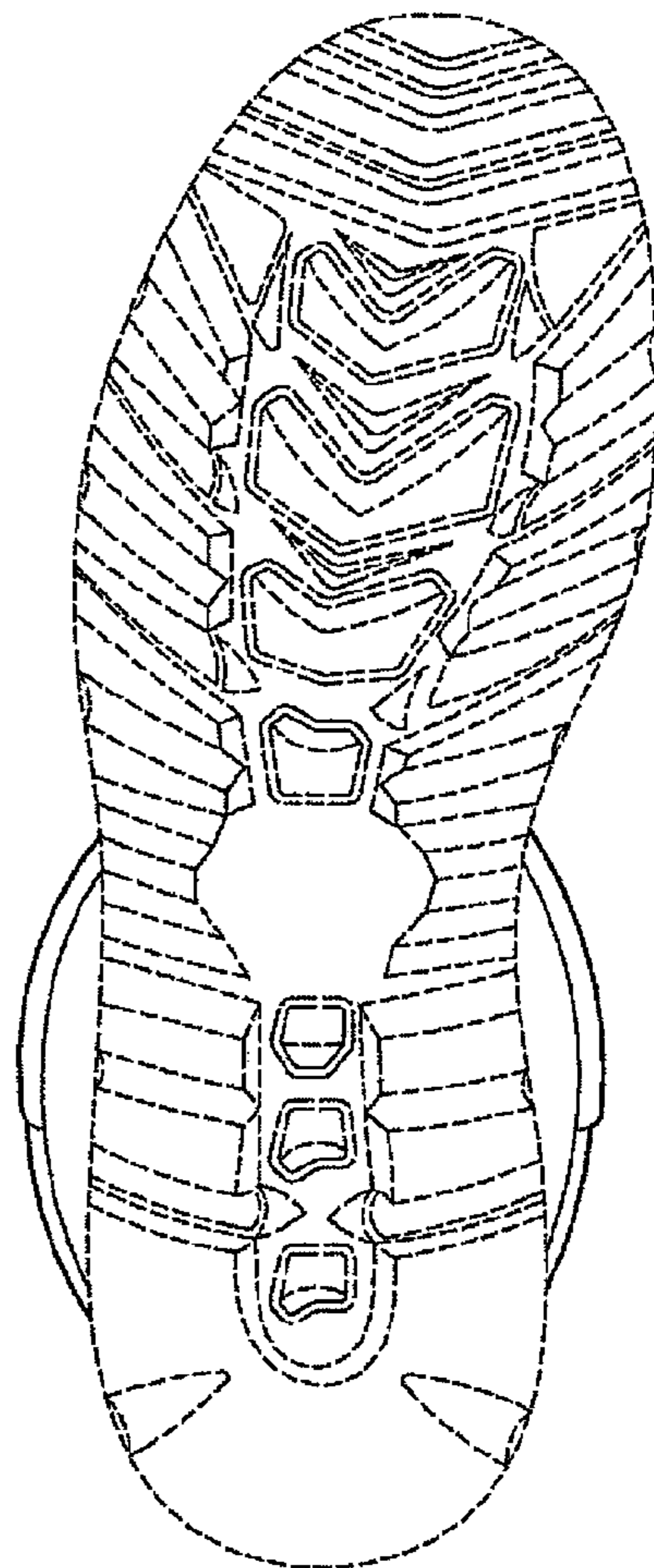
