**DESCRIPTION**

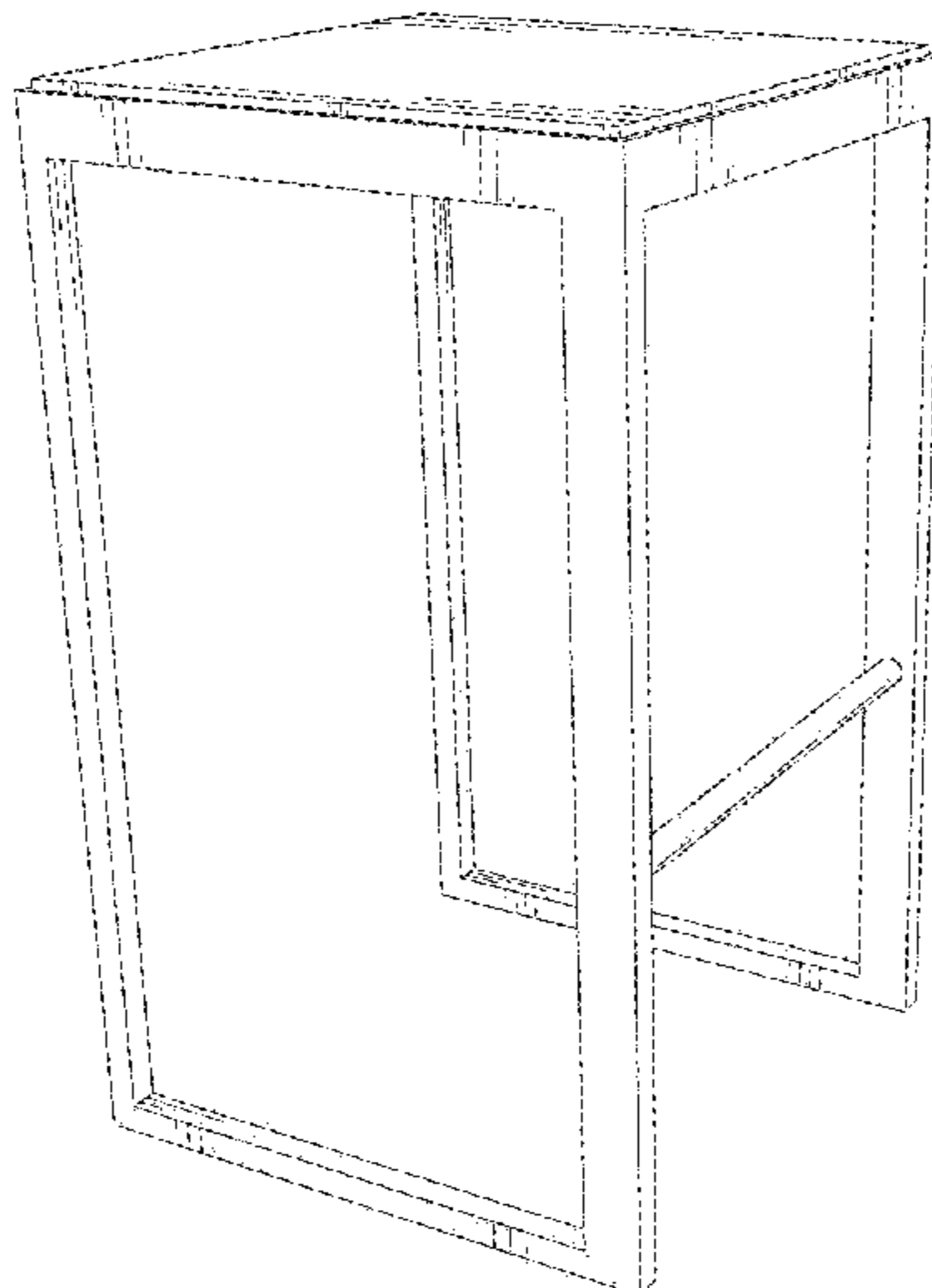
FIG. 1 is a perspective view of the stool of the present invention;

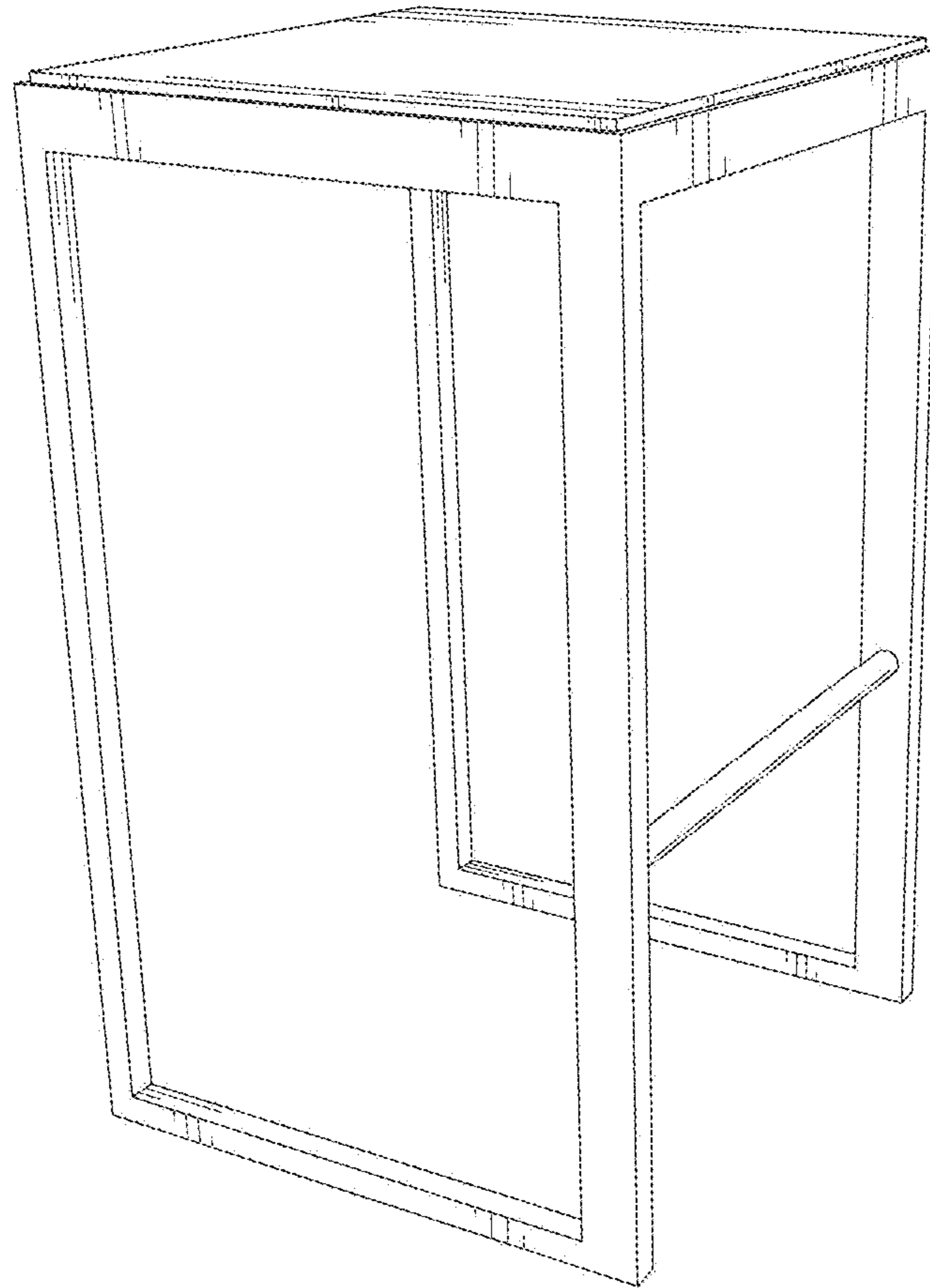

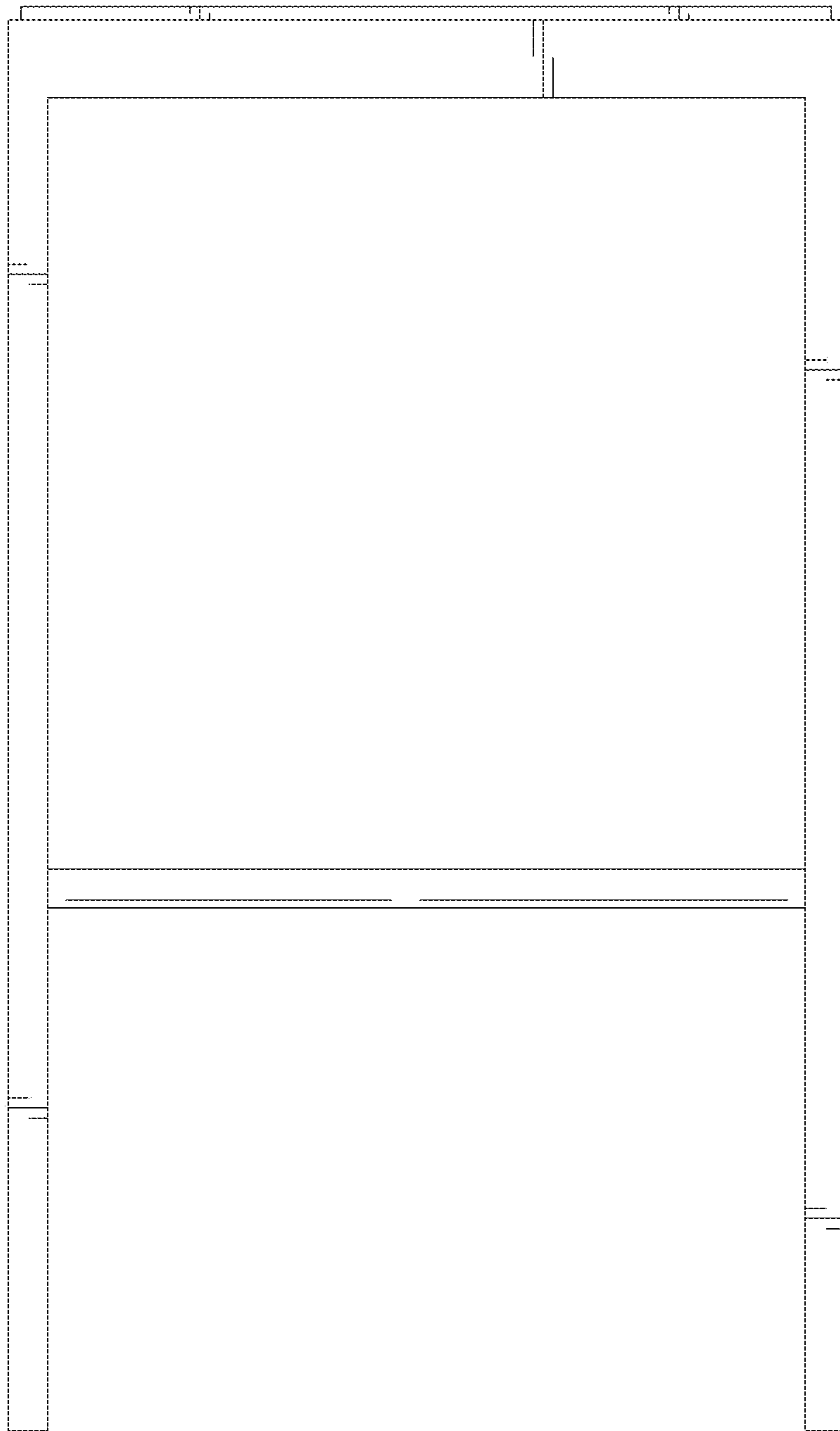

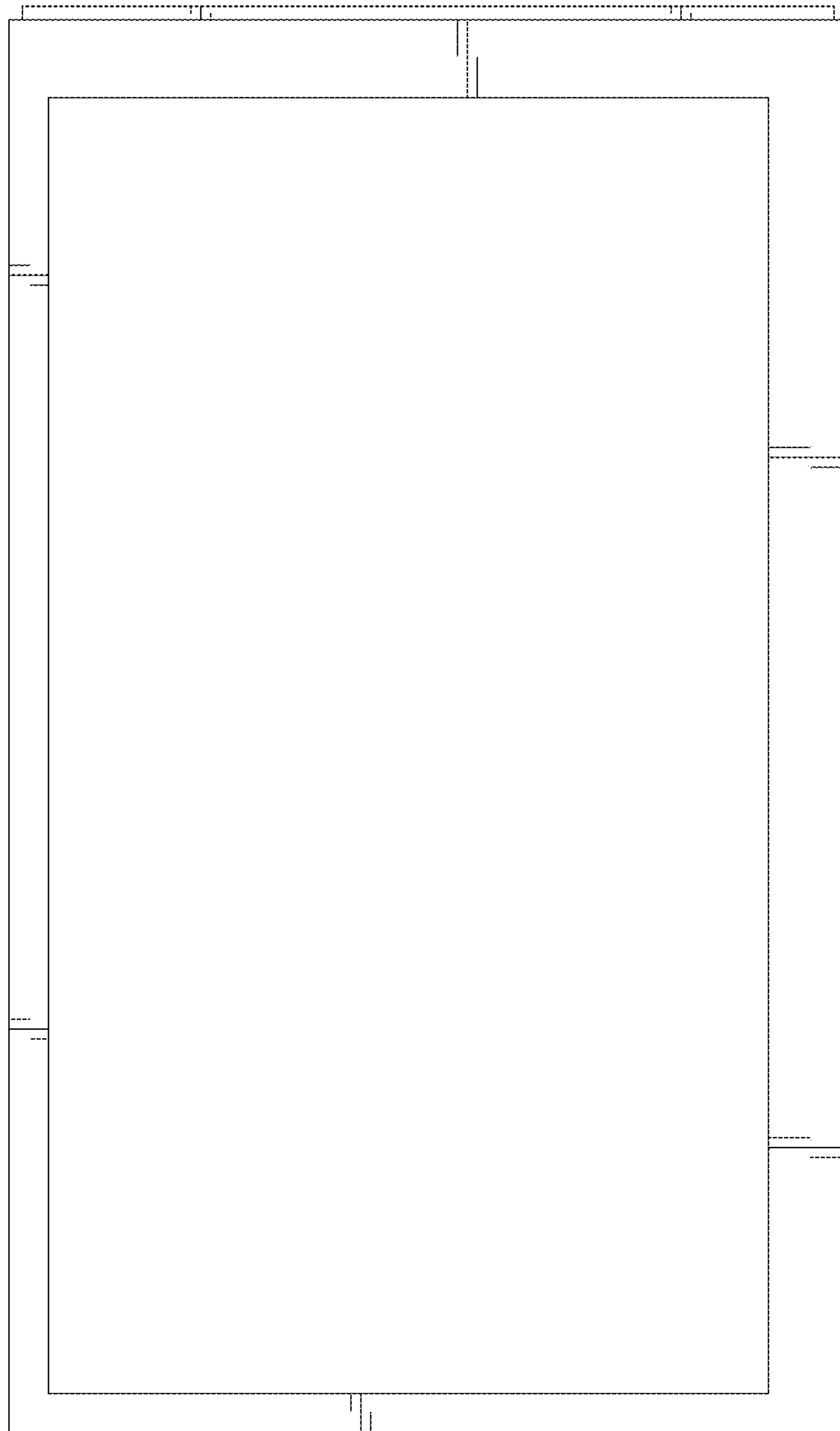

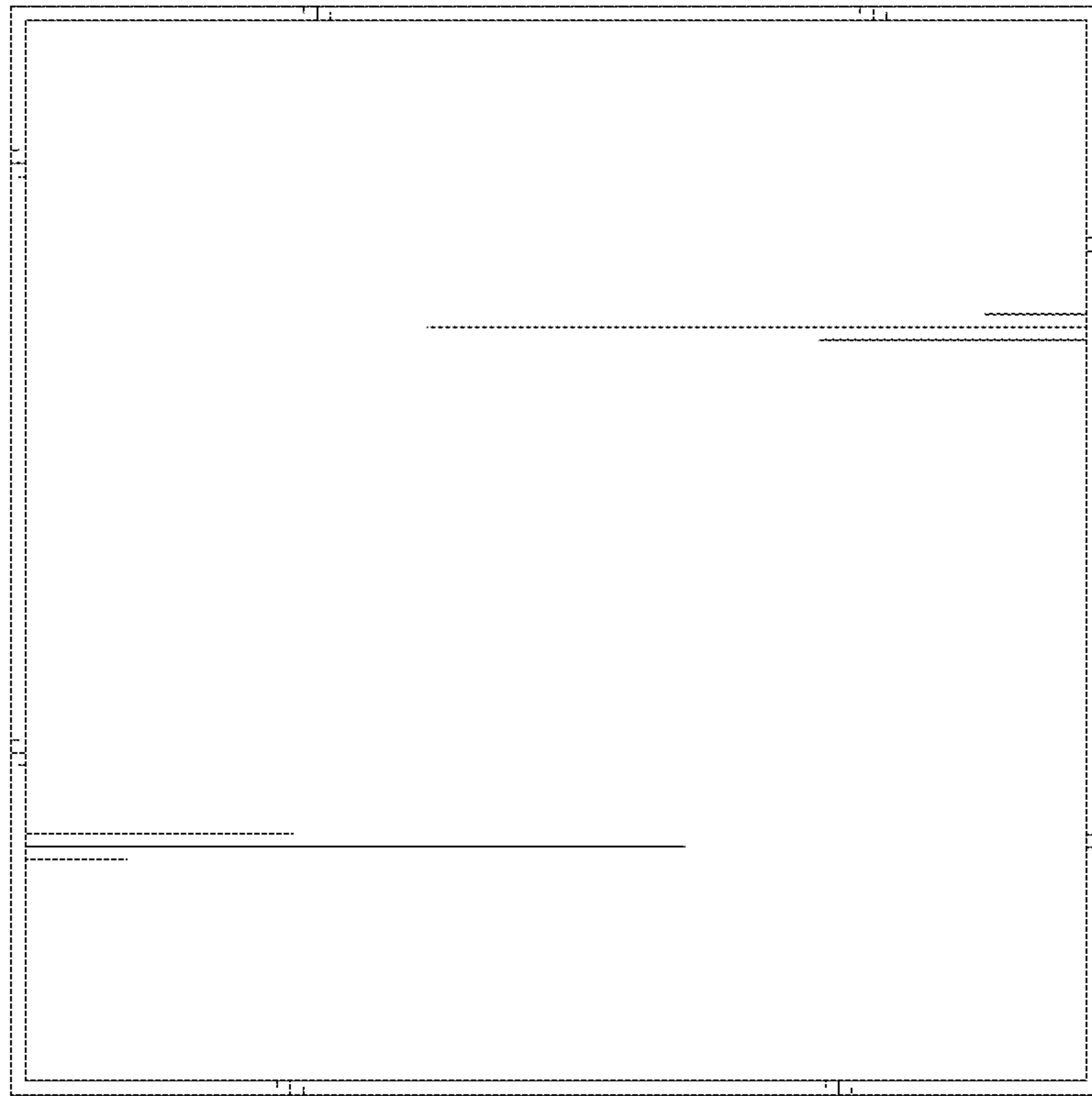
