FIG. 6 is a right side view of FIG. 3.

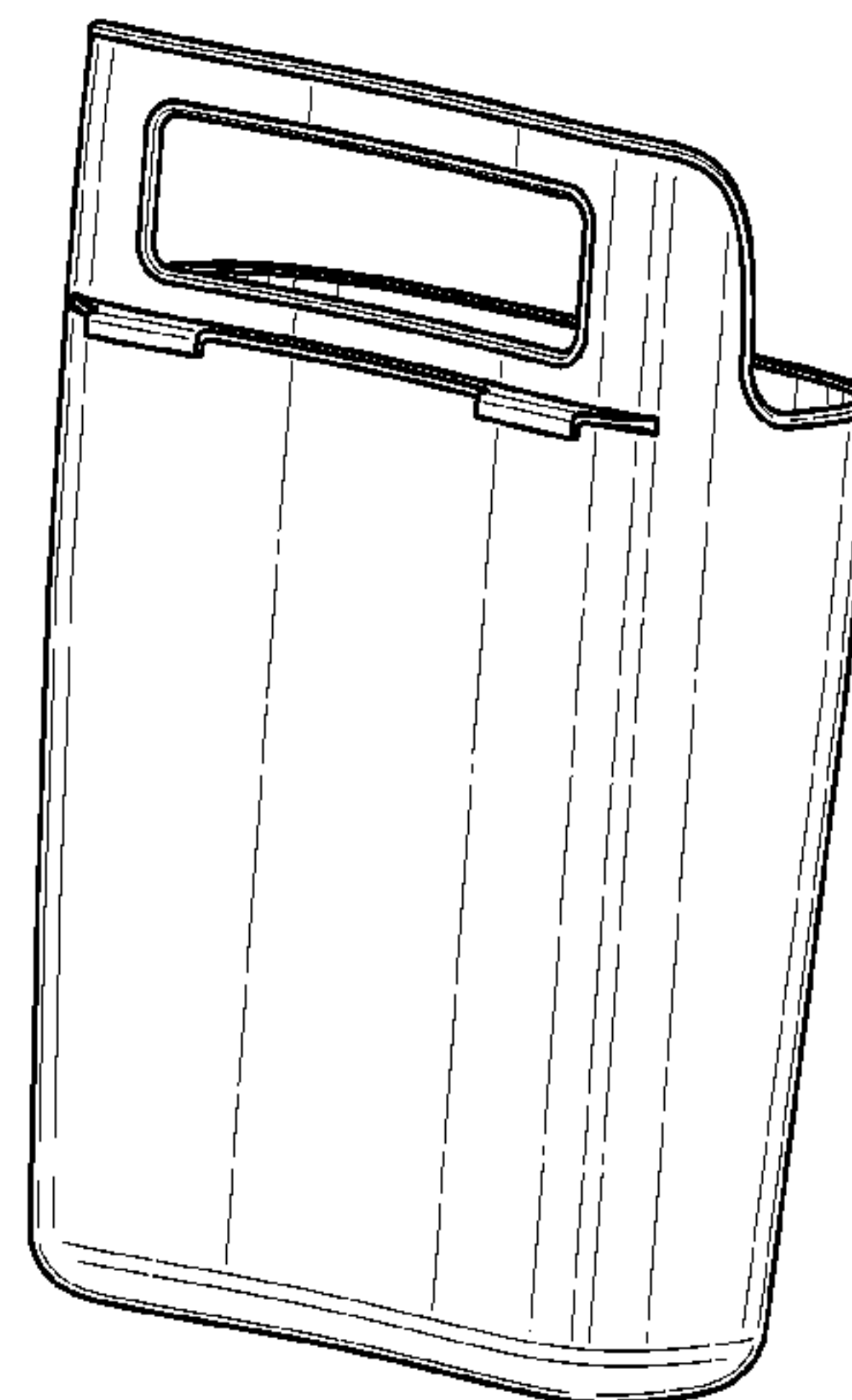
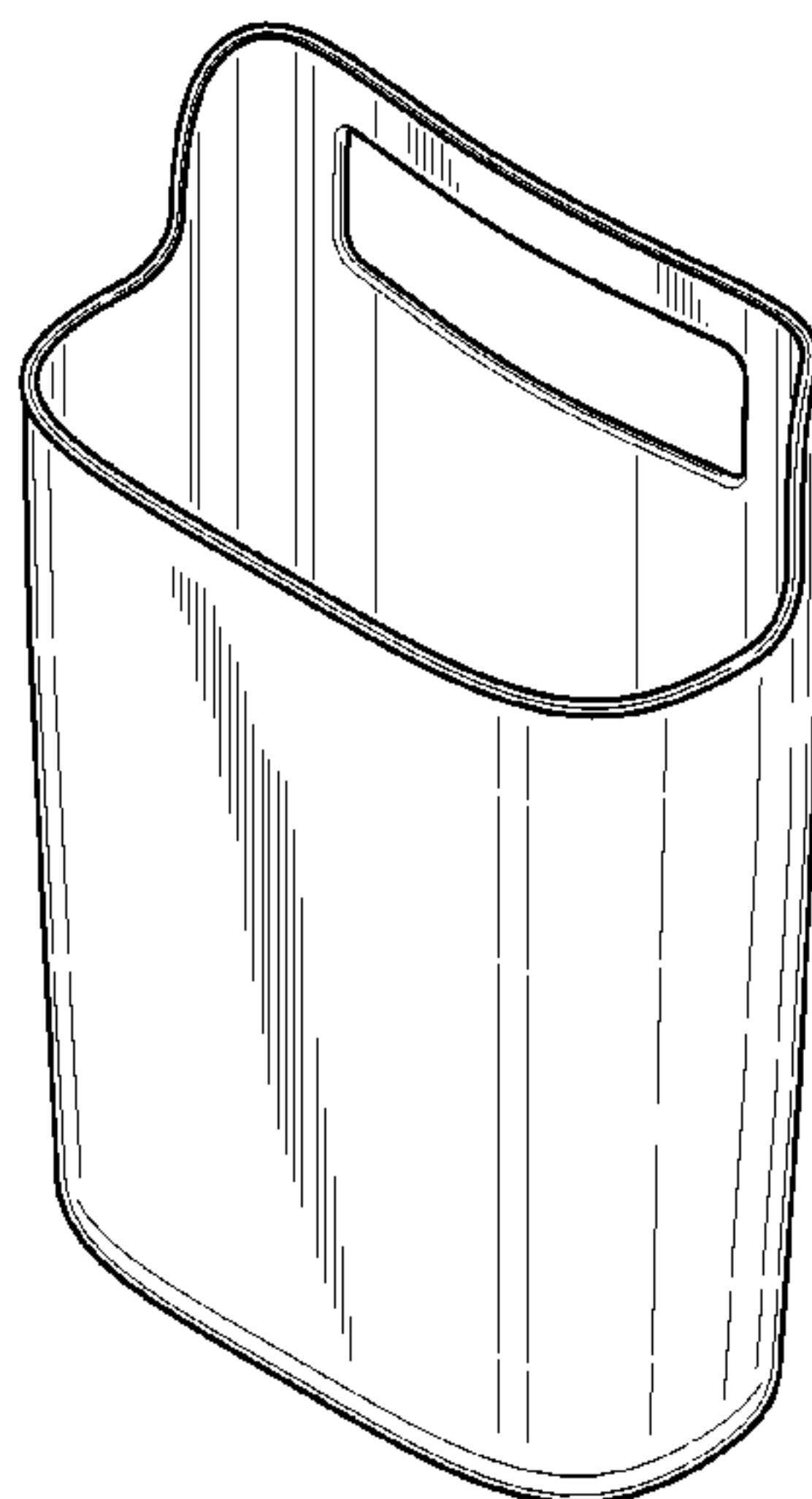
FIG. 7 is a left side view of FIG. 3.

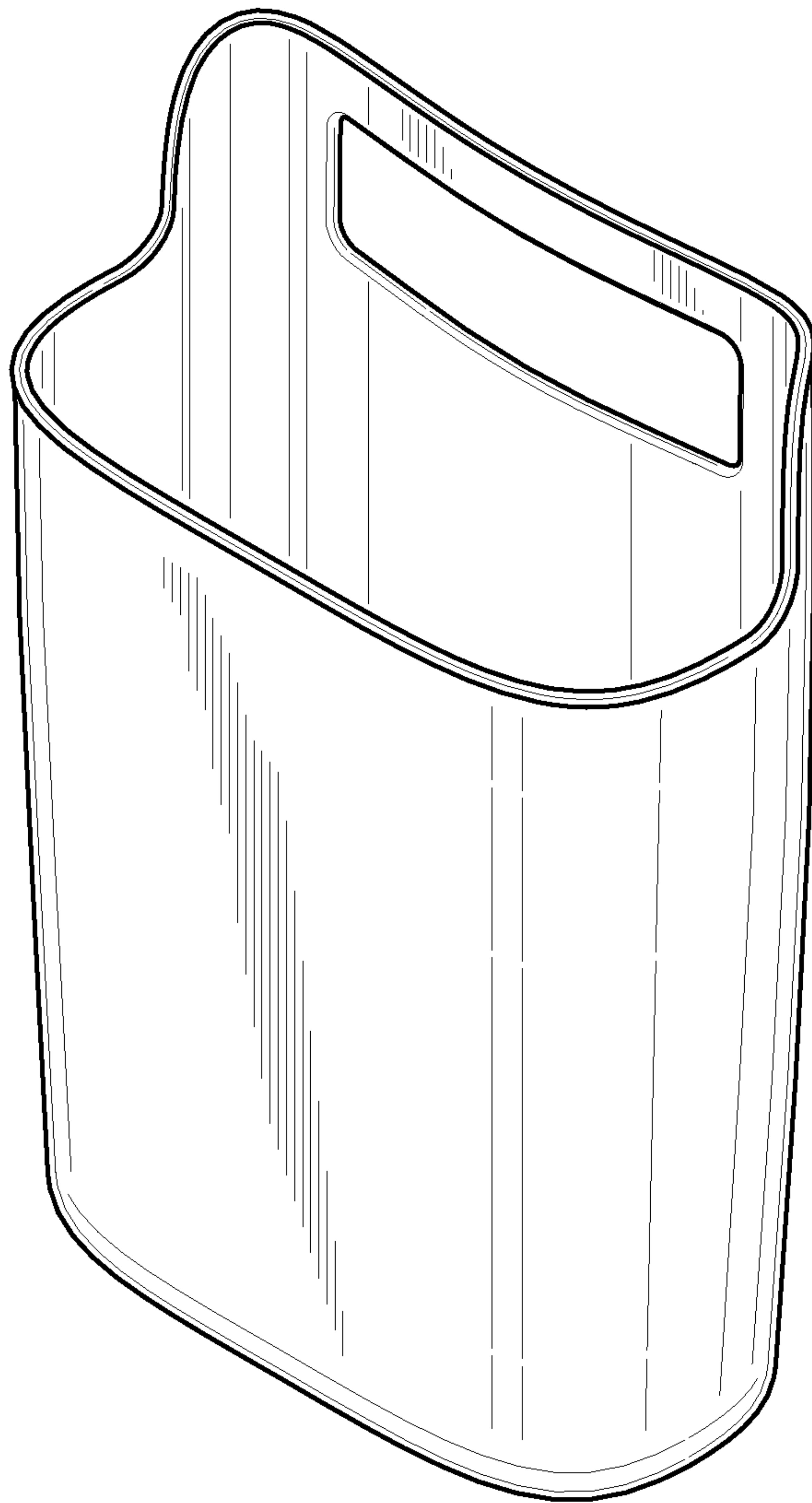

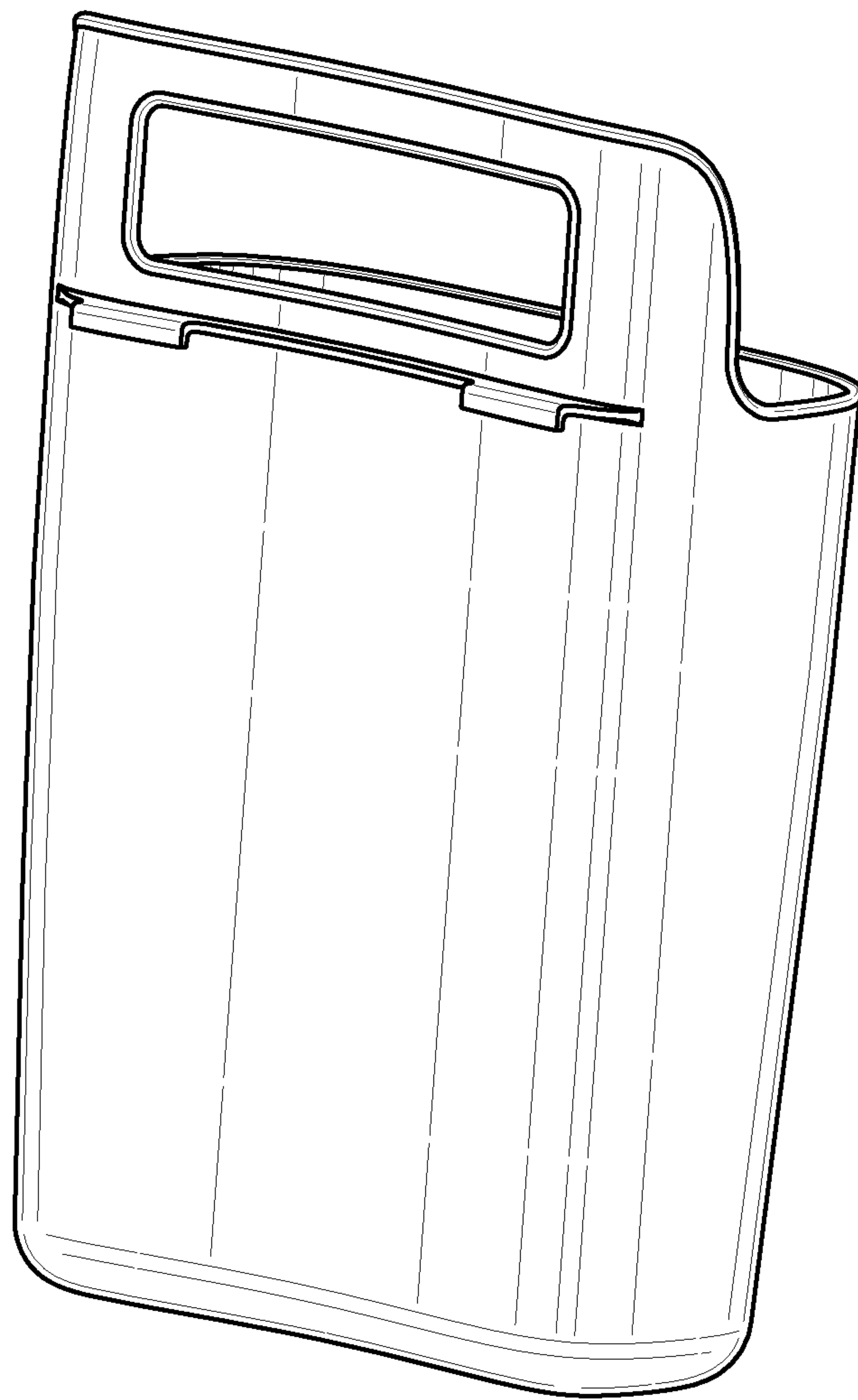

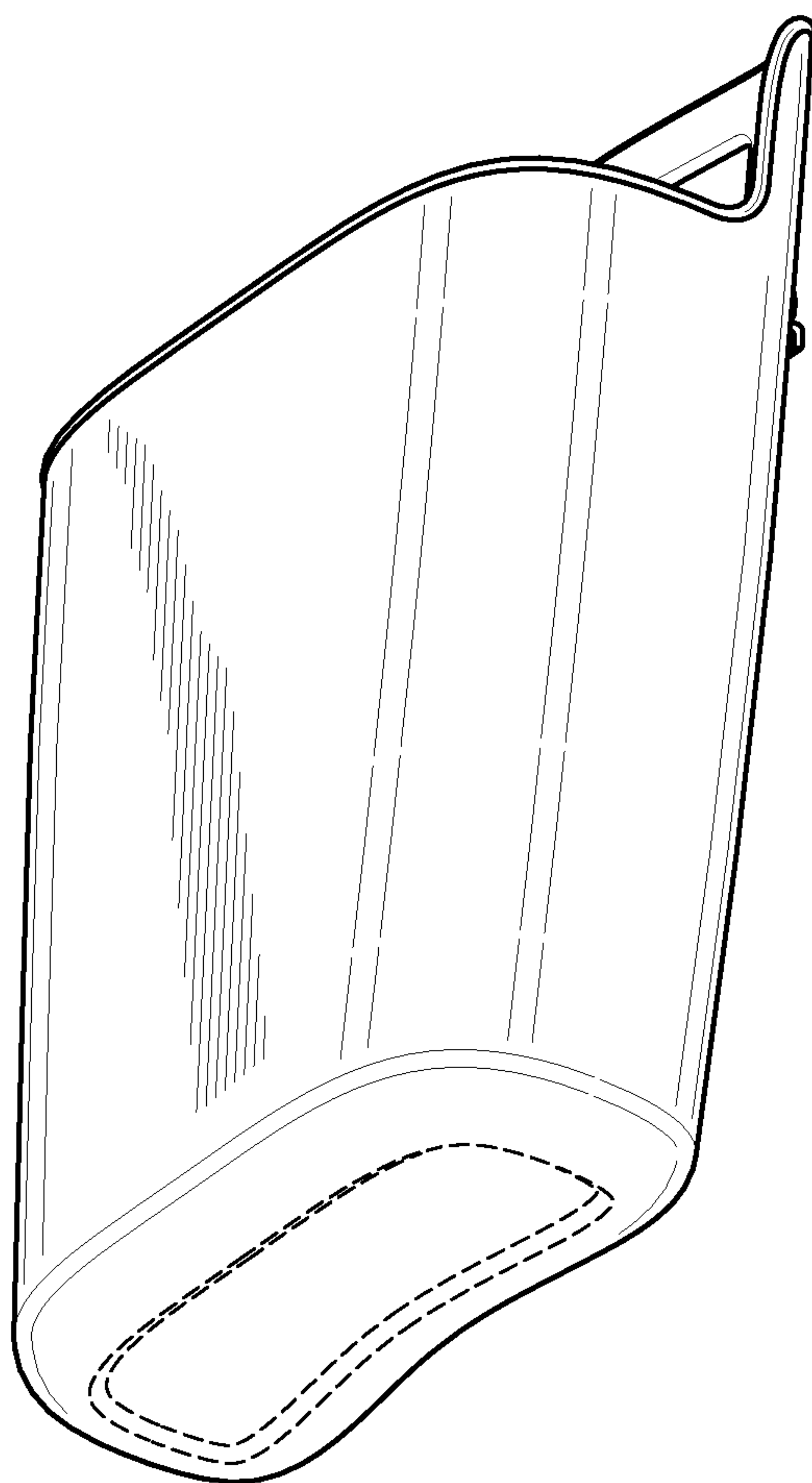

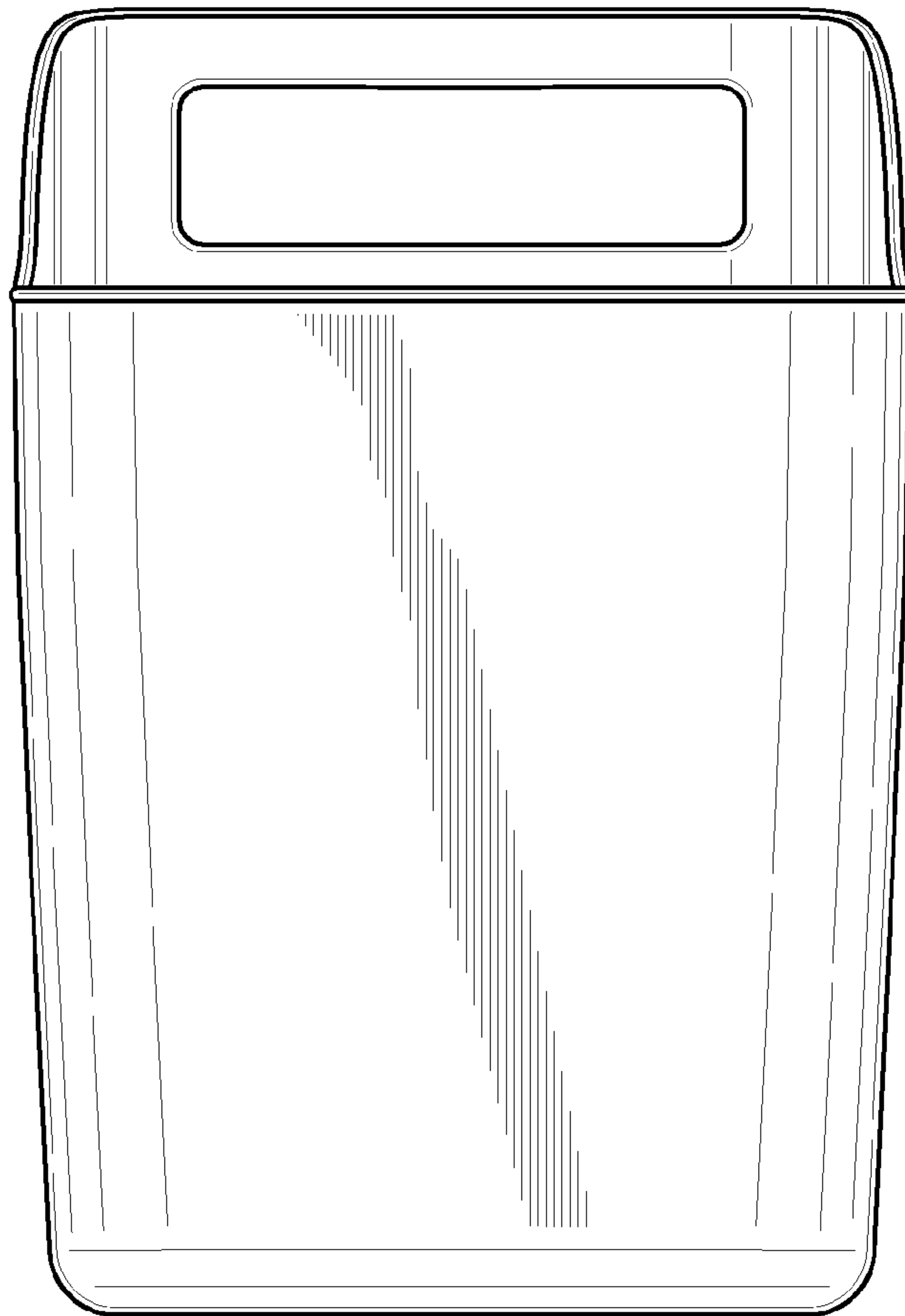

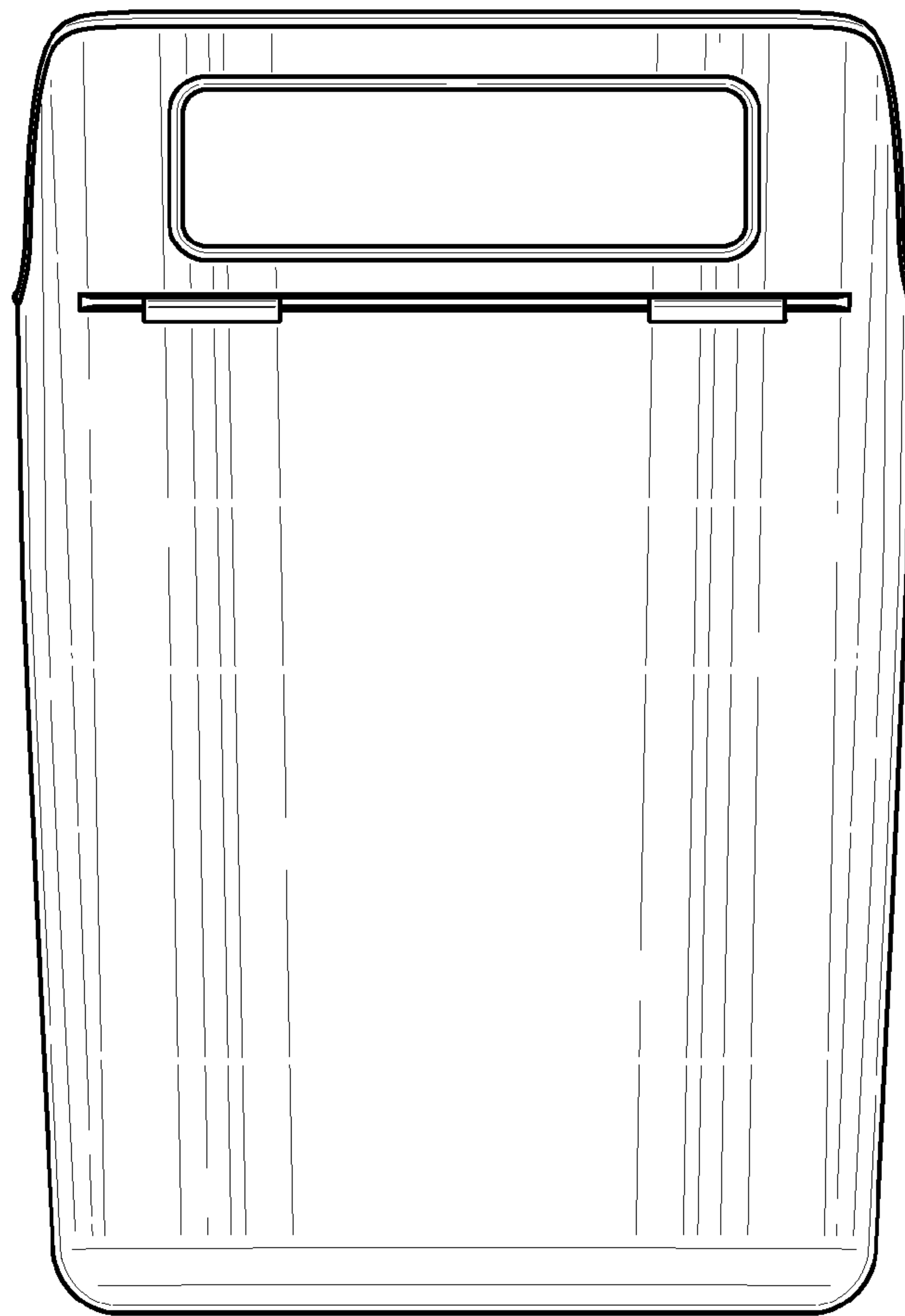

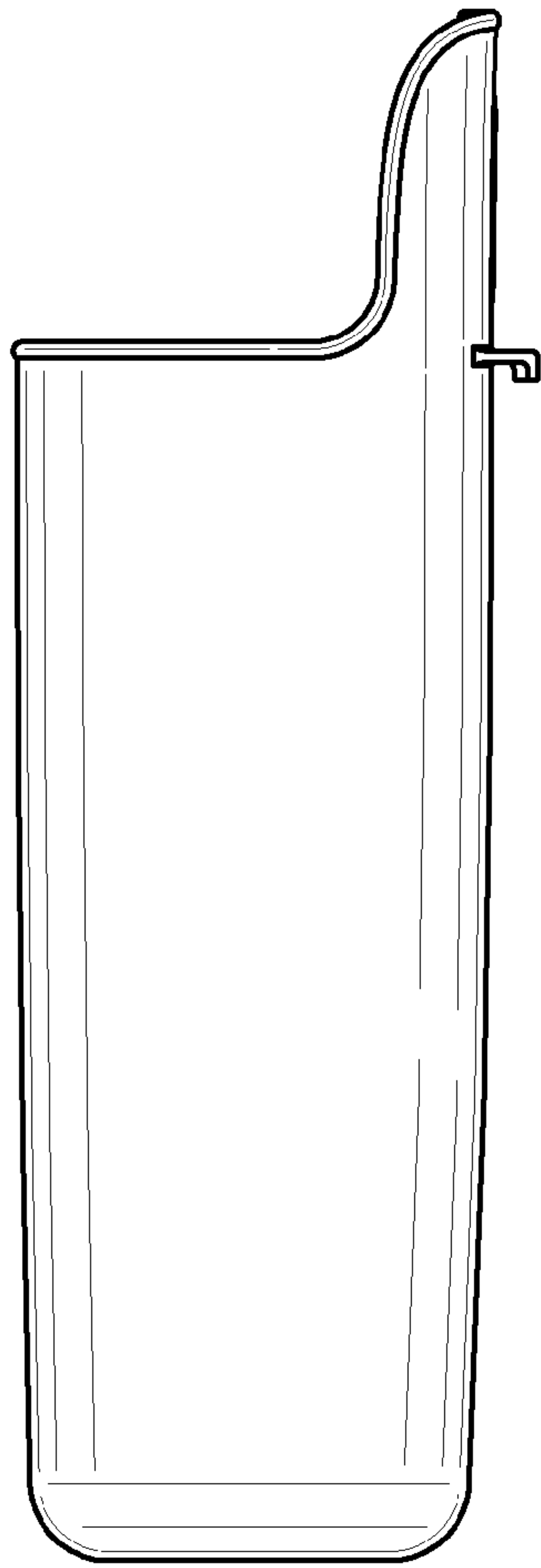

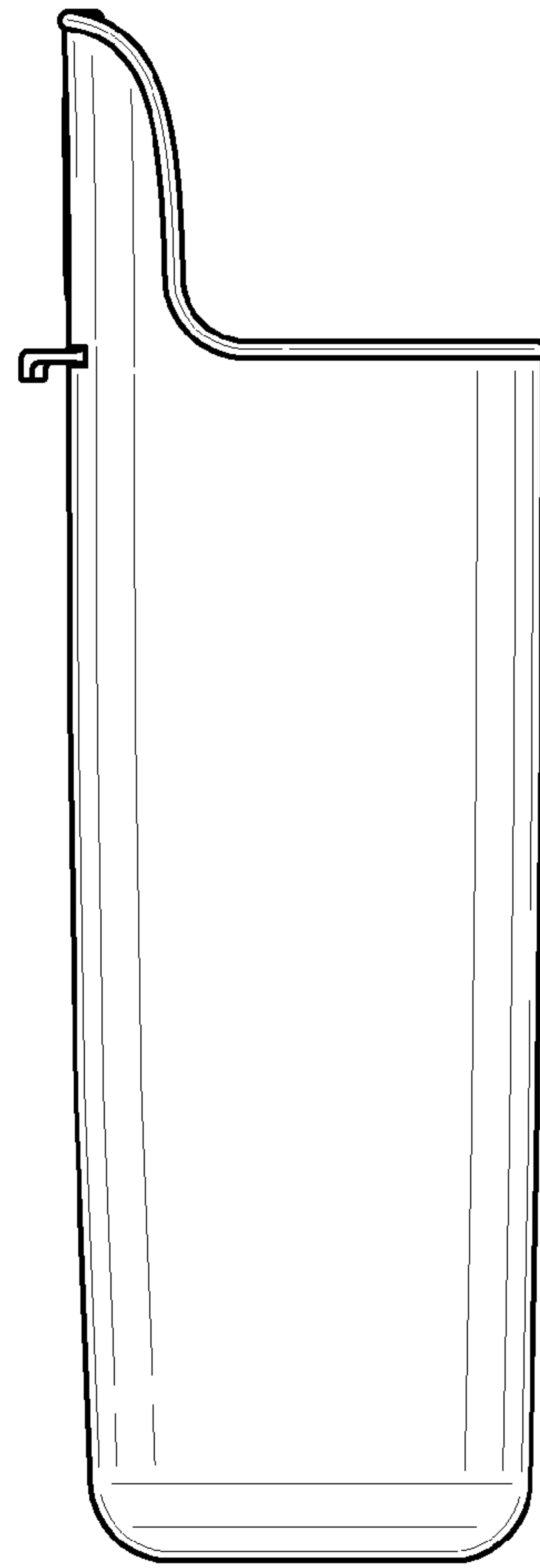

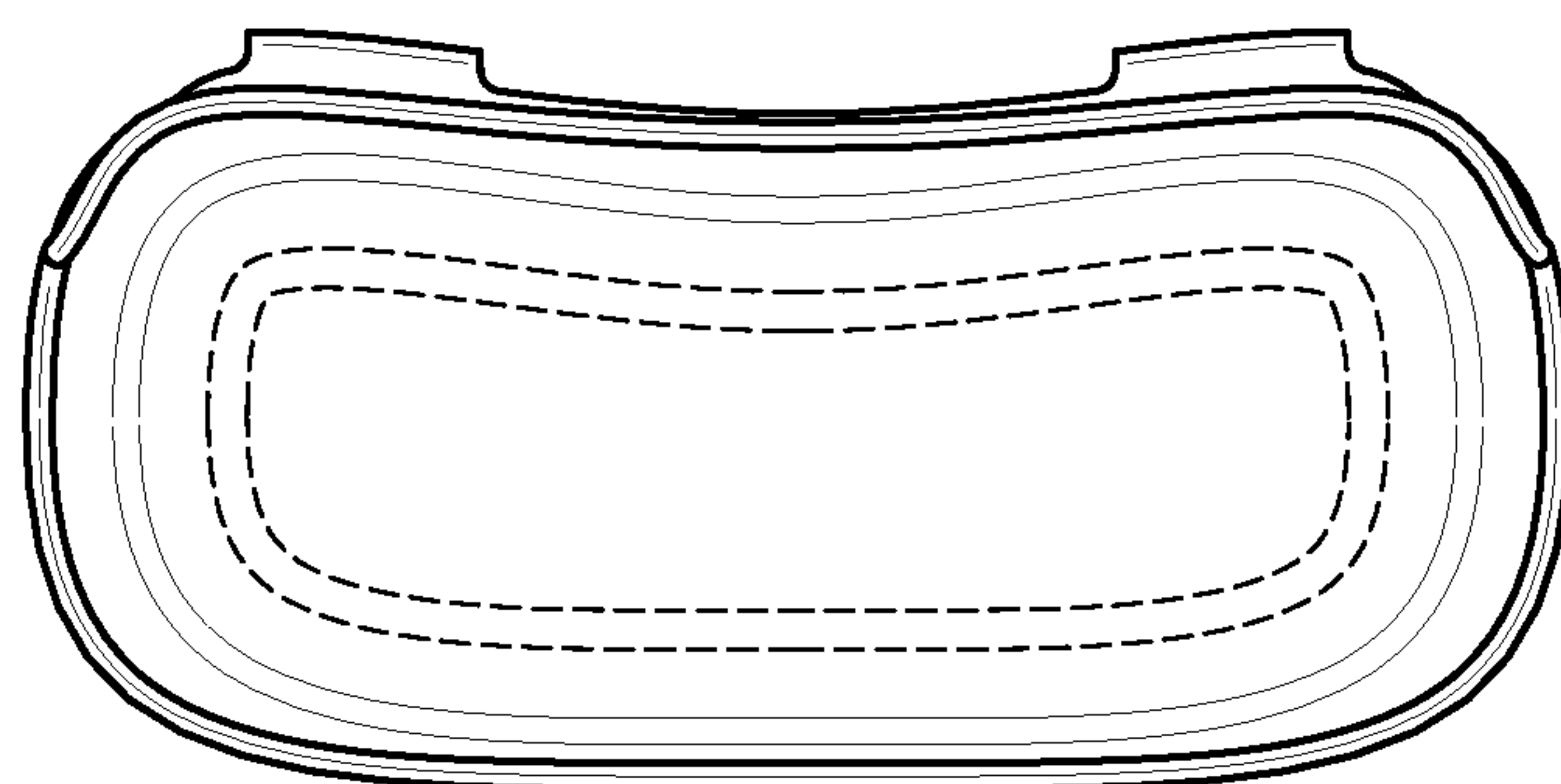

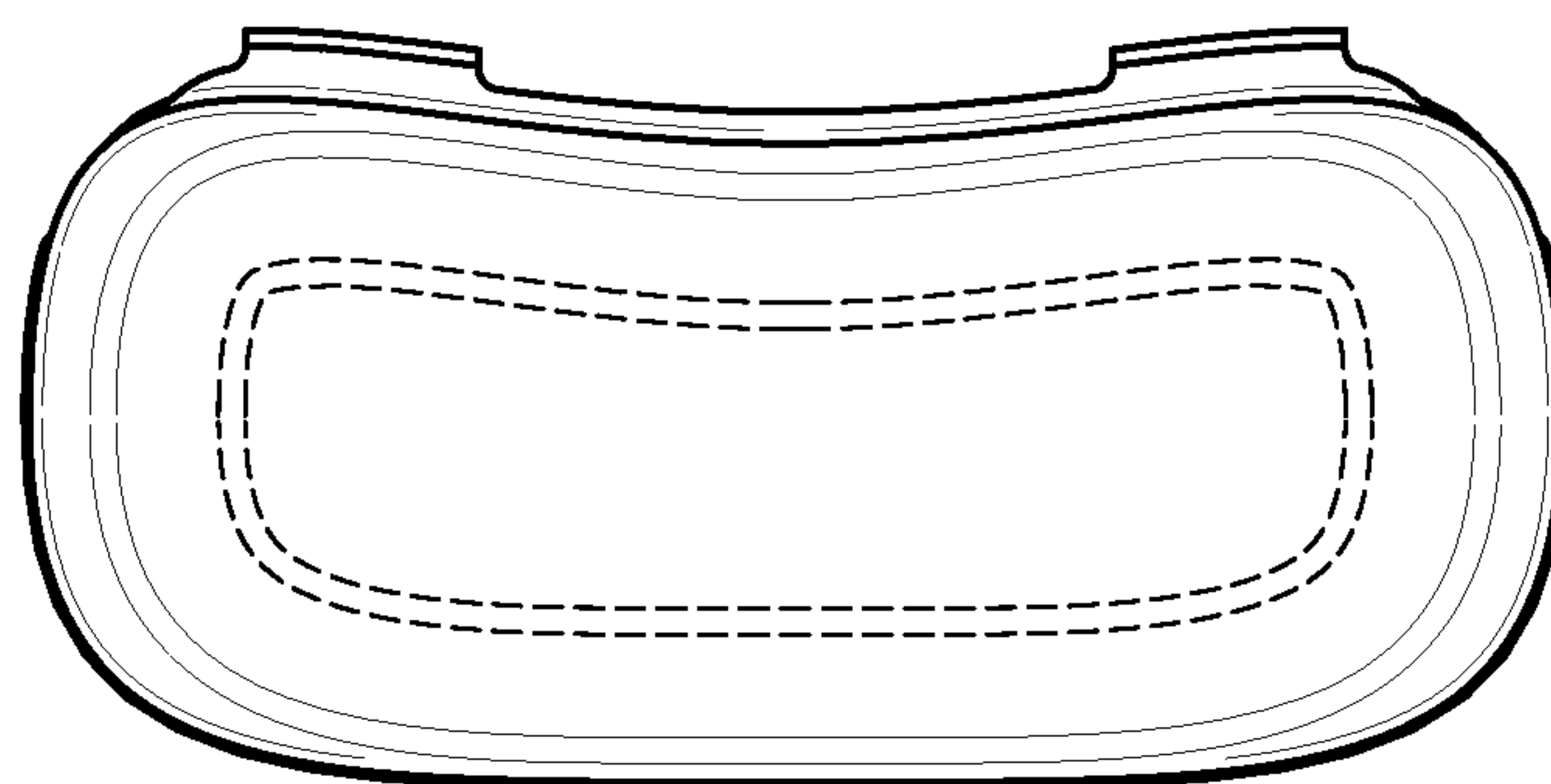
