DESCRIPTION

FIG. 1 is a top perspective view of a stair tread overlay of the present invention;

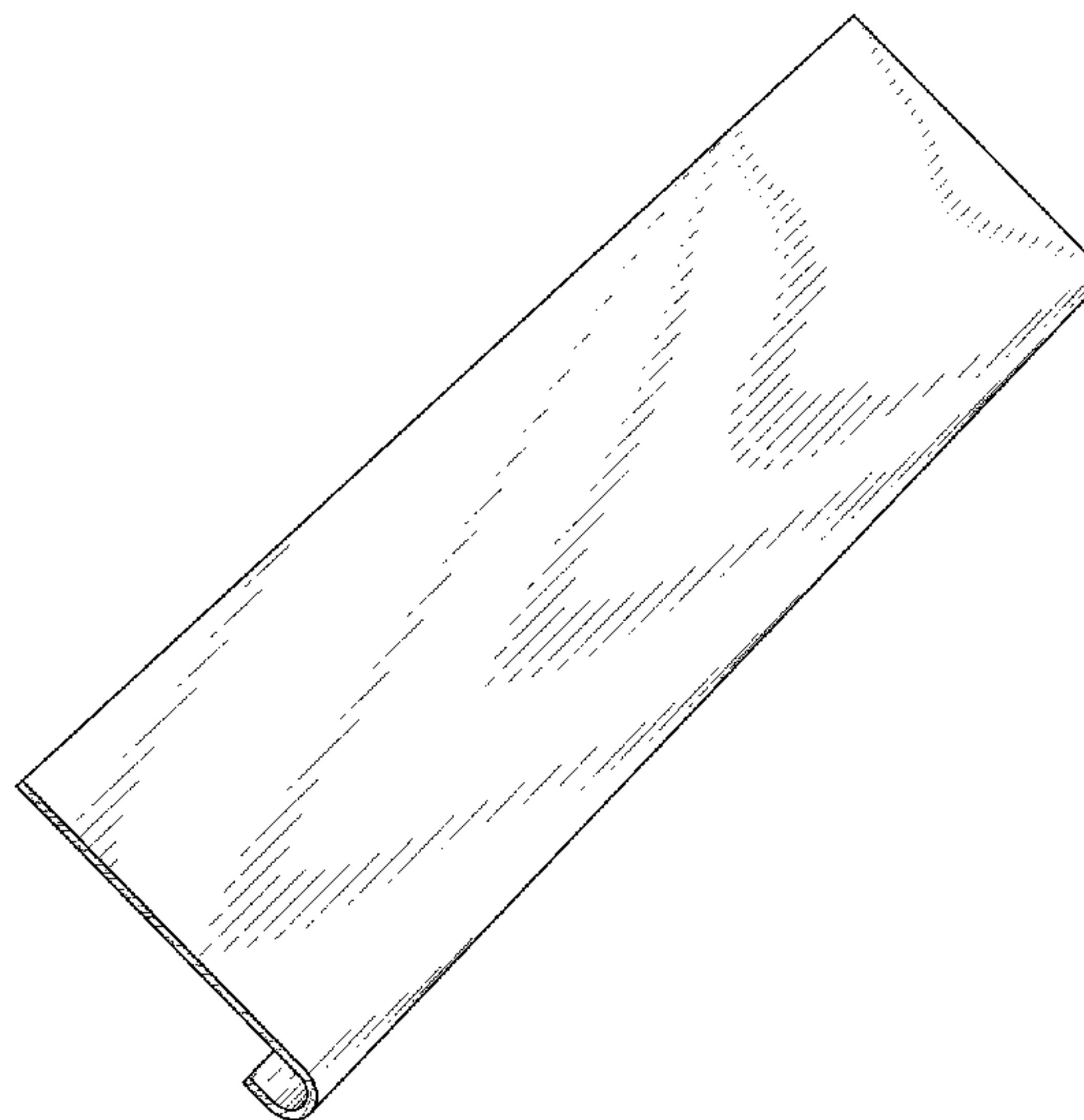

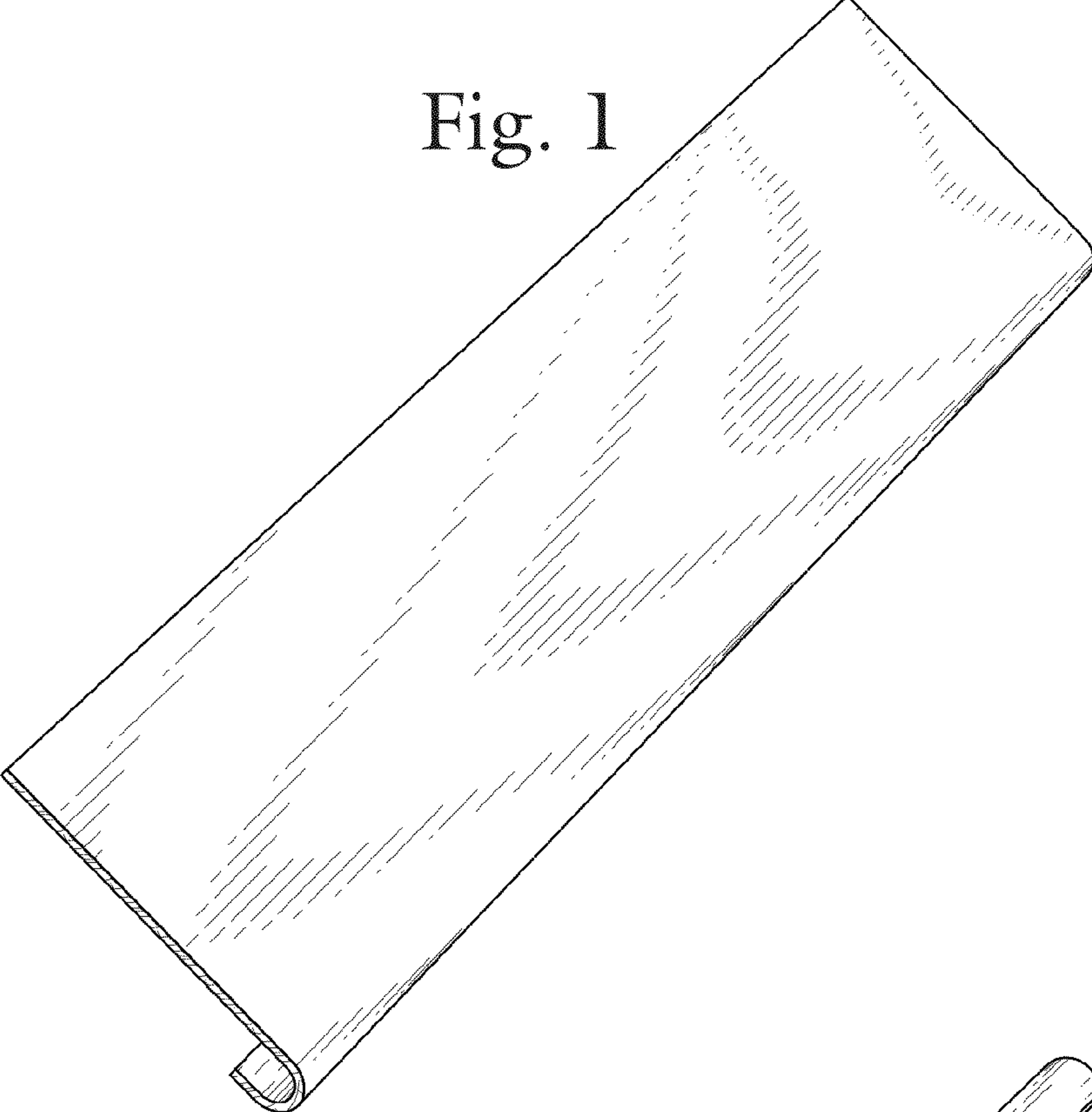
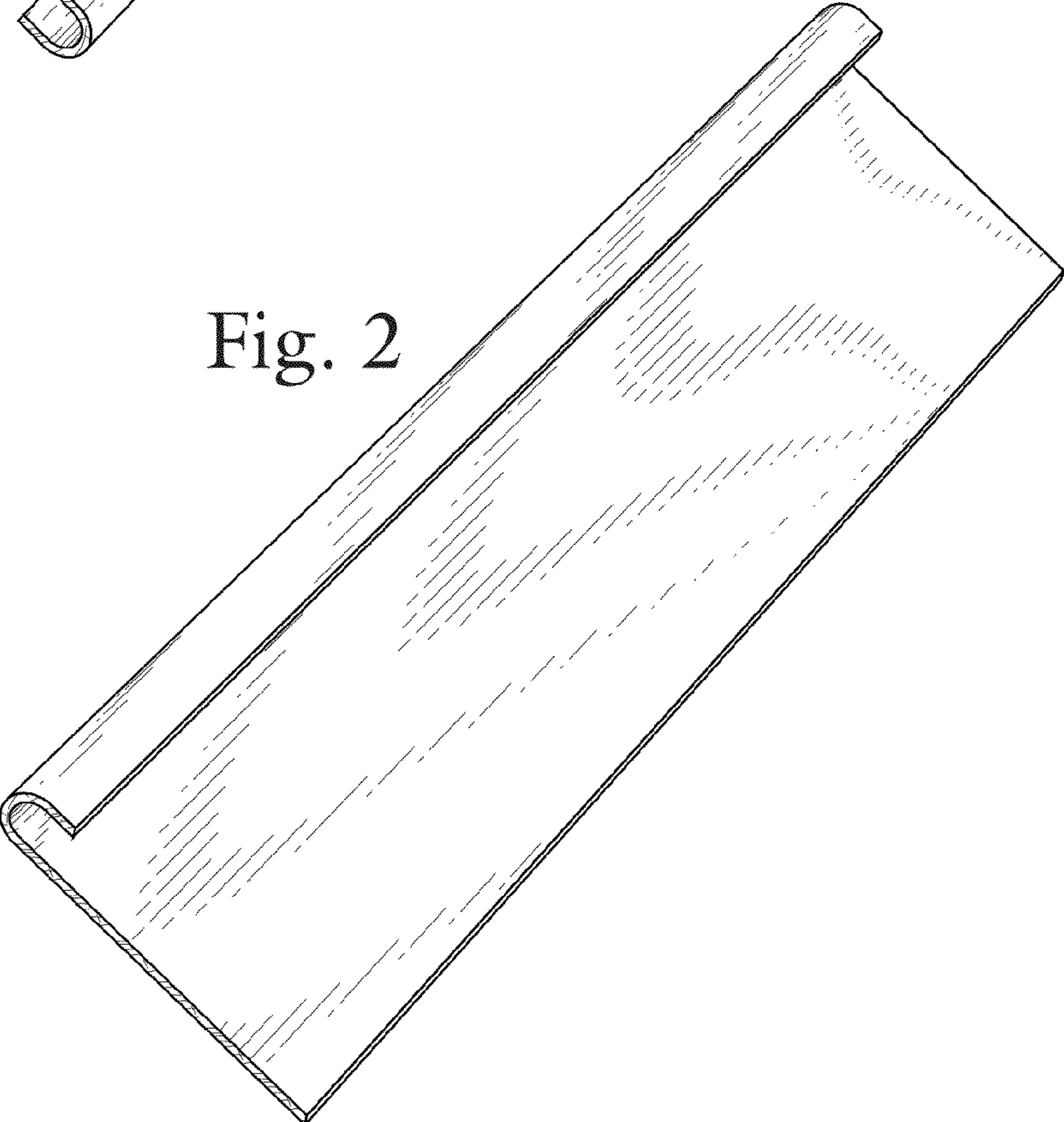

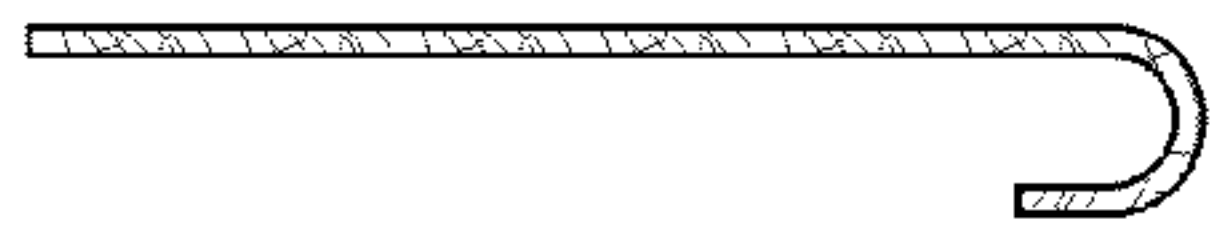

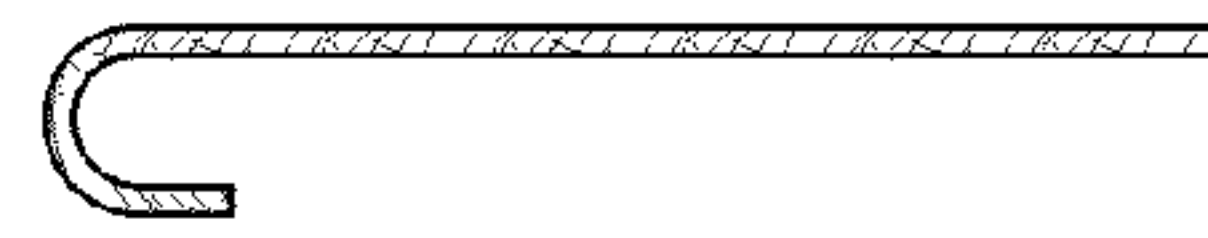

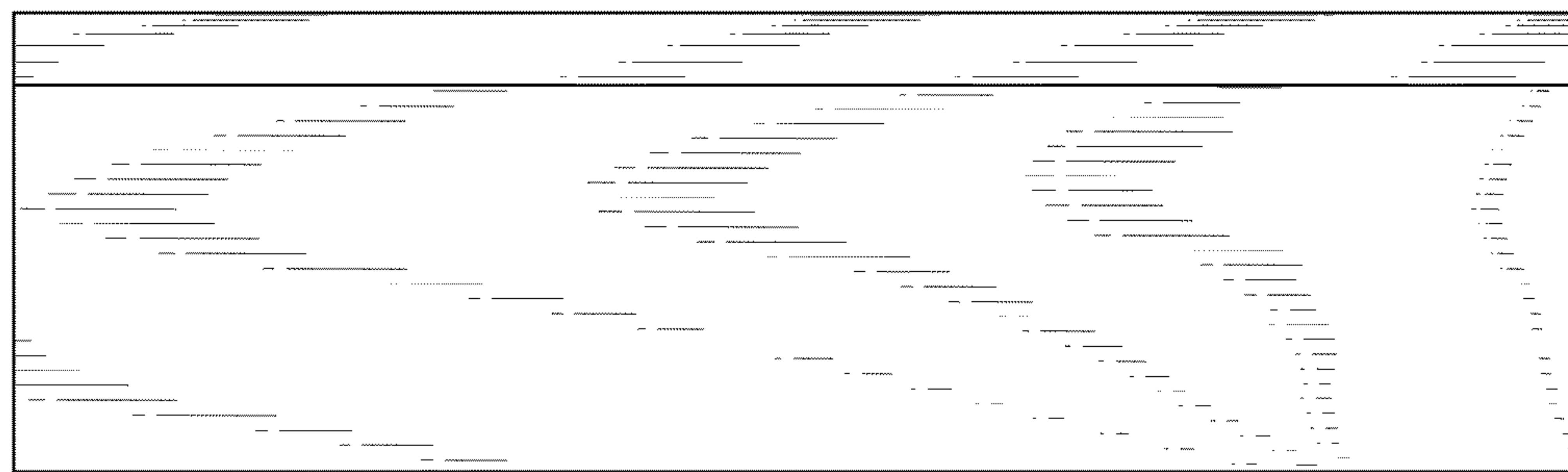

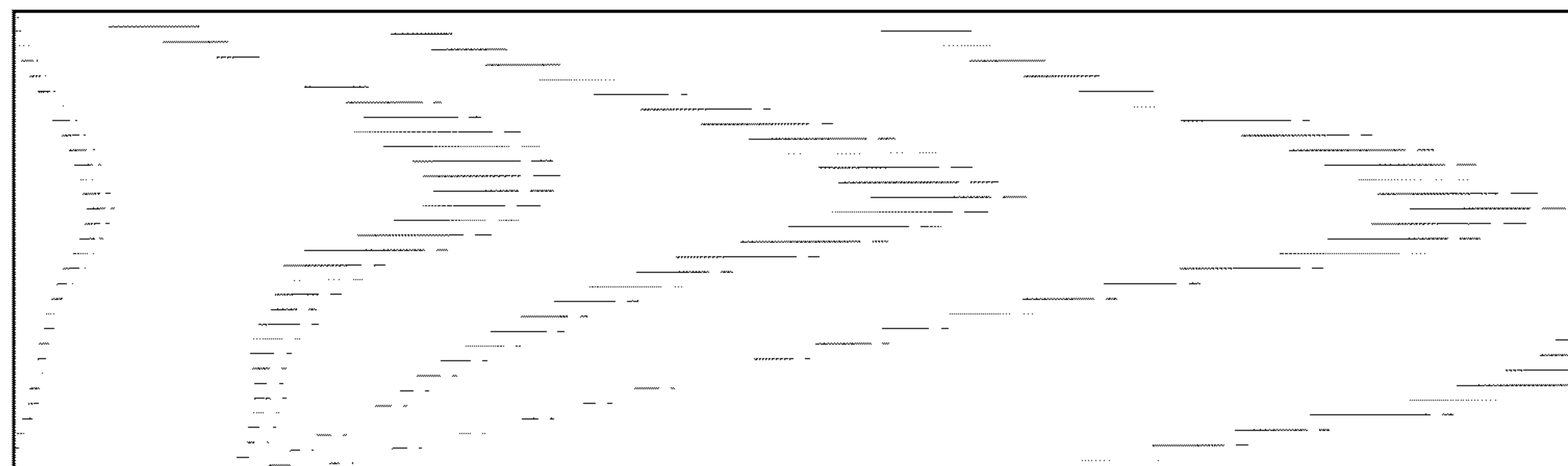
