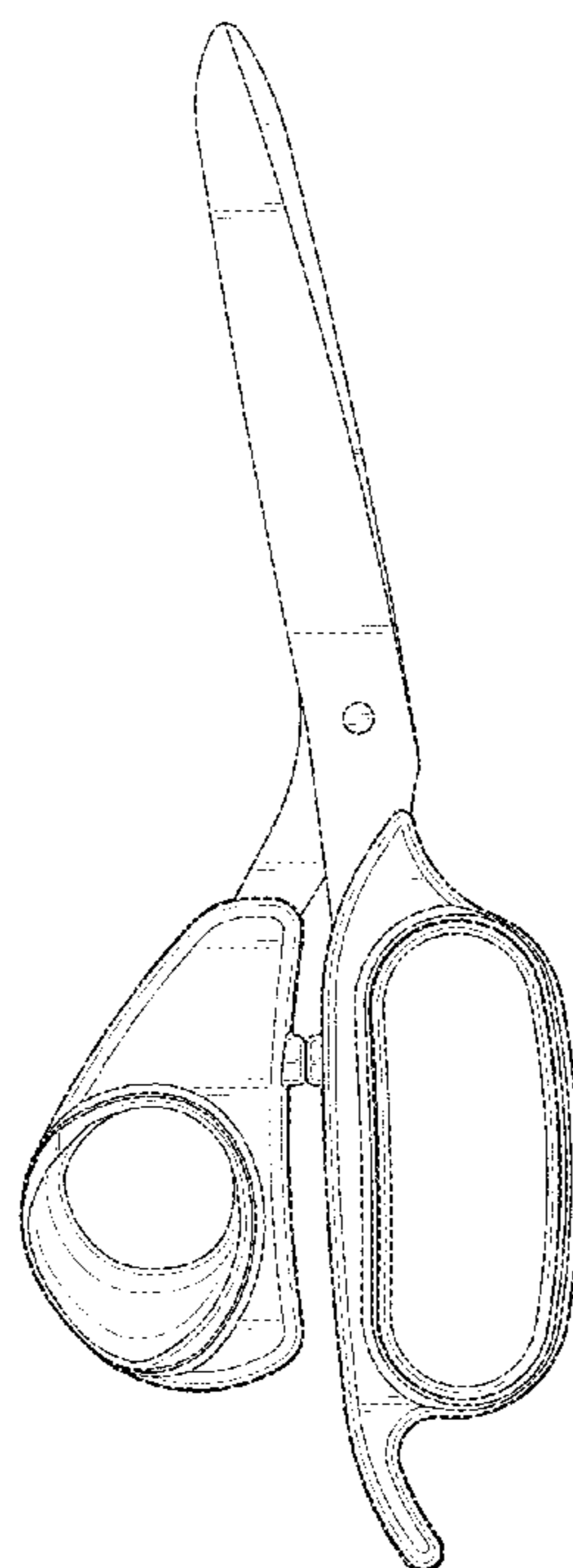
(57) **CLAIM**
The ornamental design for poultry shears, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of a poultry shears according to the invention;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a front elevational view thereof as when looking left to right in FIG. 2;
FIG. 5 is a rear elevational view thereof as when looking right to left in FIG. 2;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

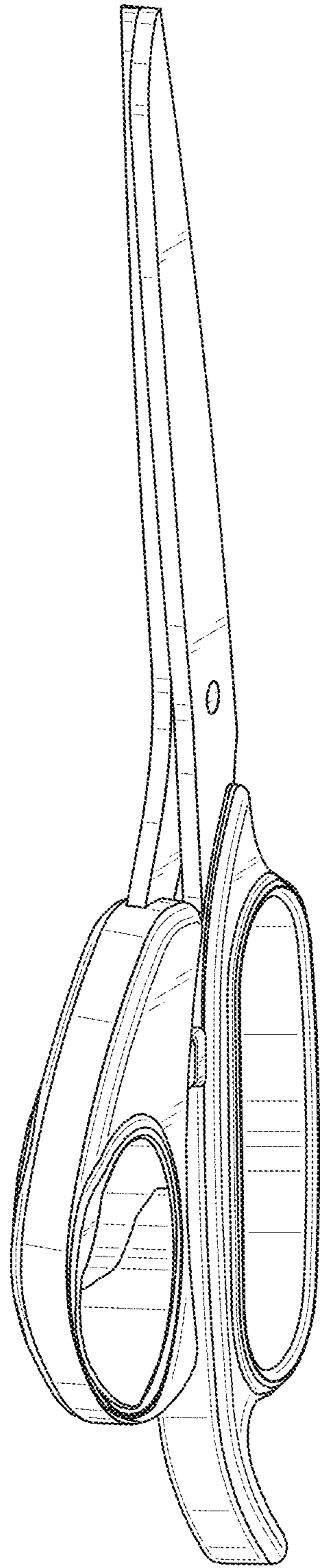

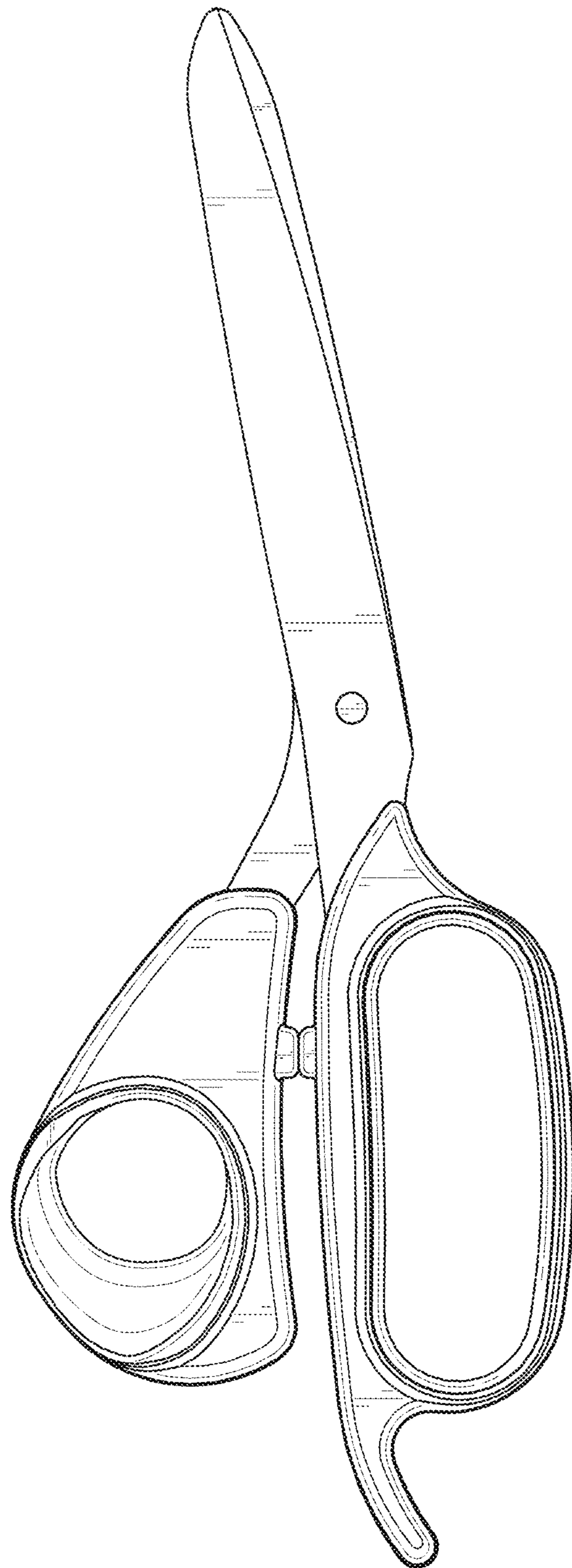

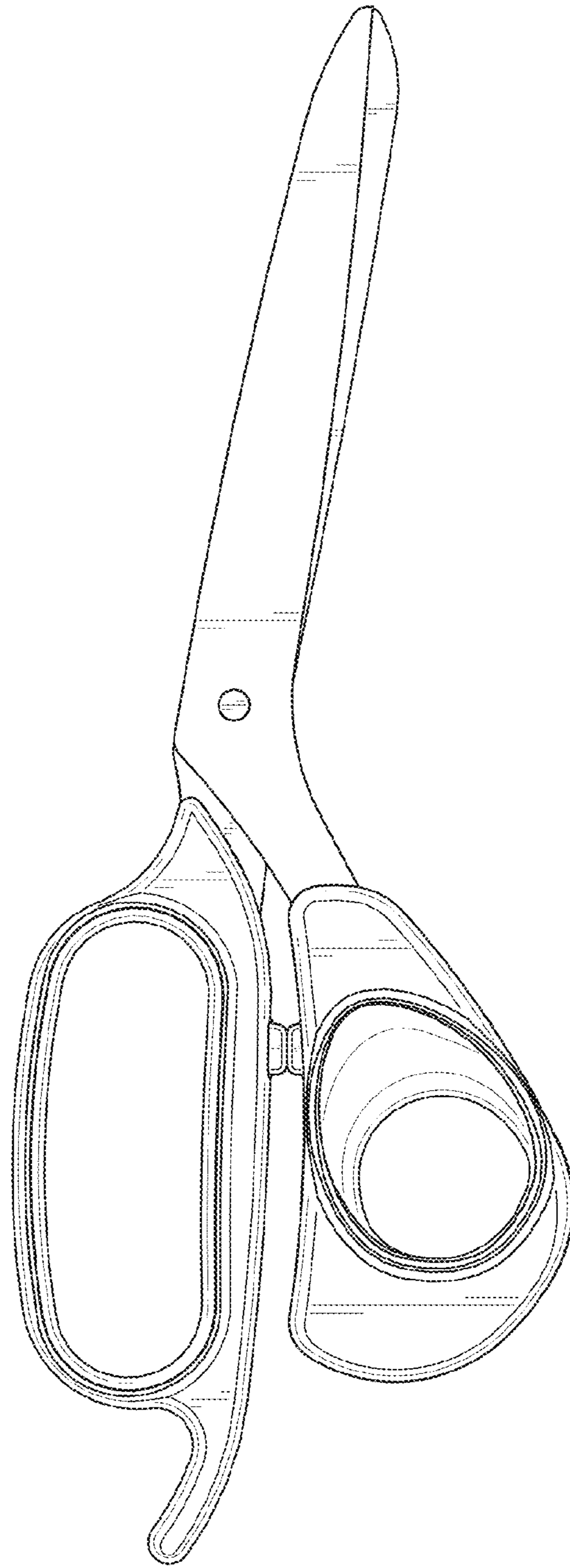

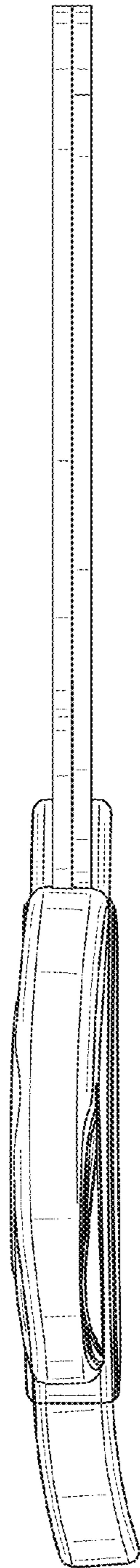

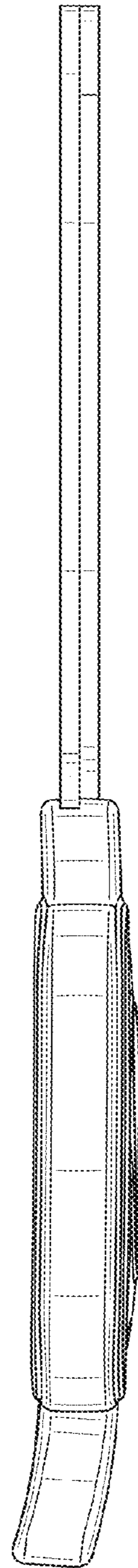

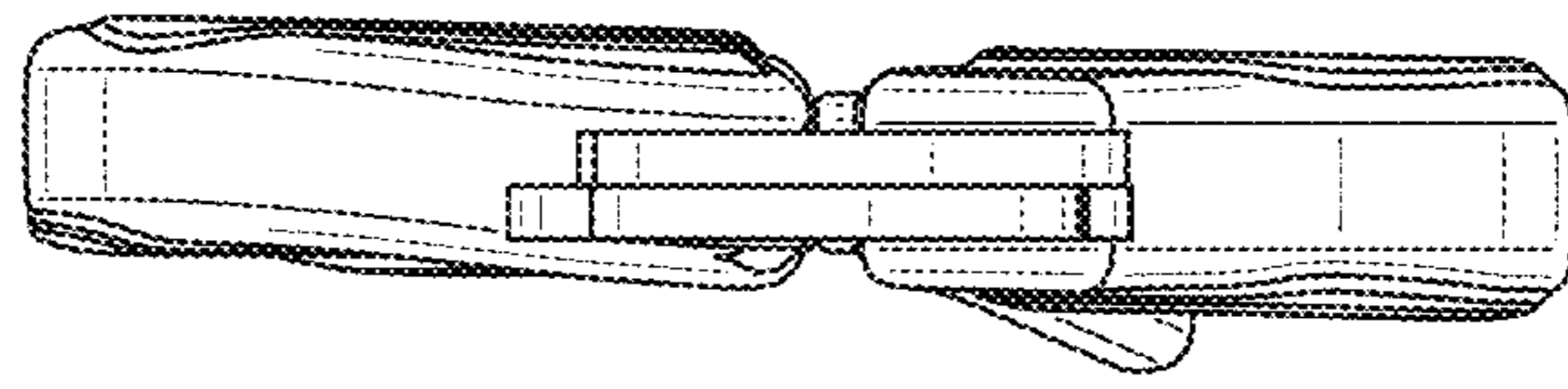

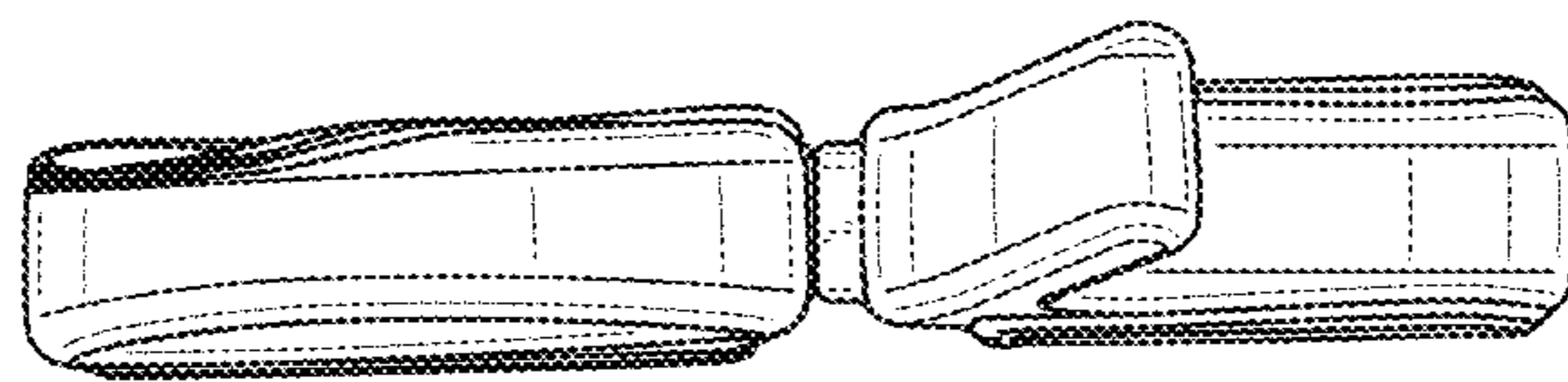
