(57) **CLAIM**

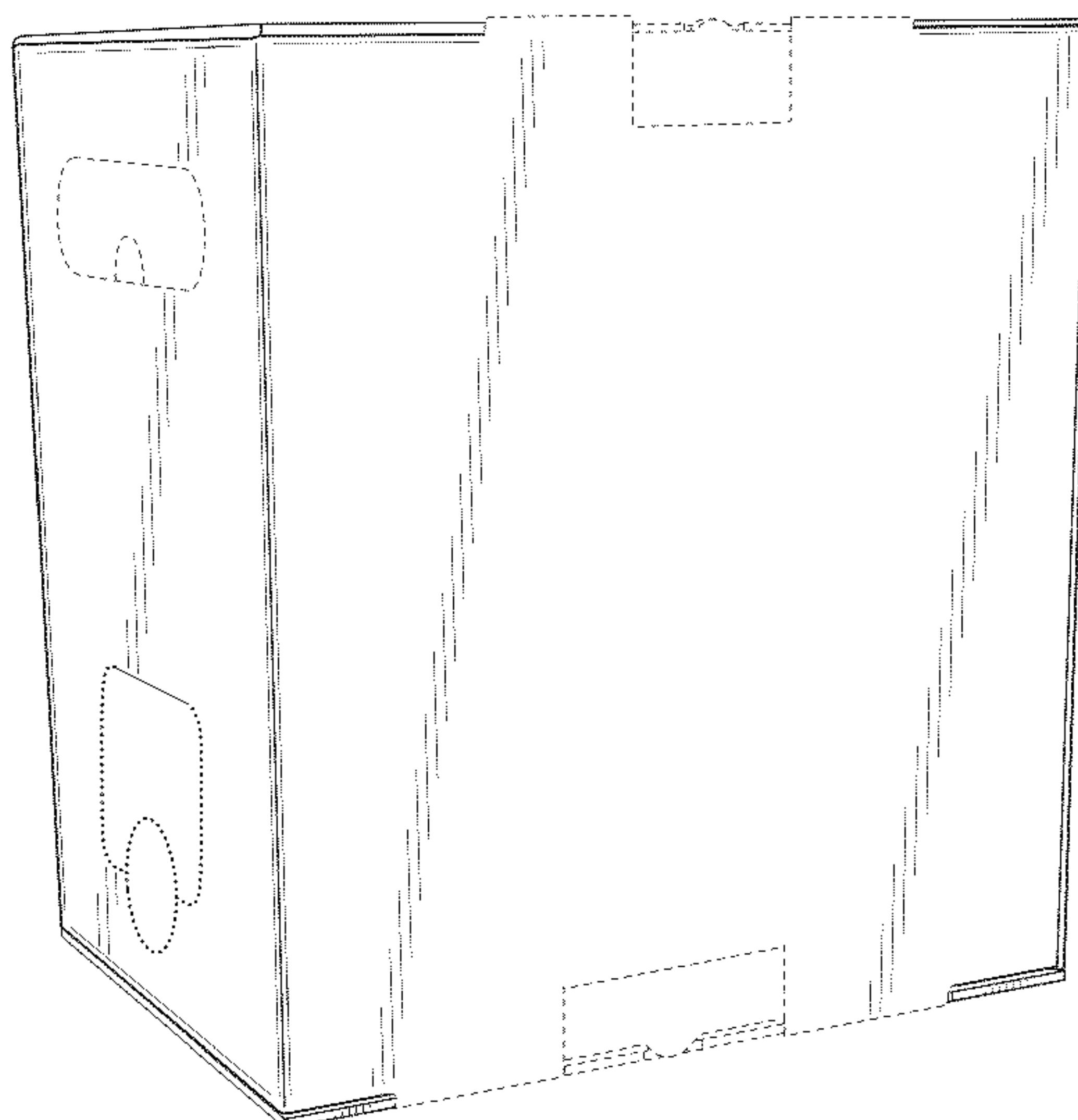
The ornamental design for a laundry product container, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view of a laundry product container showing a new design;
FIG. 2 is a top rear right side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is another front left side perspective view thereof, showing the laundry station container in an alternate configuration.

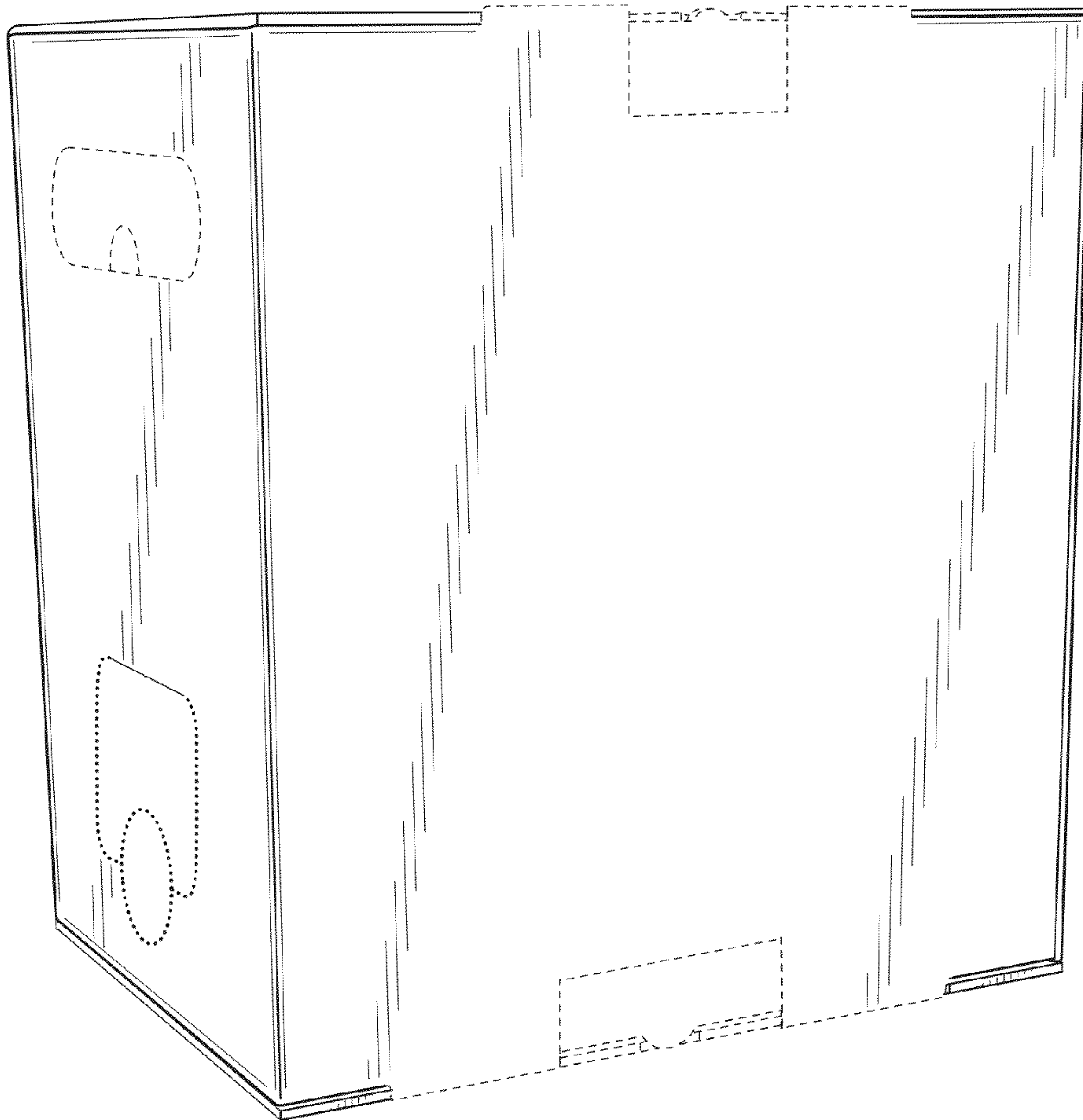

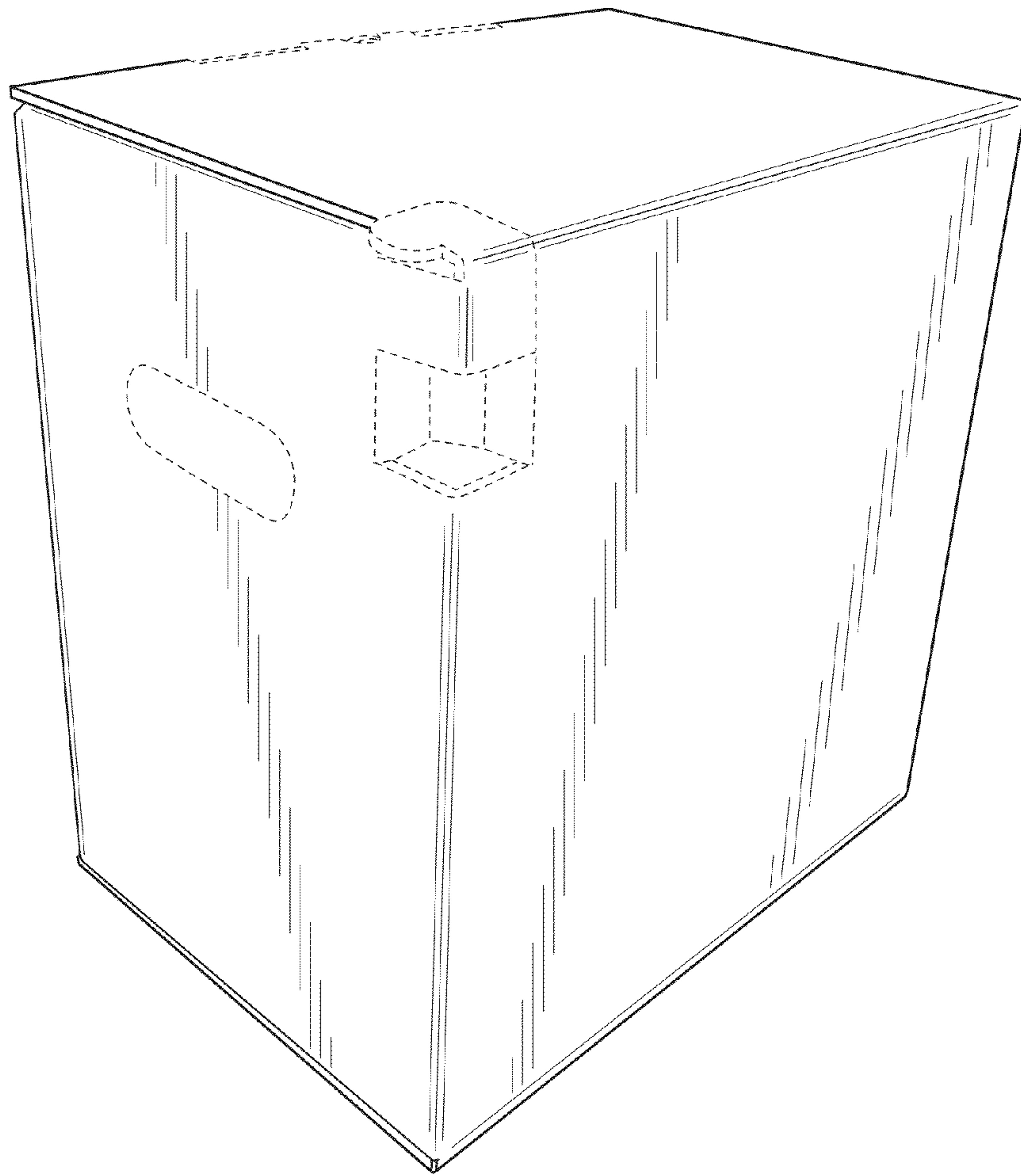

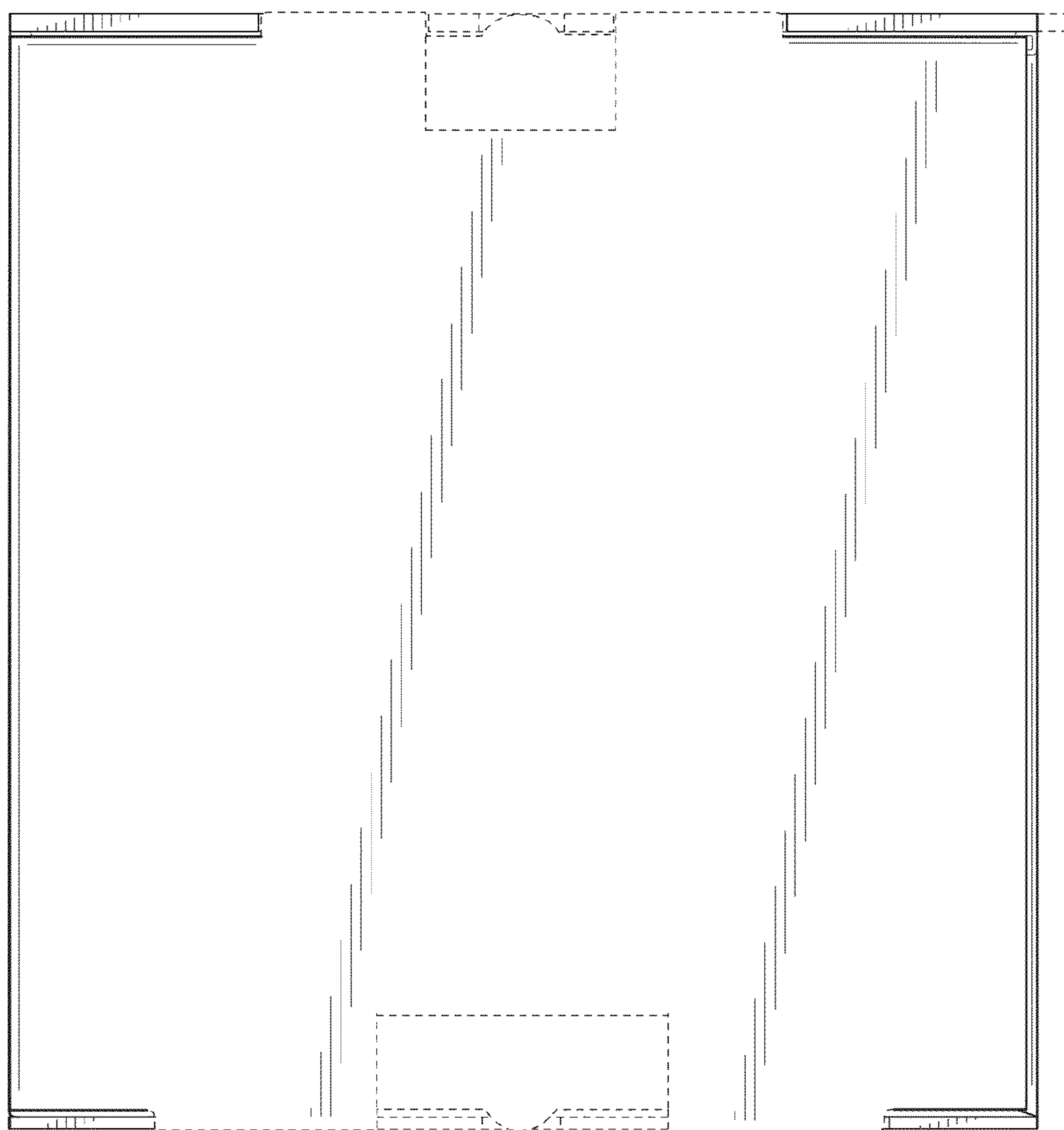

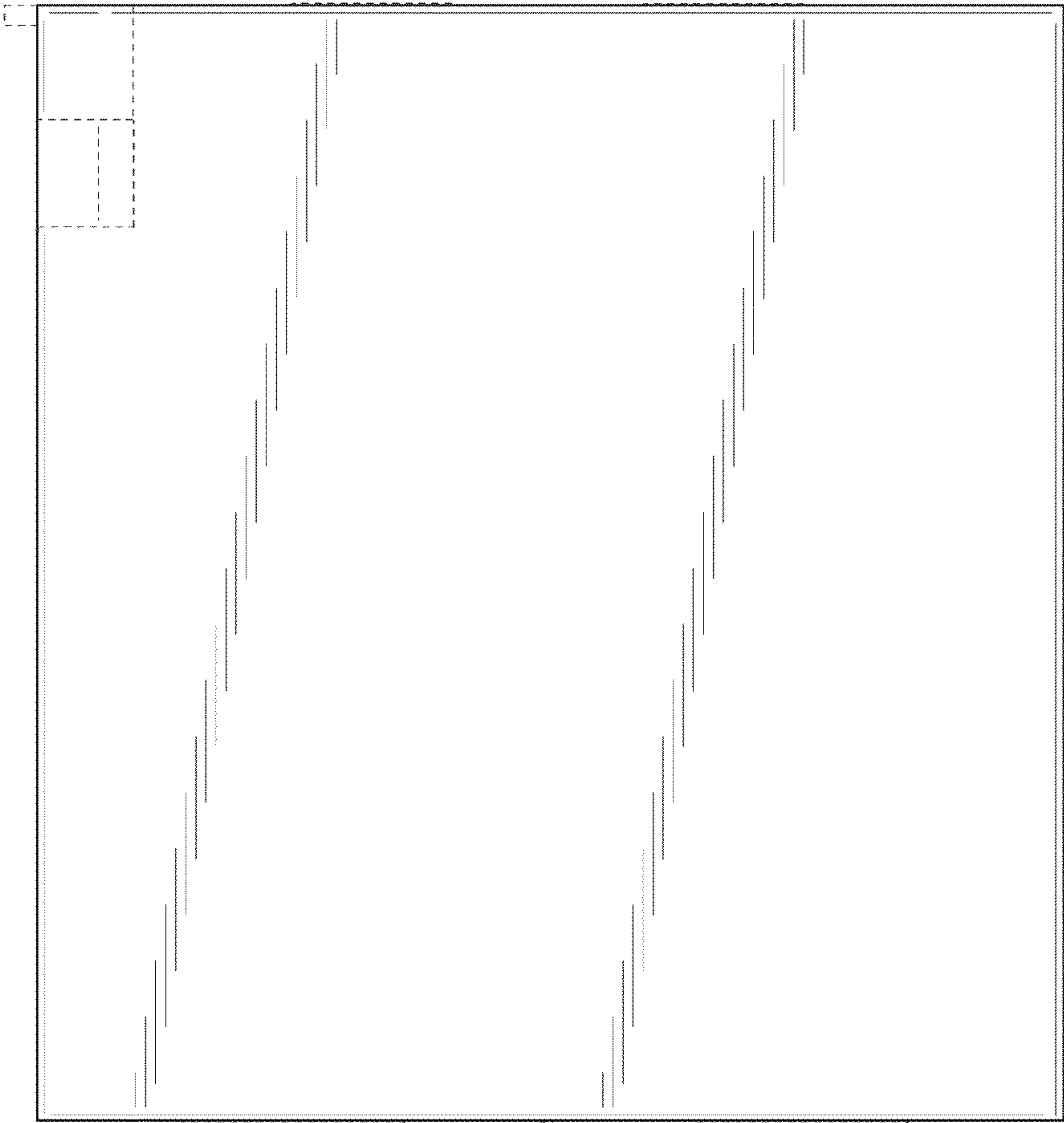

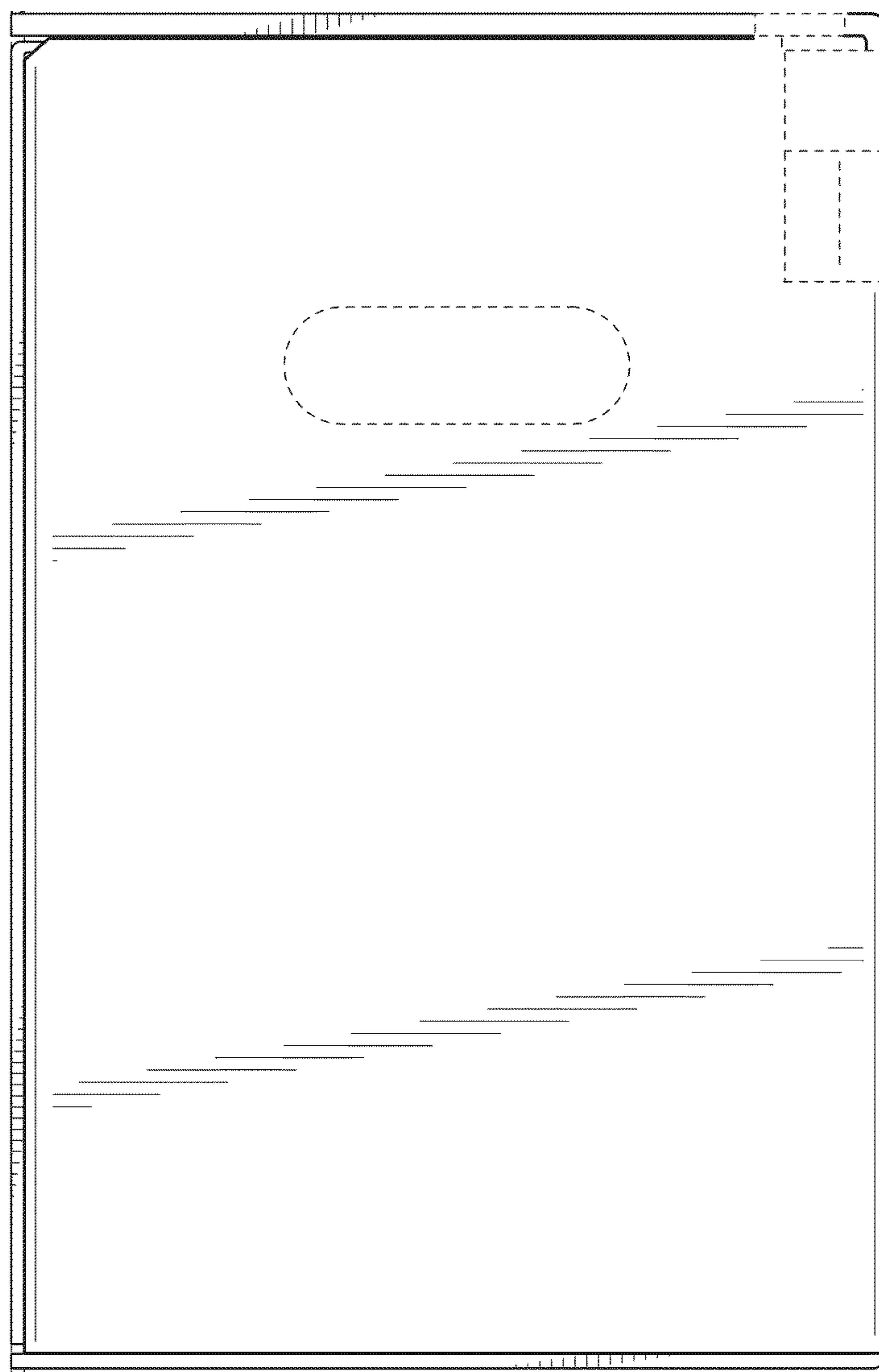

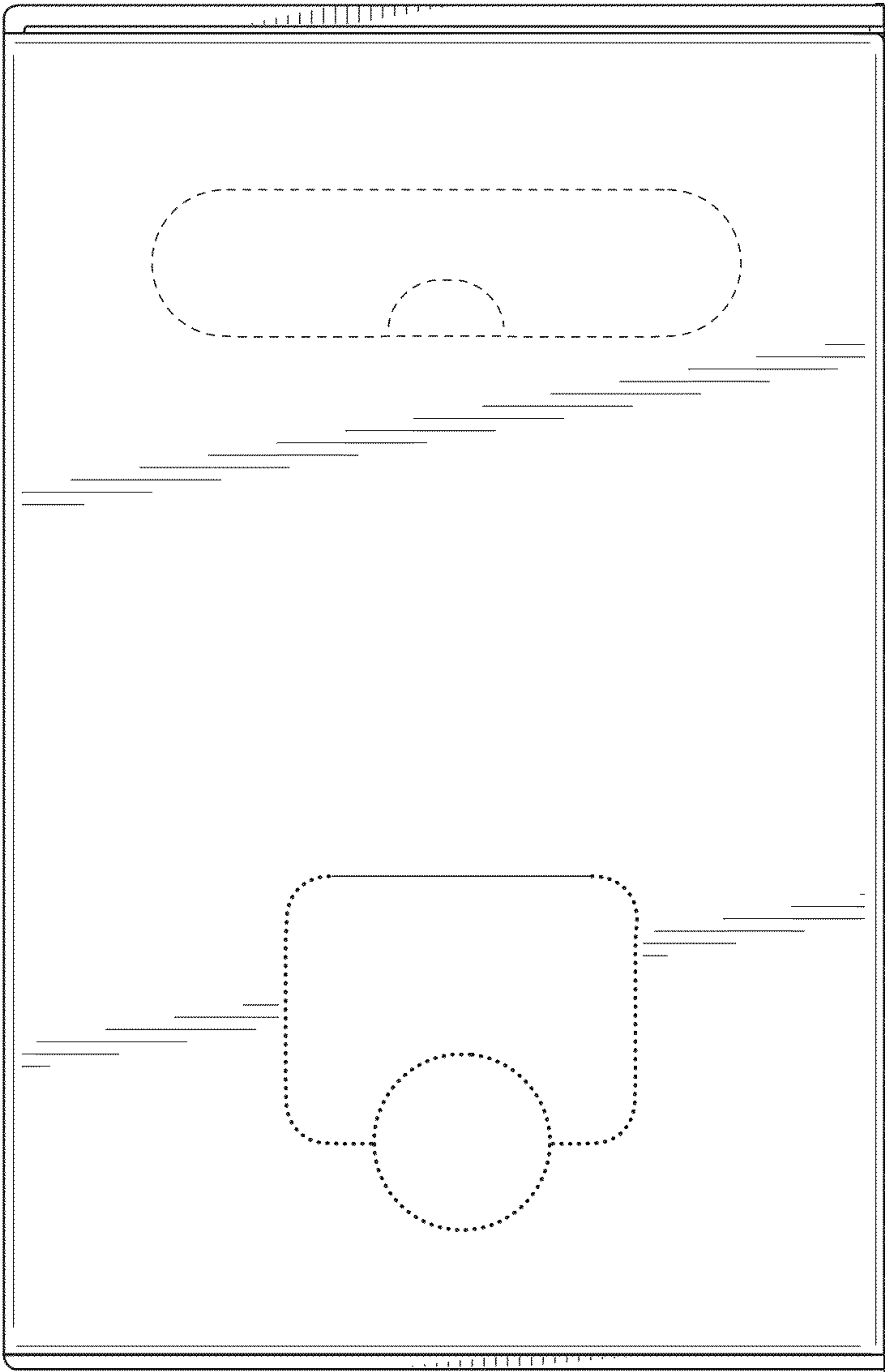

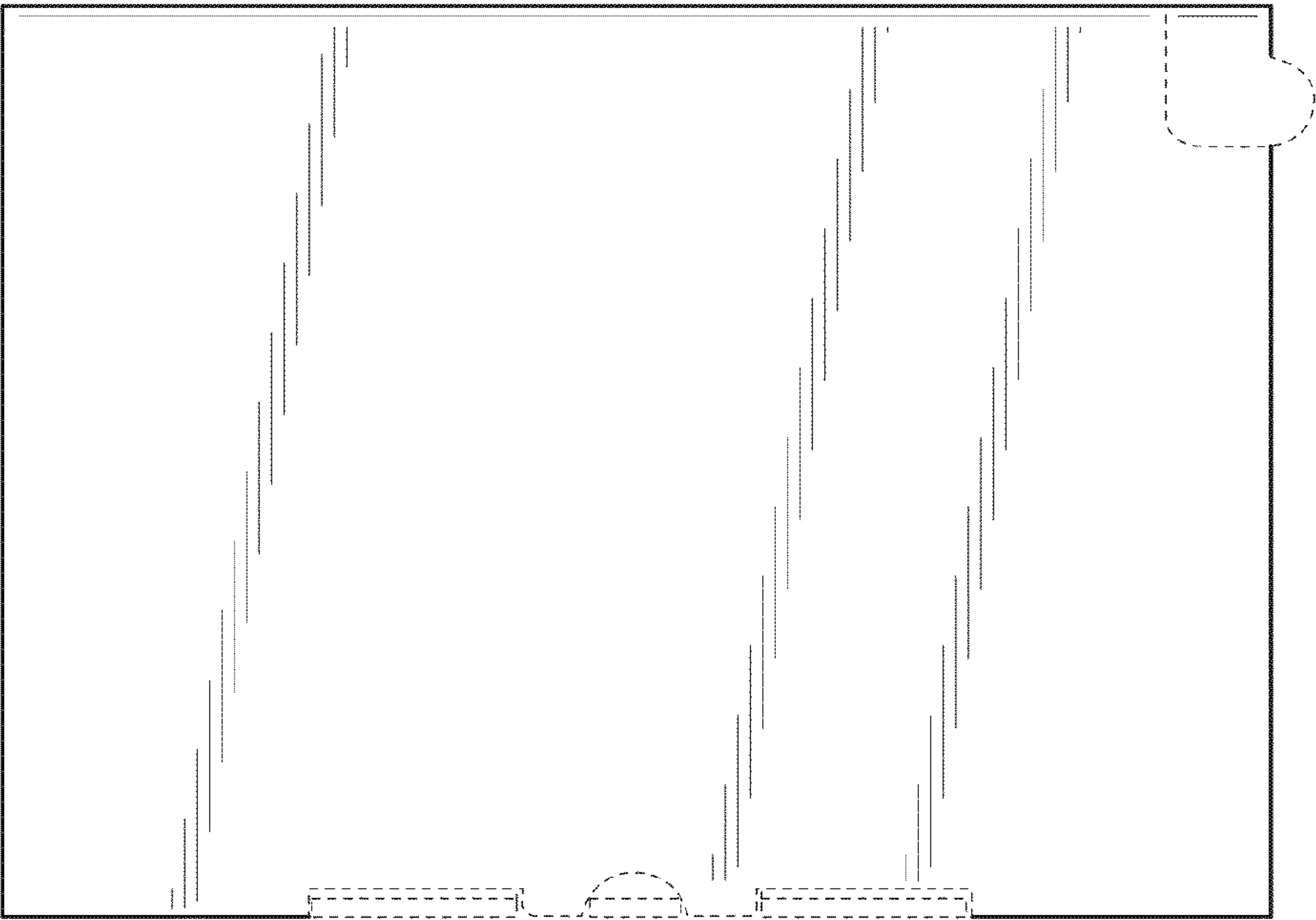

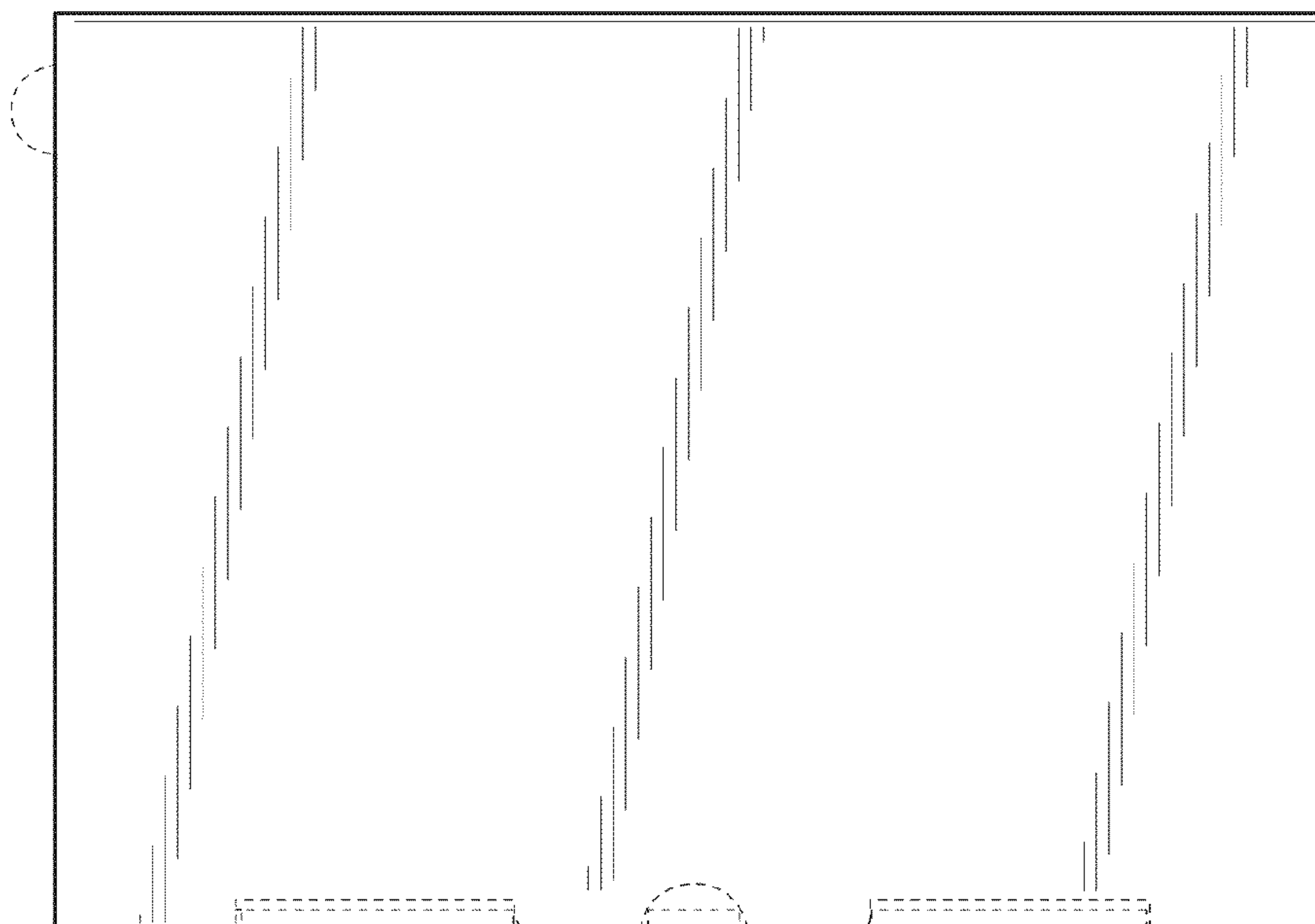

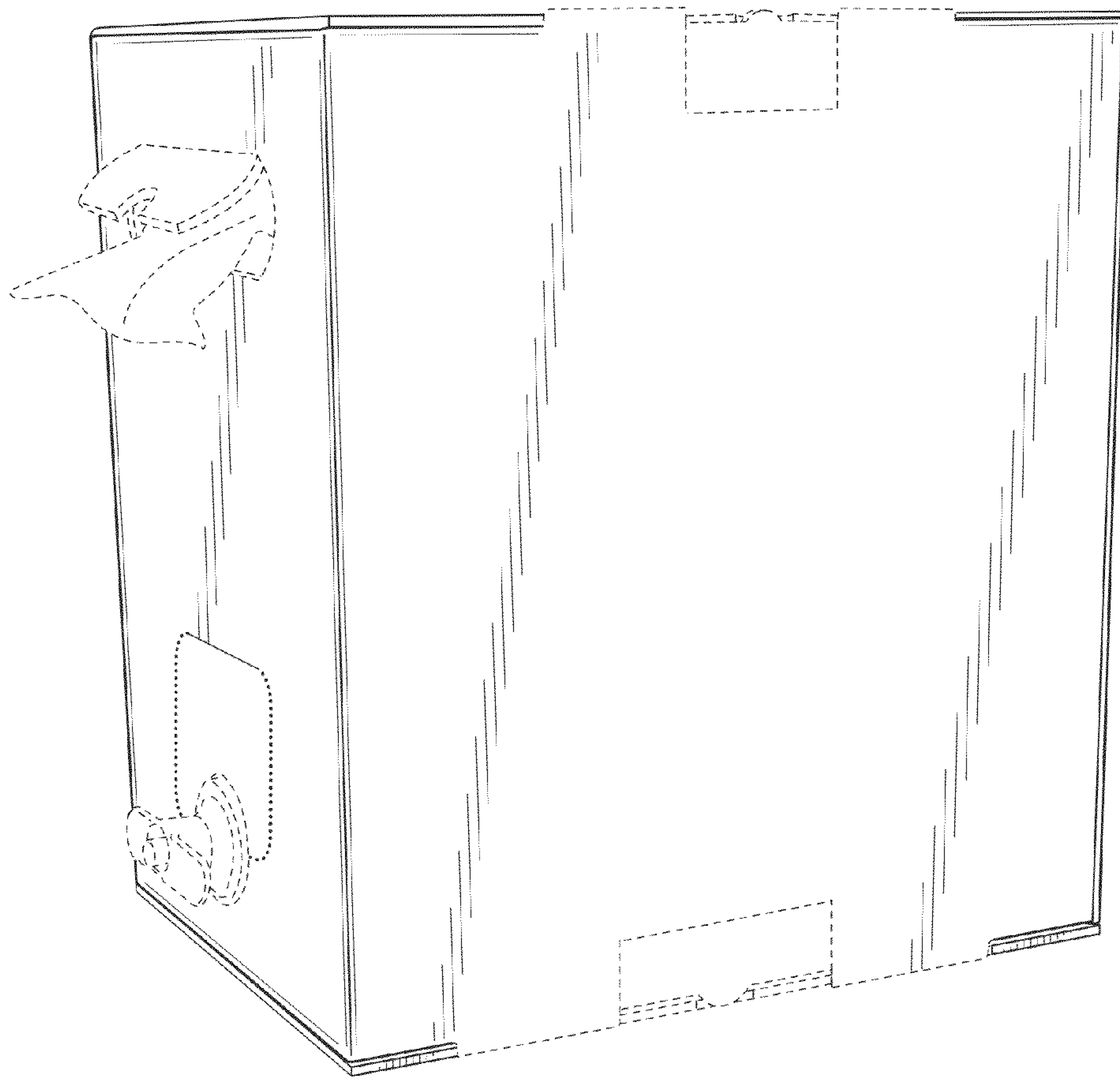
