(57) **CLAIM**

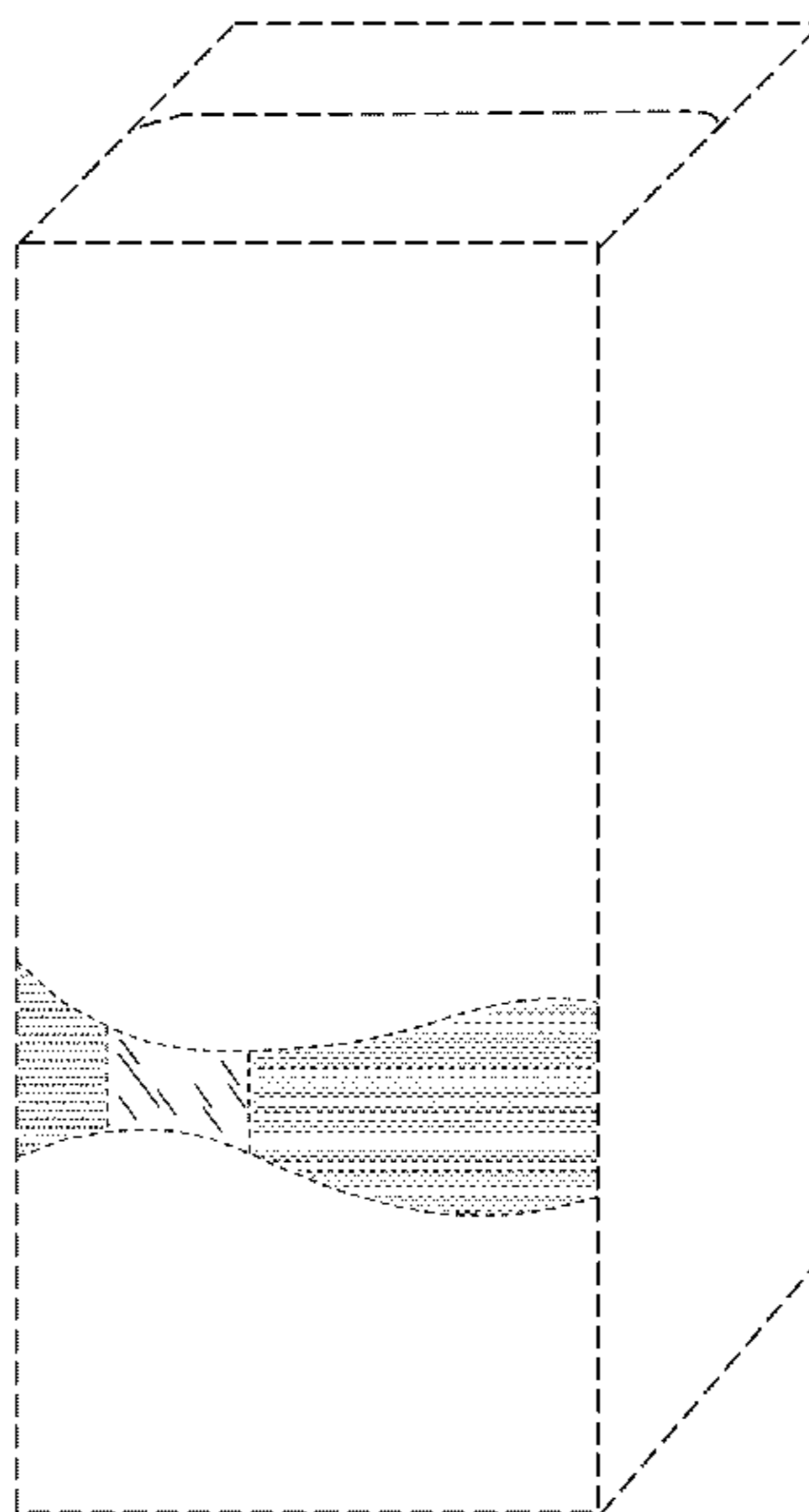
The ornamental design for an absorbent article package, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of an embodiment of an absorbent article package embodying the new design; FIG. 2 is a front view of the design shown in FIG. 1; FIG. 3 is a right side view of the design shown in FIG. 1; the left side and back views are the same and thus omitted; and, FIG. 4 is a top view of the design shown in FIG. 1; the bottom view is the same and is thus omitted; wherein the different stippling represents different colors or different shades of one color, and wherein a window is lined for transparency.

The broken lines in the drawing depict environmental subject matter only and form no part of the claimed design.

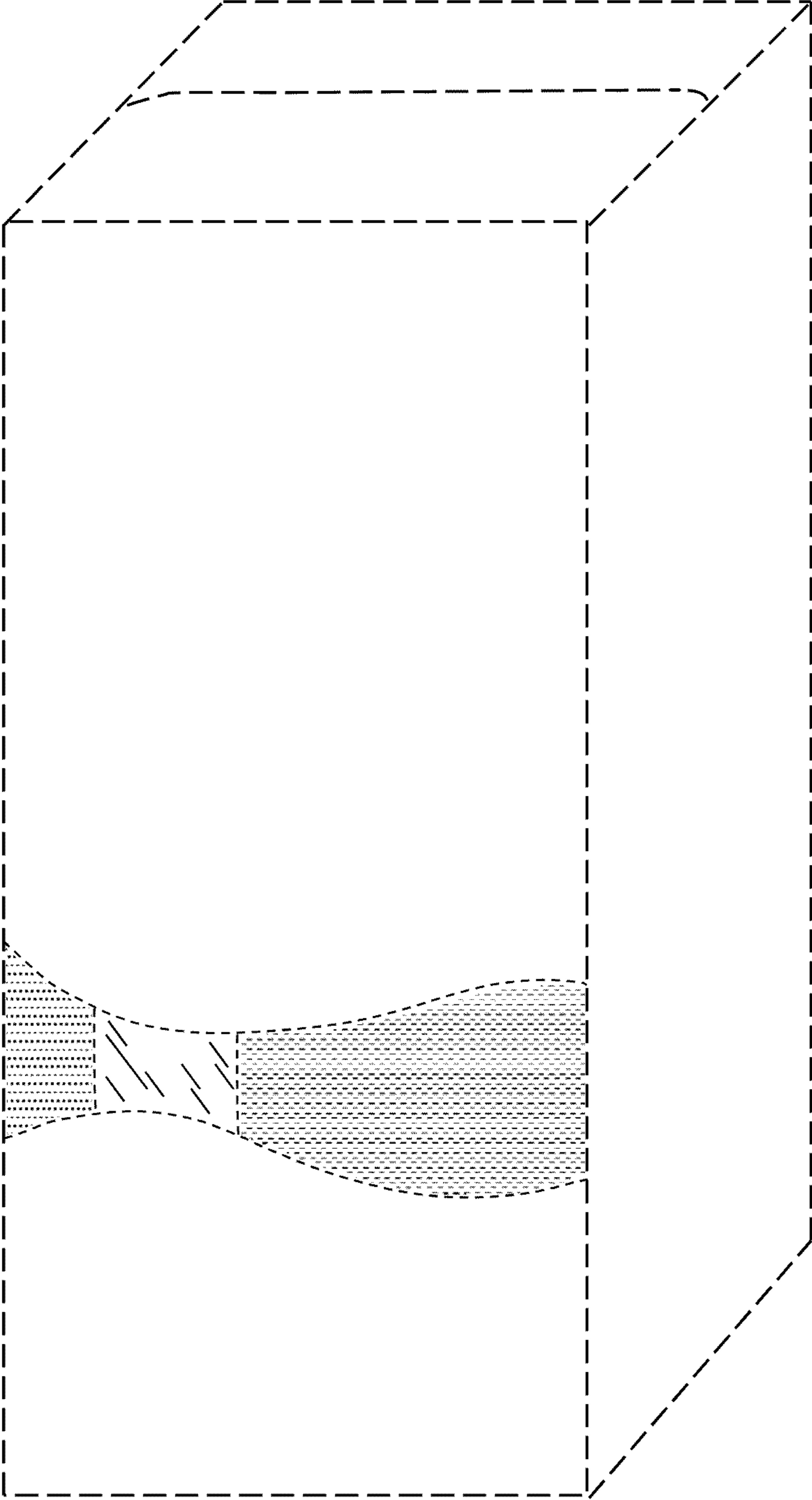

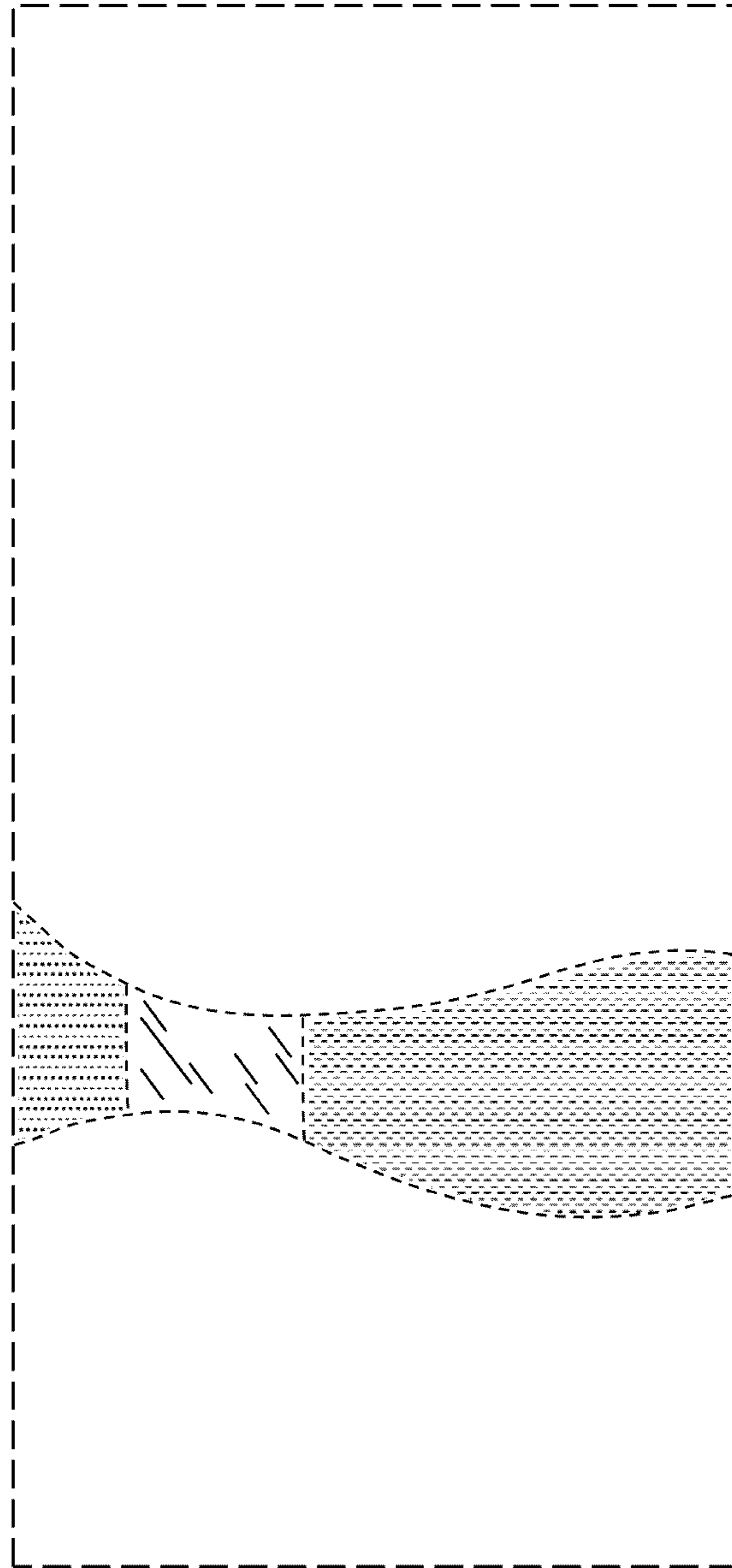

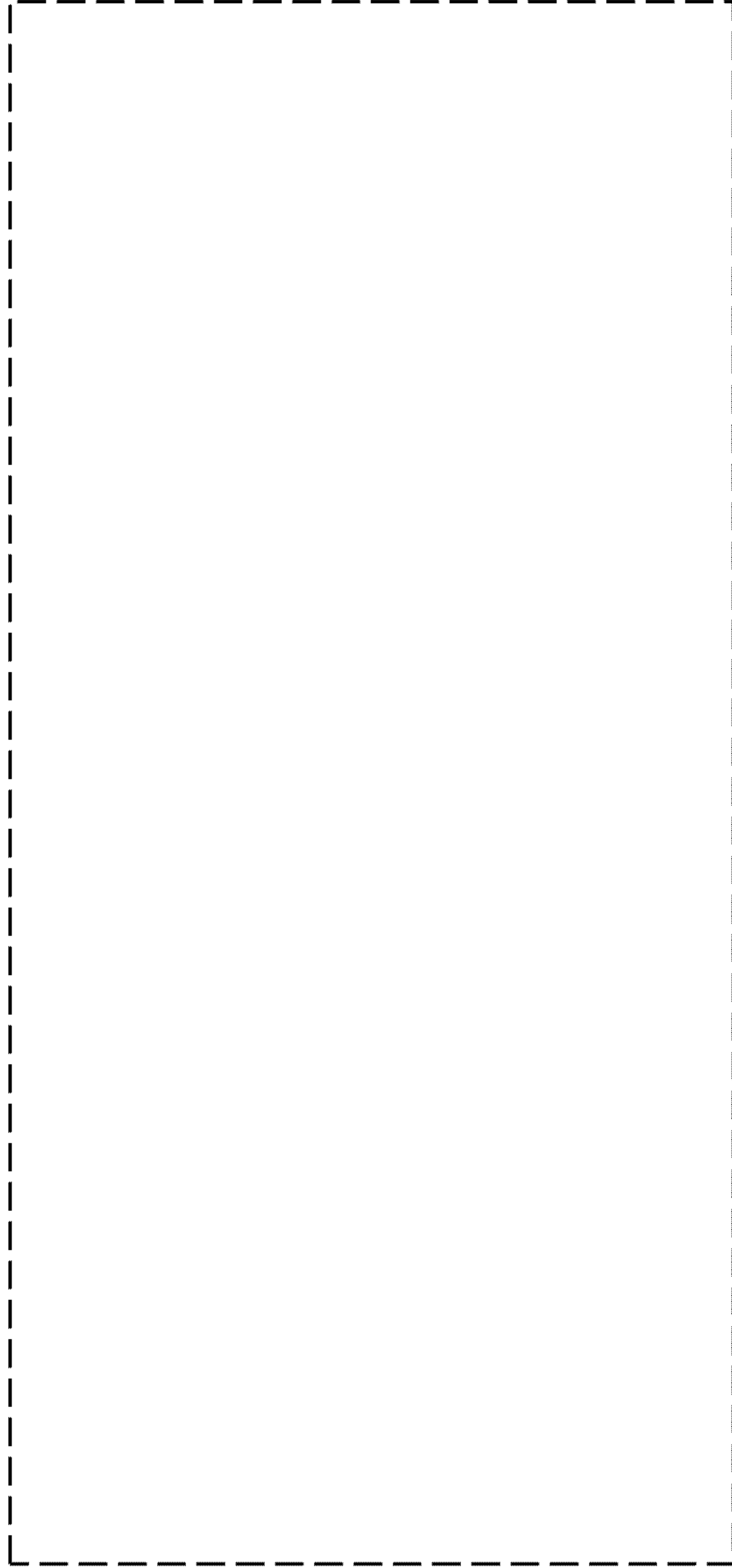

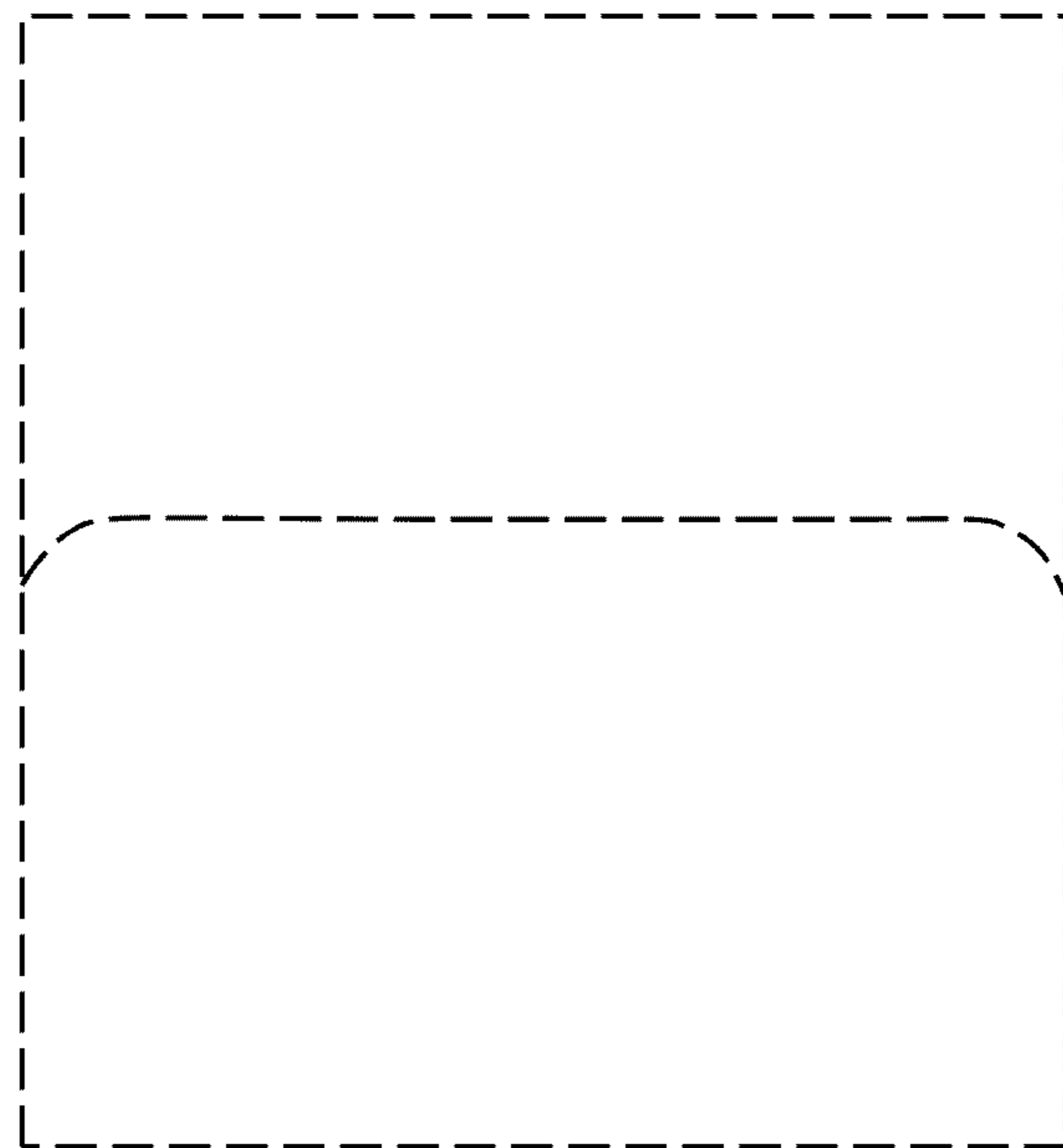
