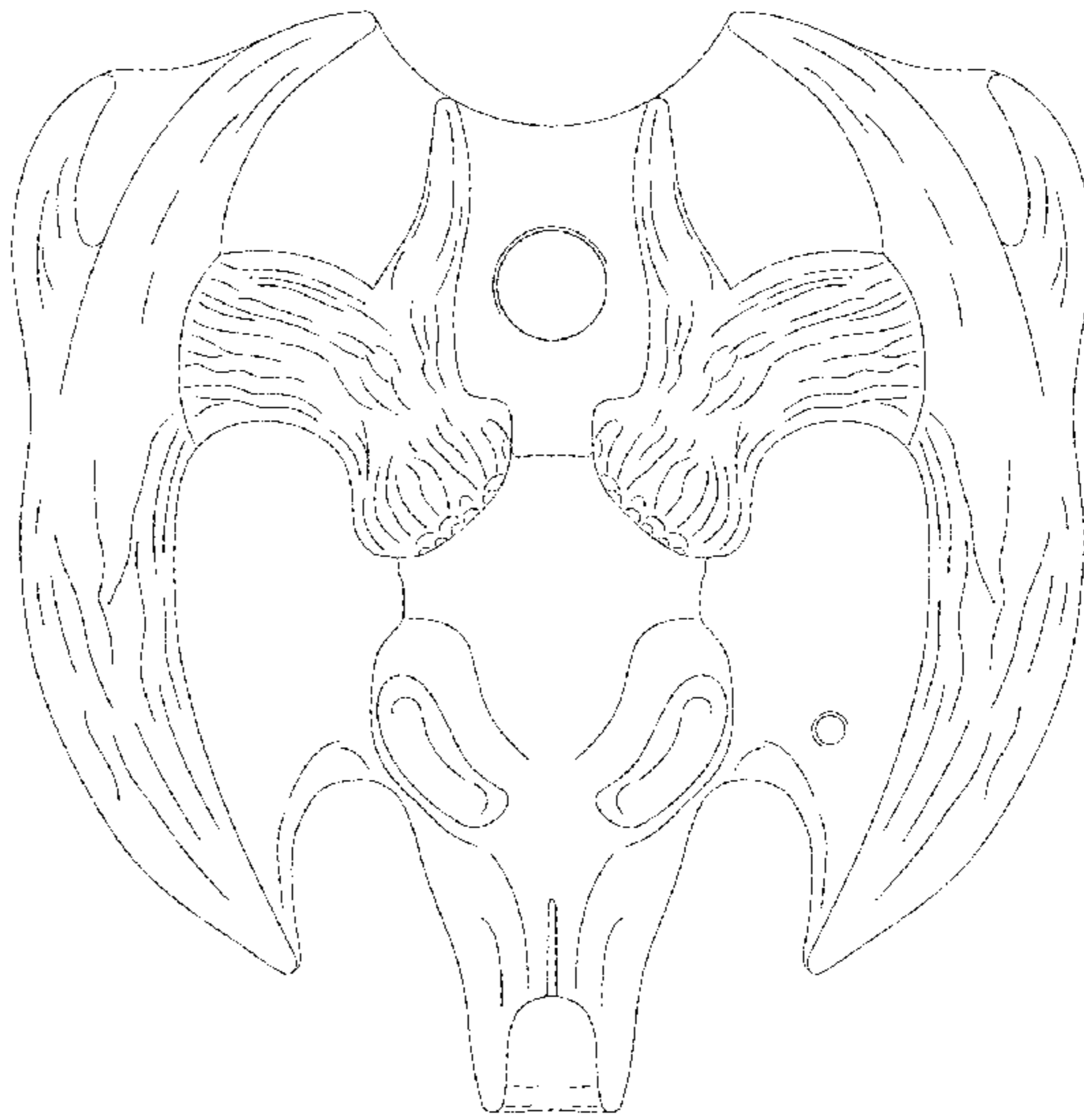
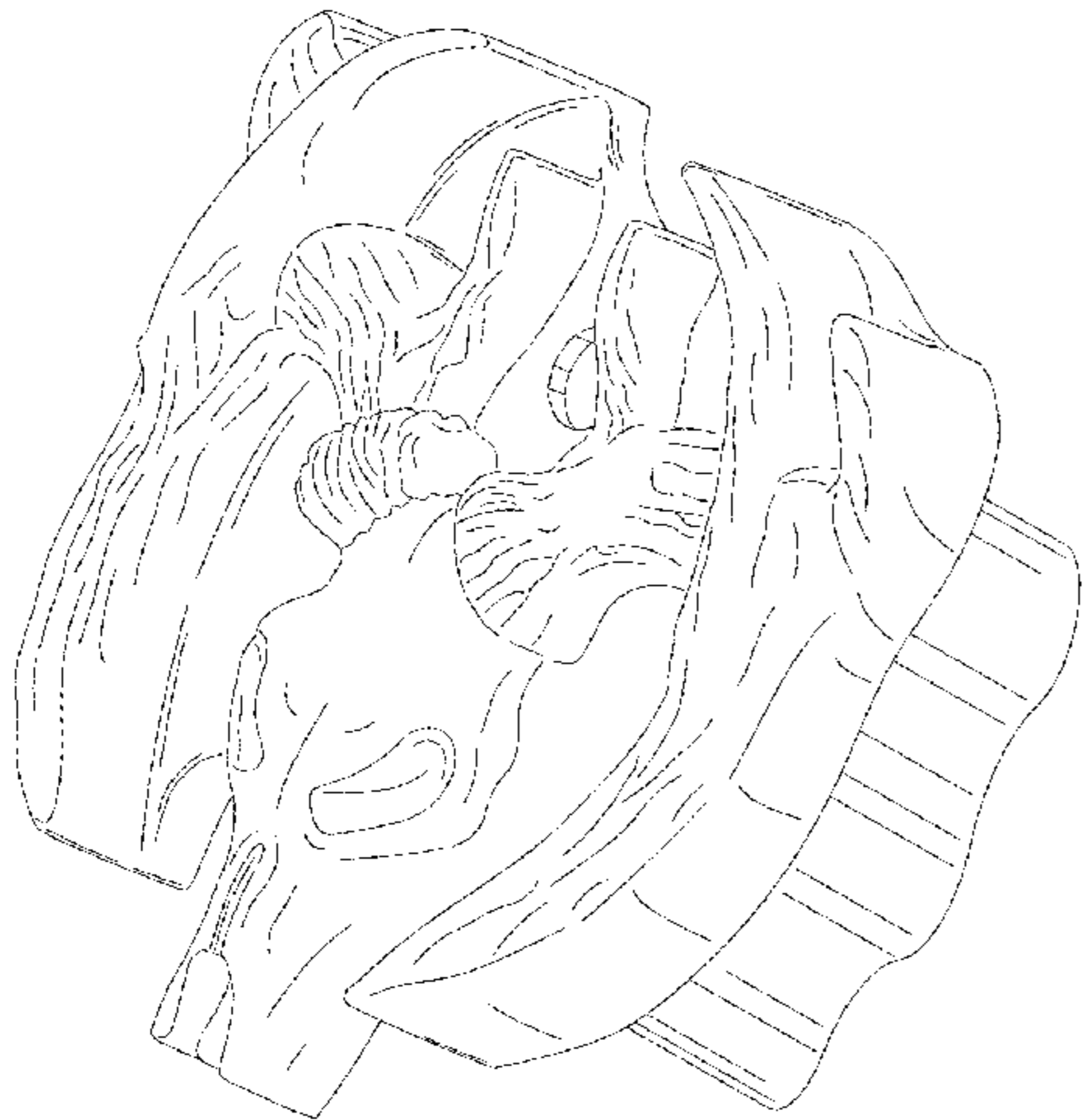
(57) **CLAIM**

The ornamental design for a deer rattle call, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first half of the deer rattle call; FIG. 2 is a front side view of the first half of the deer rattle call; FIG. 3 is a rear side view of the first half of the deer rattle call; FIG. 4 is a top view of the first half of the deer rattle call; FIG. 5 is a bottom view of the first half of the deer rattle call; FIG. 6 is a first side view first half of the deer rattle call, the opposite side view being a mirror; FIG. 7 is a perspective view of a second half of the deer rattle call; FIG. 8 is a front view of a second half of the deer rattle call; FIG. 9 is a back view of a second half of the deer rattle call; FIG. 10 is a side view of a second half of the deer rattle call, the opposite side view being a mirror image; and, FIG. 11 is a bottom view of a second half of the deer rattle call, the top view being mirror image.

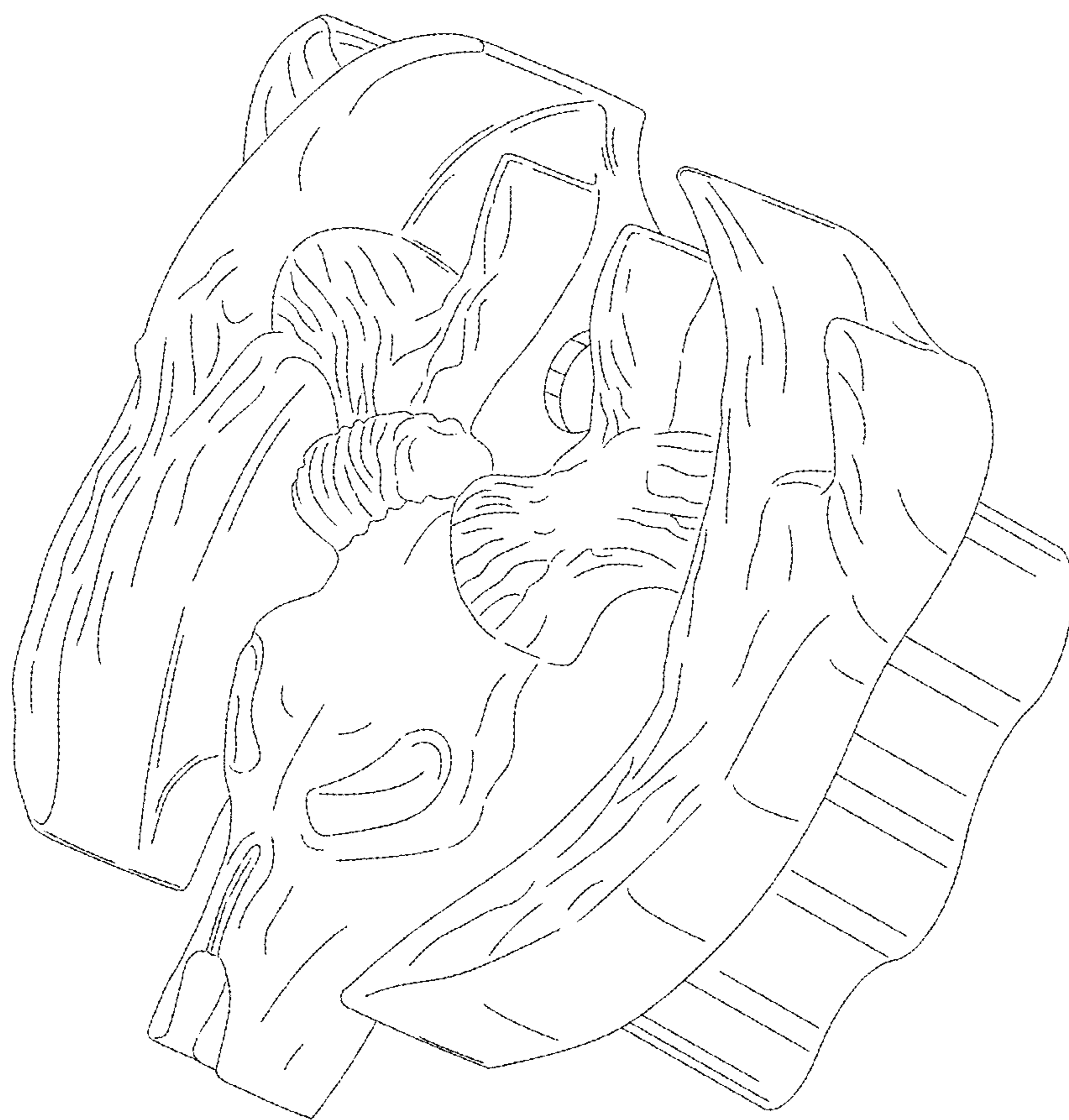

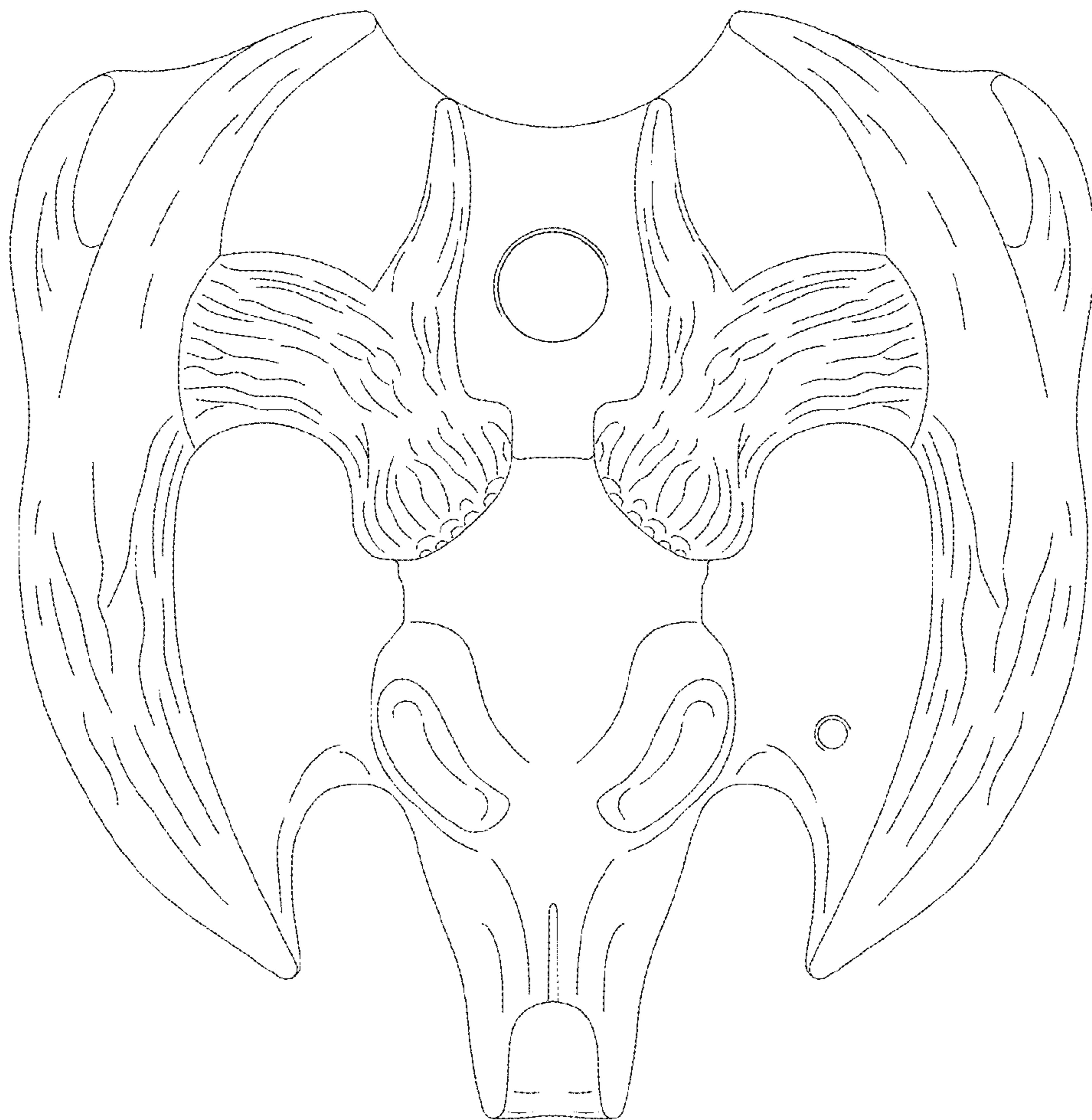

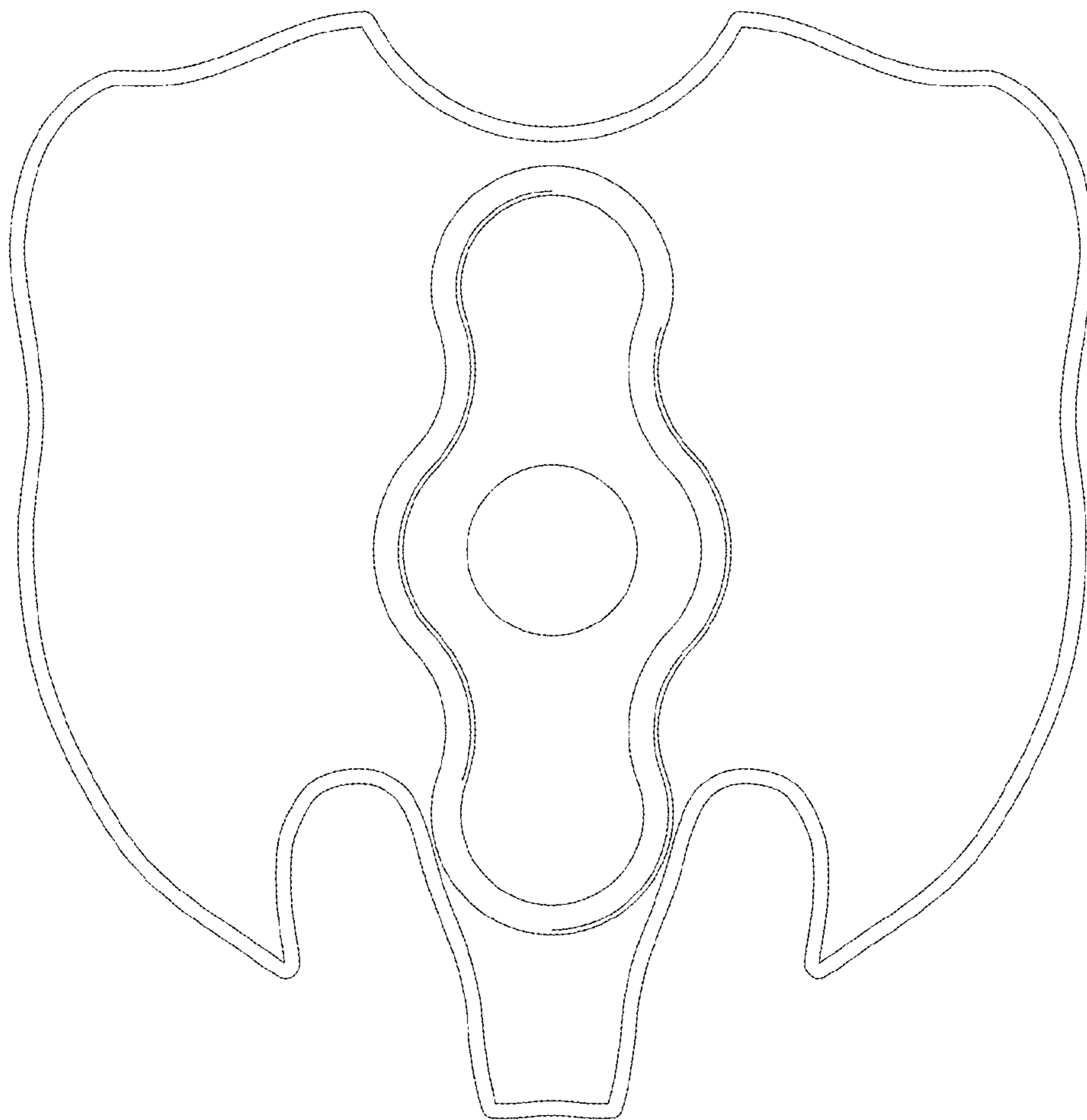

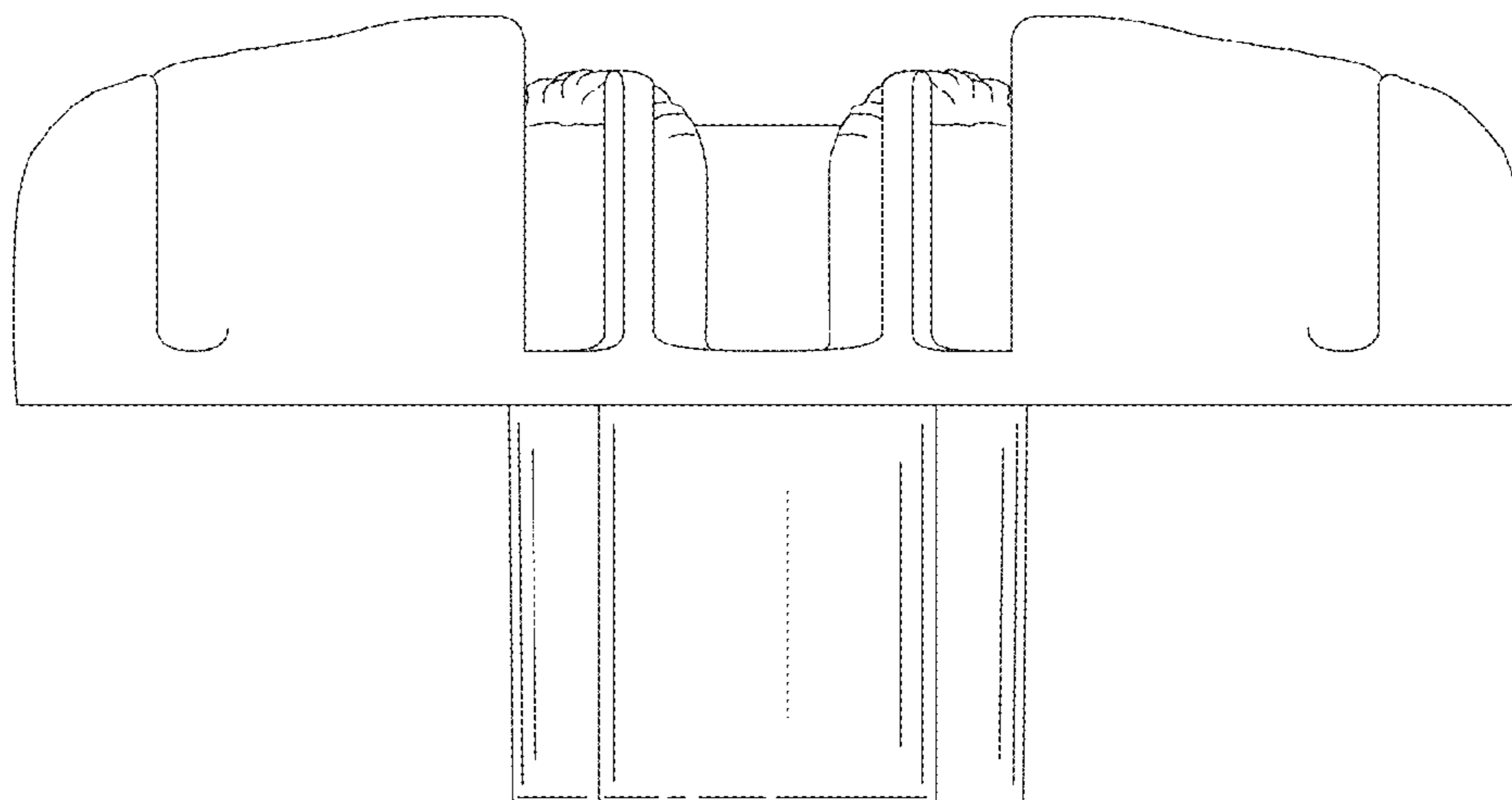

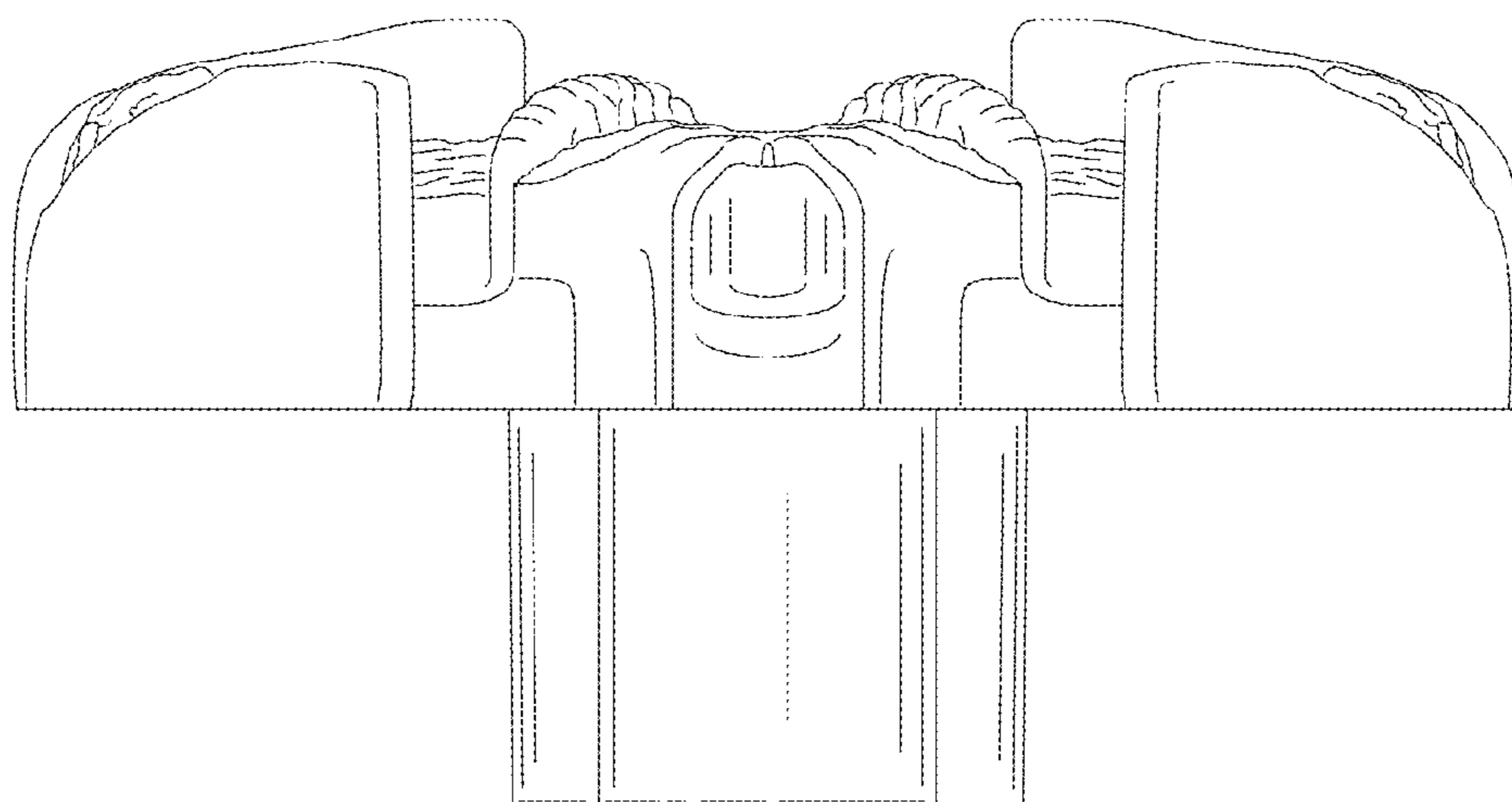

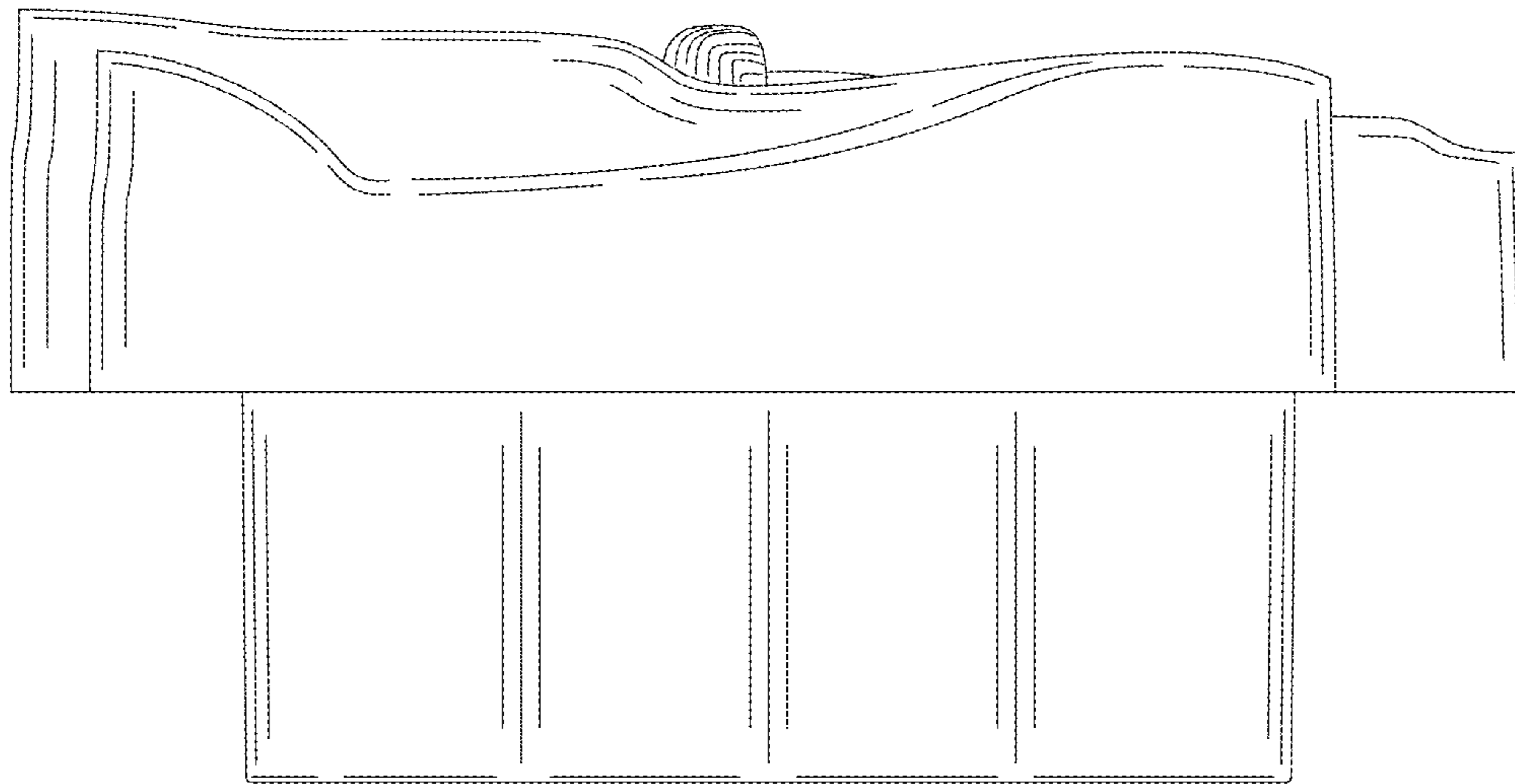

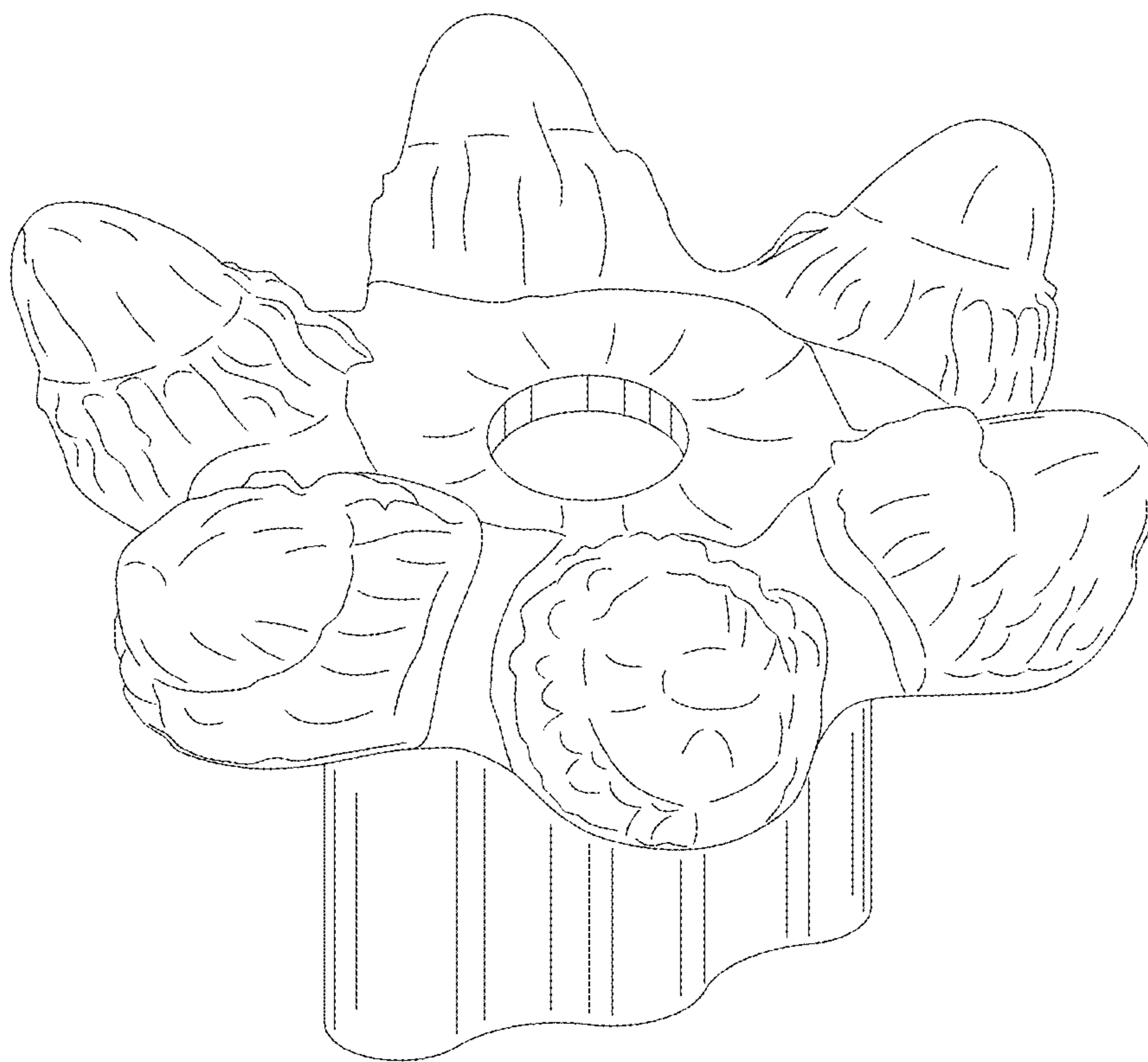

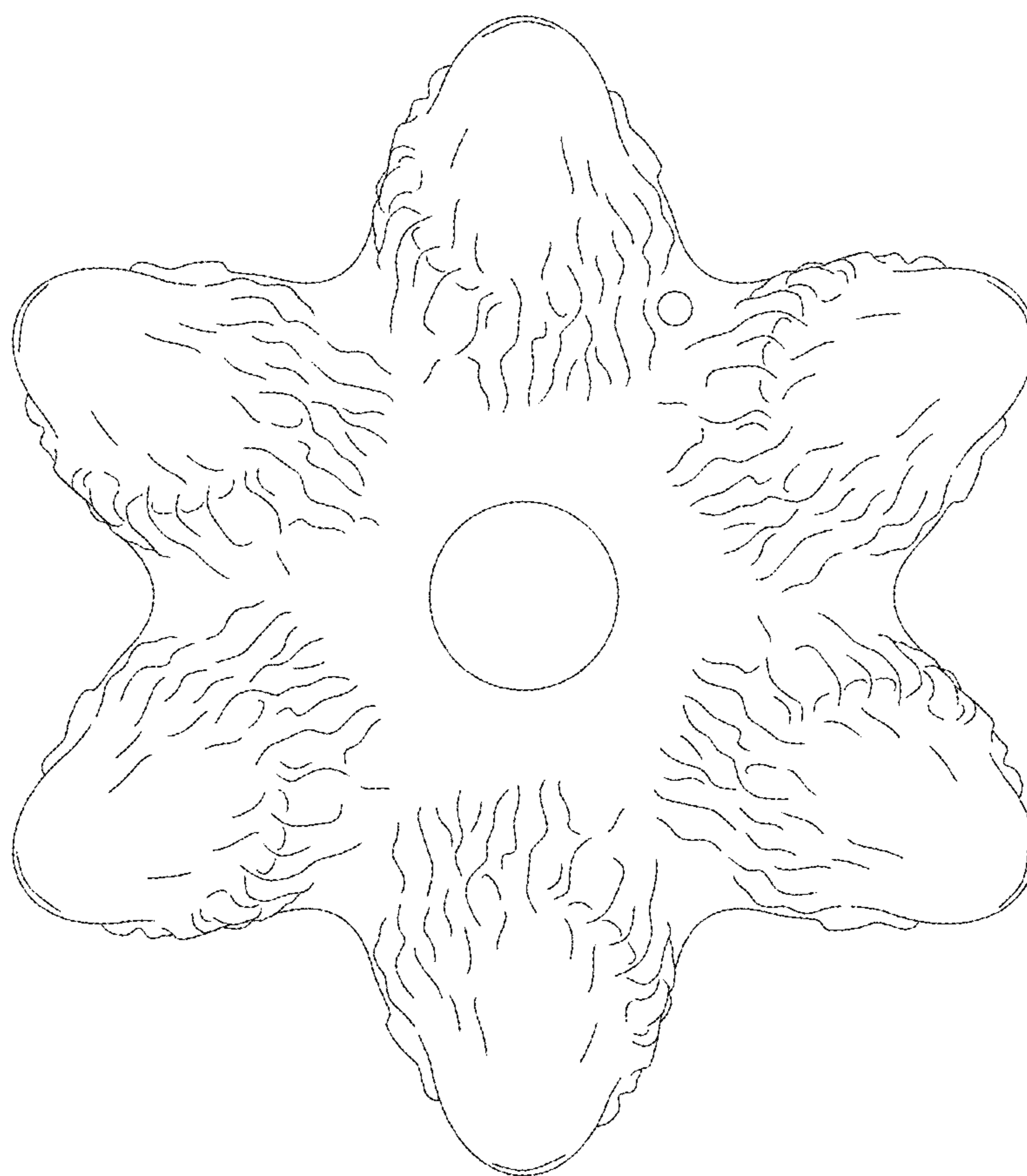

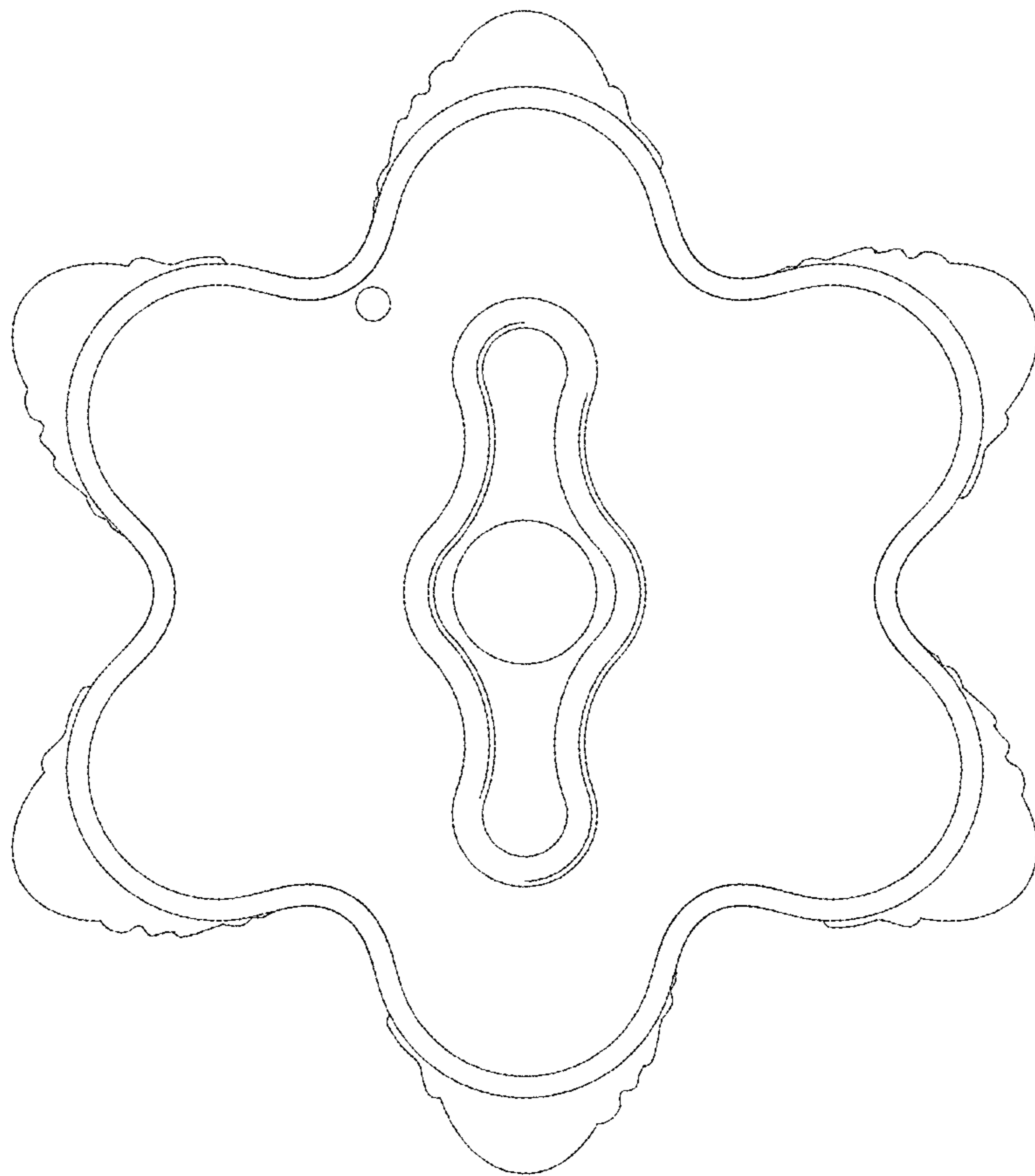

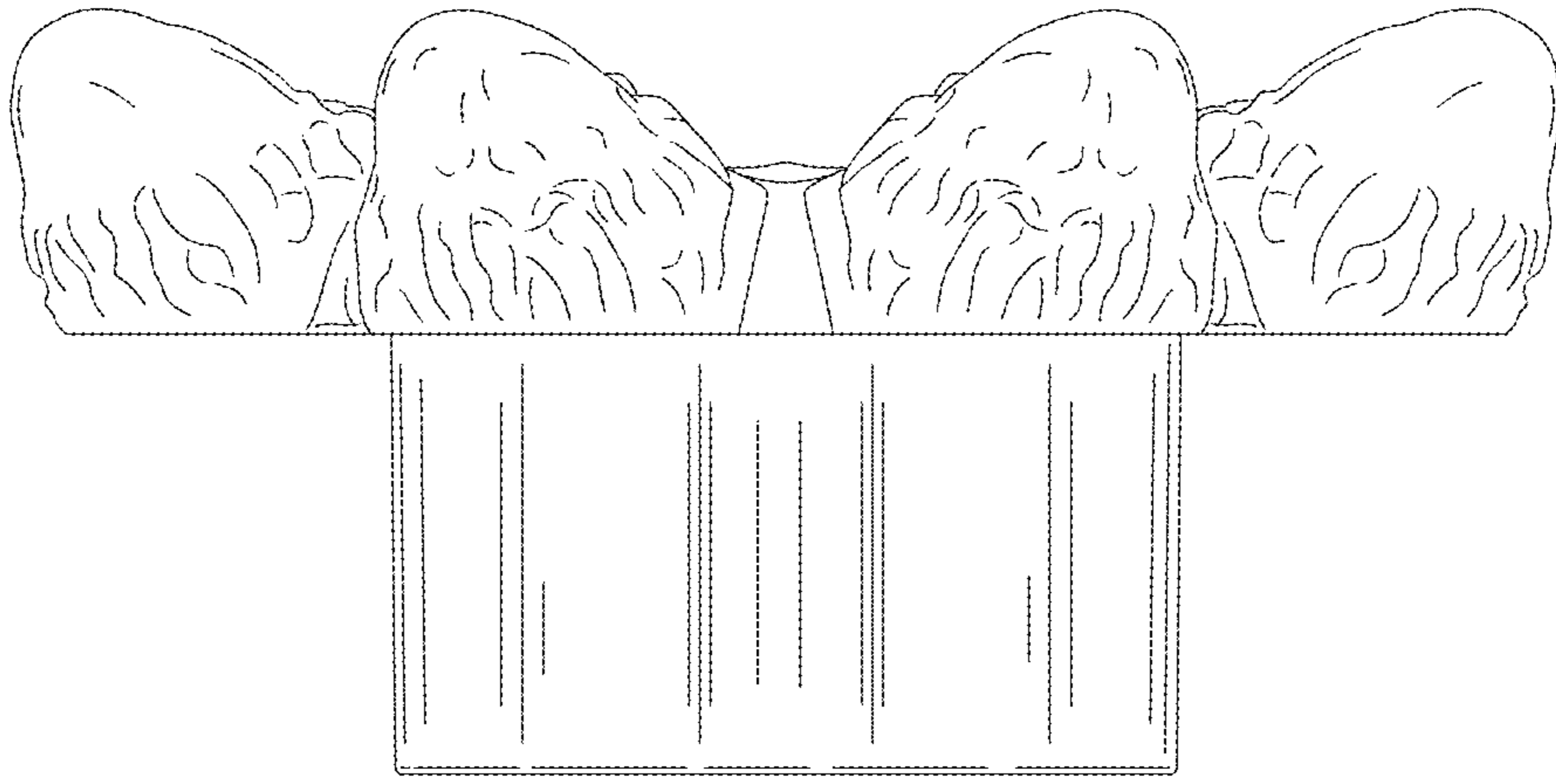

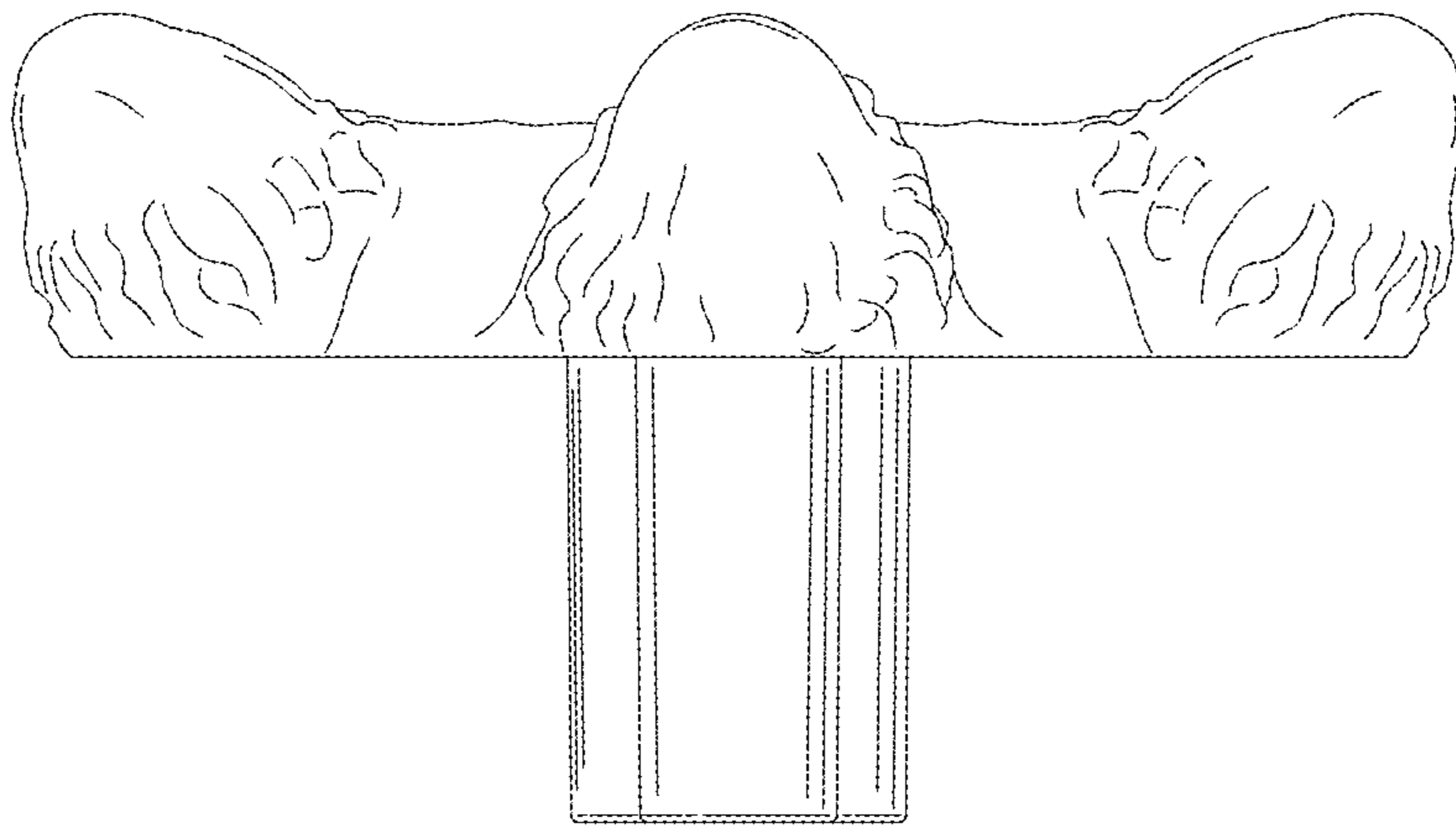
