(57) **CLAIM**

The ornamental design for a luck horseshoe, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of one embodiment of a luck horseshoe showing my new design.

FIG. 2 is a top elevation view of the embodiment of the luck horseshoe of FIG. 1.

FIG. 3 is front elevation view of the embodiment of the luck horseshoe of FIG. 1.

FIG. 4 is a left side elevation view of the embodiment of the luck horseshoe of FIG. 1.

FIG. 5 is a right side elevation view of the embodiment of the luck horseshoe of FIG. 1;

FIG. 6 is a bottom elevation view of one end of the embodiment of the luck horseshoe of FIG. 1; and,

FIG. 7 is a rear elevation view of one end of the embodiment of the luck horseshoe of FIG. 1.

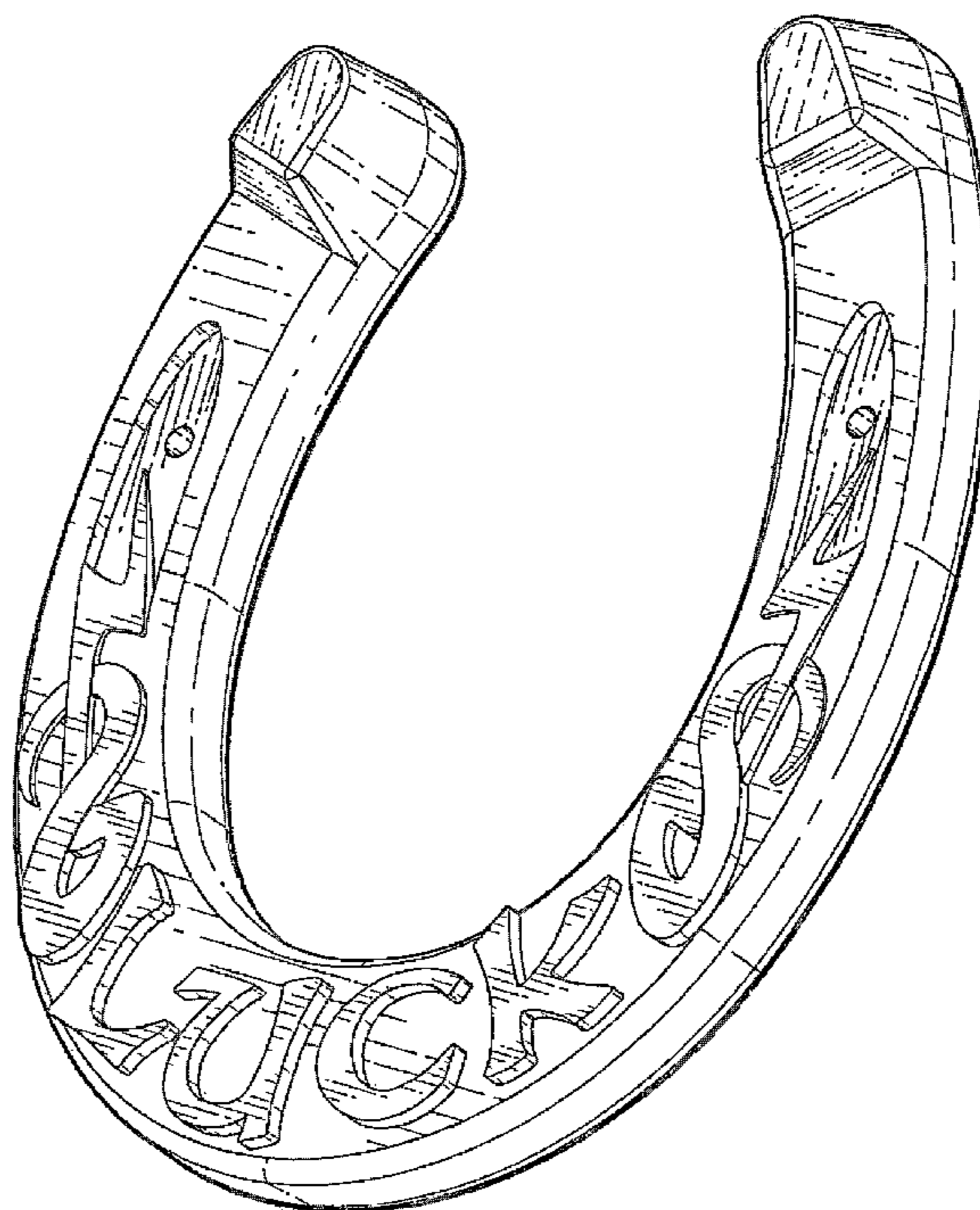

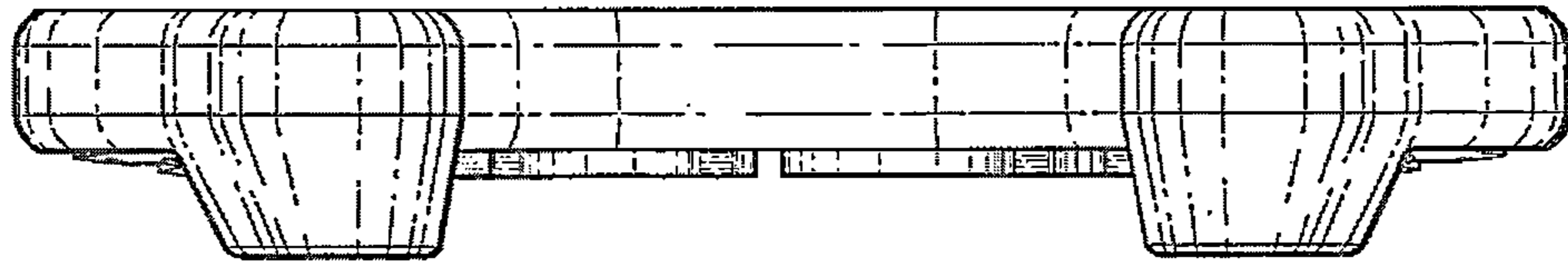

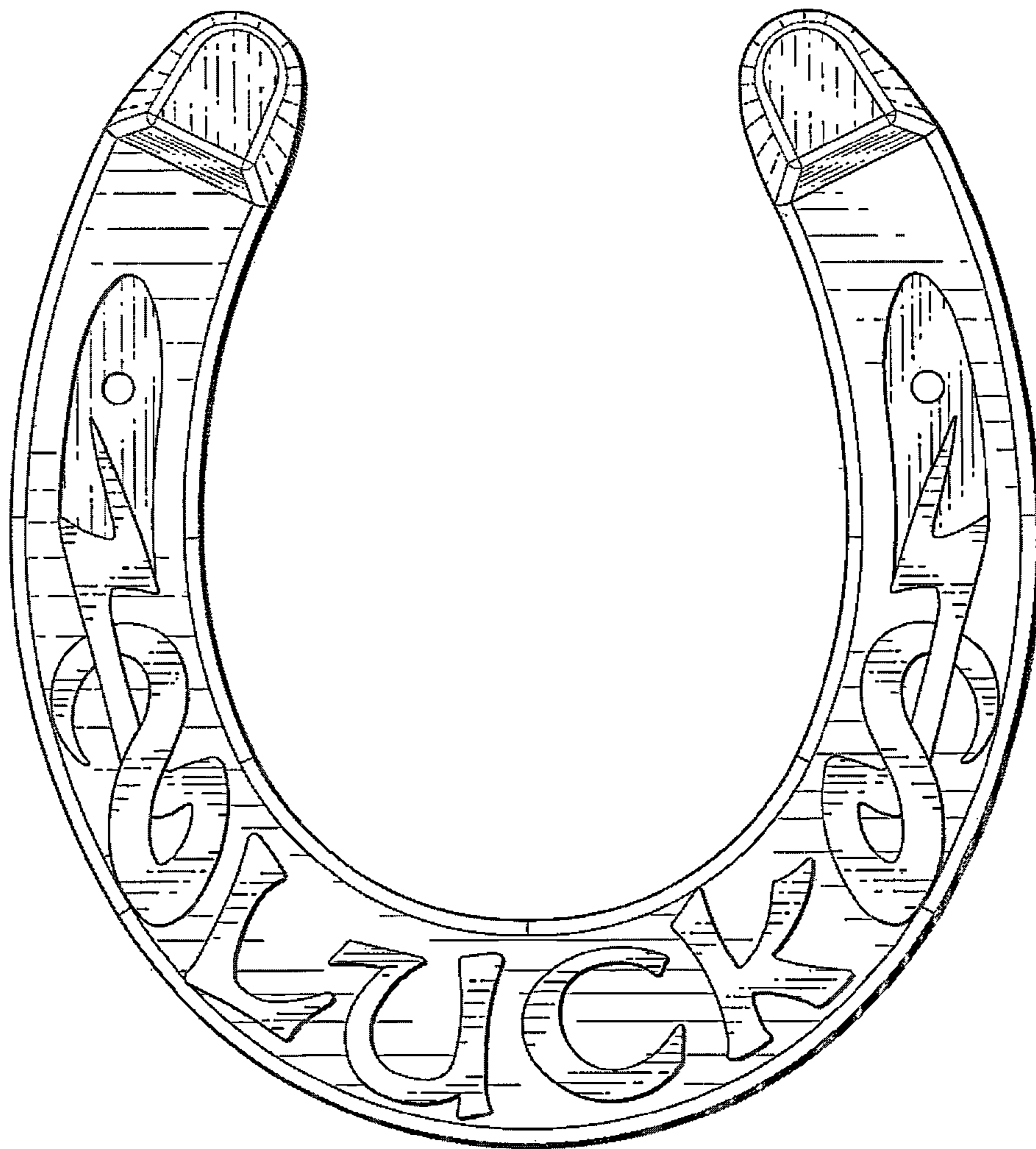

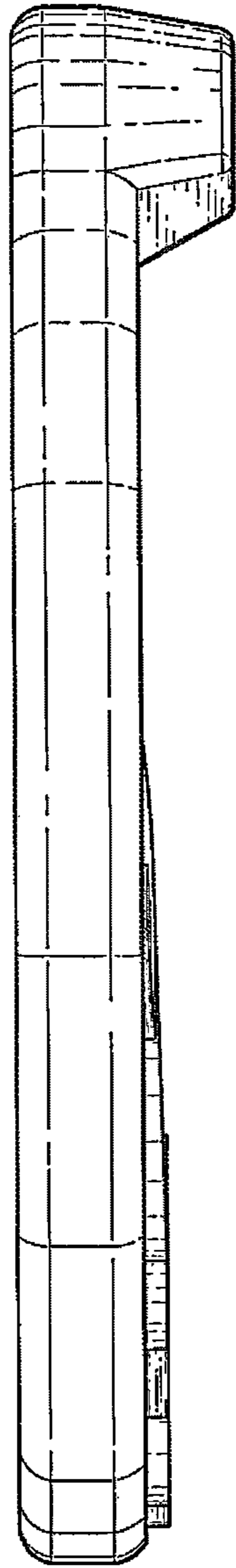

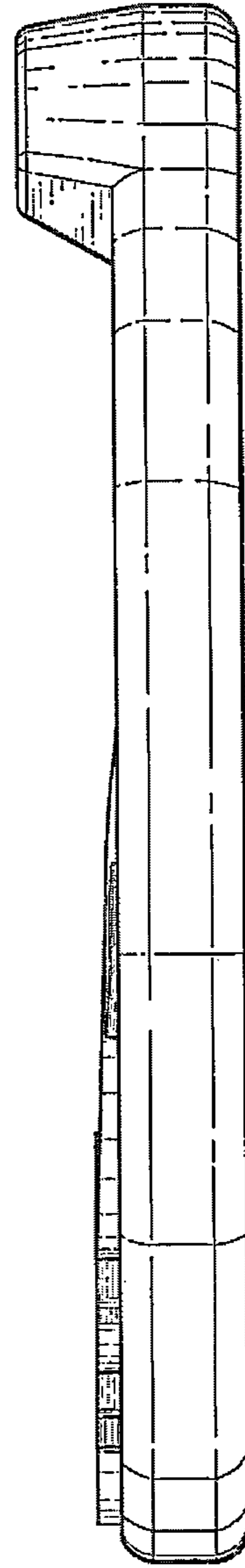

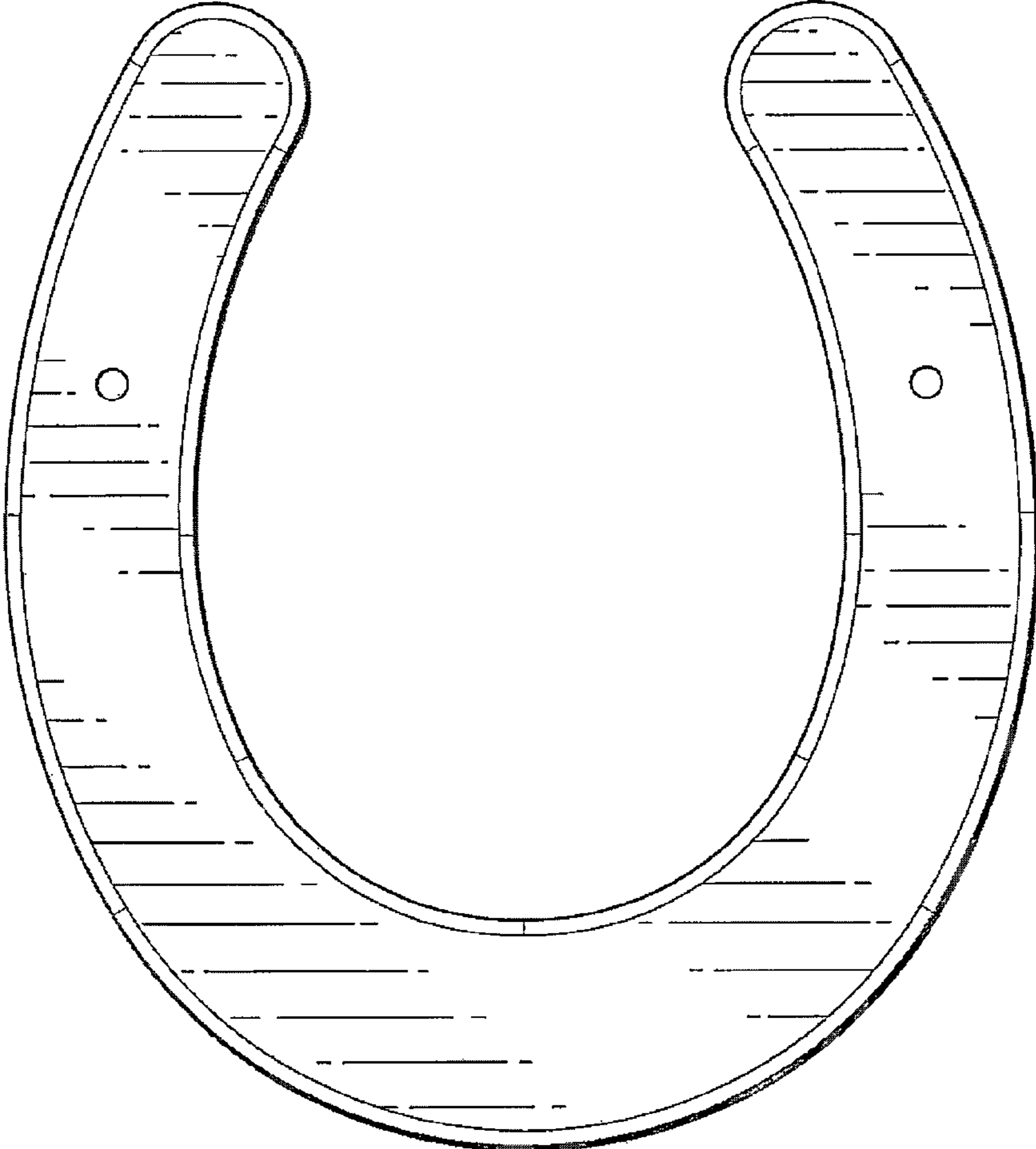

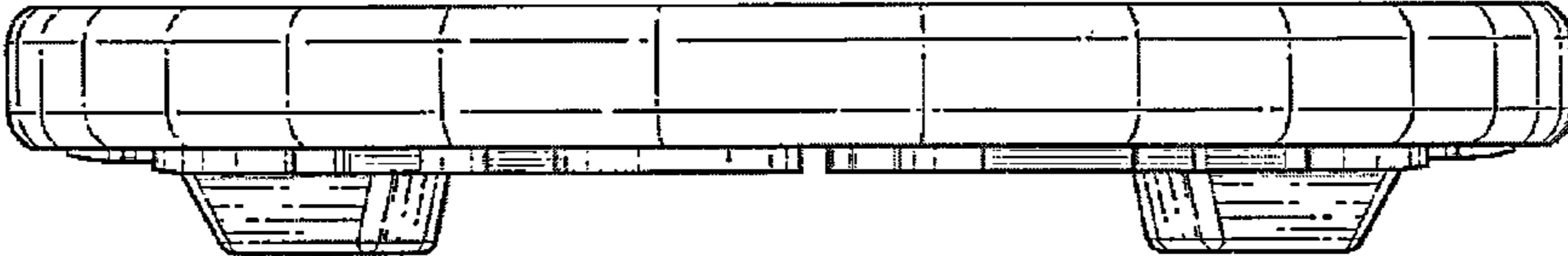
