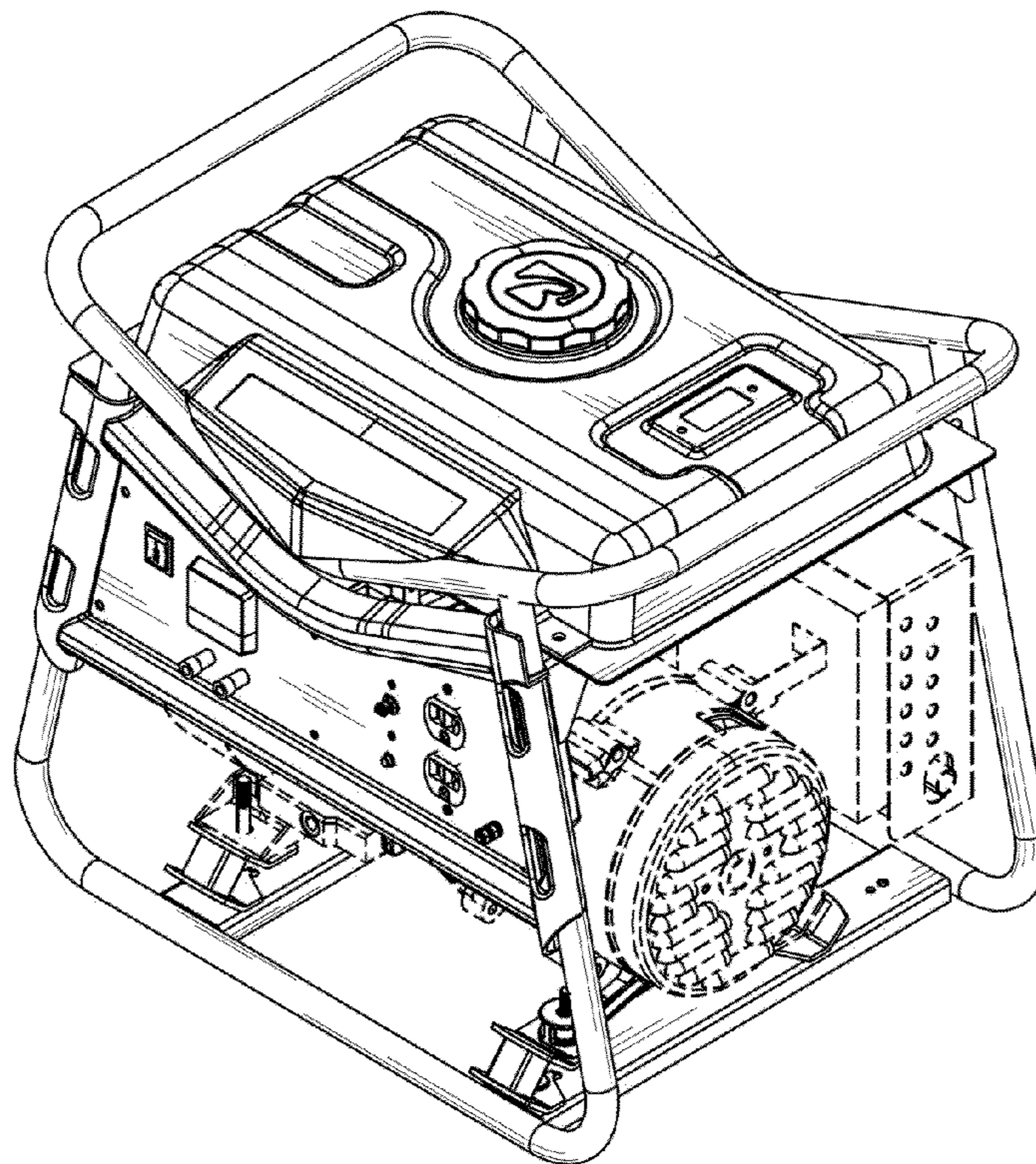
The ornamental design for portable generator, as shown and described.

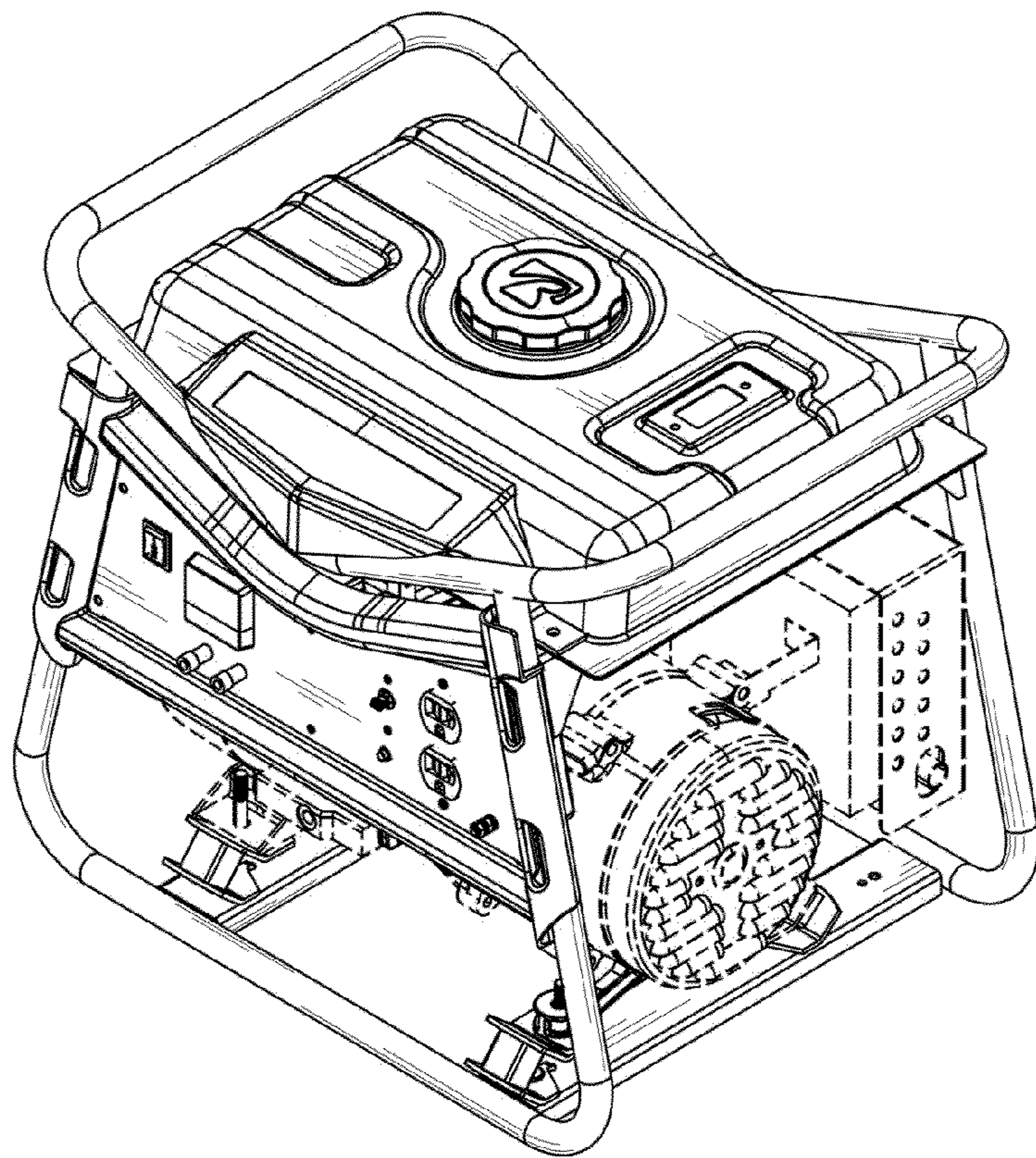

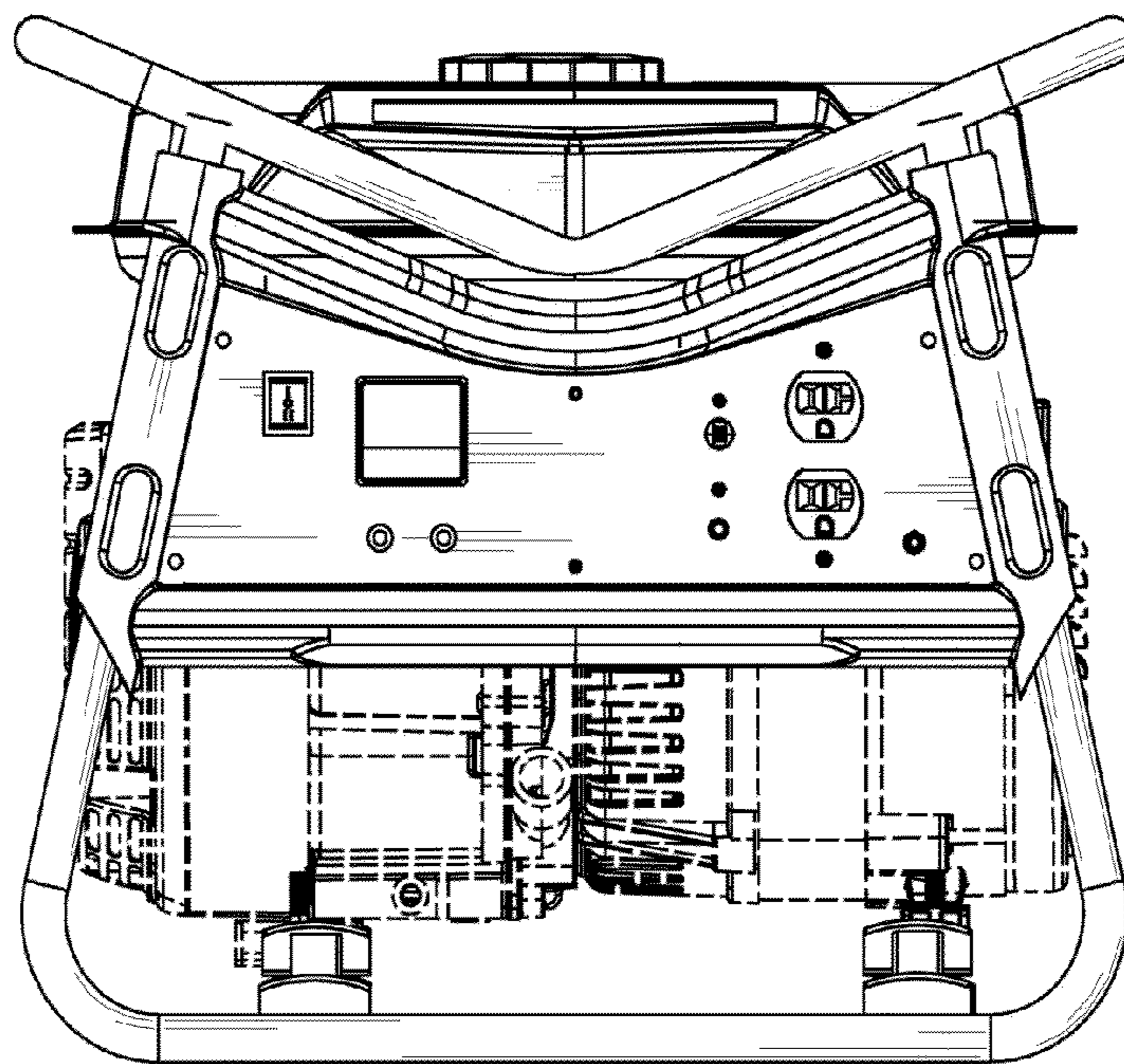

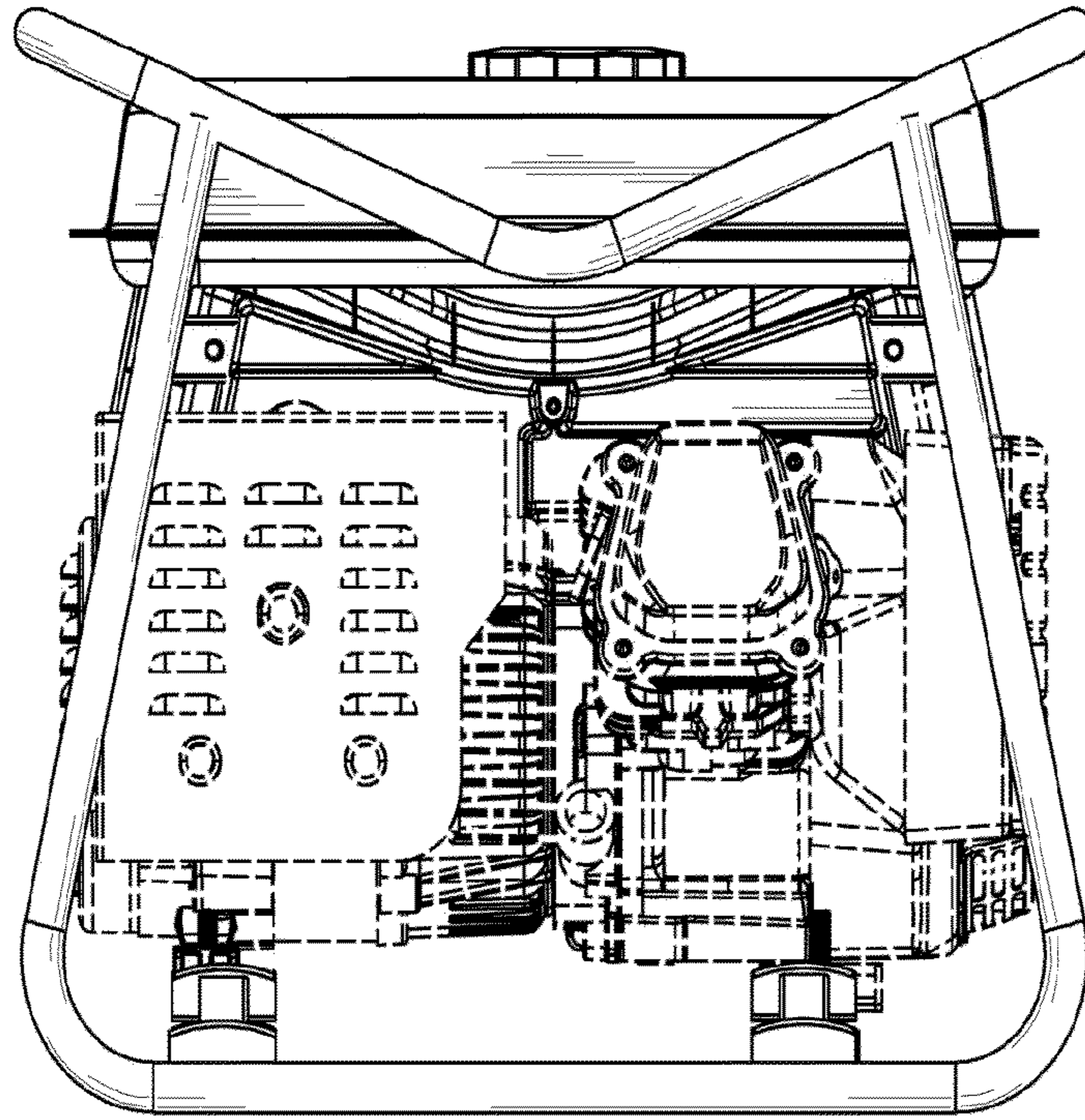

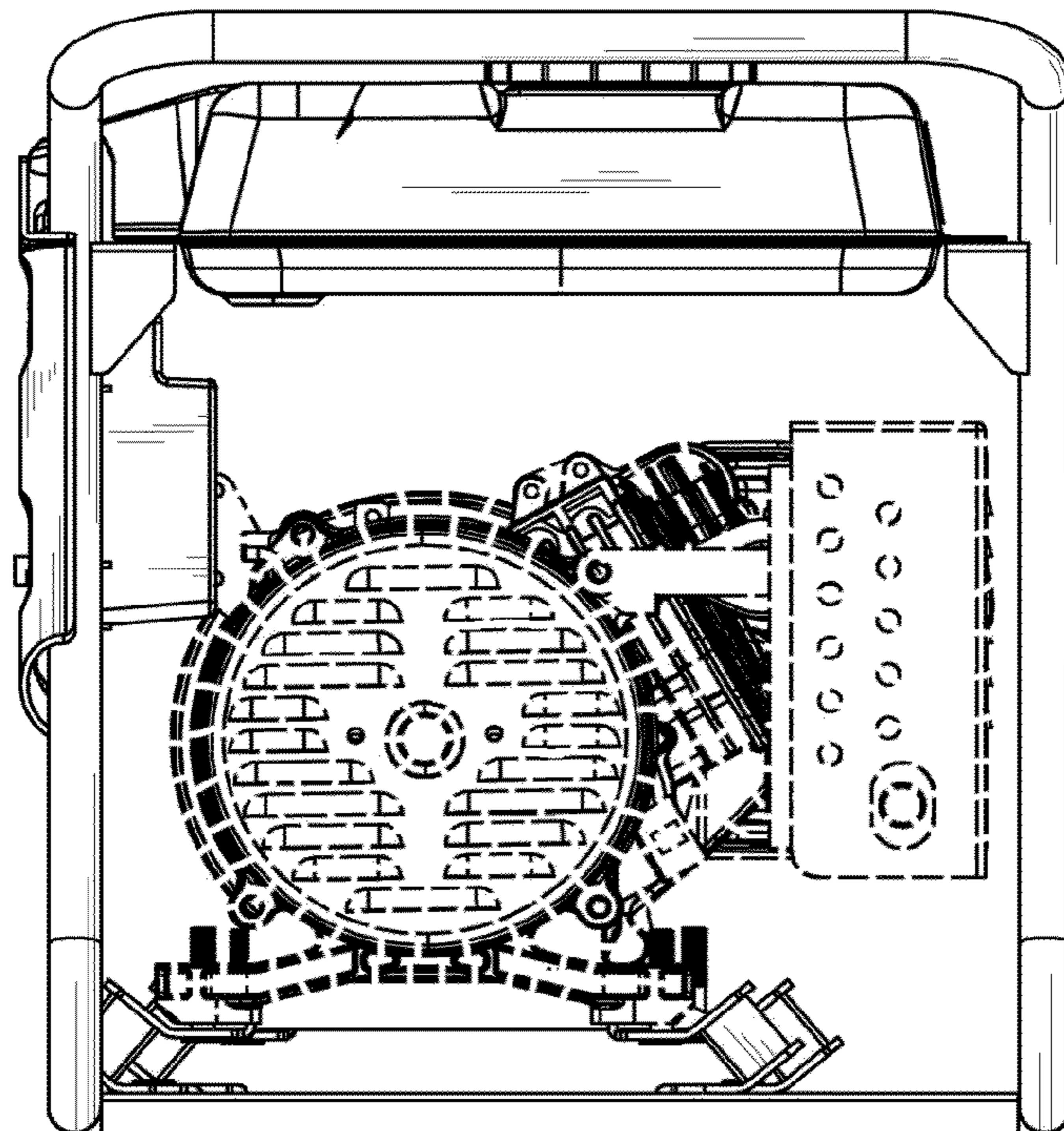

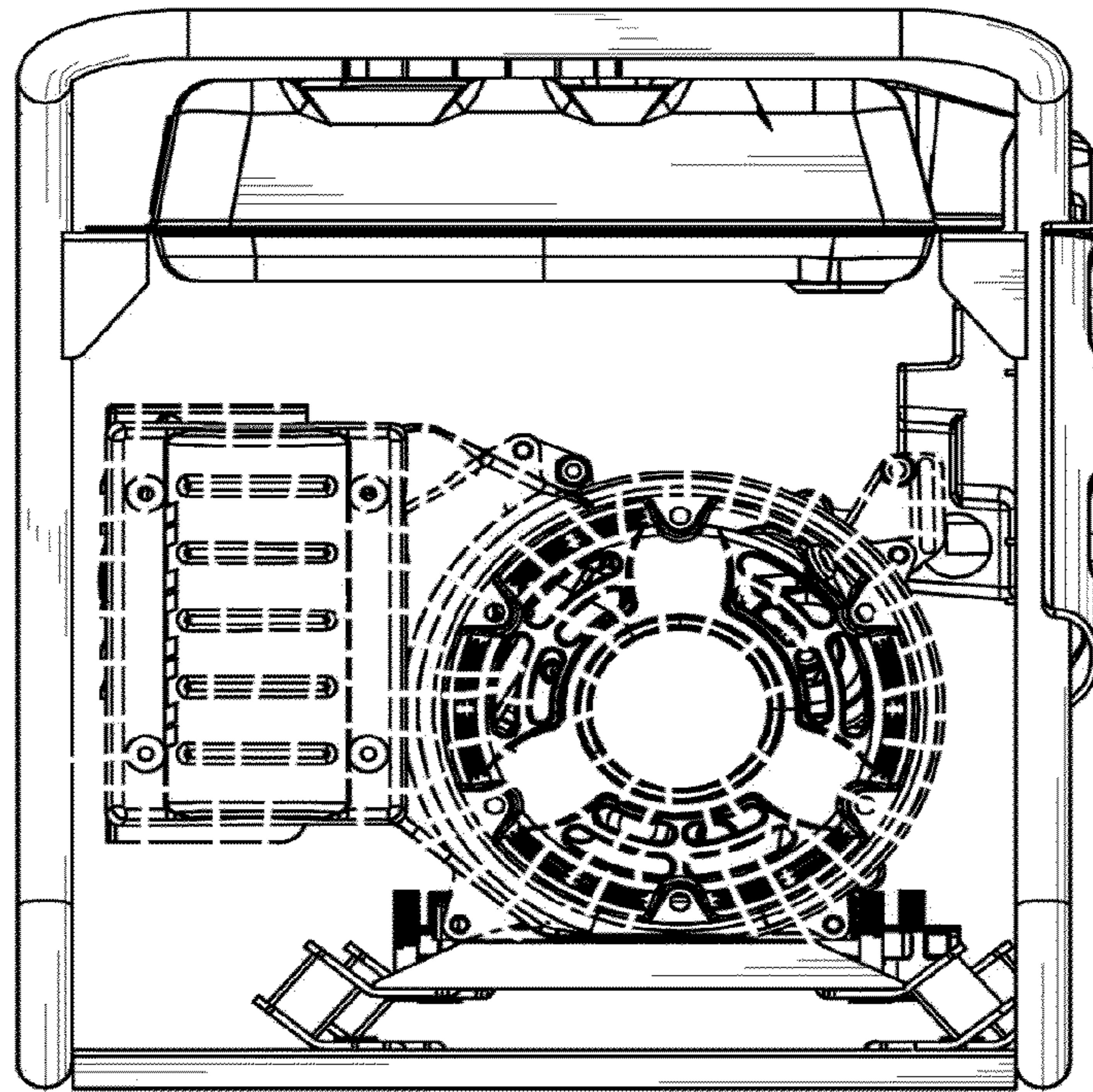

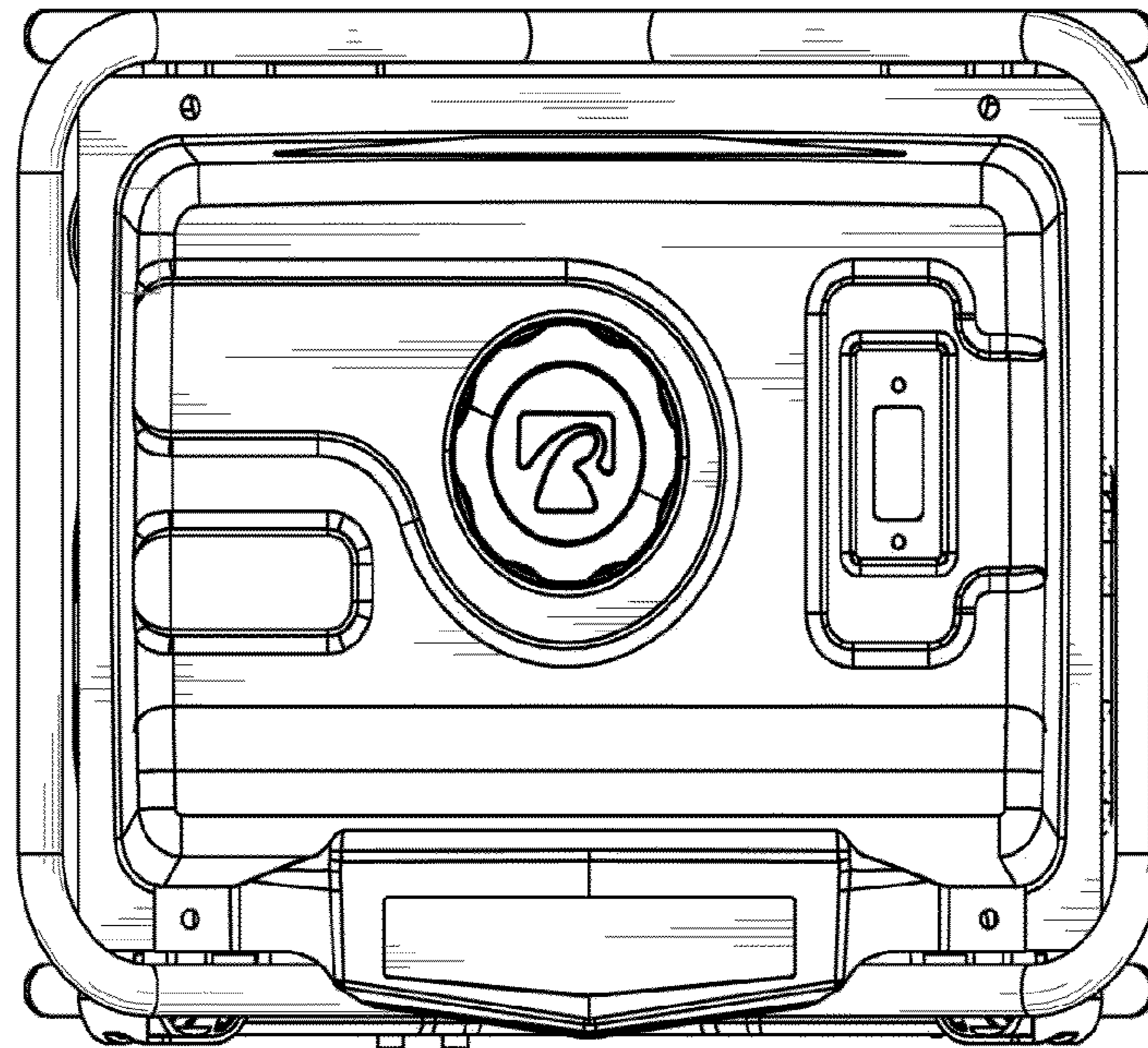
