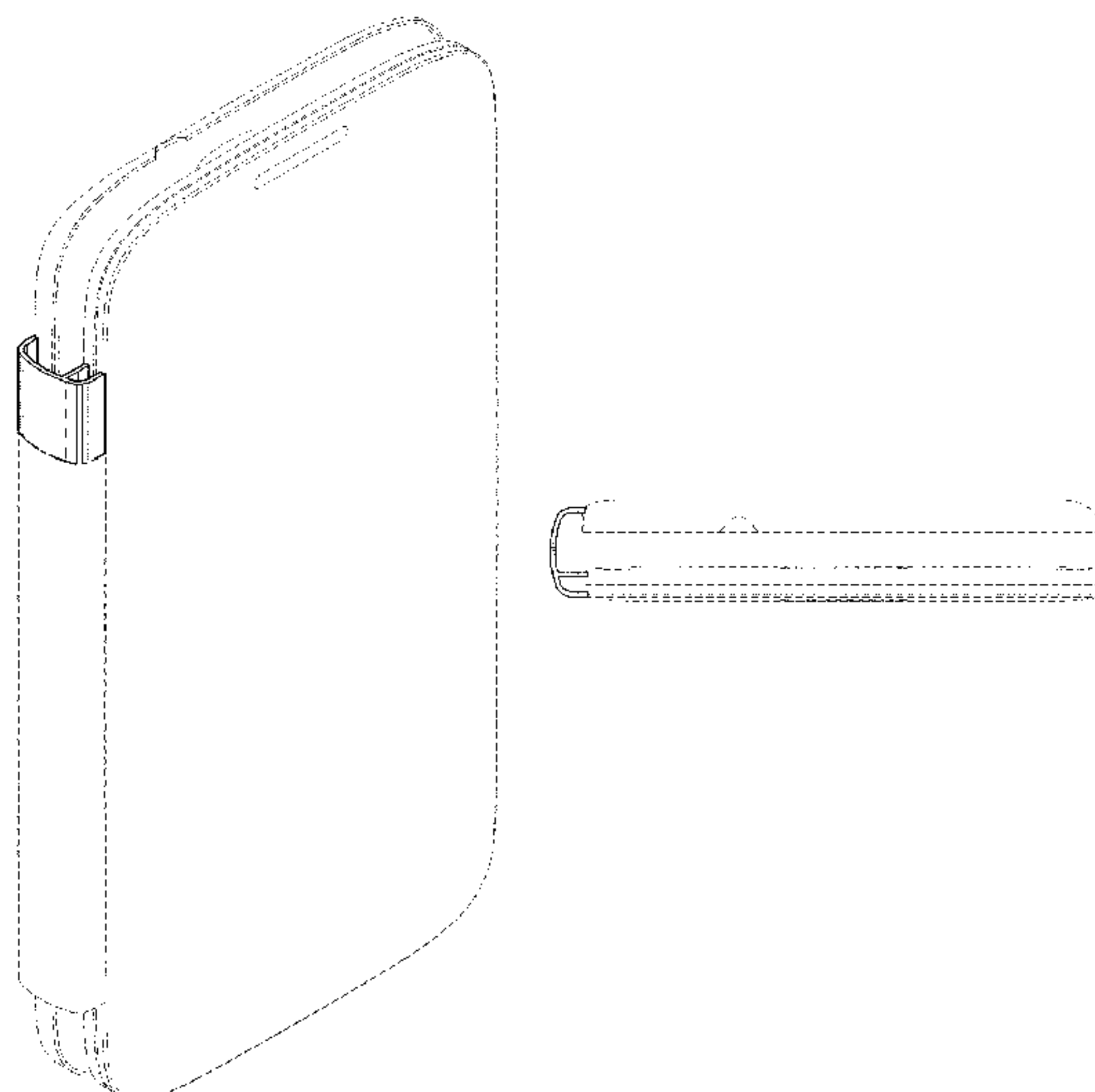
CLAIM

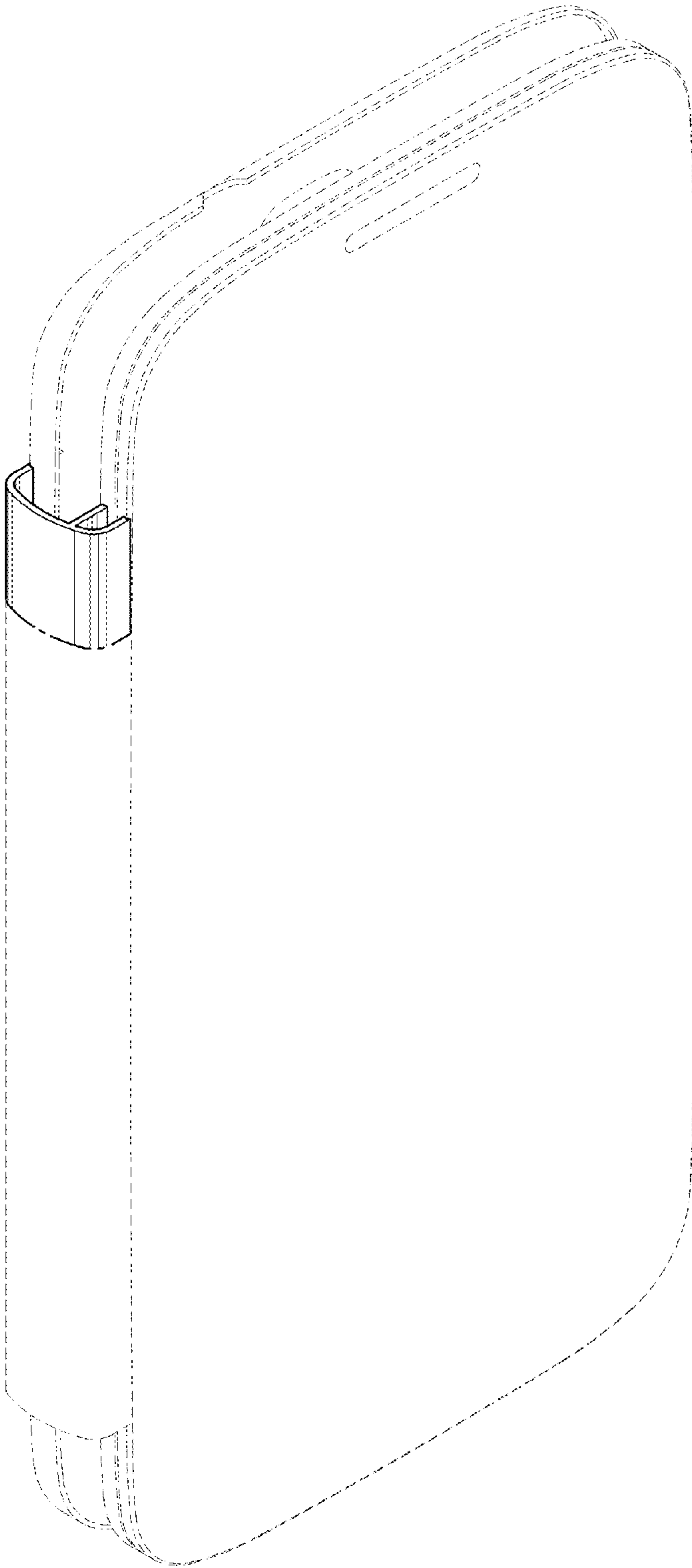

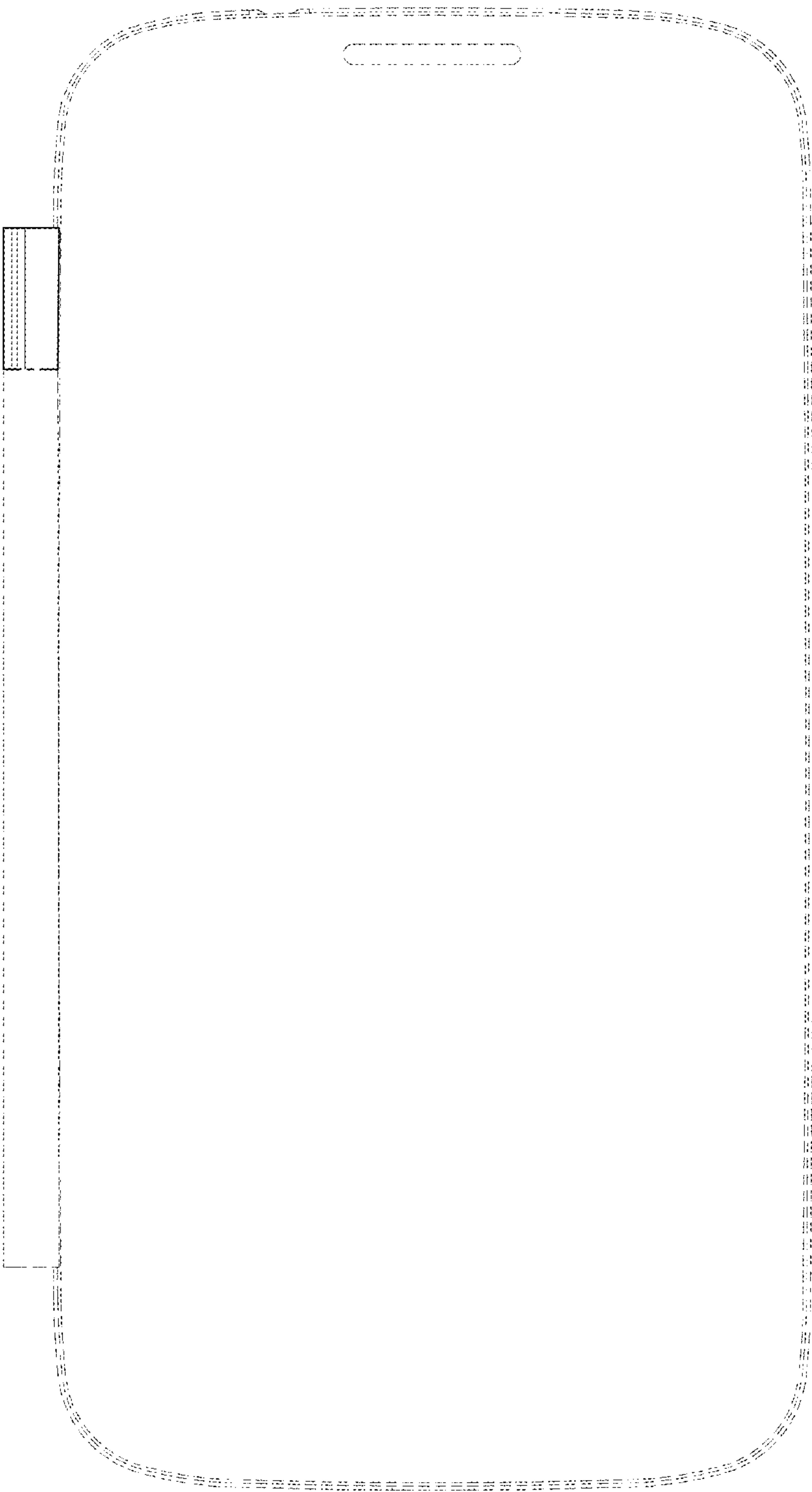

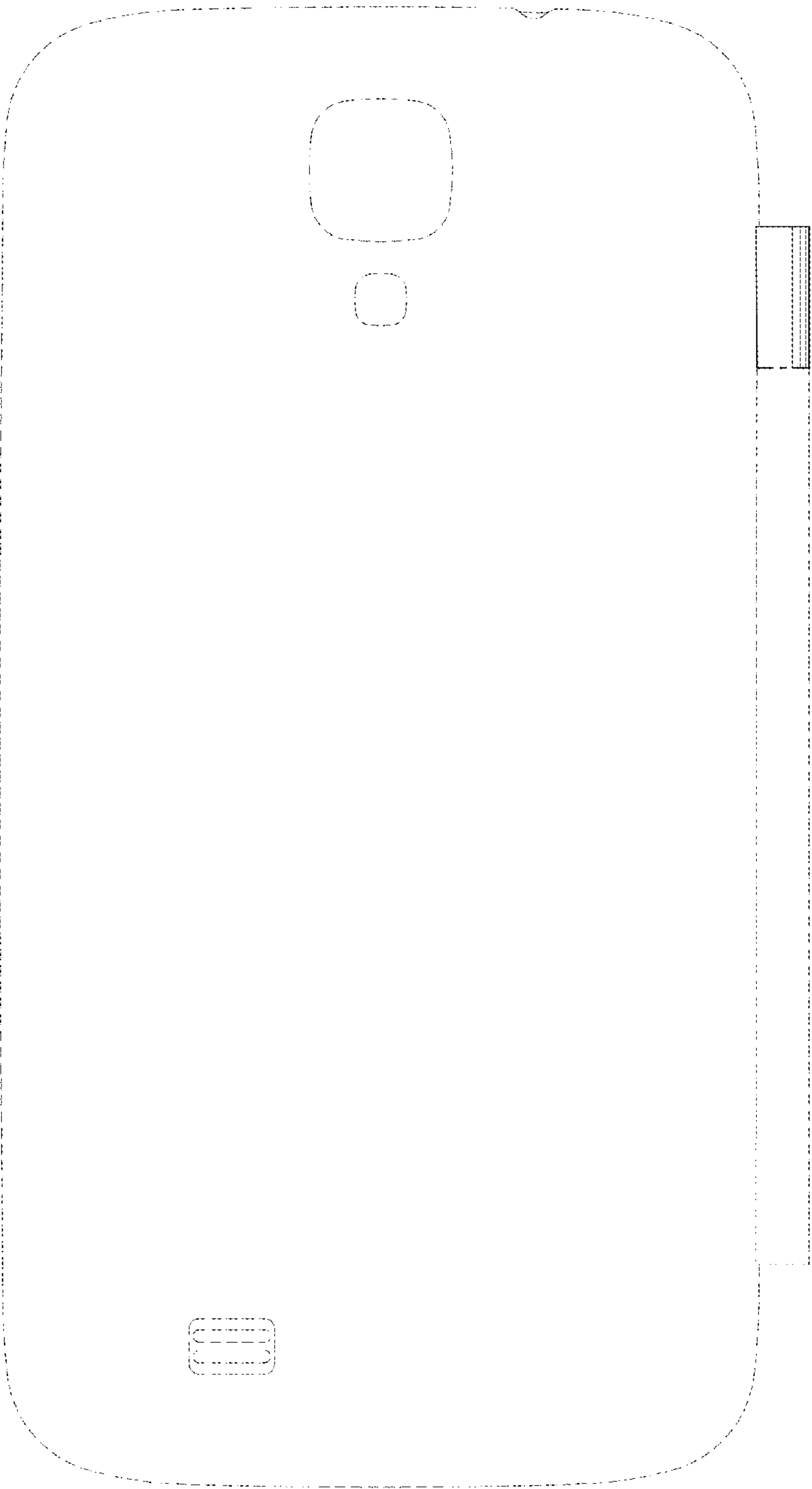

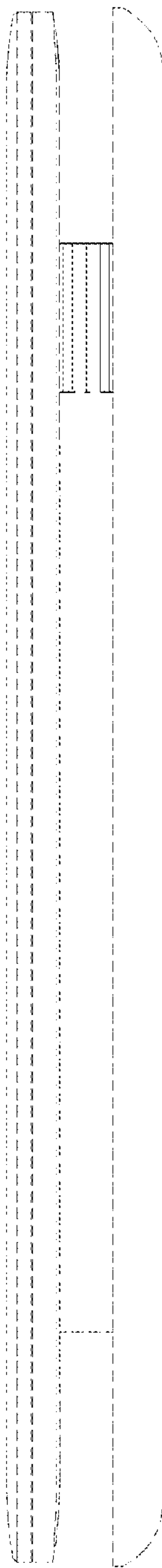

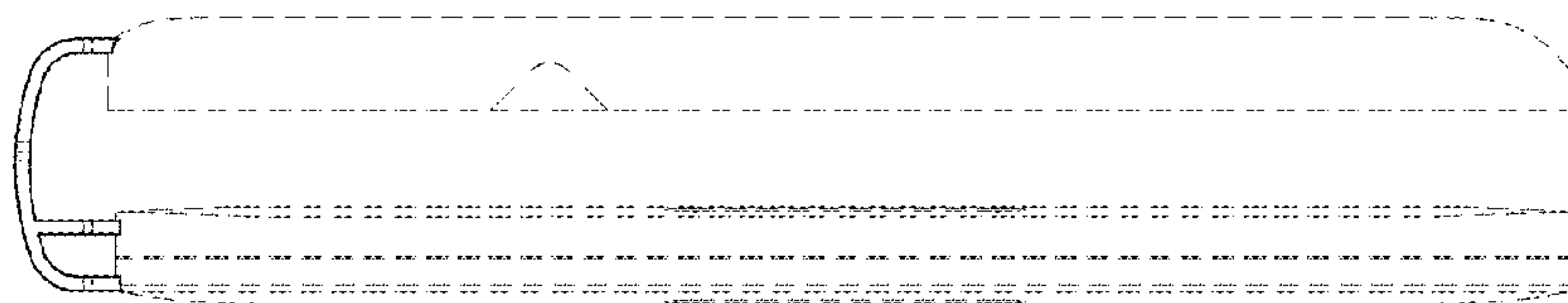

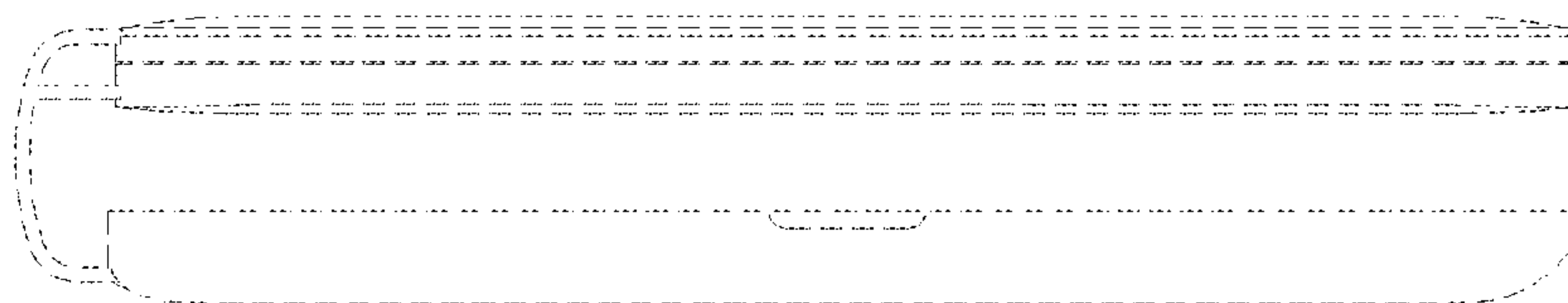

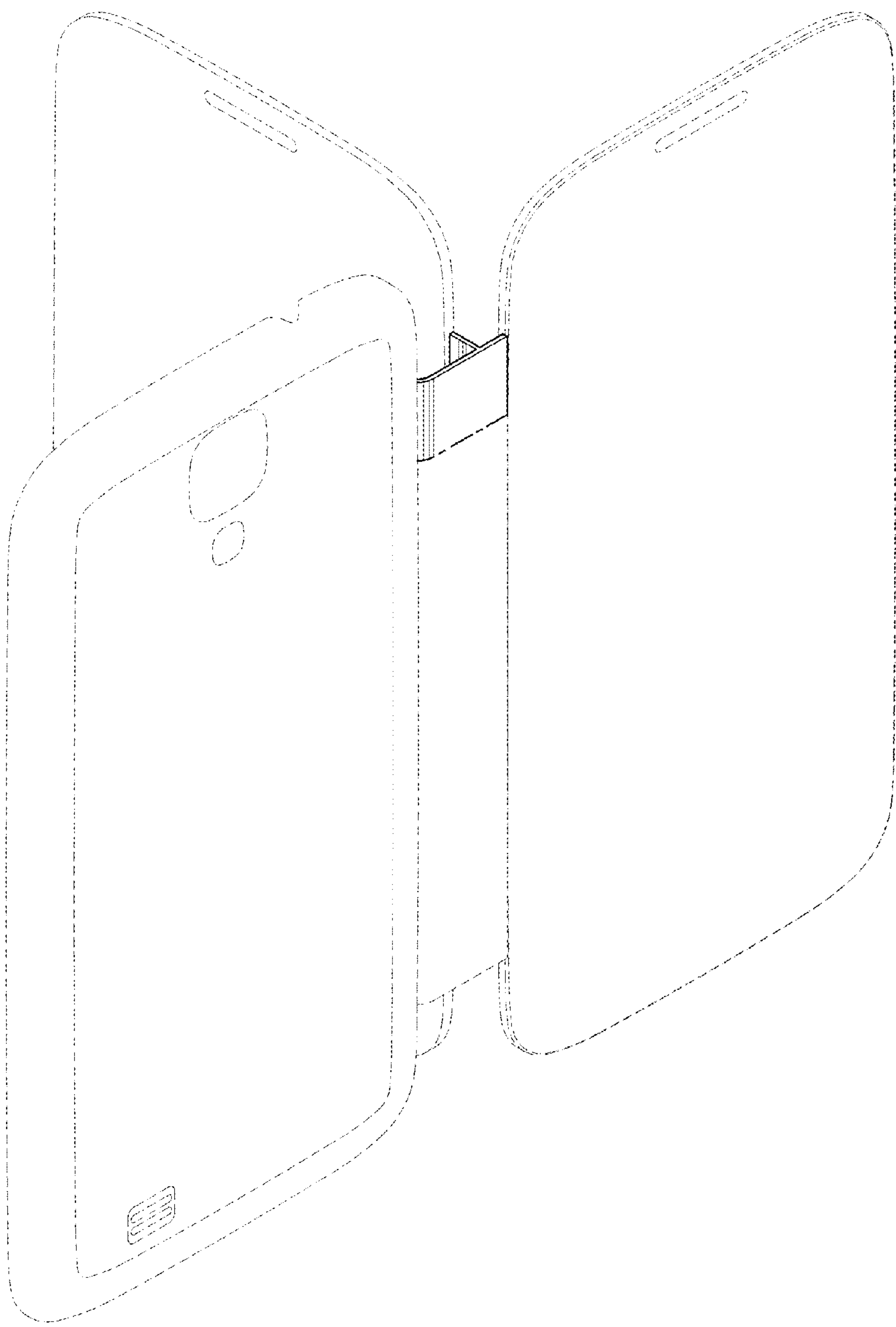
