FIG. 6 is another side view thereof; and,

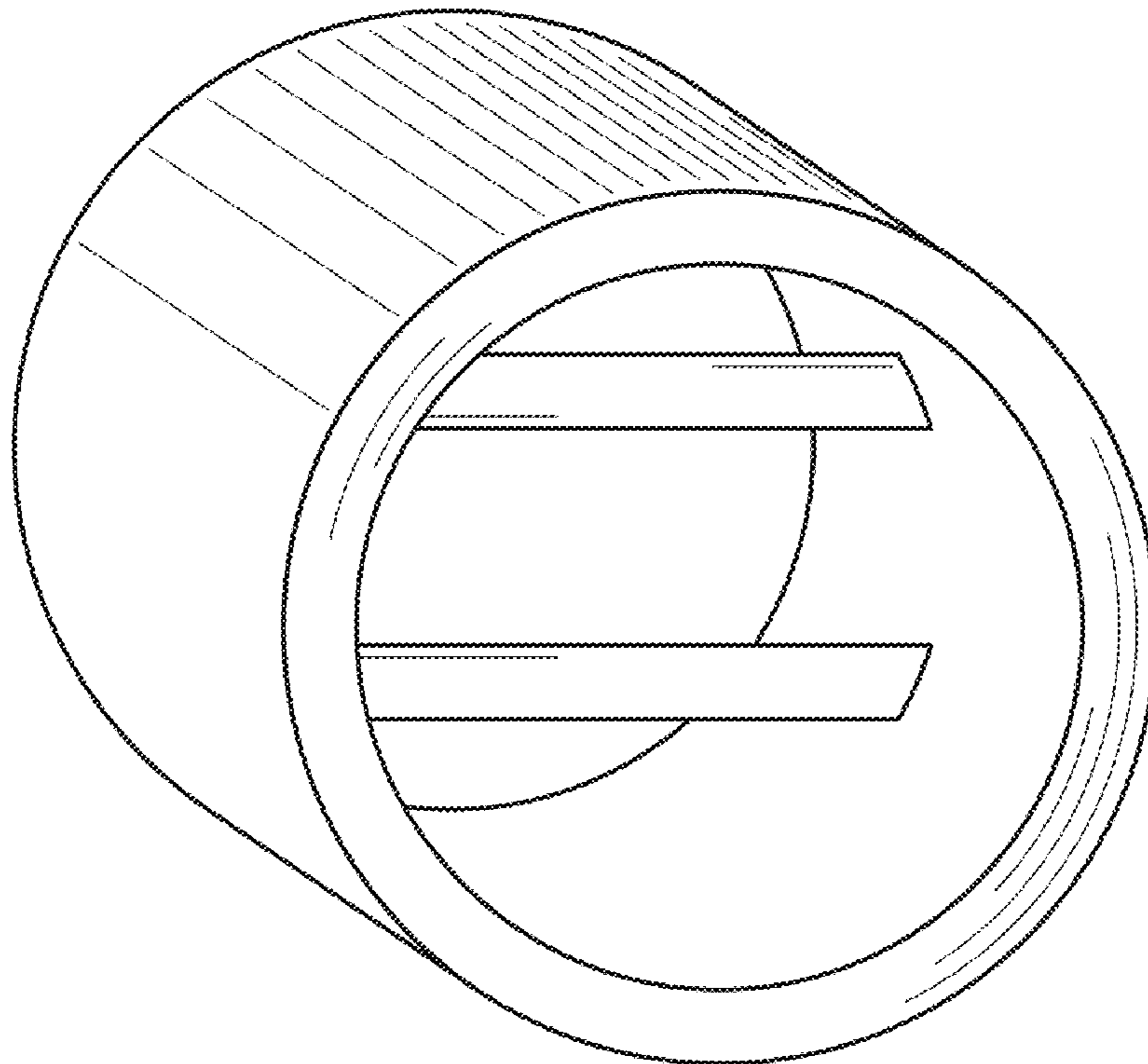
FIG. 7 is another side view thereof.

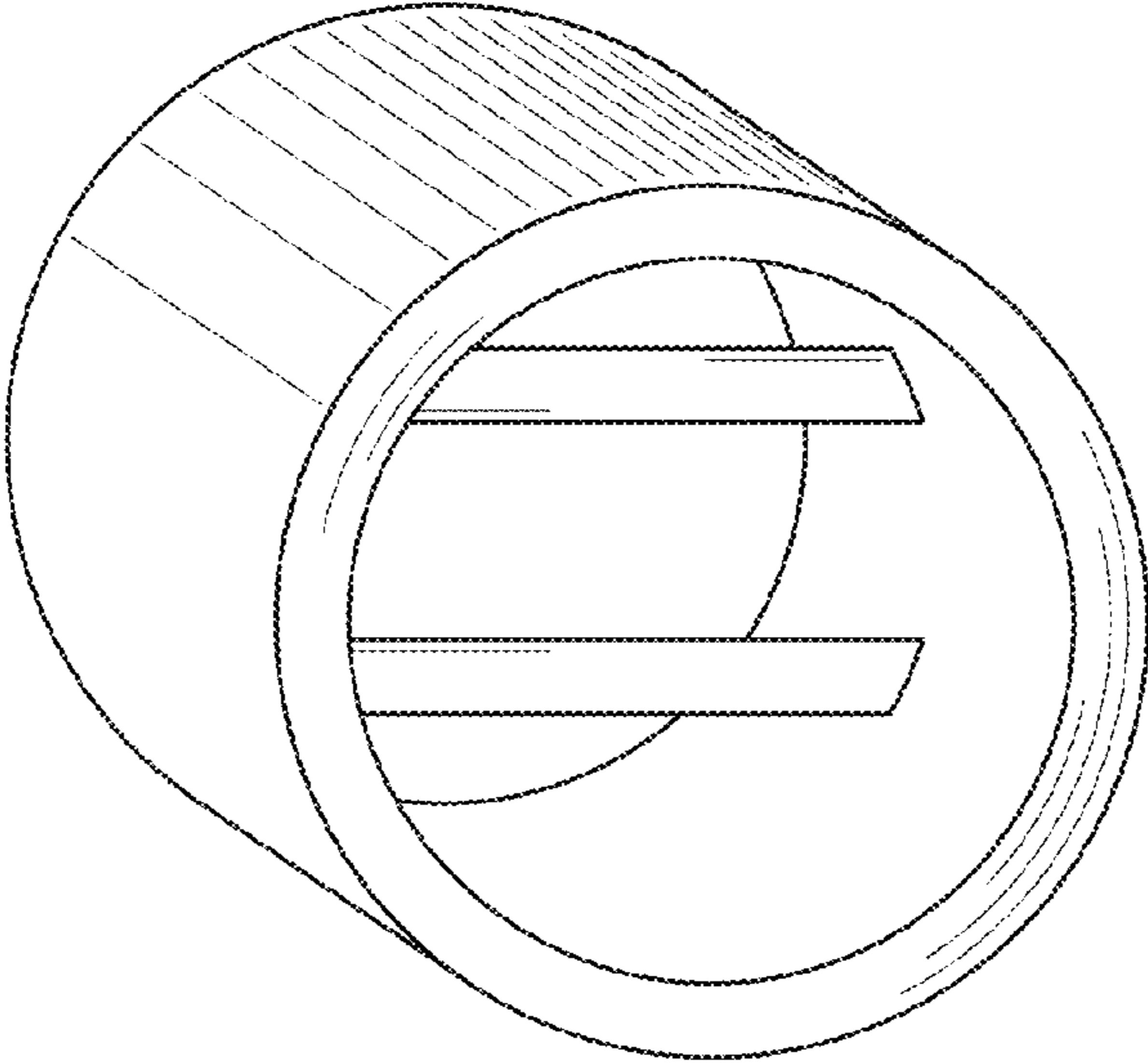

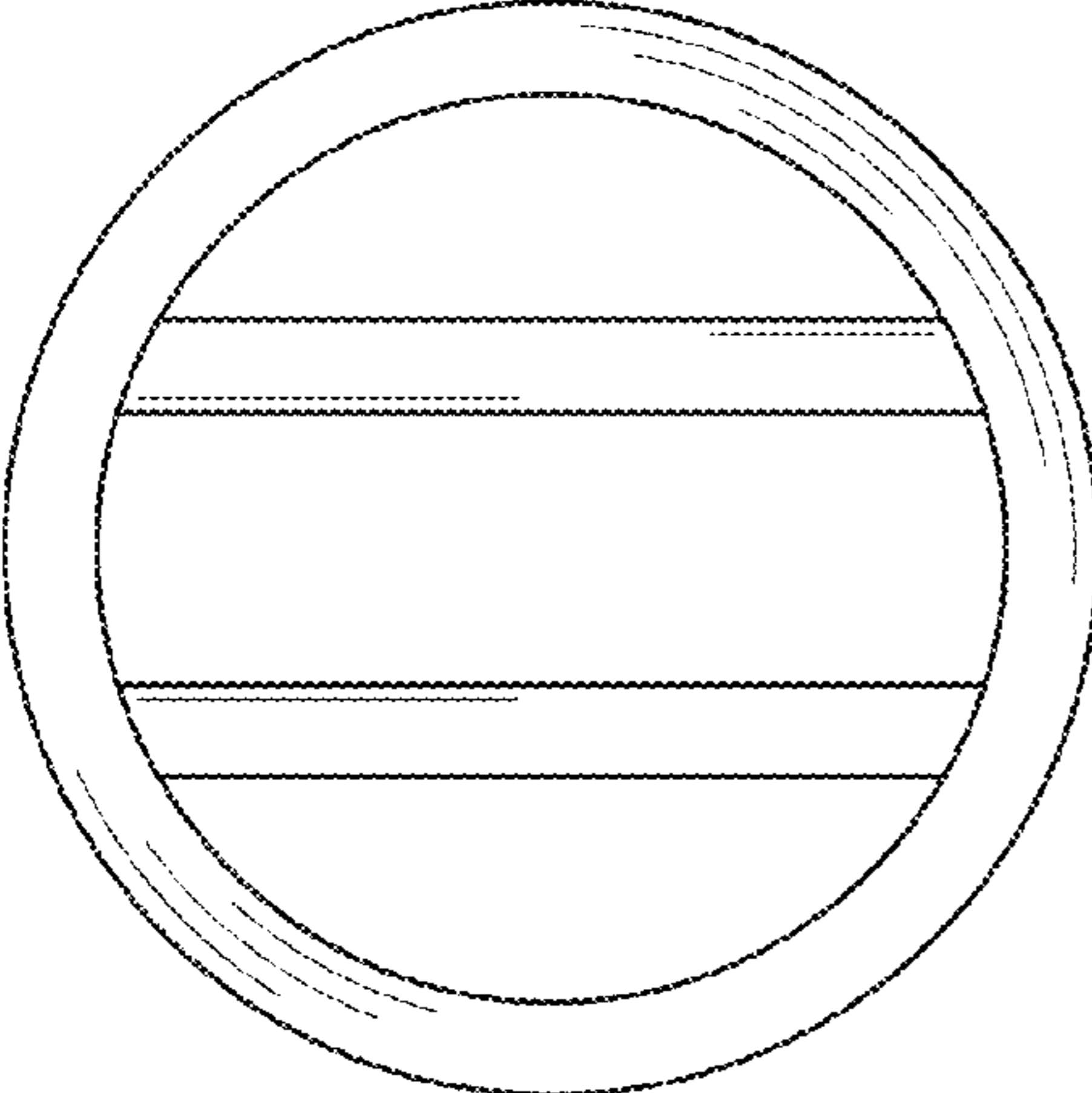

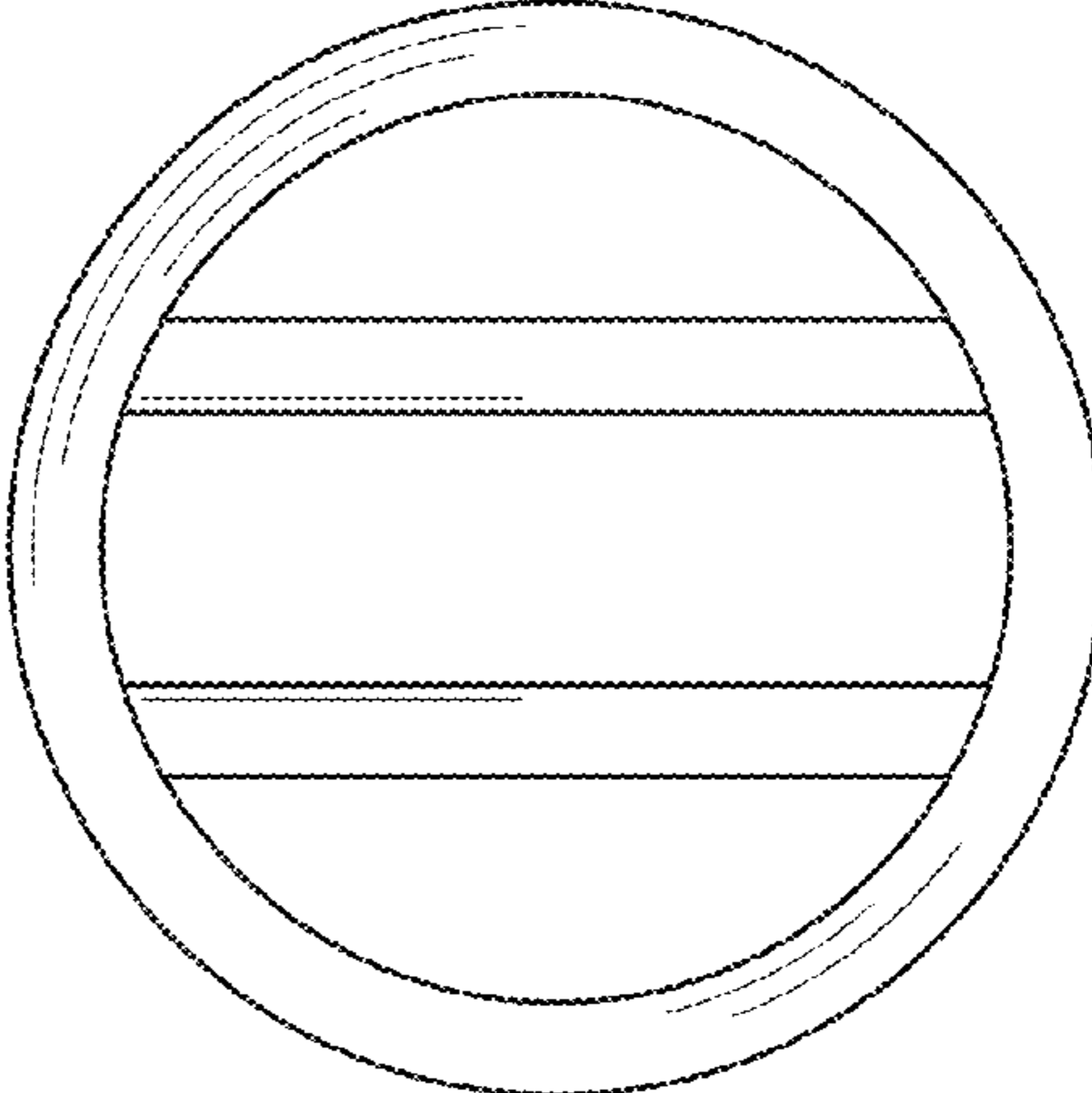

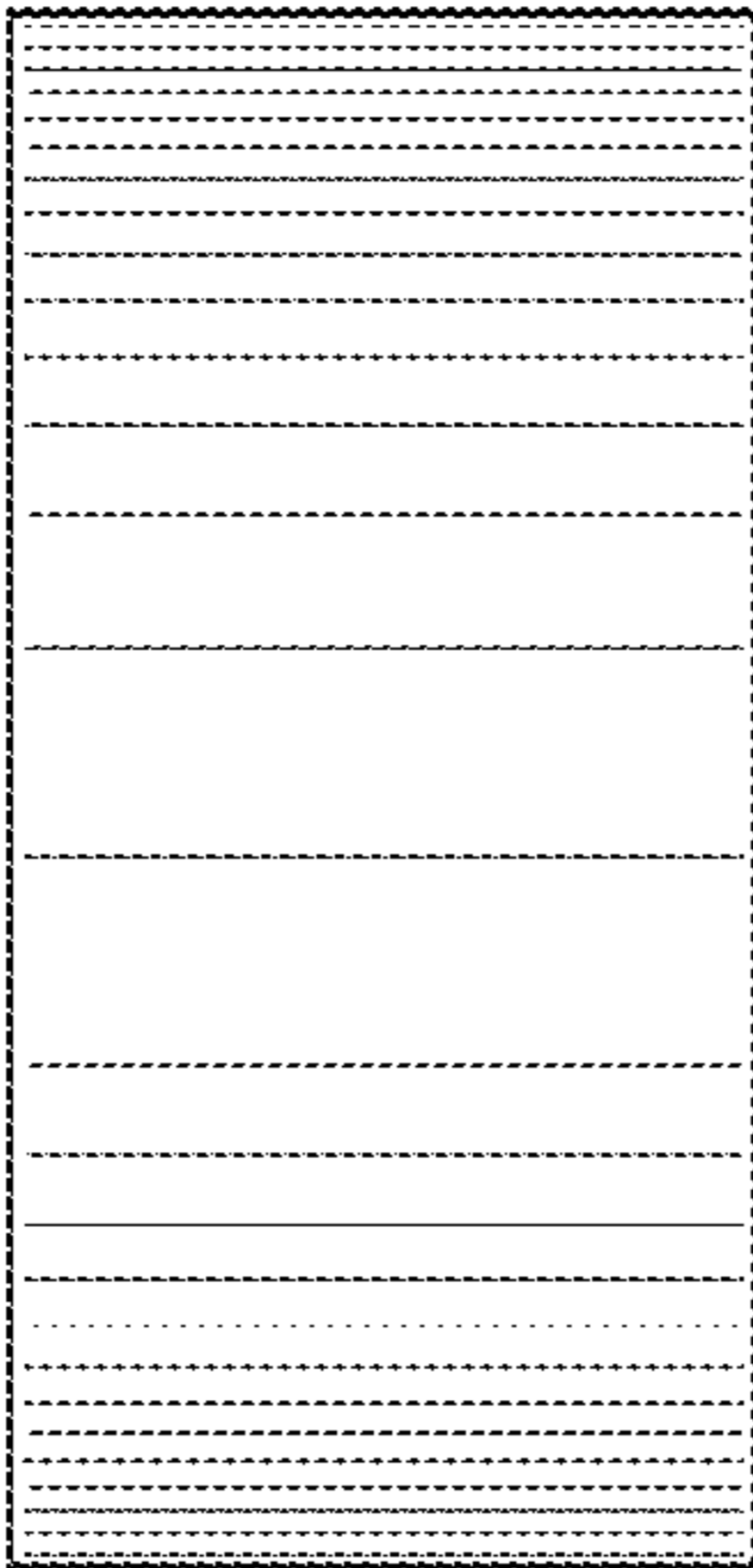

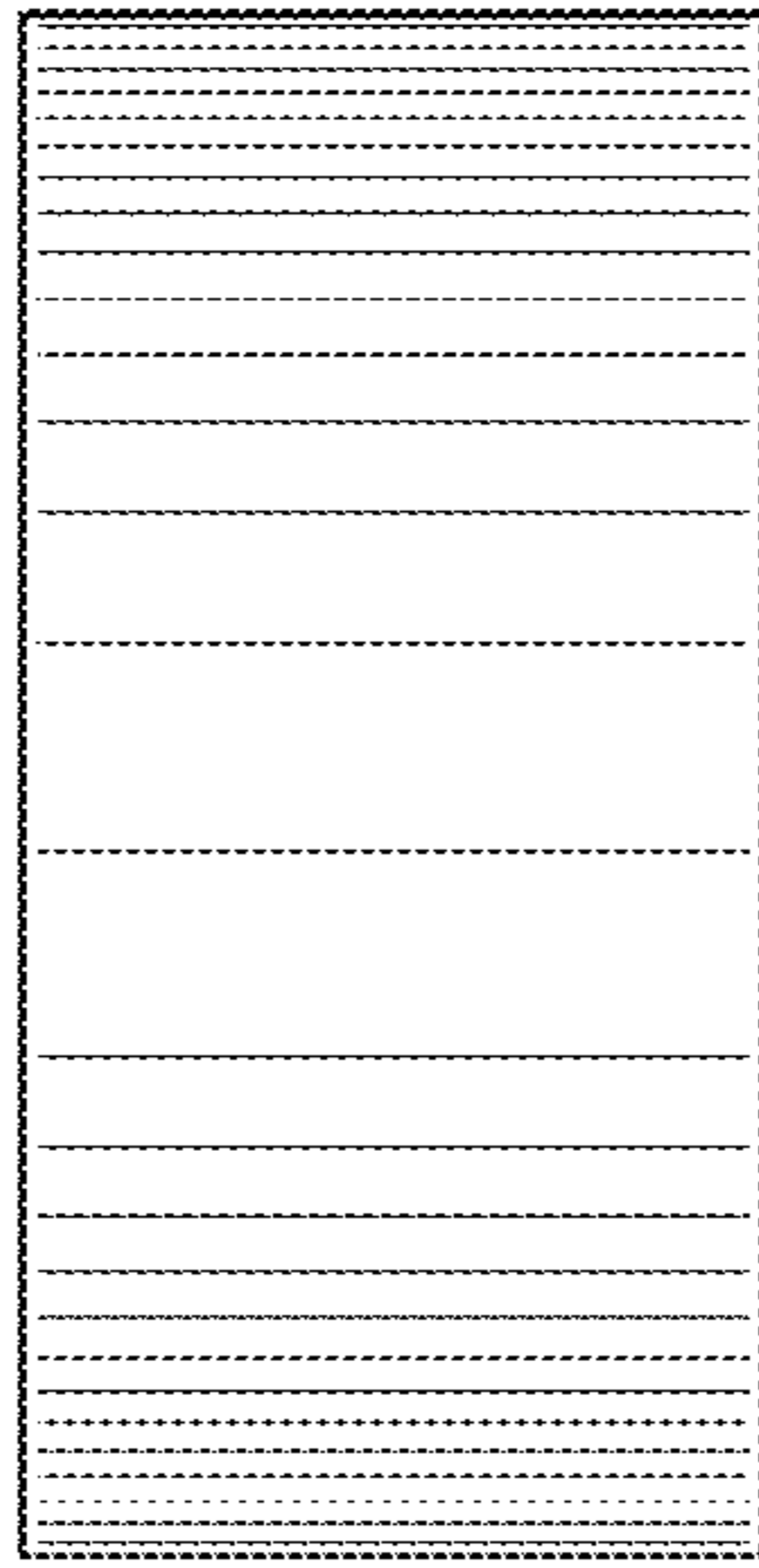

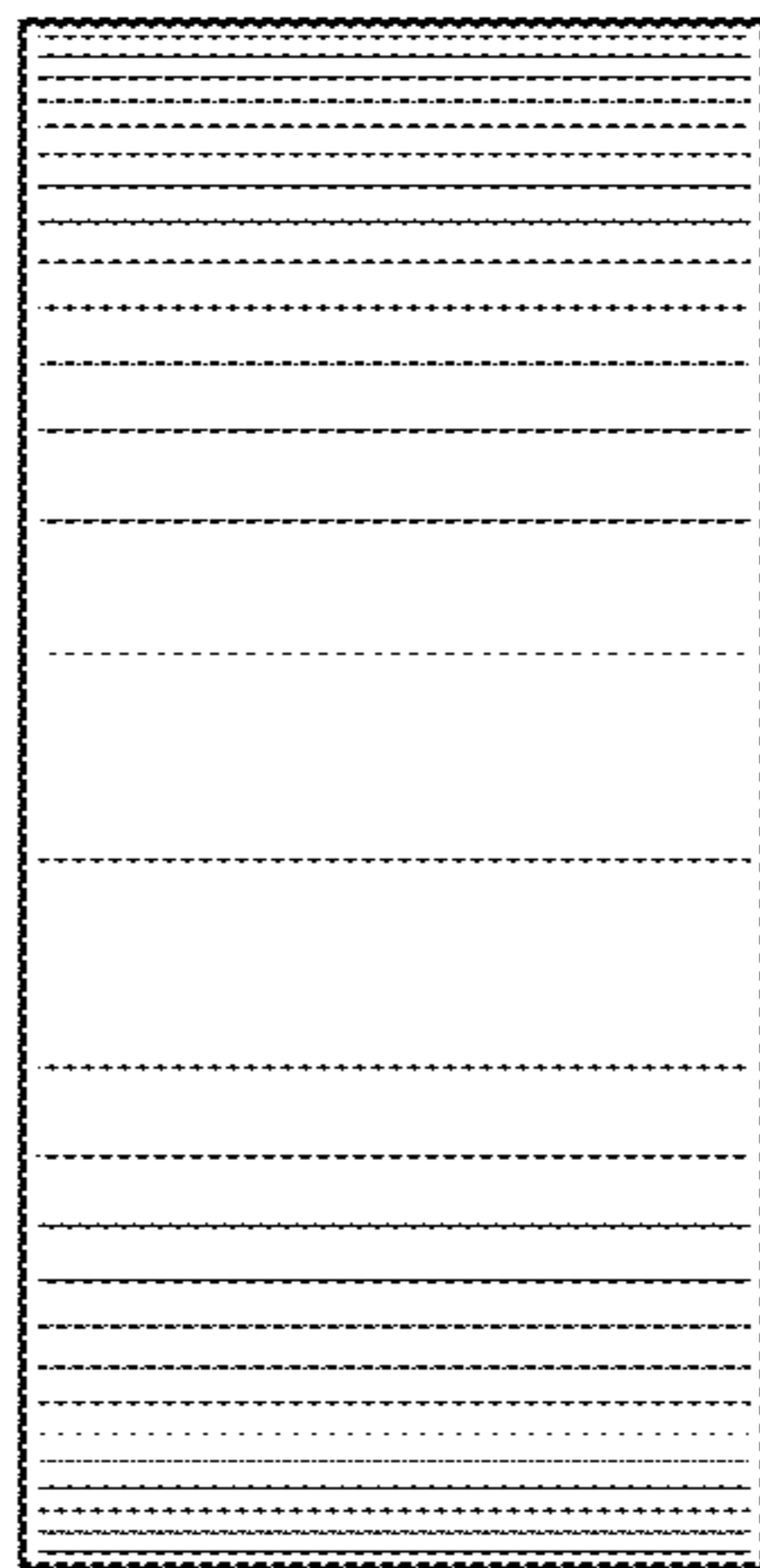

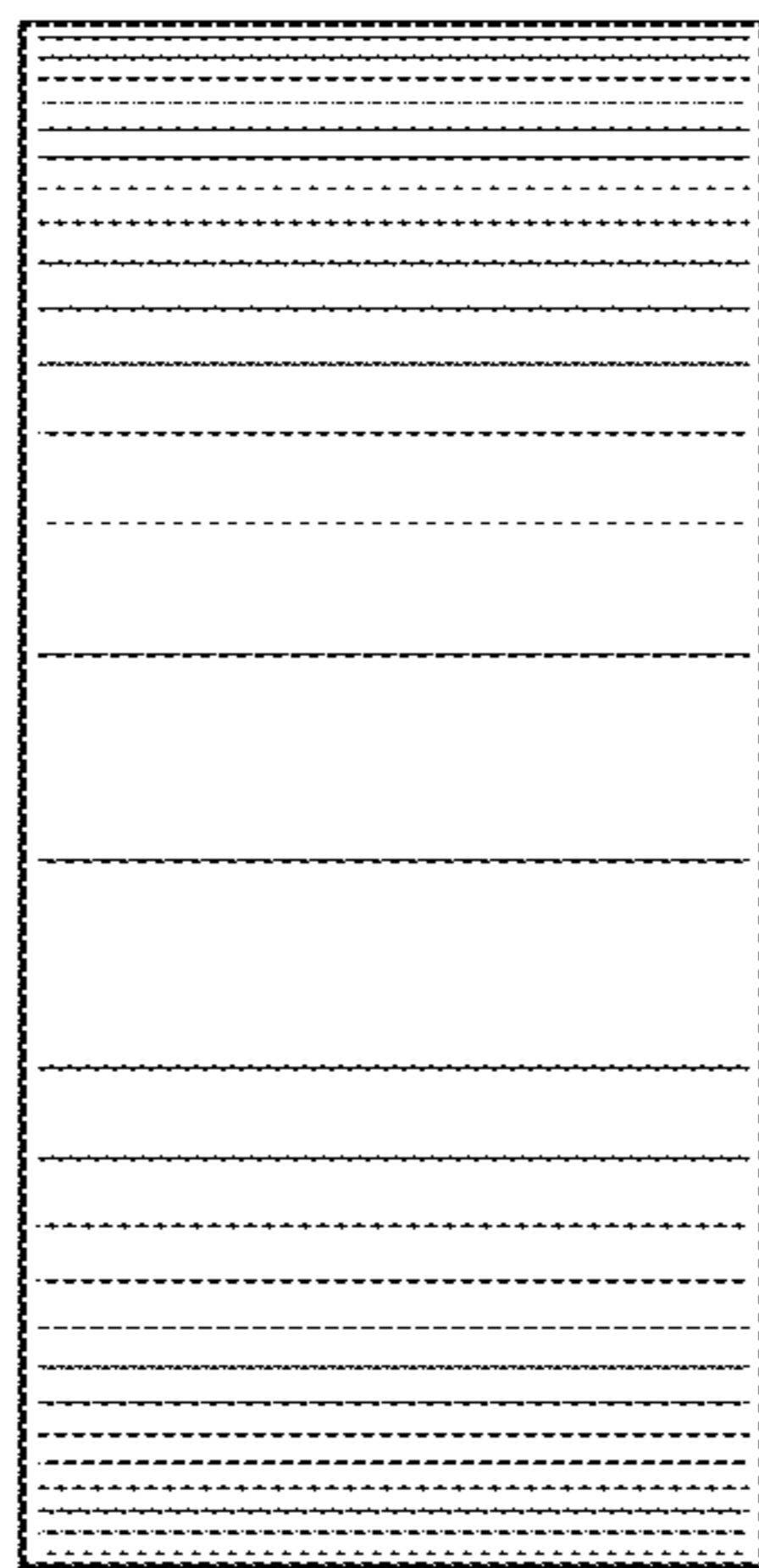
