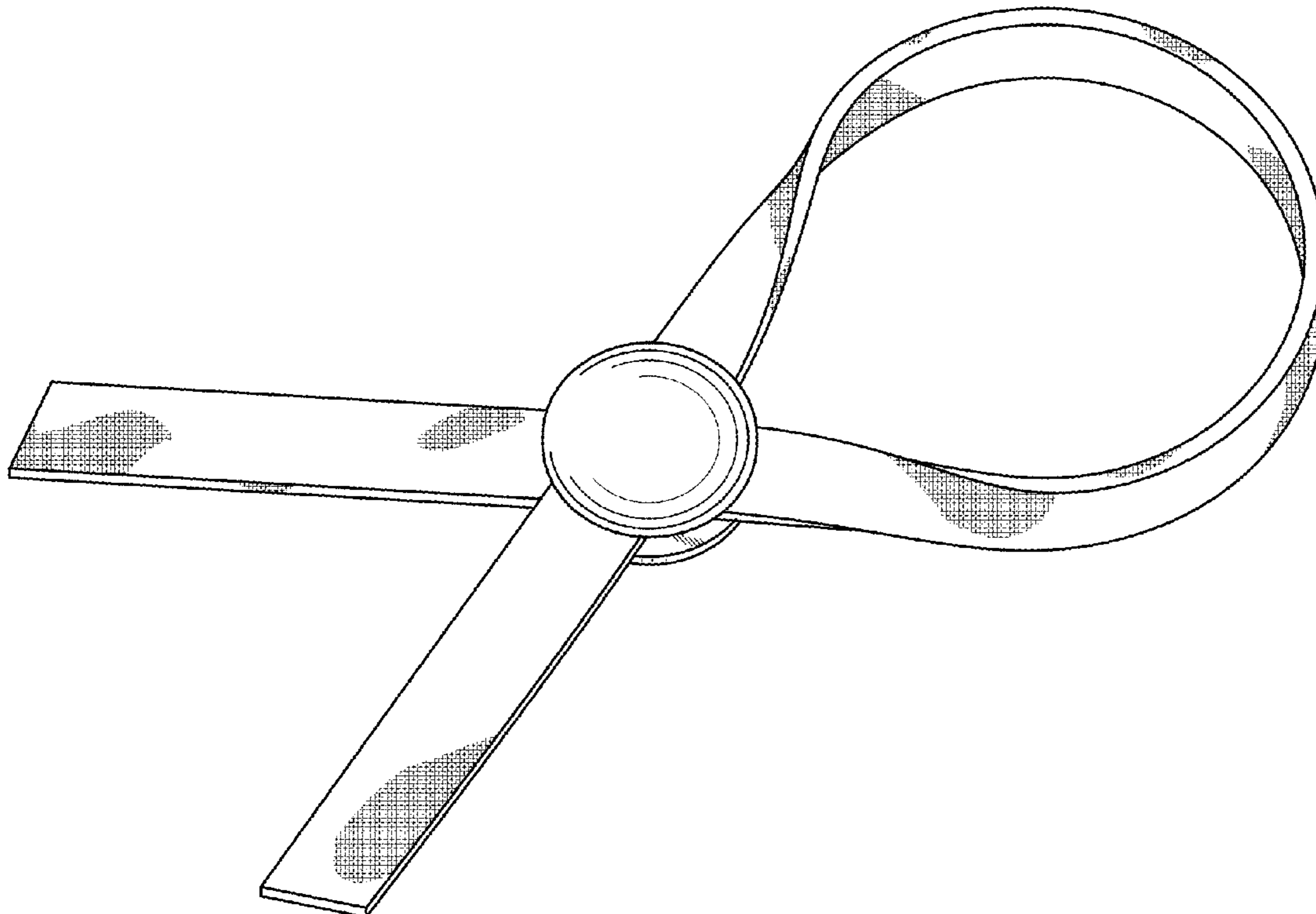
(57) **CLAIM**

The ornamental design for a sewing machine bobbin organizer, as shown and described.

DESCRIPTION

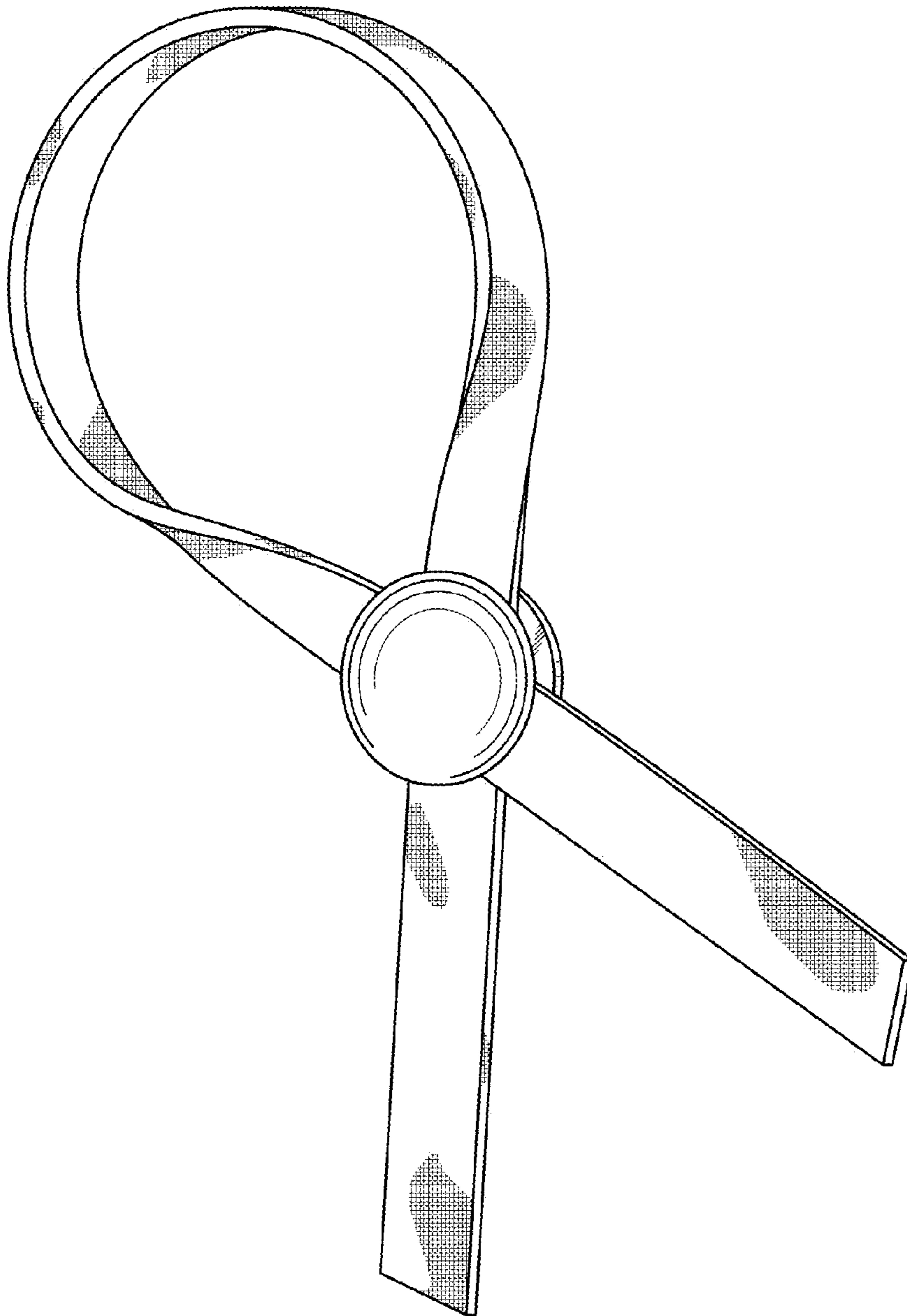

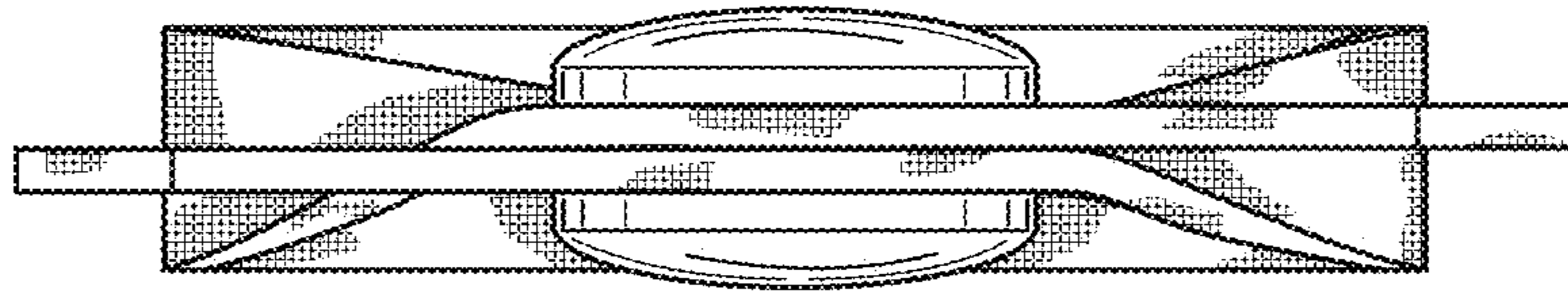

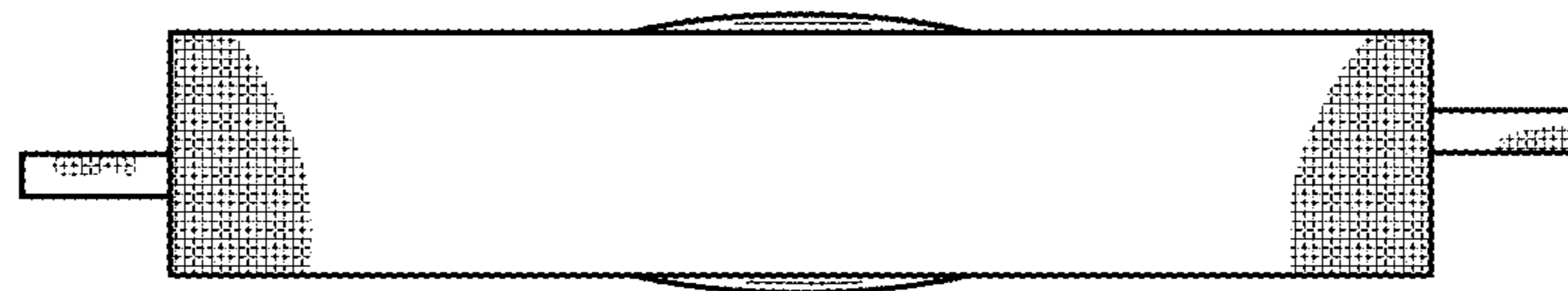

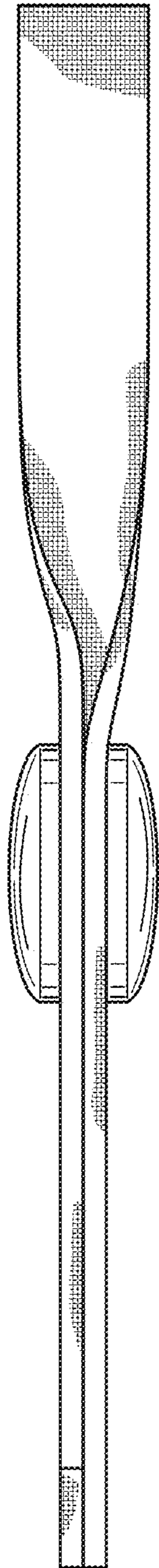

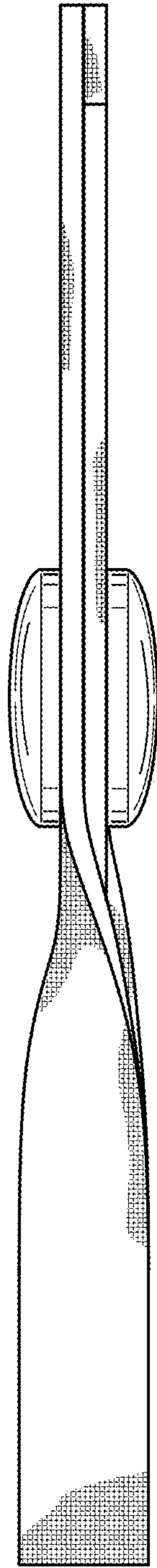

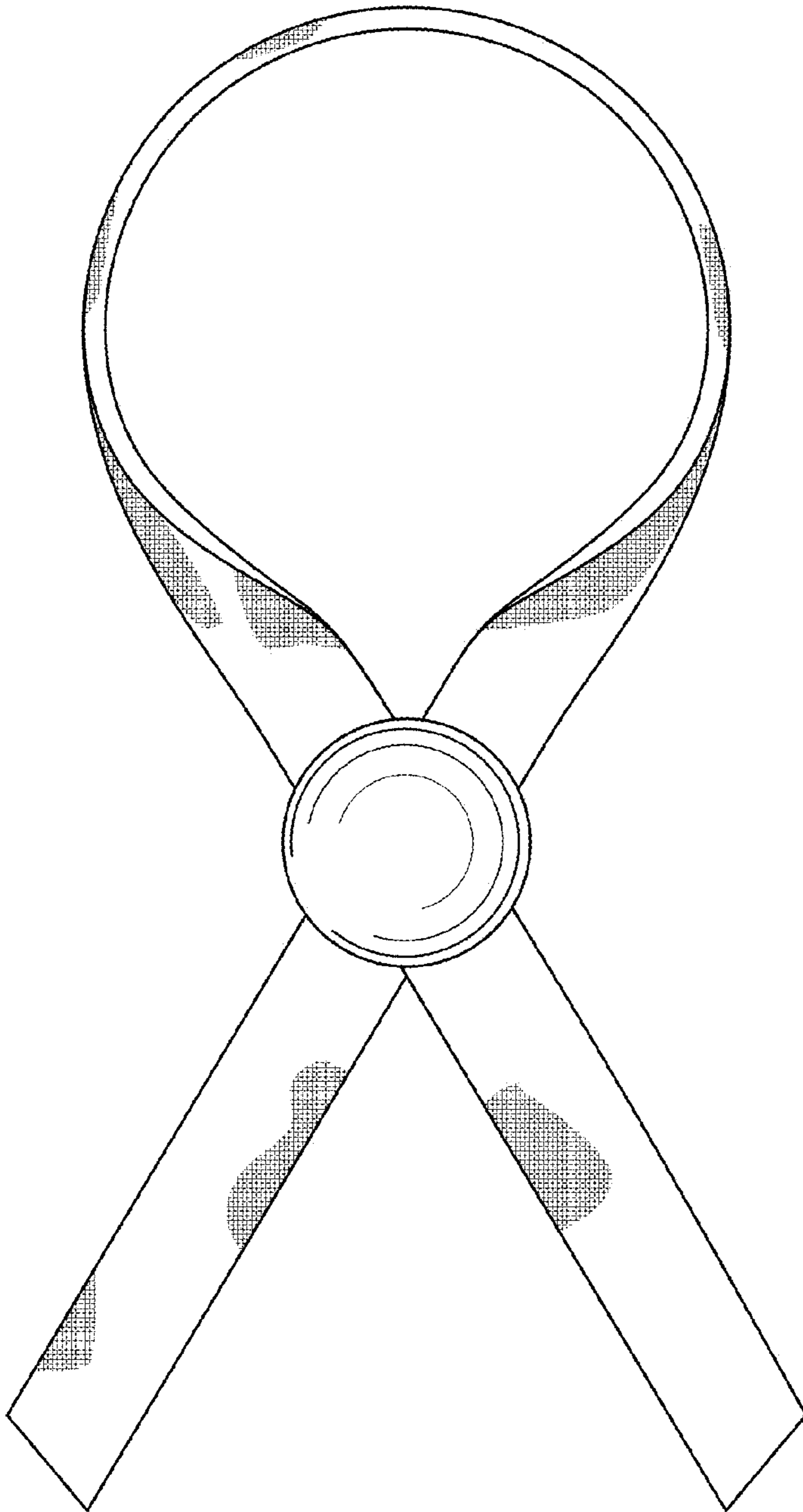

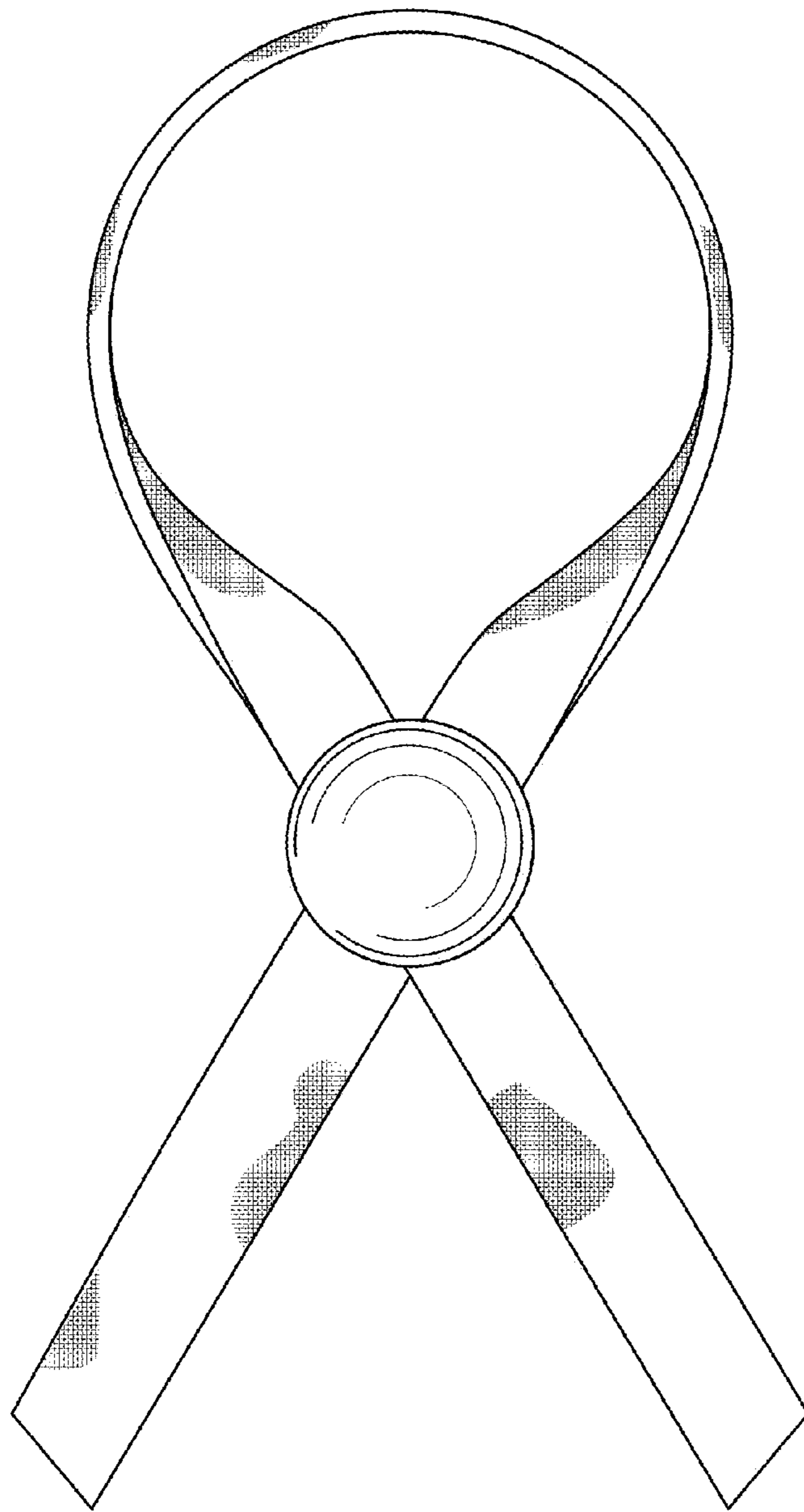
