(57) **CLAIM**

The ornamental design for a control box for fabric welding machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the control box for a fabric welding machine shown mounted on a gantry which is illustrated in dashed lines.

FIG. 2 is an enlarged front elevational view of the control box.

FIG. 3 is a rear elevational view of the control box.

FIG. 4 is a left side elevational view of the control box.

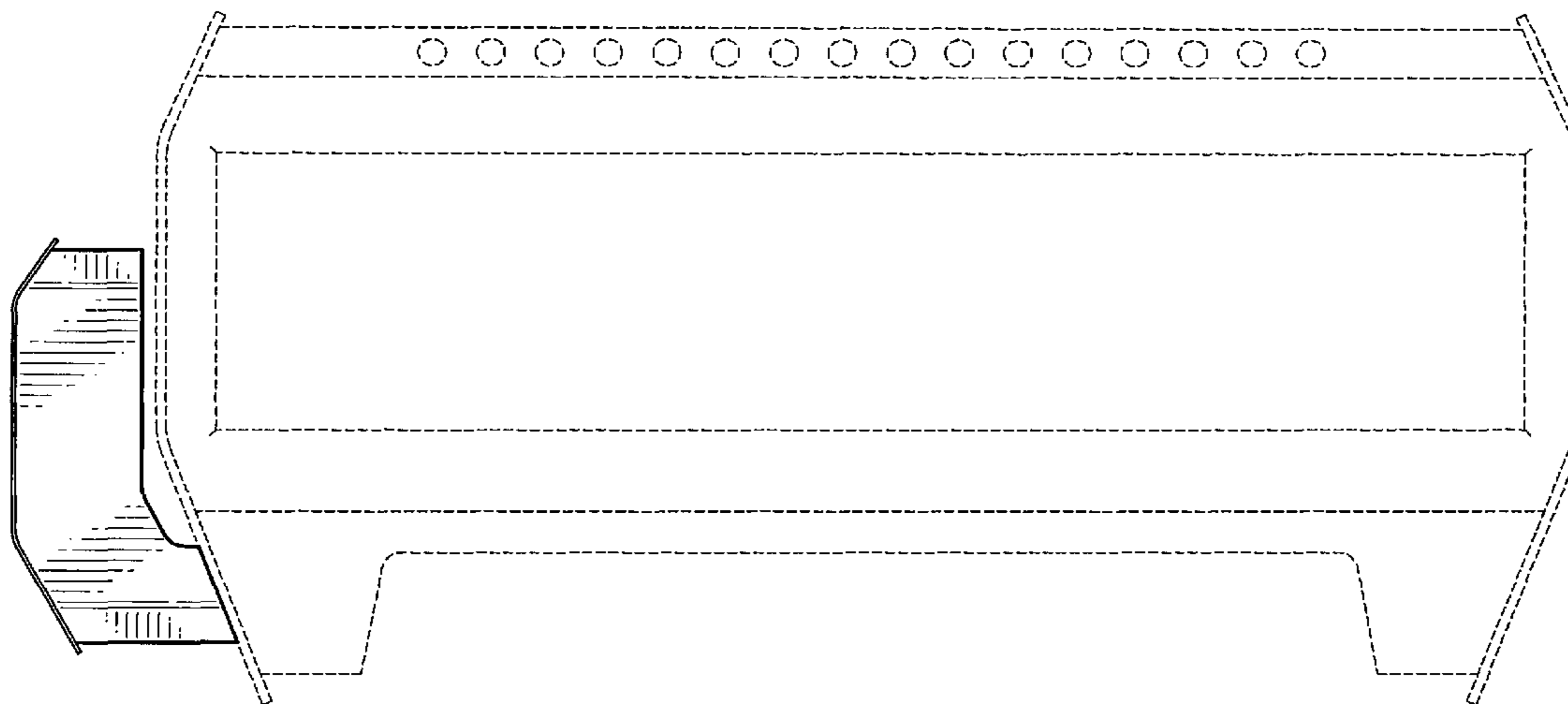
FIG. 5 is a right side elevational view of the control box.

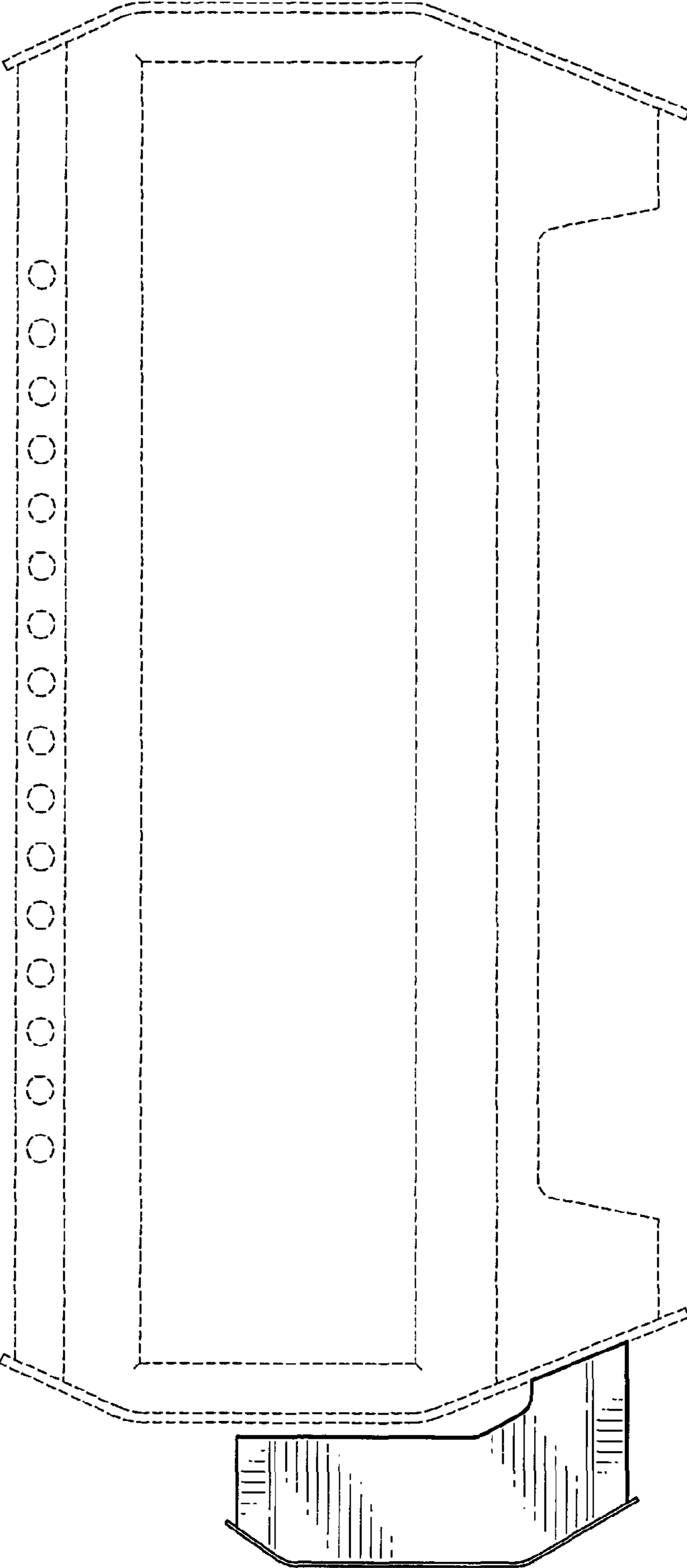

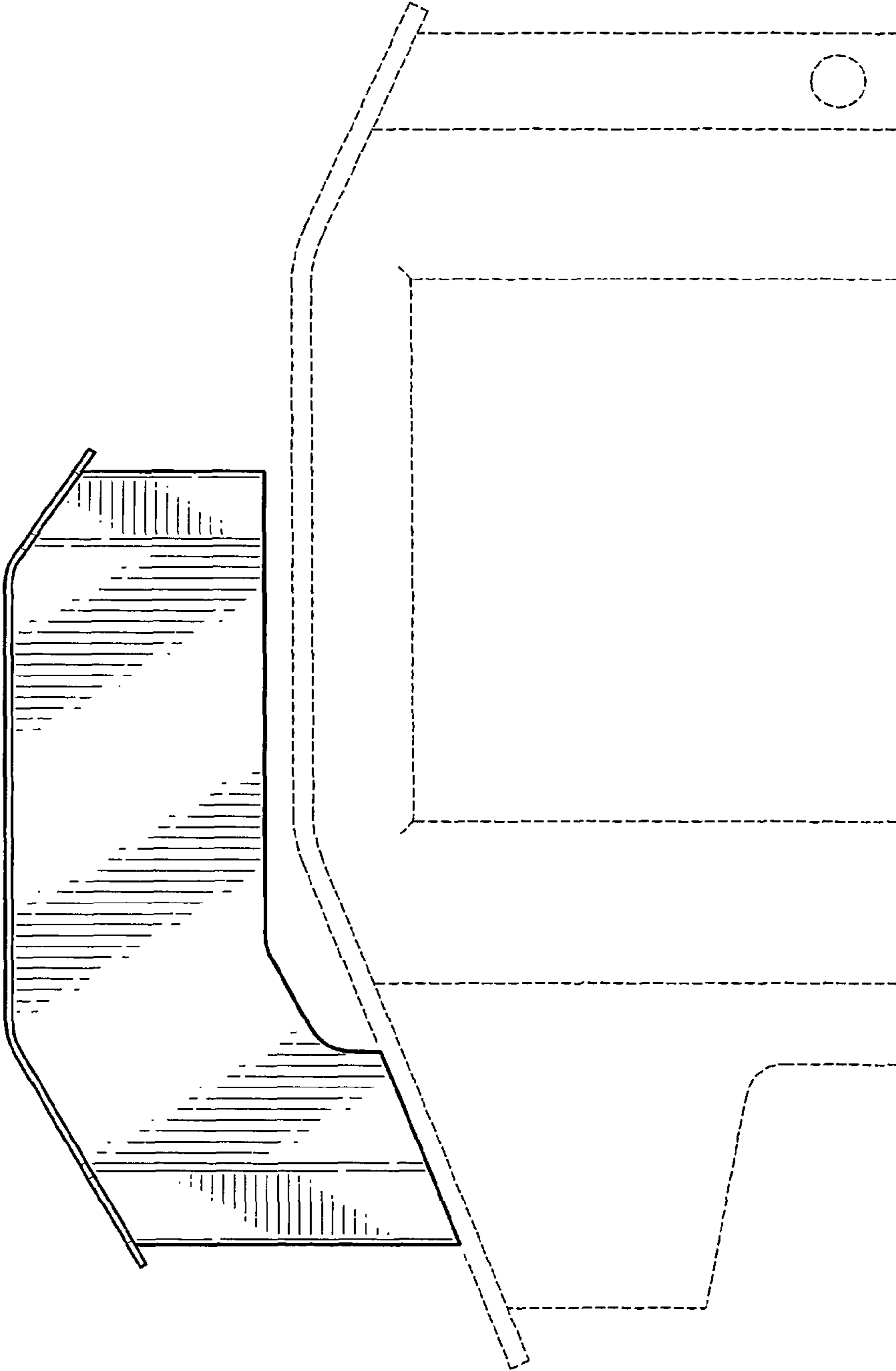

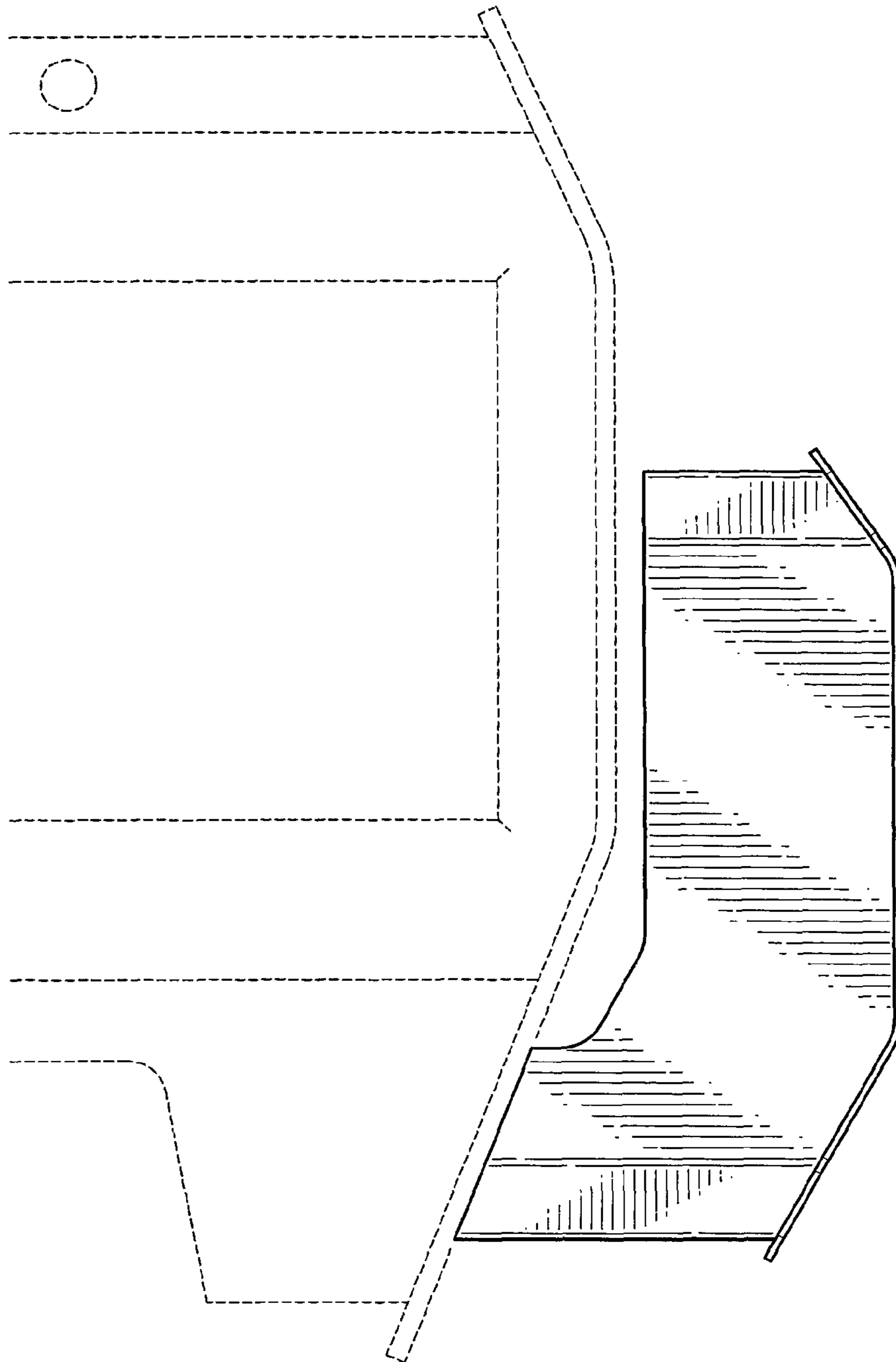

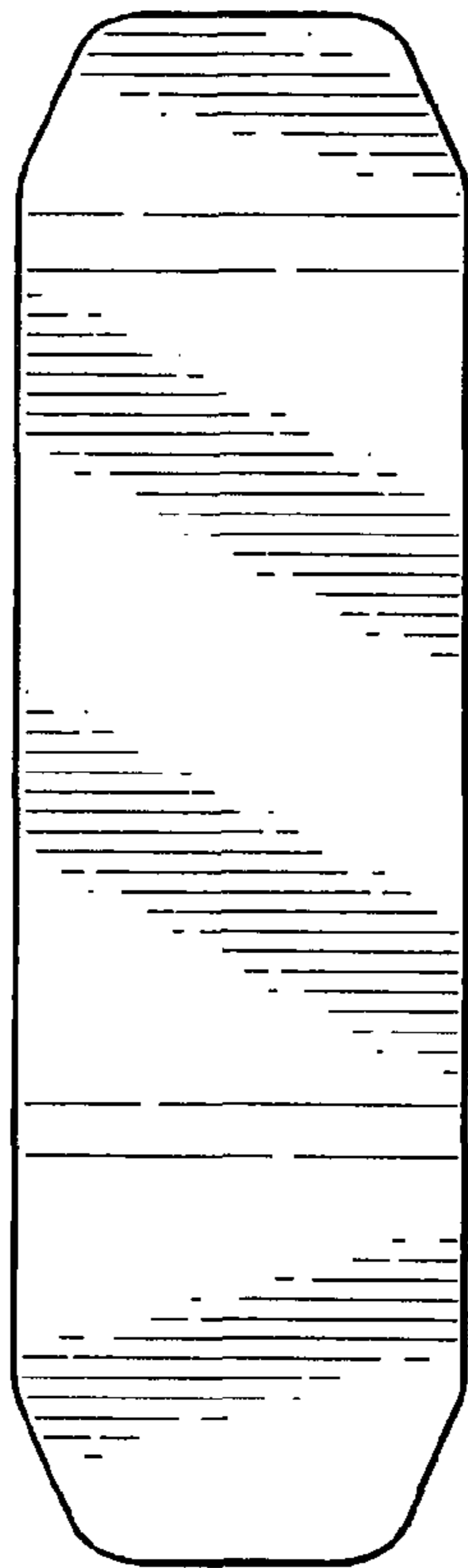

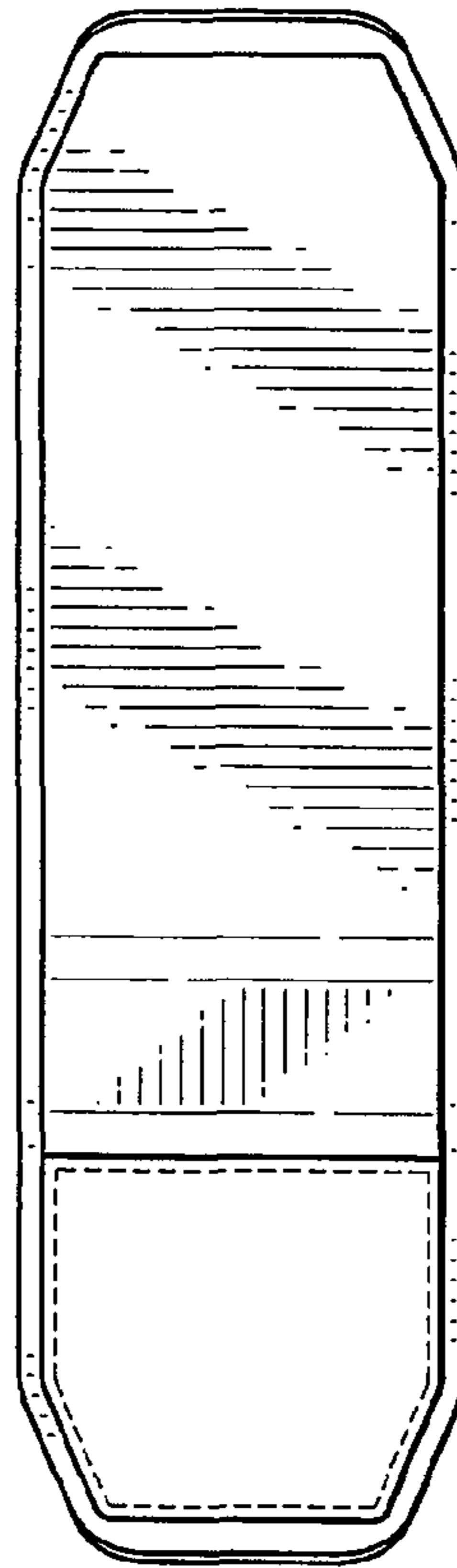

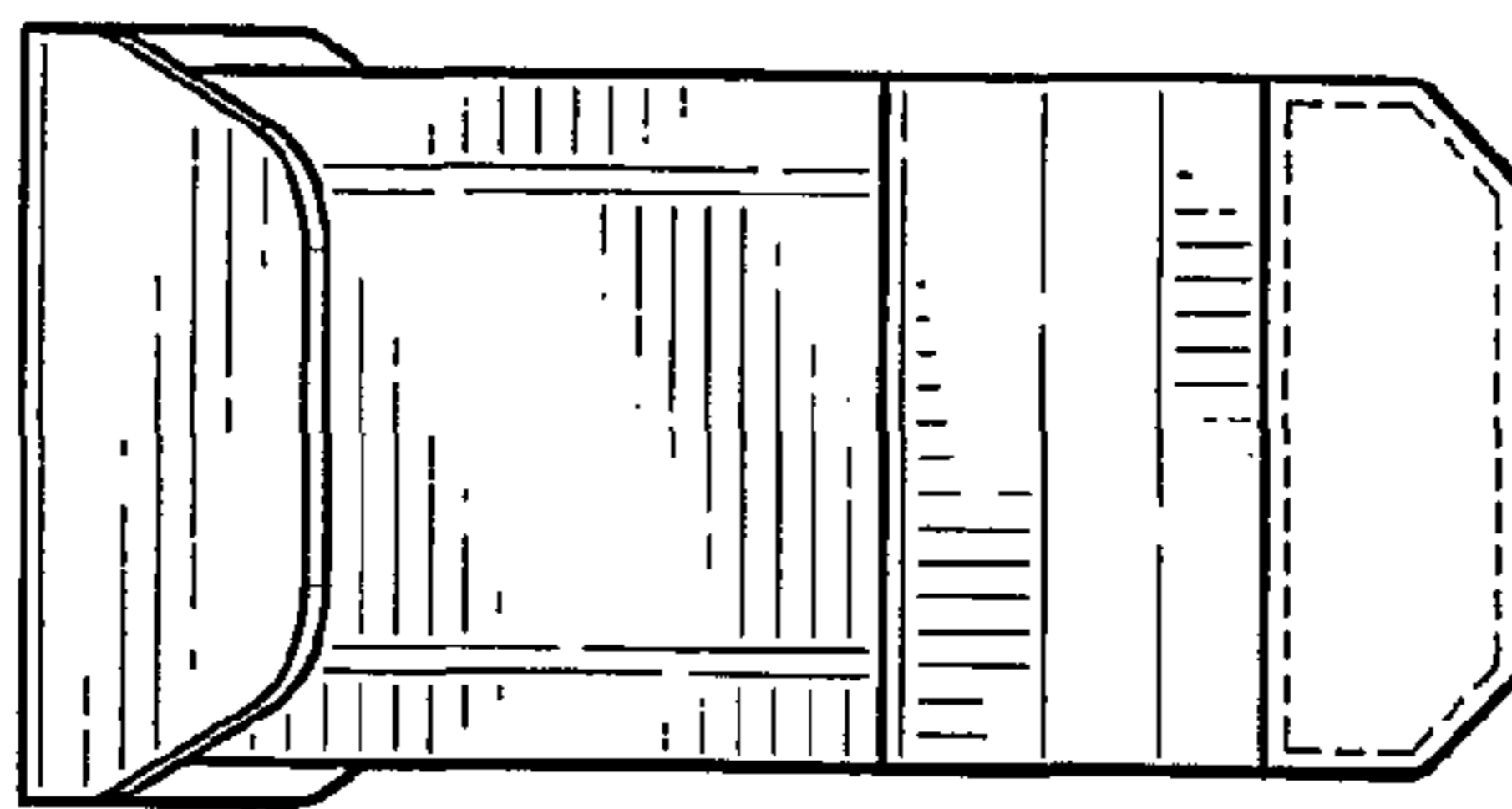
