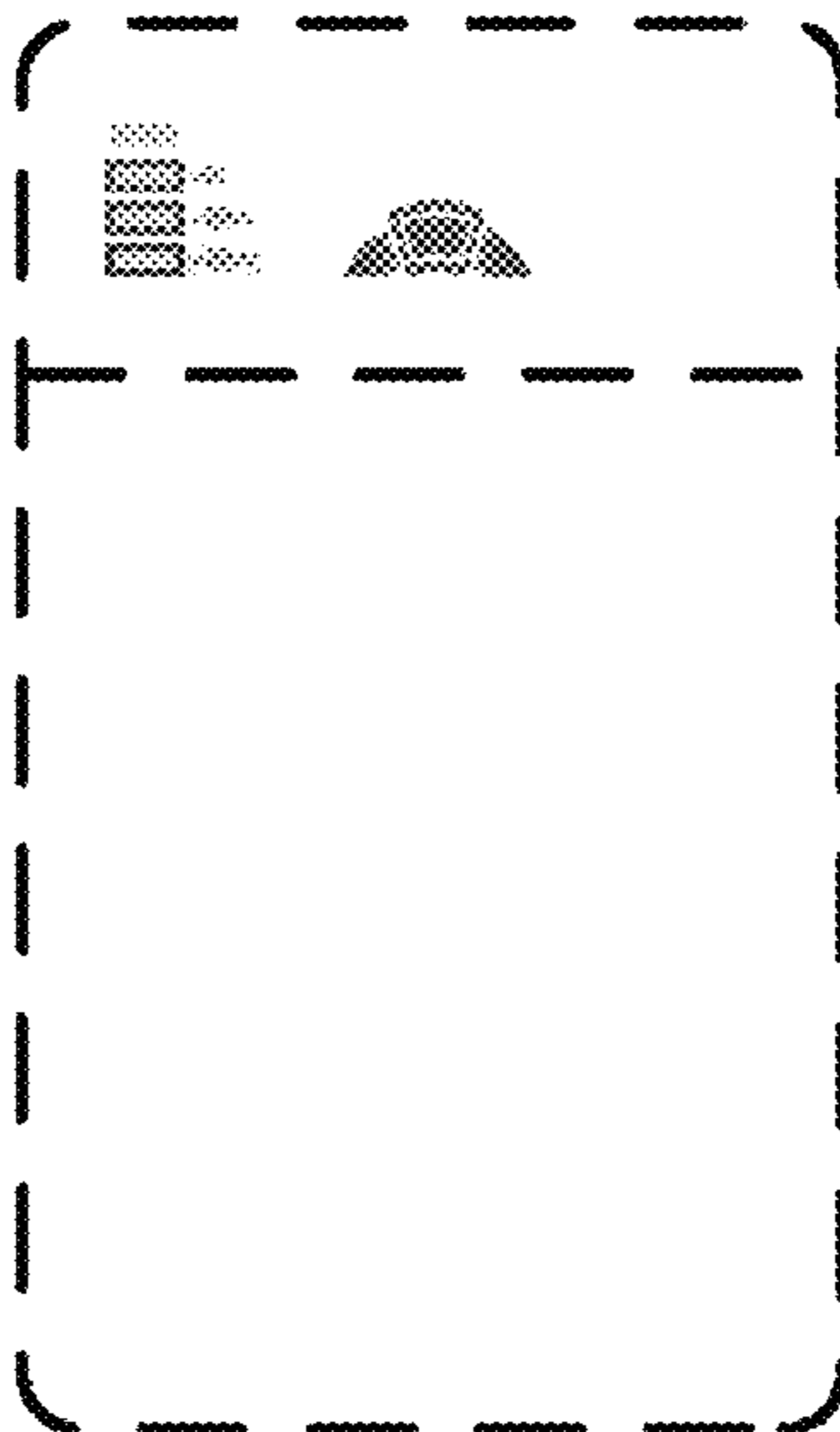
The ornamental design for a card with symbols, as shown and described.
