(57) **CLAIM**

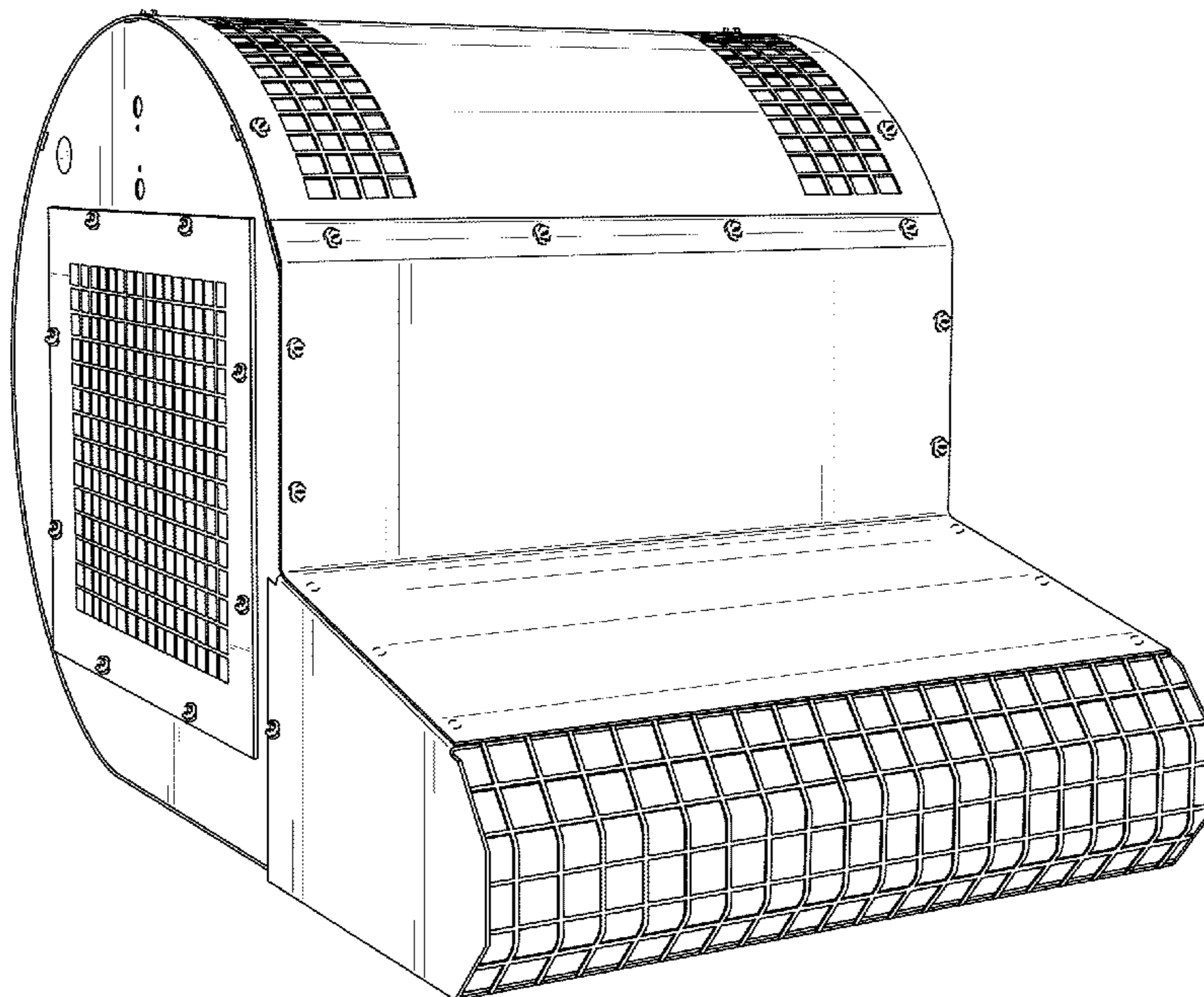
The ornamental design for a high velocity truck cooler, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a high velocity truck cooler in accordance with an embodiment of the present invention; FIG. 2 is a front elevation view of the high velocity truck cooler of FIG. 1; FIG. 3 is a rear elevation view of the high velocity truck cooler of FIG. 1; FIG. 4 is a left side elevation view of the high velocity truck cooler of FIG. 1; FIG. 5 is a right side elevation view of the high velocity truck cooler of FIG. 1; FIG. 6 is a top plan view of the high velocity truck cooler of FIG. 1; and, FIG. 7 is a bottom plan view of the high velocity truck cooler of FIG. 1.

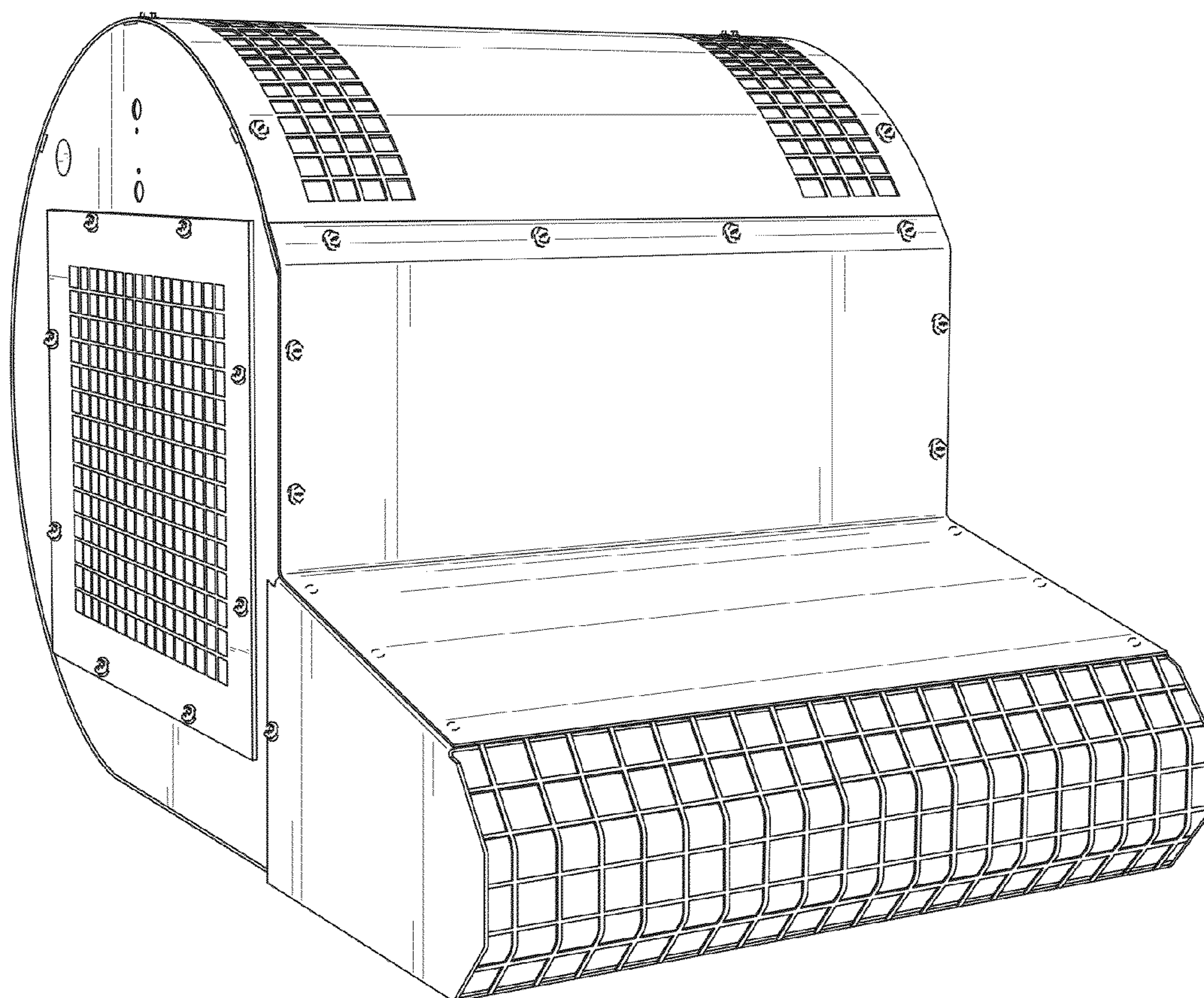

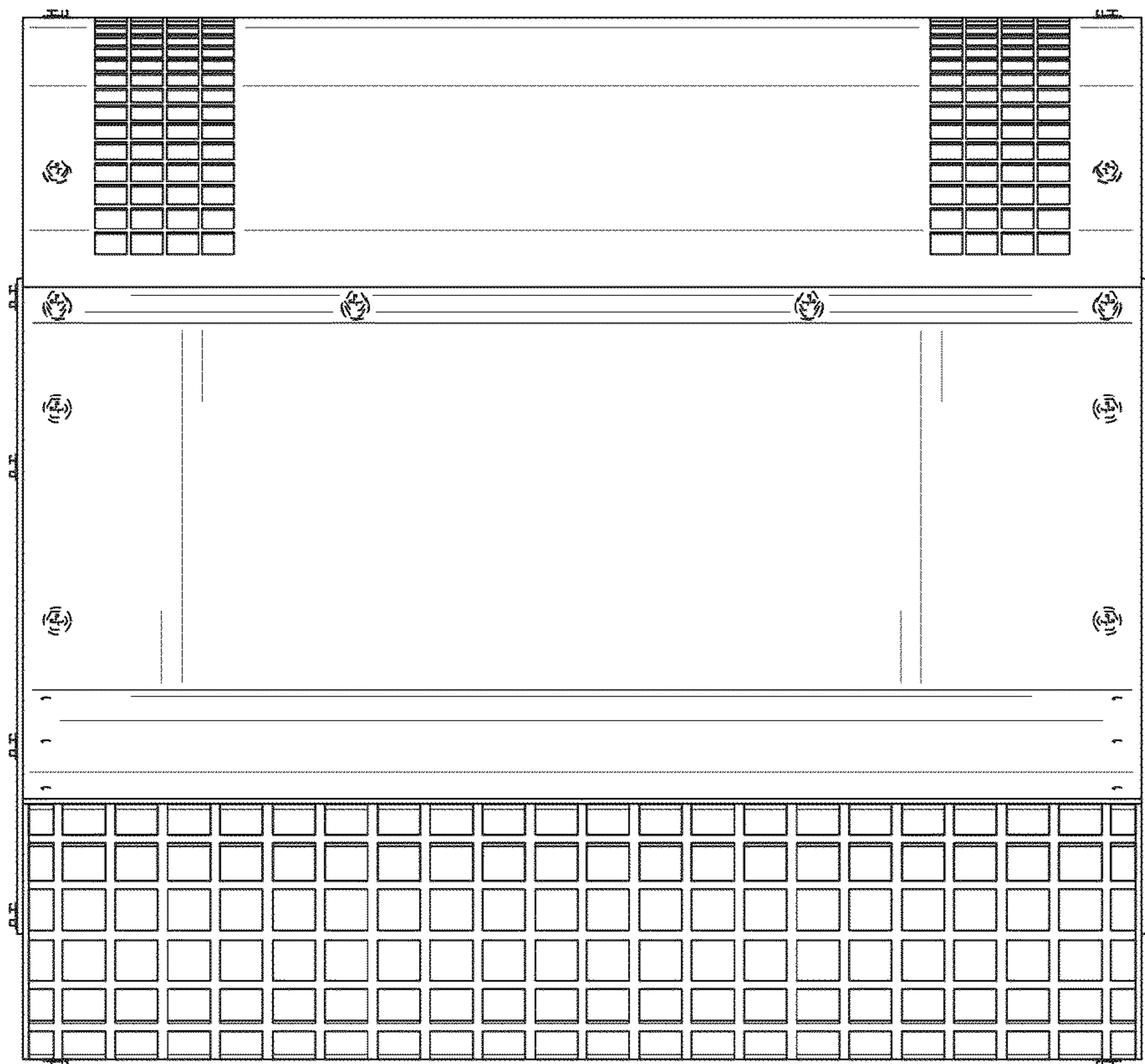

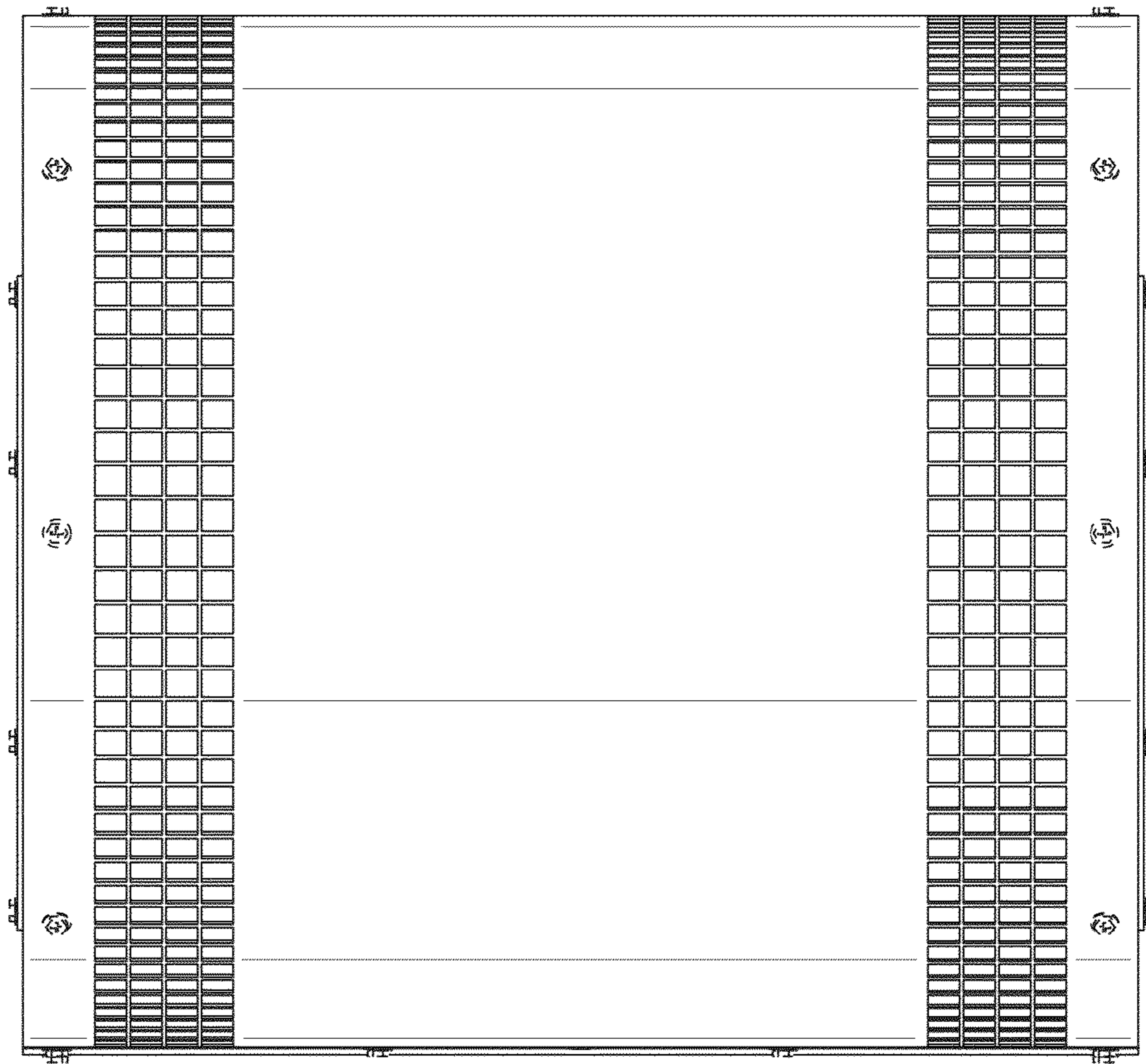

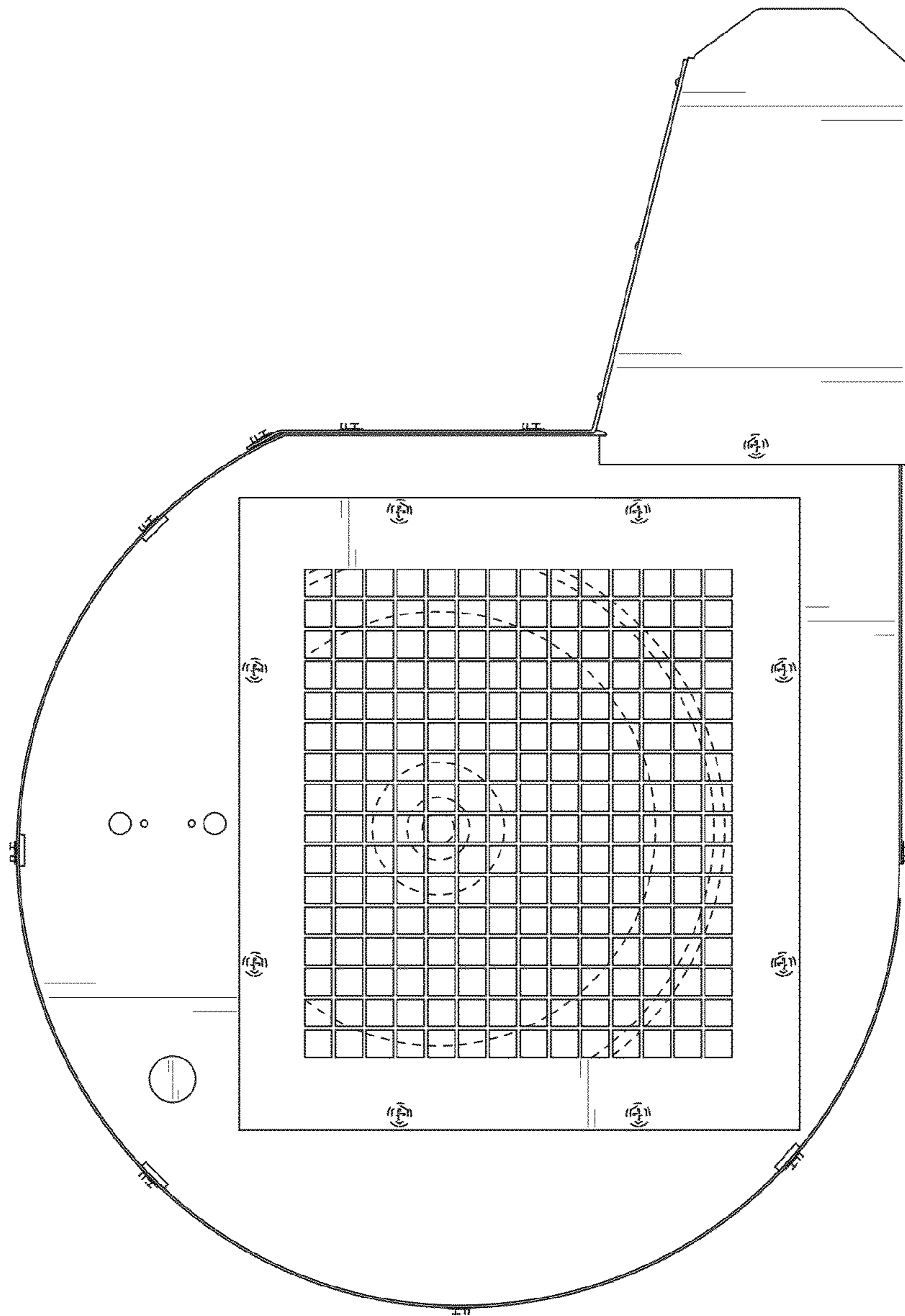

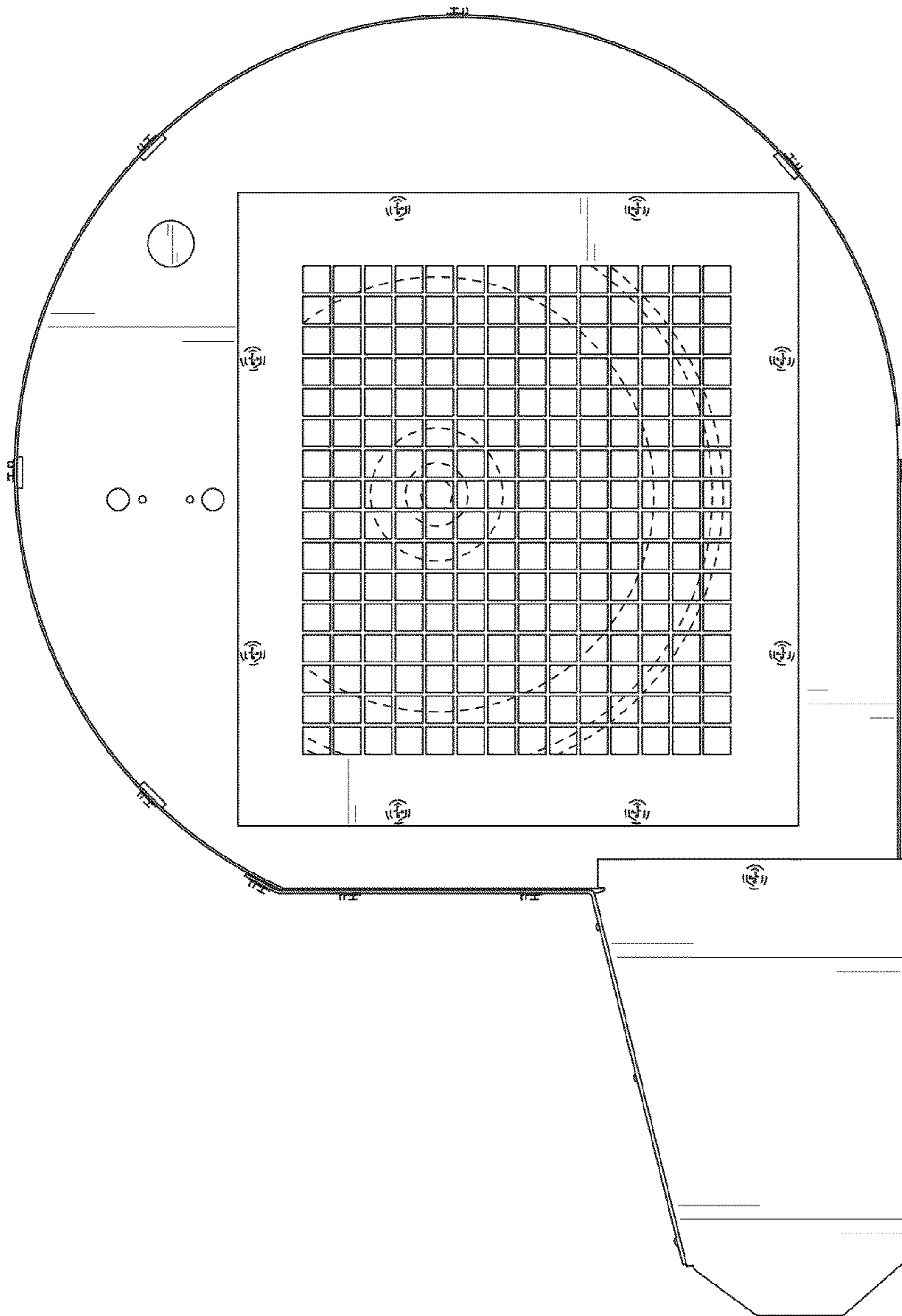

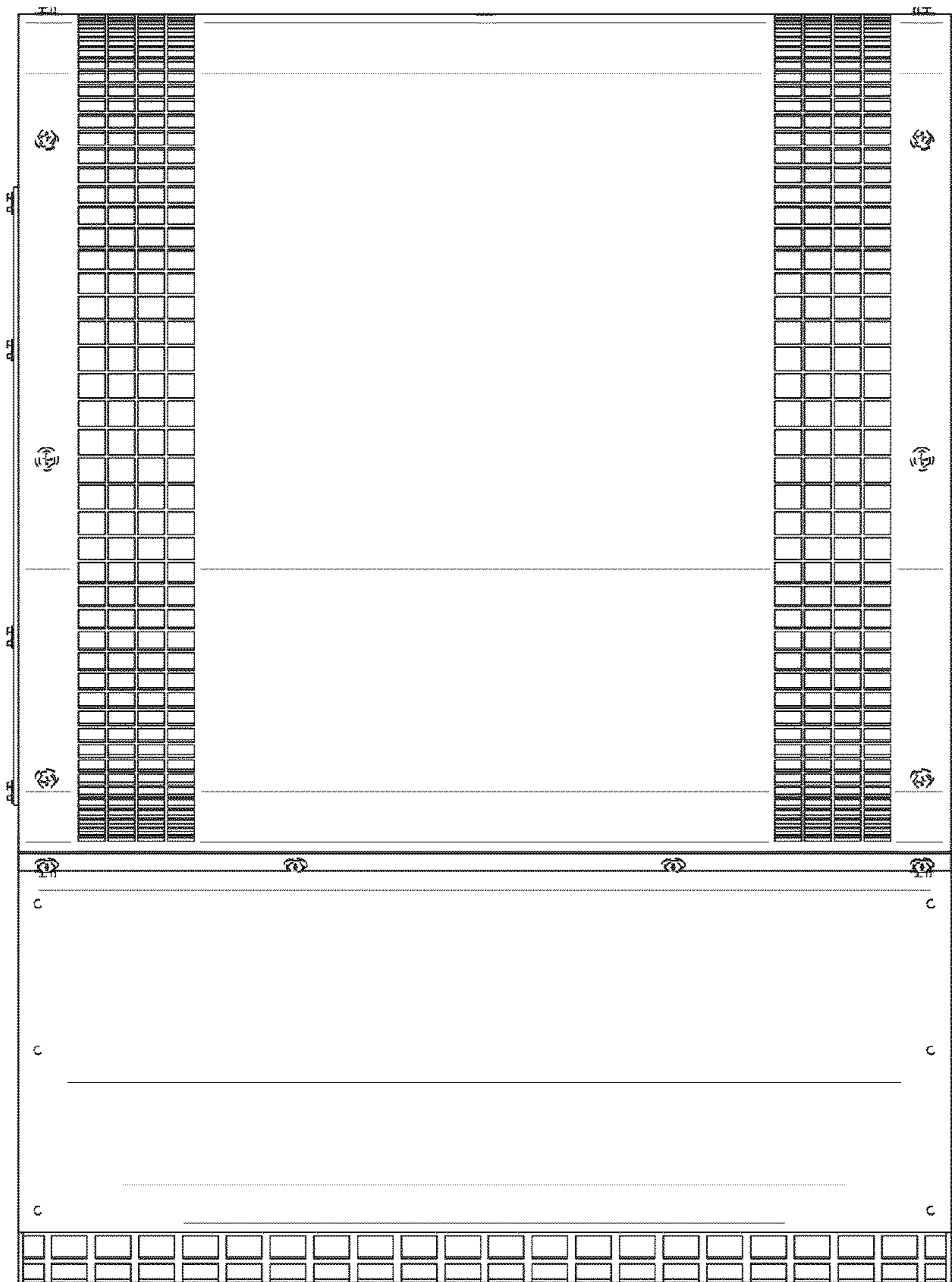

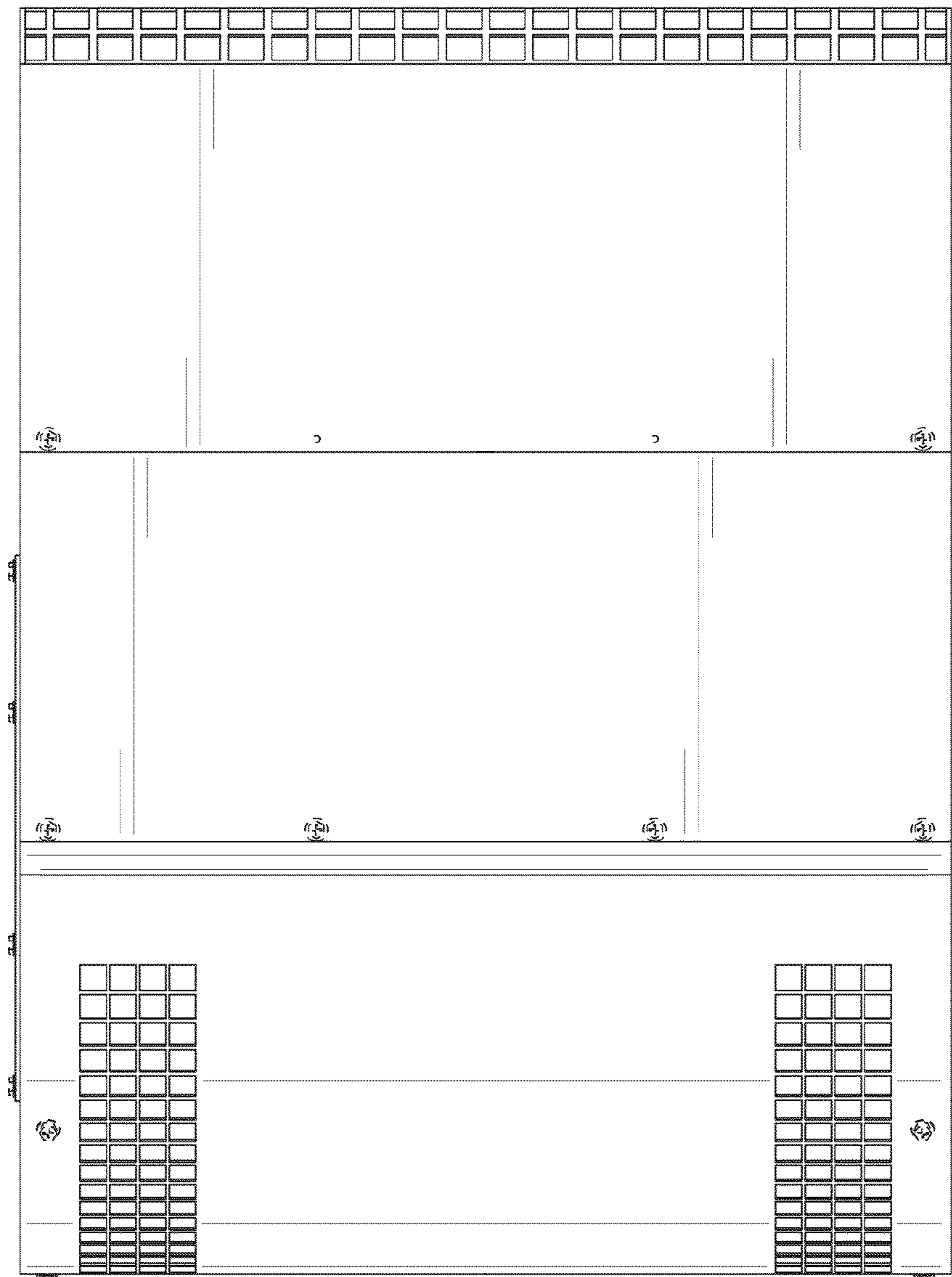
