(57) **CLAIM**

I claim the ornamental design for an animal enclosure with splash guard, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of the animal enclosure with splash guard showing the doors in an open position;

FIG. 2 is a left side elevation view showing the doors in a closed position;

FIG. 3 is a front elevation view of FIG. 2;

FIG. 4 is a right side elevation view of FIG. 2;

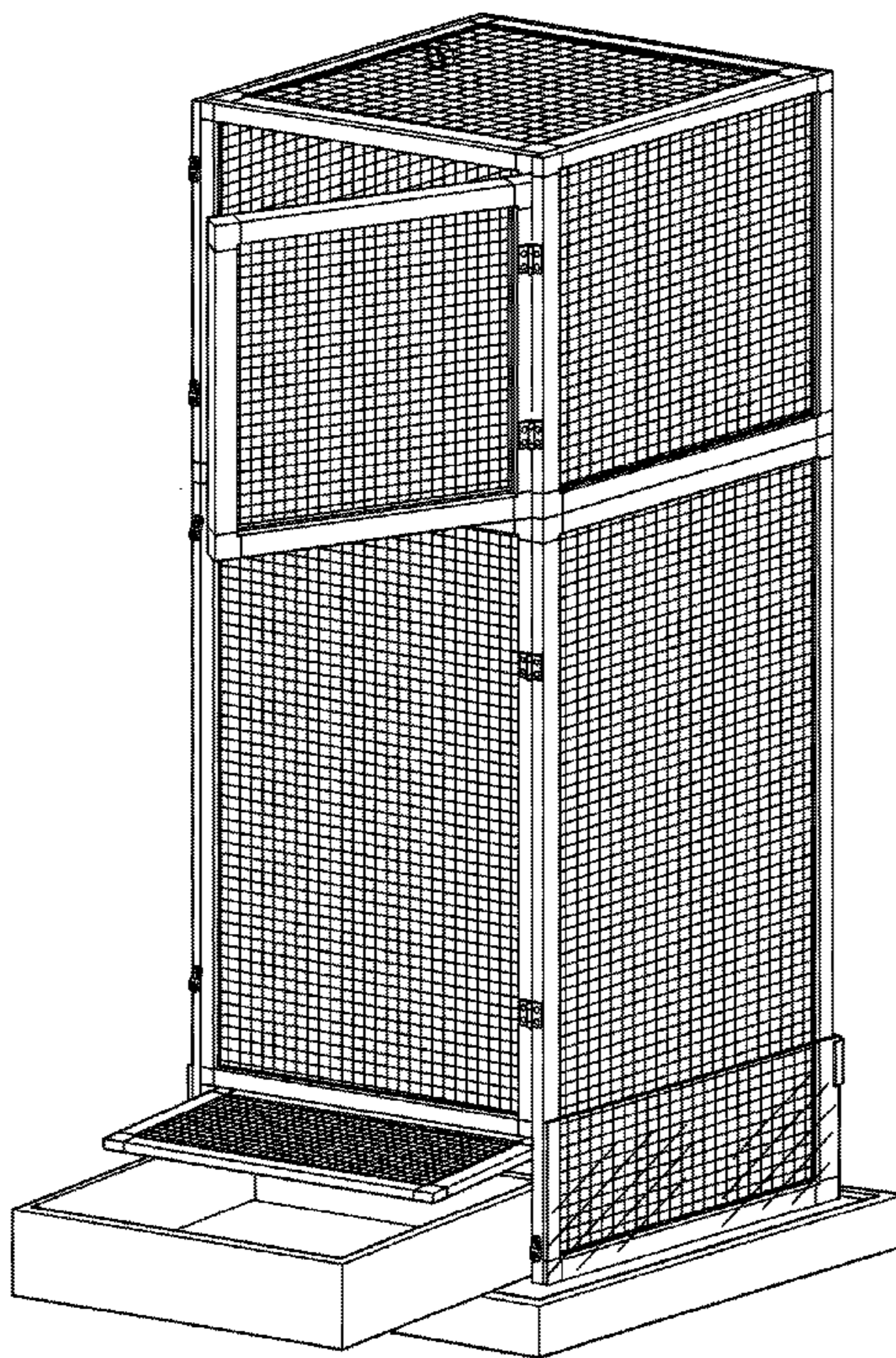
FIG. 5 is a rear view elevation of FIG. 2;

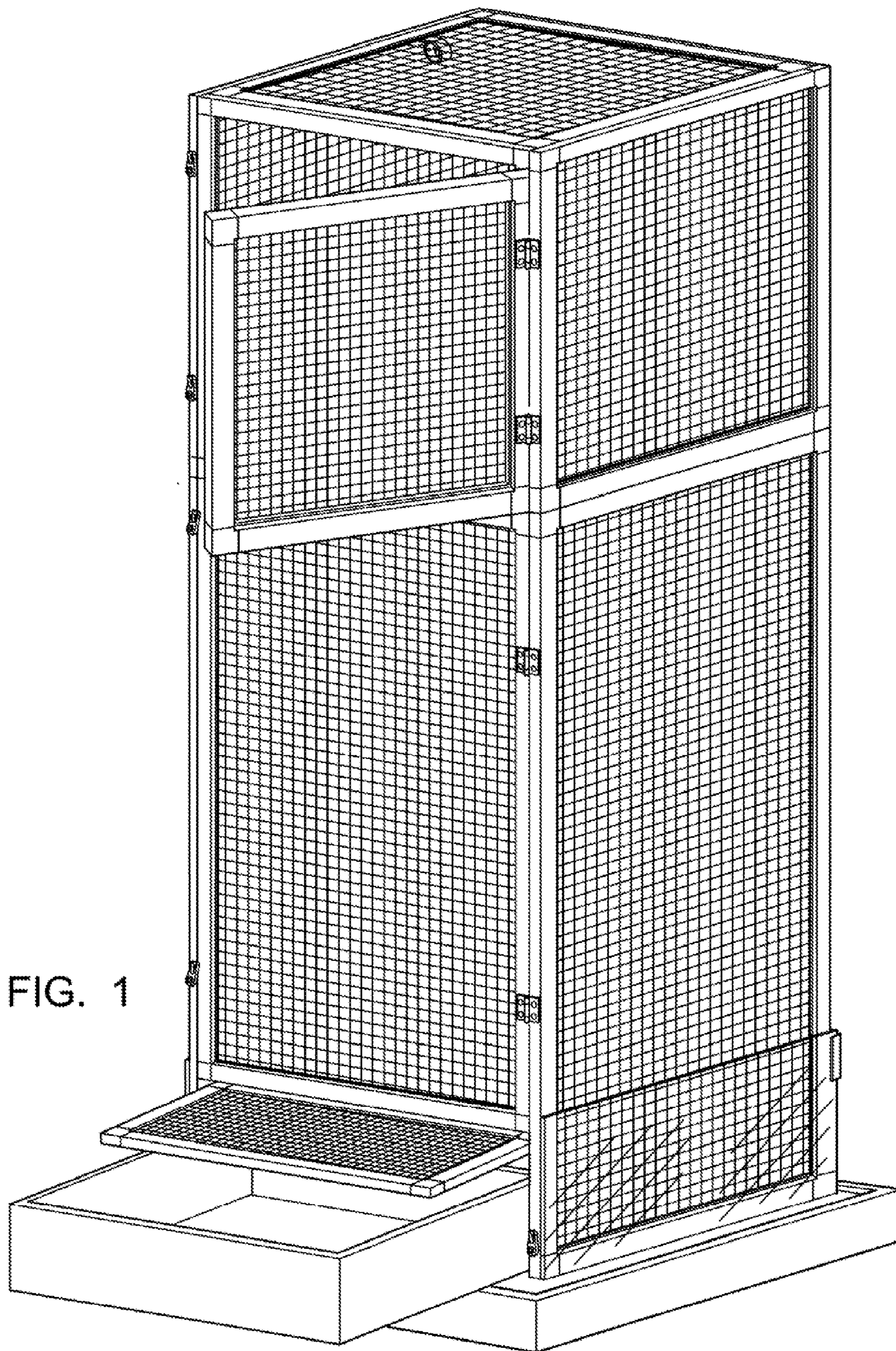

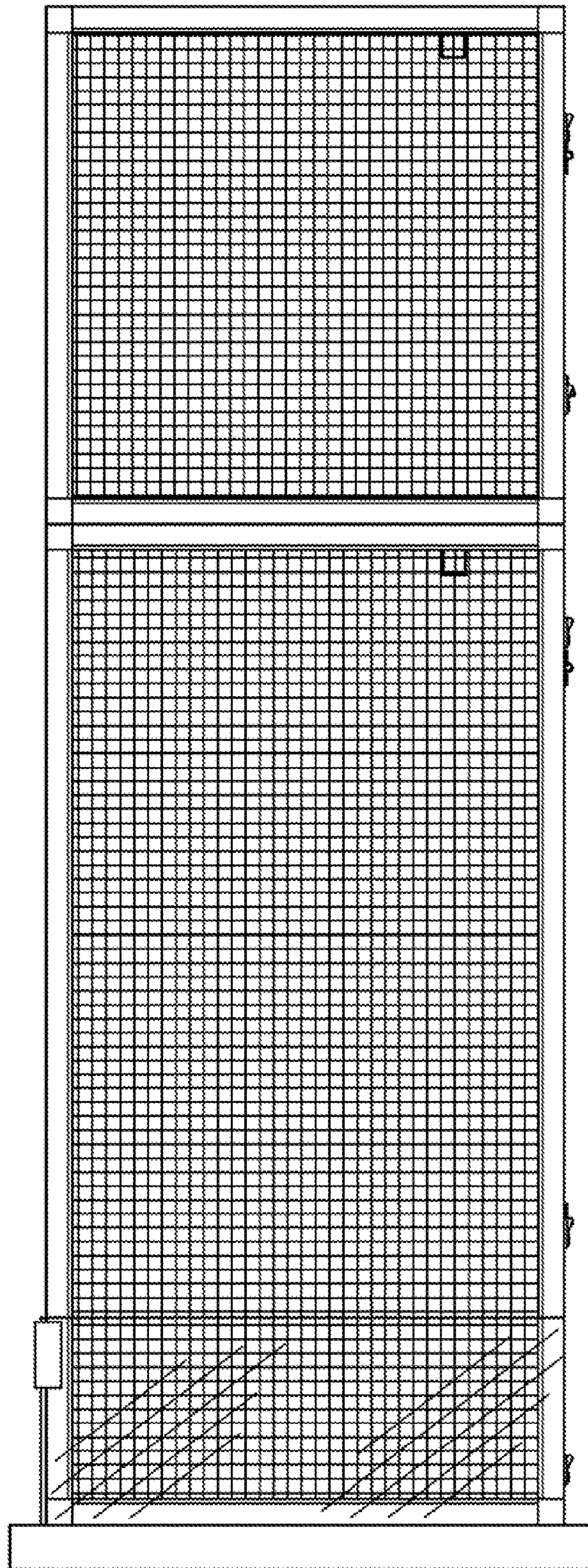

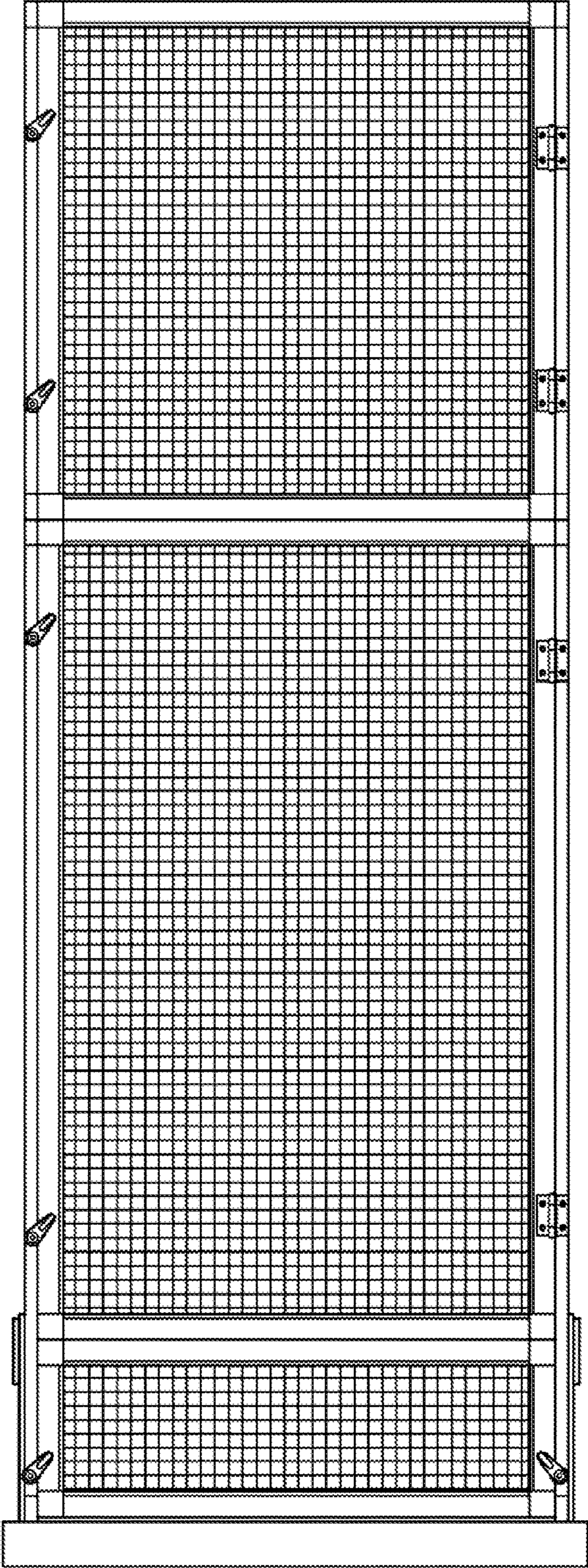

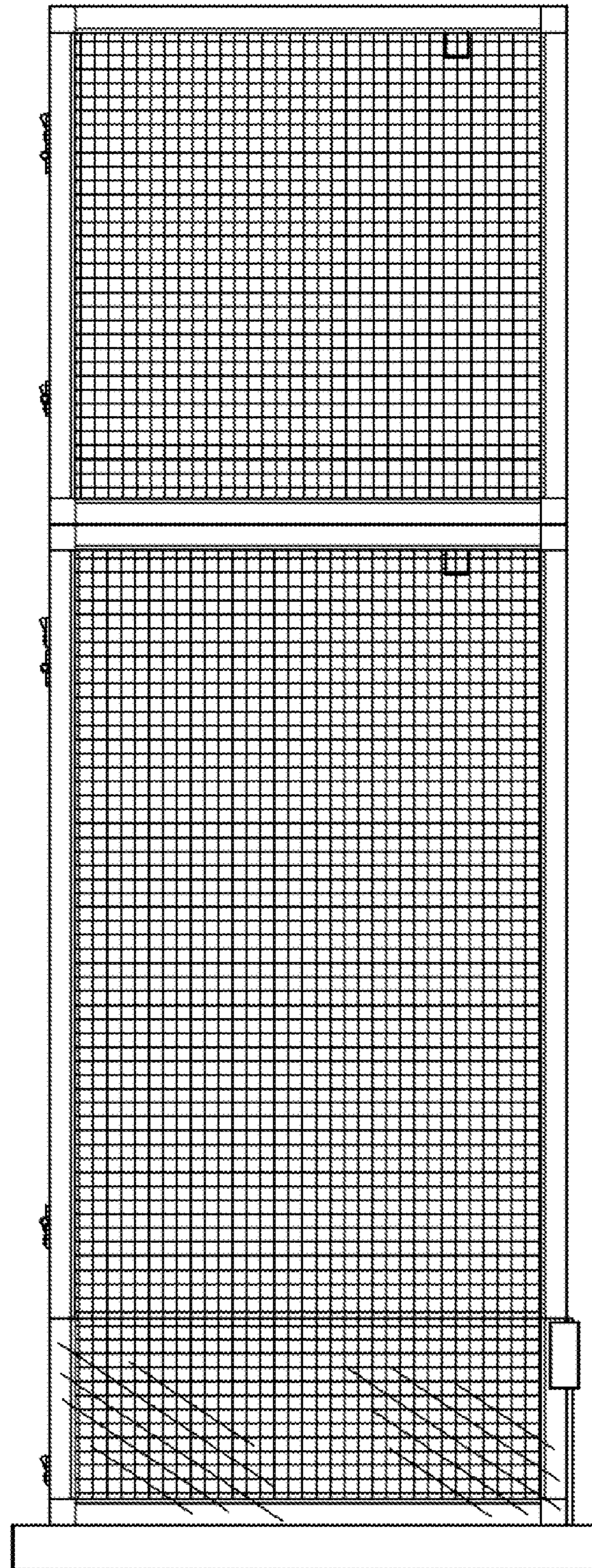

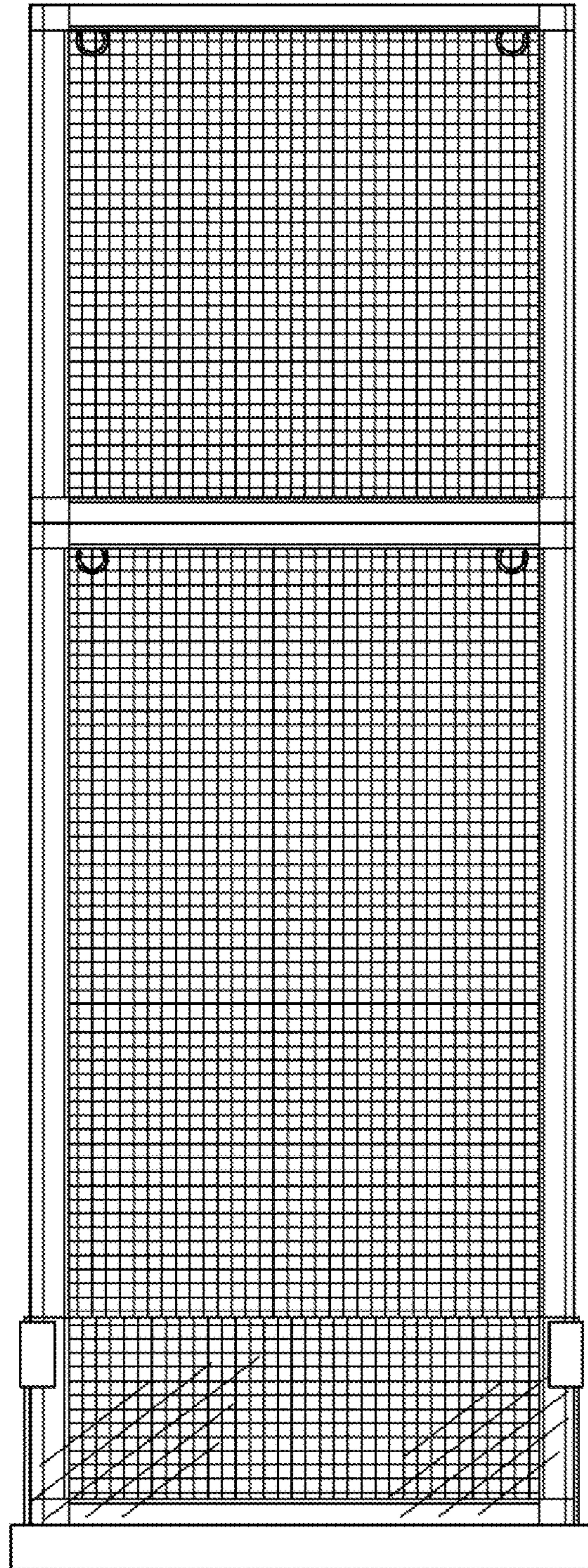

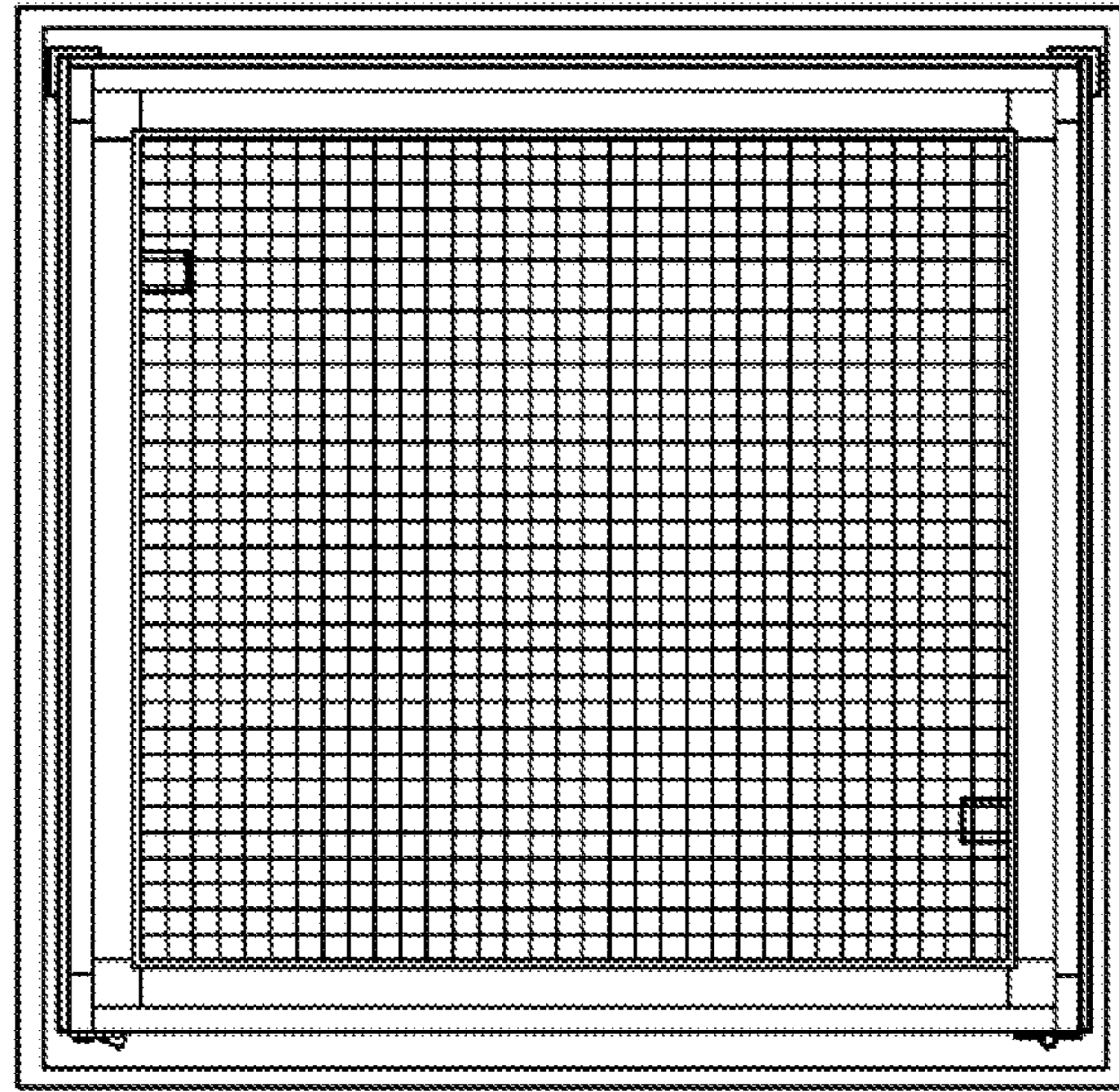

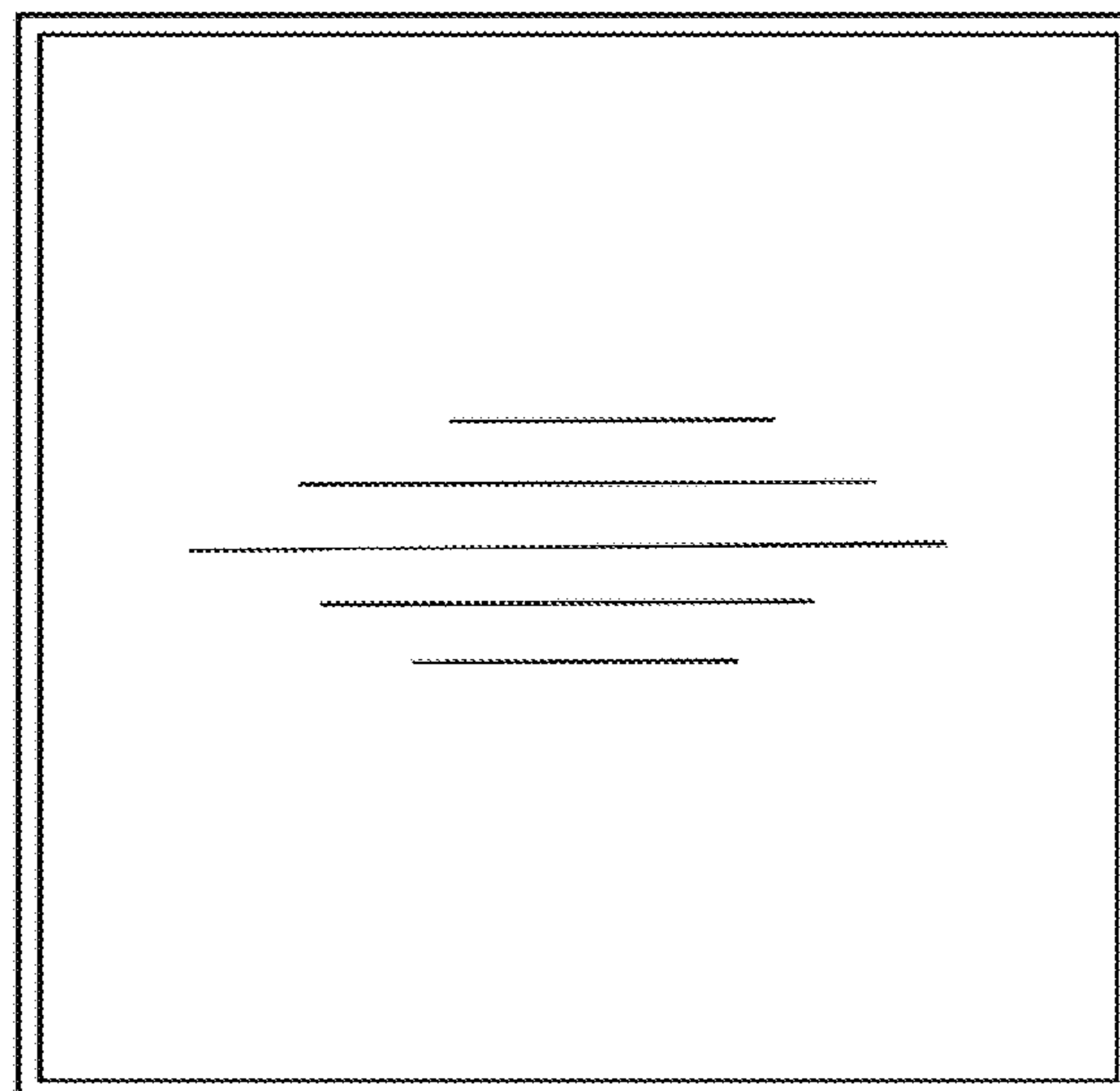

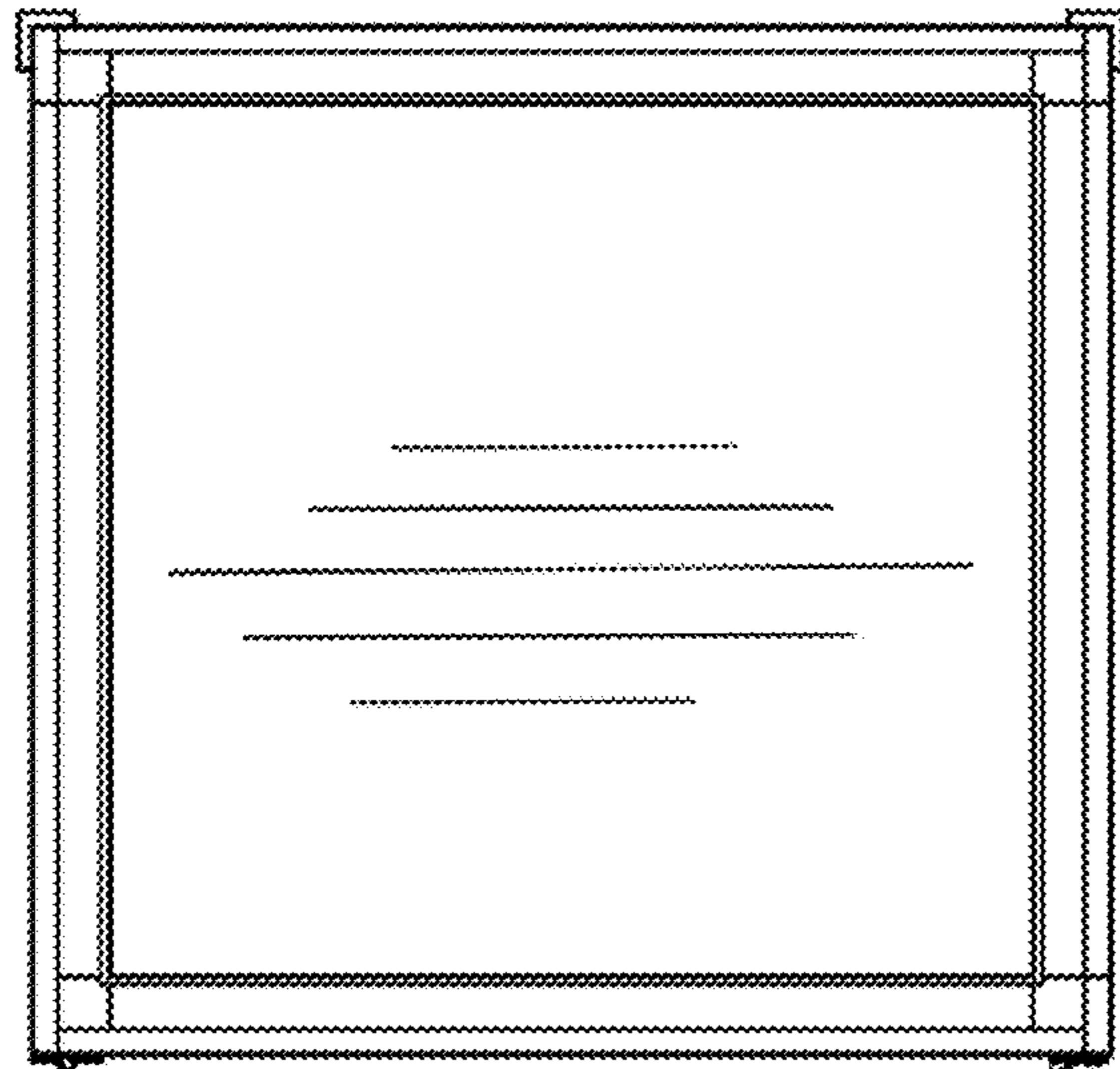
