FIG. 2 is a bottom view.

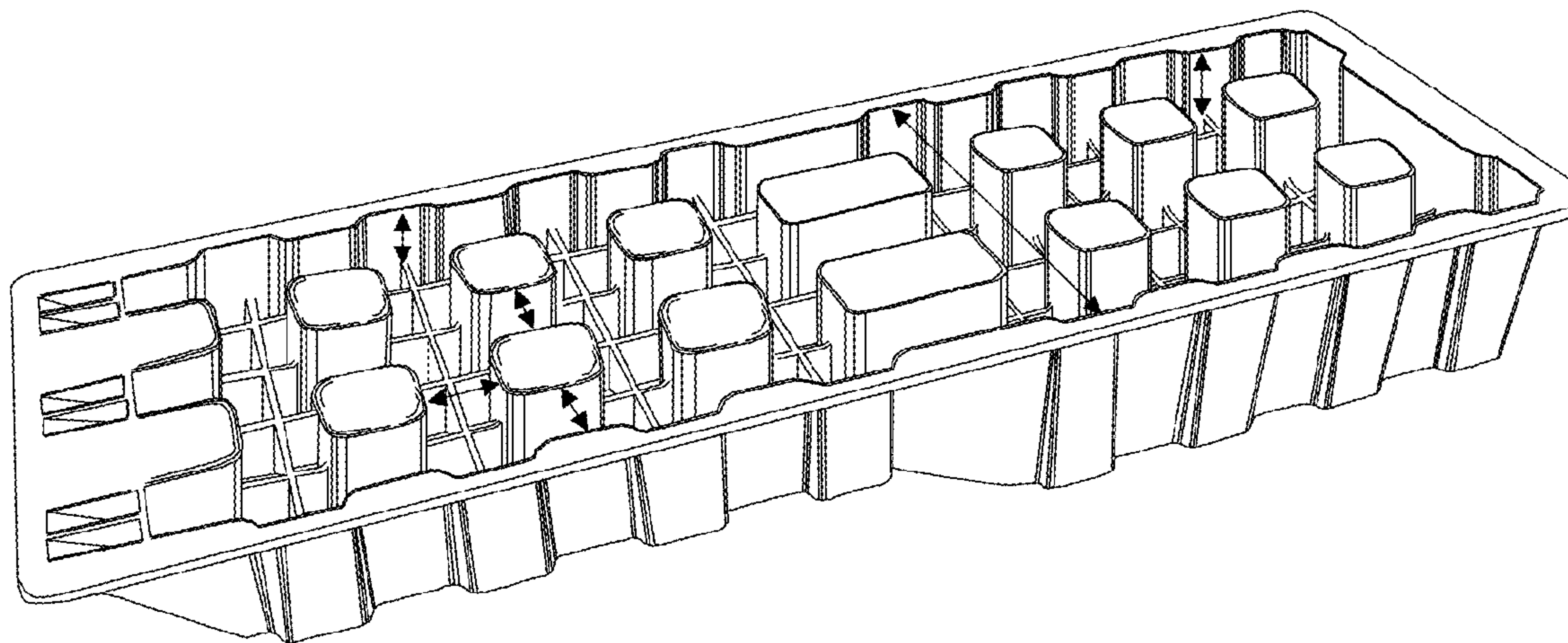
FIG. 3 is a top view thereof.

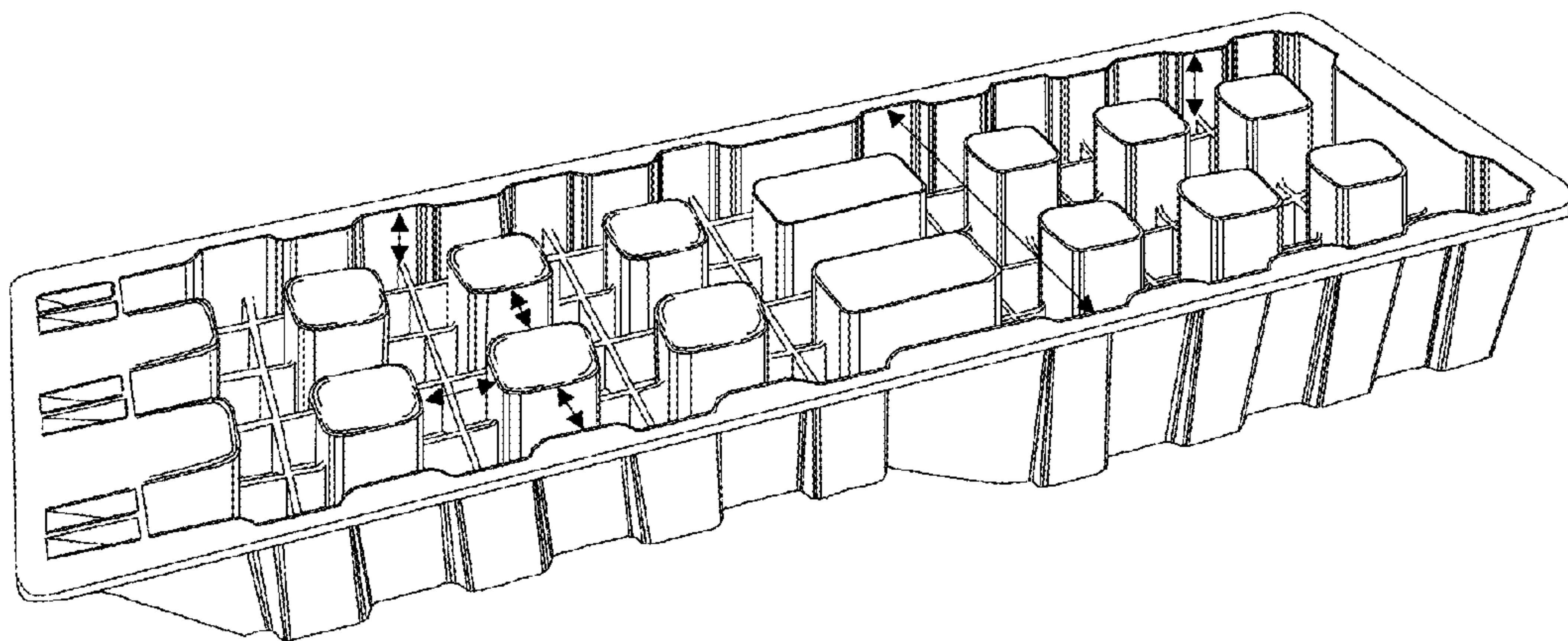

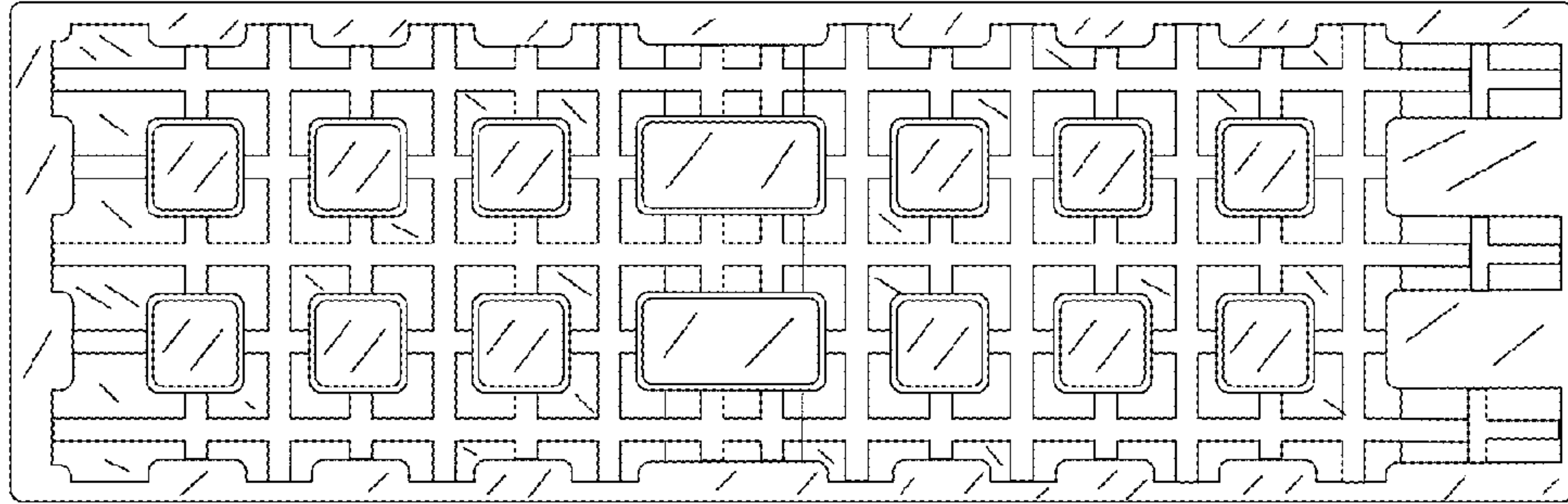

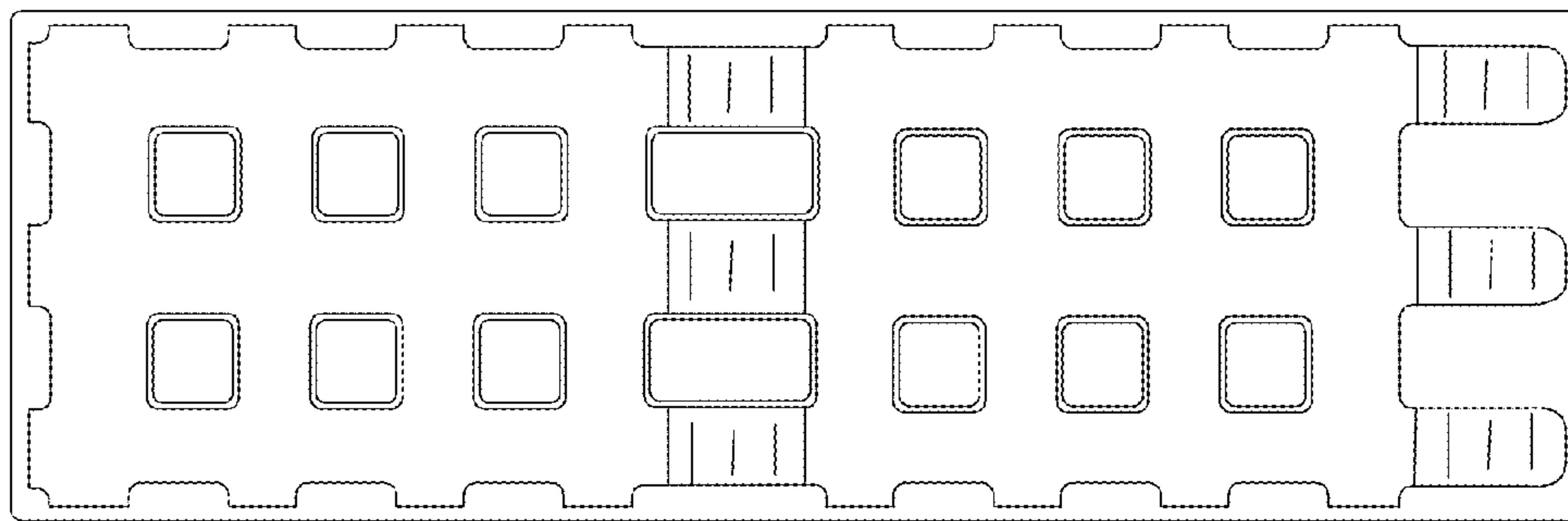

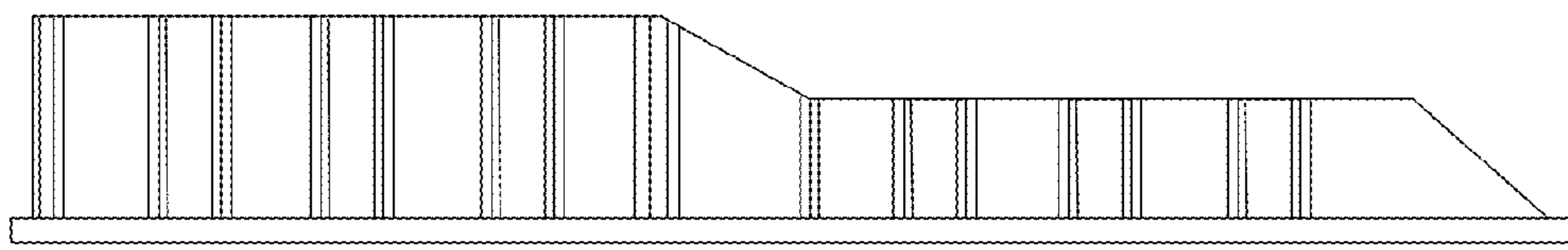

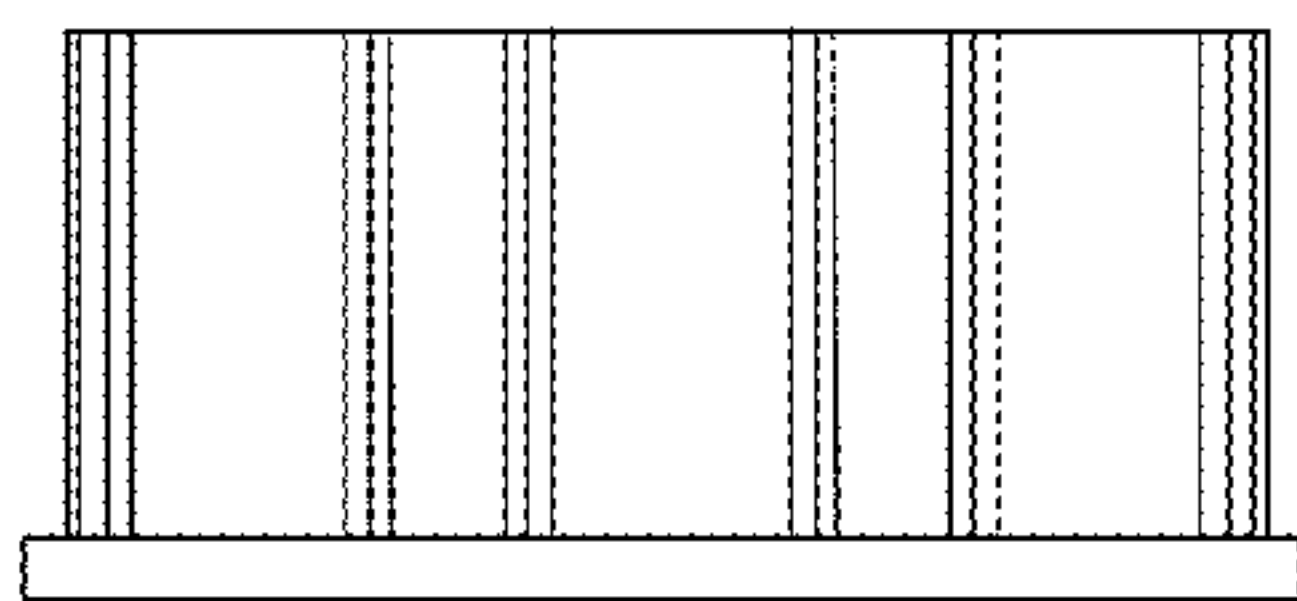

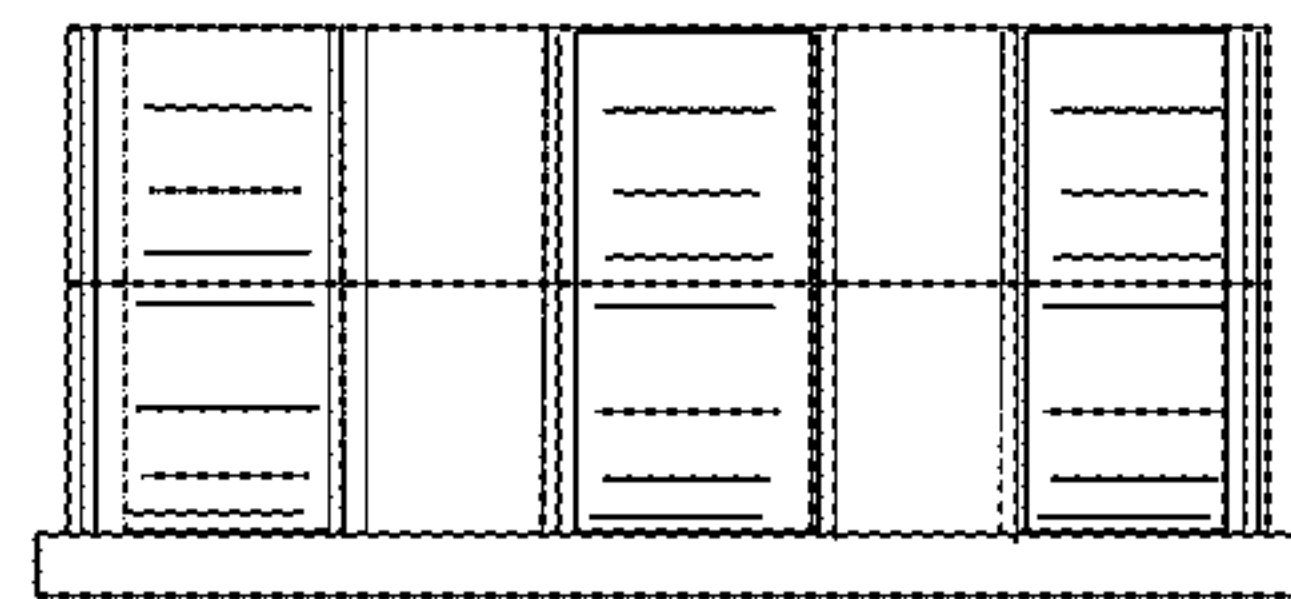

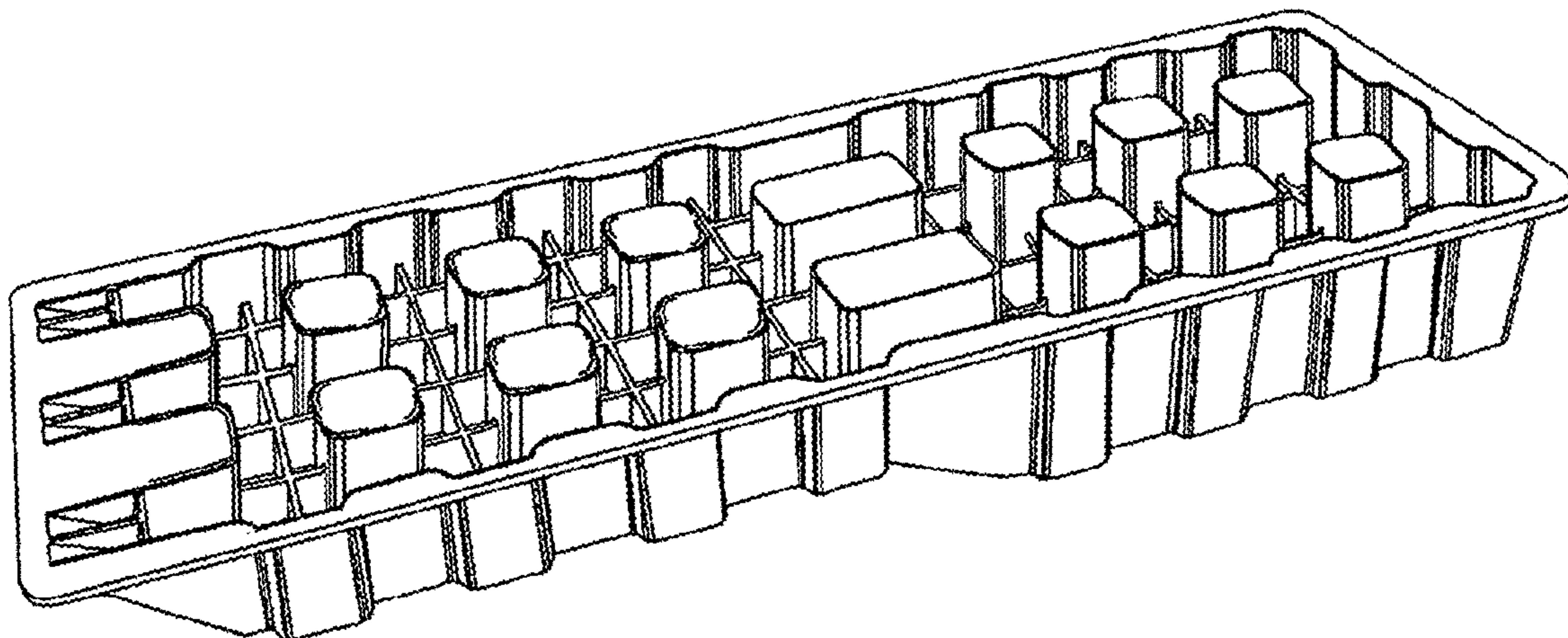

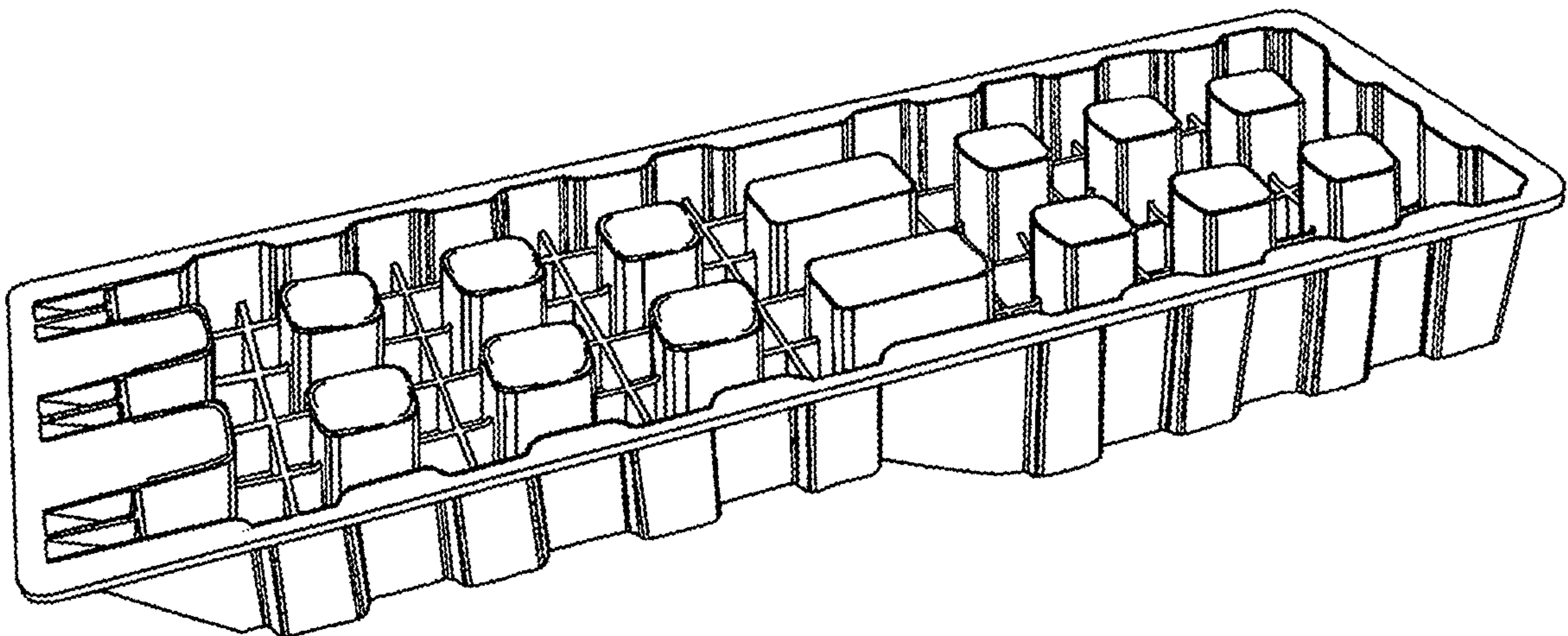

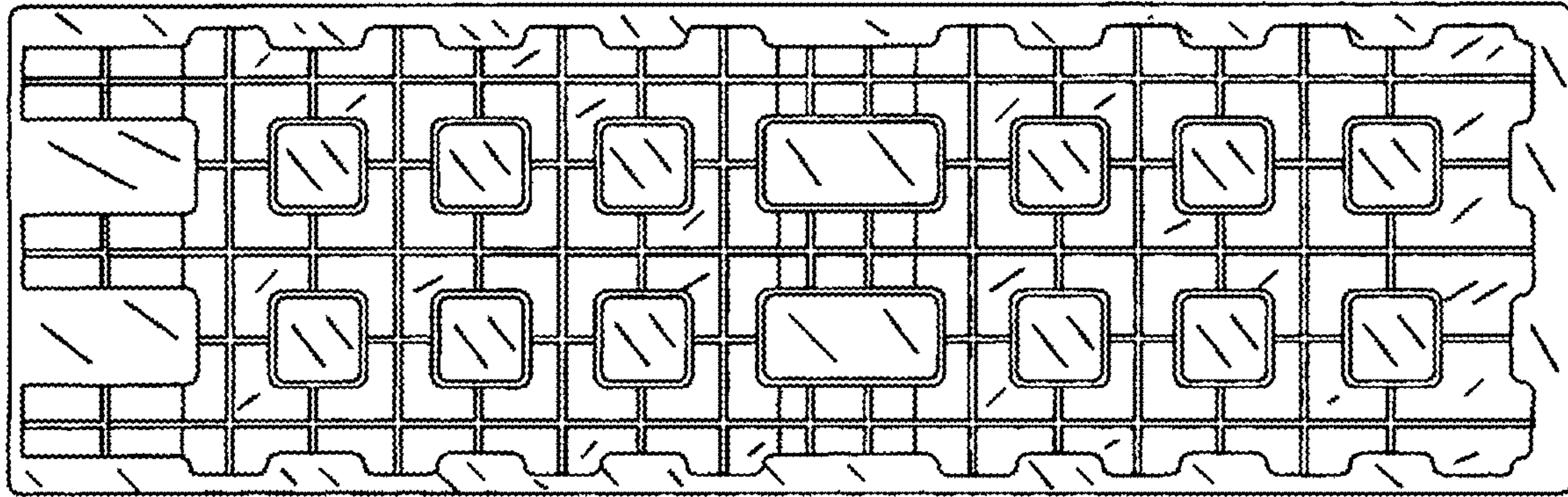

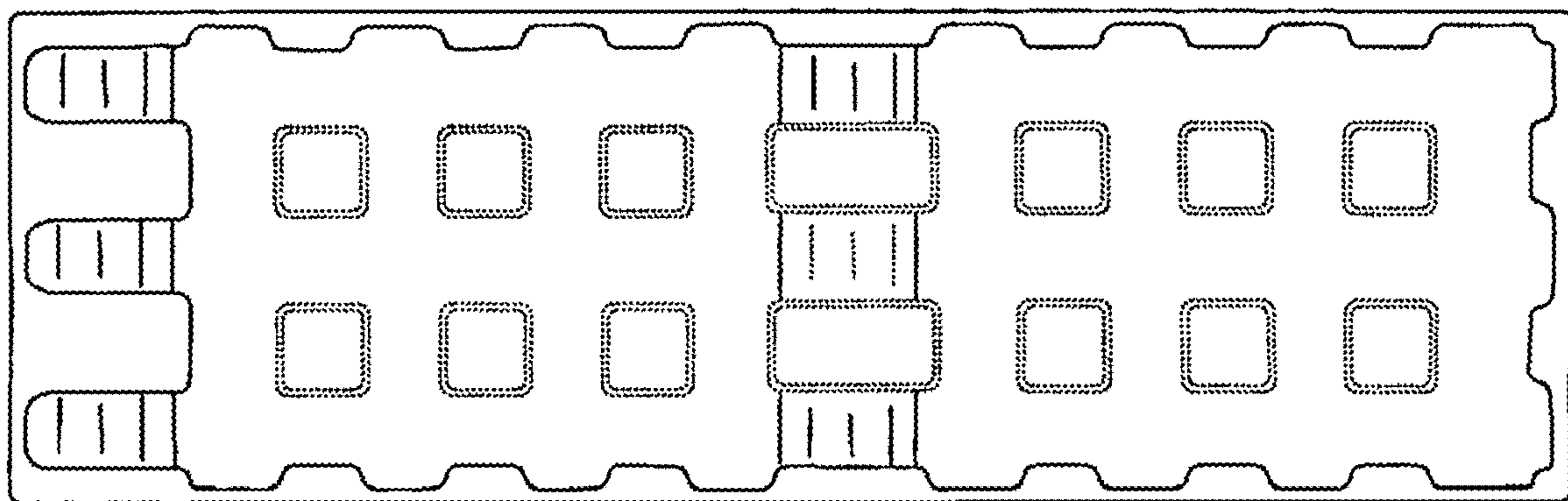
