(57) **CLAIM**

The ornamental design for a hat resembling a buckeye nut, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged frontal perspective view of a hat resembling a buckeye nut;
FIG. 2 is a frontal perspective view of said hat resembling a buckeye nut thereof;
FIG. 3 is a rear elevational view of said hat resembling a buckeye nut thereof;
FIG. 4 is a left elevational view of said hat resembling a buckeye nut thereof;
FIG. 5 is a right elevational view of said hat resembling a buckeye nut thereof;
FIG. 6 is a top plan view of said hat resembling a buckeye nut; and,
FIG. 7 is a bottom plan view of said hat resembling a buckeye nut thereof.

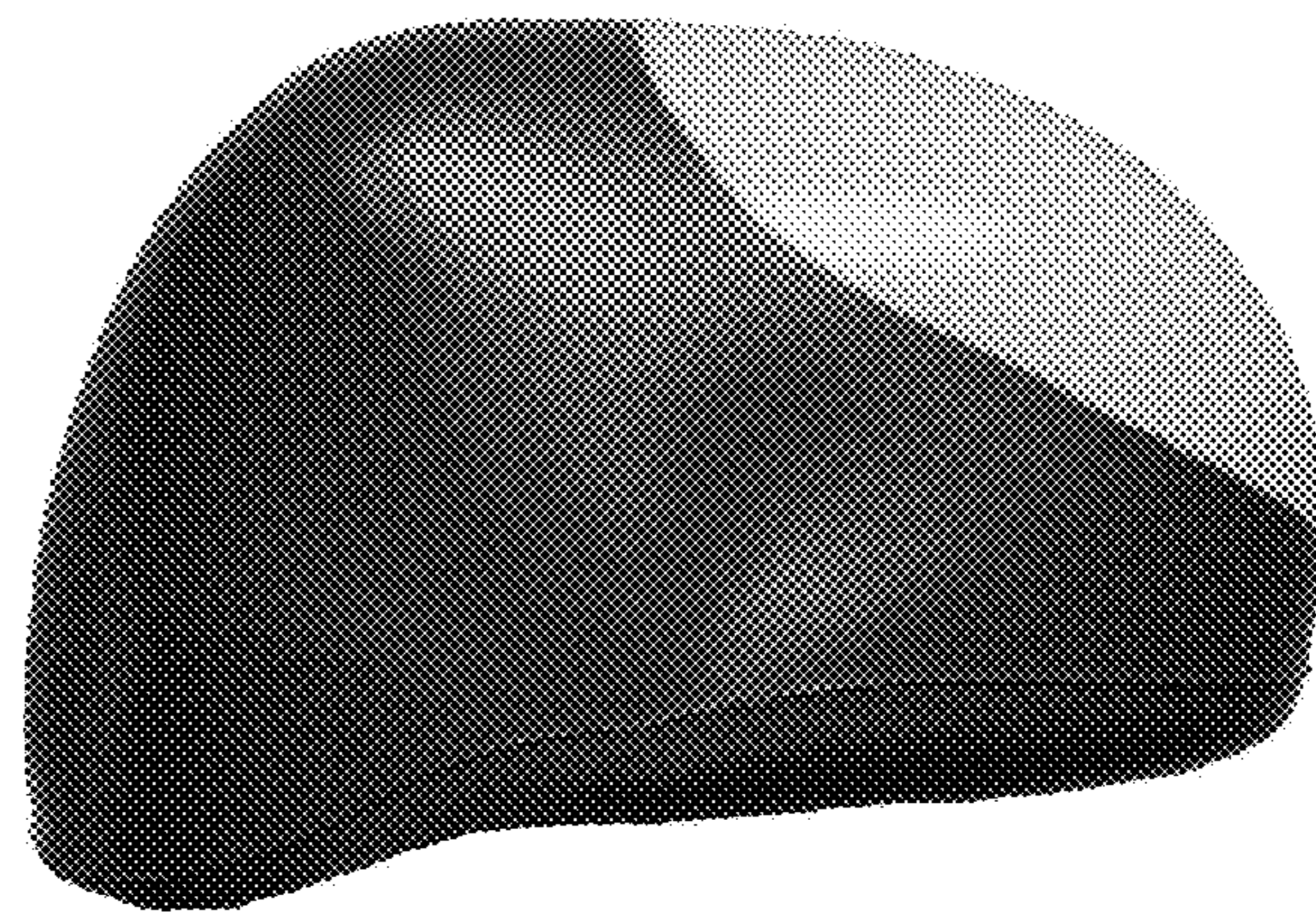
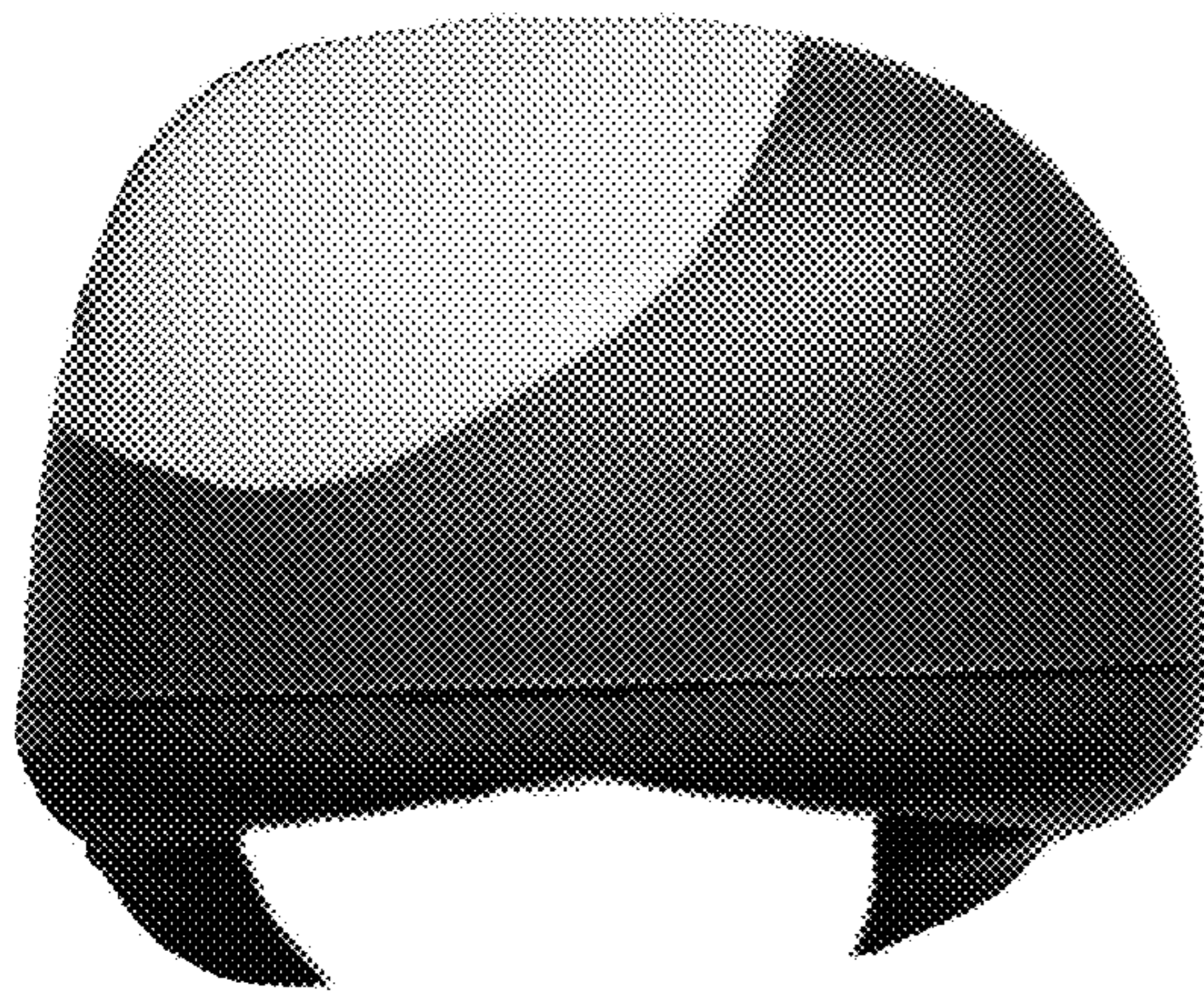

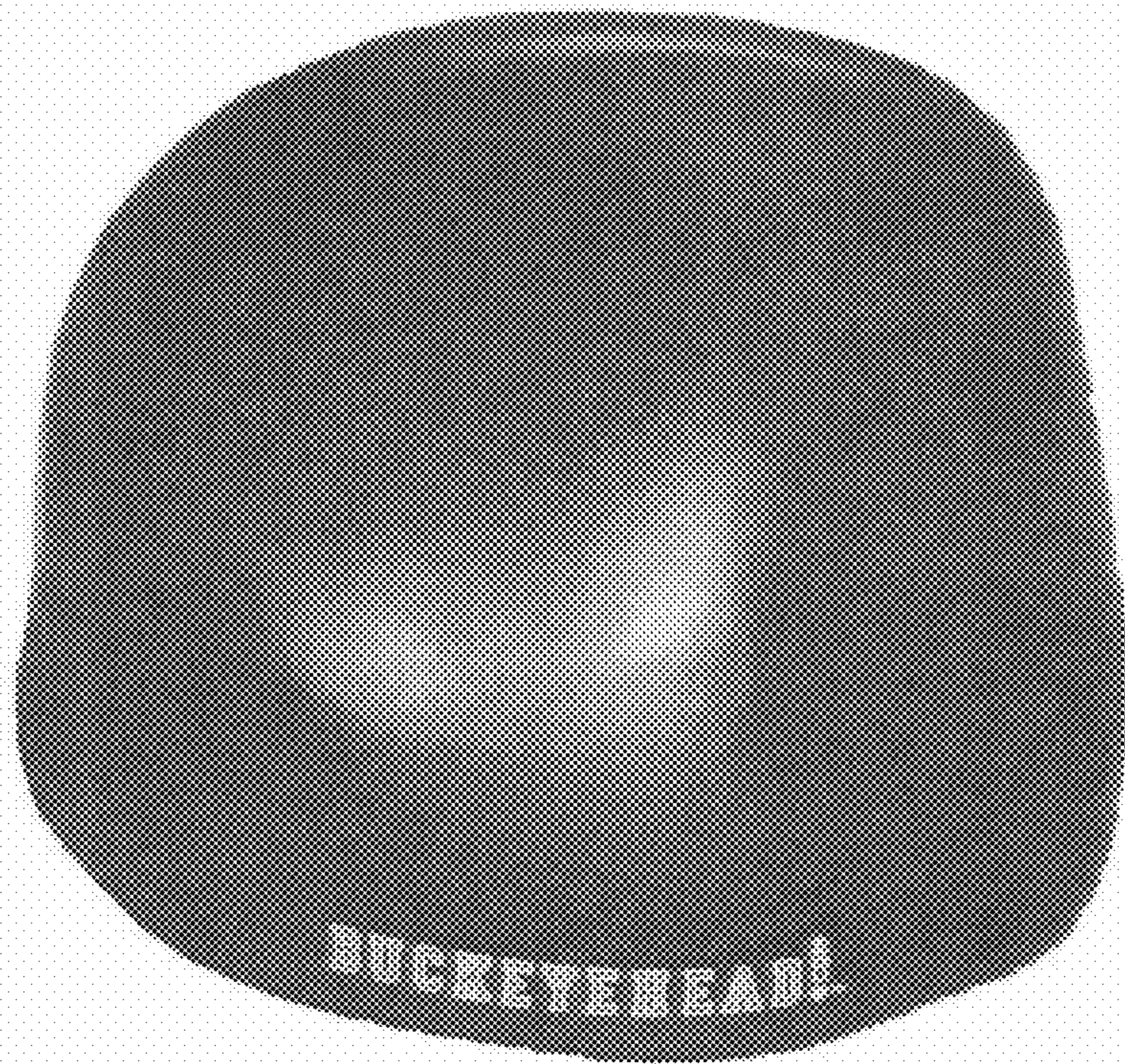

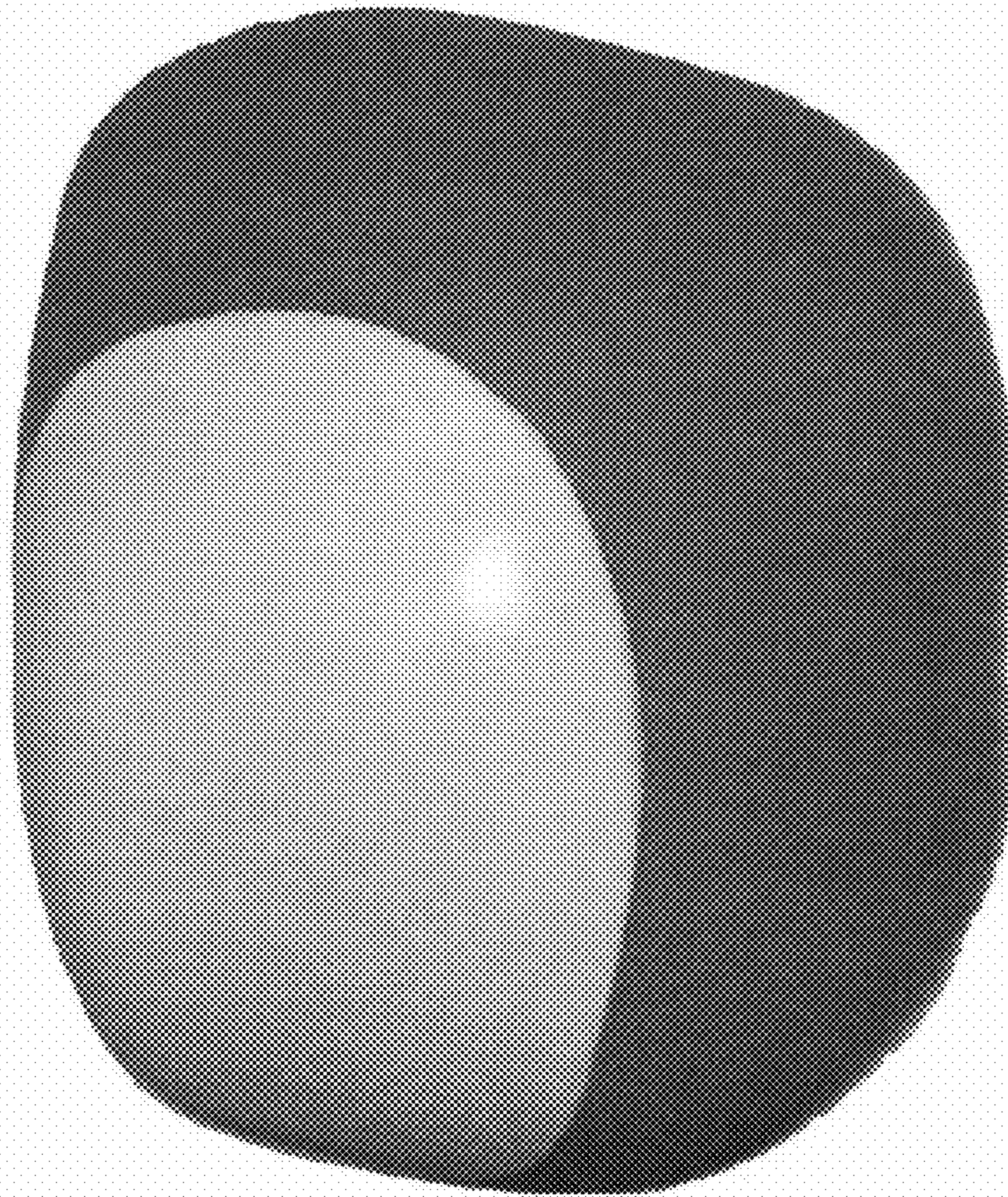

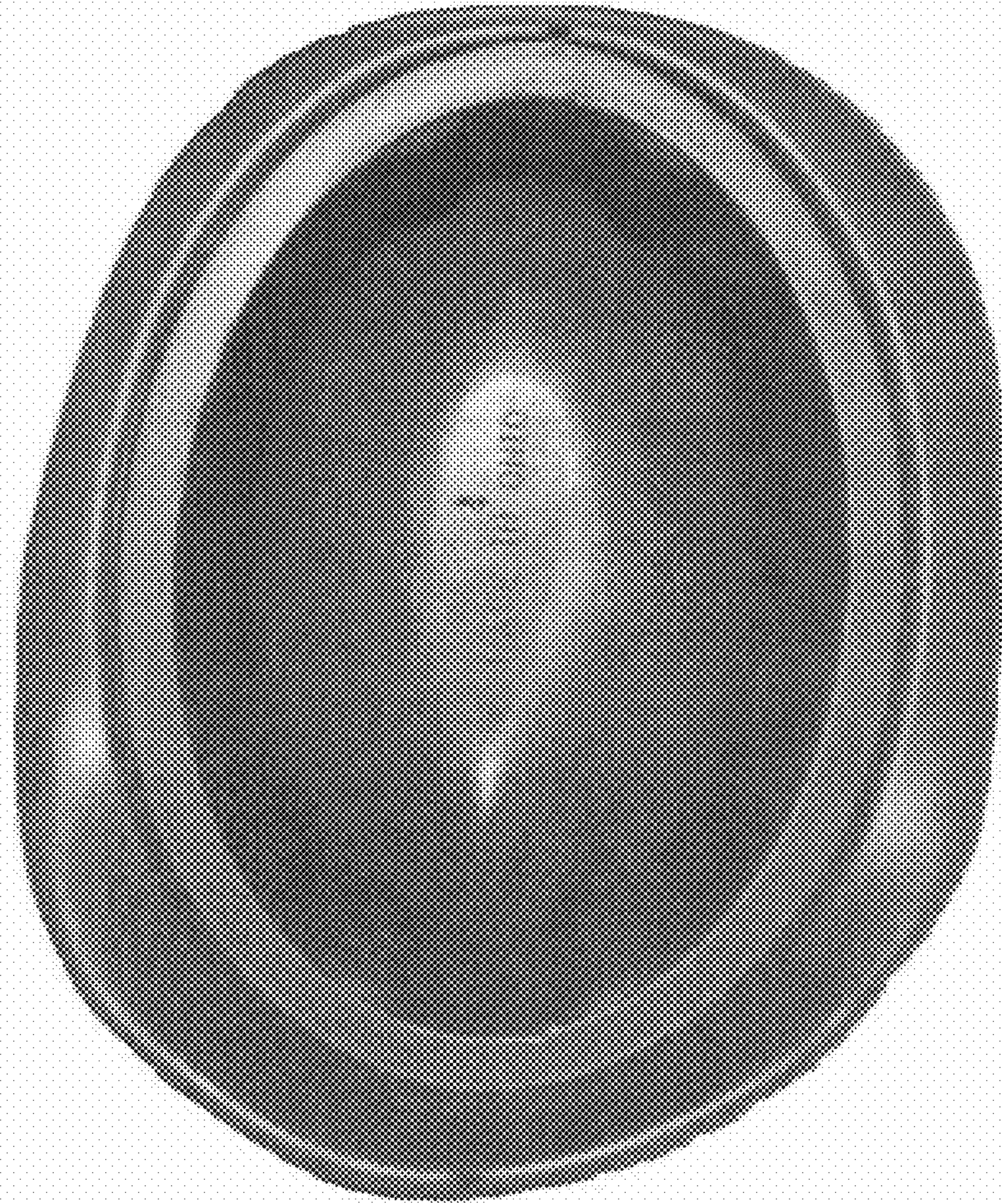
