(57) **CLAIM**

The ornamental design for a mobile phone carrier attachable to footwear, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a mobile phone carrier attachable to footwear showing my new design, the mobile phone carrier being shown in a closed configuration;

FIG. 2 is an environmental top plan view thereof, illustrating the mobile phone carrier attached to an article of footwear;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is an environmental left side elevational view thereof, illustrating the mobile phone carrier attached to an article of footwear;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a rear end elevational view thereof;

FIG. 8 is a front end elevational view thereof;

FIG. 9 is a second top plan view of the mobile phone carrier attachable to footwear of FIG. 1, the mobile phone carrier being shown in an opened configuration;

FIG. 10 is a left side elevational view thereof;

FIG. 11 is a right side elevational view thereof;

FIG. 12 is a bottom plan view thereof;

FIG. 13 is a rear end elevational view thereof; and,

FIG. 14 is a front end elevational view thereof.

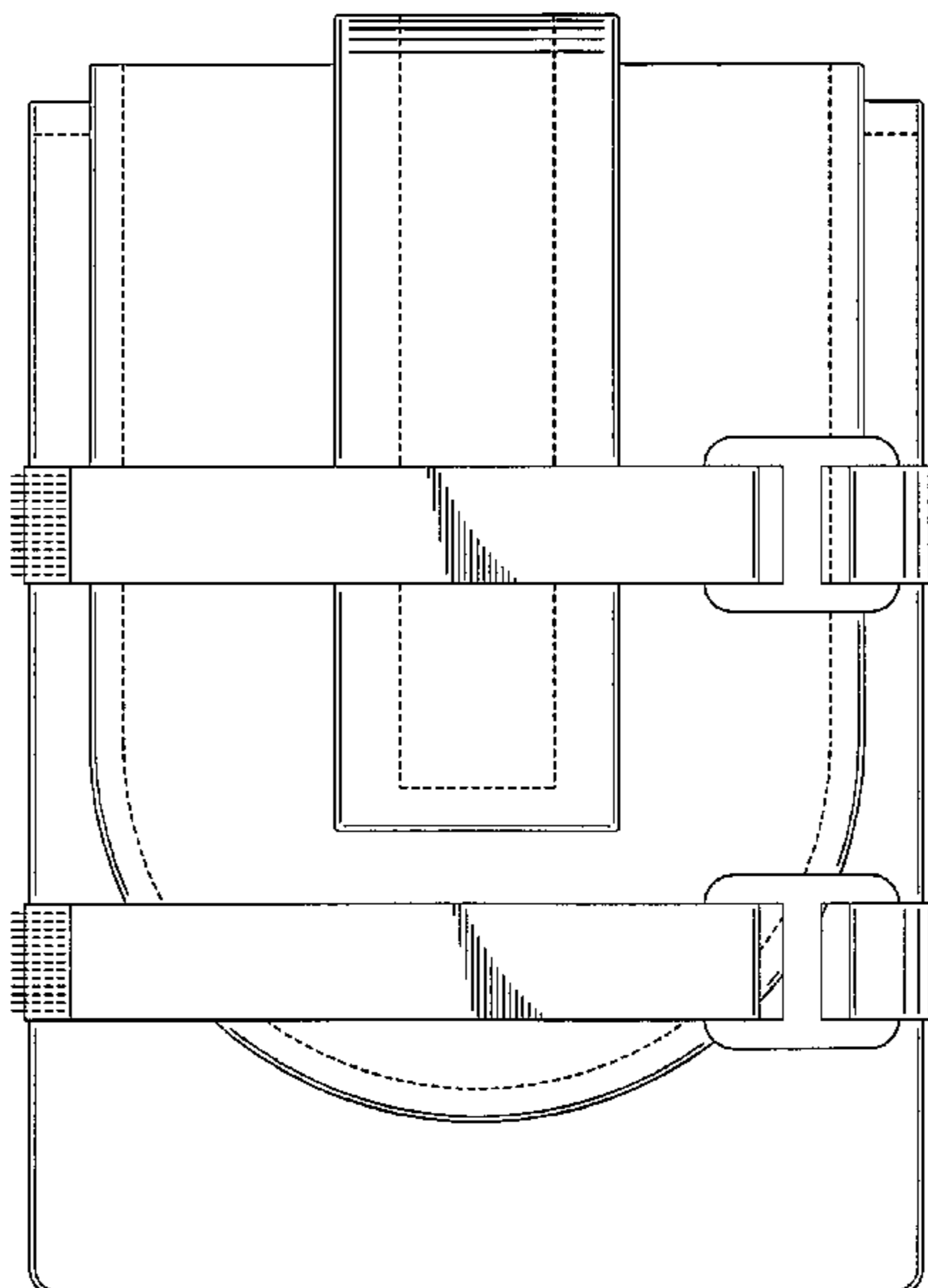

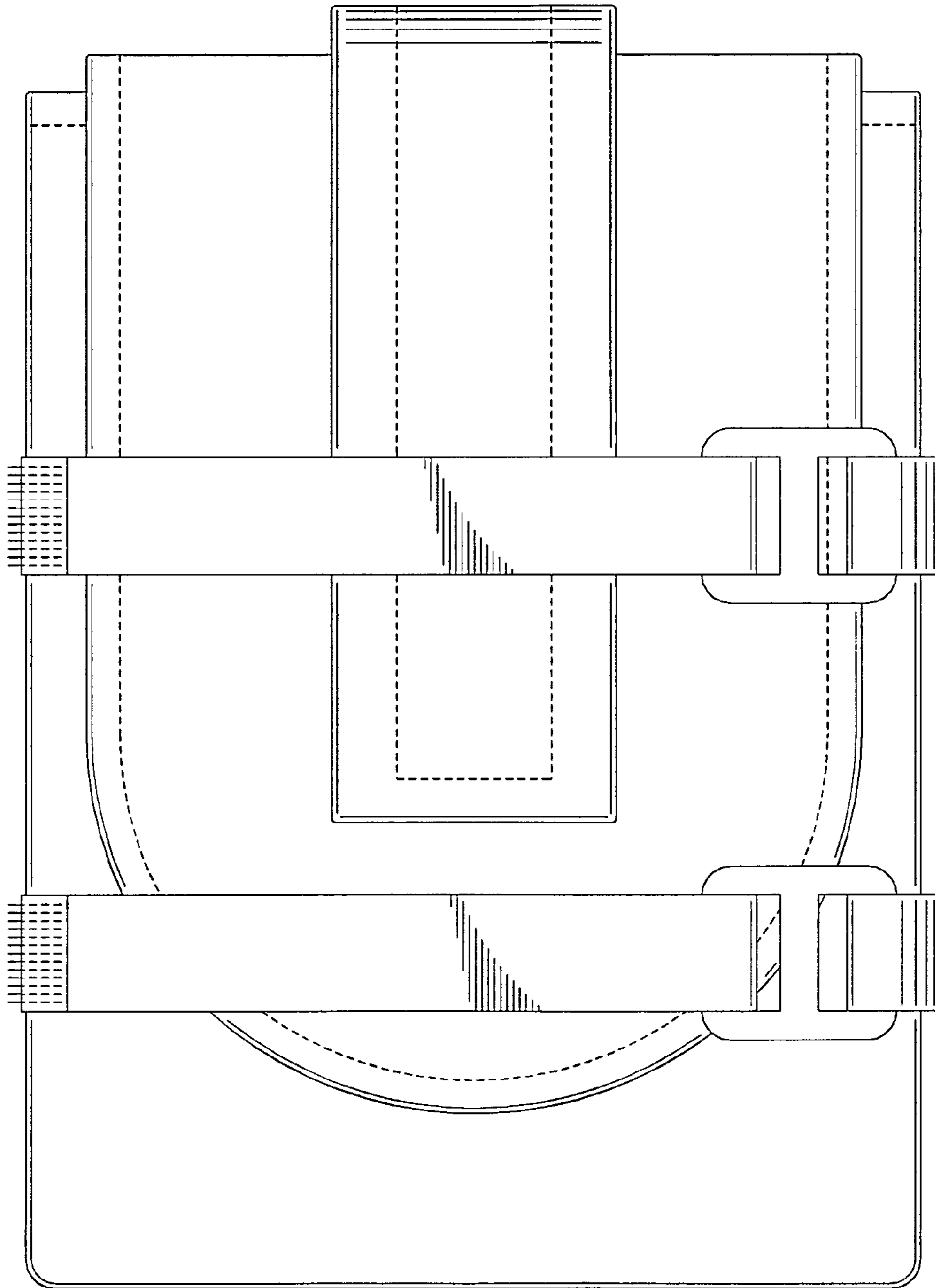

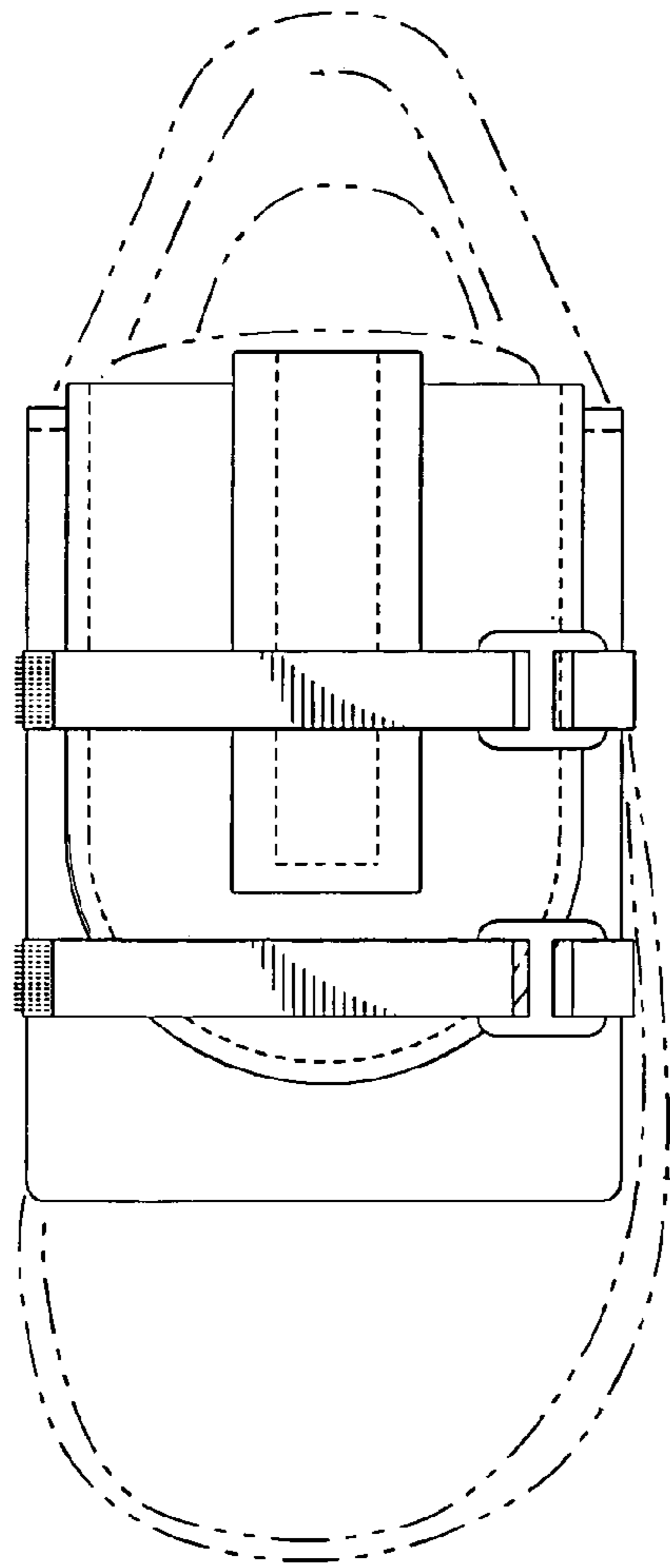

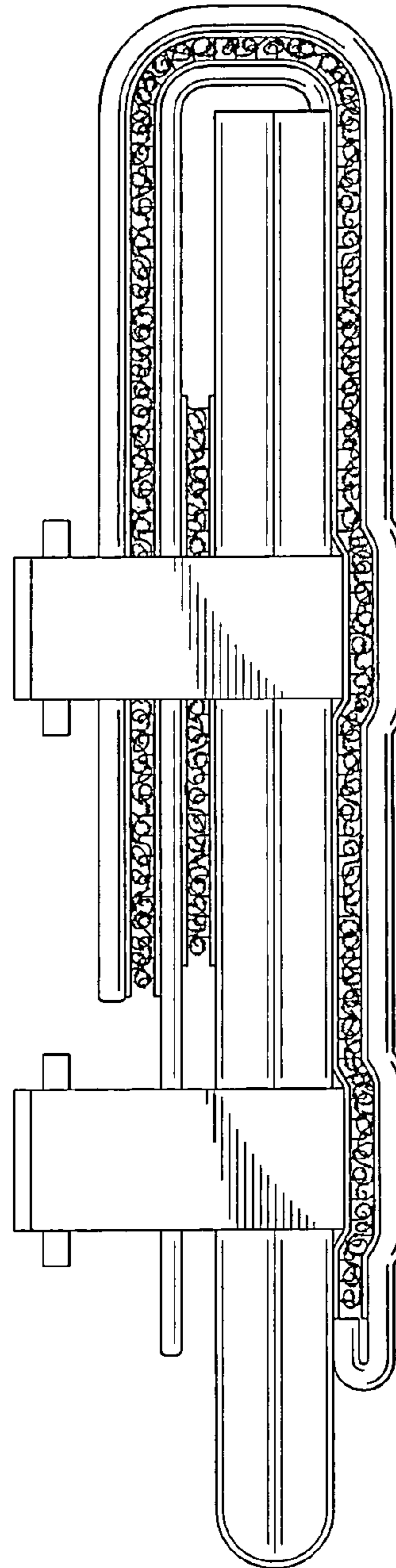

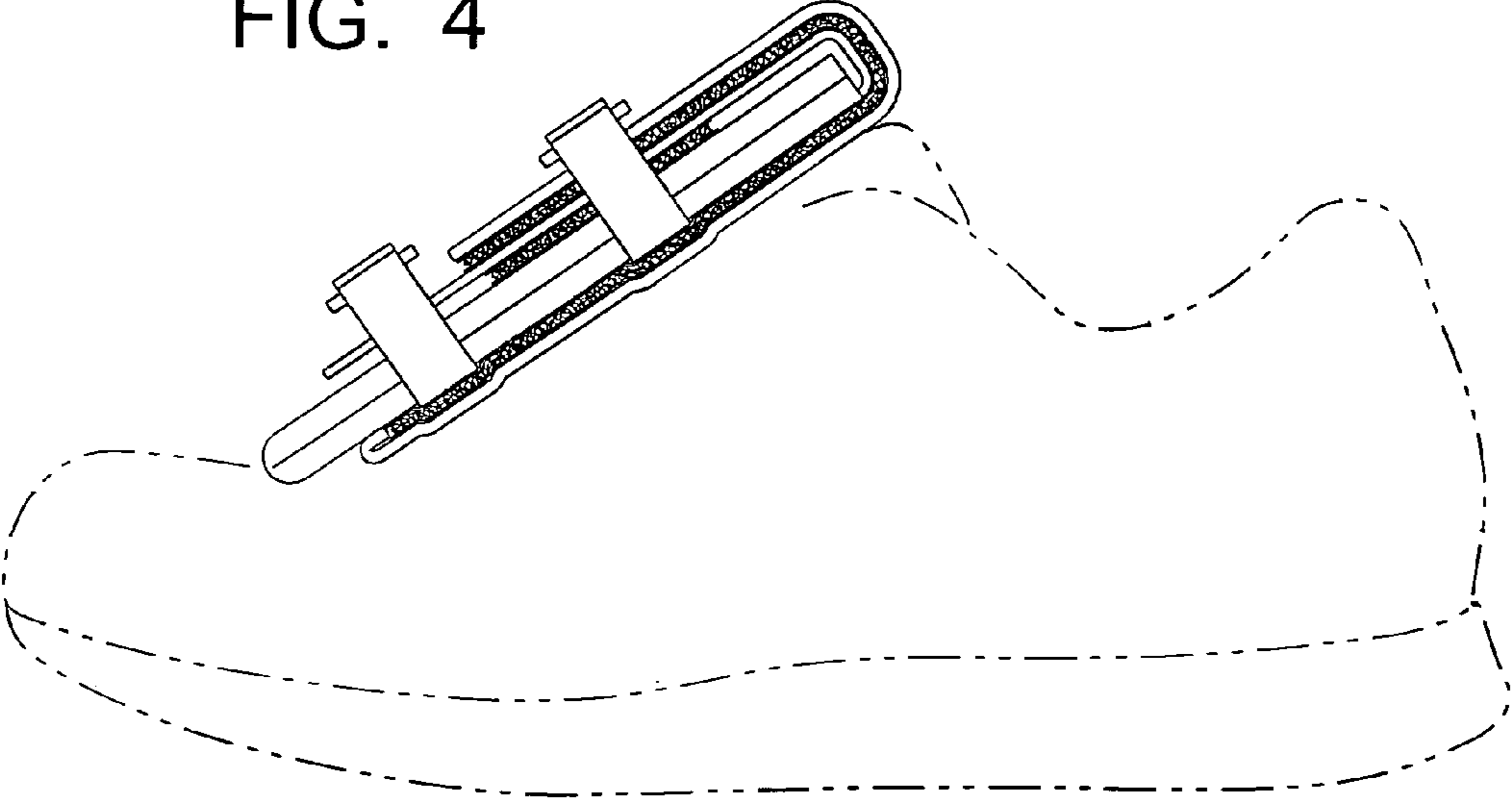

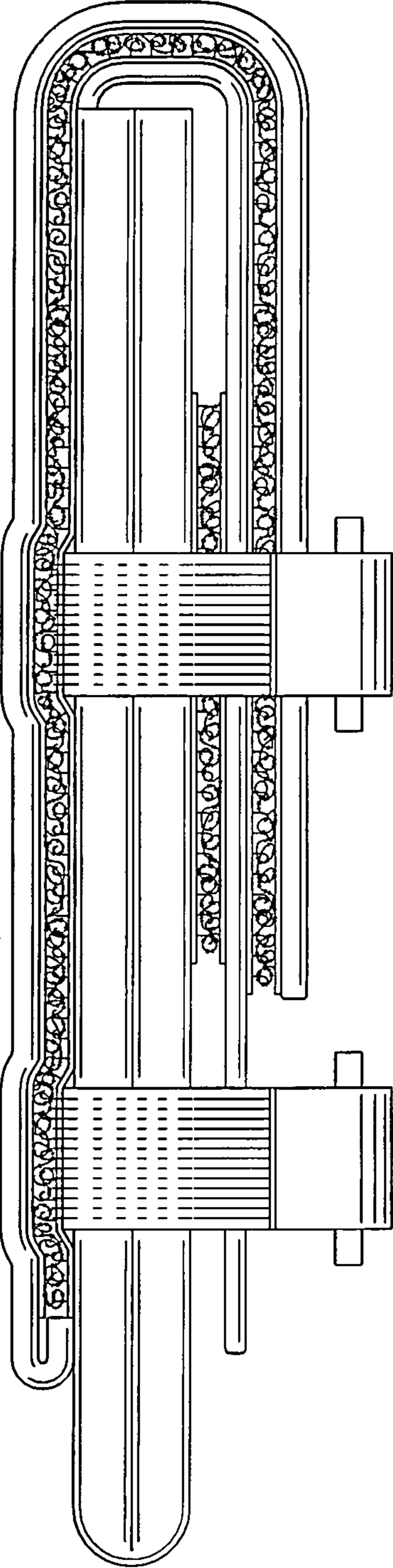

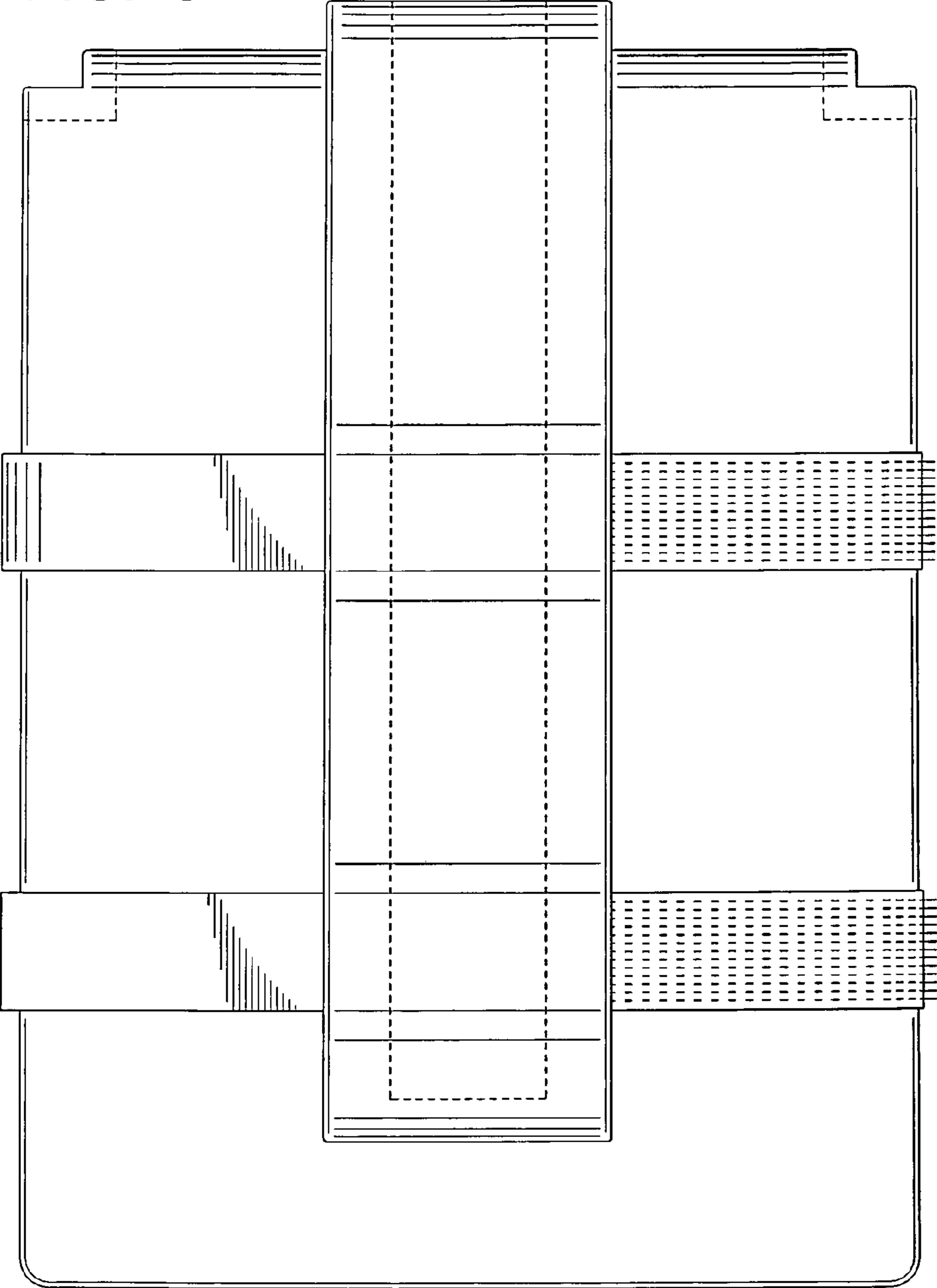

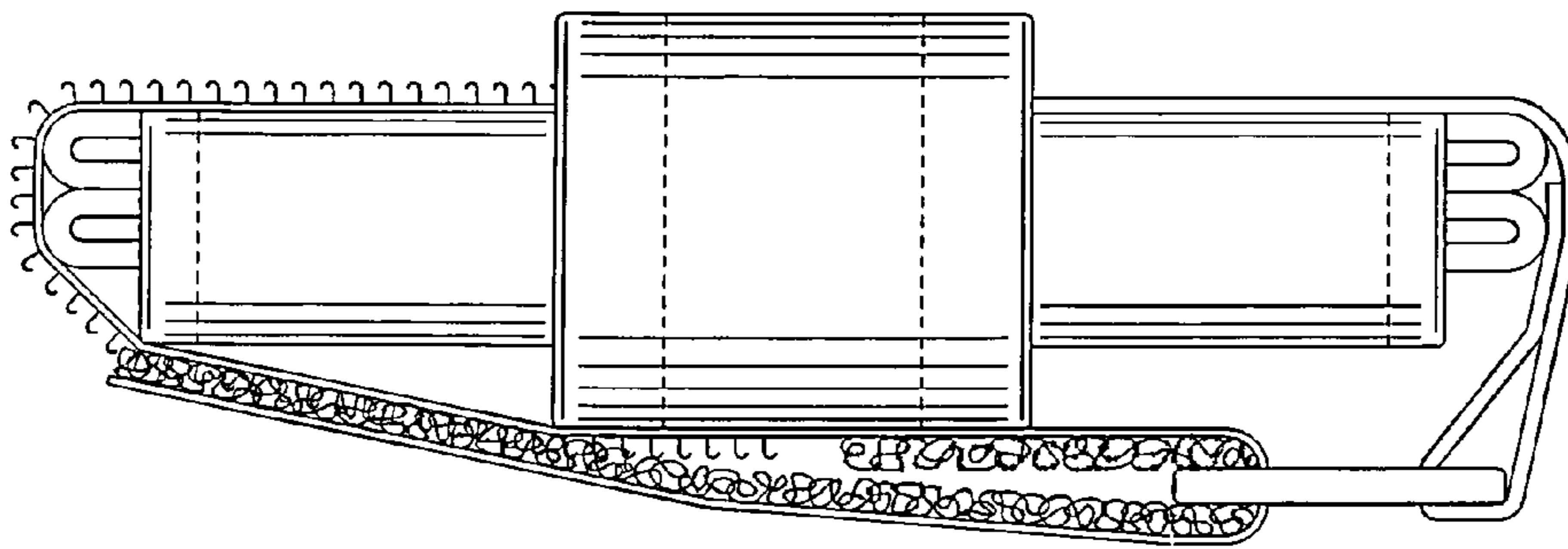

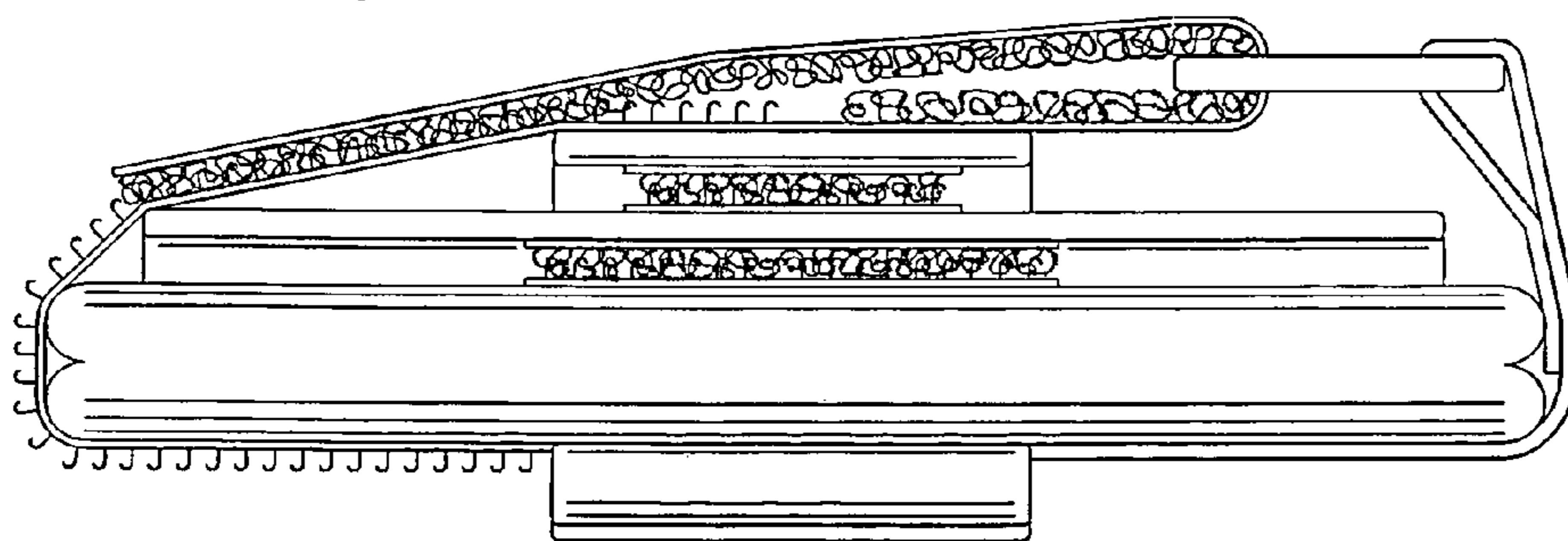

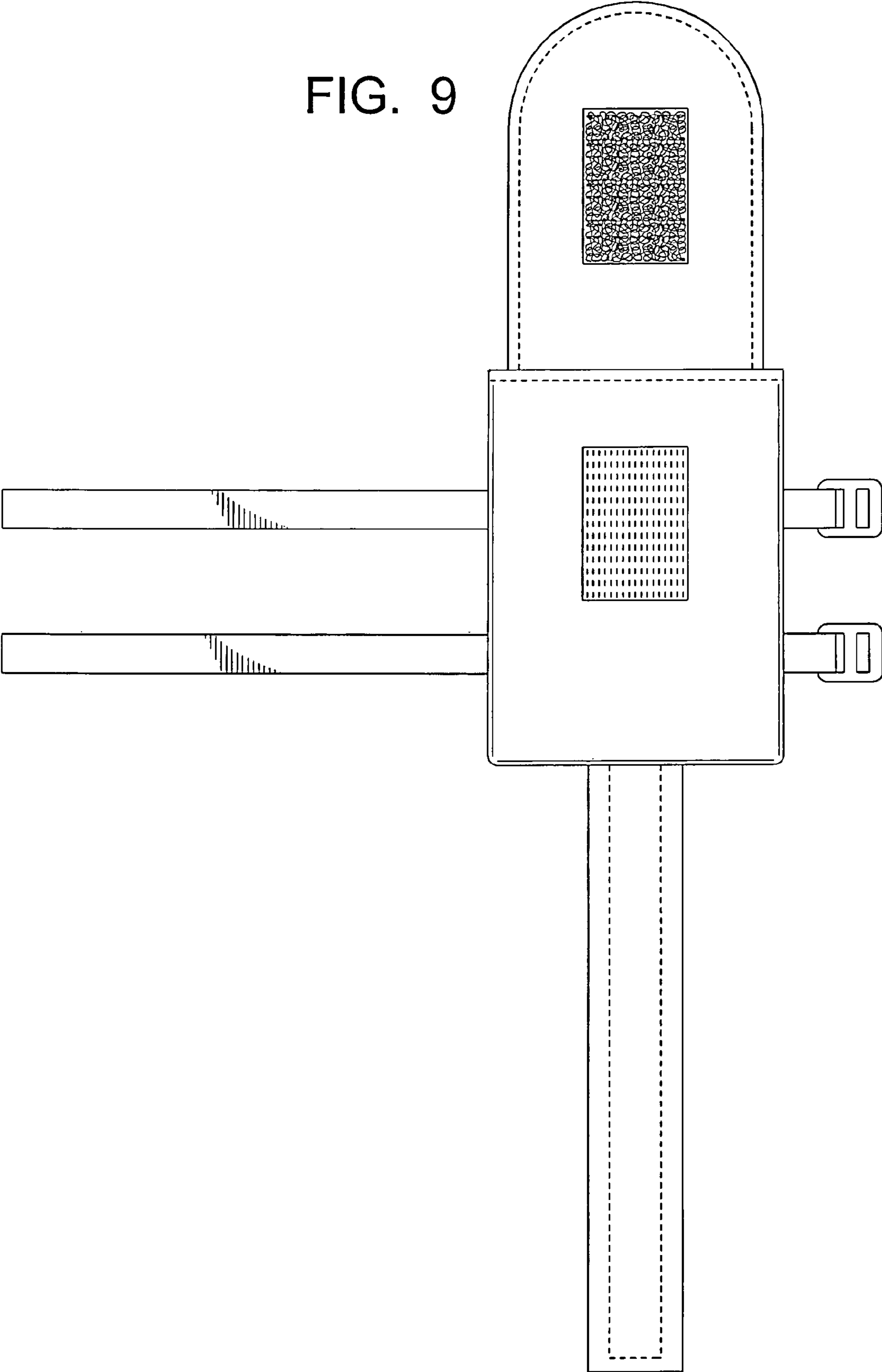

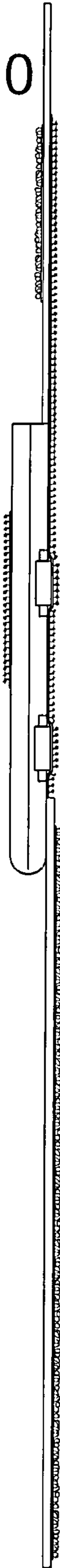

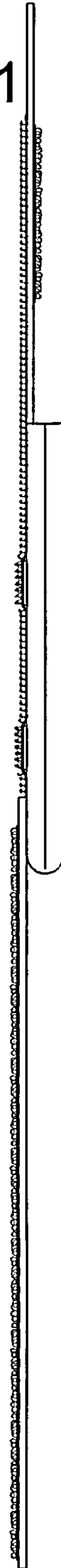

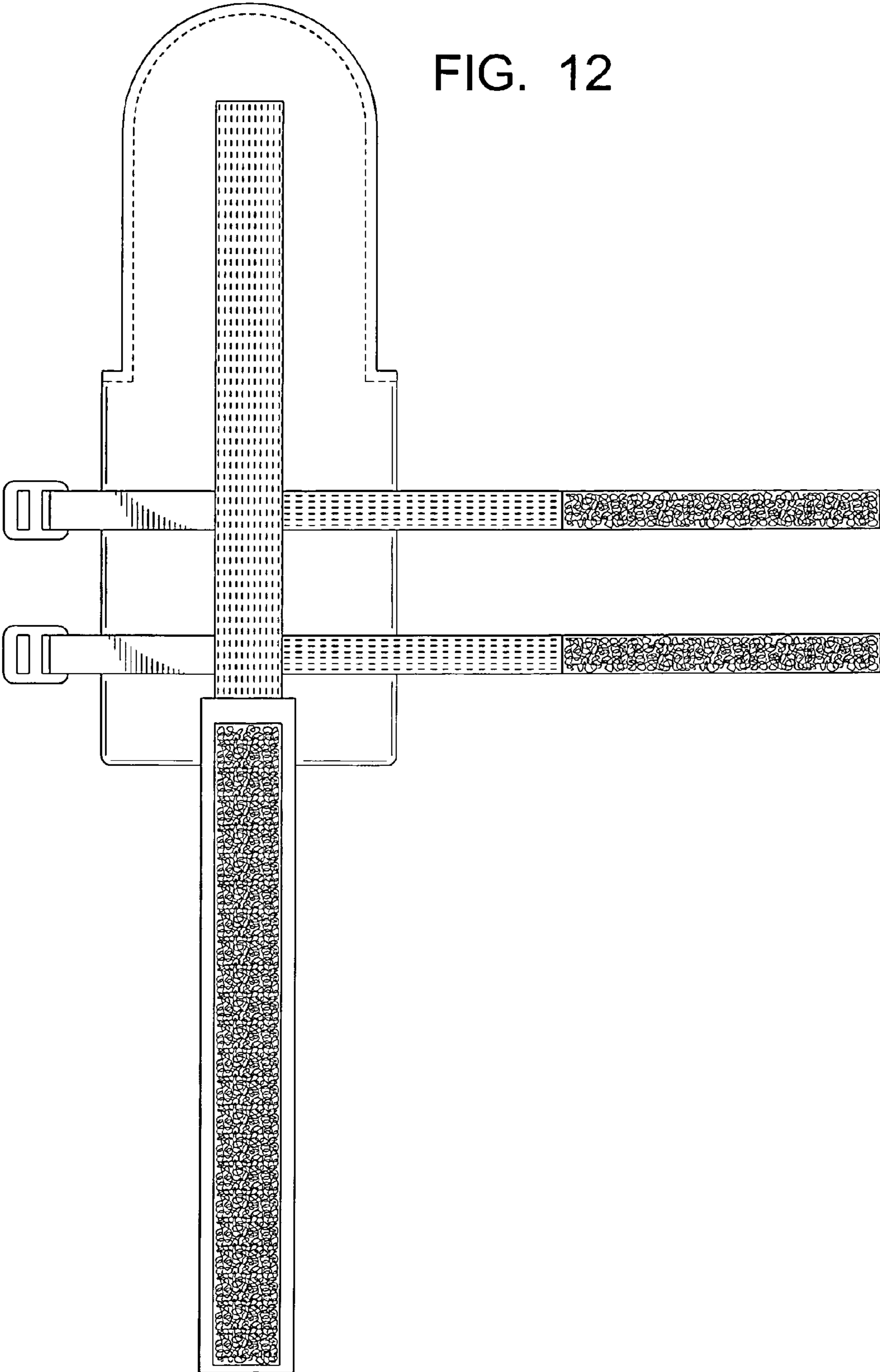

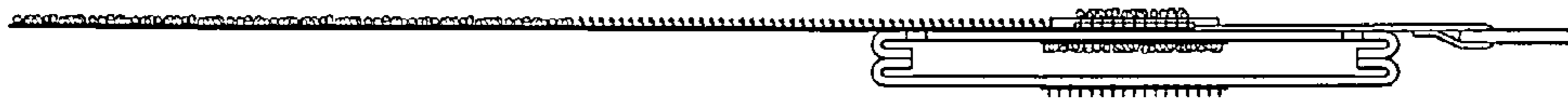
