(57) **CLAIM**

The ornamental design for a portion of a wall of an escalator, moving walkway, elevator, or lifting apparatus, as shown and described.

**DESCRIPTION**

The drawing FIGURE is a front view of a portion of a wall of an escalator, moving walkway, elevator, or lifting apparatus having a of a bamboo radiant color appearance.

The broken lines surrounding the portion of a wall of an escalator, moving walkway, elevator, or lifting apparatus represent unclaimed environmental structure and the boundaries of the claim and form no part thereof.

The portion of a wall of an escalator, moving walkway, elevator, or lifting apparatus is flat and planar.
