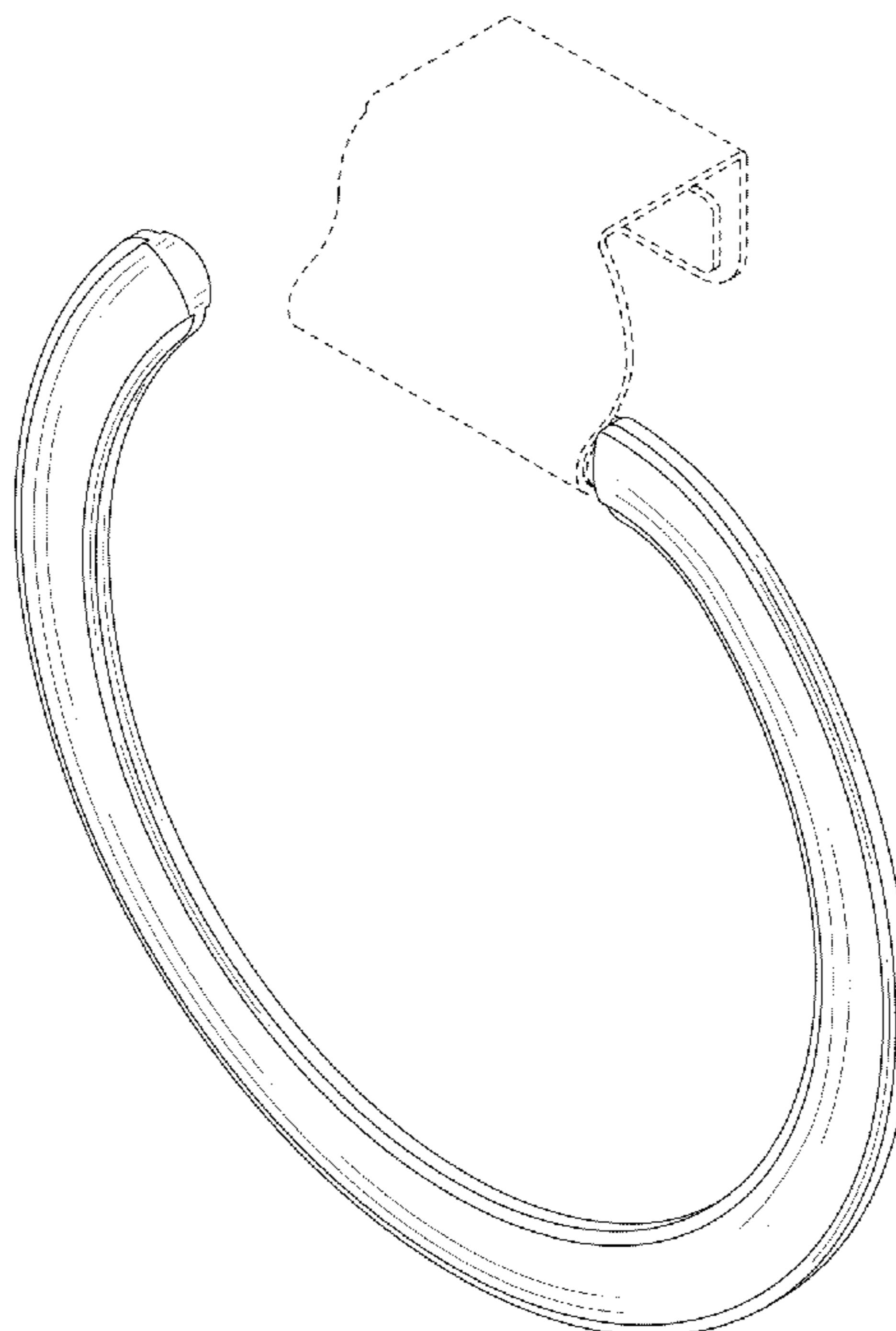
FIG. 1 is a perspective view of a towel ring showing a new design;

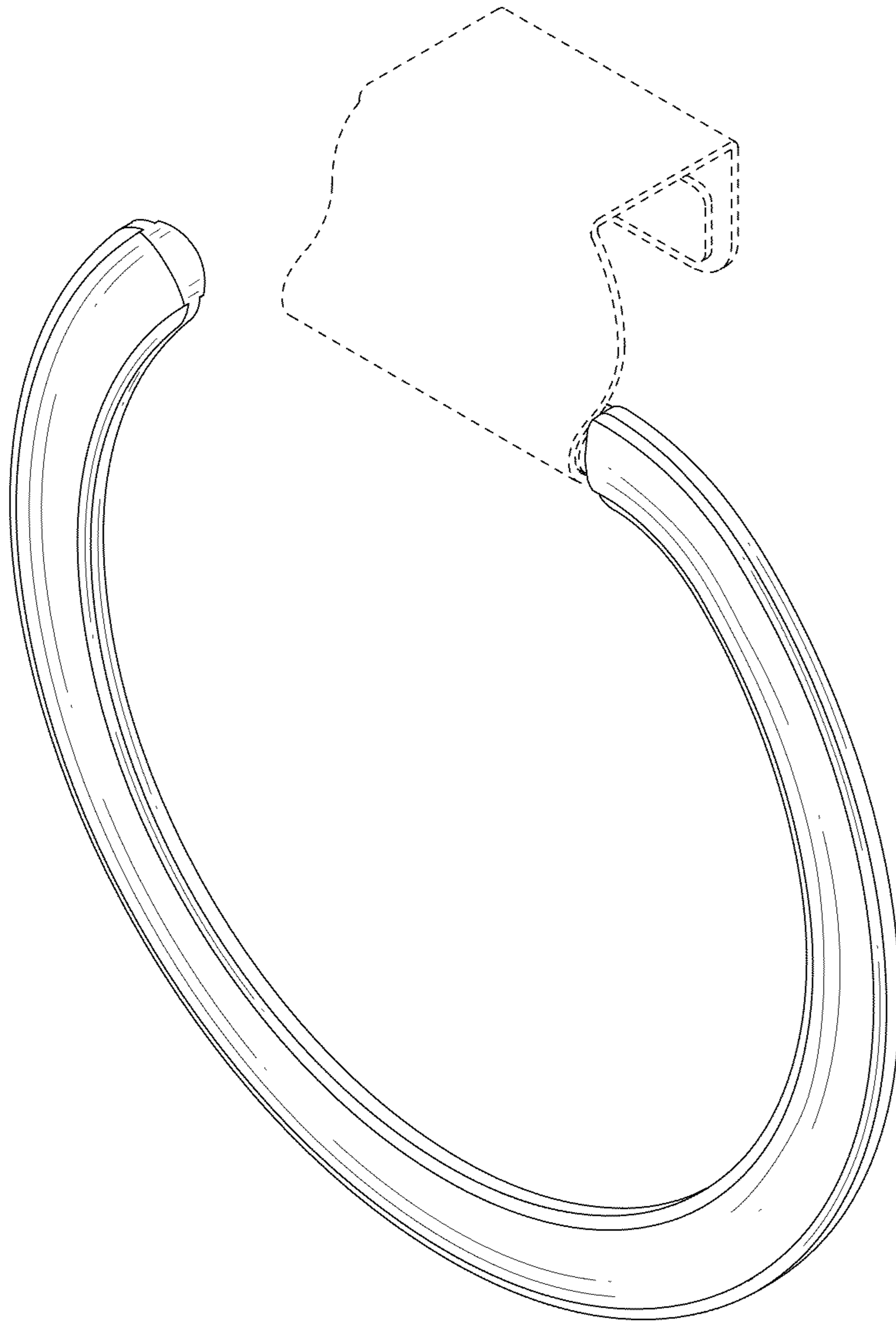

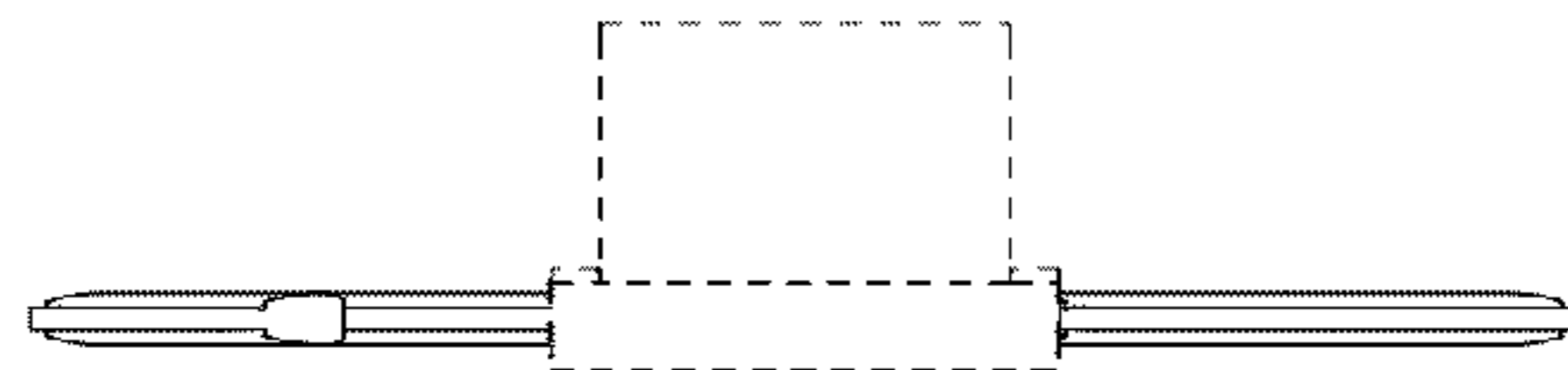

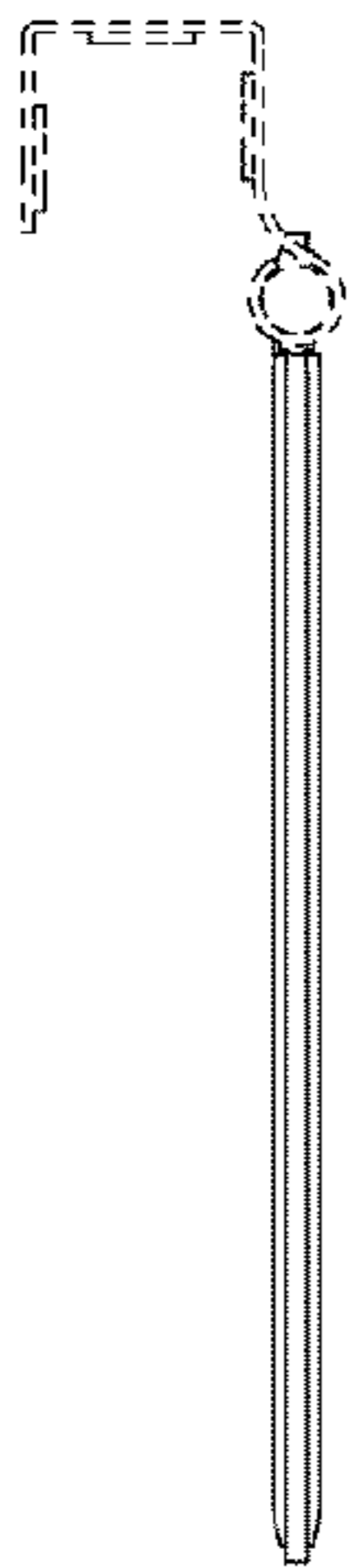

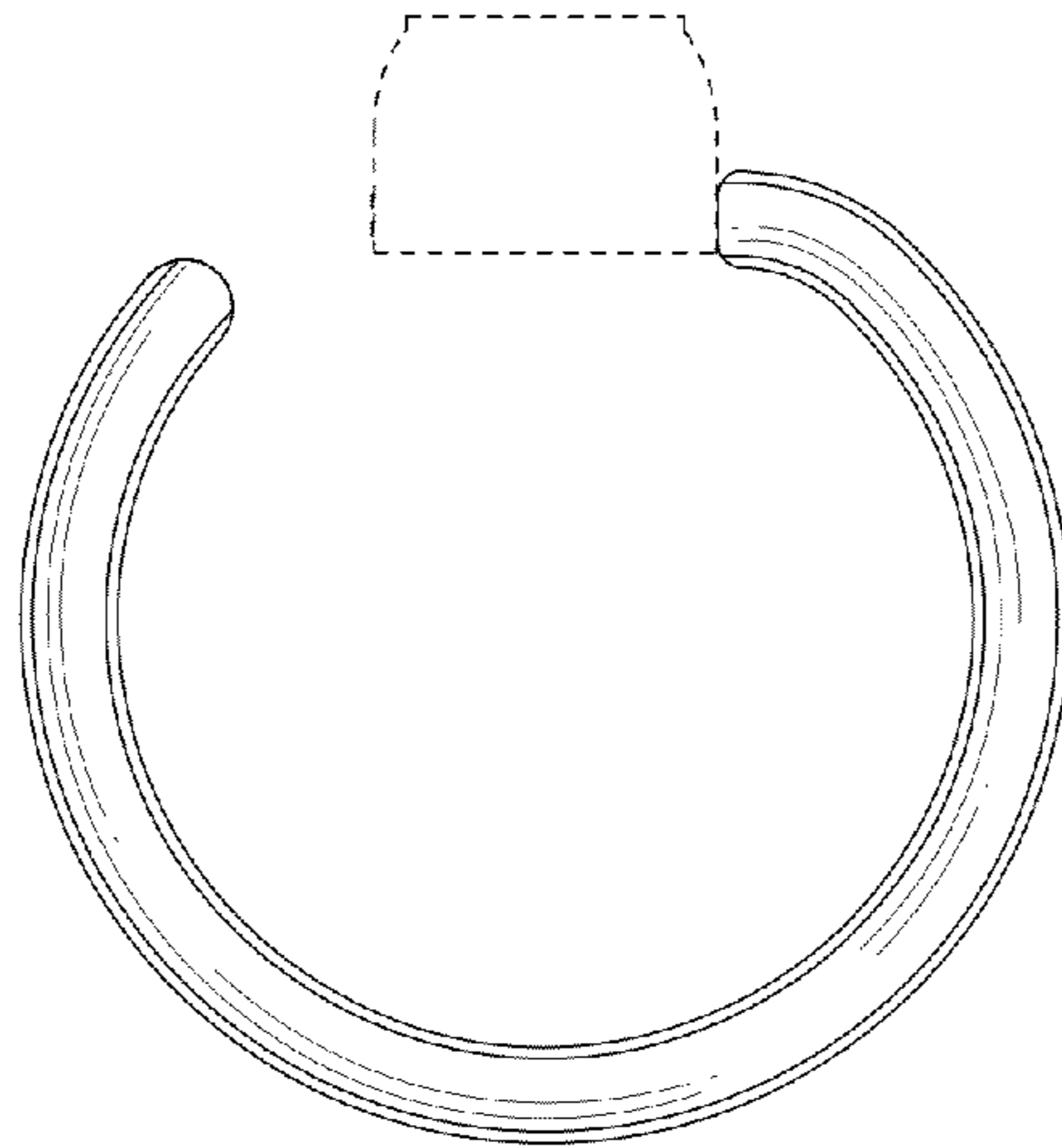

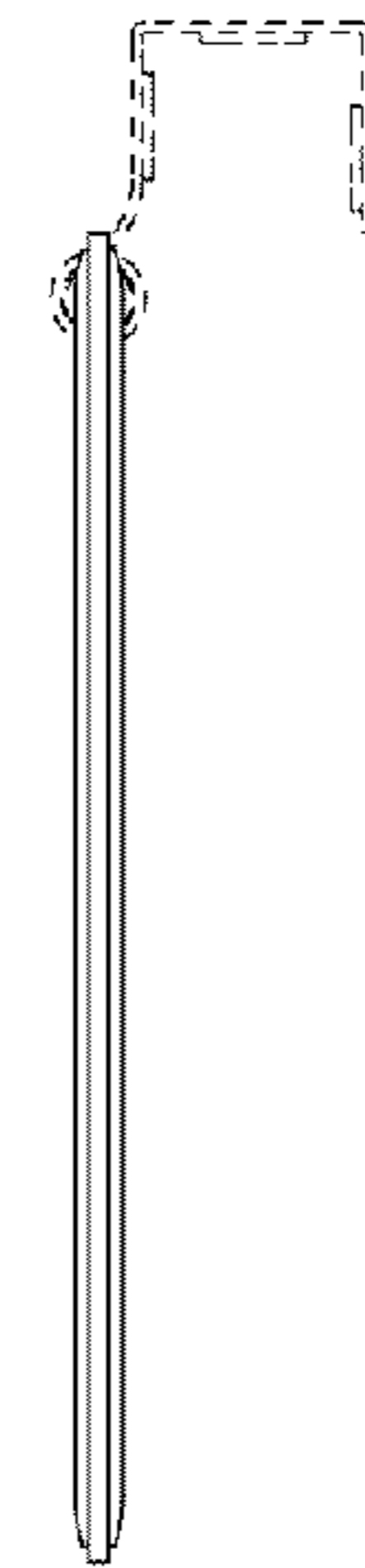

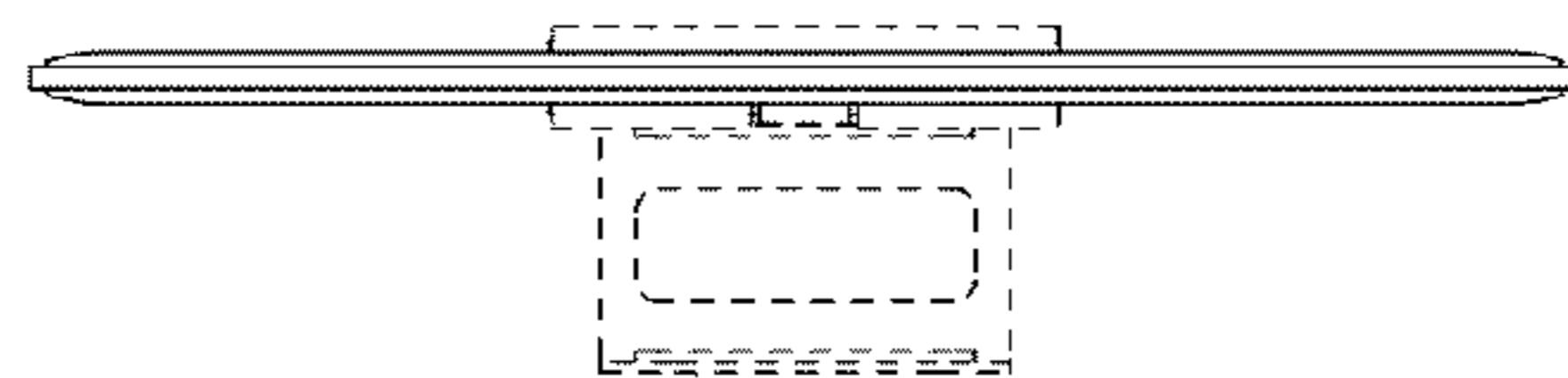

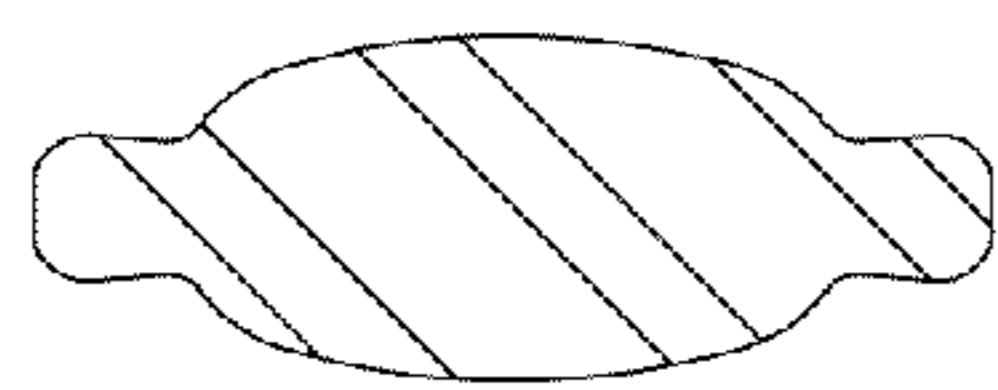

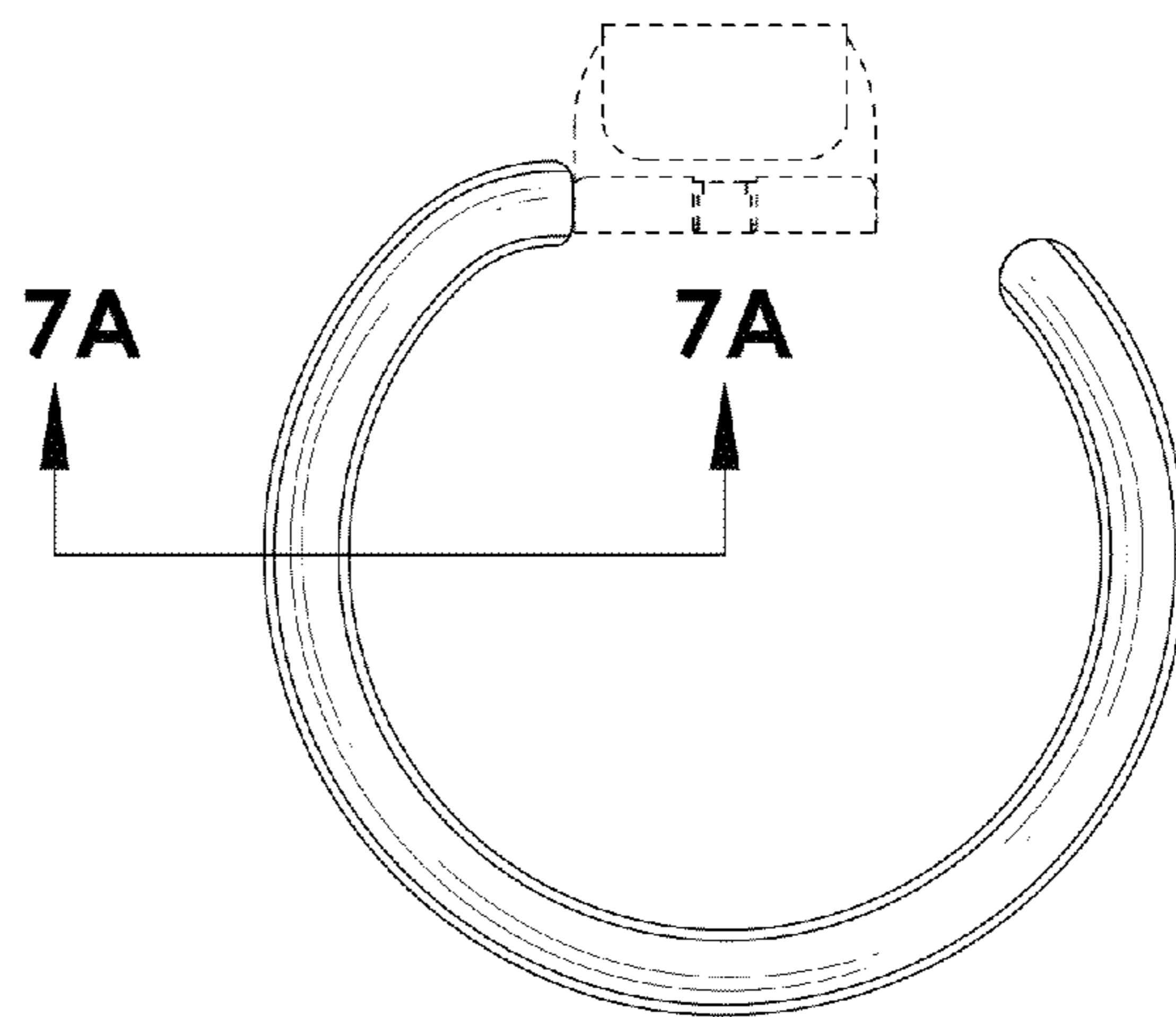
