The ornamental design for pair of hospital bed attachments, as shown and described.

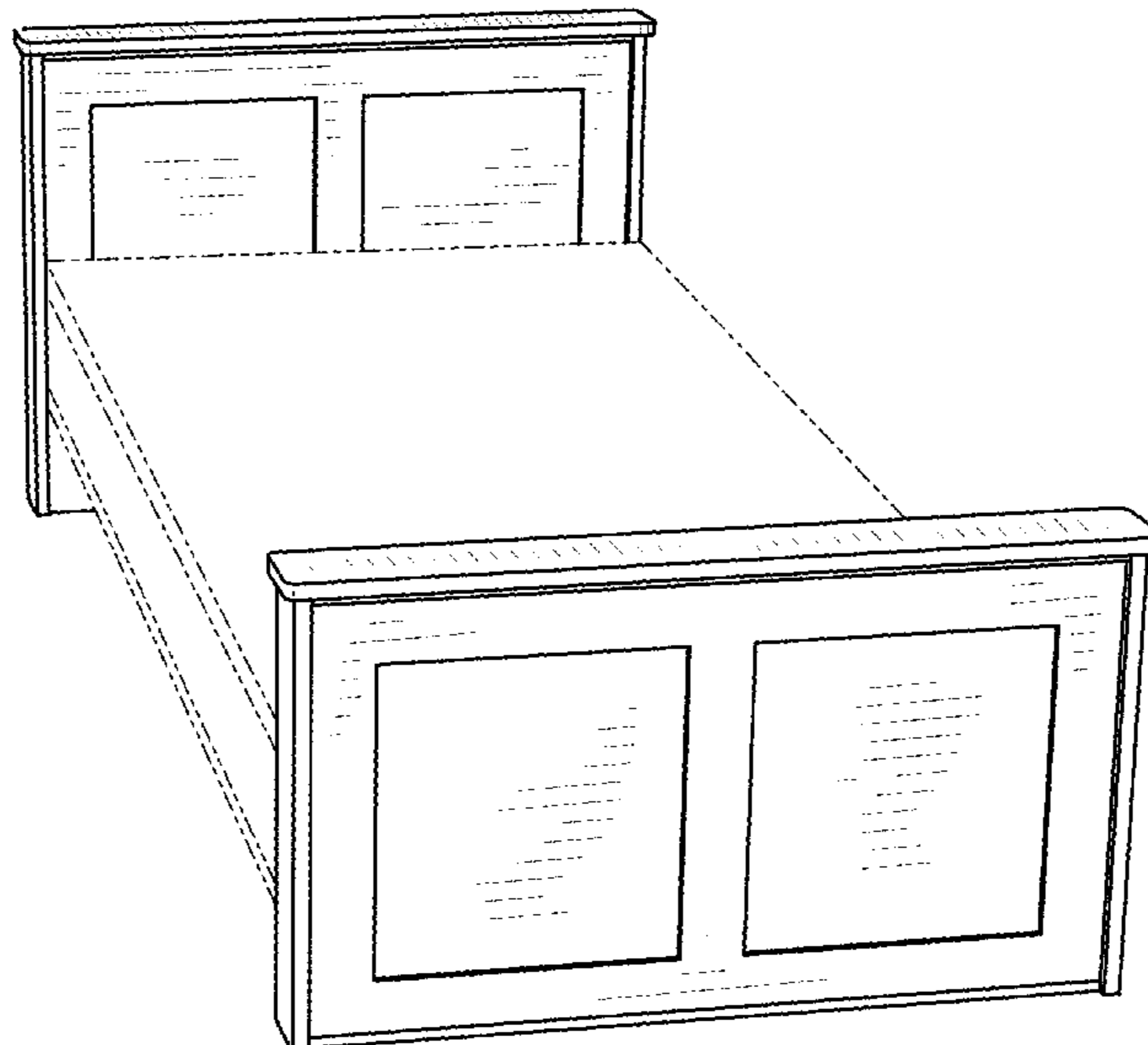
DESCRIPTION

FIG. 1 is a front elevational view illustrating pair of hospital bed attachments inserted over the head and foot of a hospital bed, showing my new design;

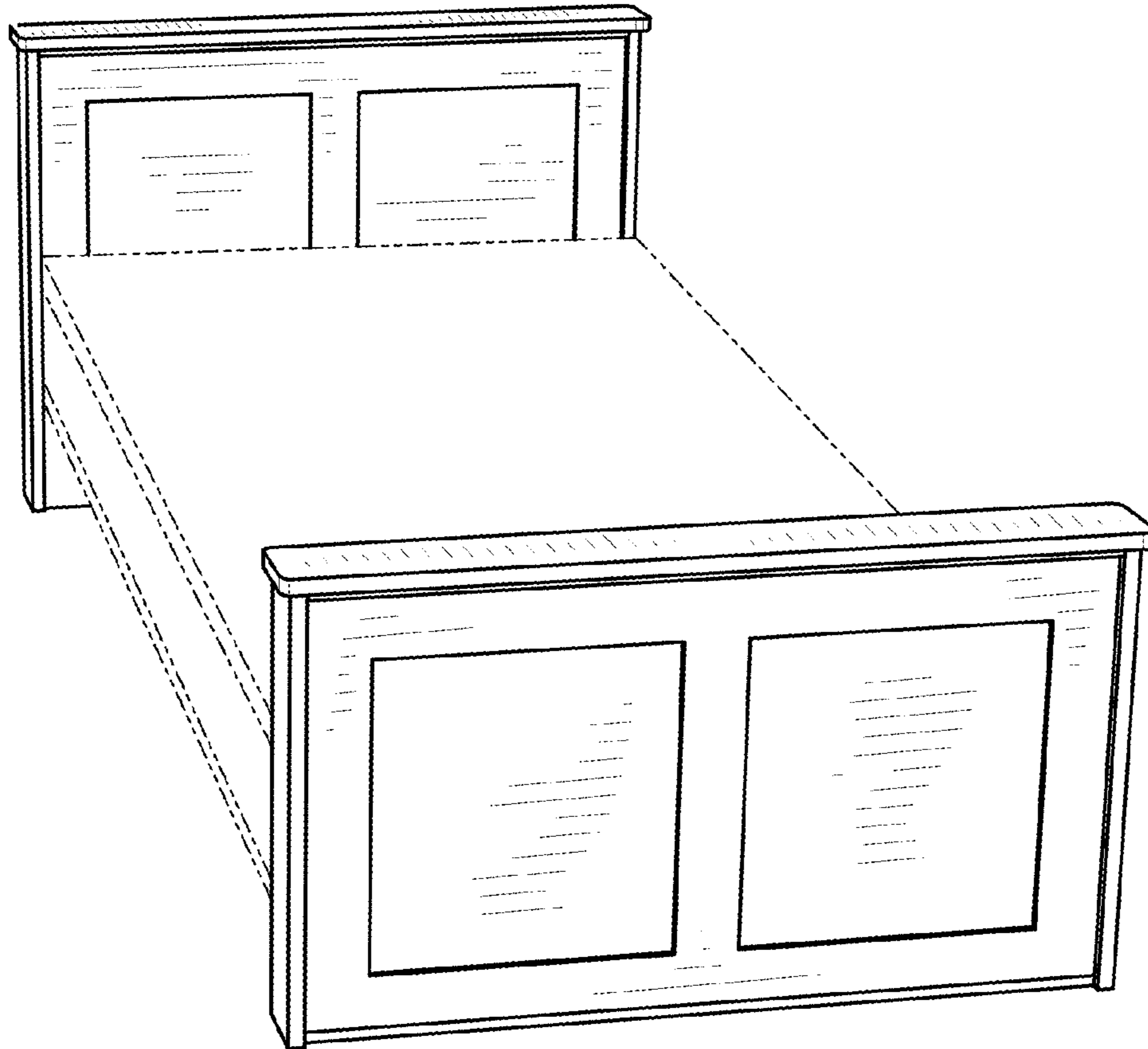

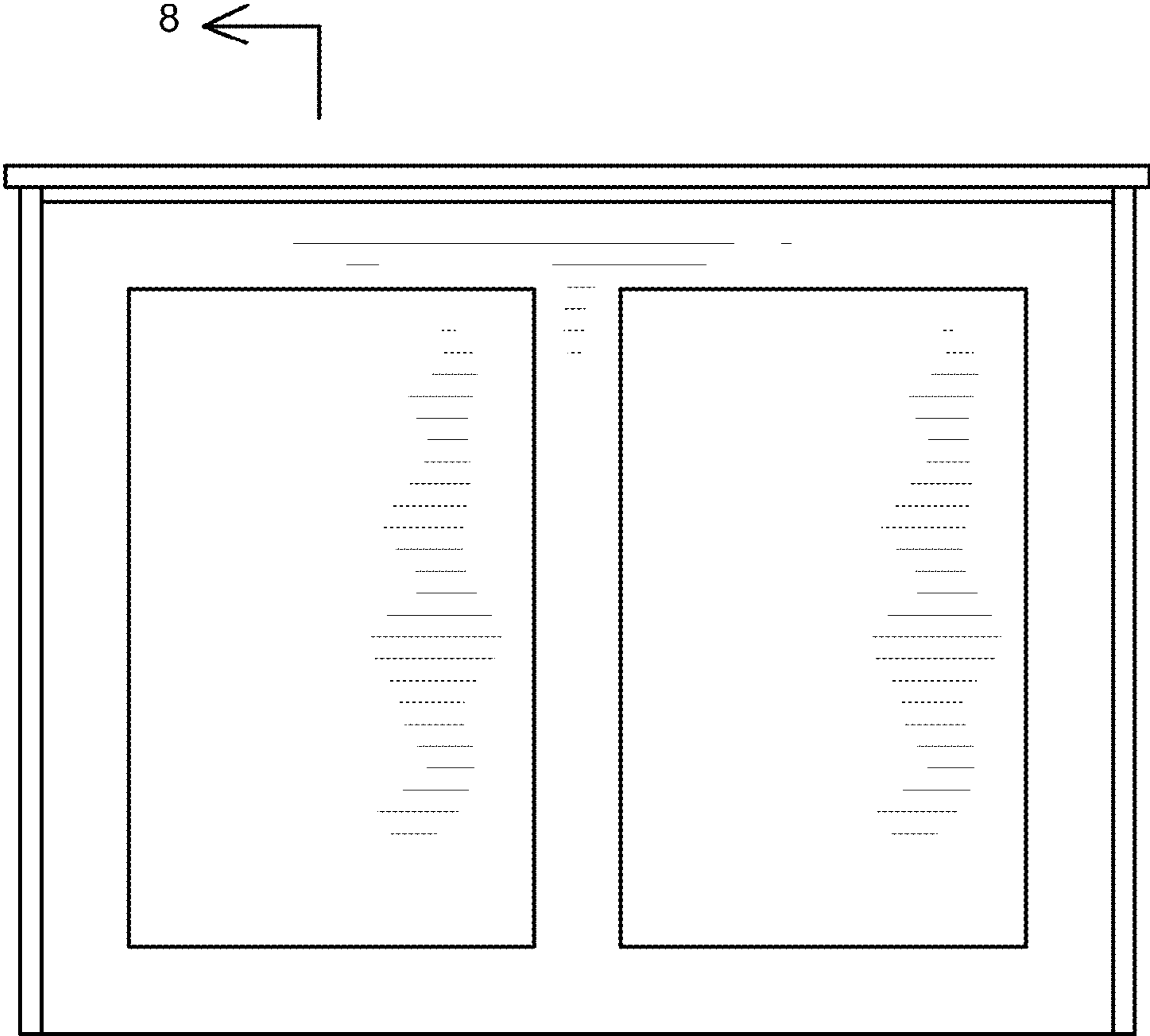

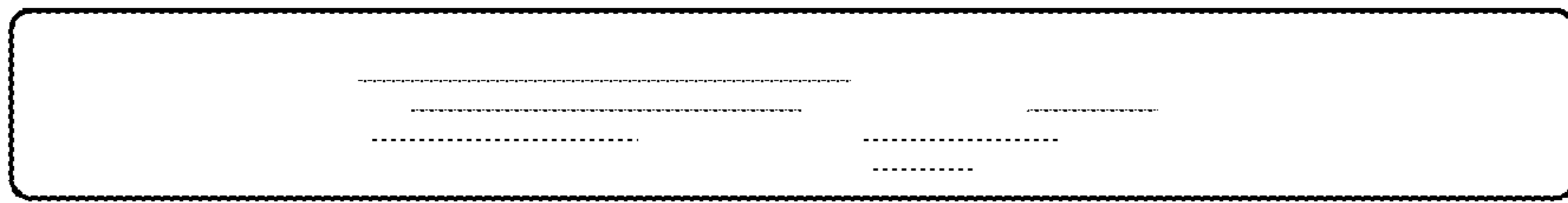

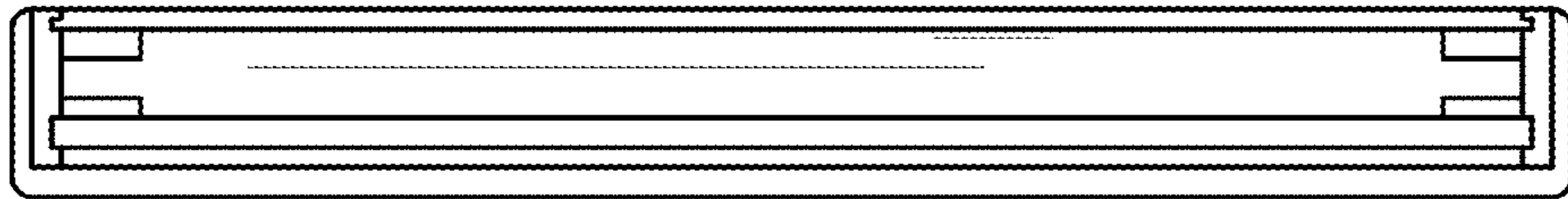

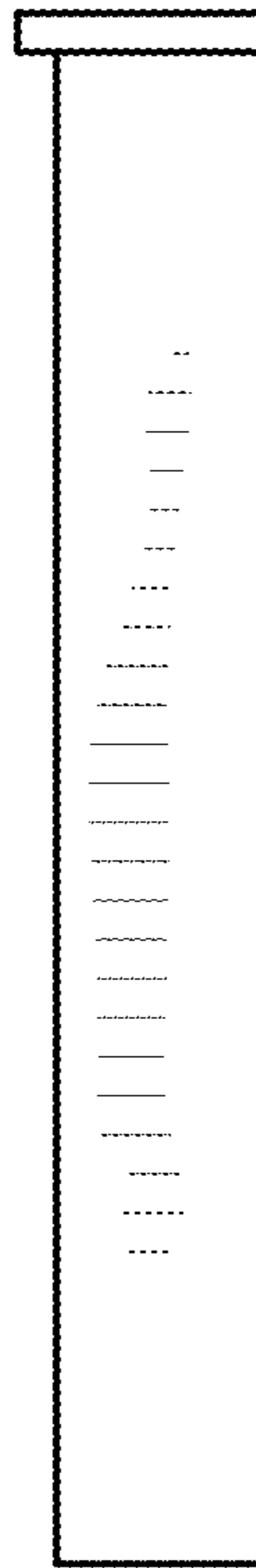

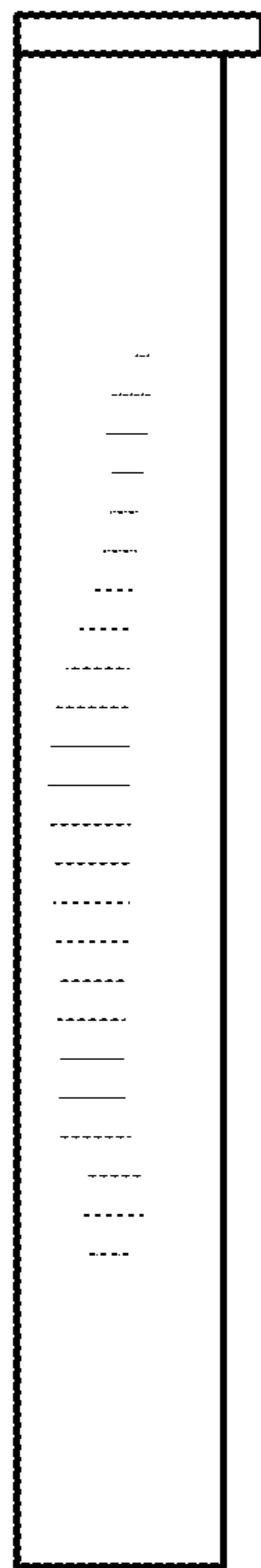

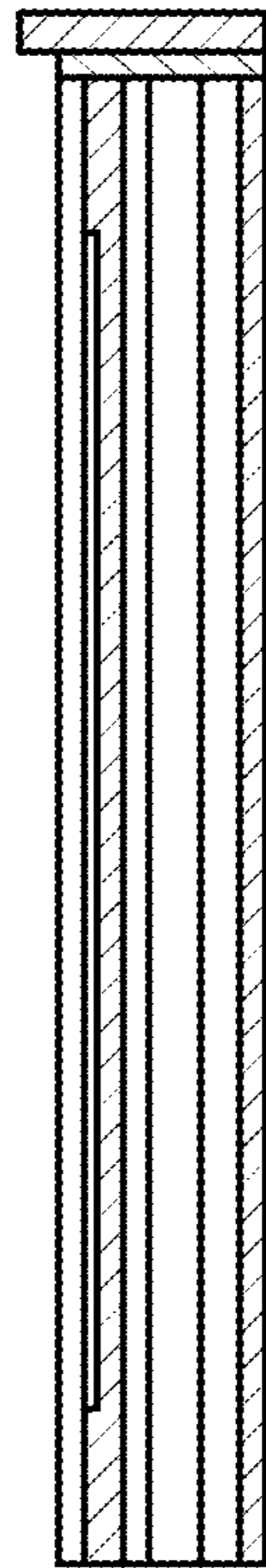

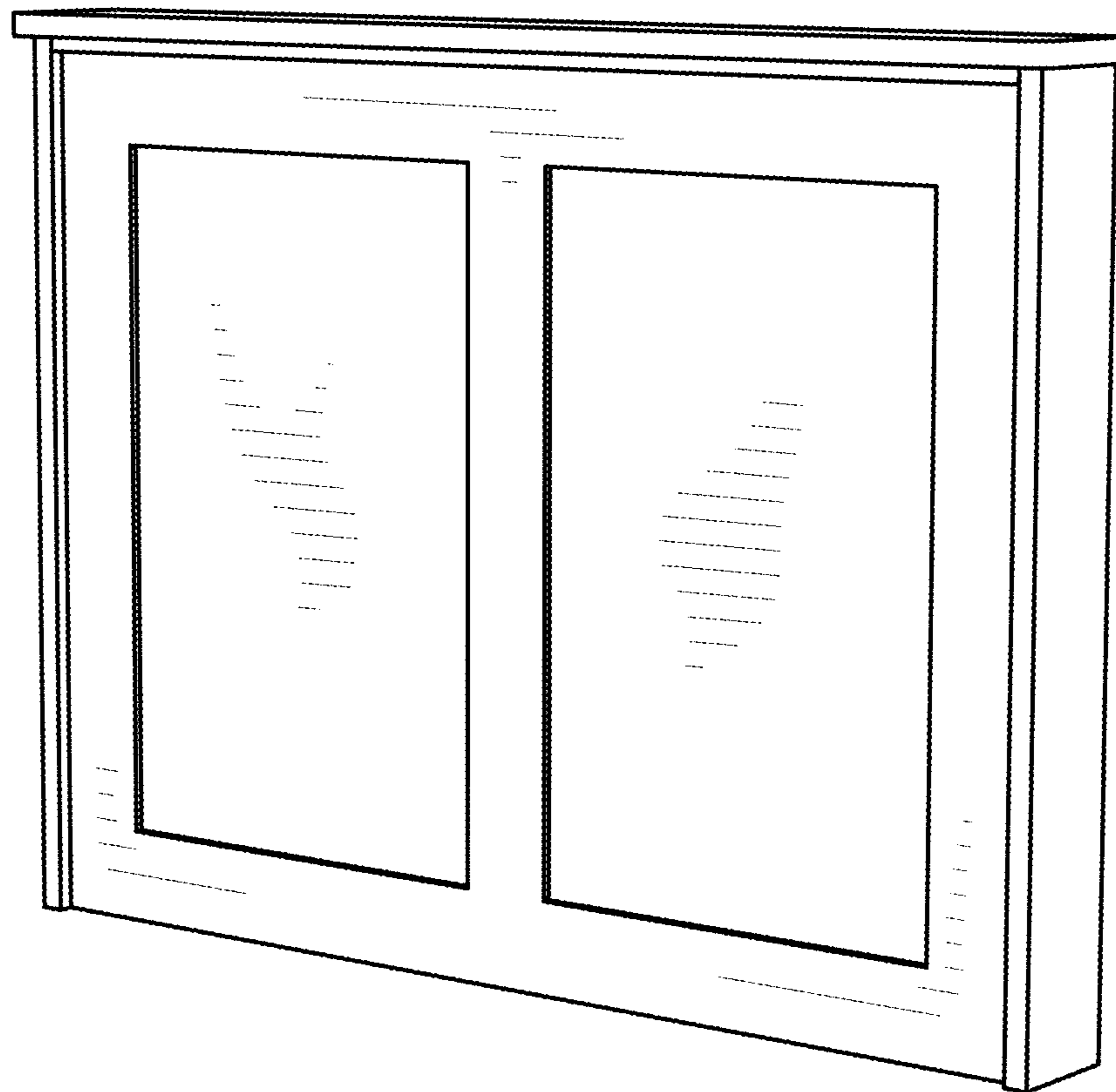

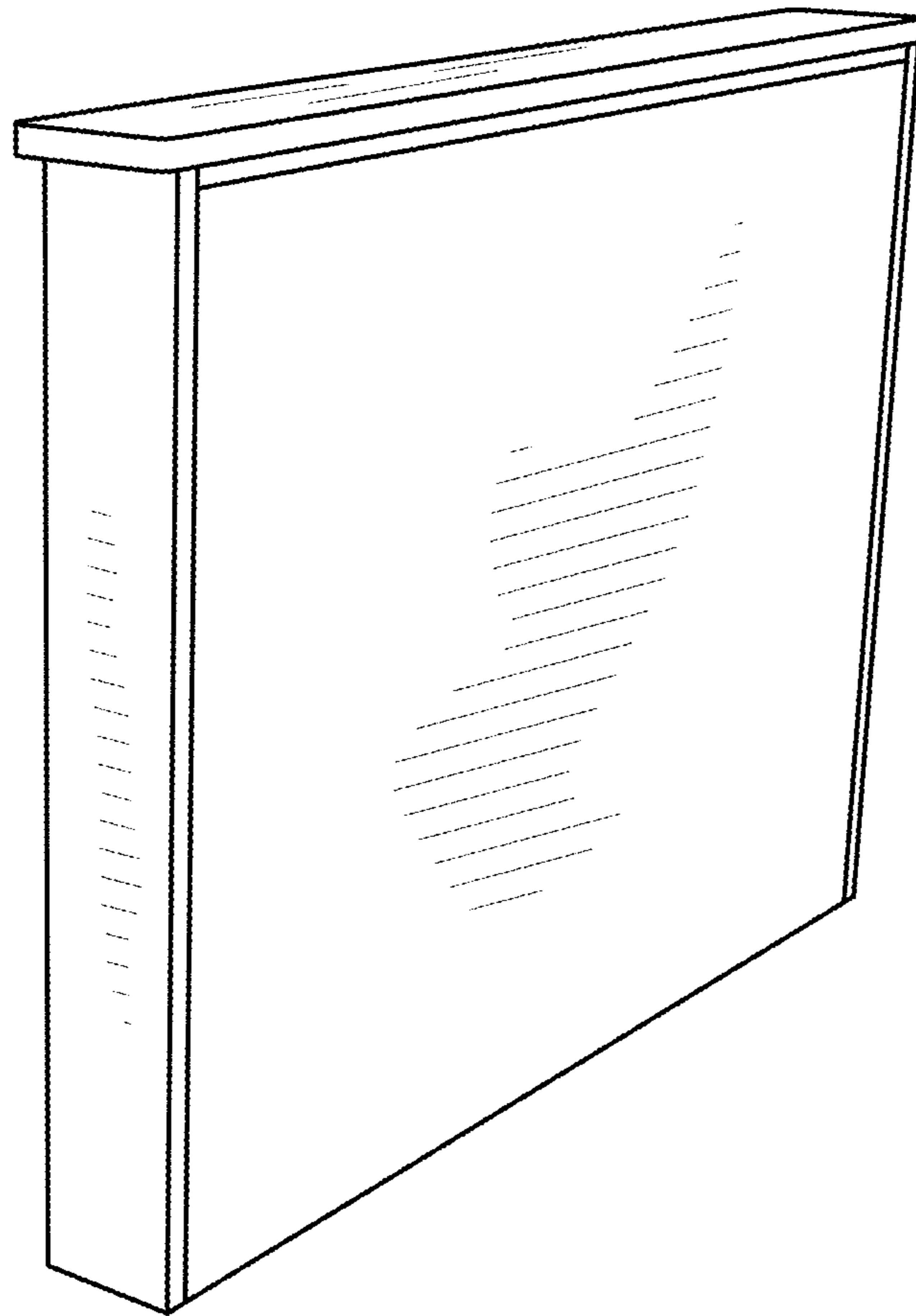

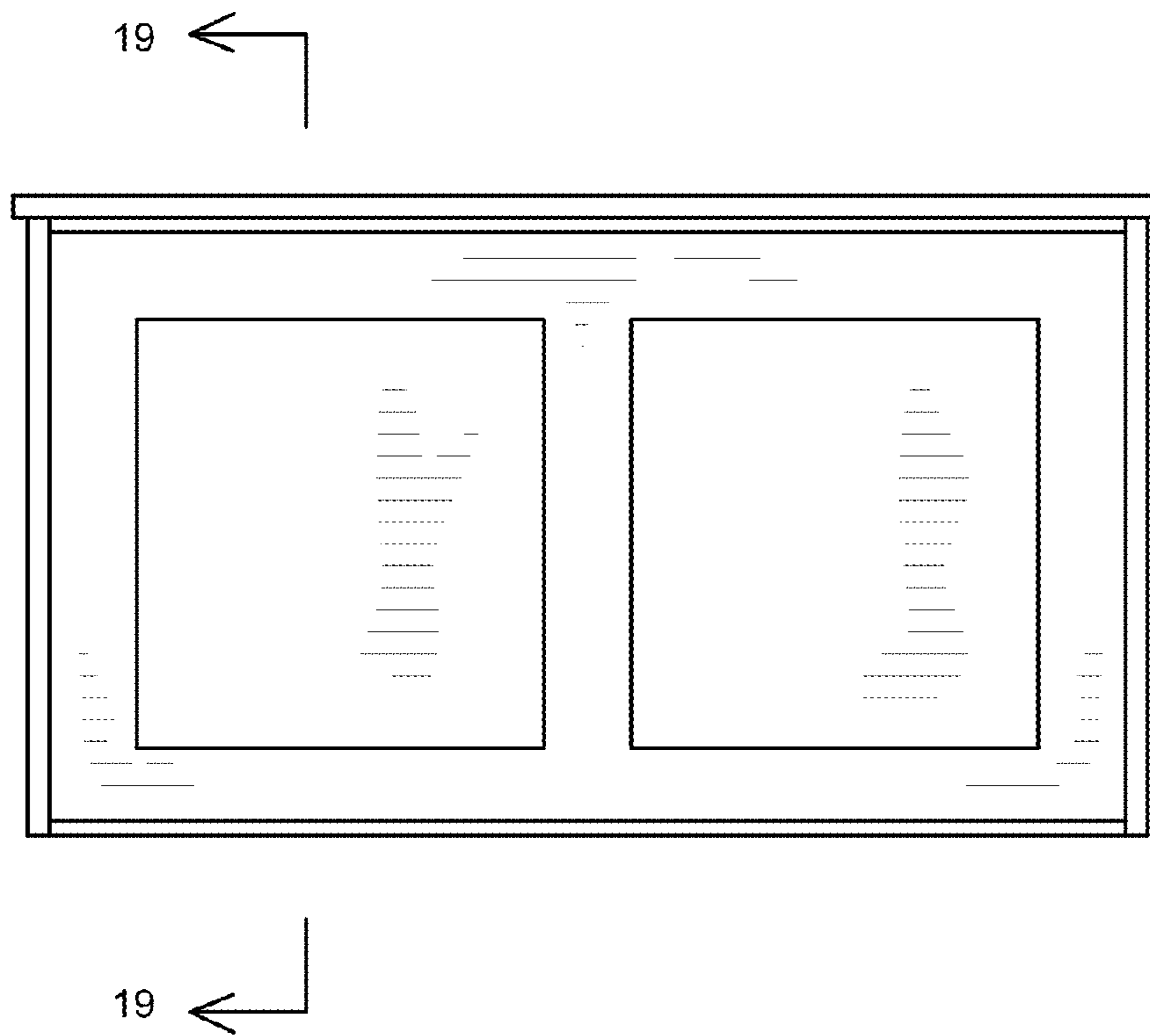

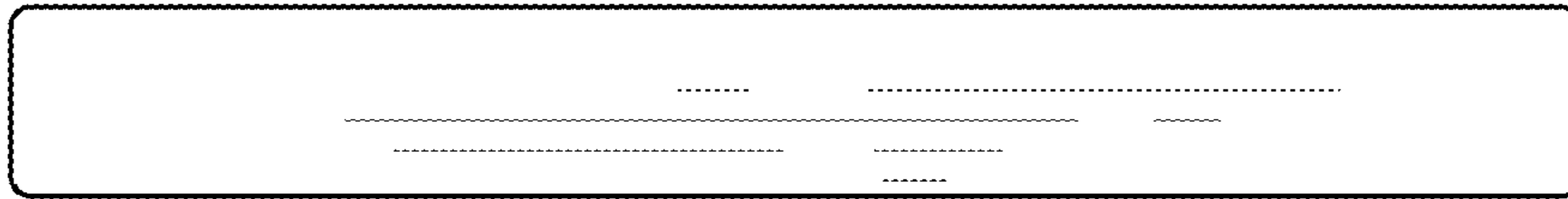

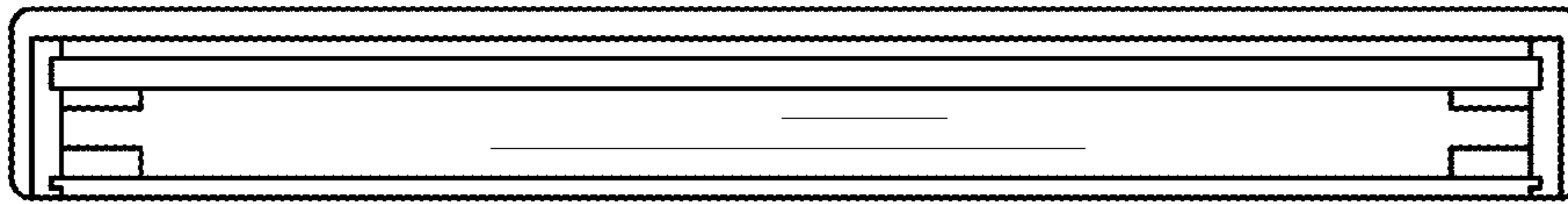

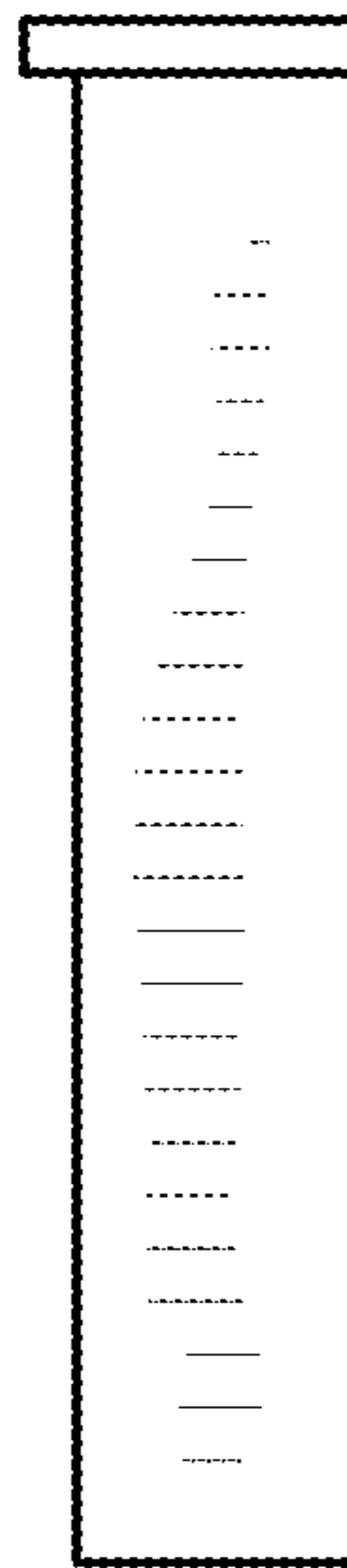

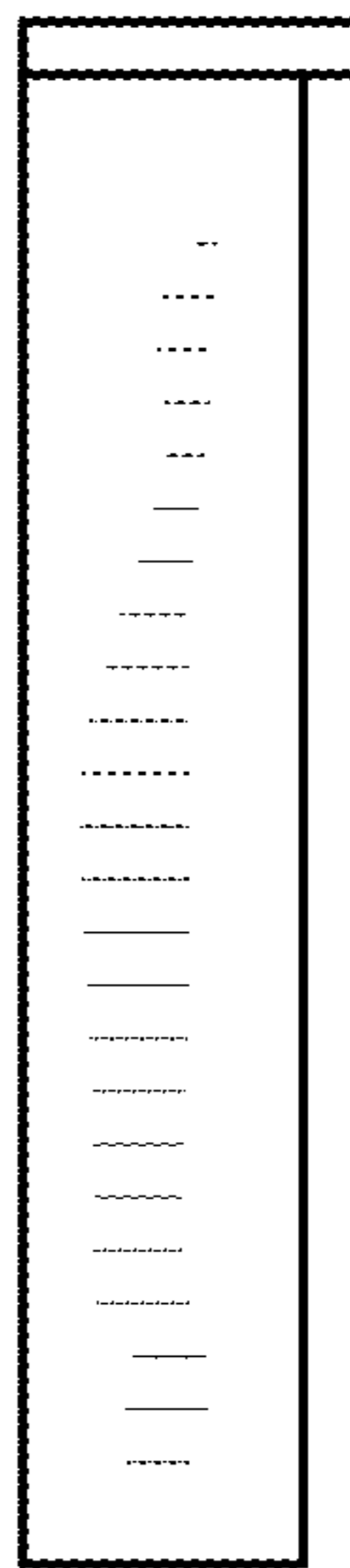

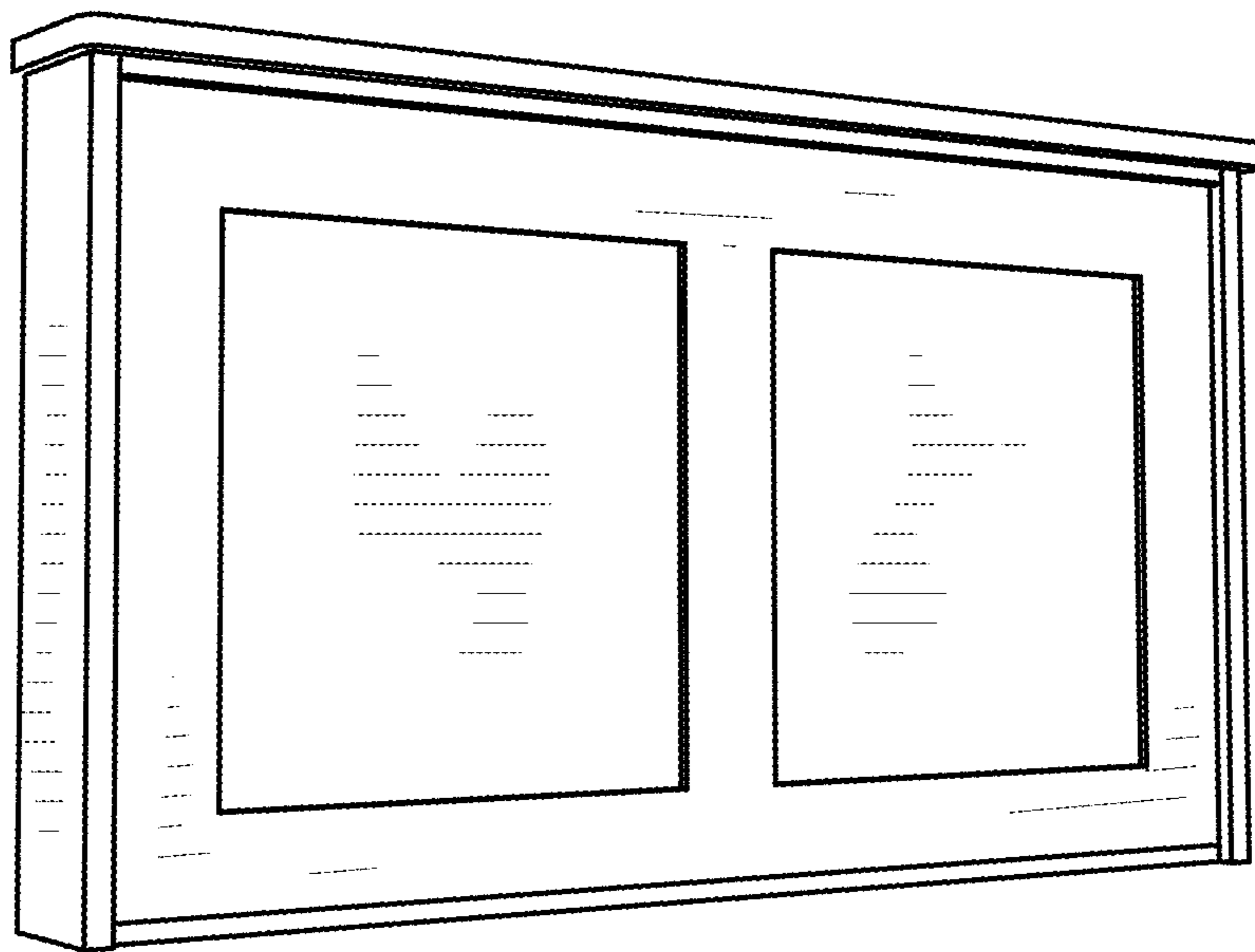

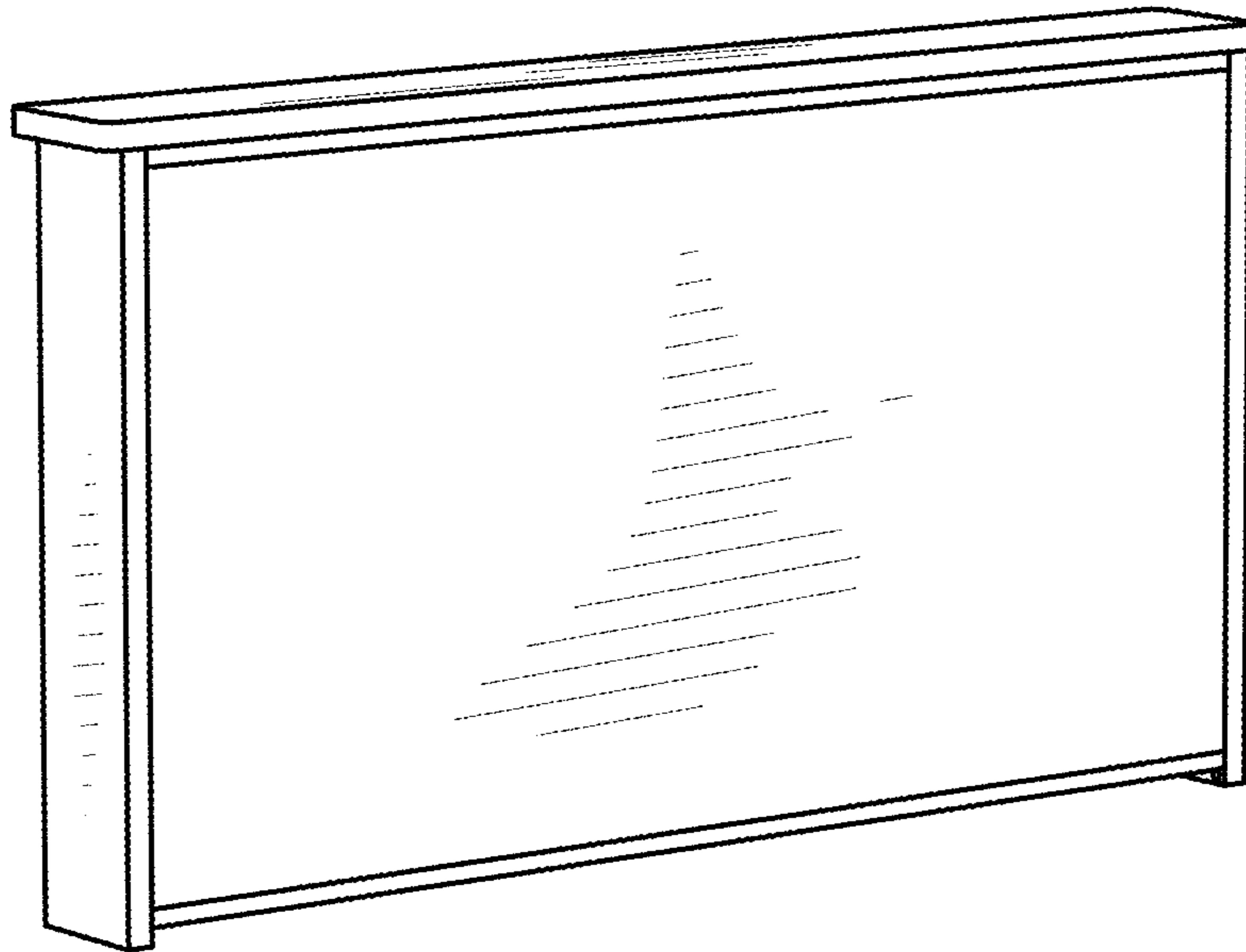

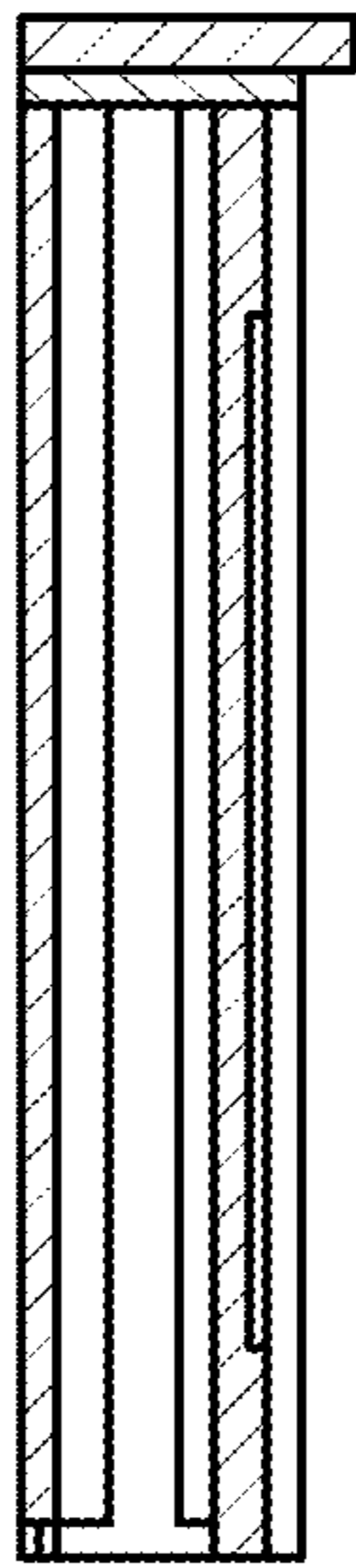
