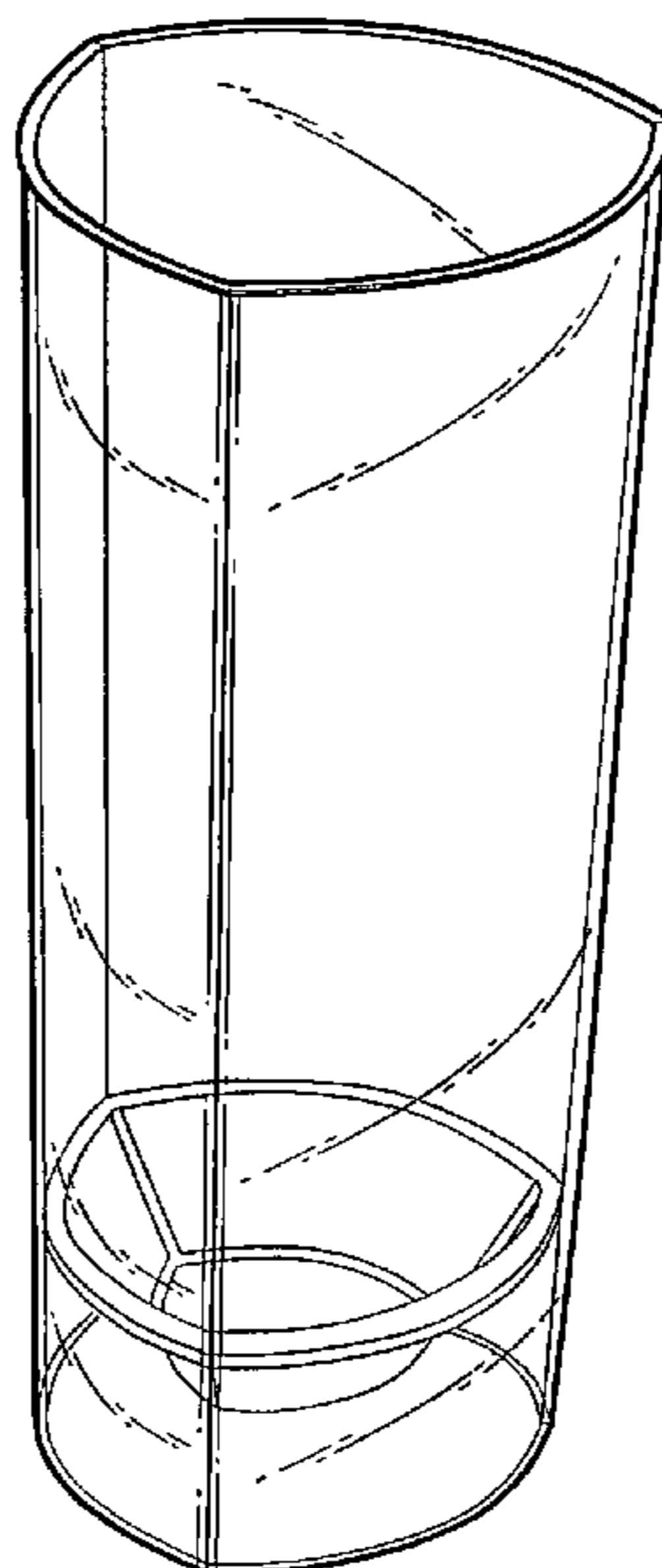
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a drinking glass showing my new design;

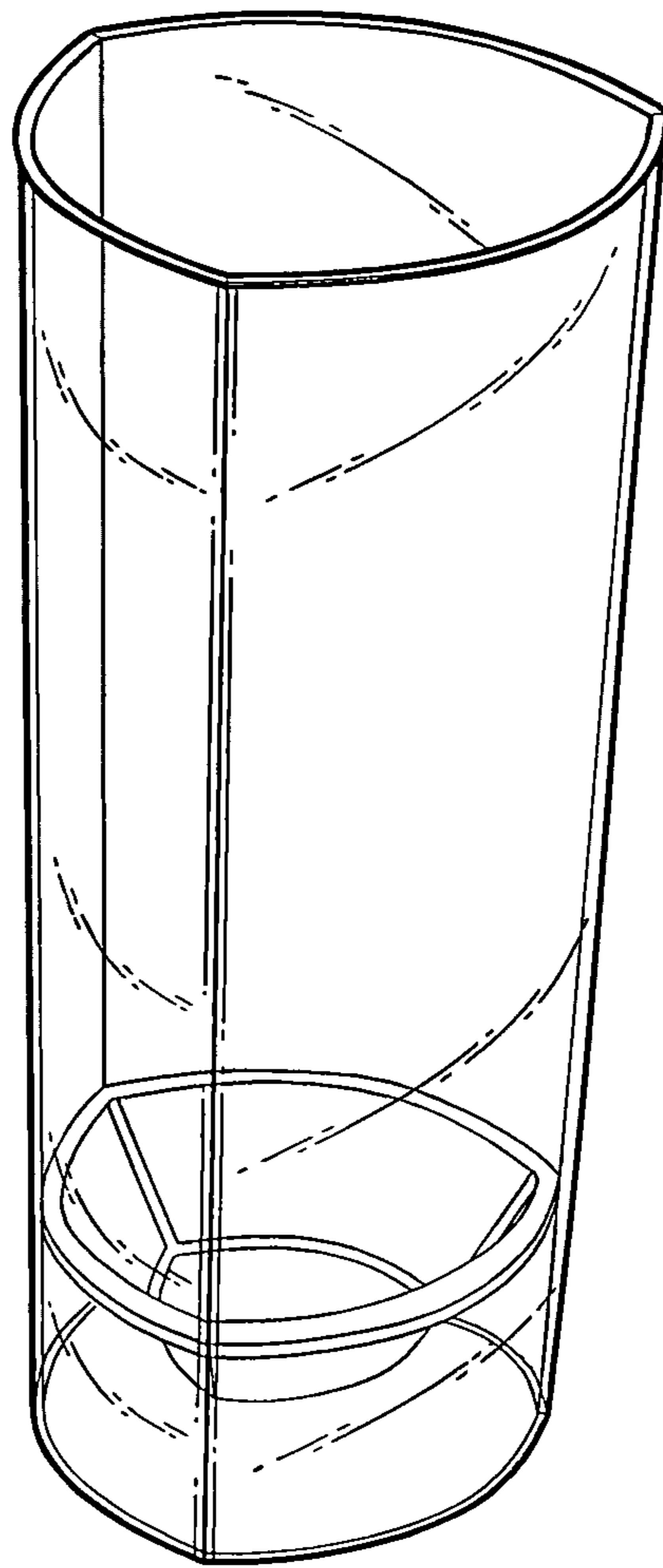

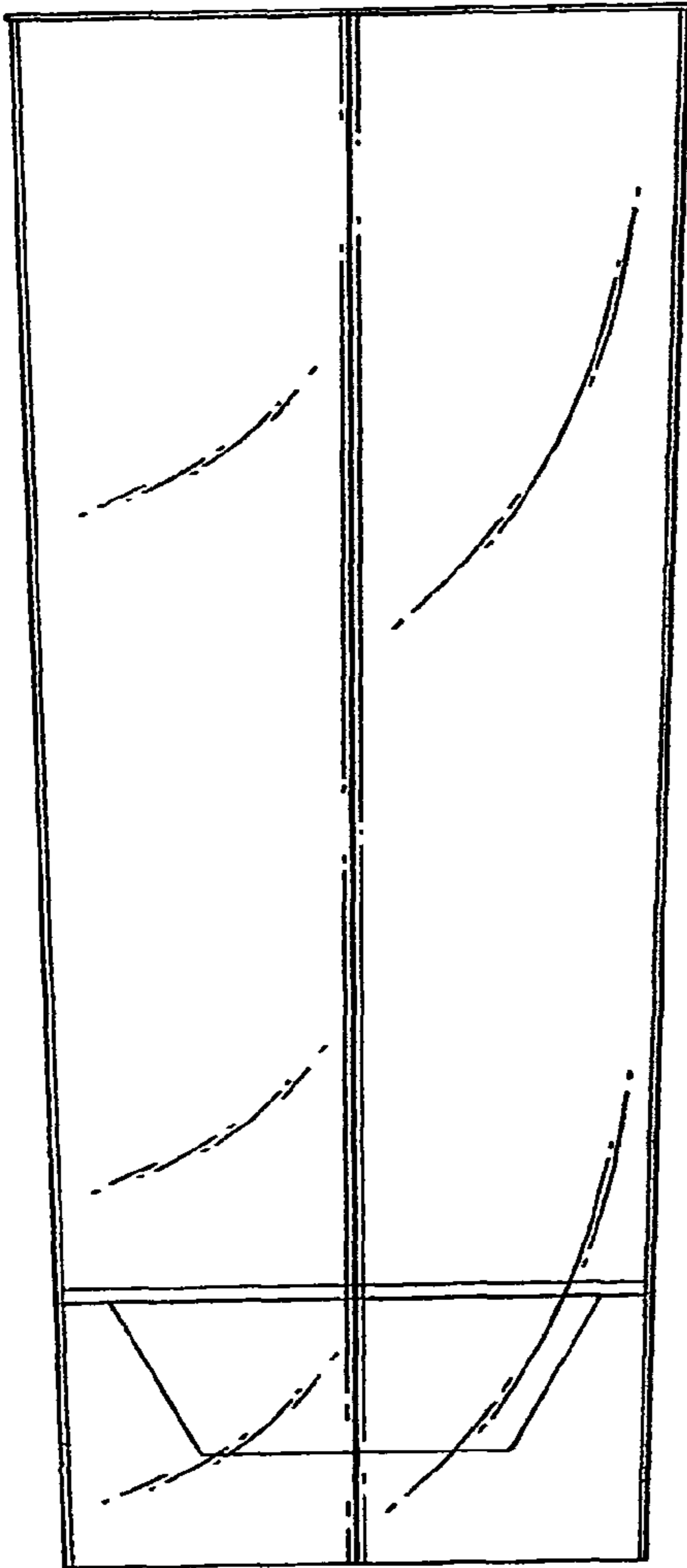

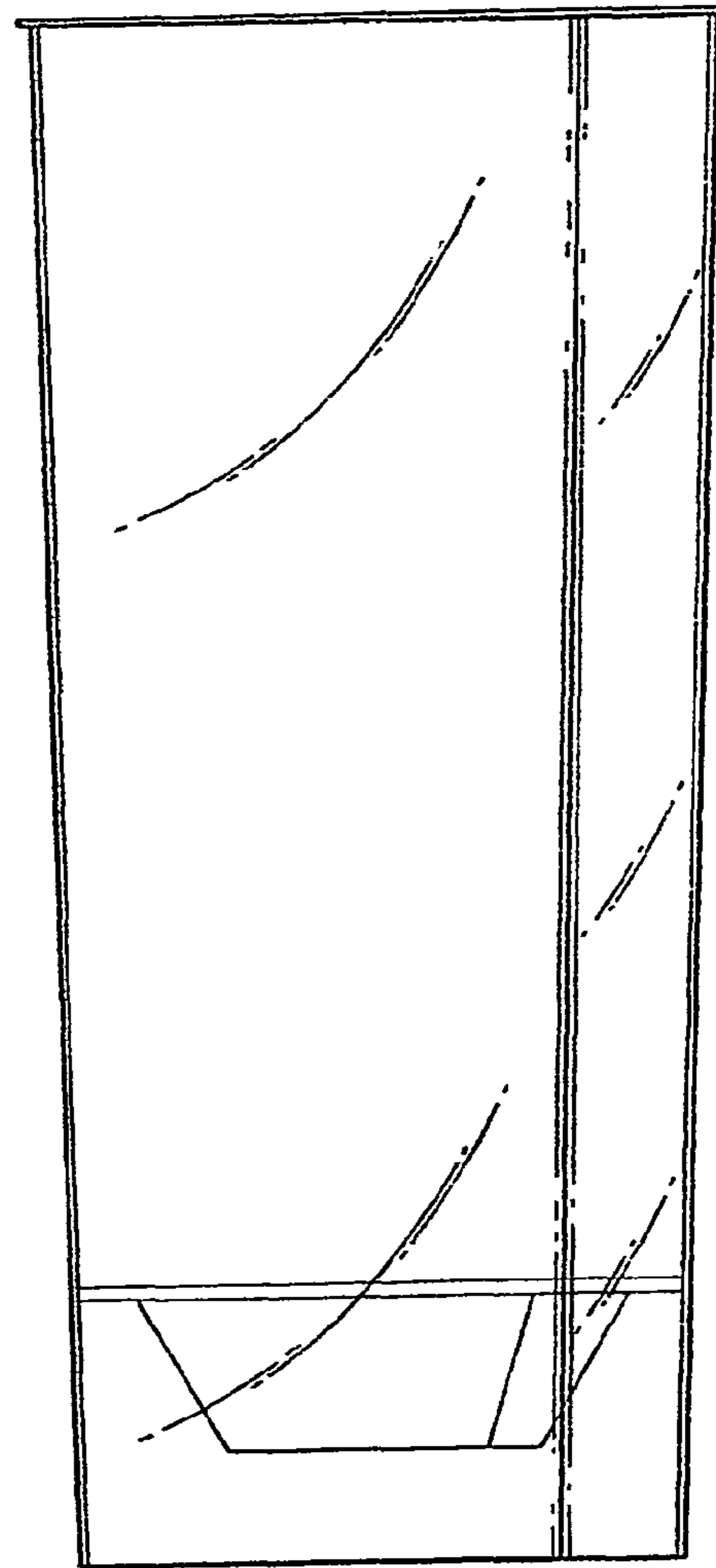

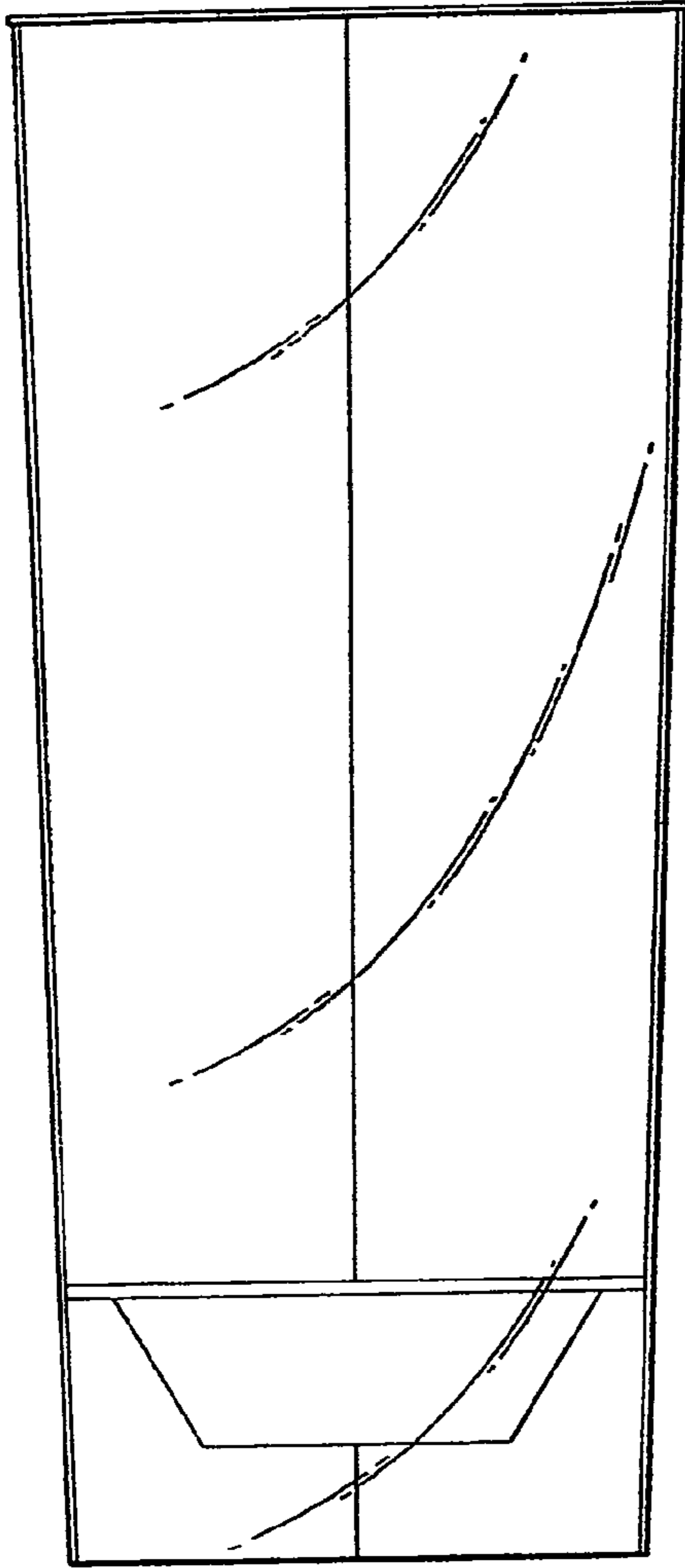

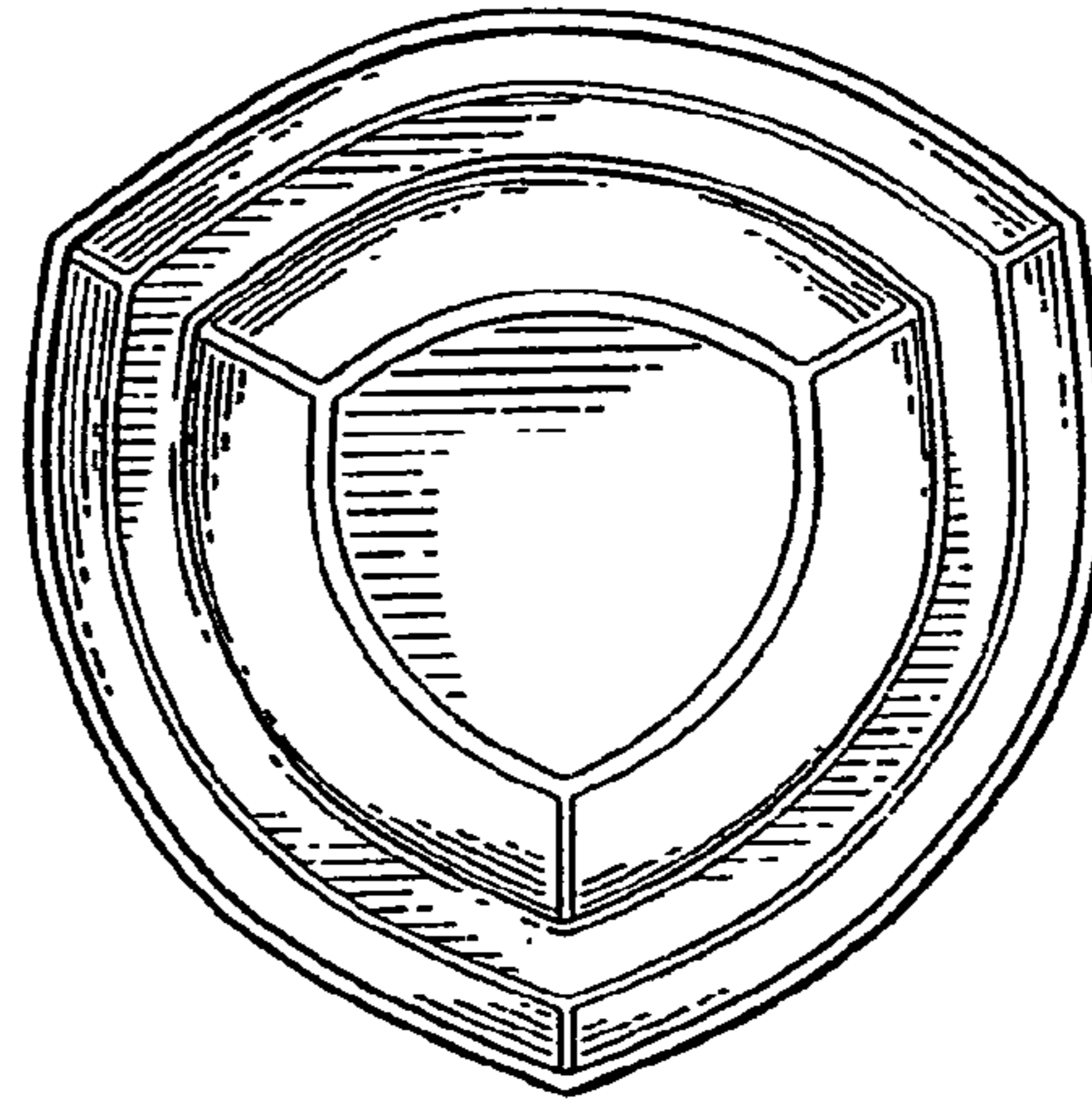

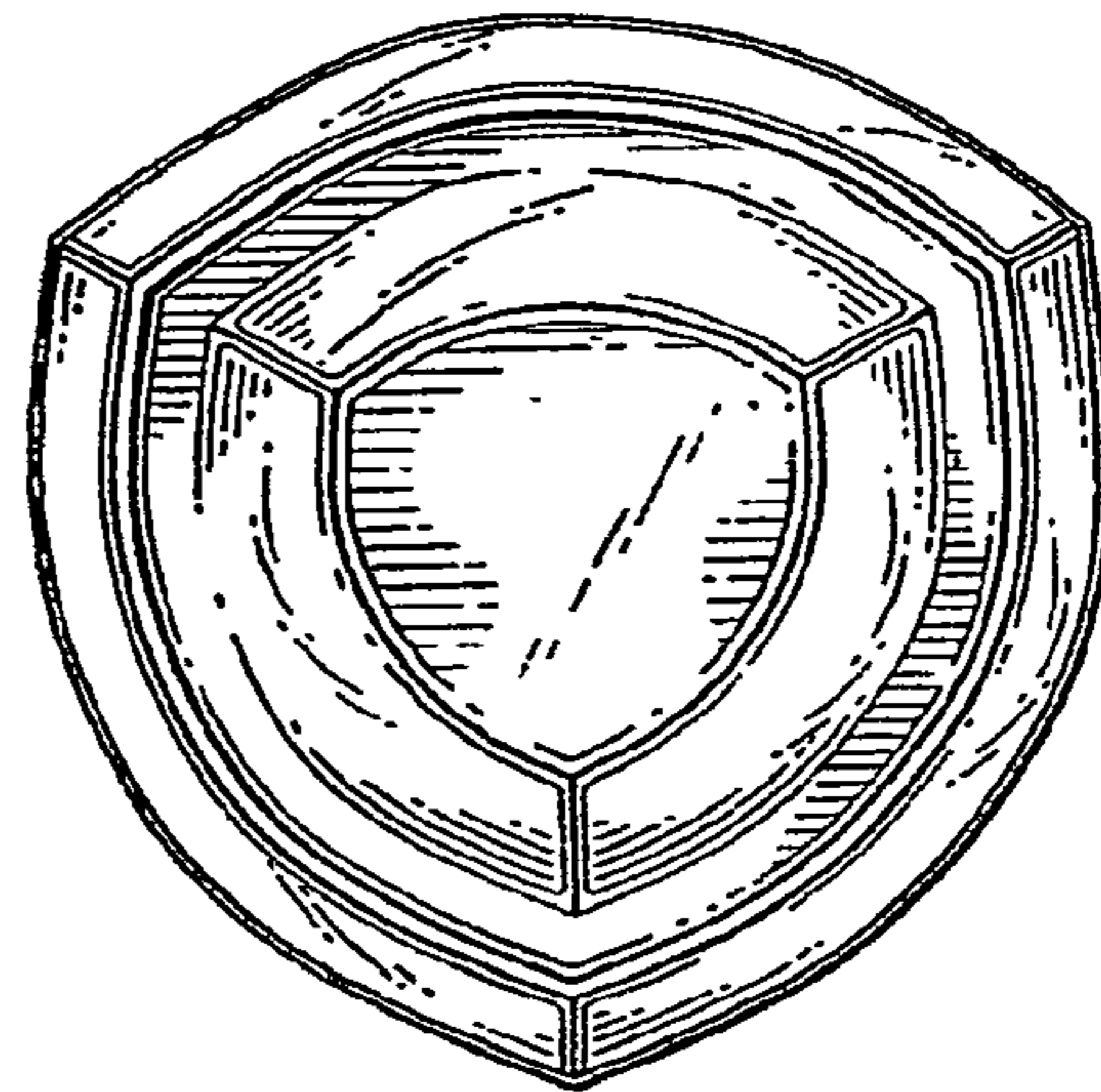

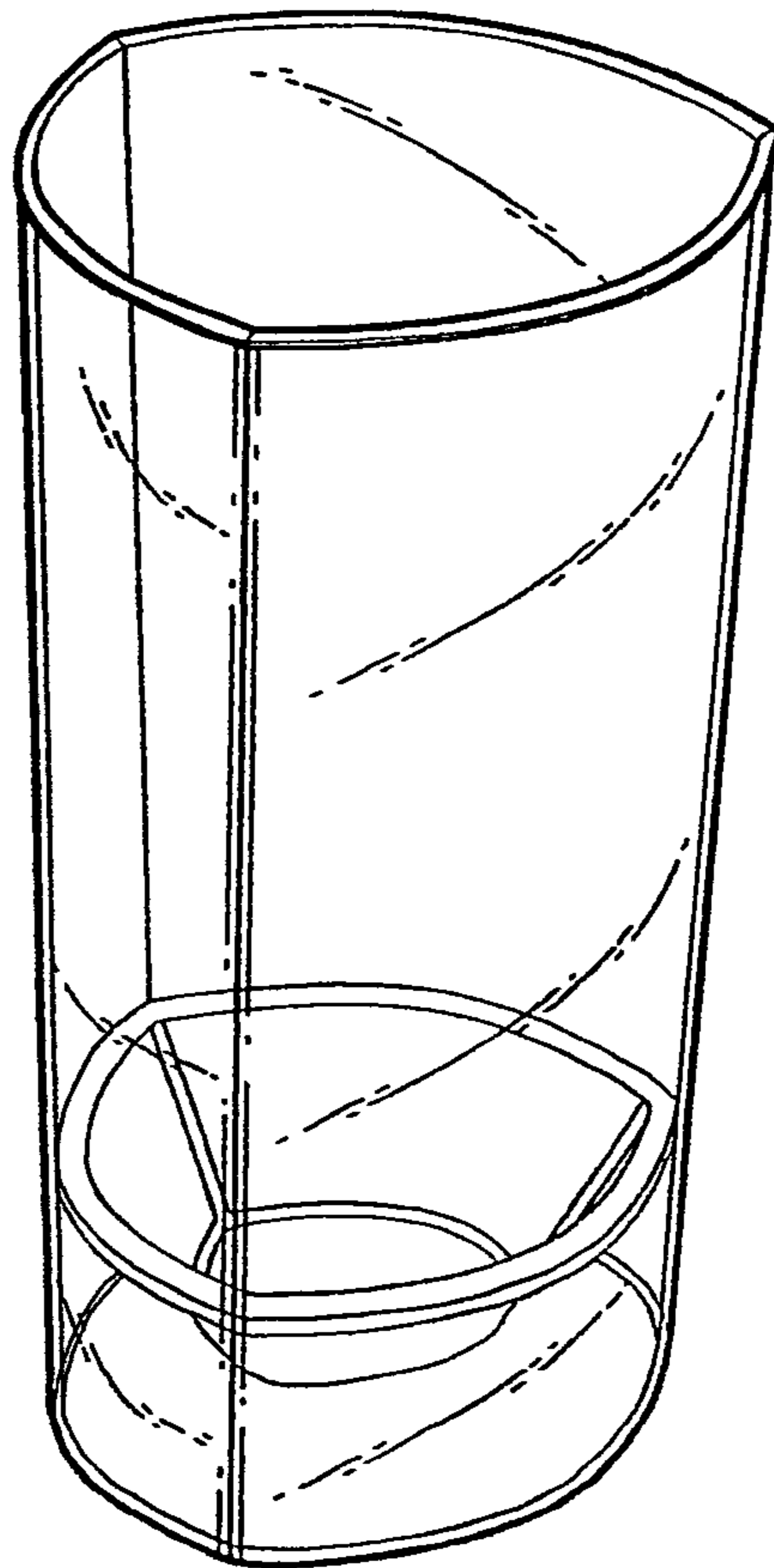

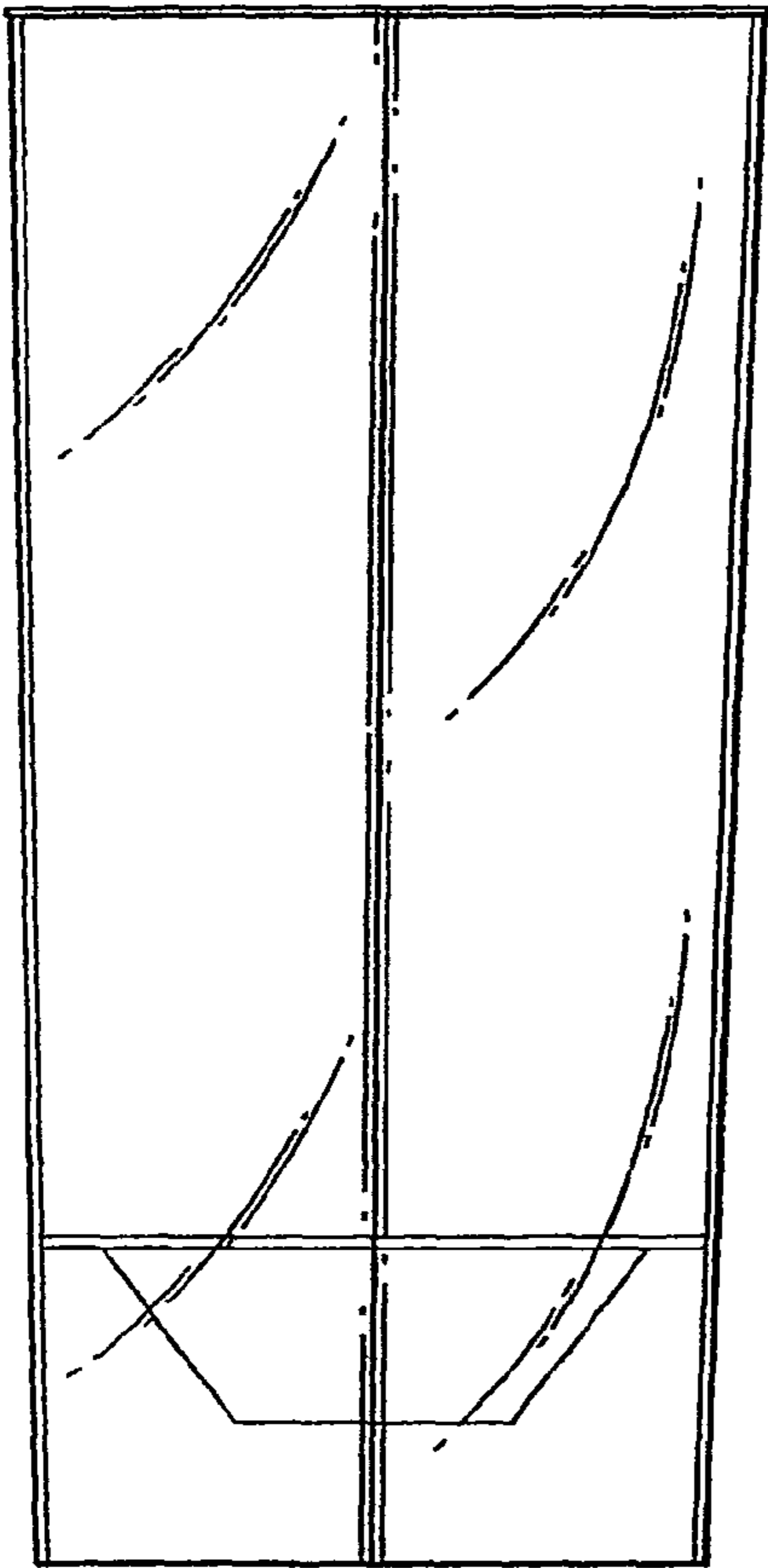

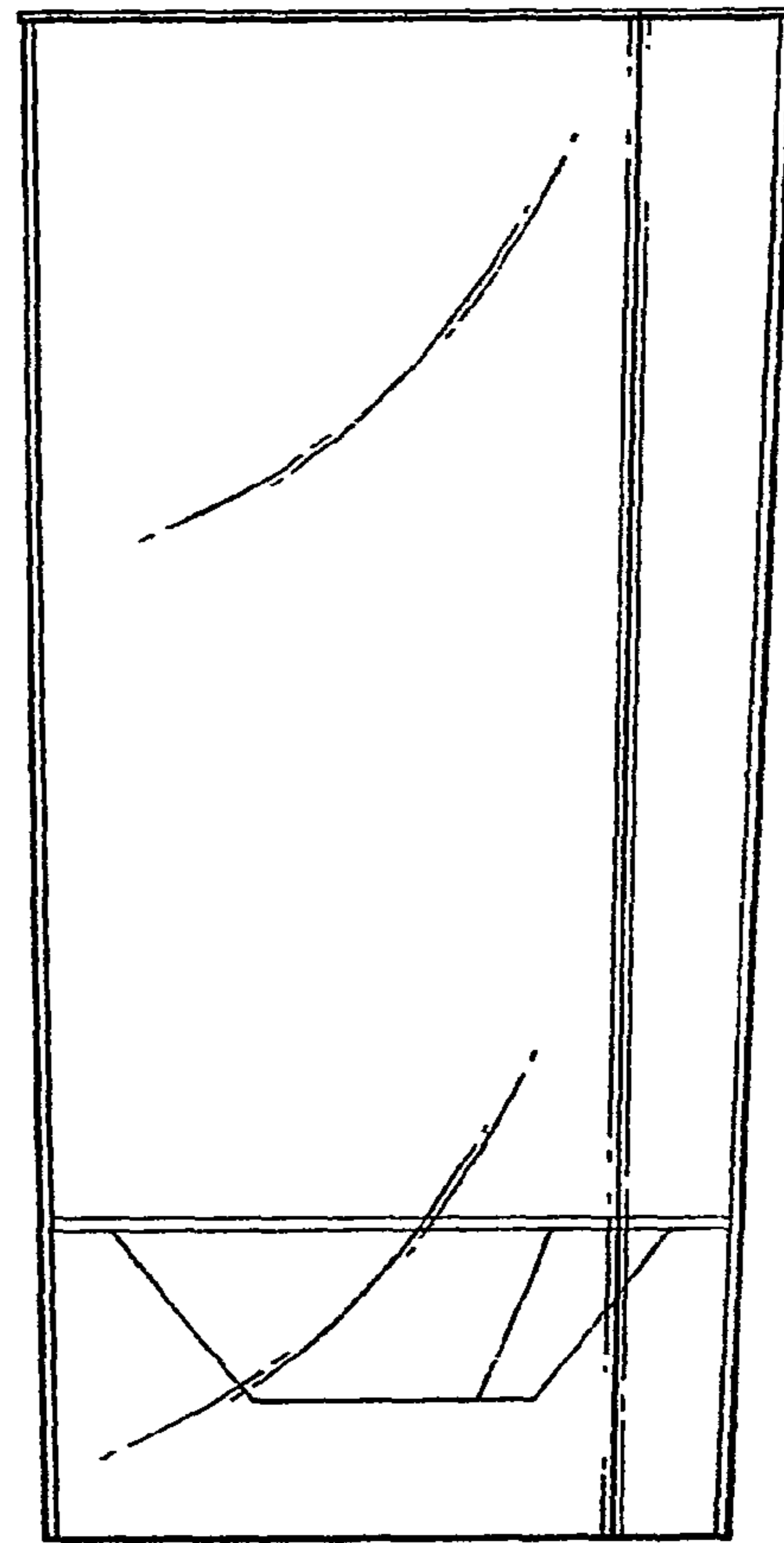

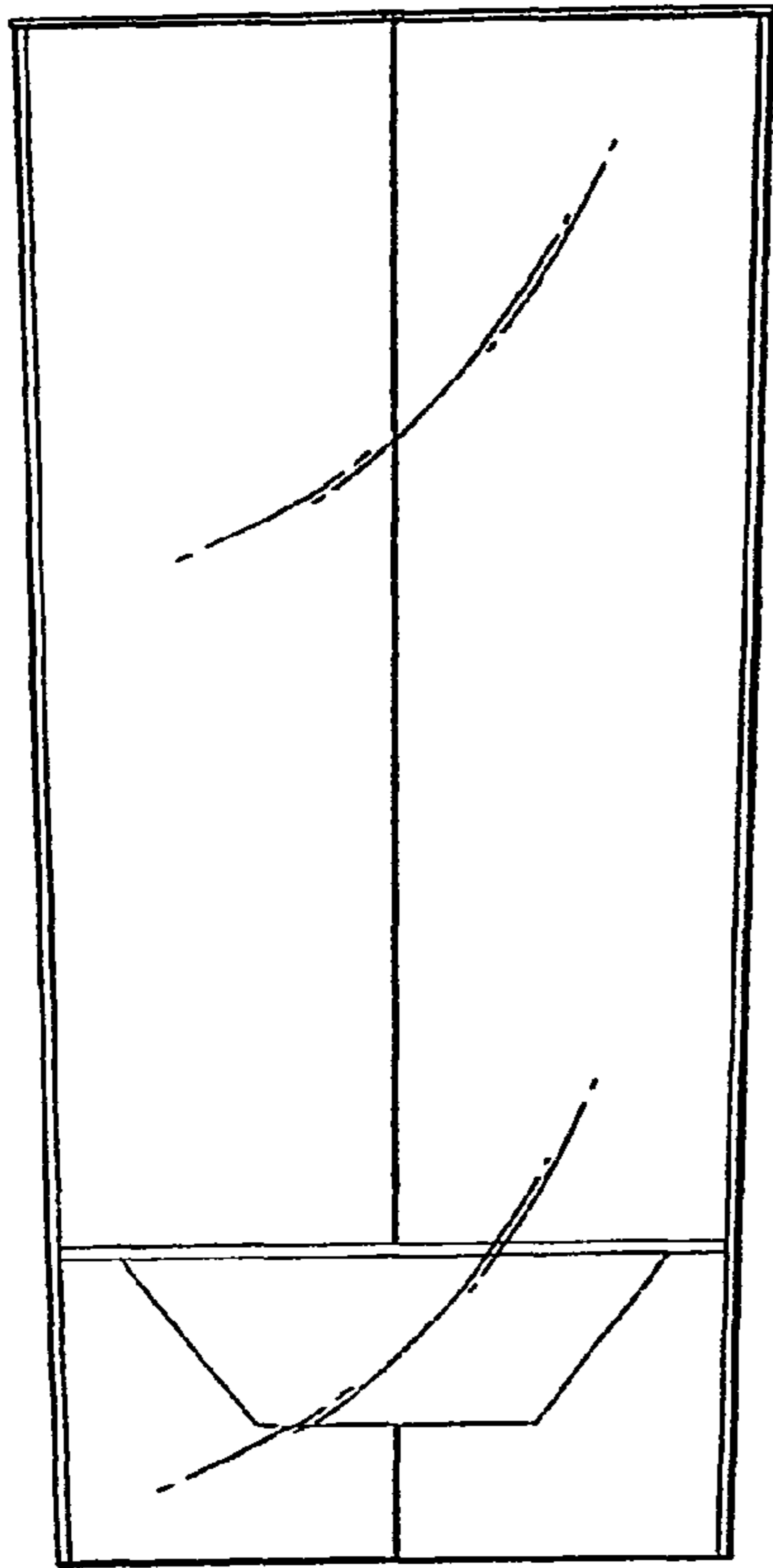

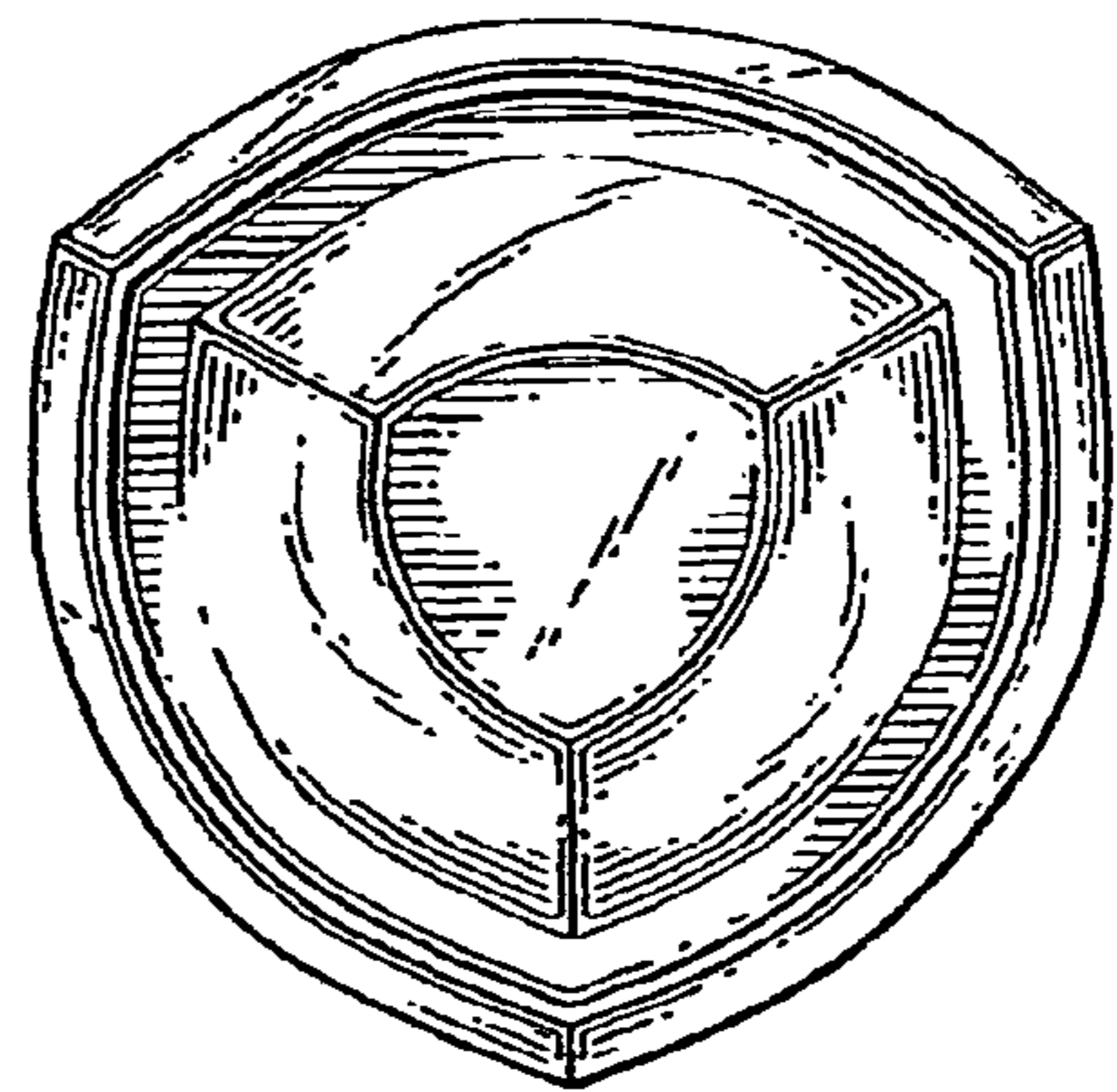

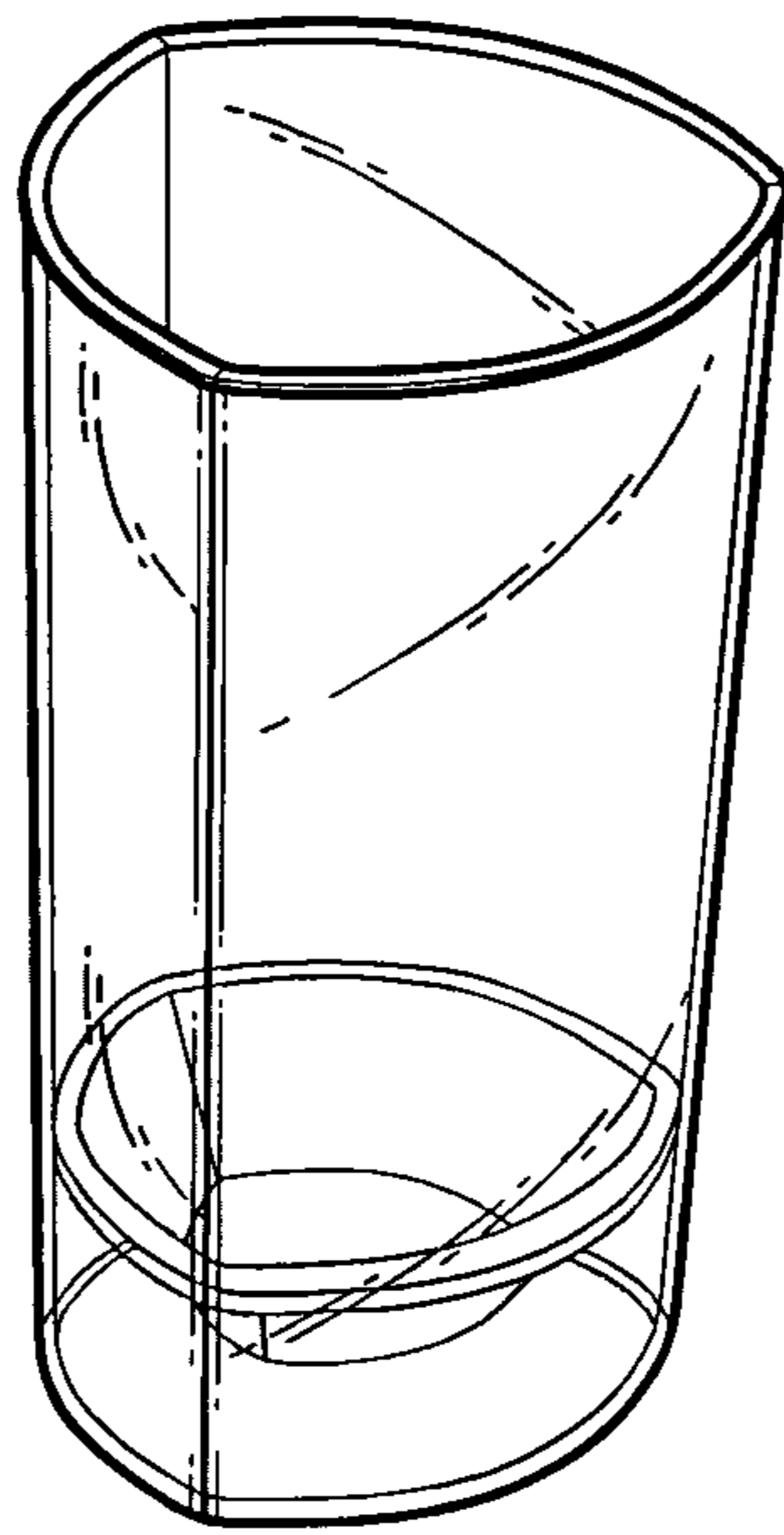
