(57) **CLAIM**

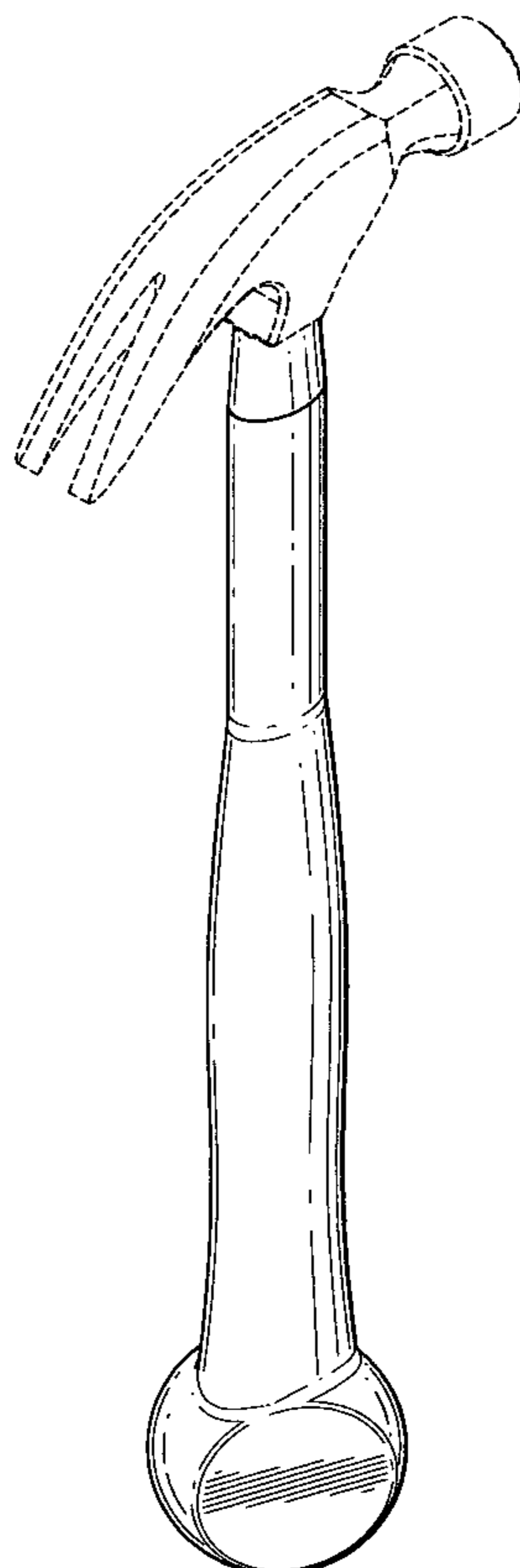
We claim the ornamental design for a hammer handle, as shown and described.

DESCRIPTION

FIG. 1 is a rear right side perspective view of a hammer handle showing our new design;
FIG. 2 is a rear left side perspective view of a hammer handle showing our new design;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a front view thereof;
FIG. 6 is a rear view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.

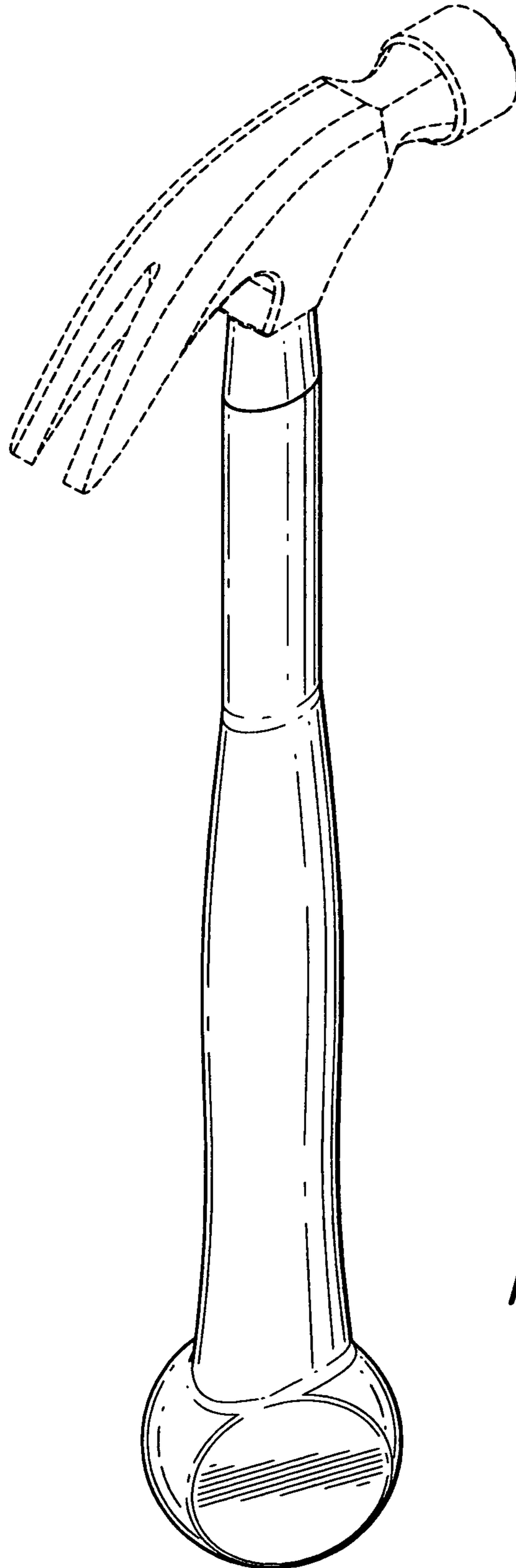

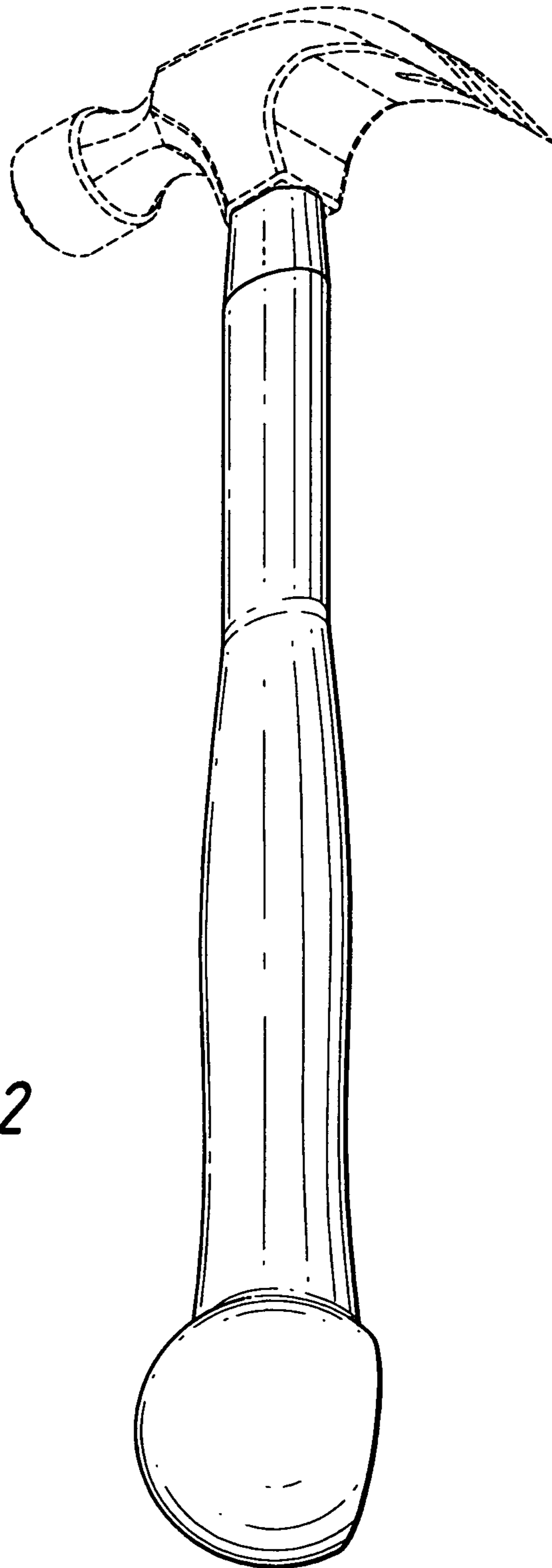

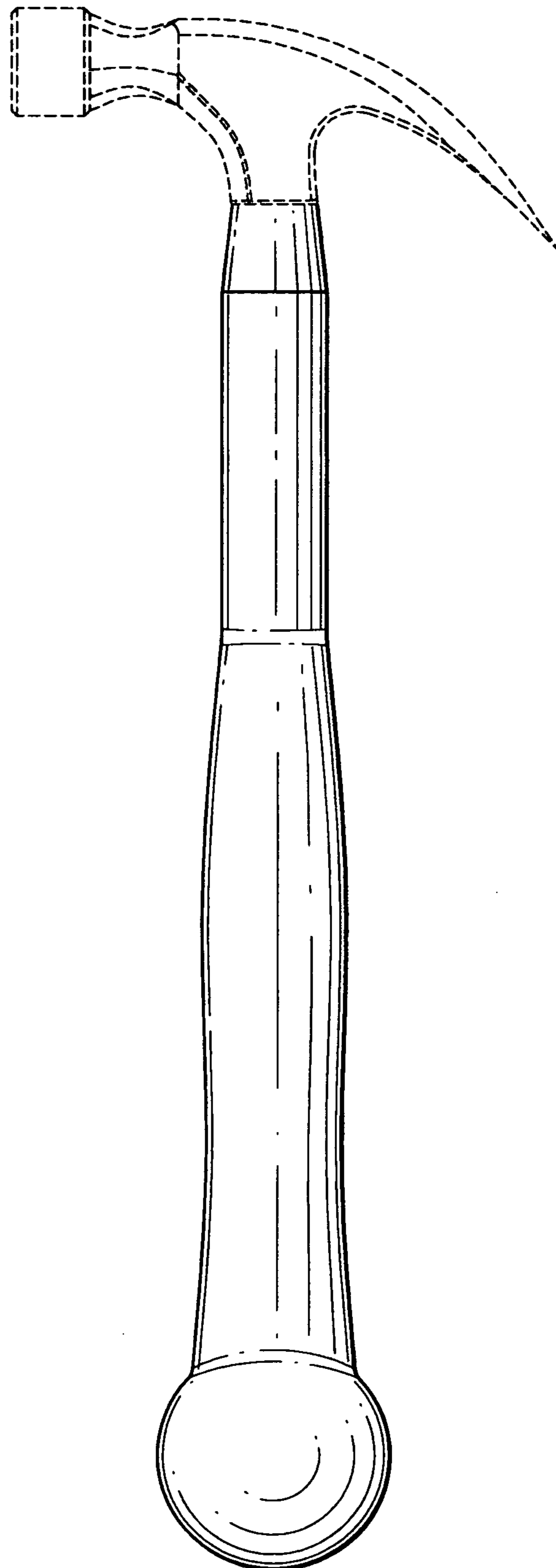

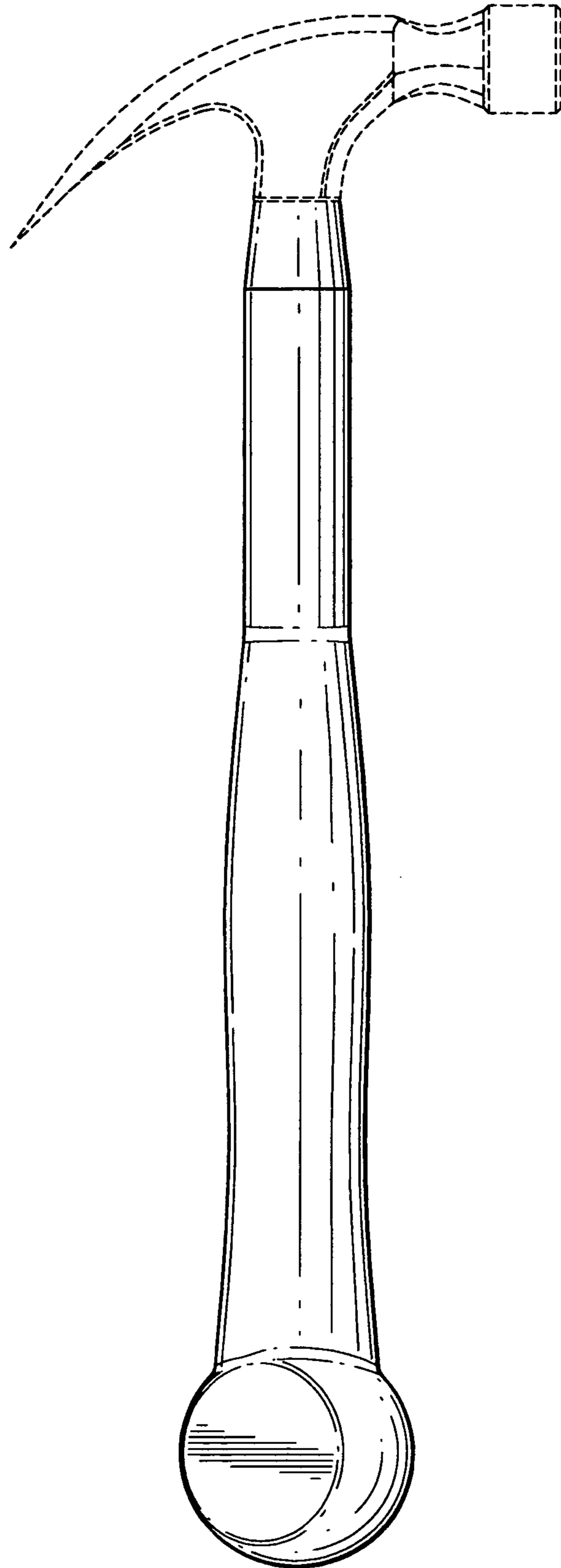

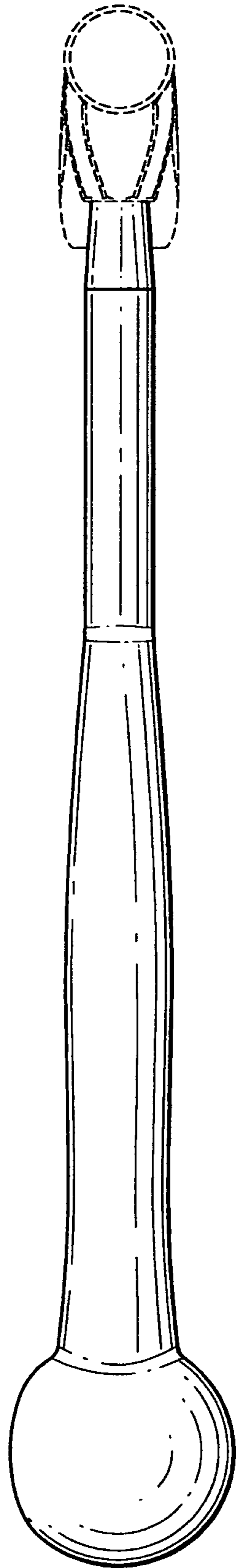

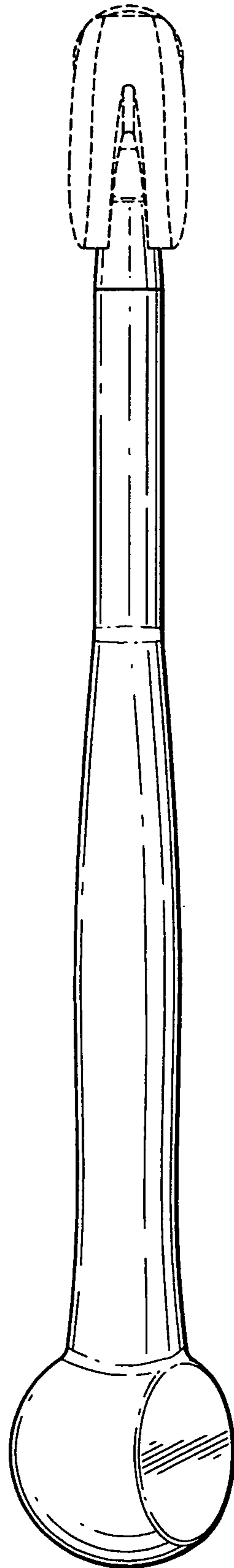

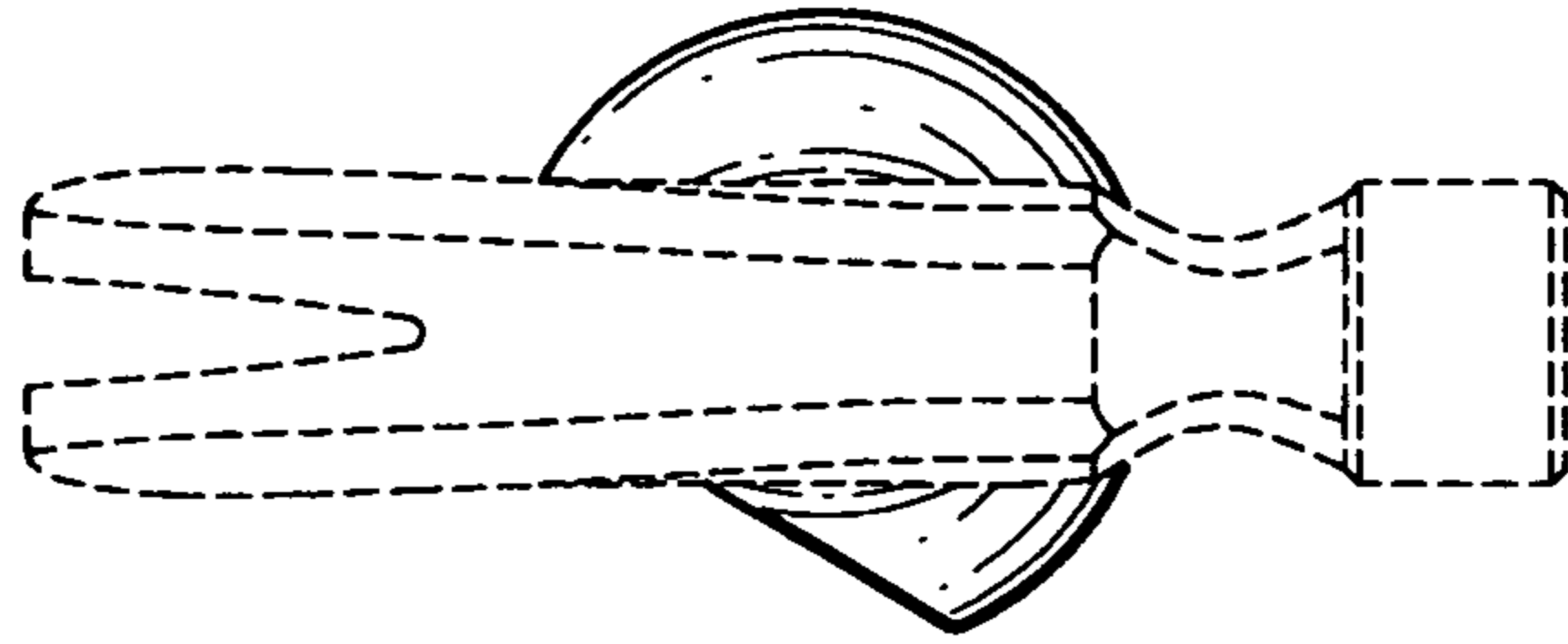

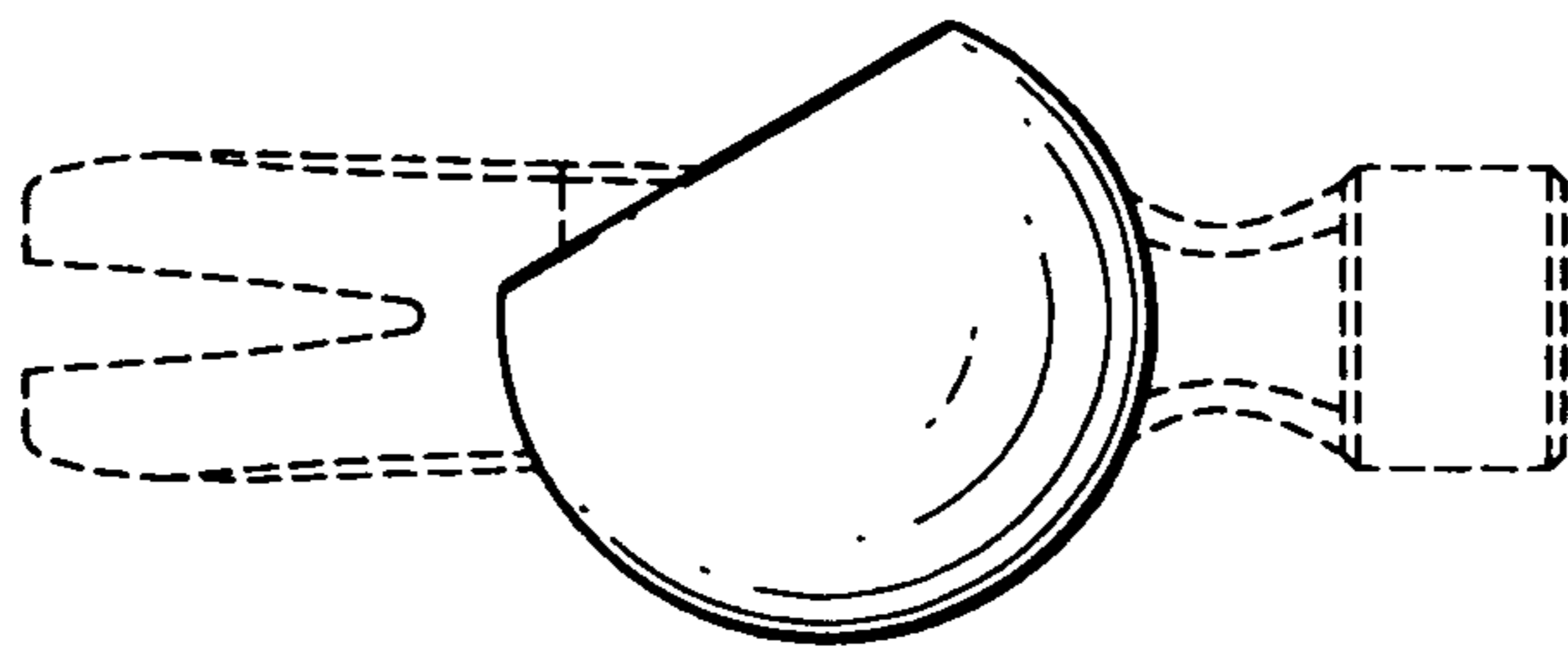
