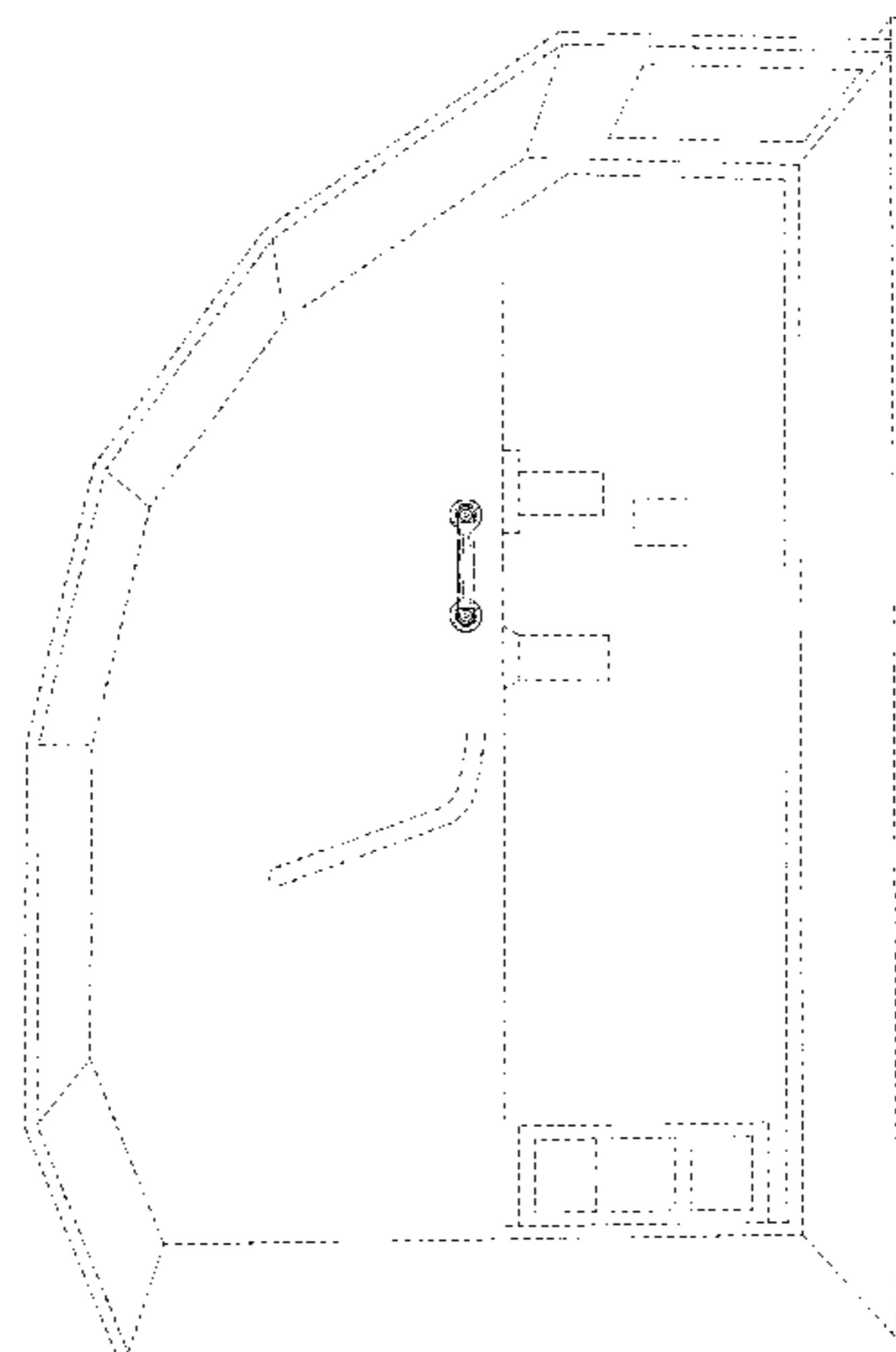
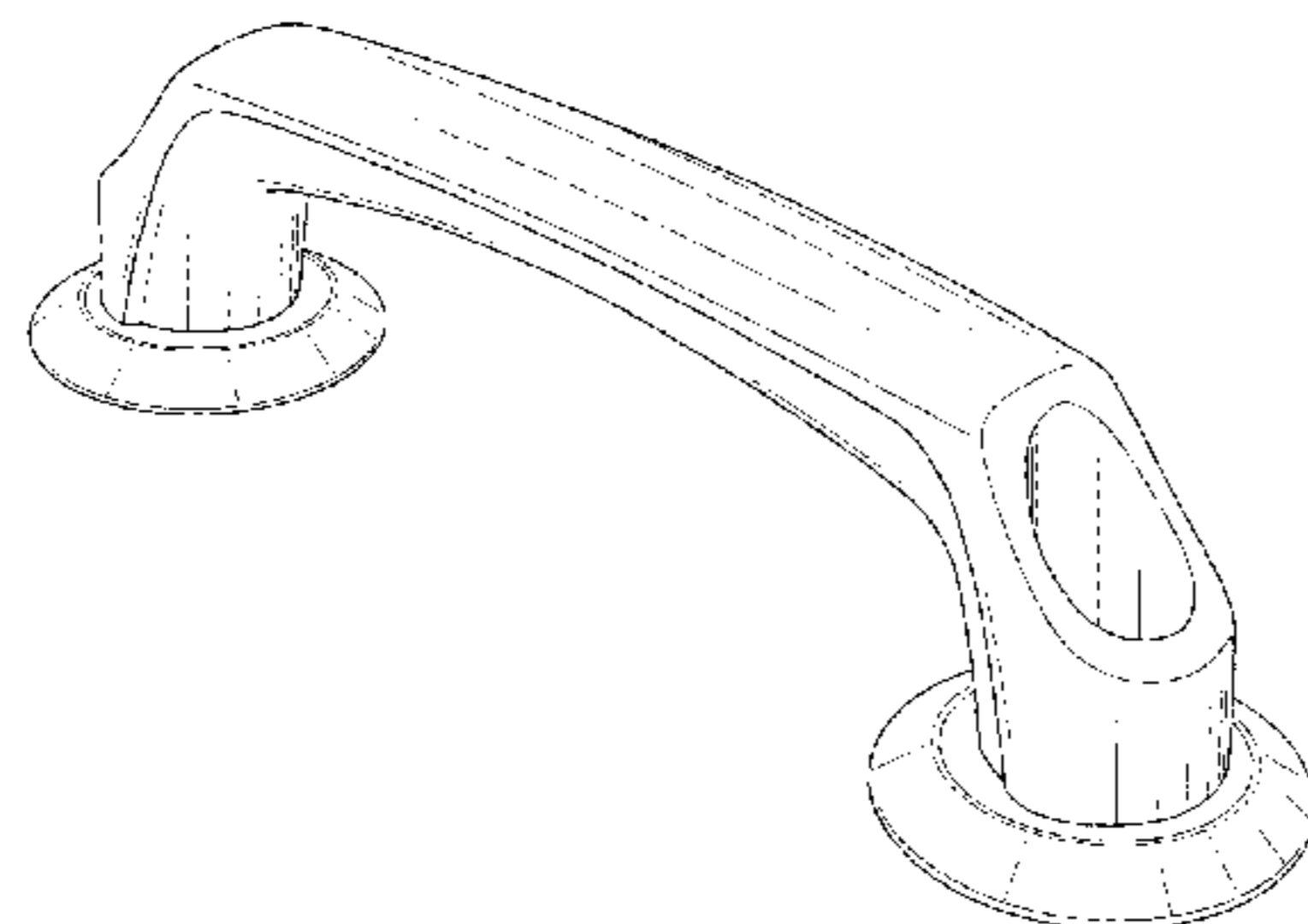

(57) **CLAIM**  
The ornamental design for an assist handle for aircraft, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an assist handle for aircraft. FIG. 2 is a perspective view thereof. FIG. 3 is a front elevation view thereof. A rear elevation view is identical to the front elevation view. FIG. 4 is a top plan view thereof. FIG. 5 is a bottom plan view thereof. FIG. 6 is a left side elevation view thereof. A right side elevation view is identical to the left side elevation view. FIG. 7 is a cross-sectional view taken along the line 7-7 in FIG. 6. FIG. 8 is a cross-sectional view taken along the line 8-8 in FIG. 3. FIG. 9 is a referential view showing use thereof on the lavatory wall. FIG. 10 is a referential view showing use thereof around the door; and, FIG. 11 is a referential view showing use thereof in the cockpit. The portions shown in broken lines are for the purpose of showing environmental structure only and form no part of the claimed design.

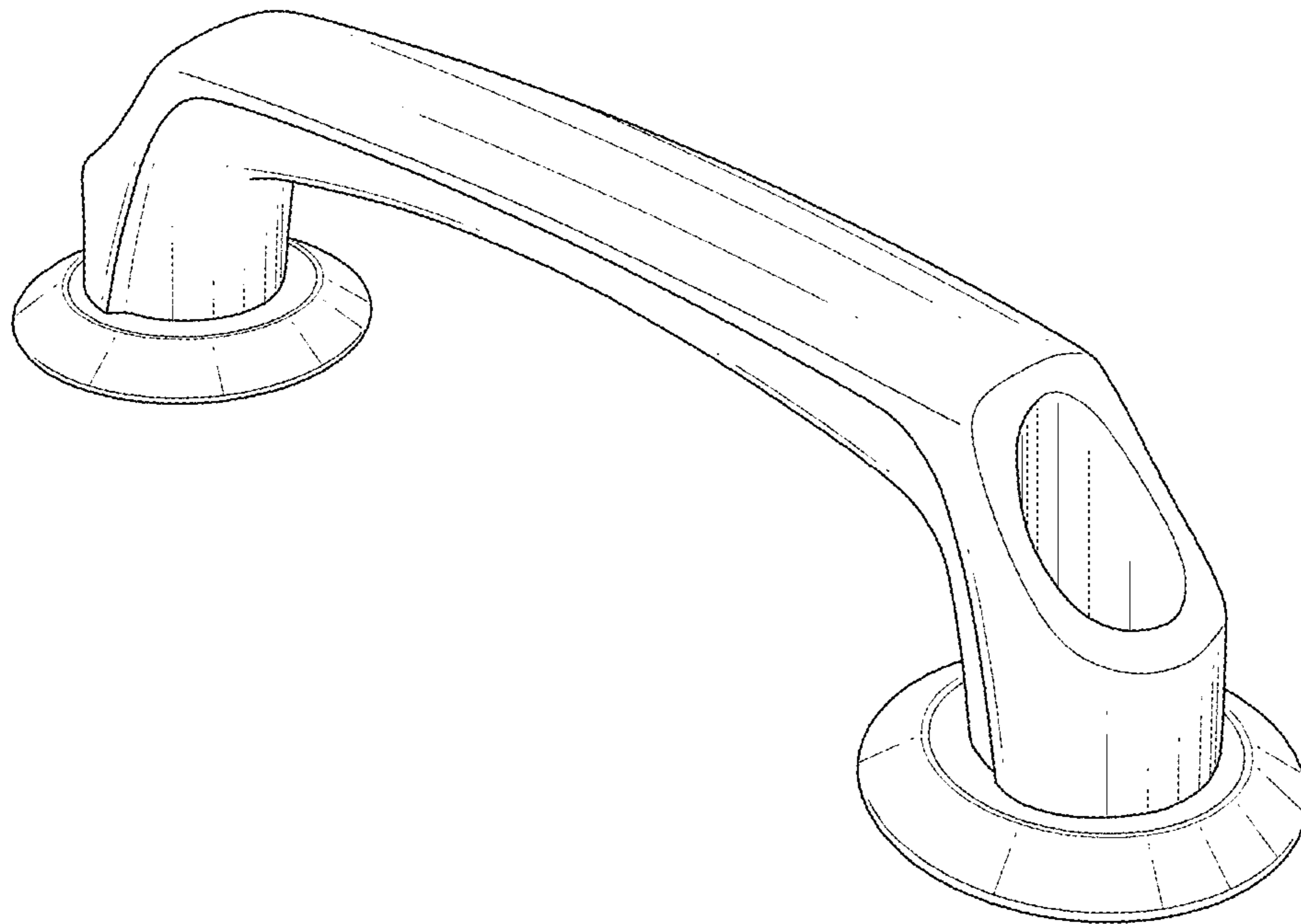

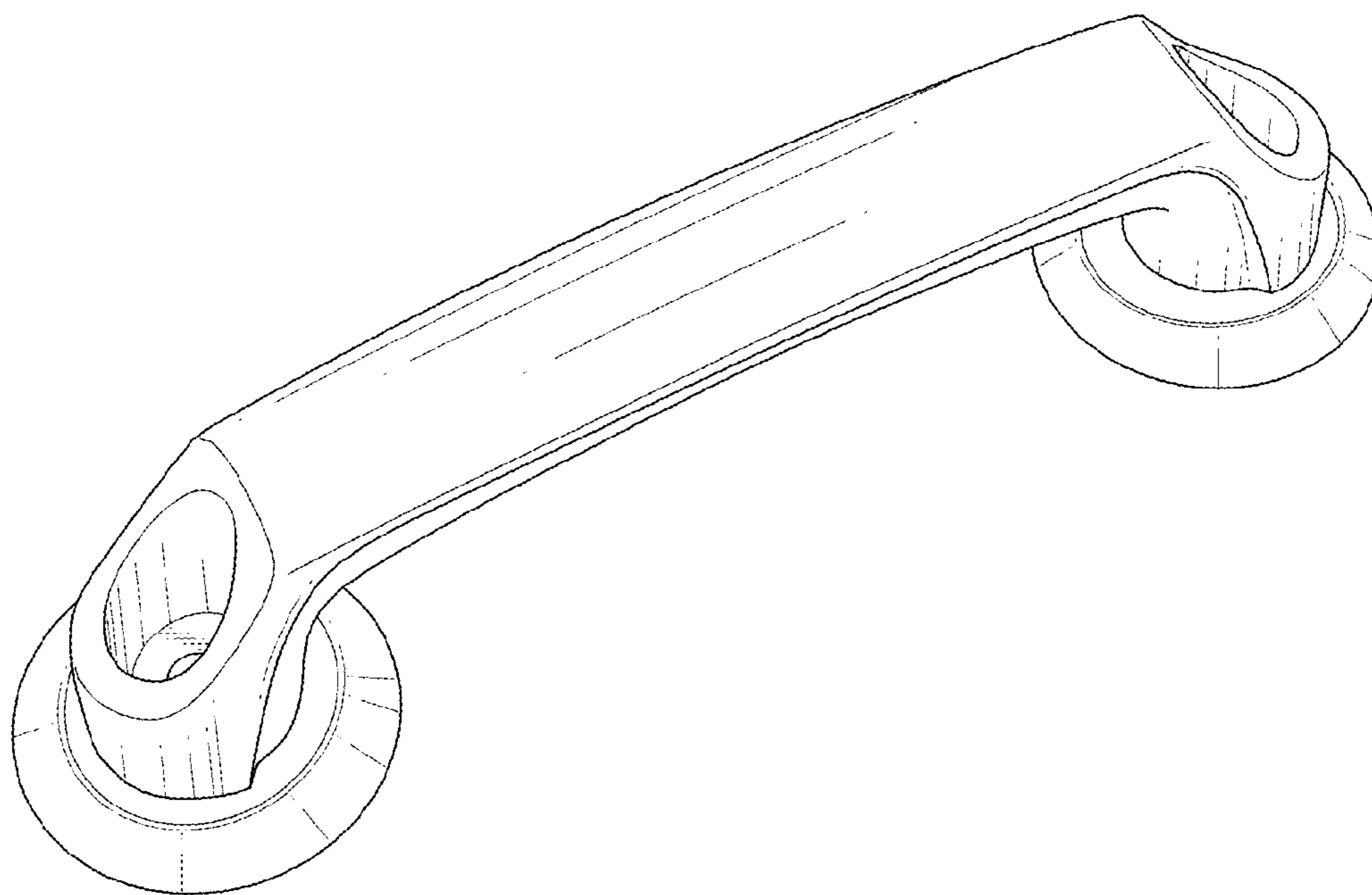

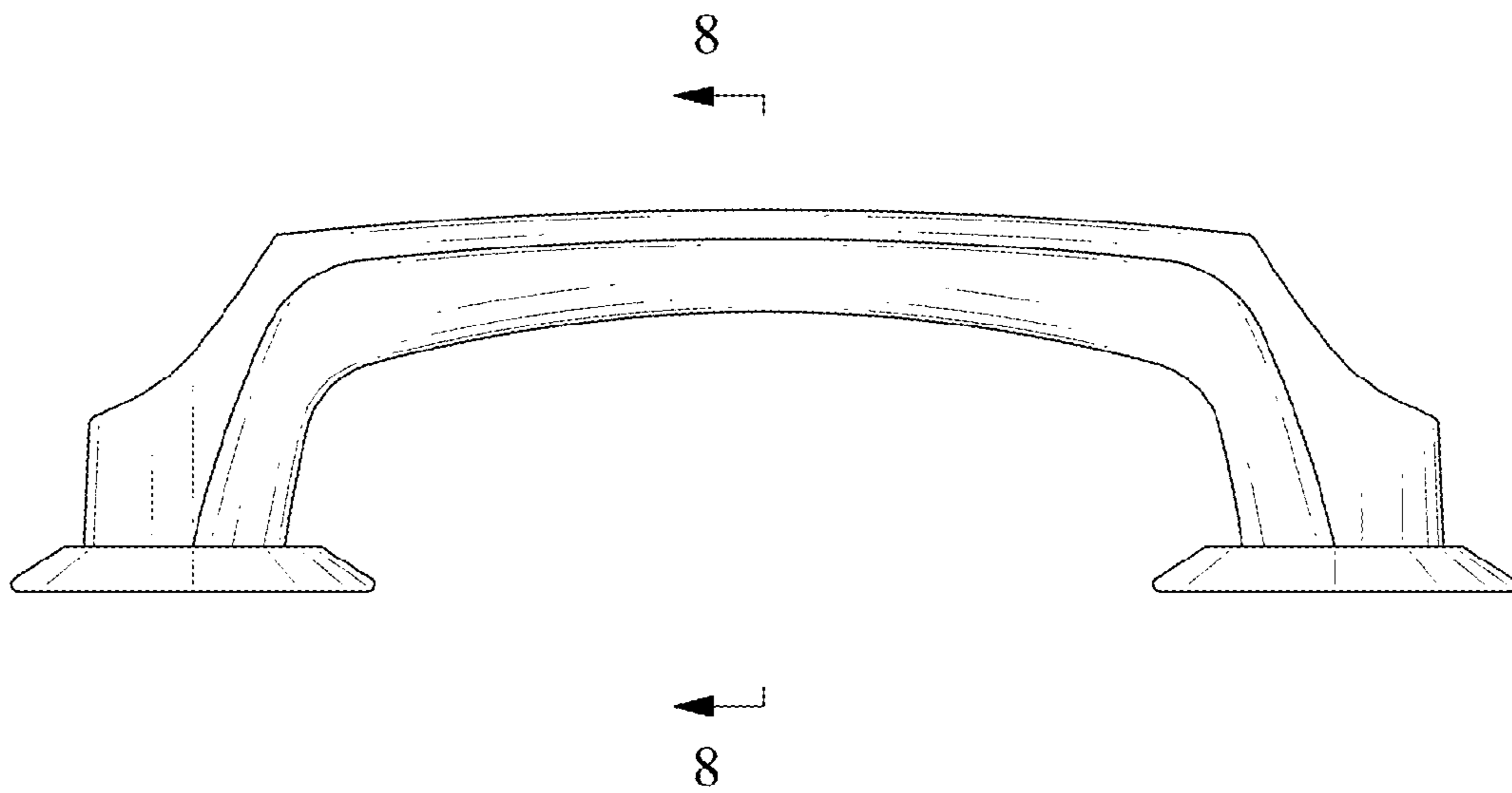

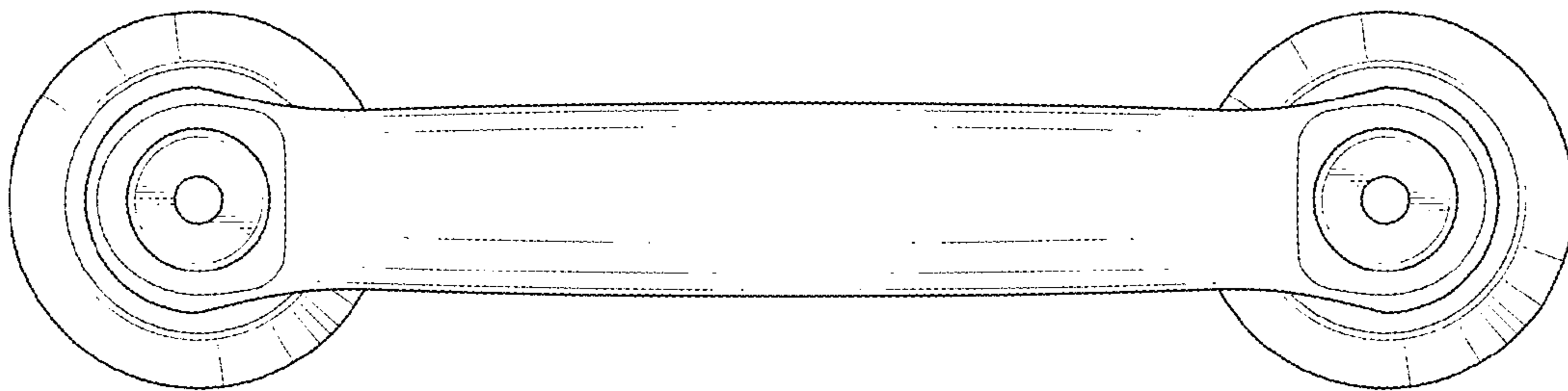

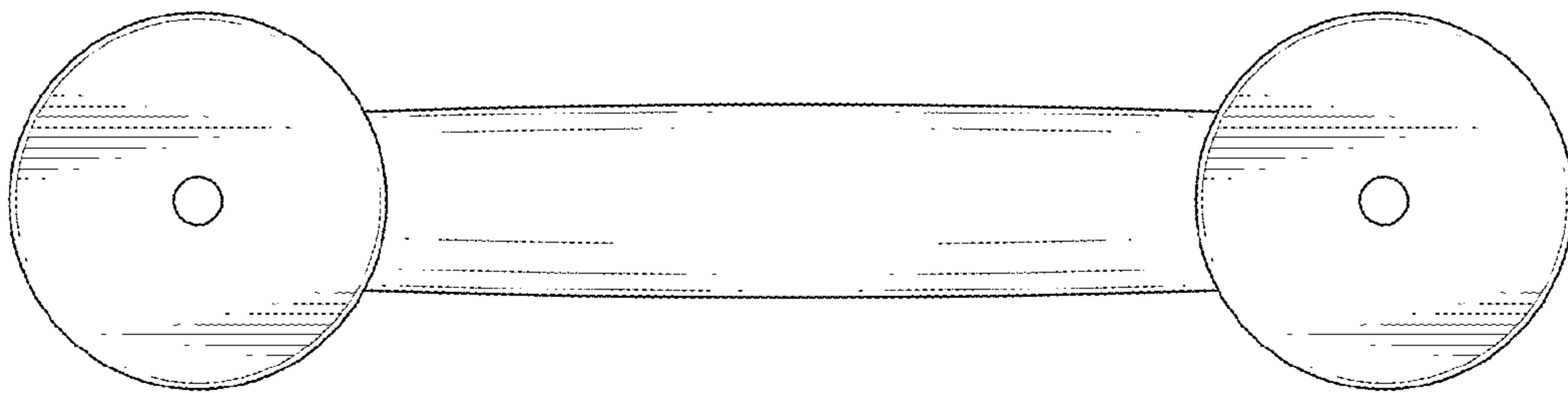

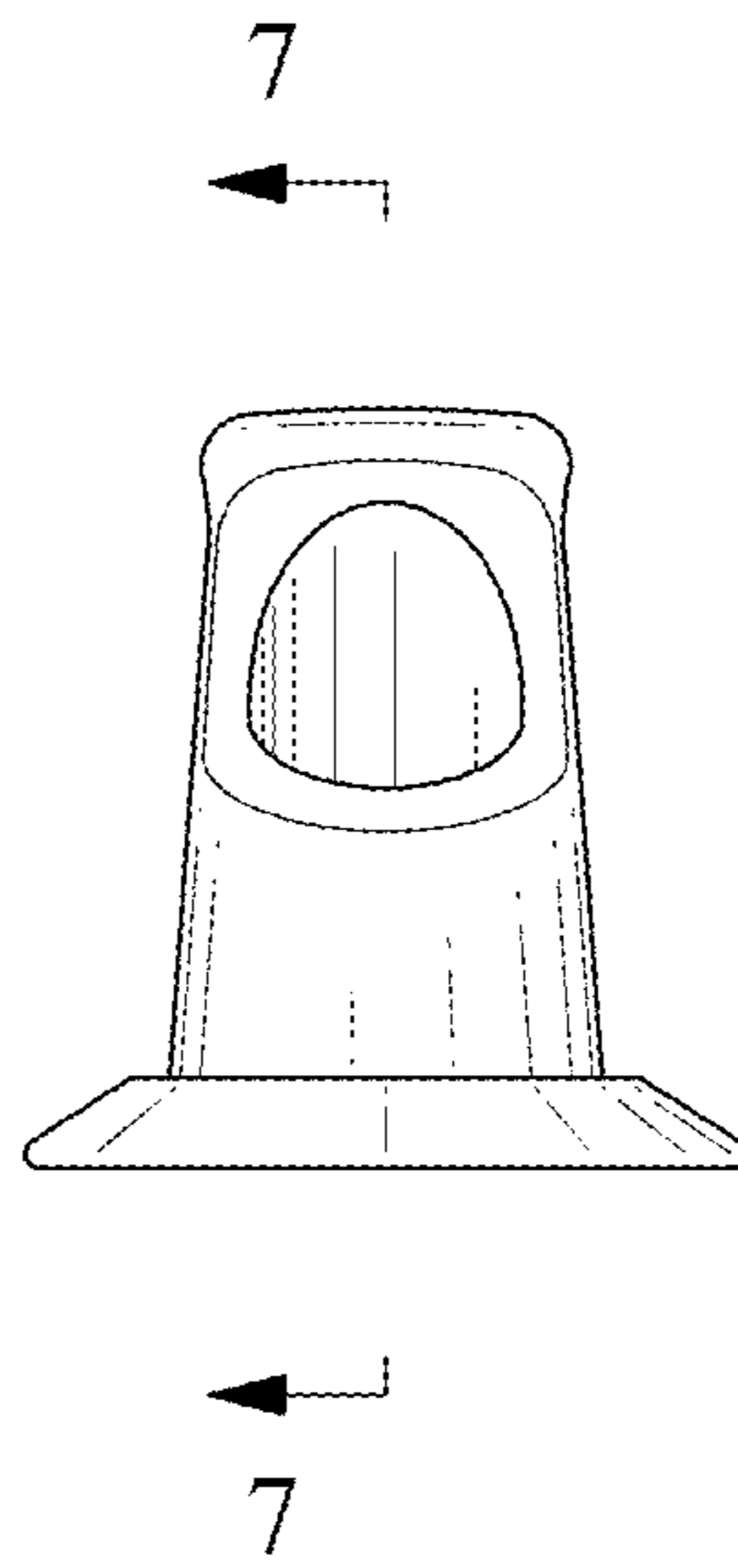

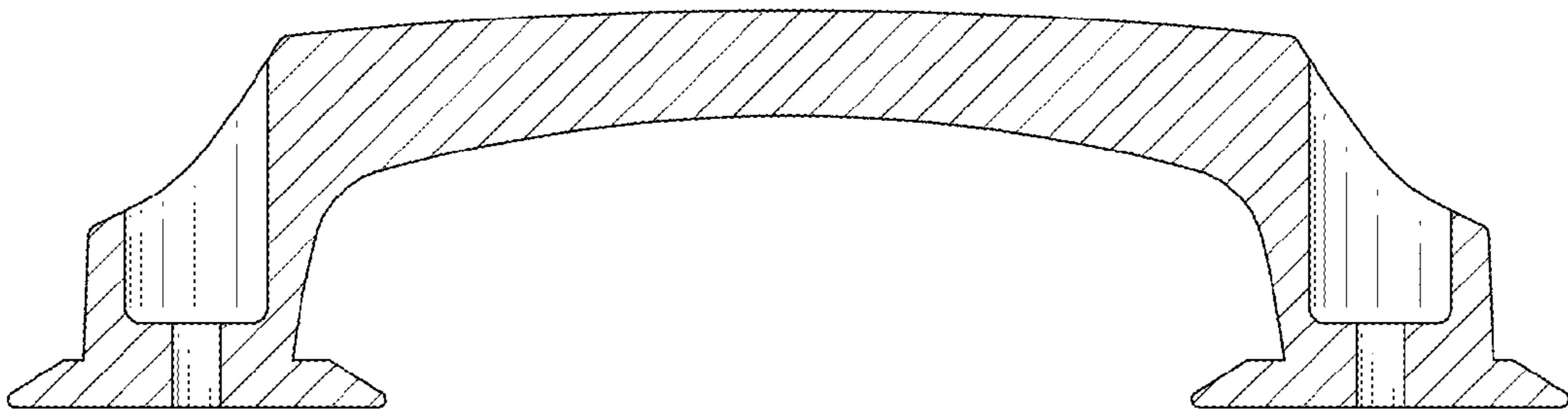

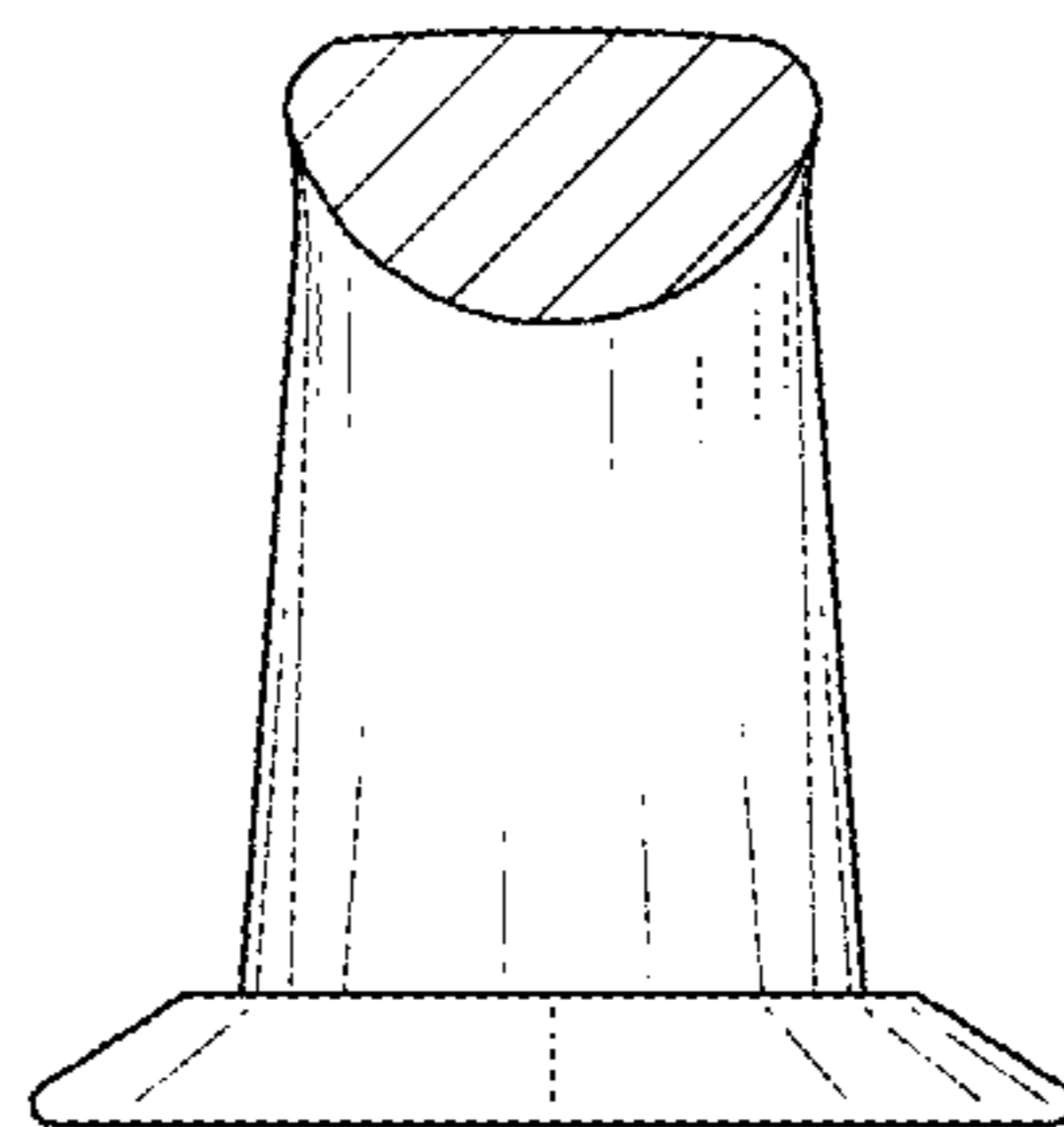

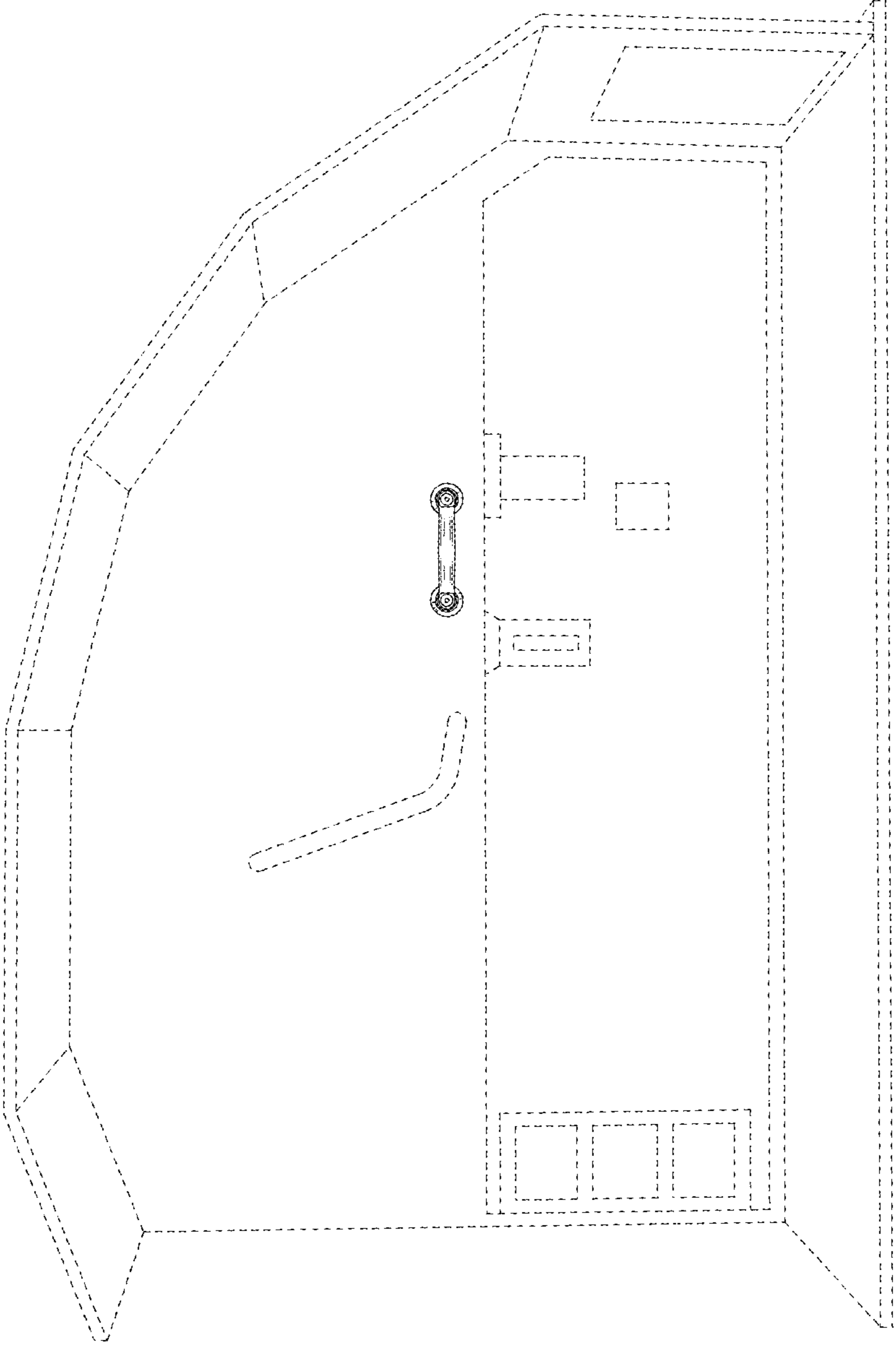

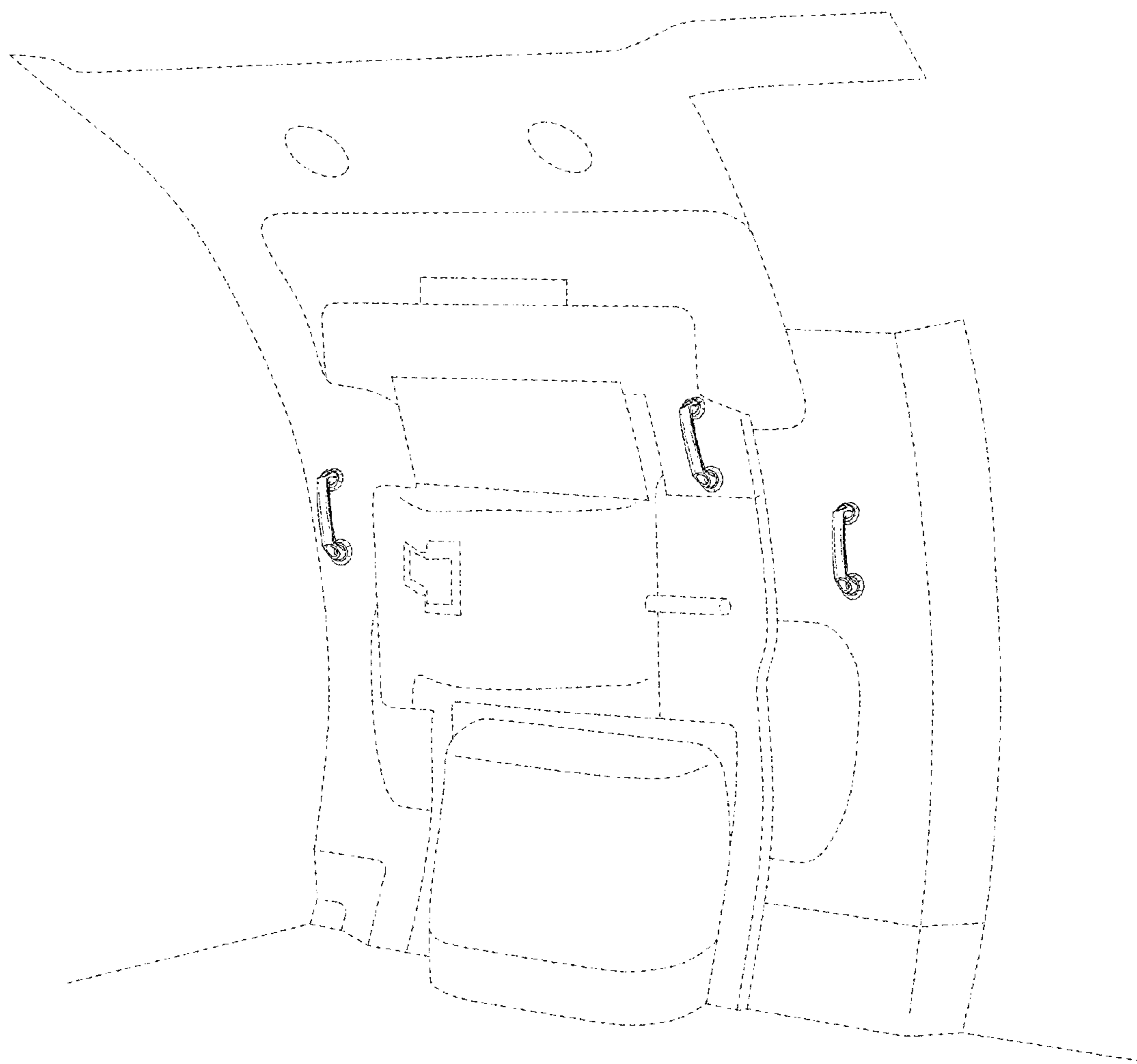
