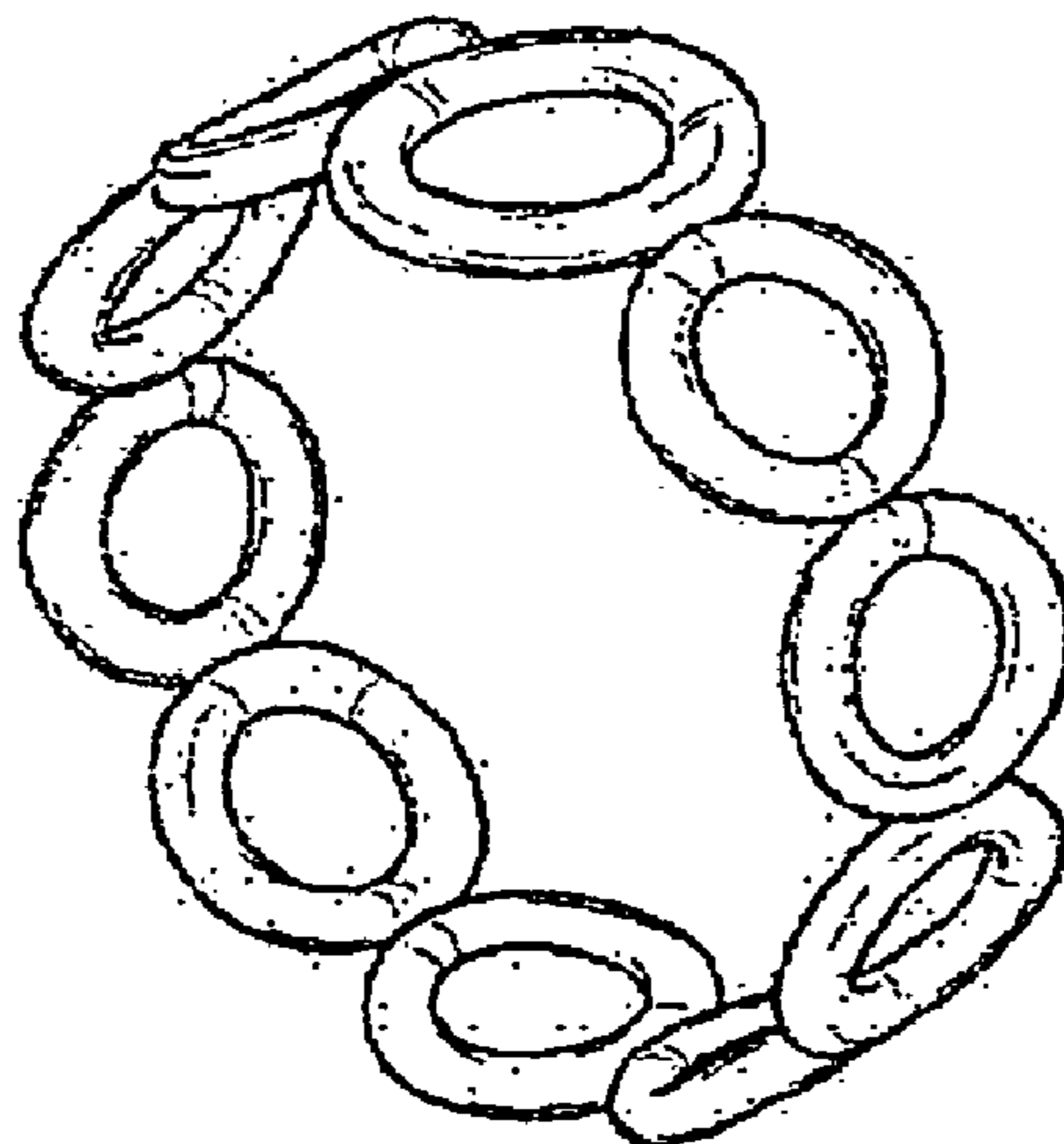

**DESCRIPTION**

FIG. 1 is perspective view of the decorative ring employing my new design, with the finger portion shown in phantom; FIG. 2 is a perspective view of FIG. 1; FIG. 3 is a rear view of FIG. 1; FIG. 4 is a right side view of FIG. 1; FIG. 5 is a left side view of FIG. 1; FIG. 6 is a top view of FIG. 1; FIG. 7 is a bottom view of FIG. 1; FIG. 8 is a perspective view of an alternative embodiment of the view shown in FIG. 1; FIG. 9 is a rear view of FIG. 8; FIG. 10 is a right side view of FIG. 8; FIG. 11 is a left side view of FIG. 8; FIG. 12 is a top view of FIG. 8; and, FIG. 13 is a bottom view of FIG. 8.

The broken lines shown in the drawings represent the environment of the decorative ring and form no part of the claimed design.

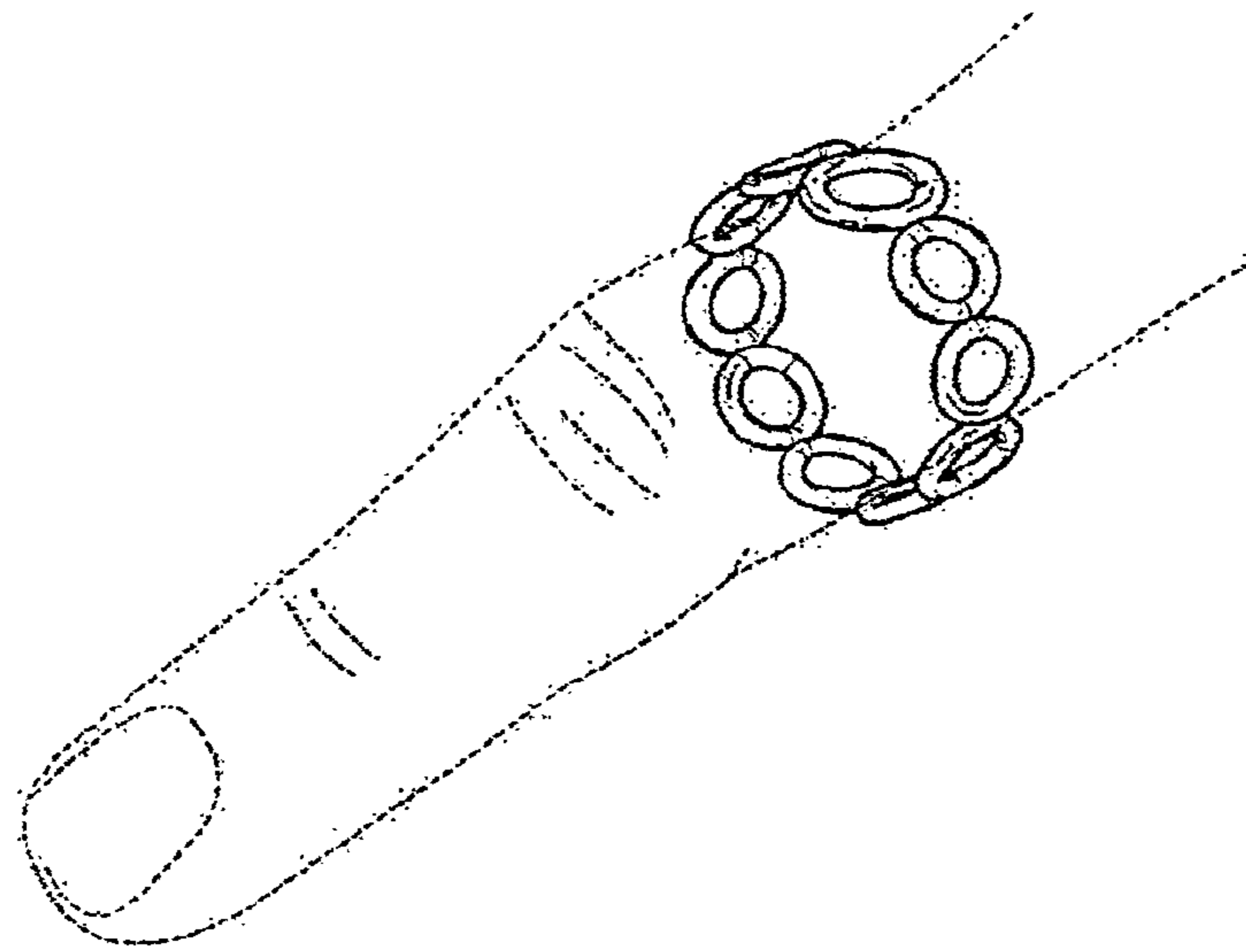

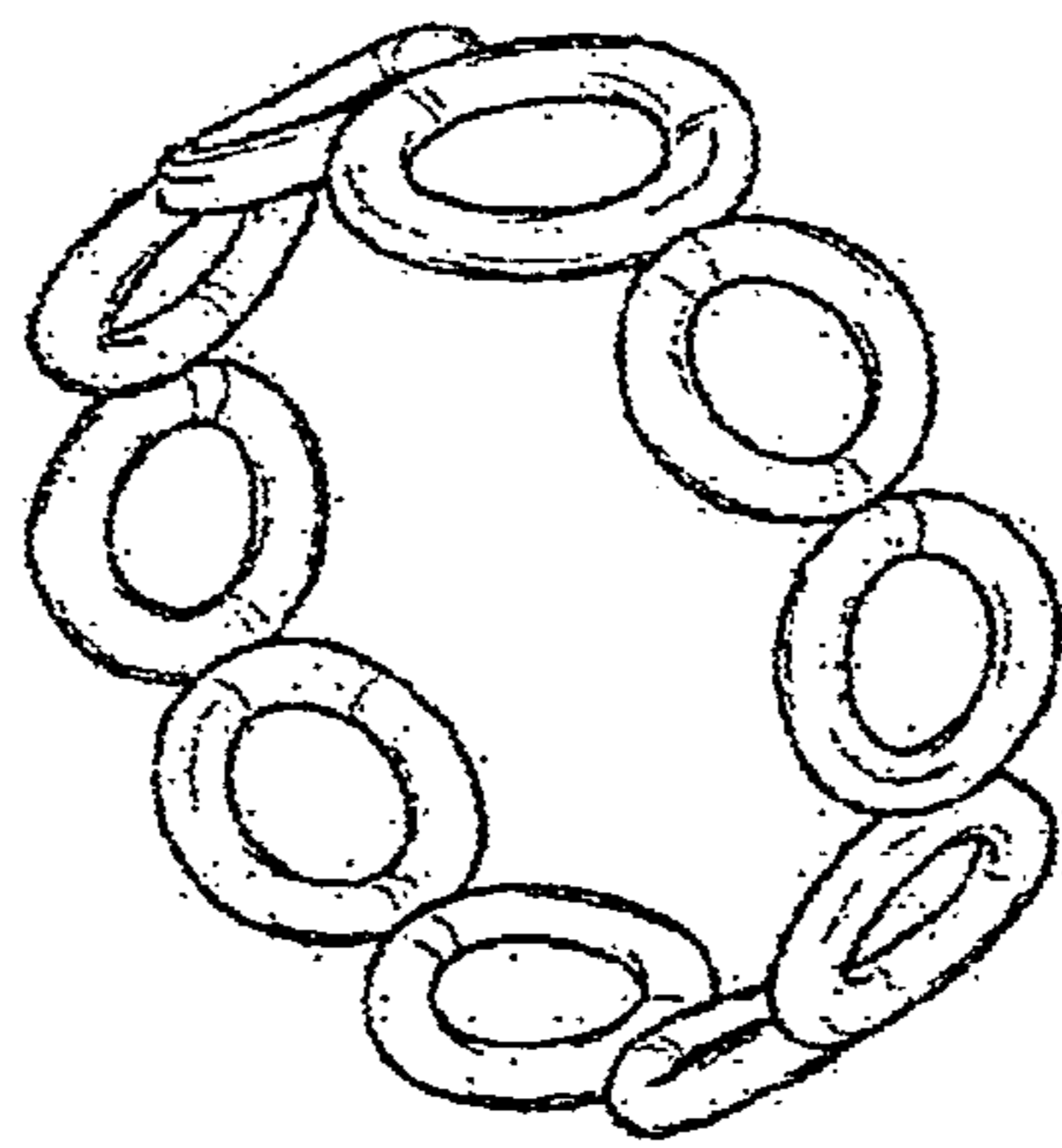

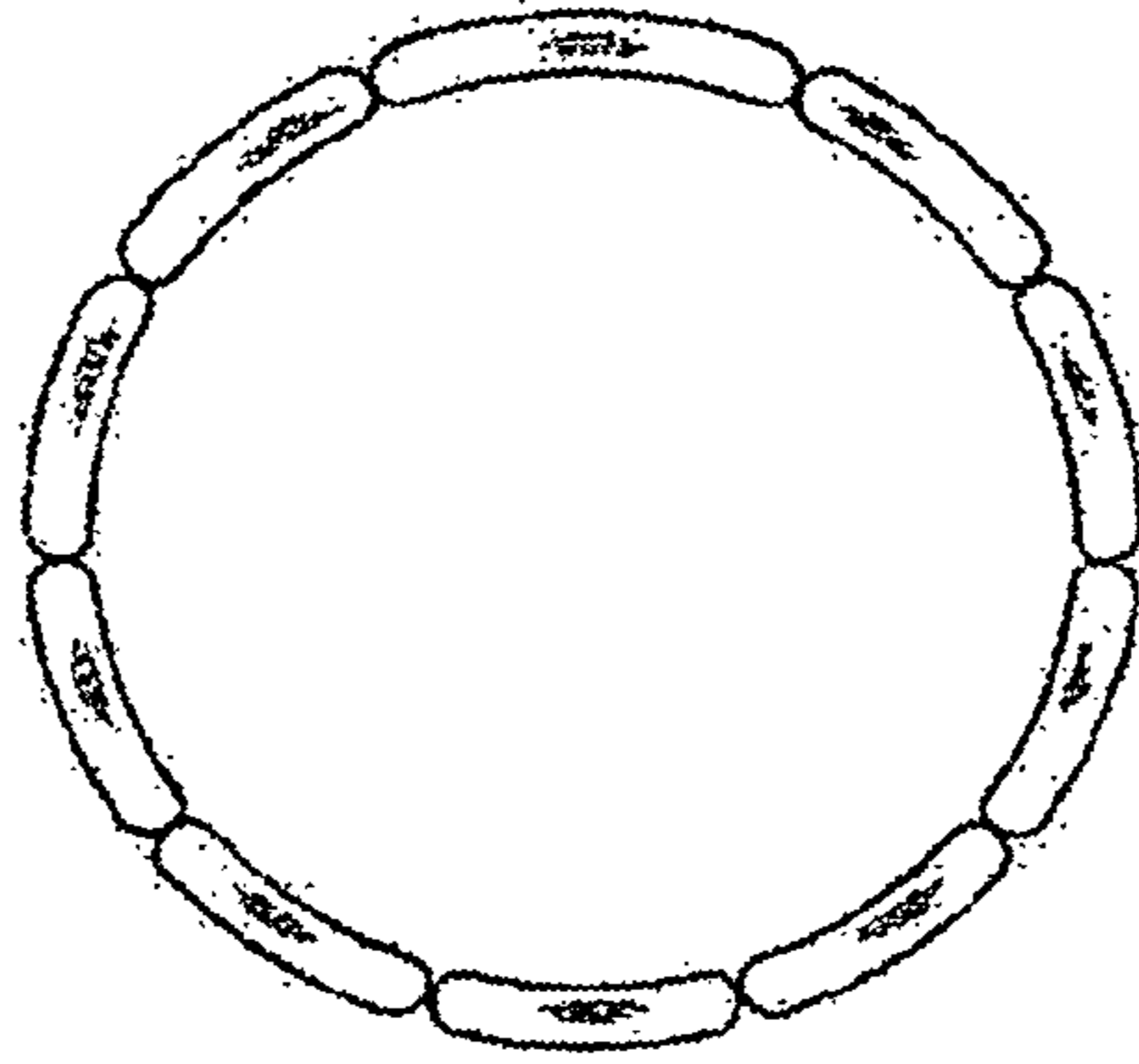

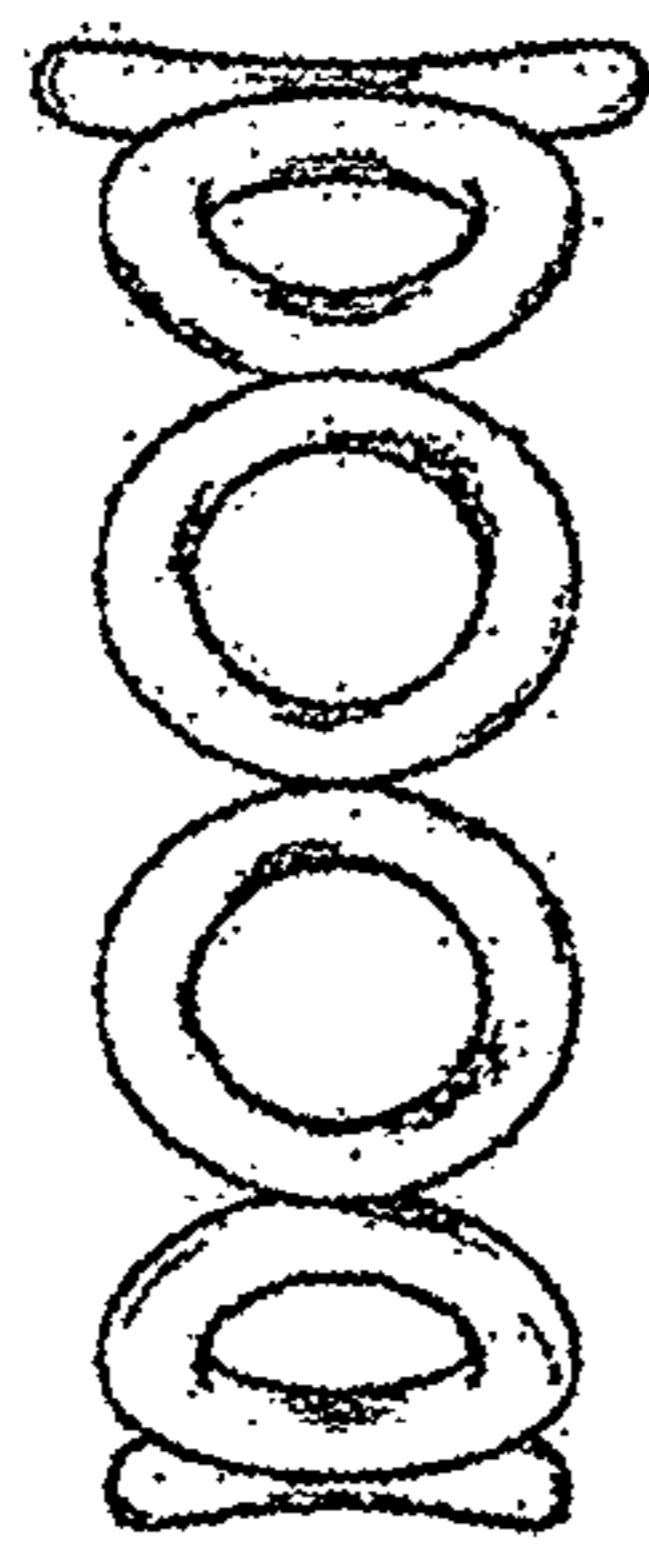

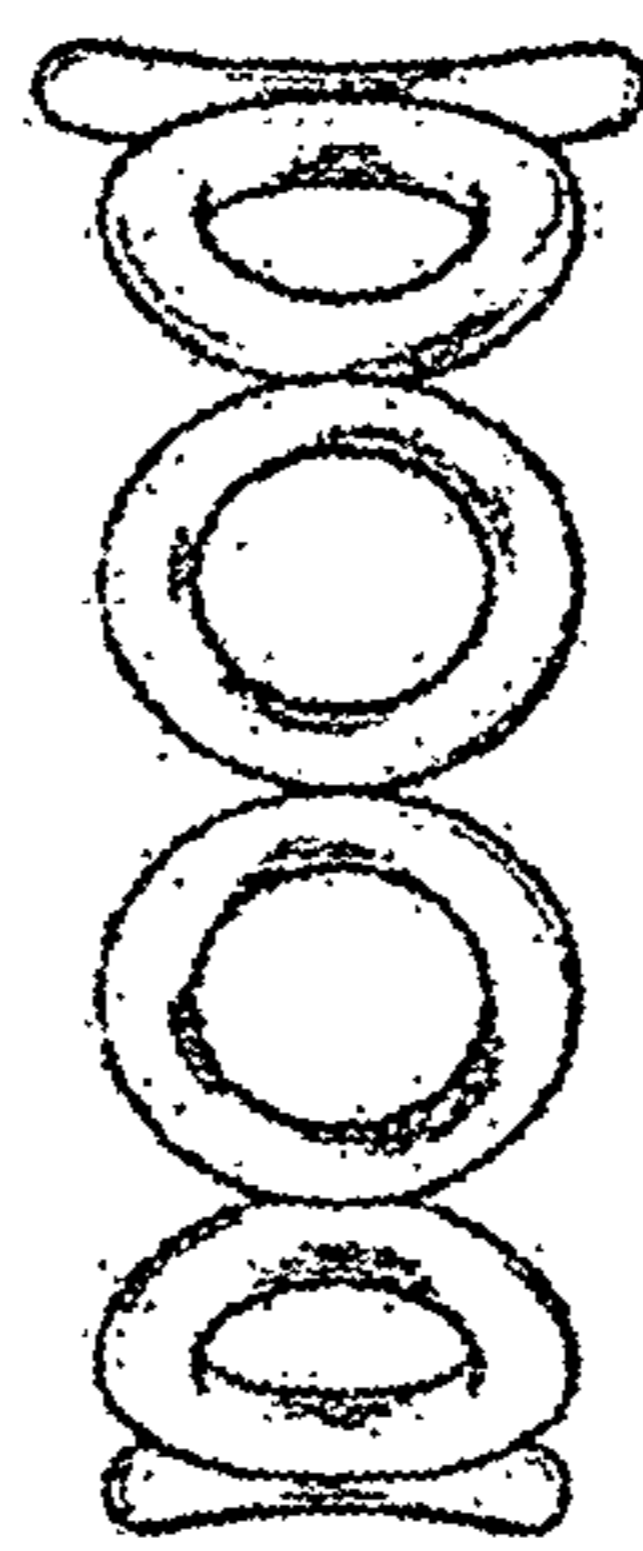

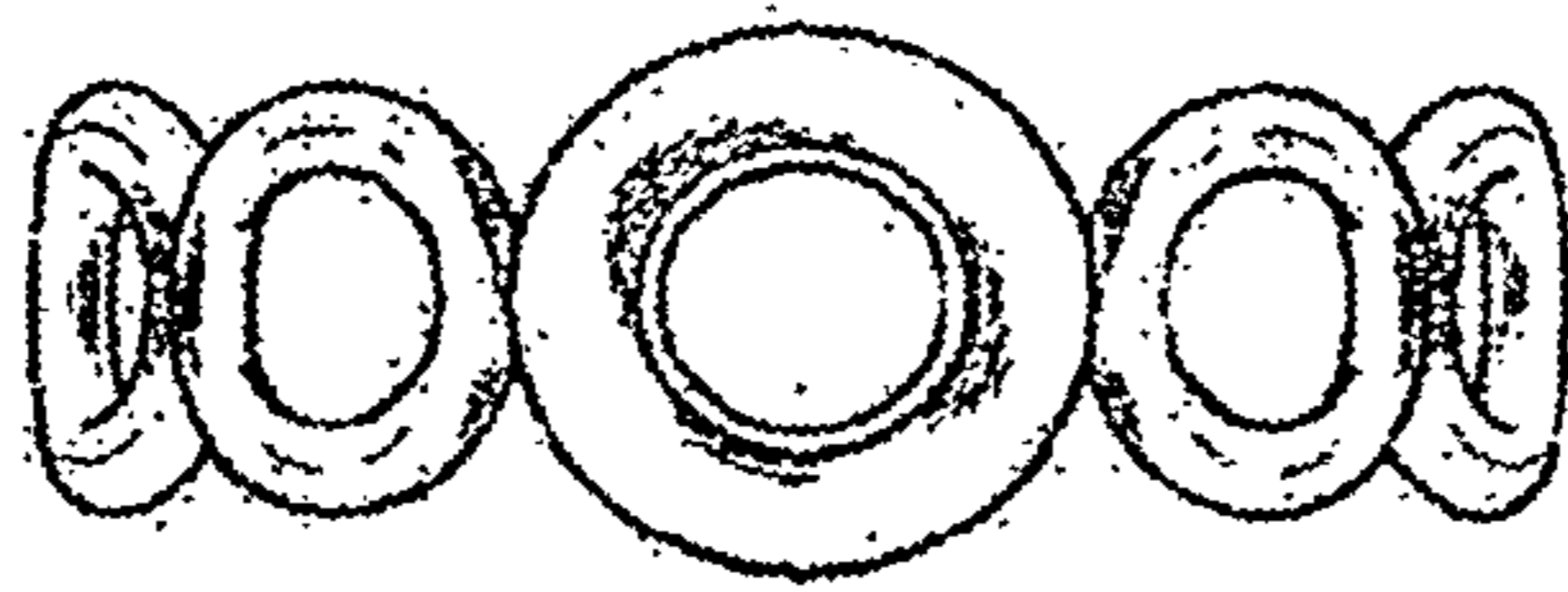

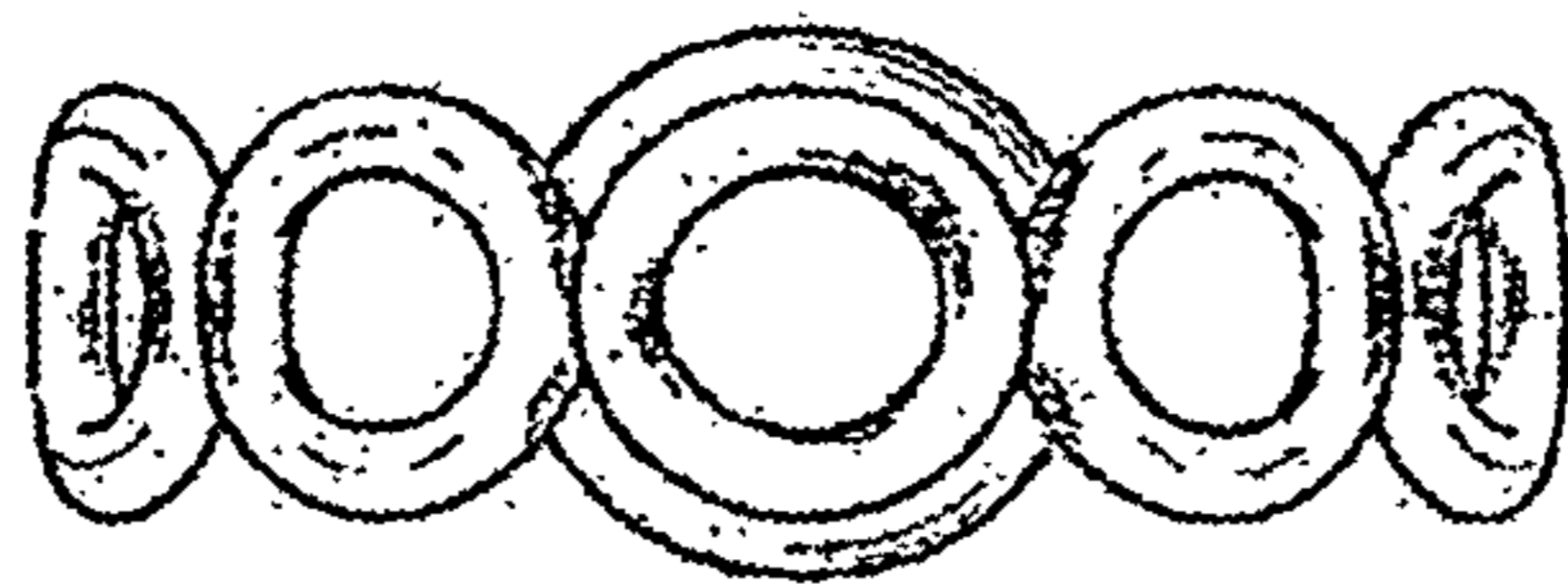

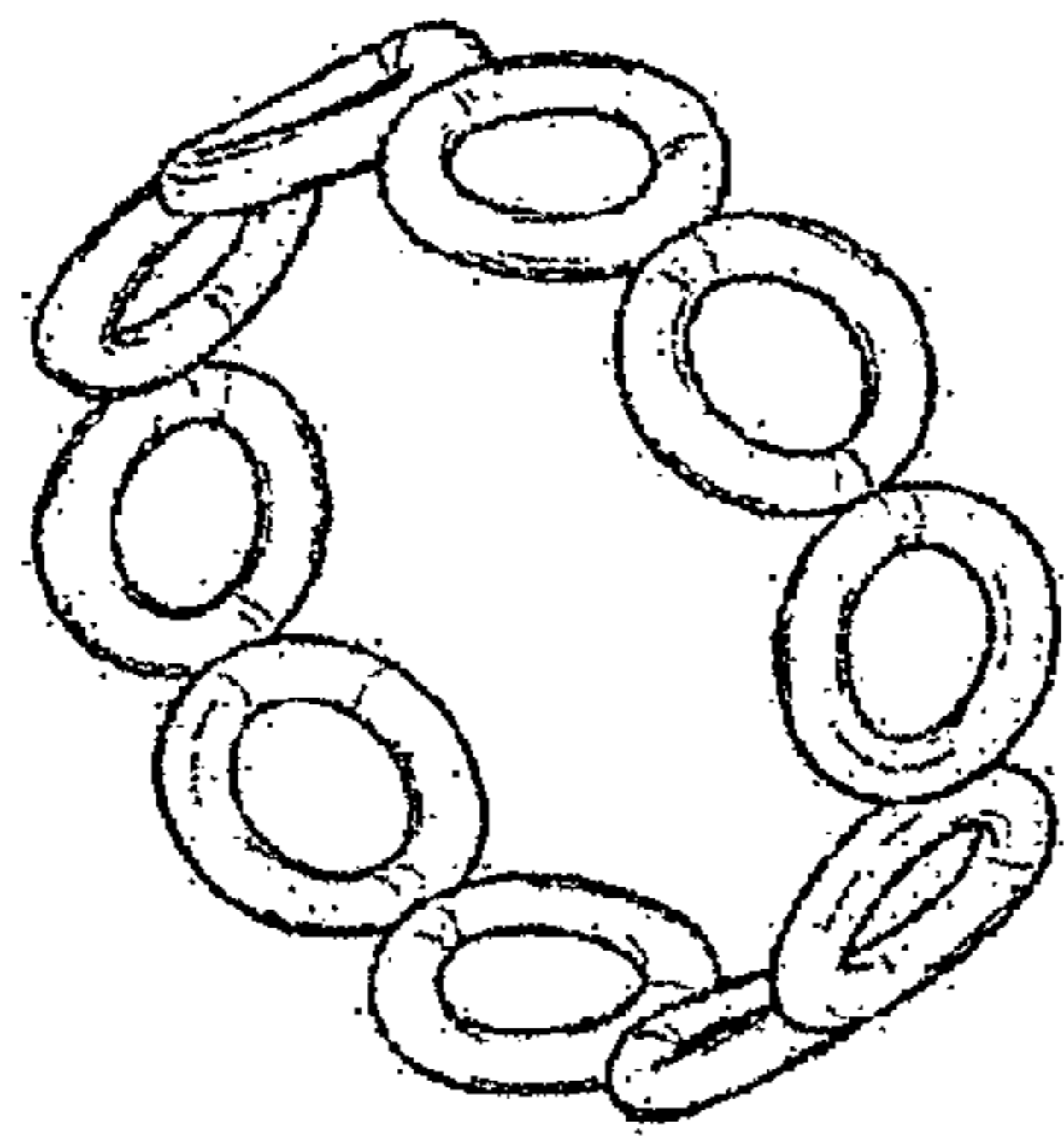

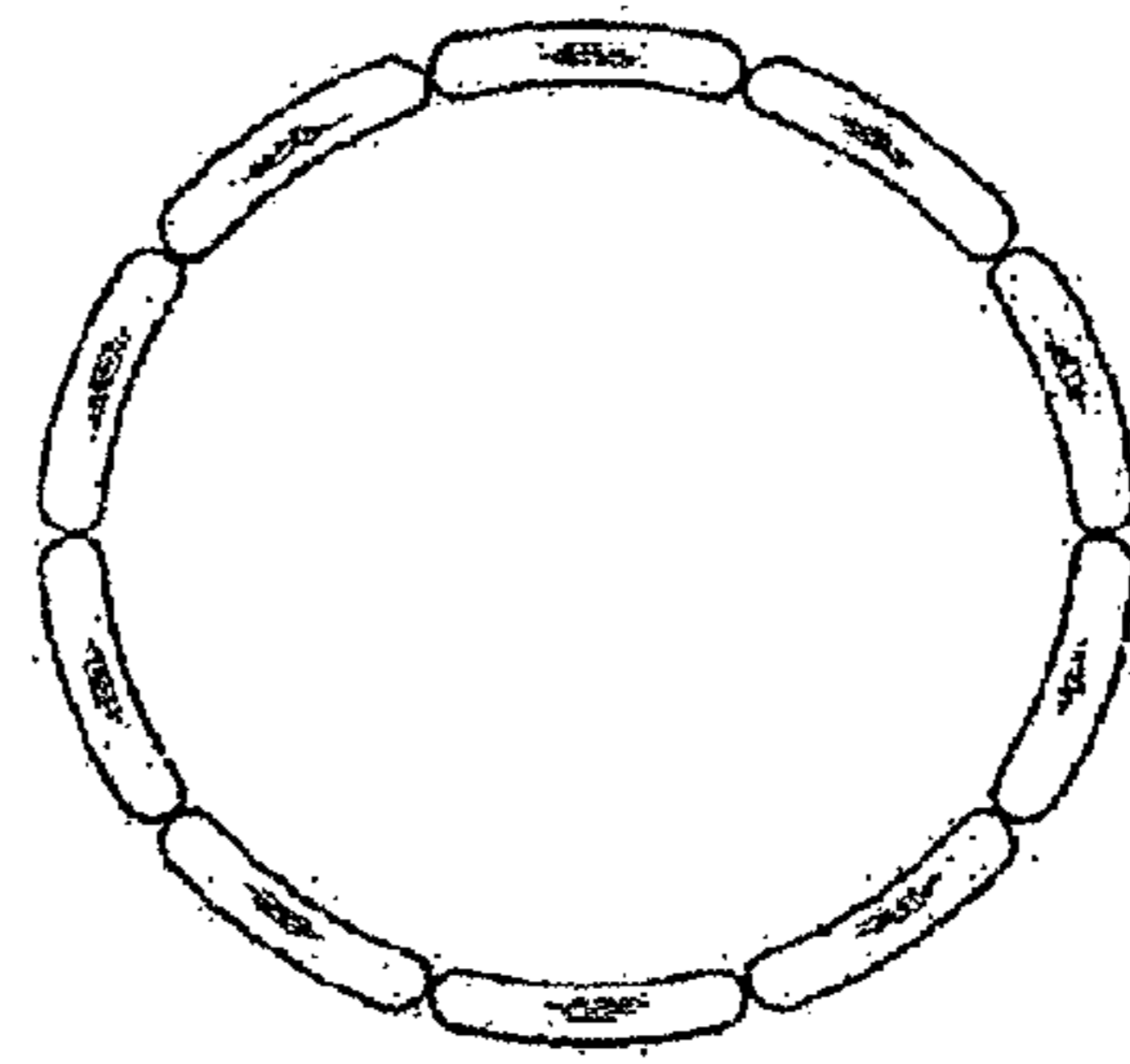

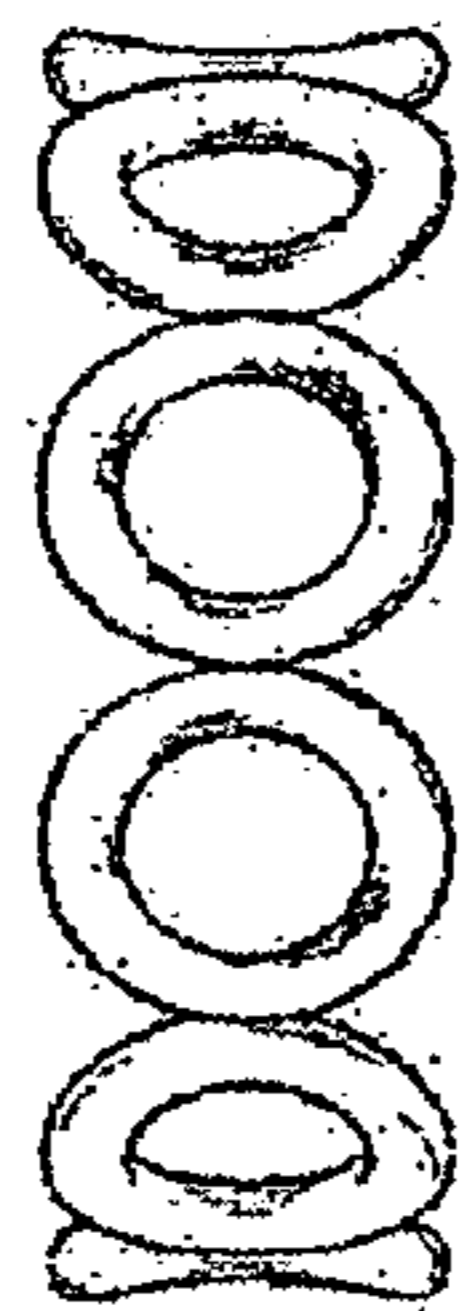
