(57) **CLAIM**

The ornamental design for a motor vehicle, toy replica and/or other replicas, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of the motor vehicle, toy replica and/or other replicas showing our new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

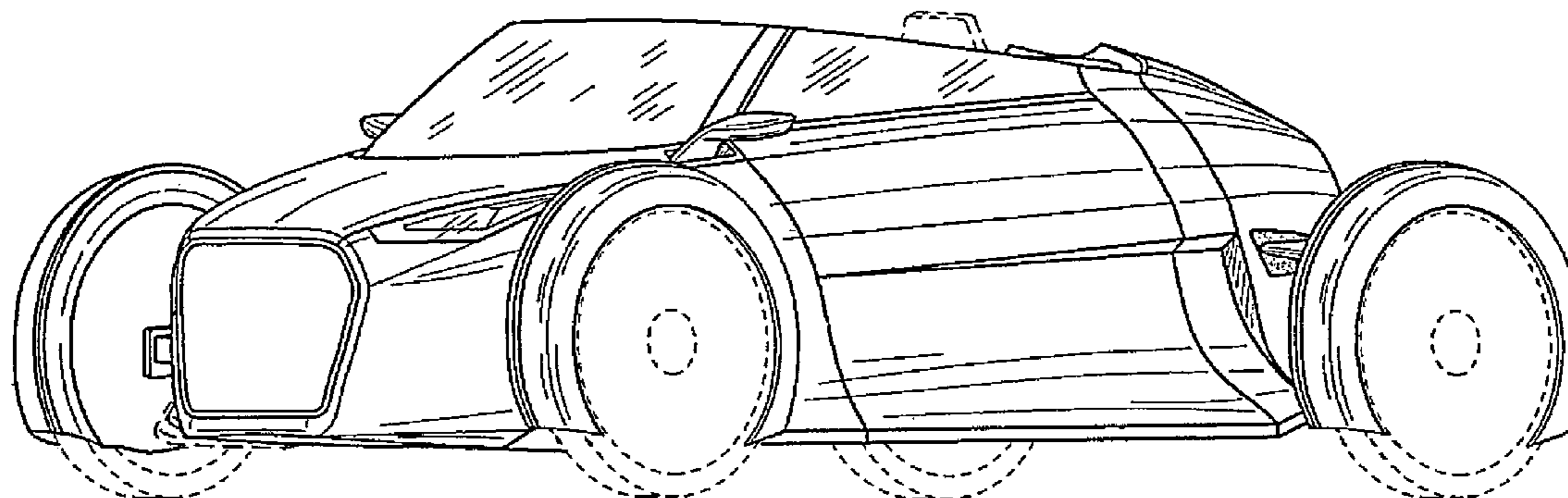
FIG. 4 is a top plan view thereof;

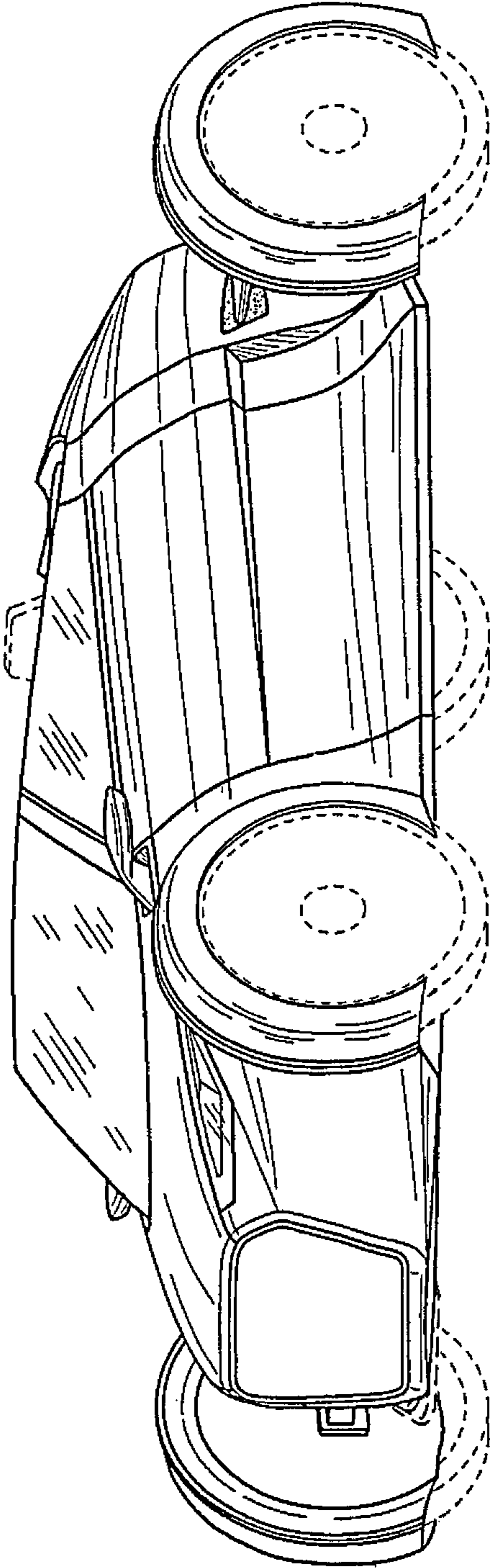

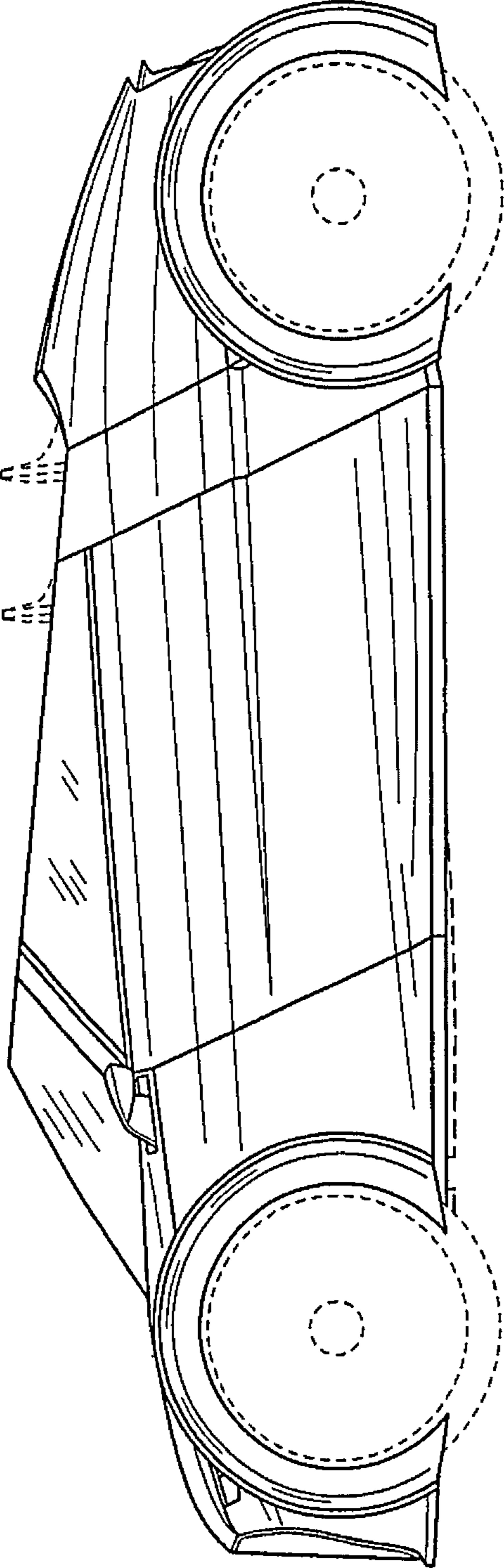

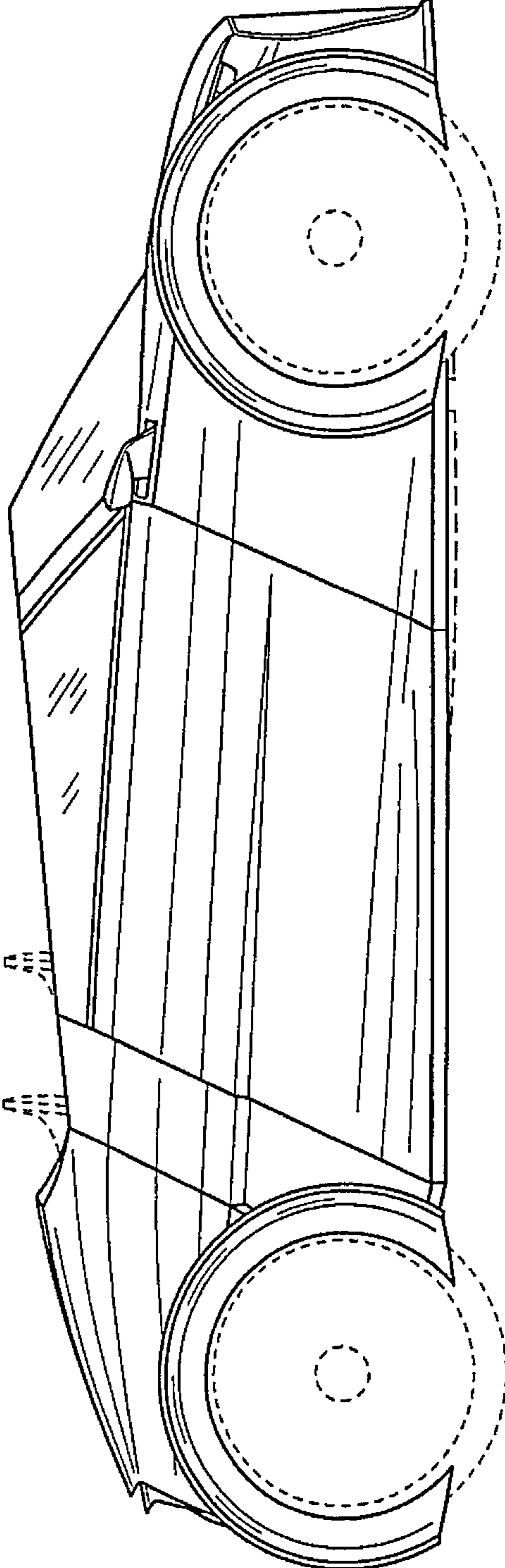

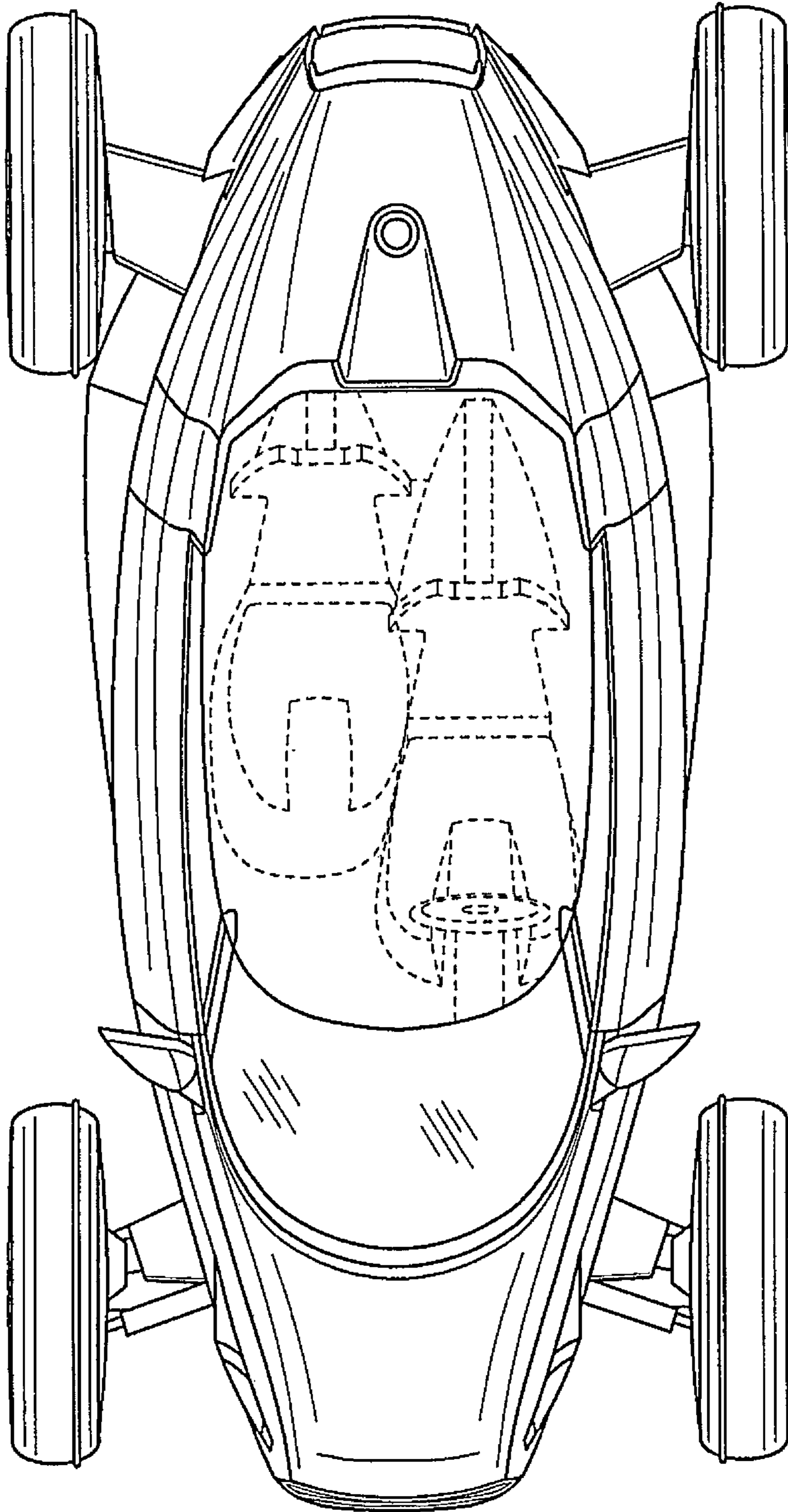

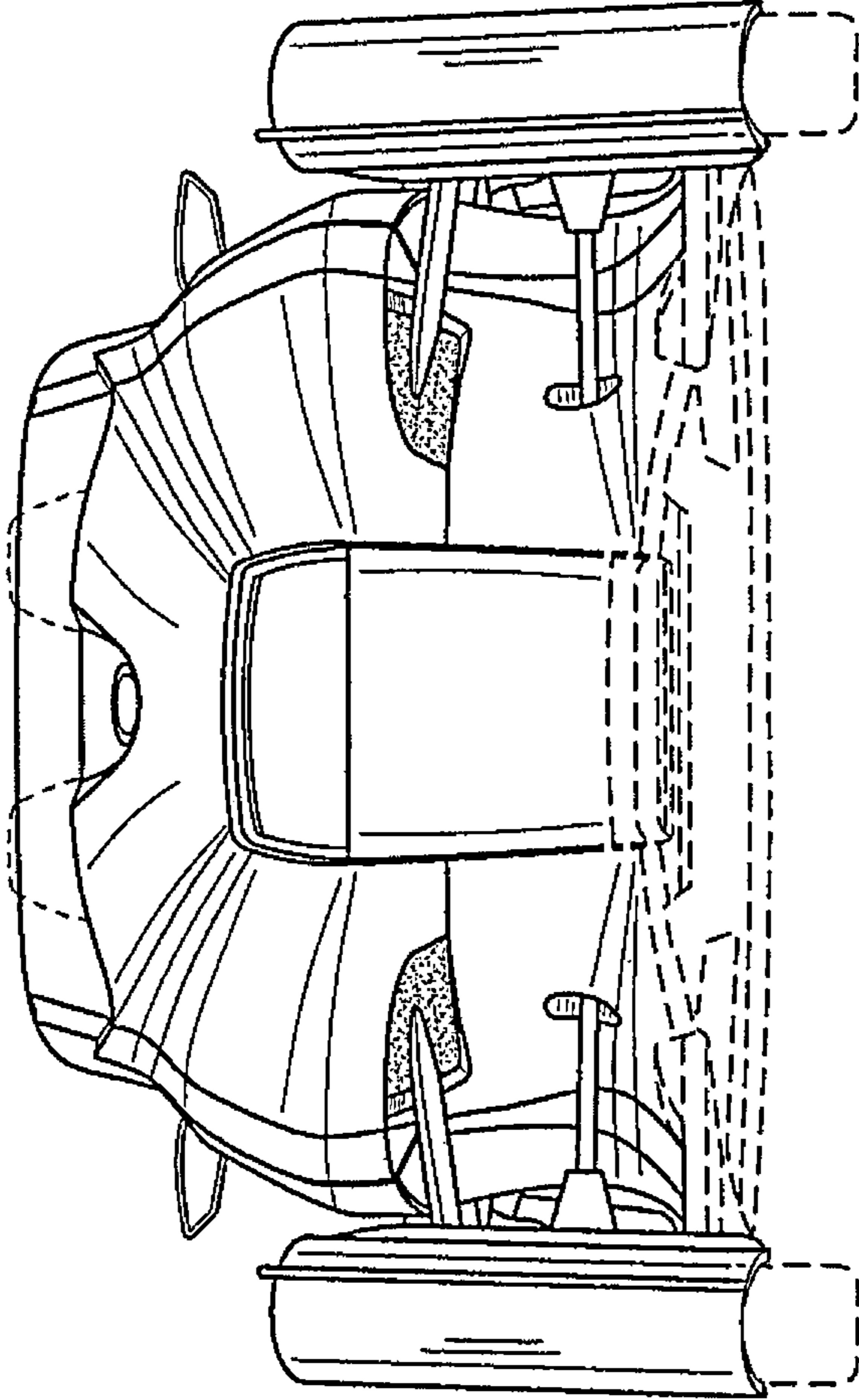

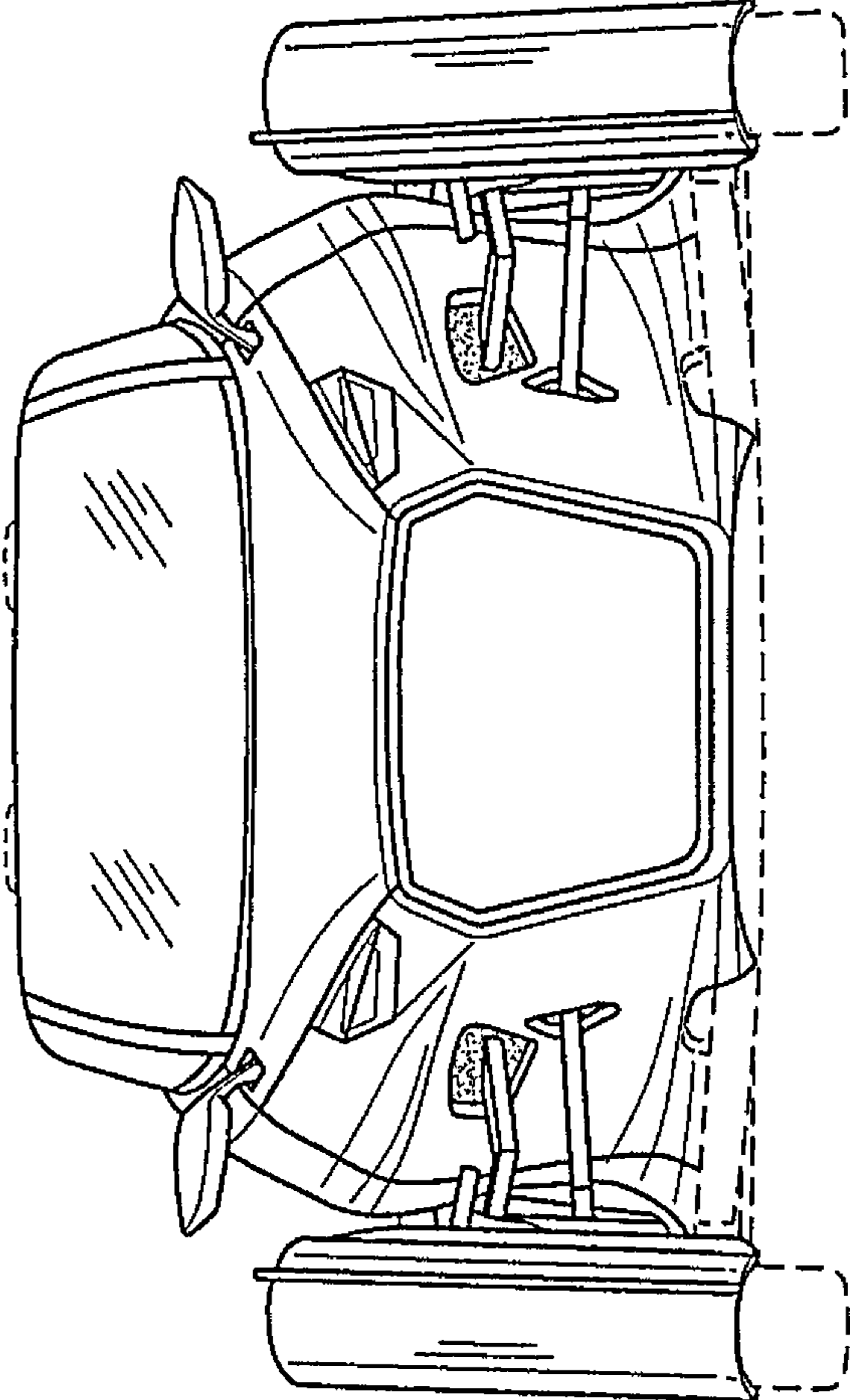
